**DESCRIPTION**

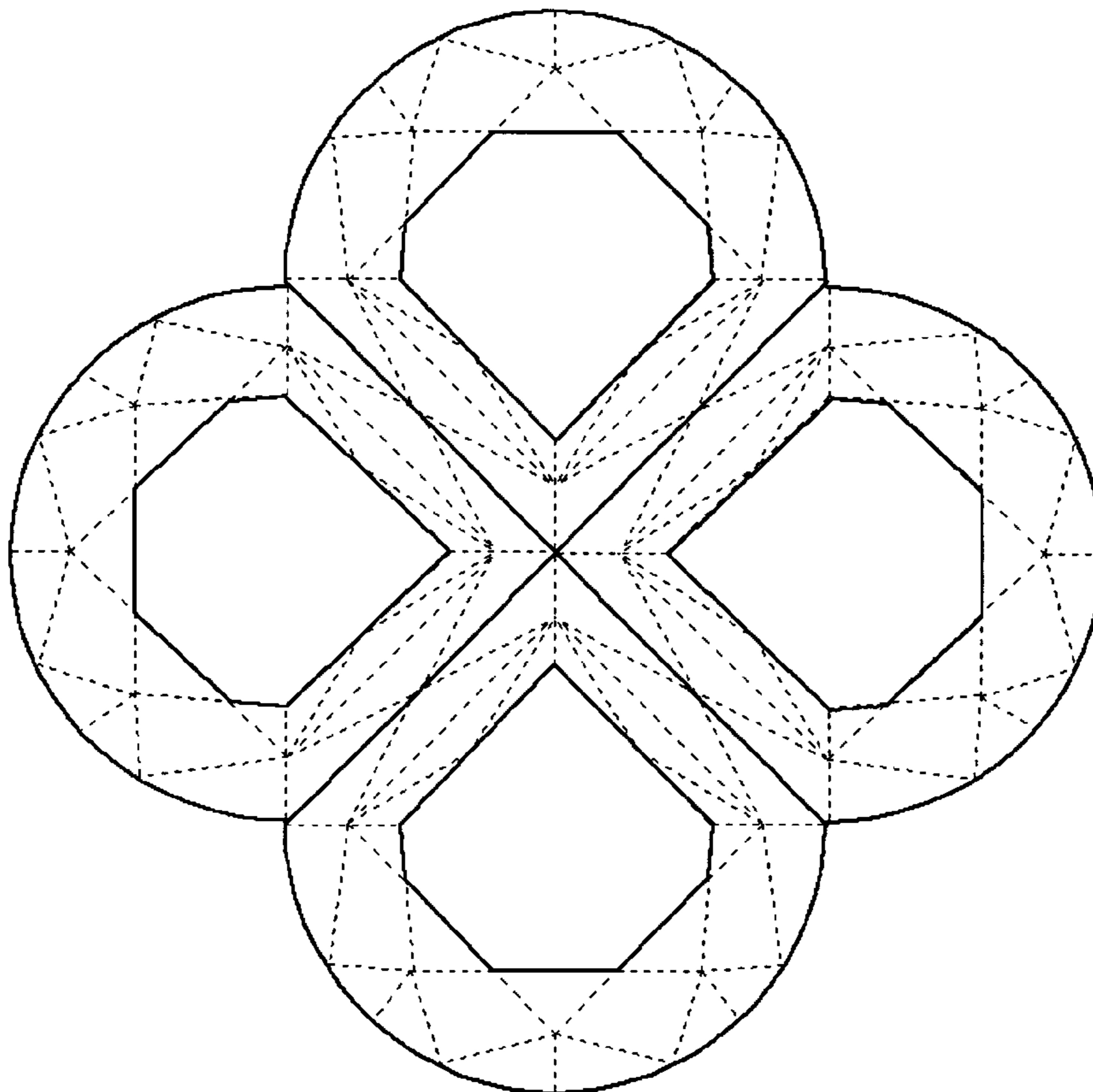
FIG. 1 is a top view of an embodiment of the invention.

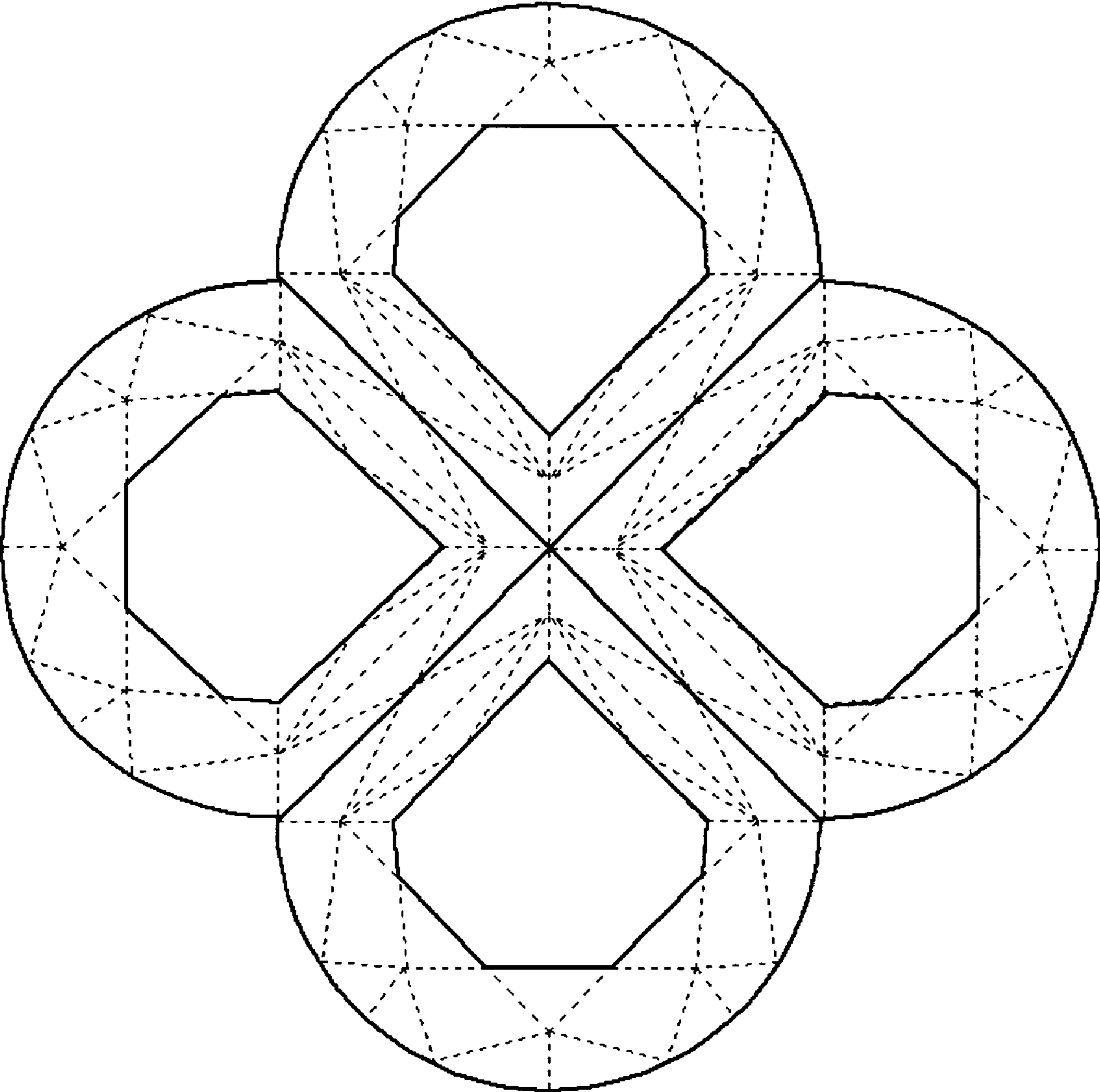
FIG. 2 is a bottom view thereof; and,

FIG. 3 is a side view thereof.

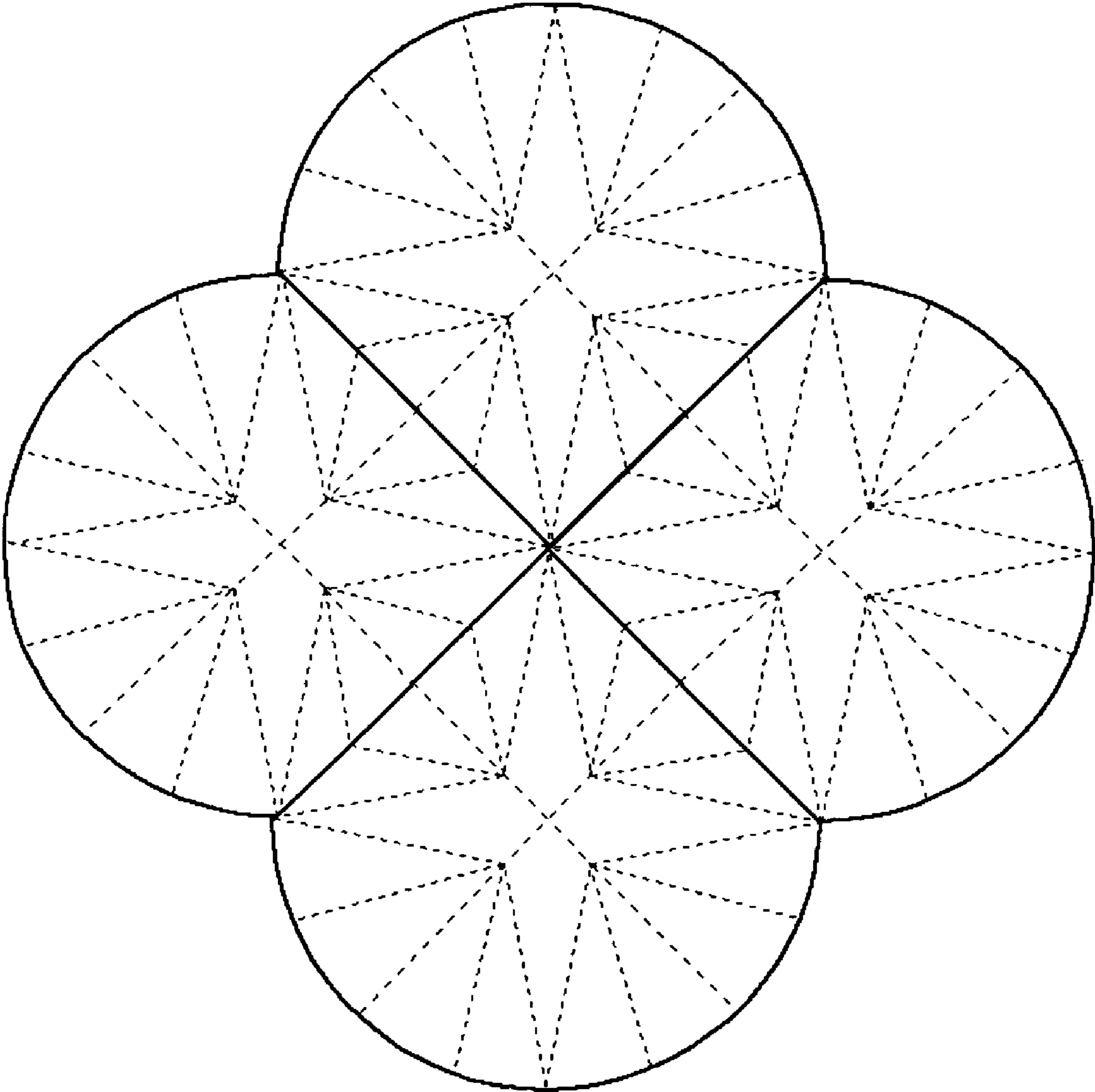
The features shown in broken lines in FIG. 1 depict environ-

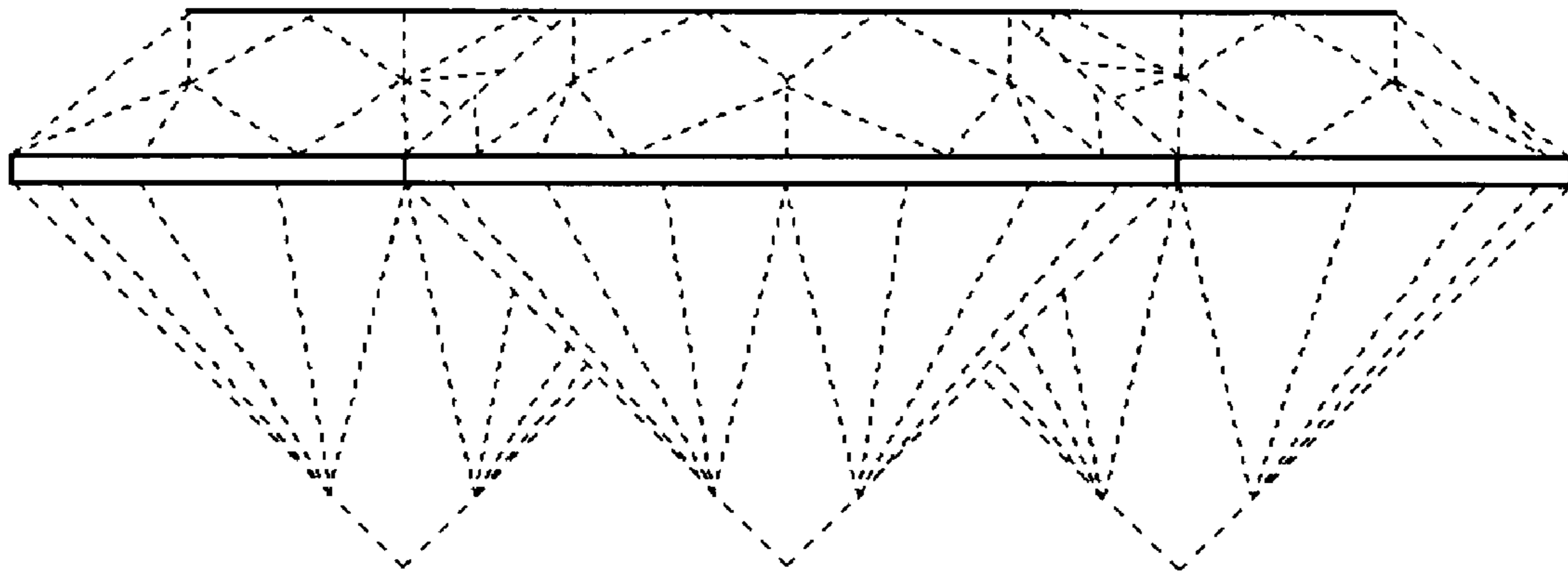
