The ornamental design for a front bumper for automobile, as shown and described.

DESCRIPTION

FIG. 3 is a top view thereof;

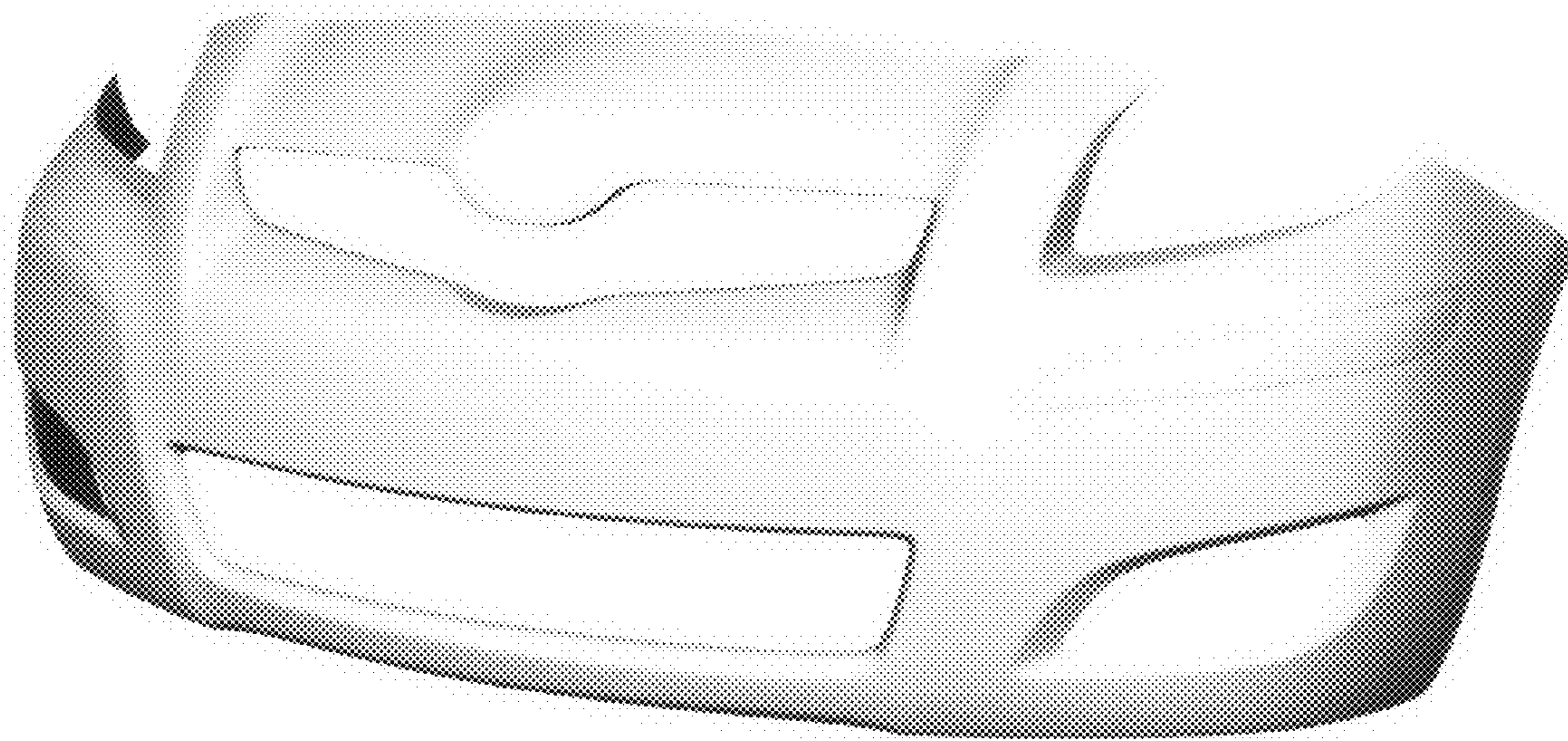
FIG. 4 is a bottom view thereof;

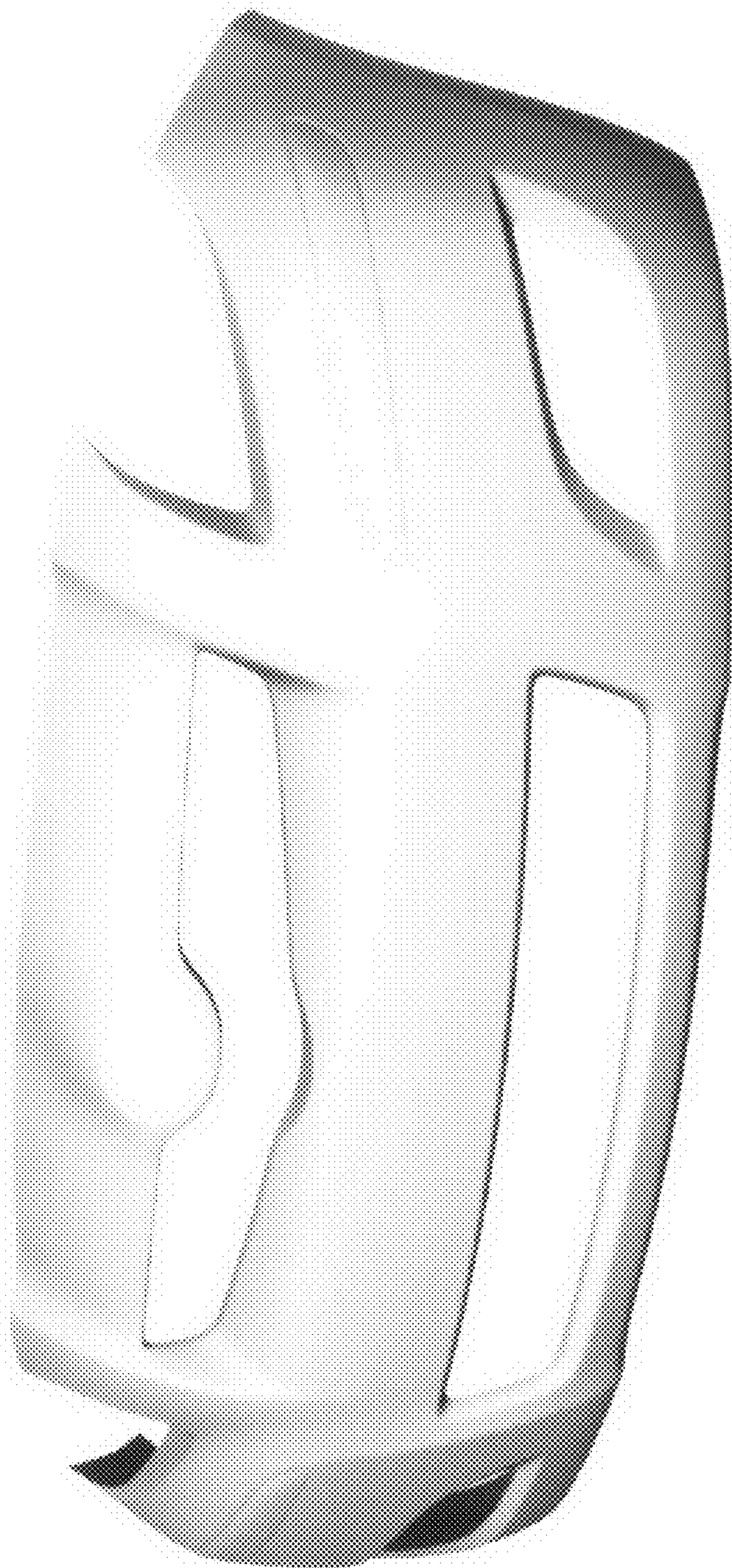

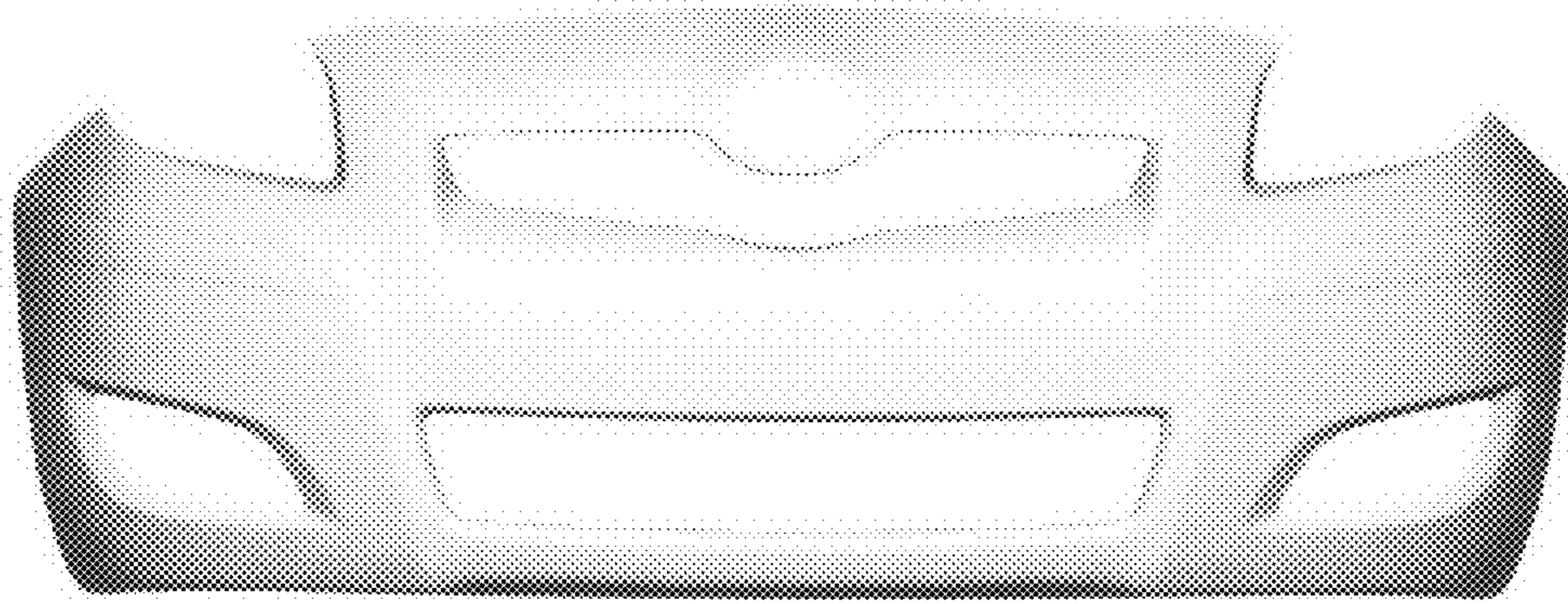

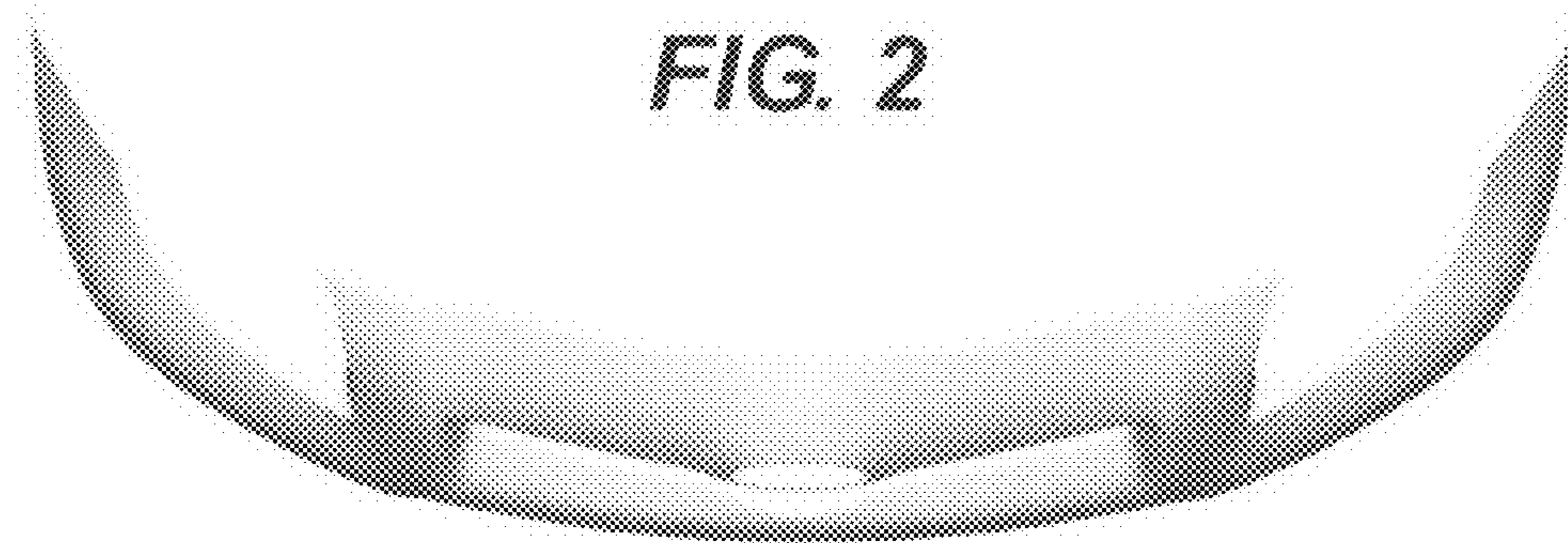

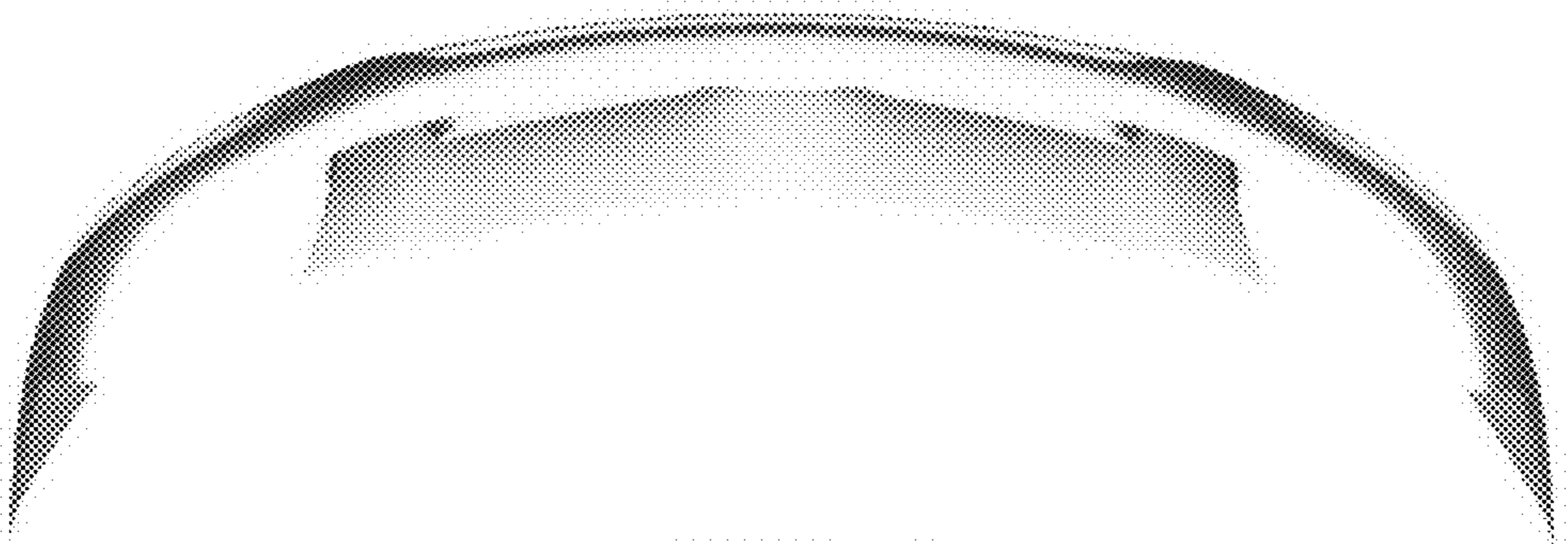

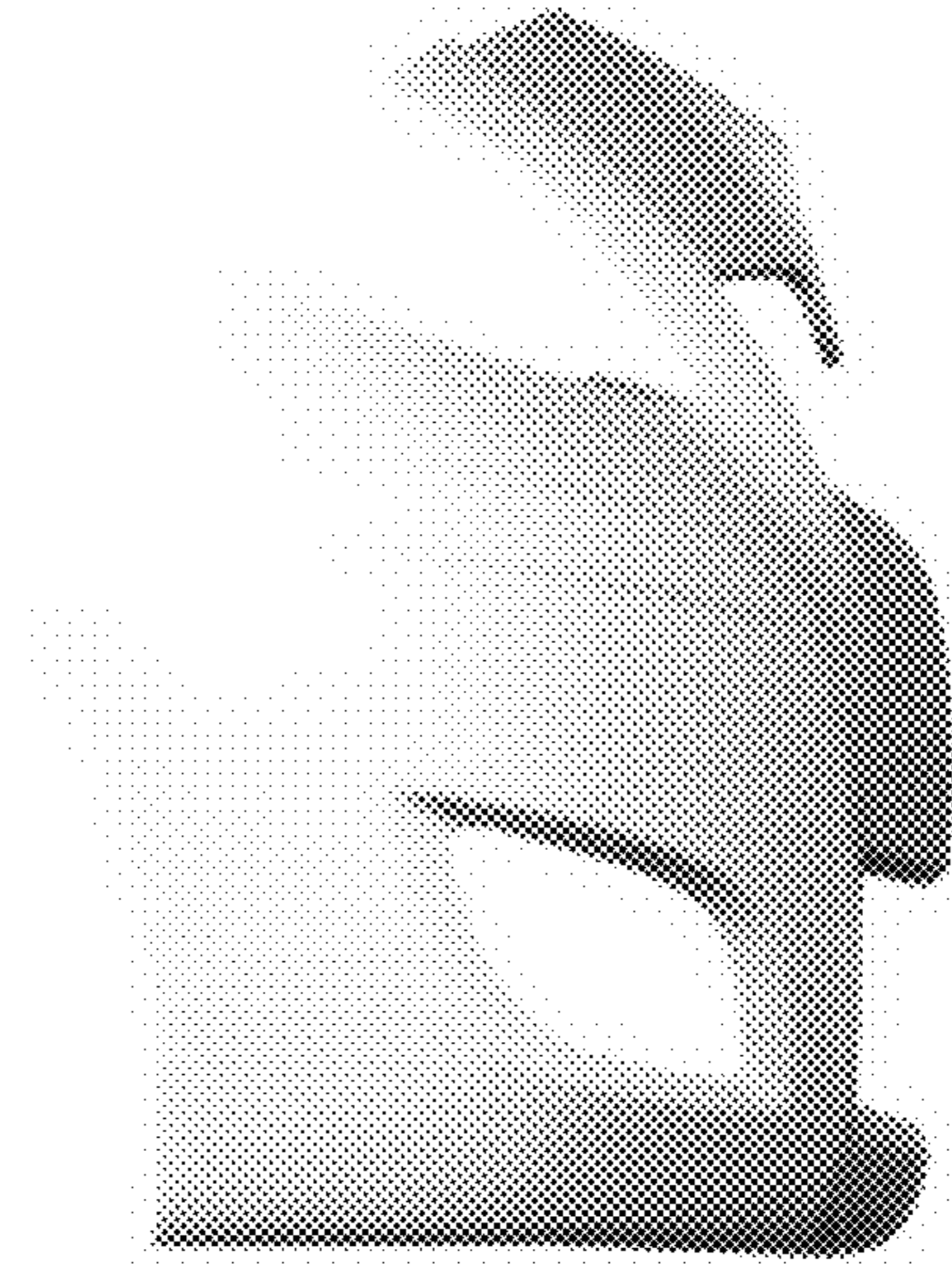

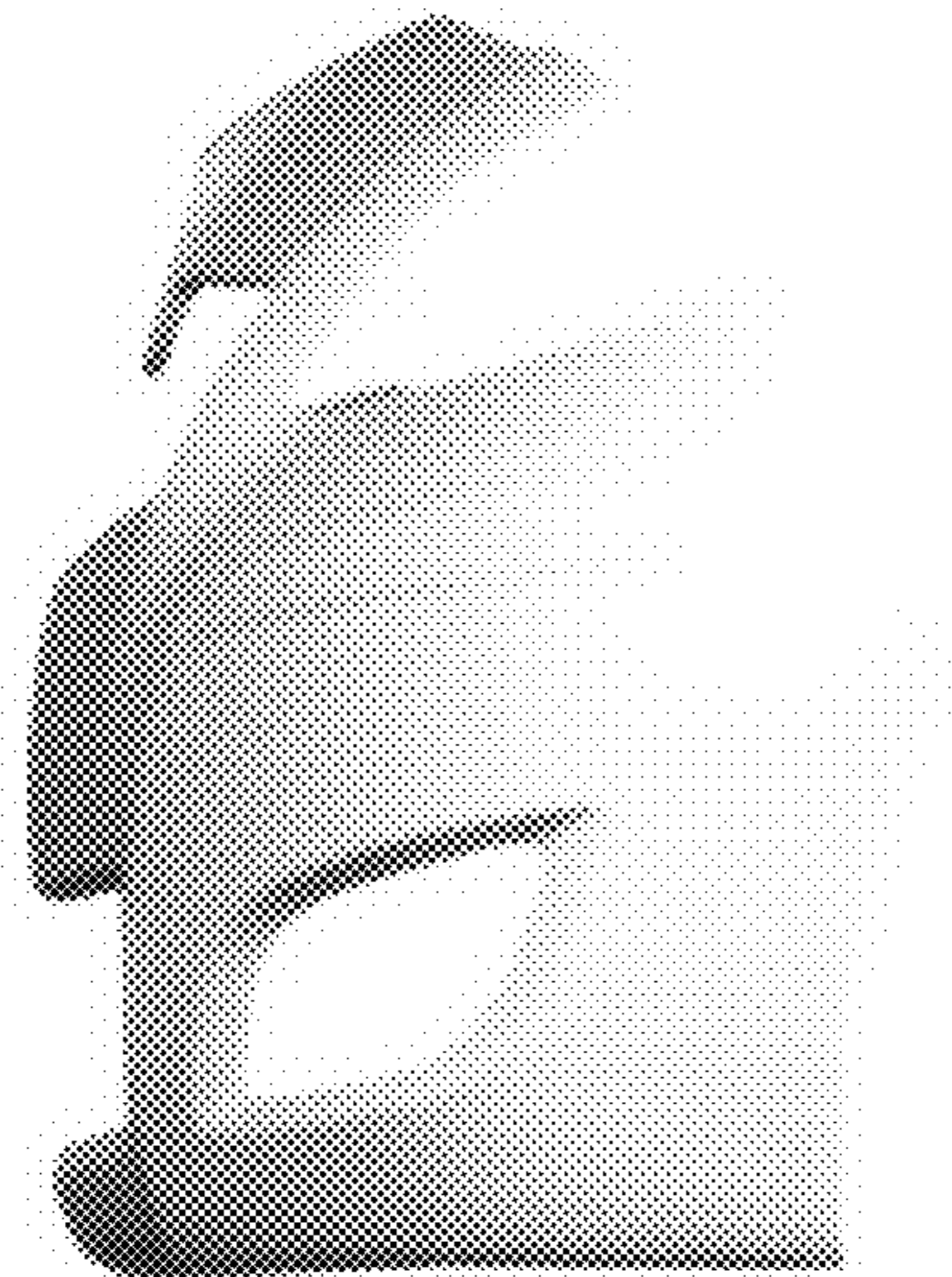
