 FIG. 25 is a front elevational view of a fifth embodiment of an adaptor for power tools of the design;

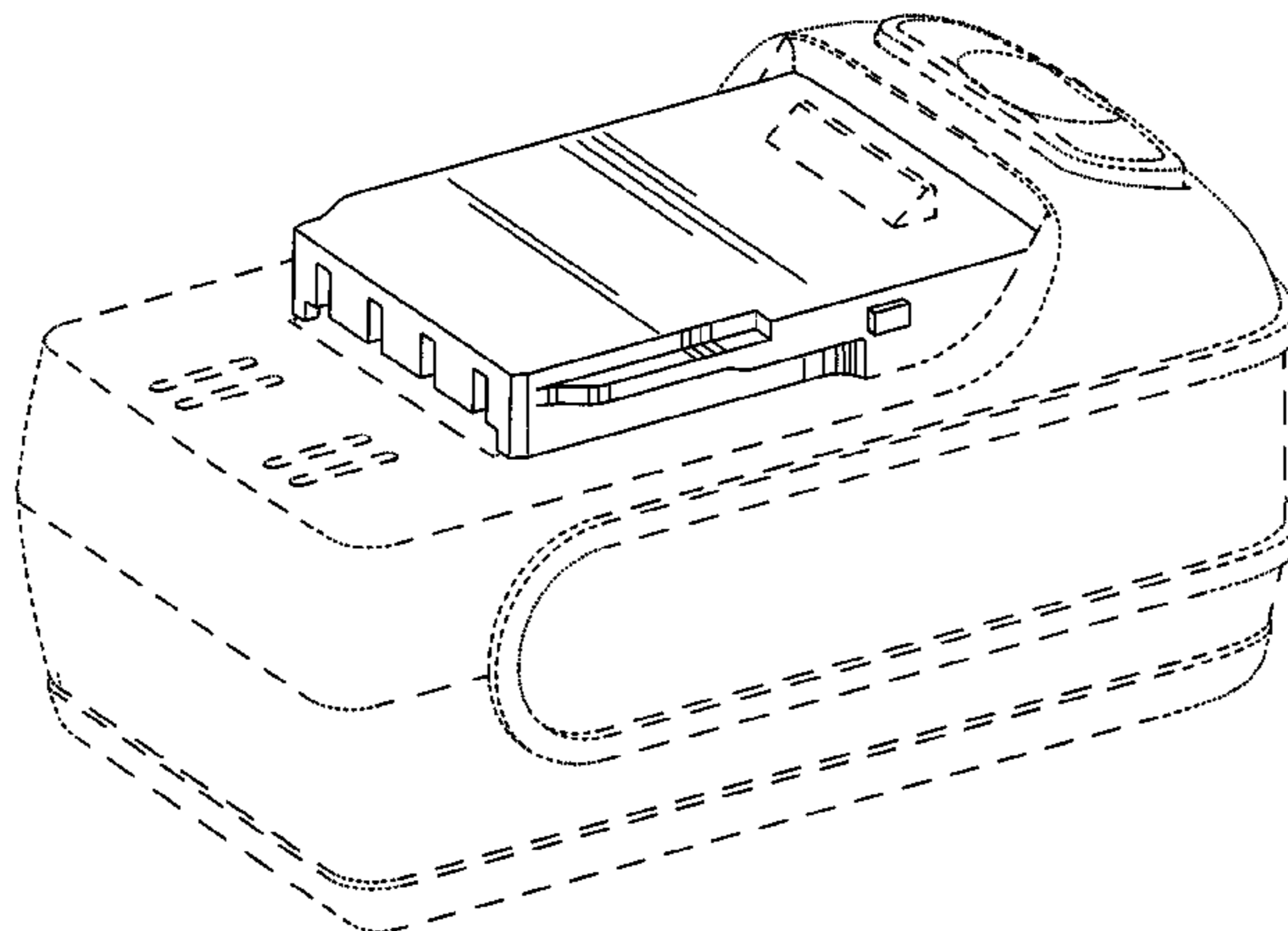


FIG. 26 is a rear elevational view thereof;

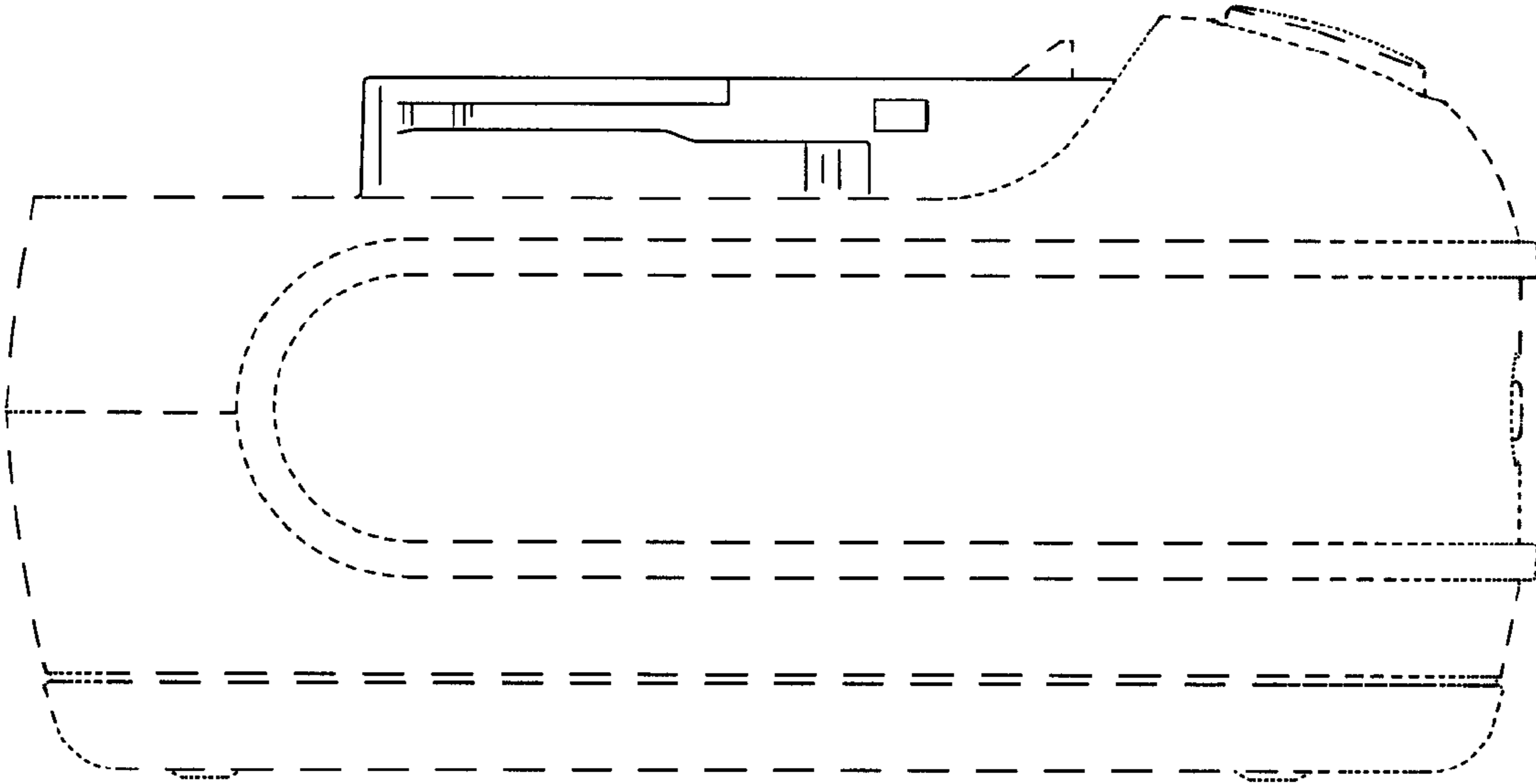

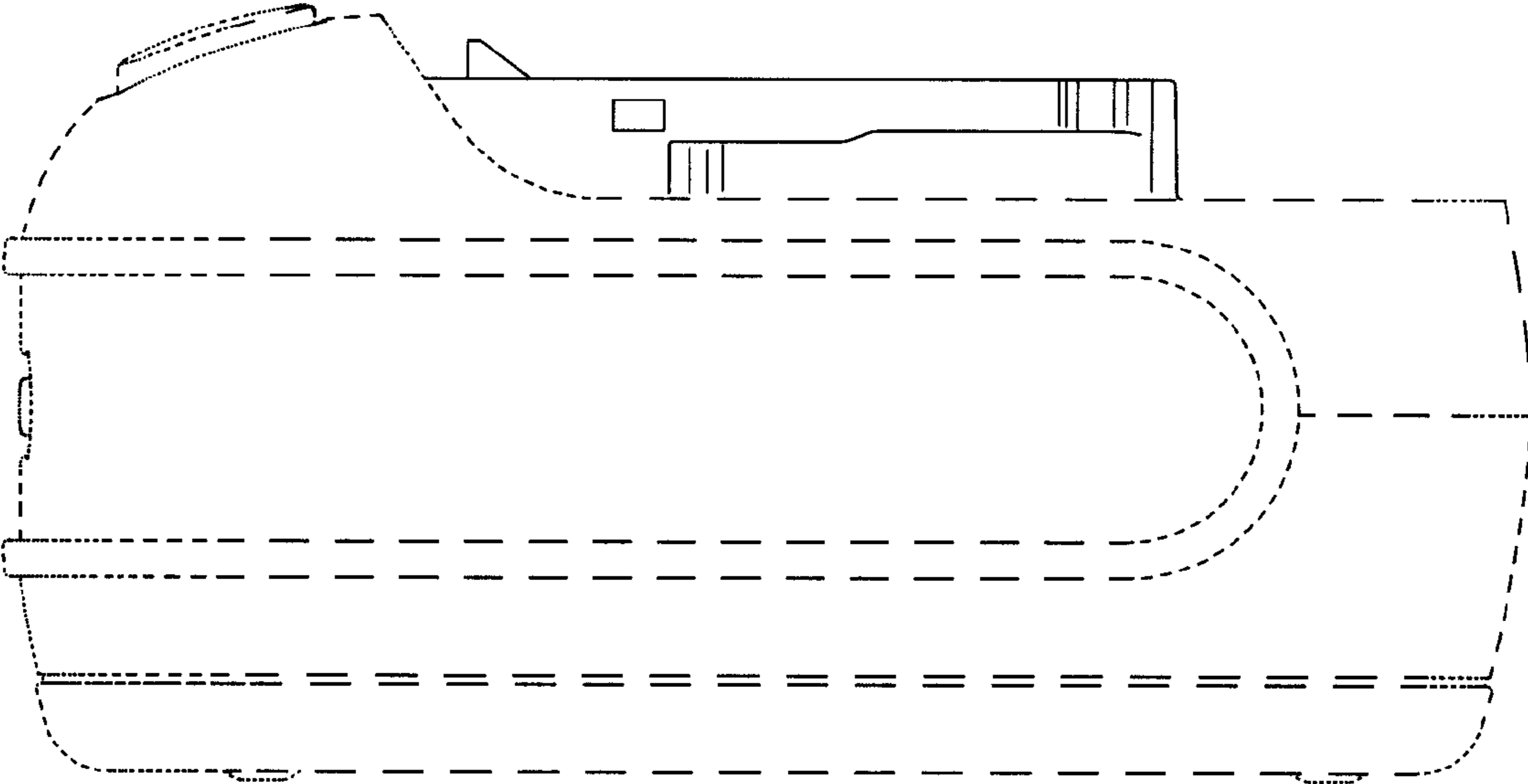

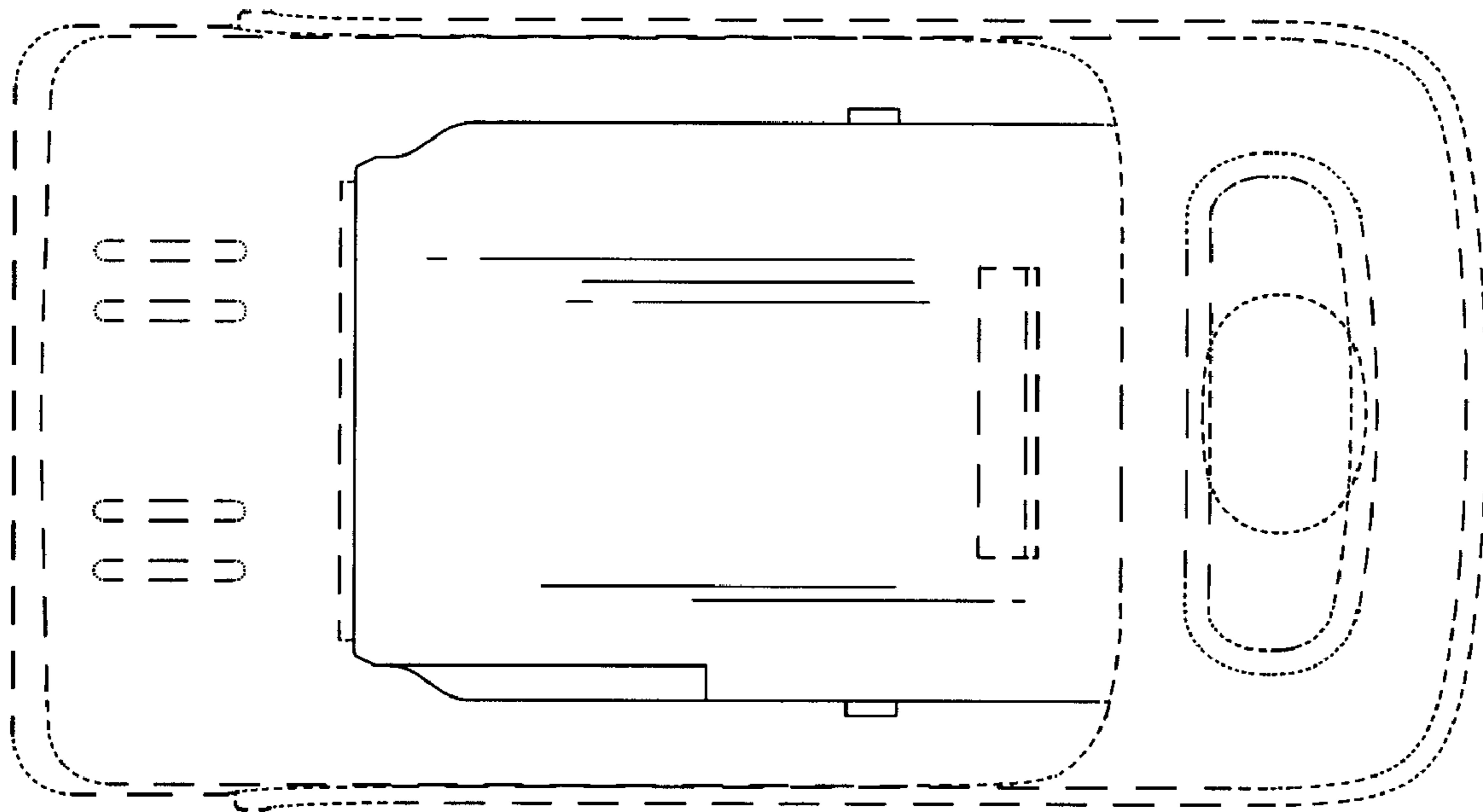

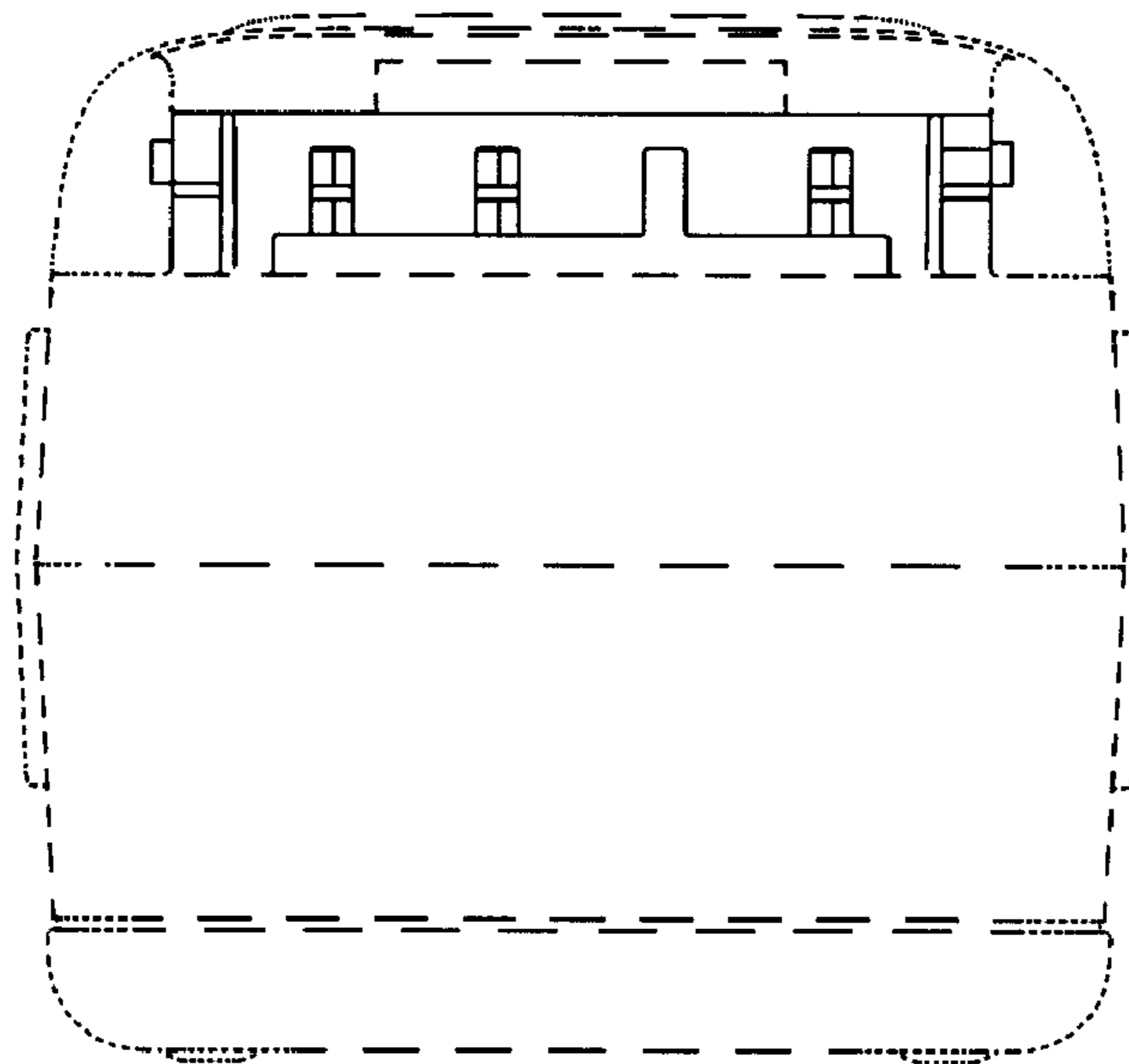

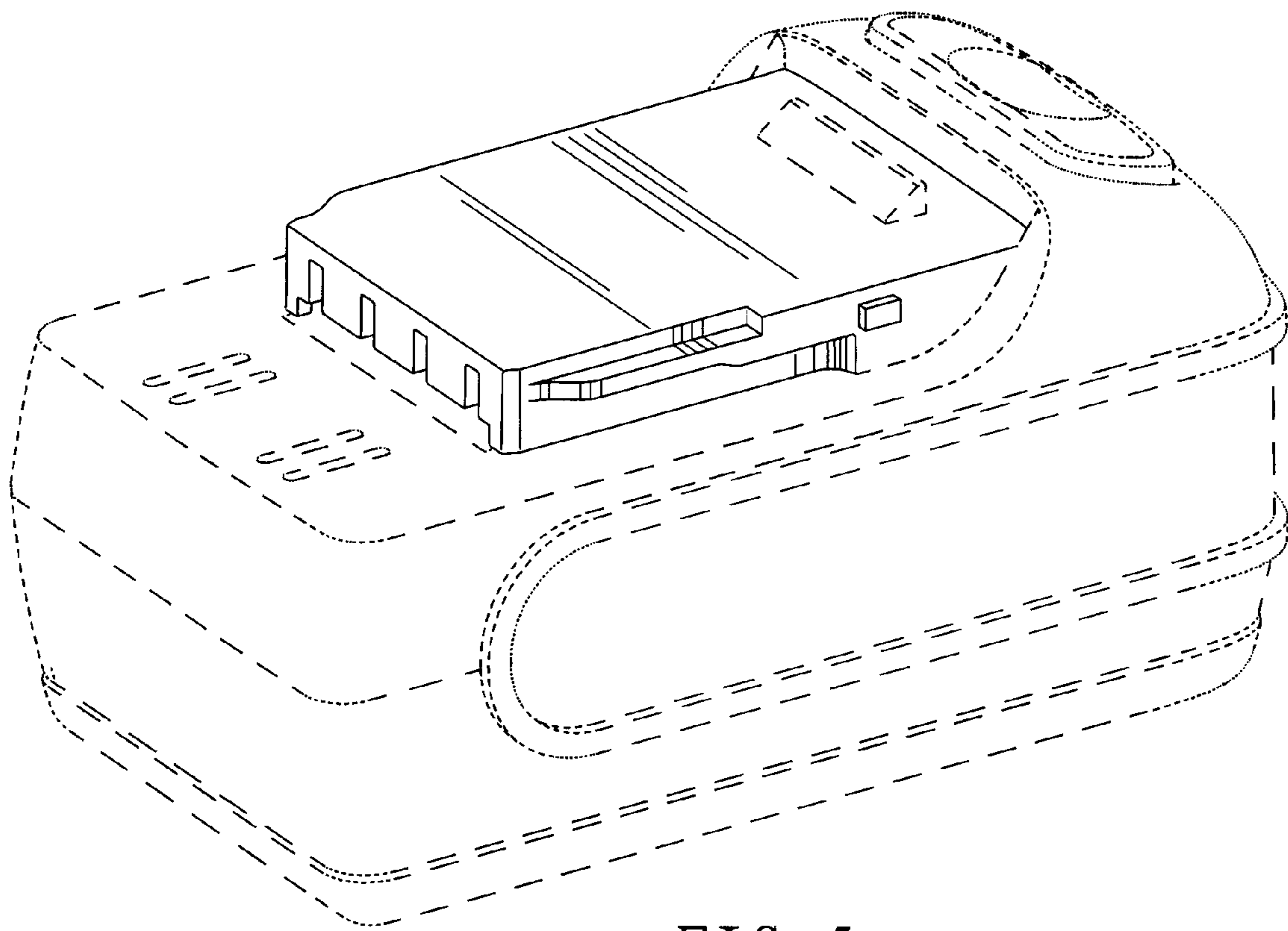

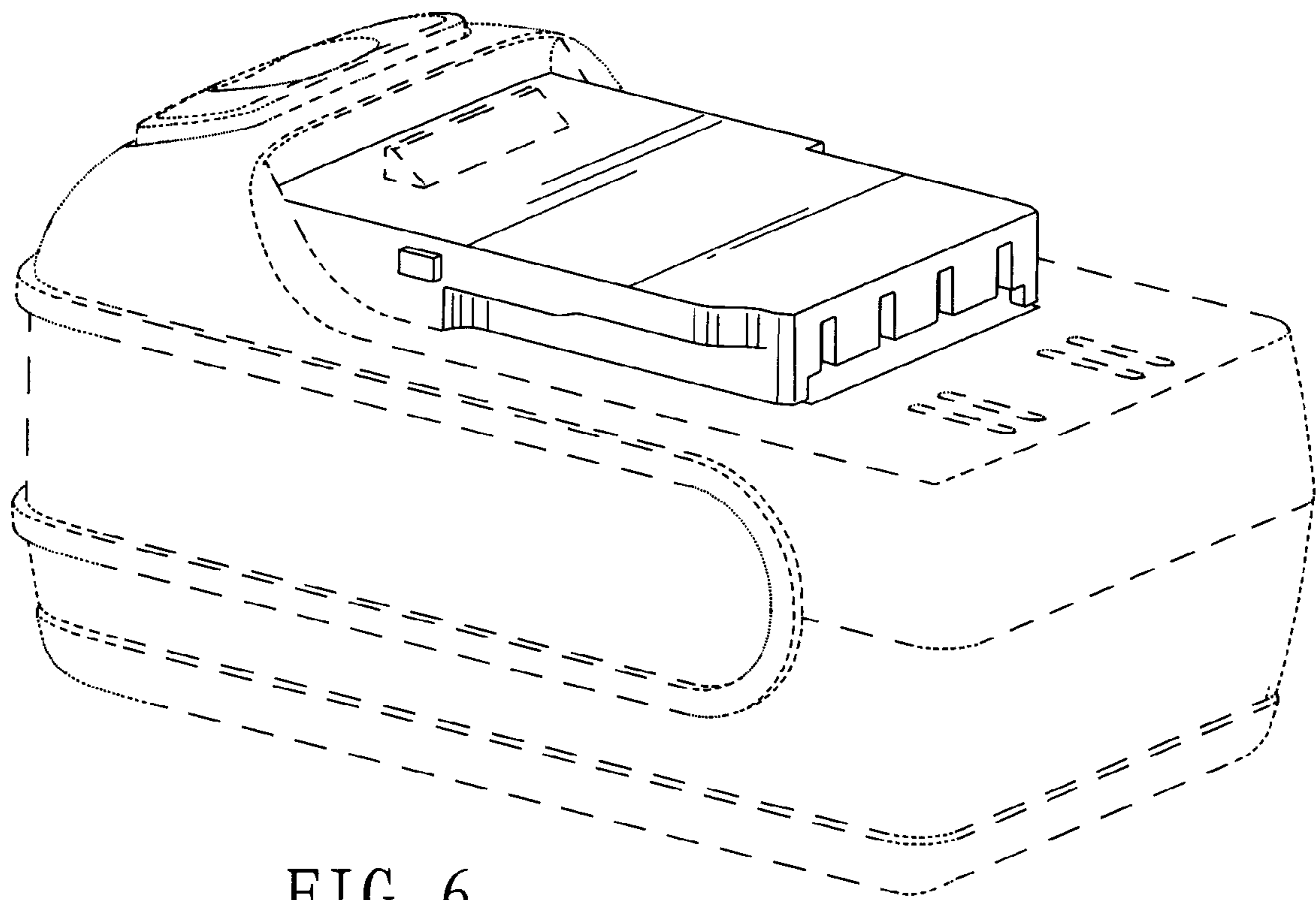

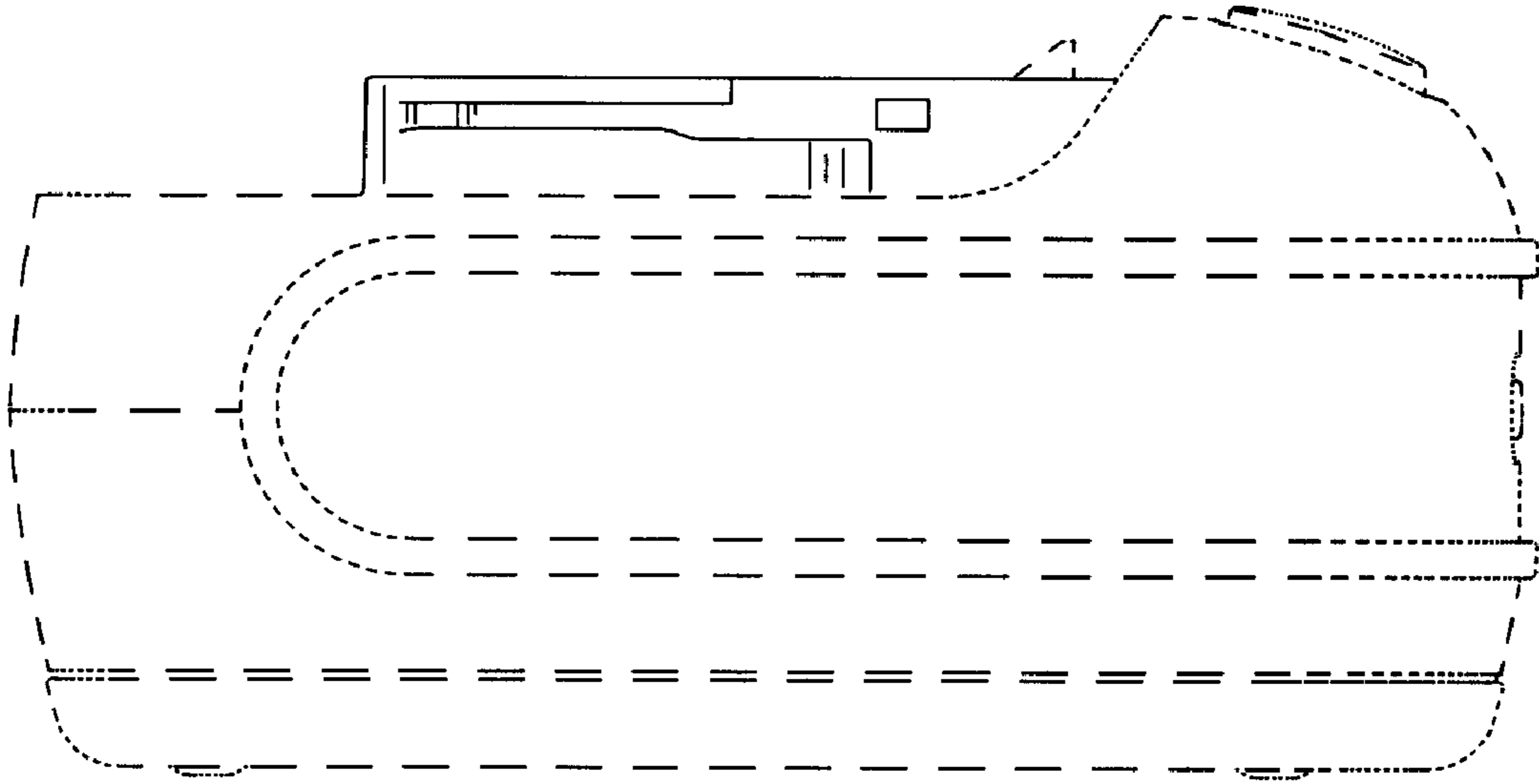

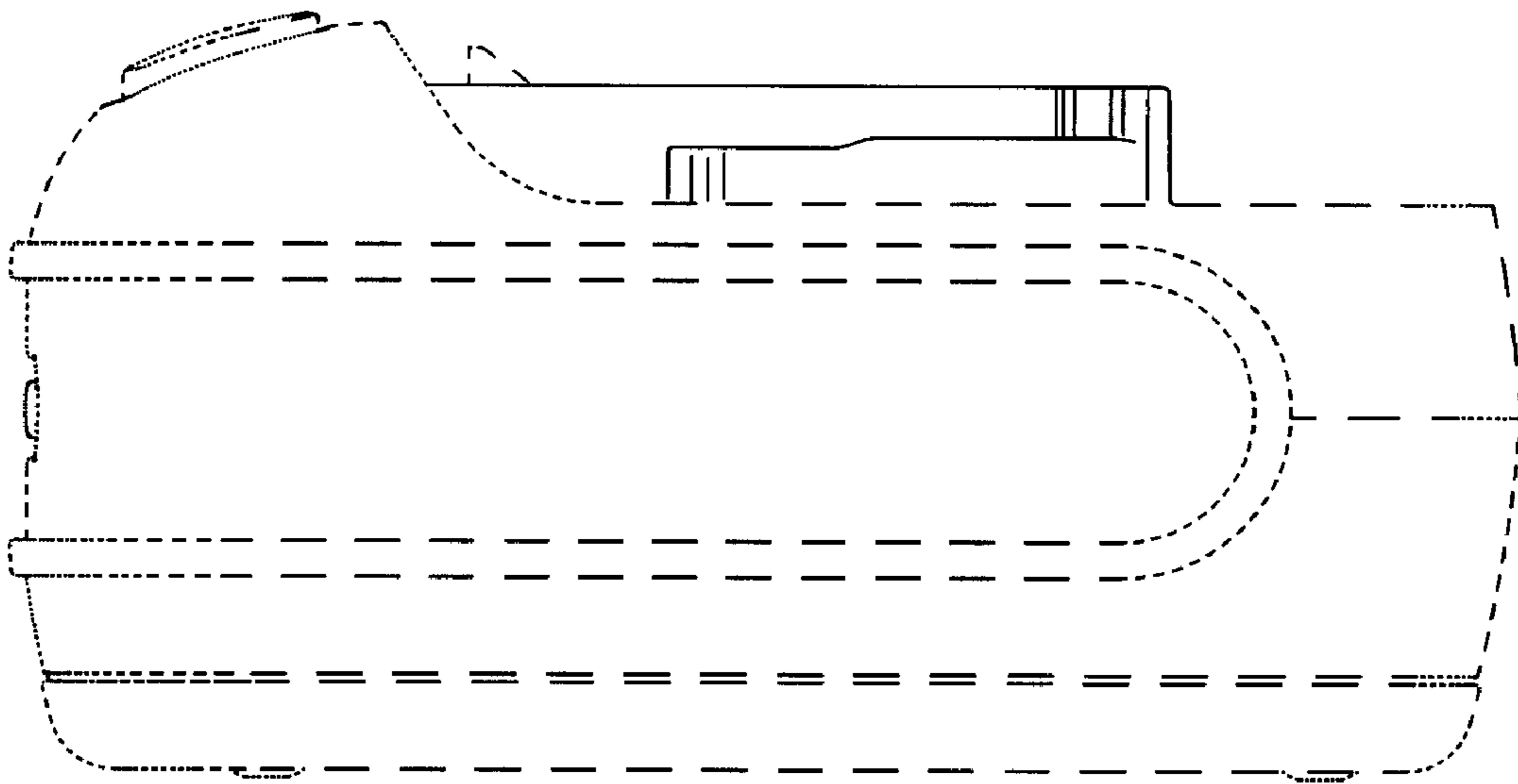

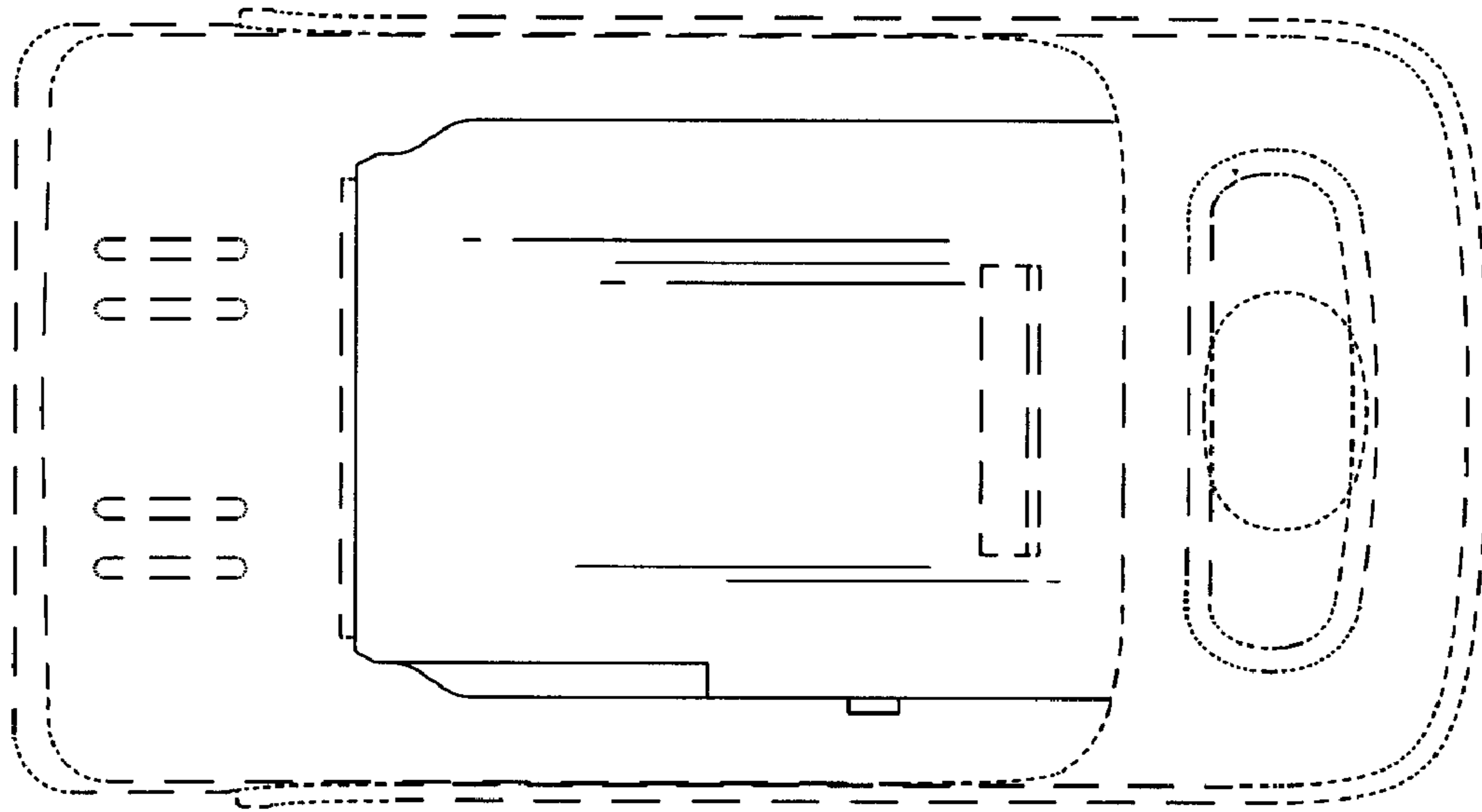

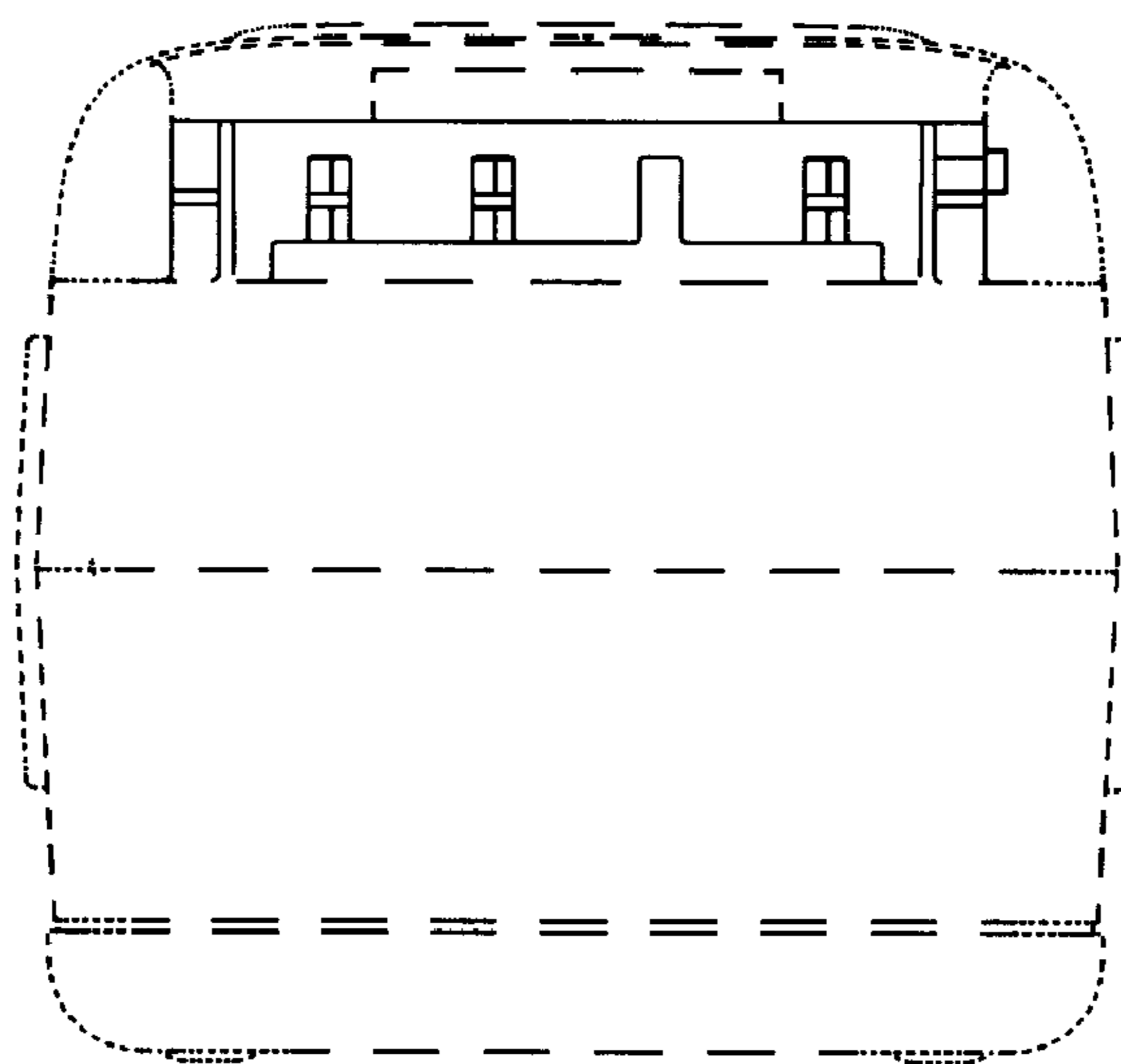

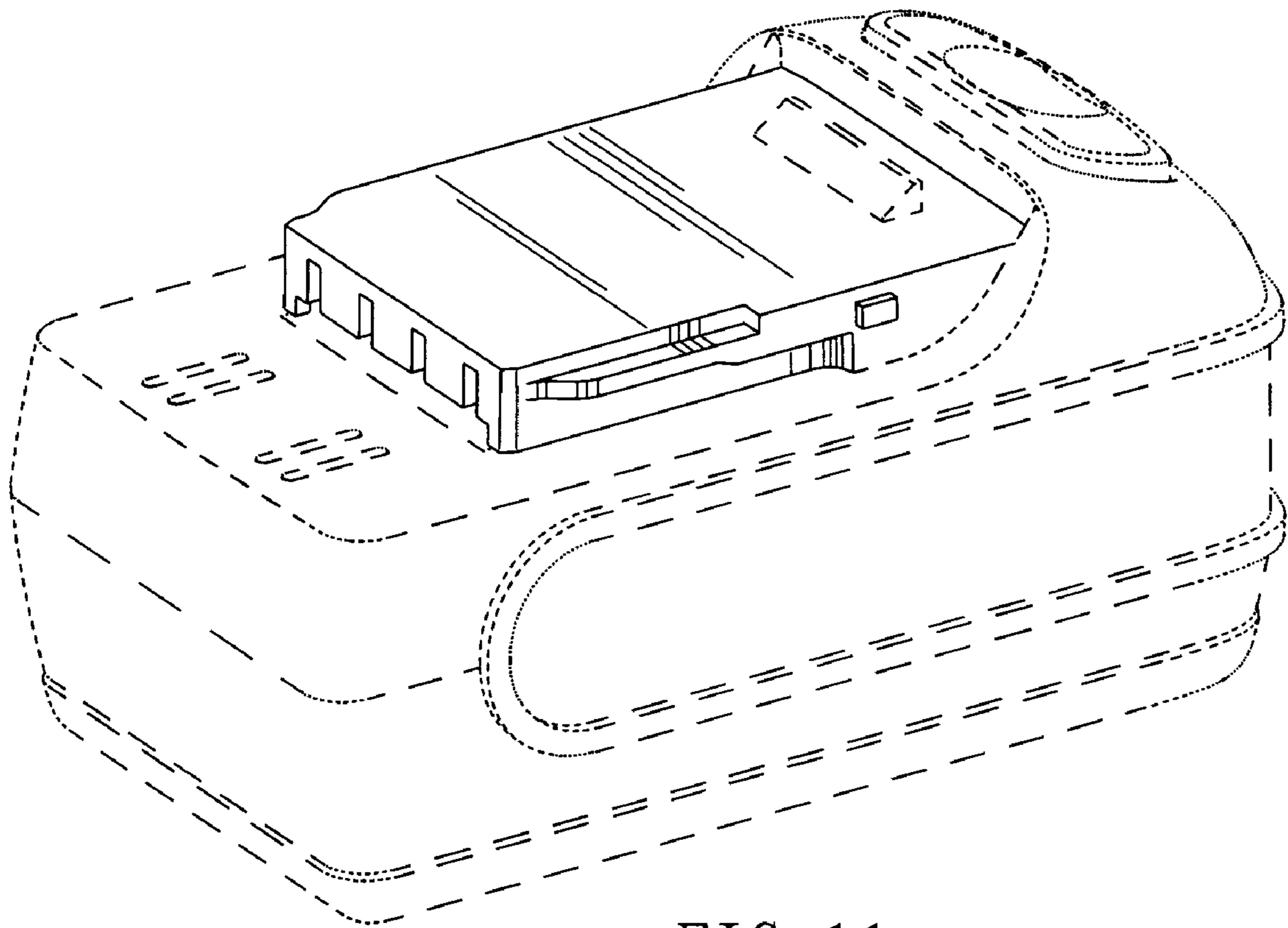

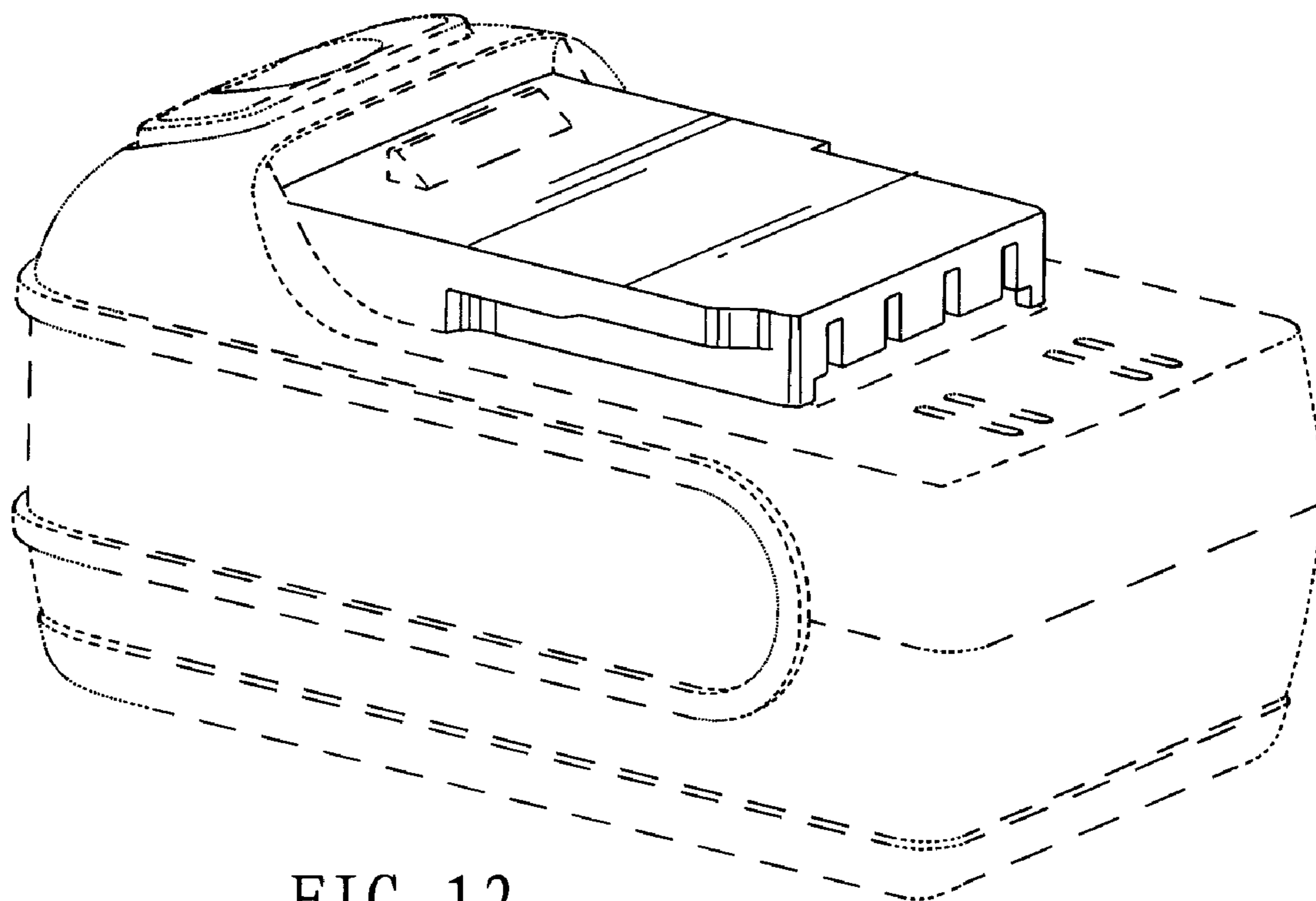

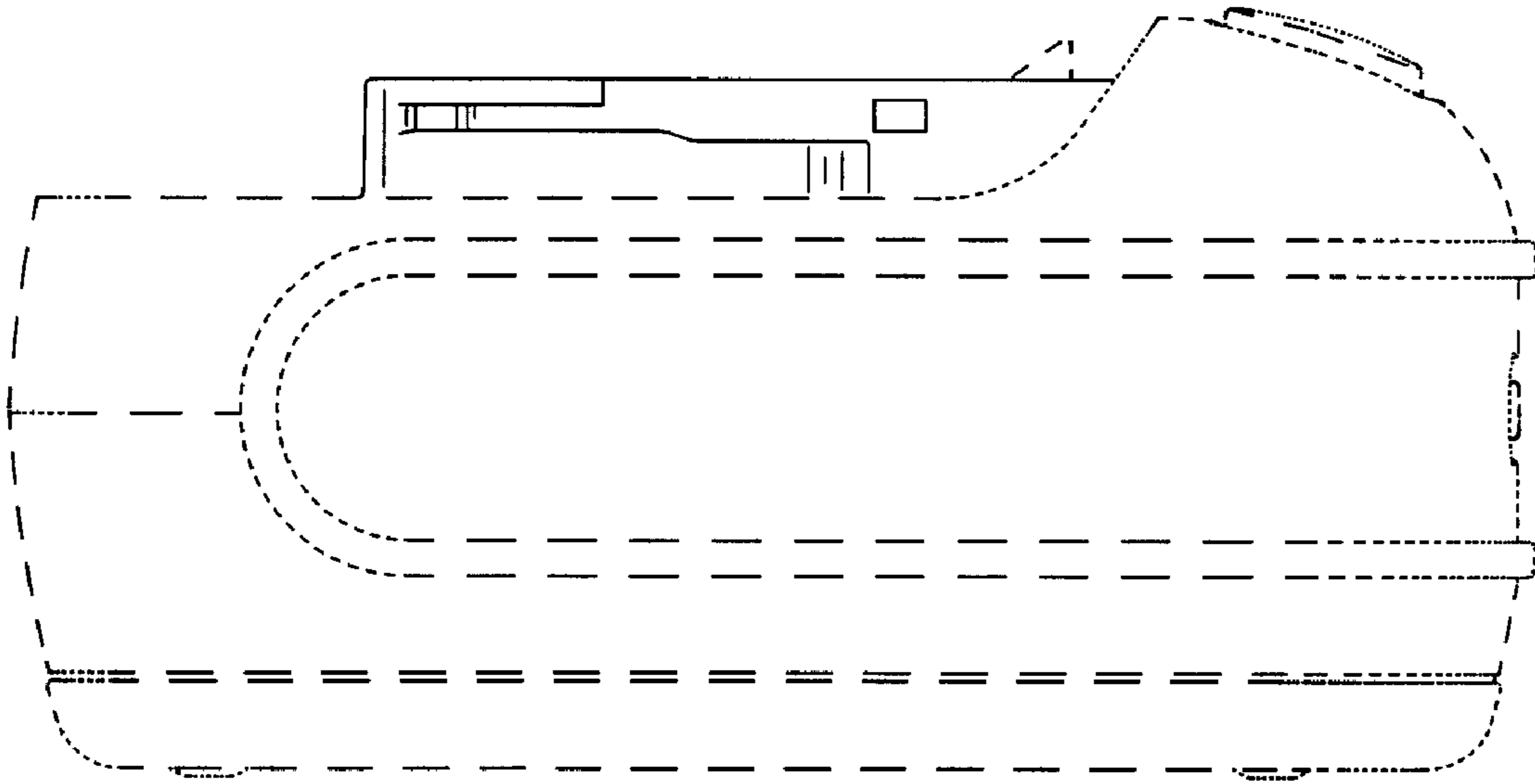

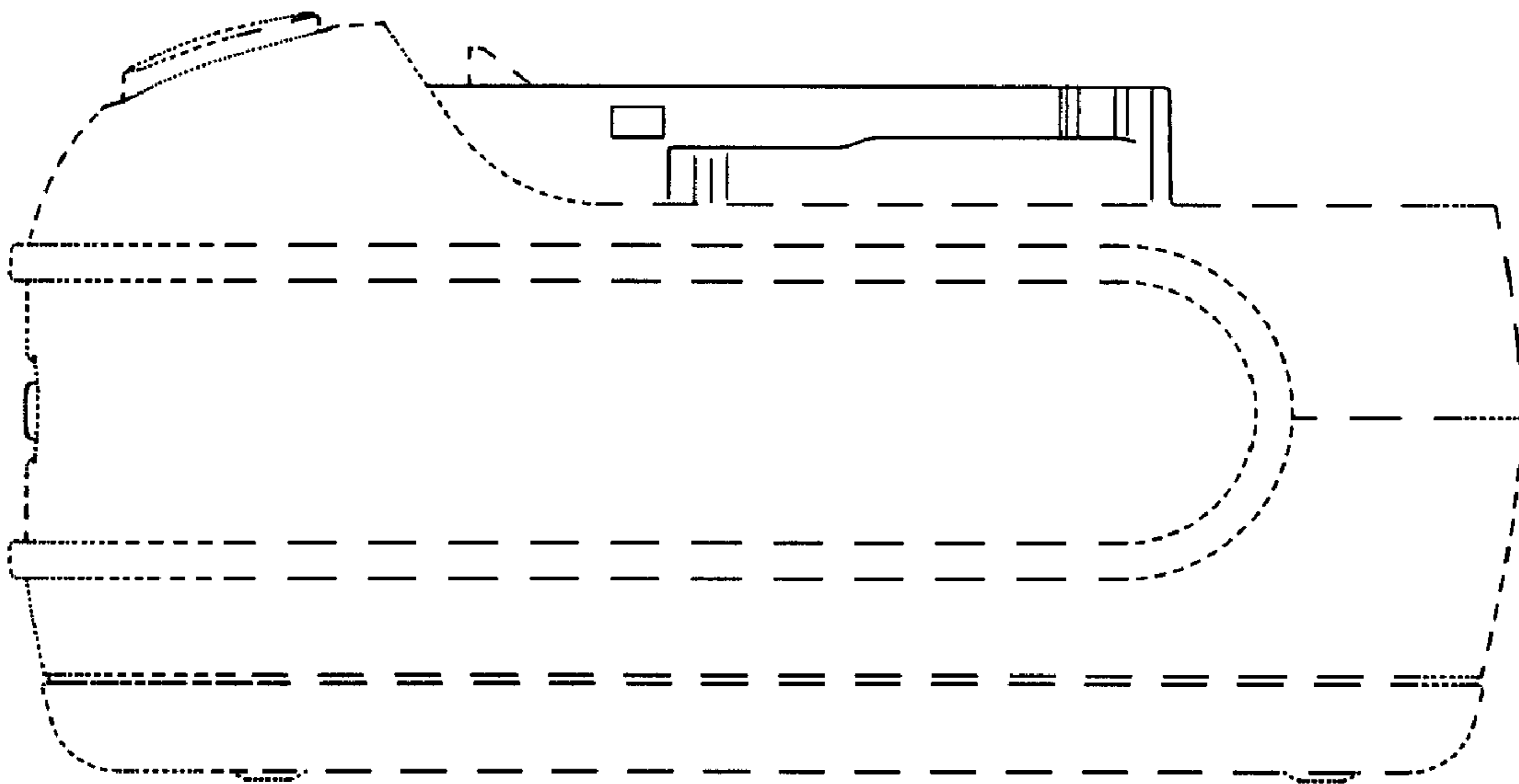

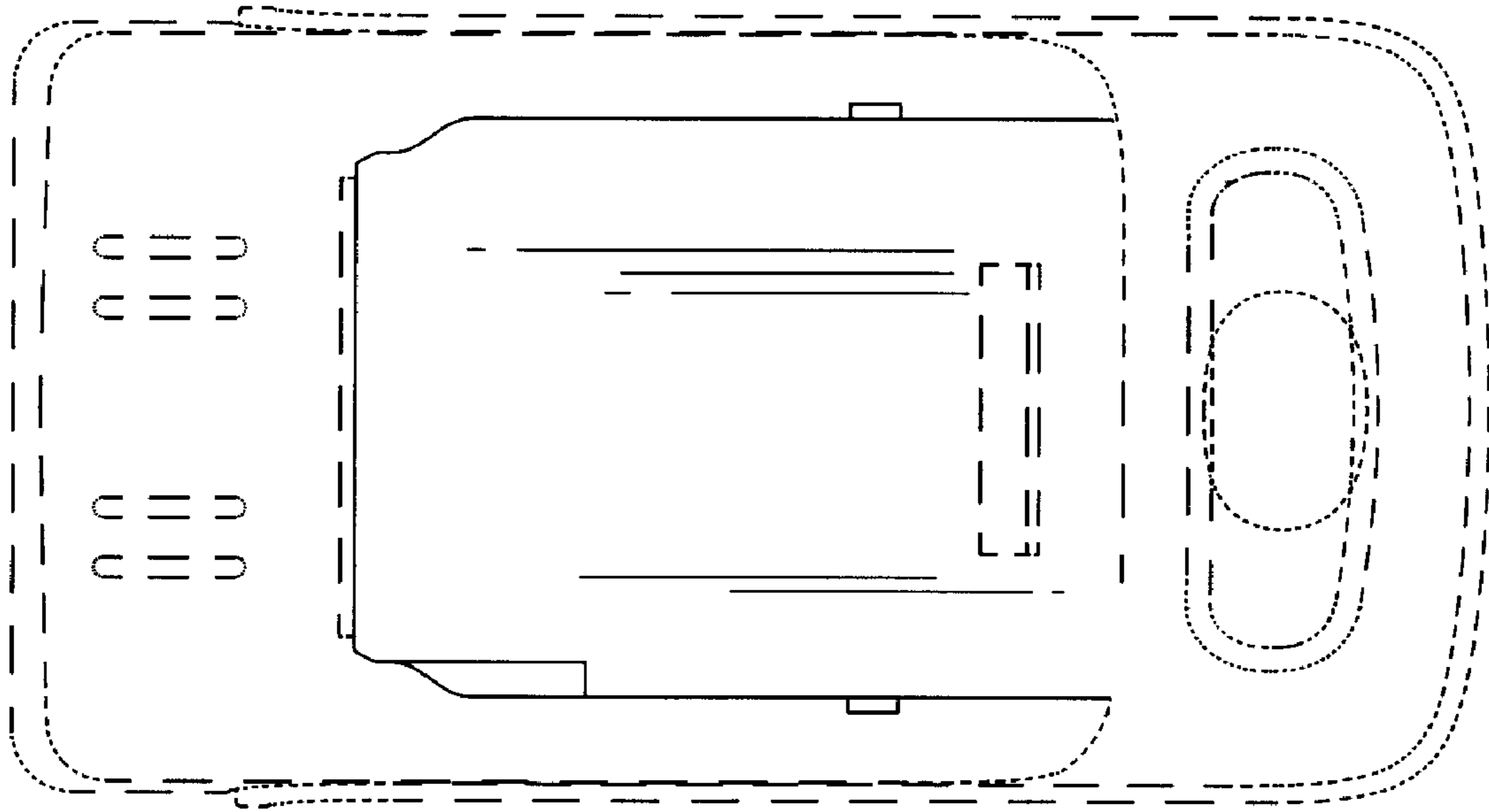

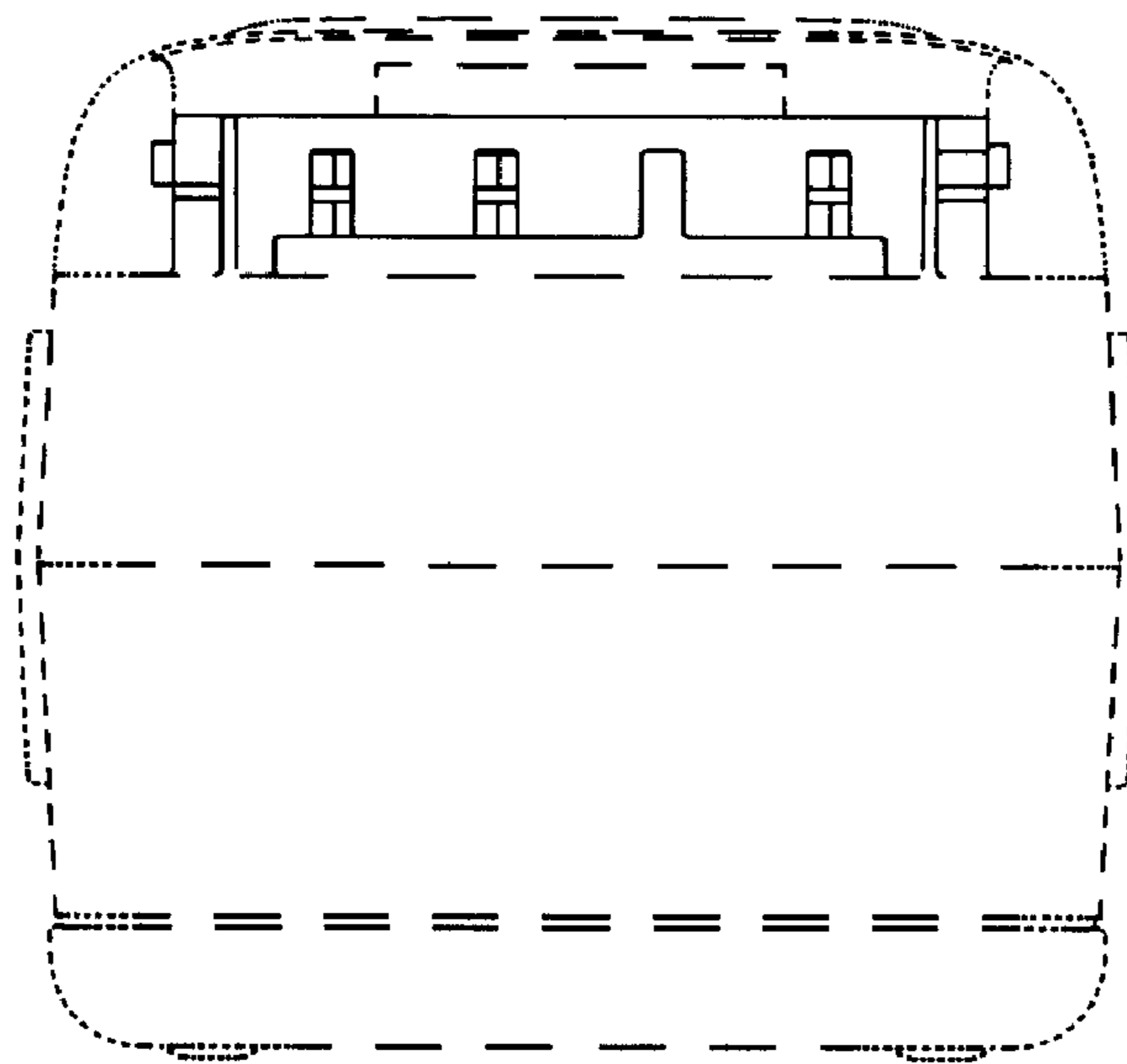

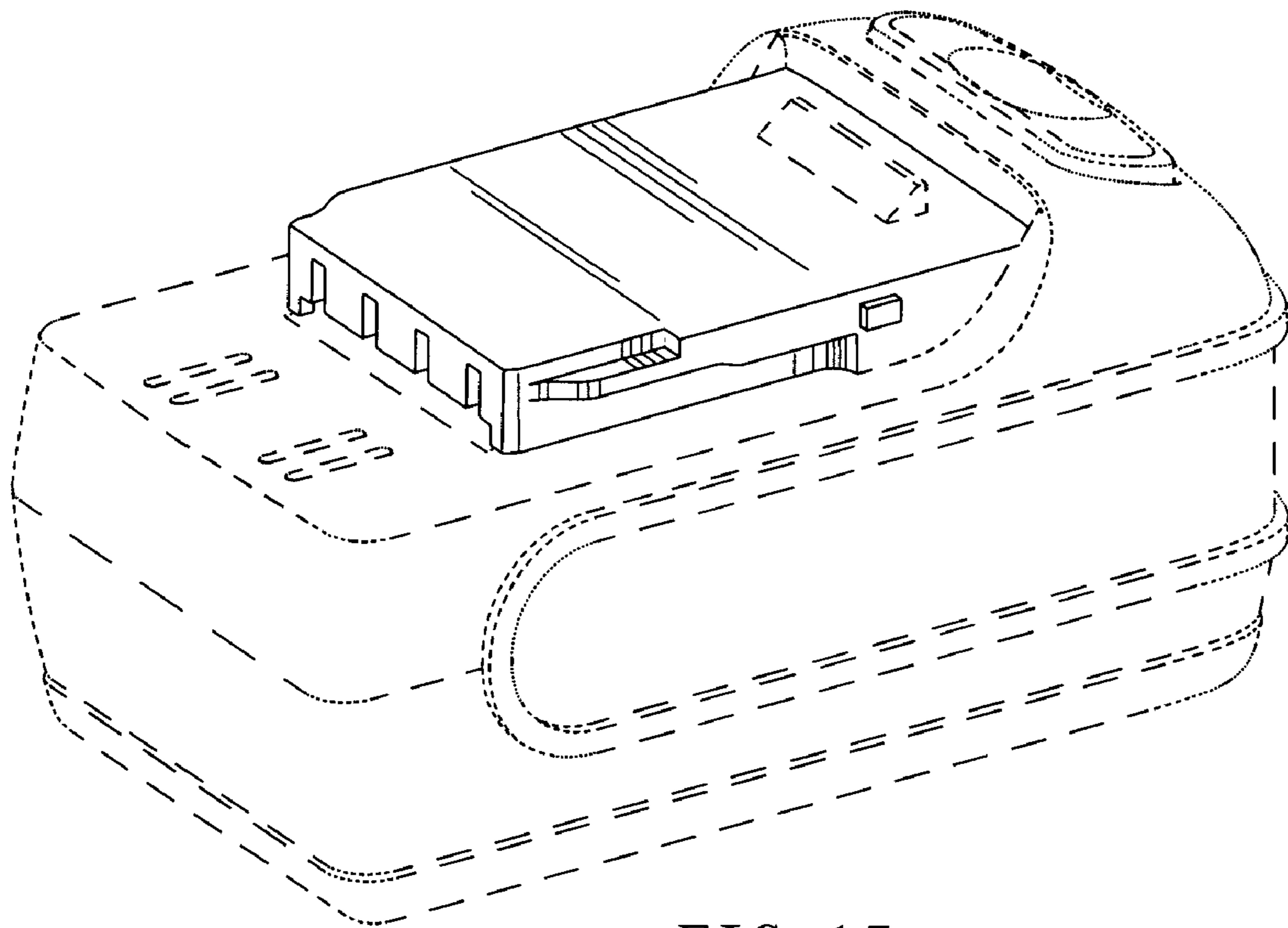

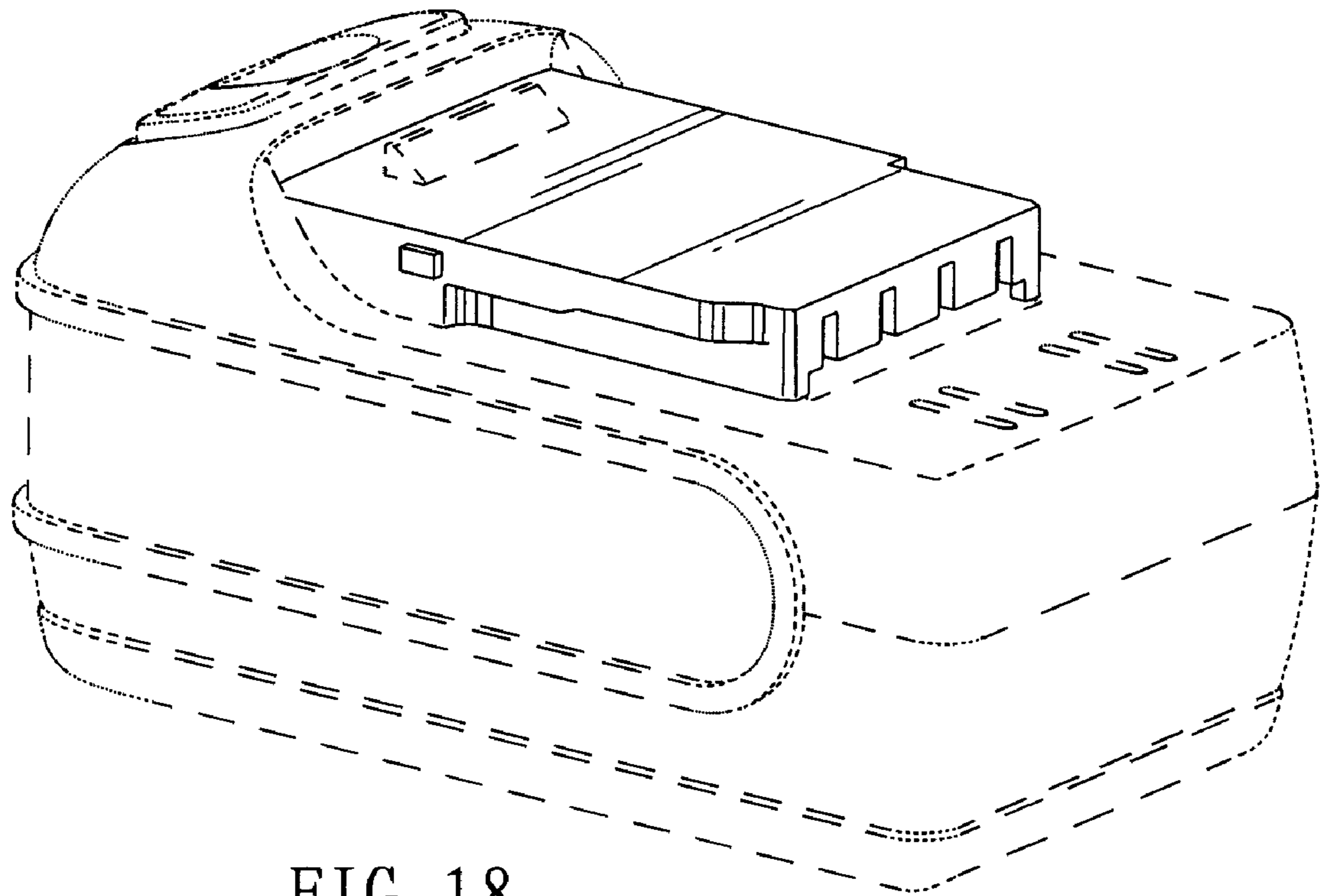

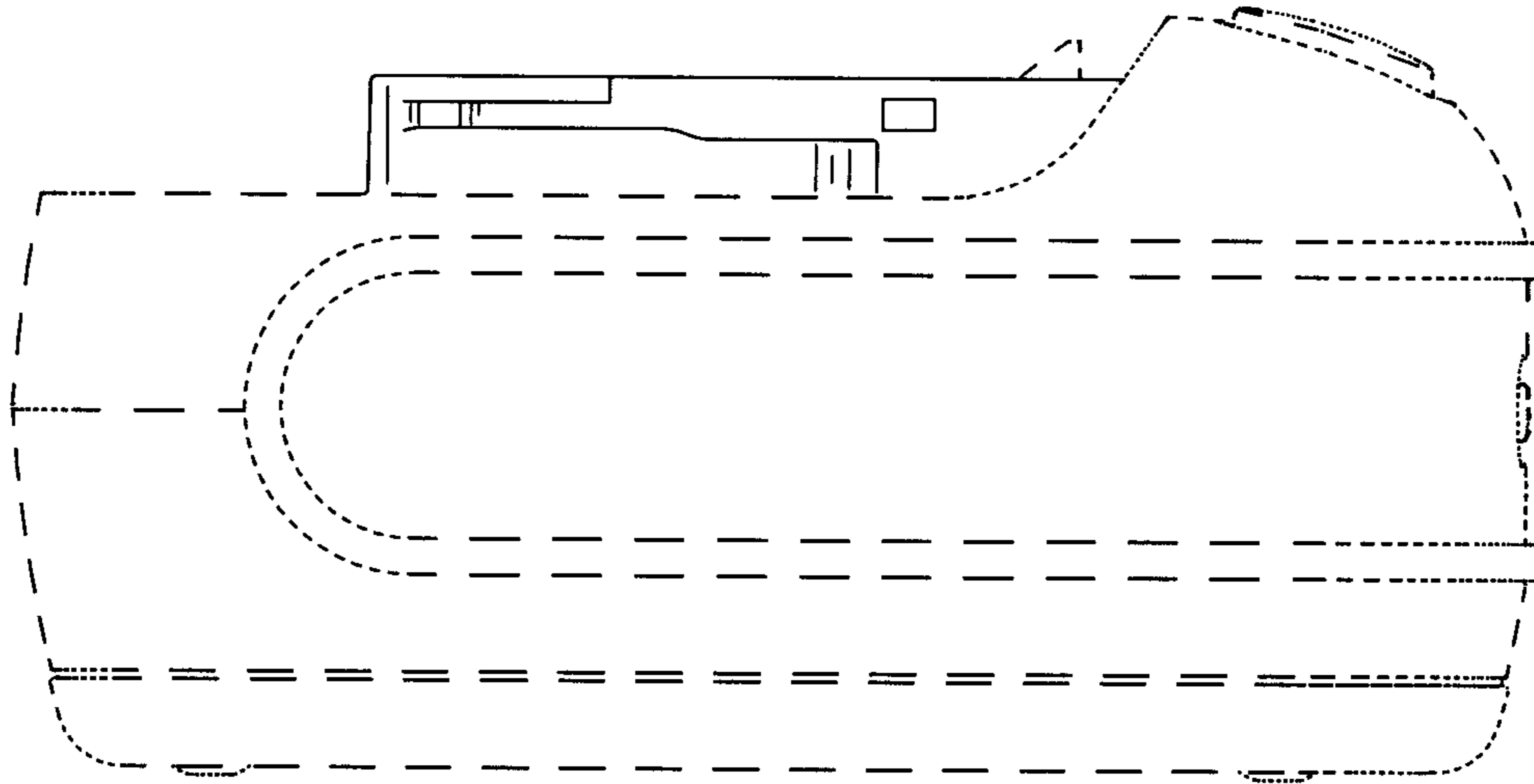

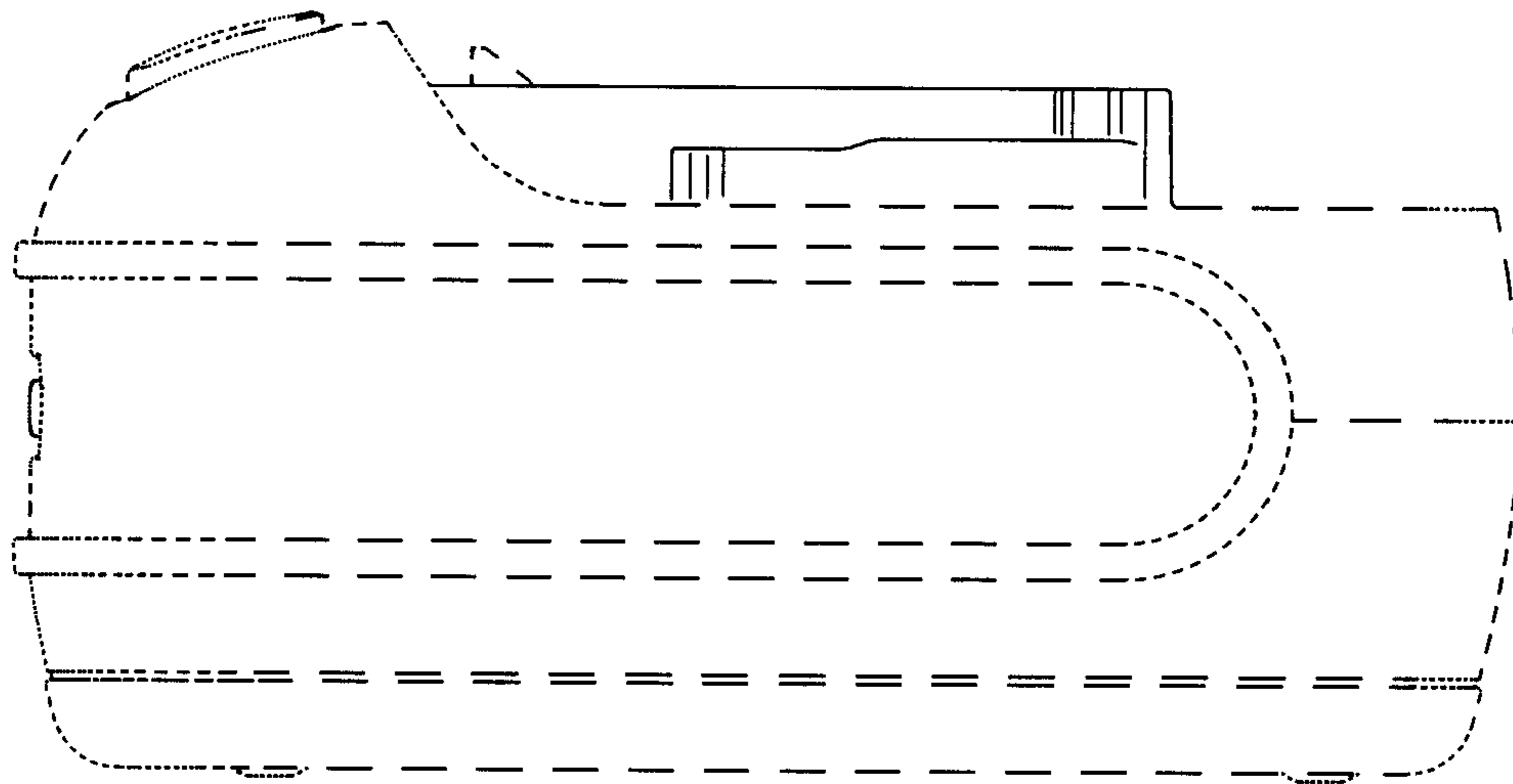

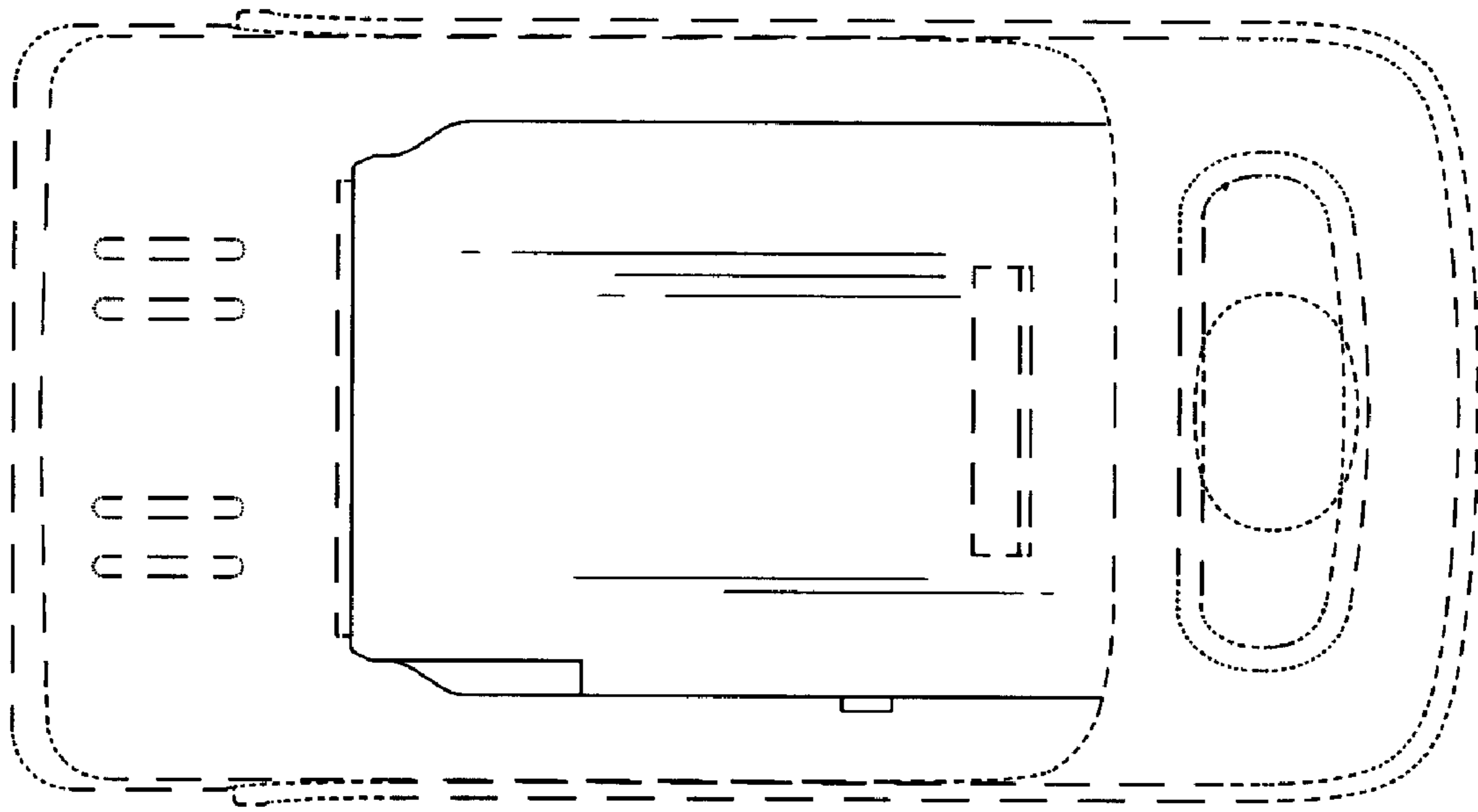

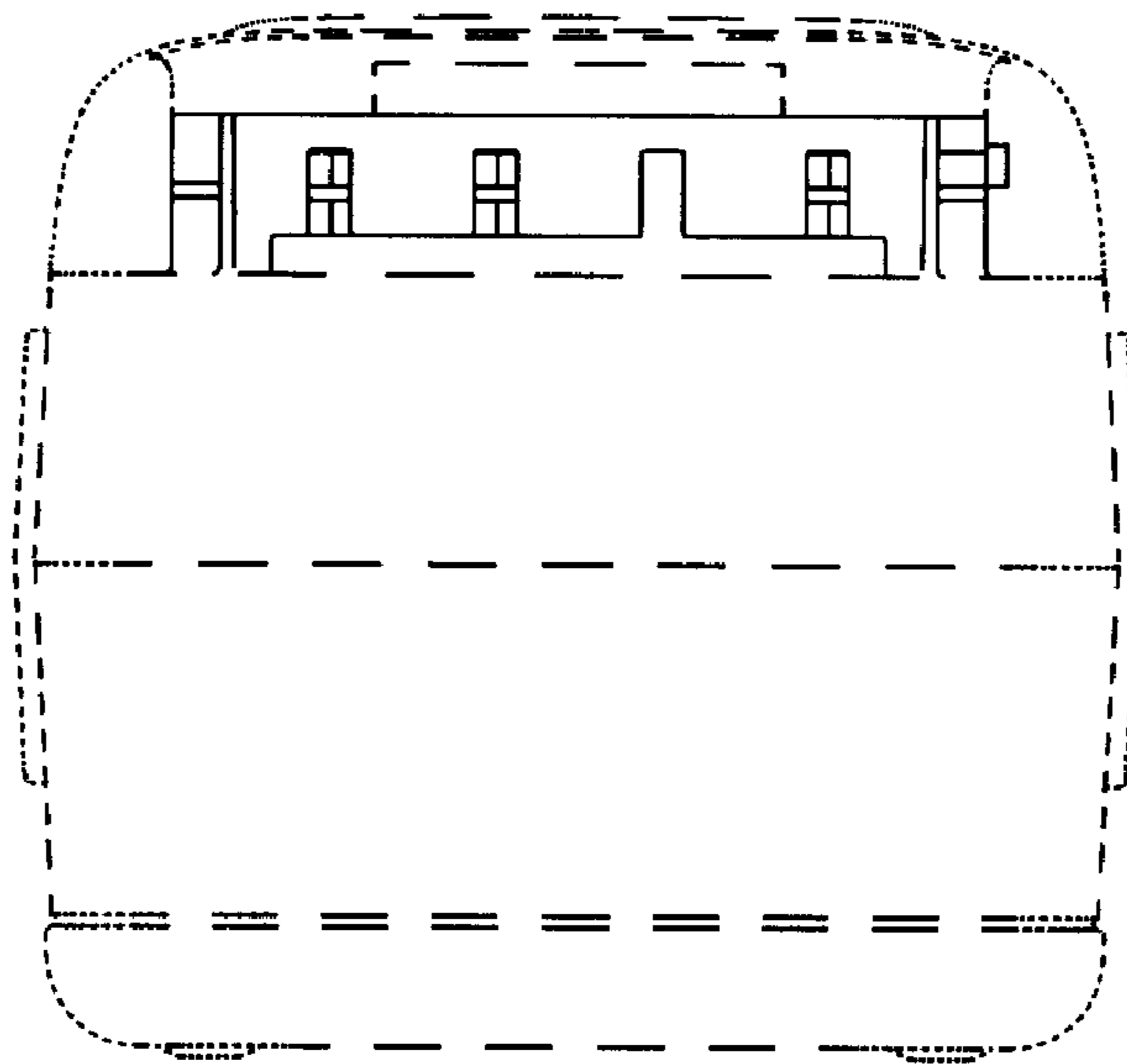

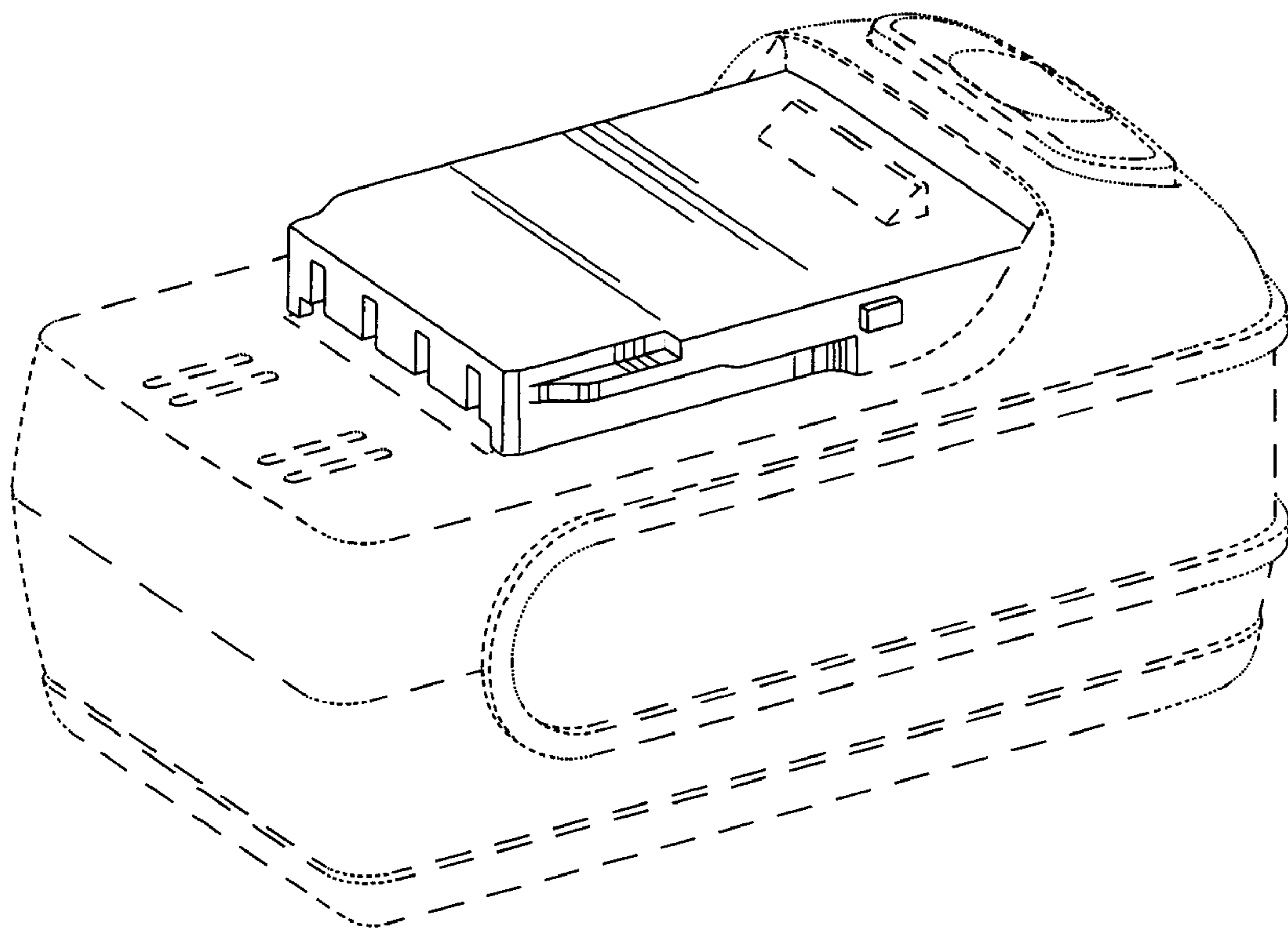

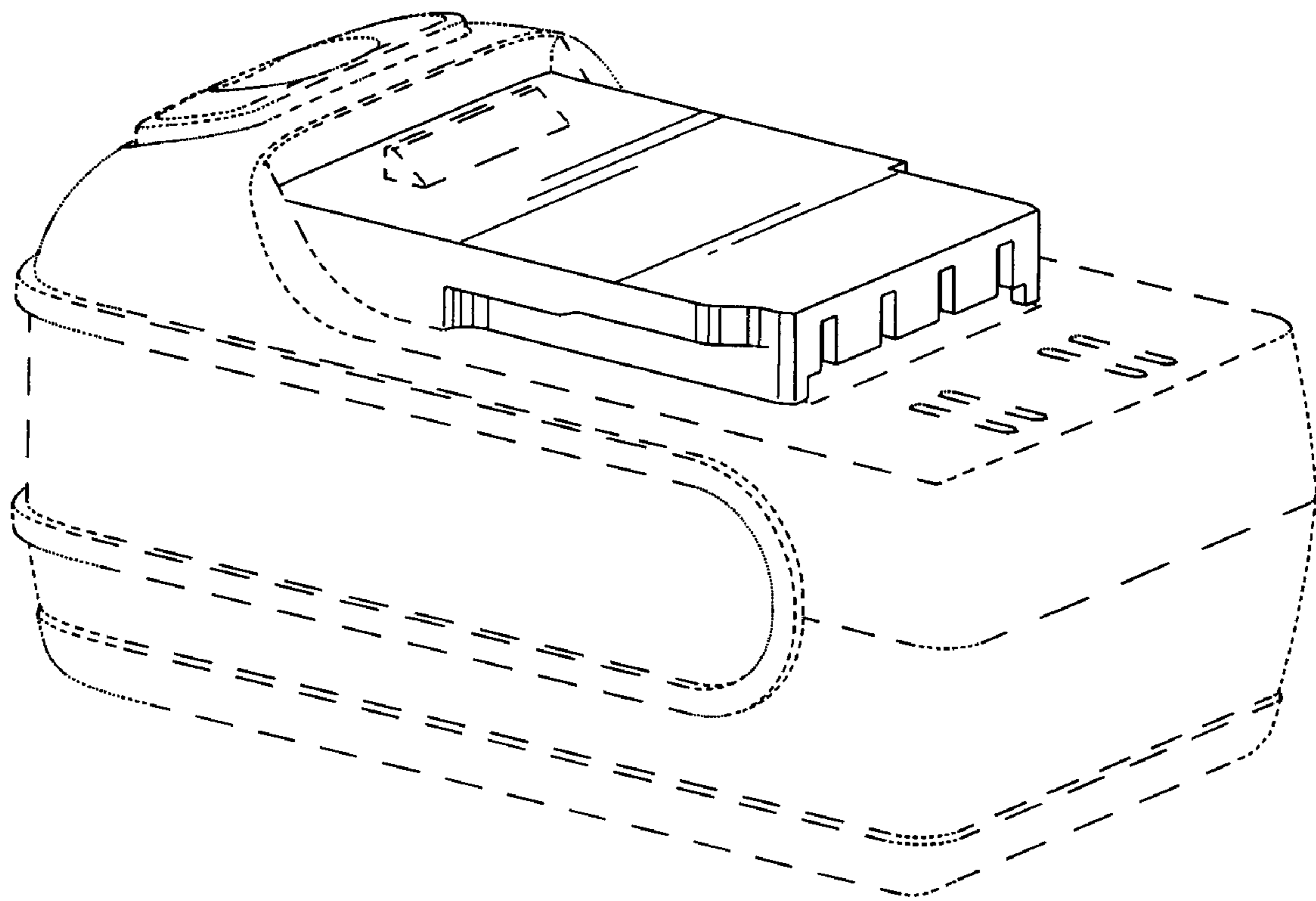

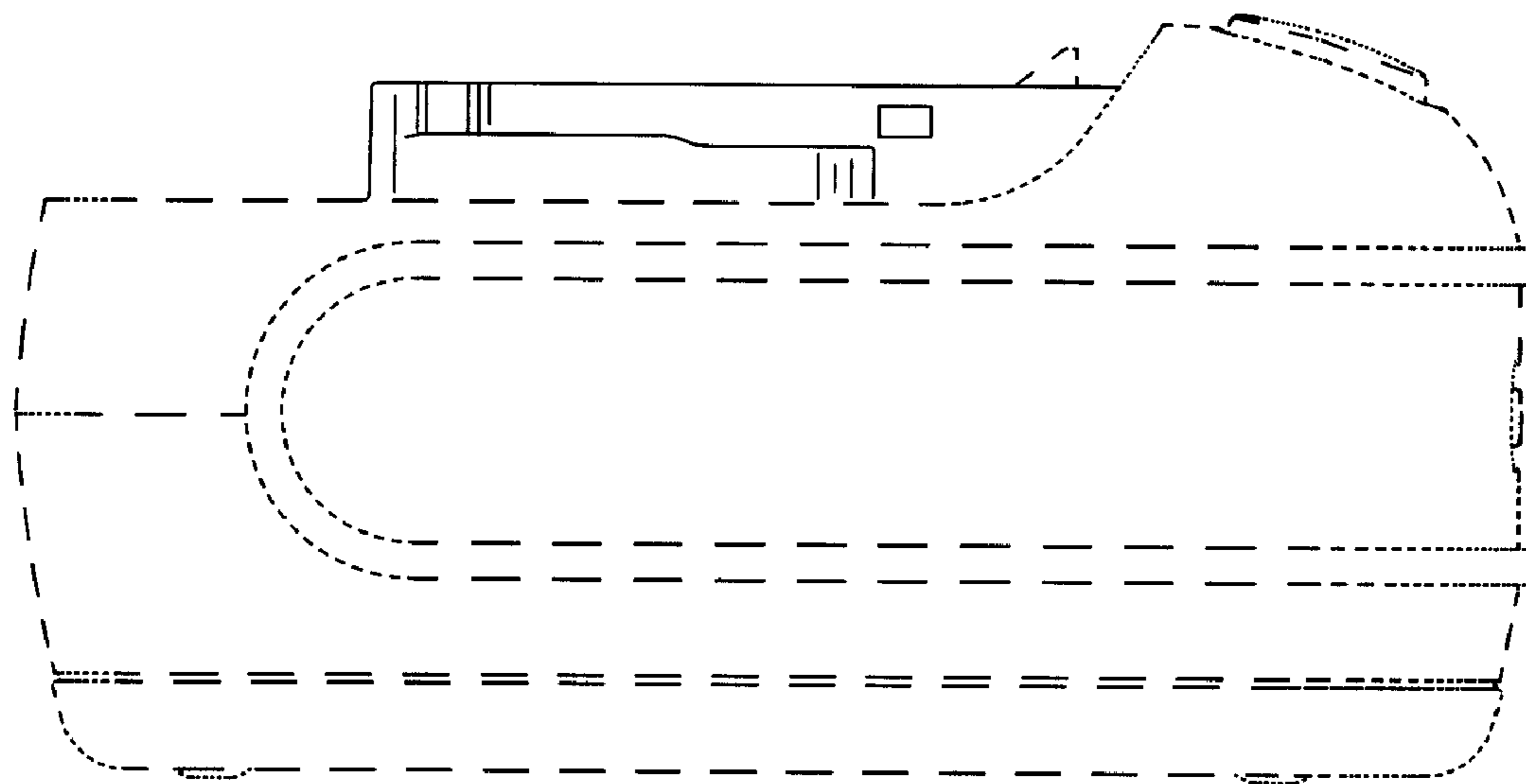

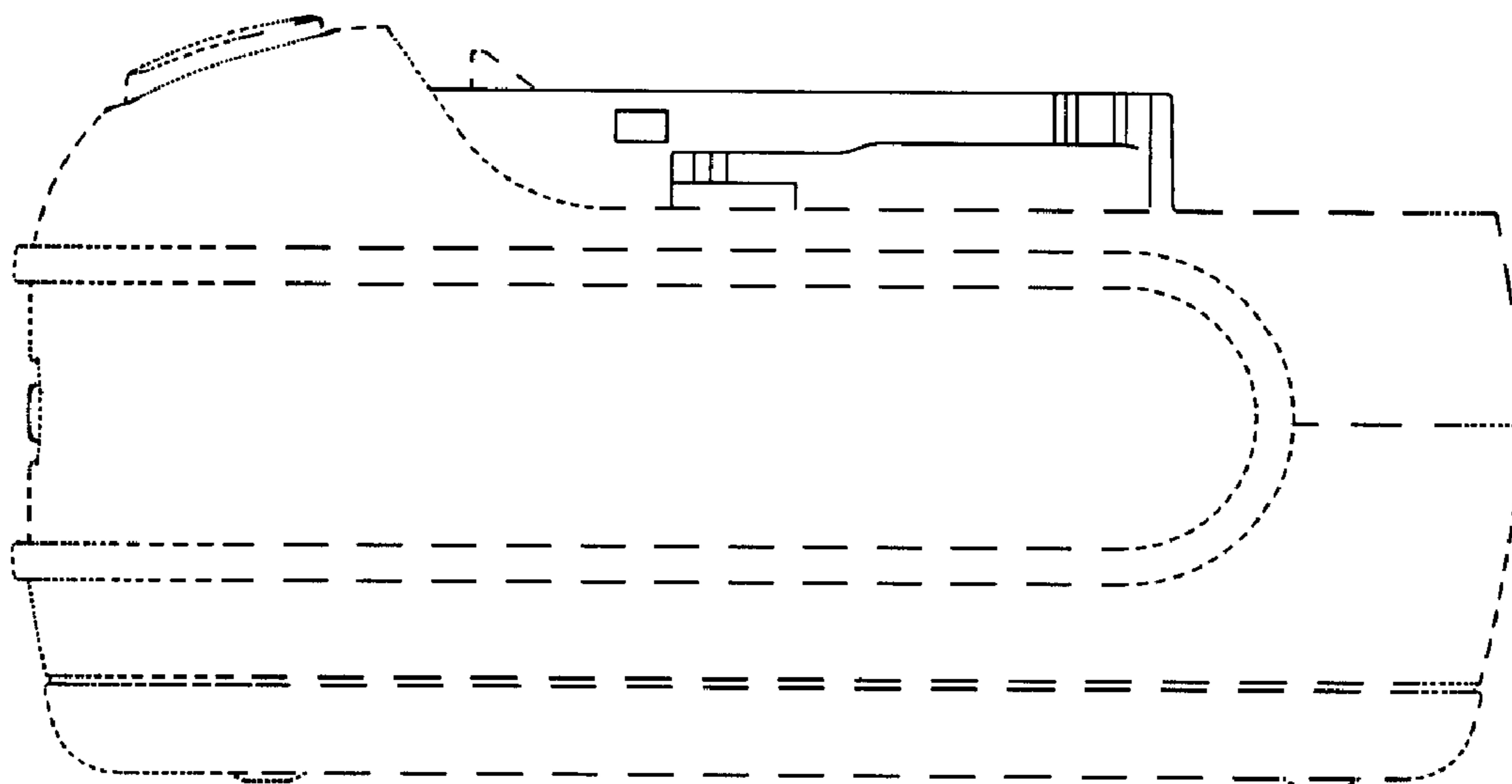

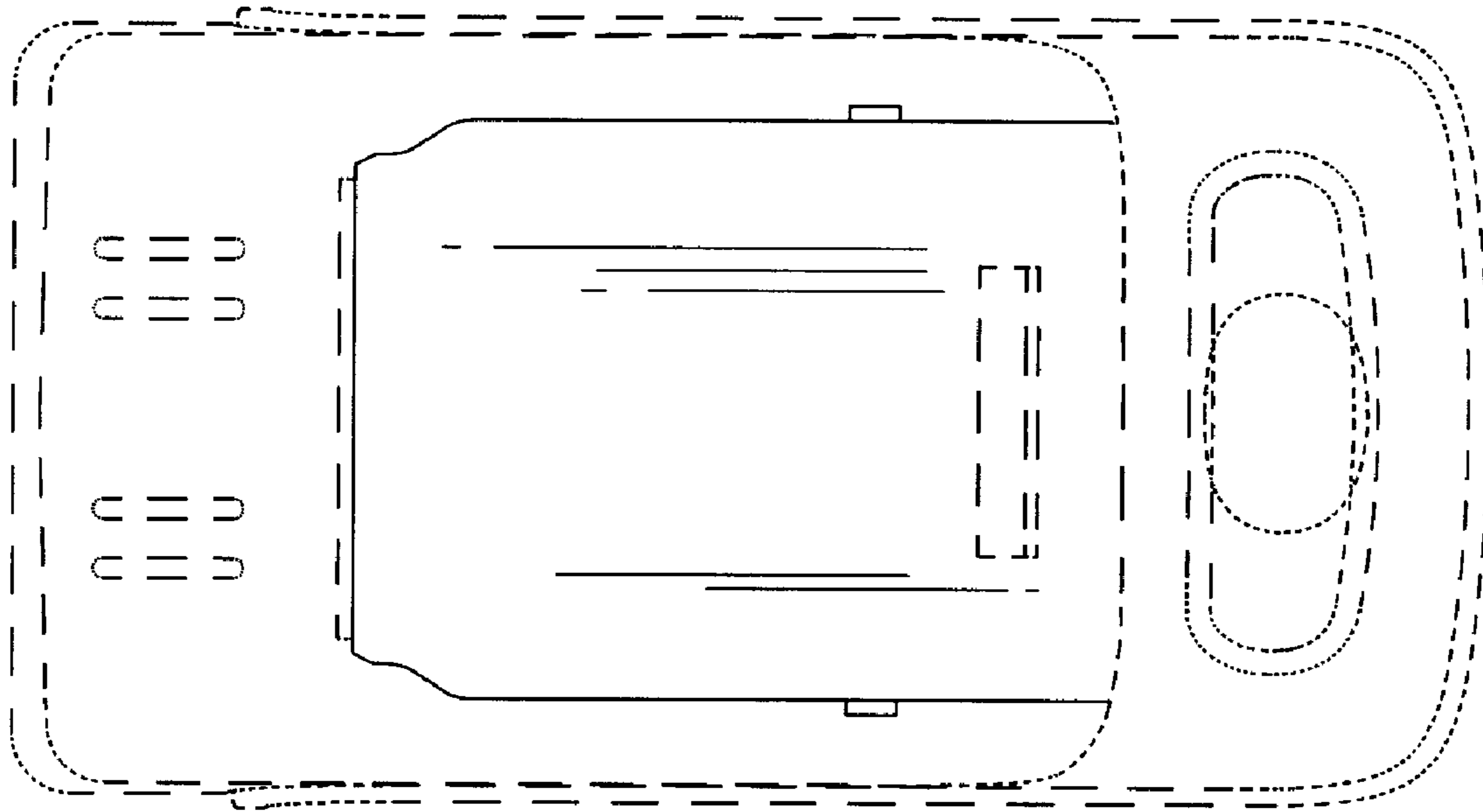

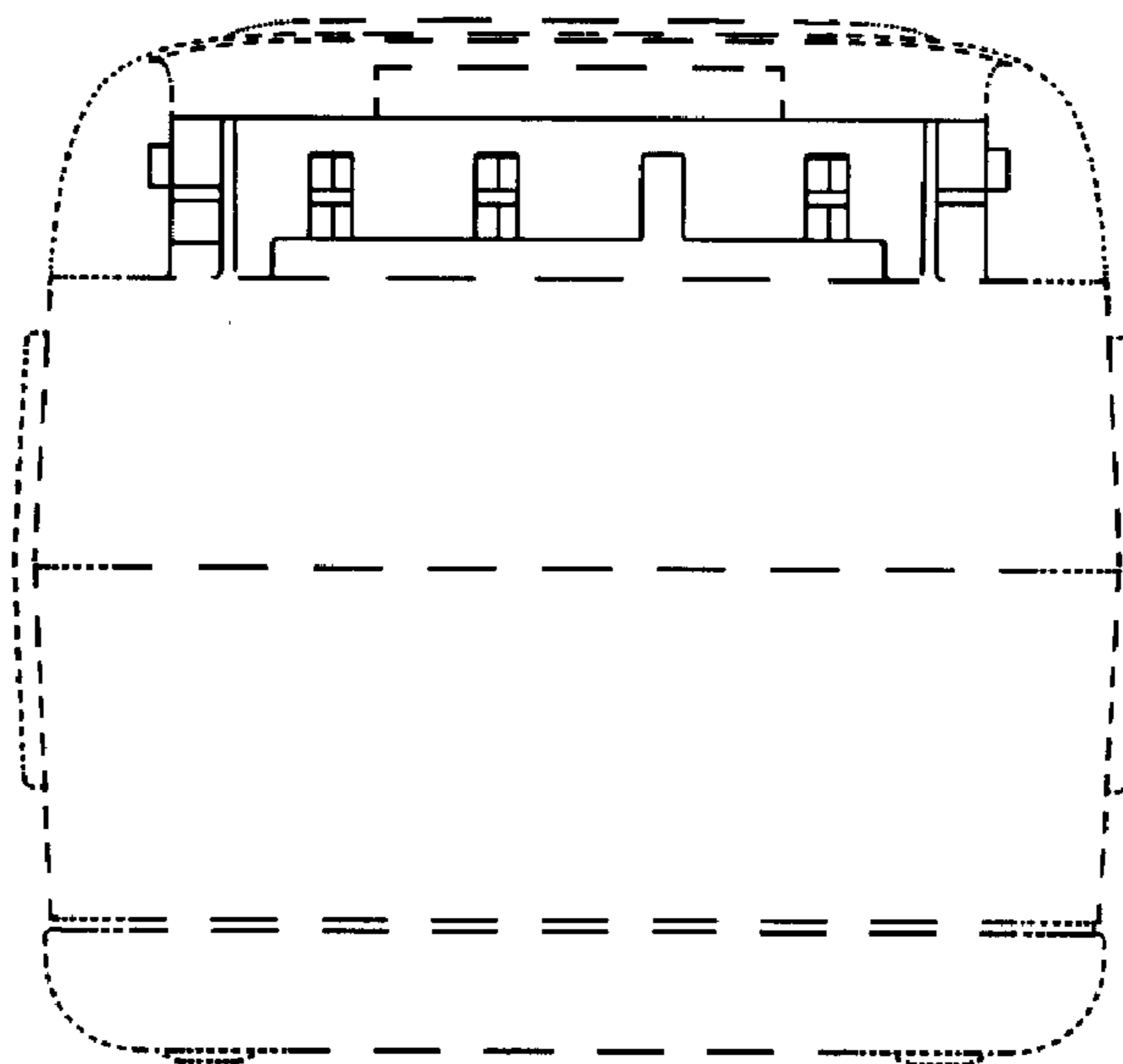

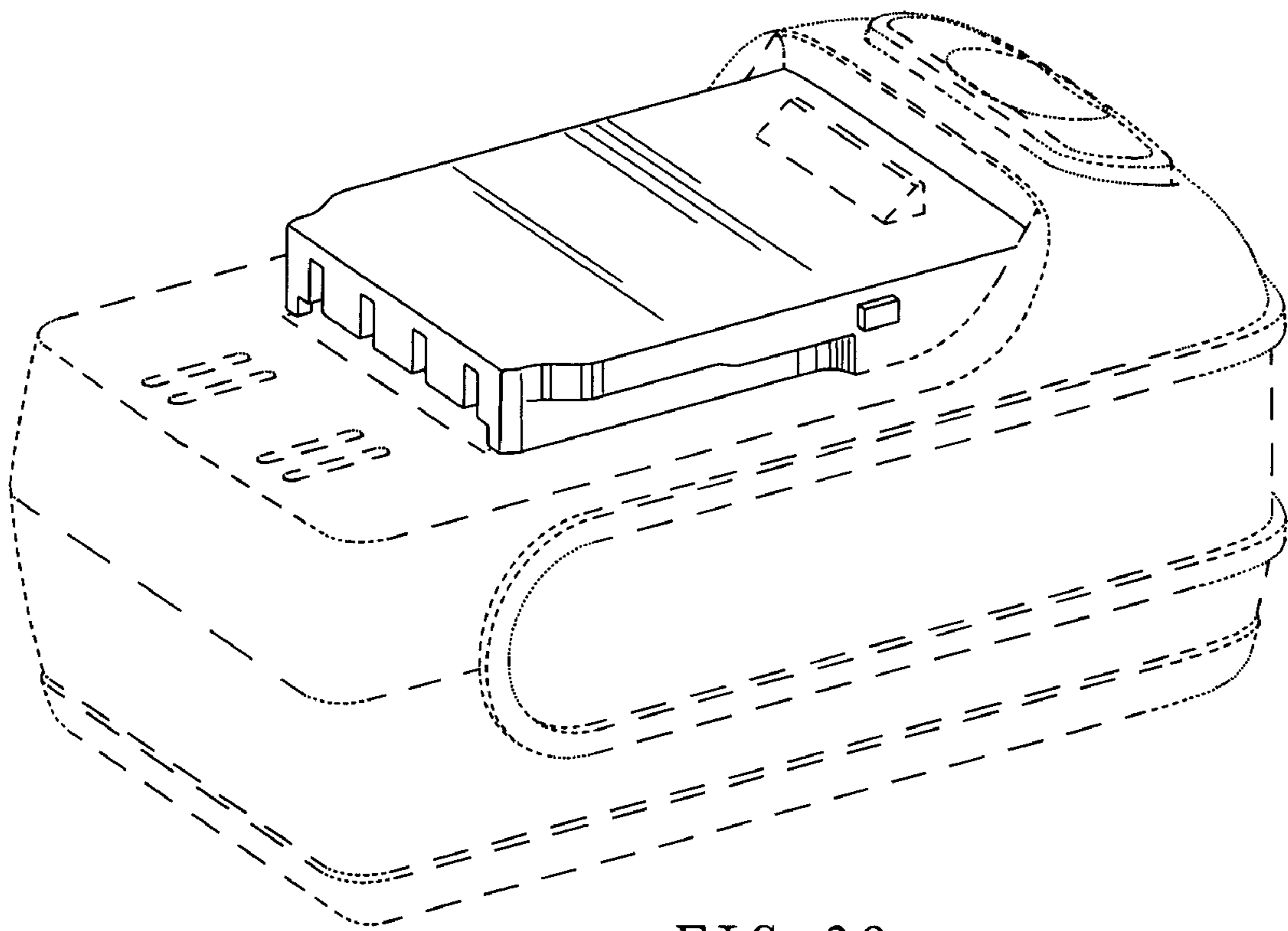

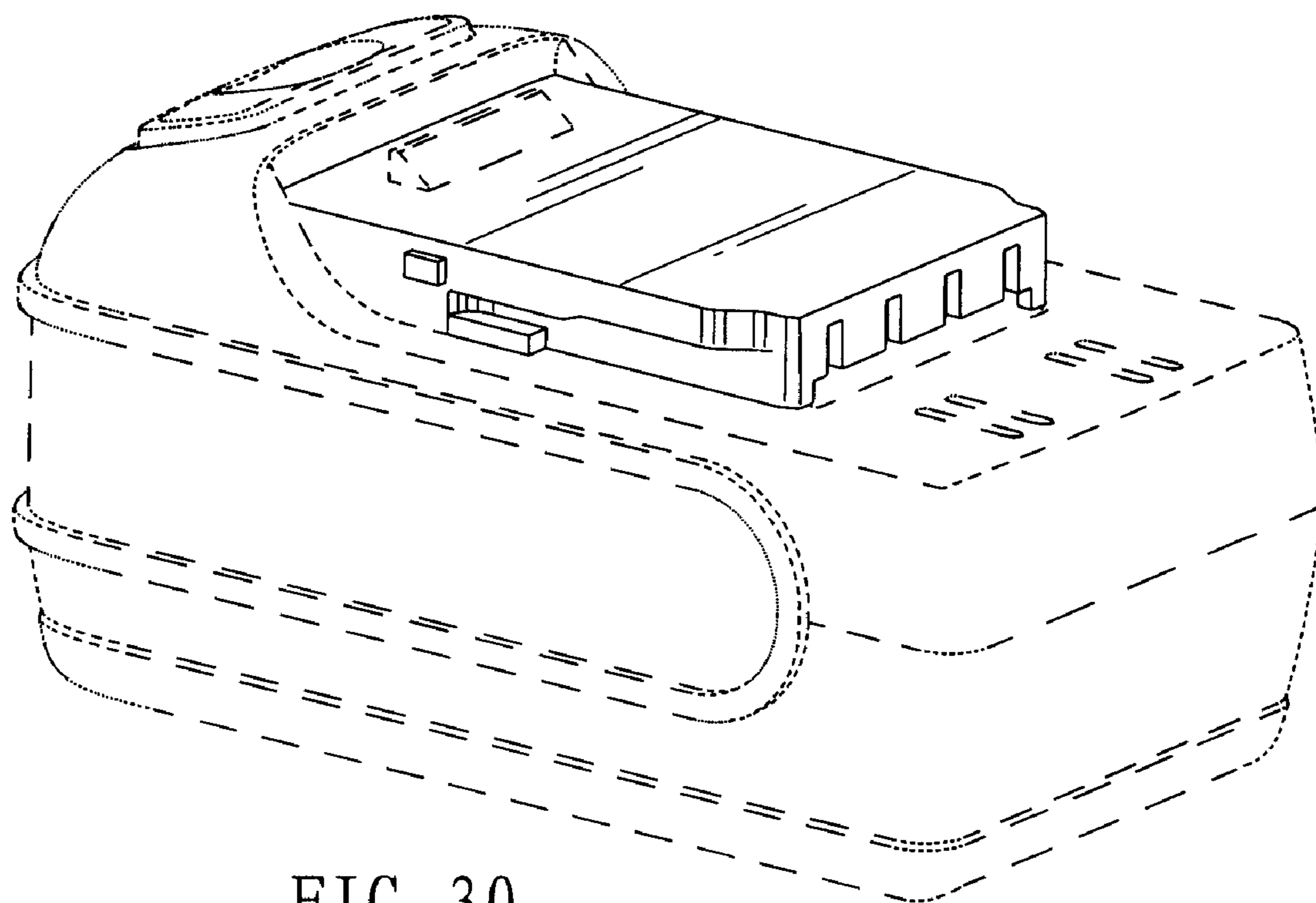

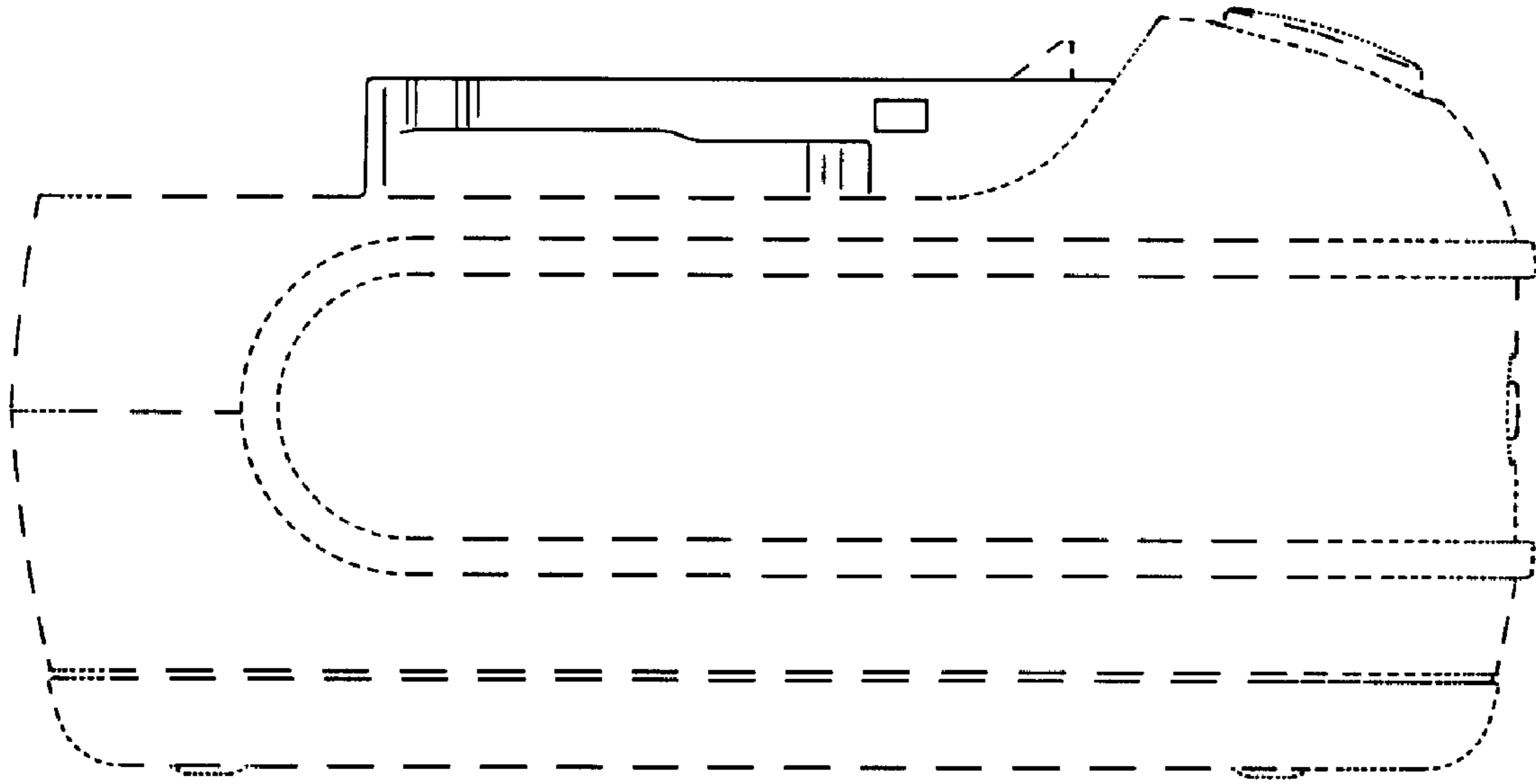

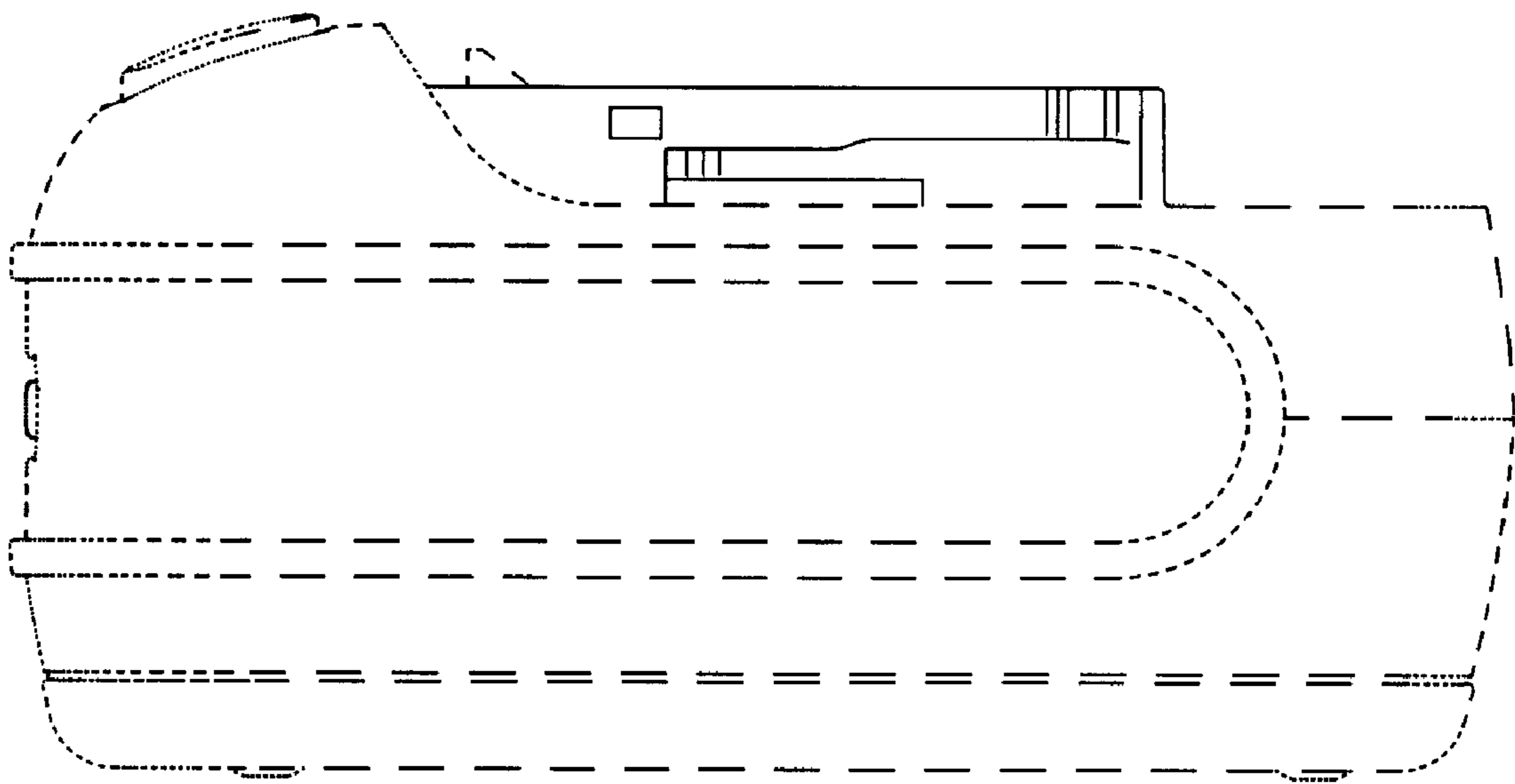

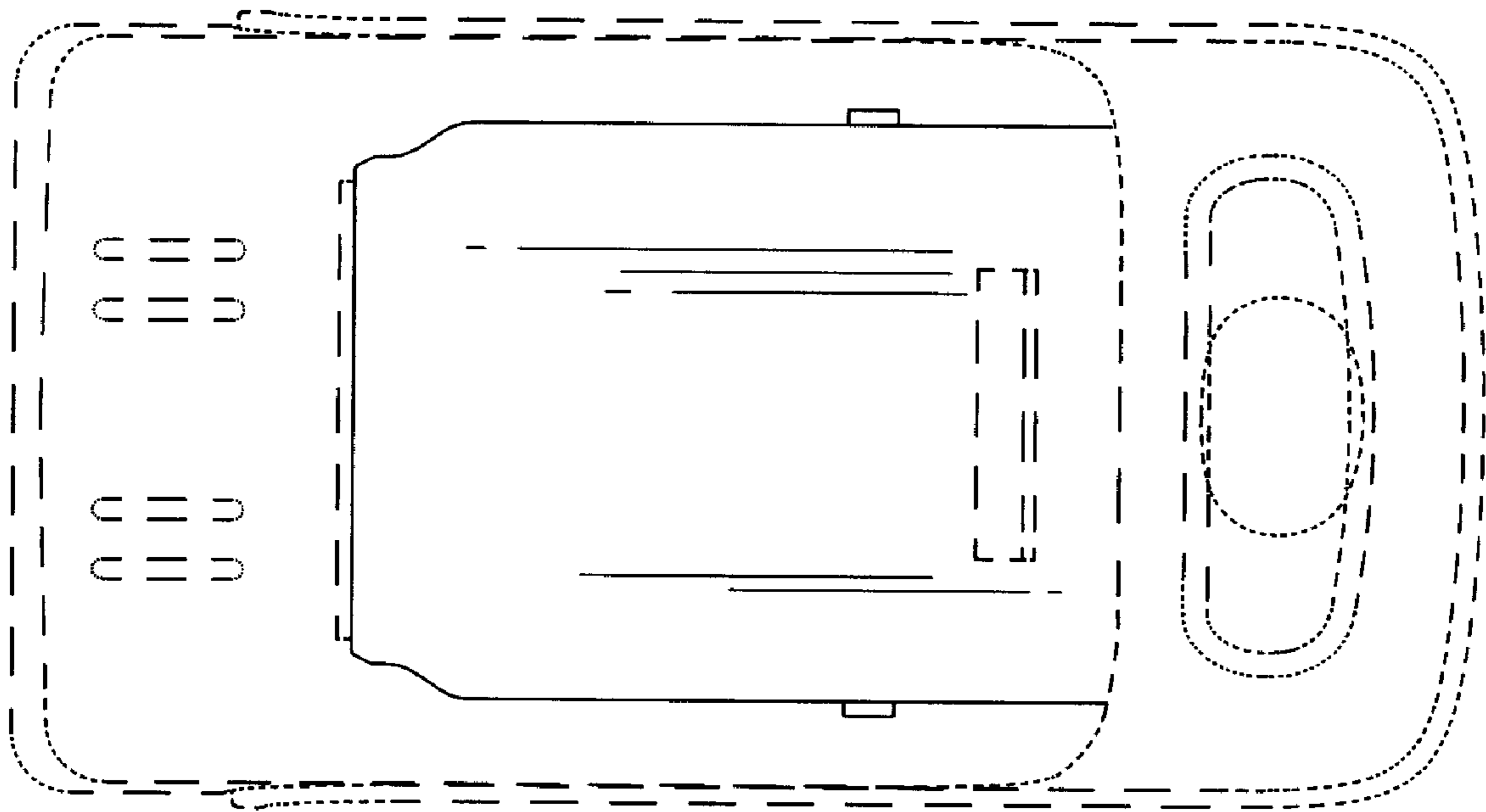

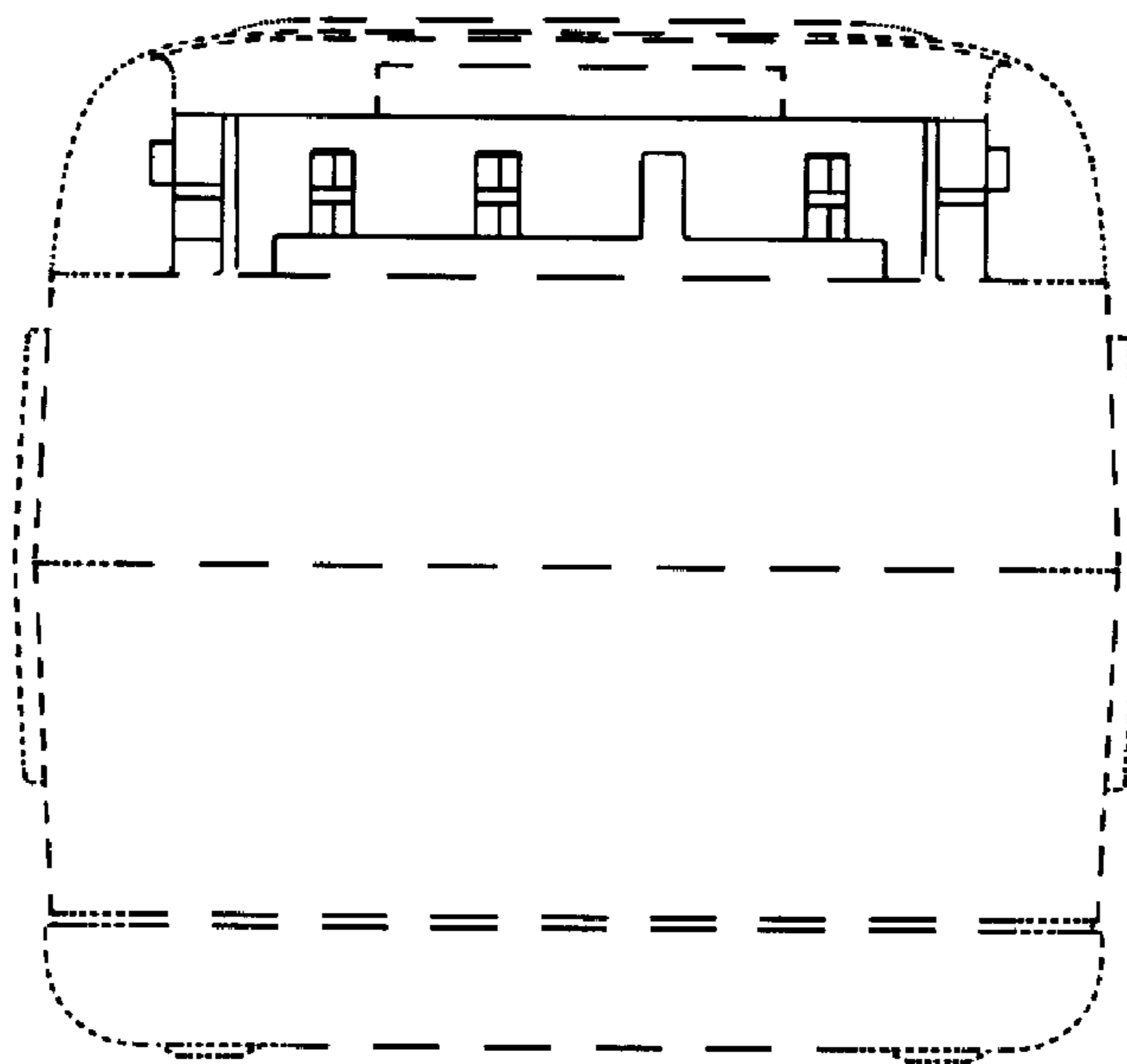

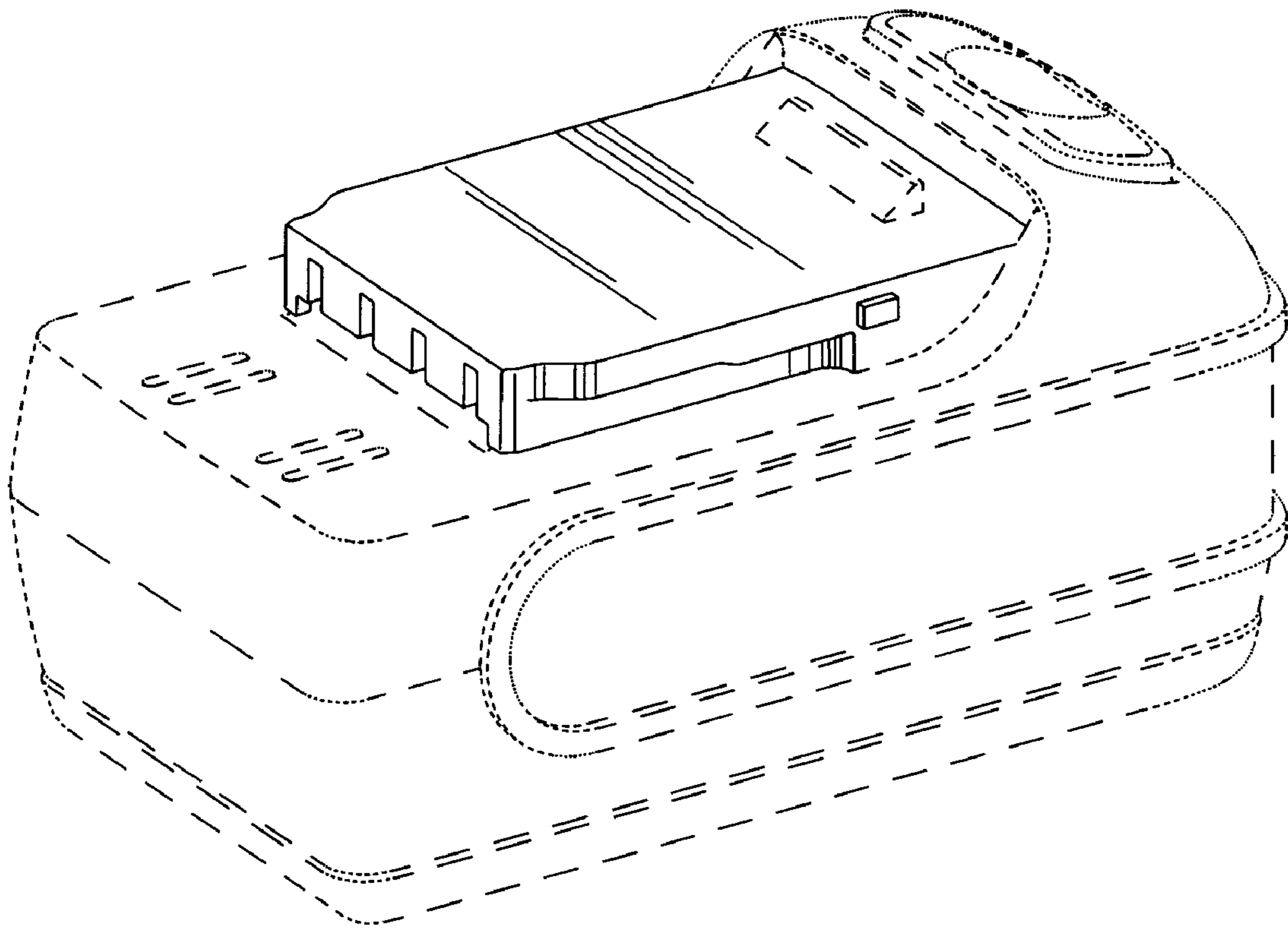

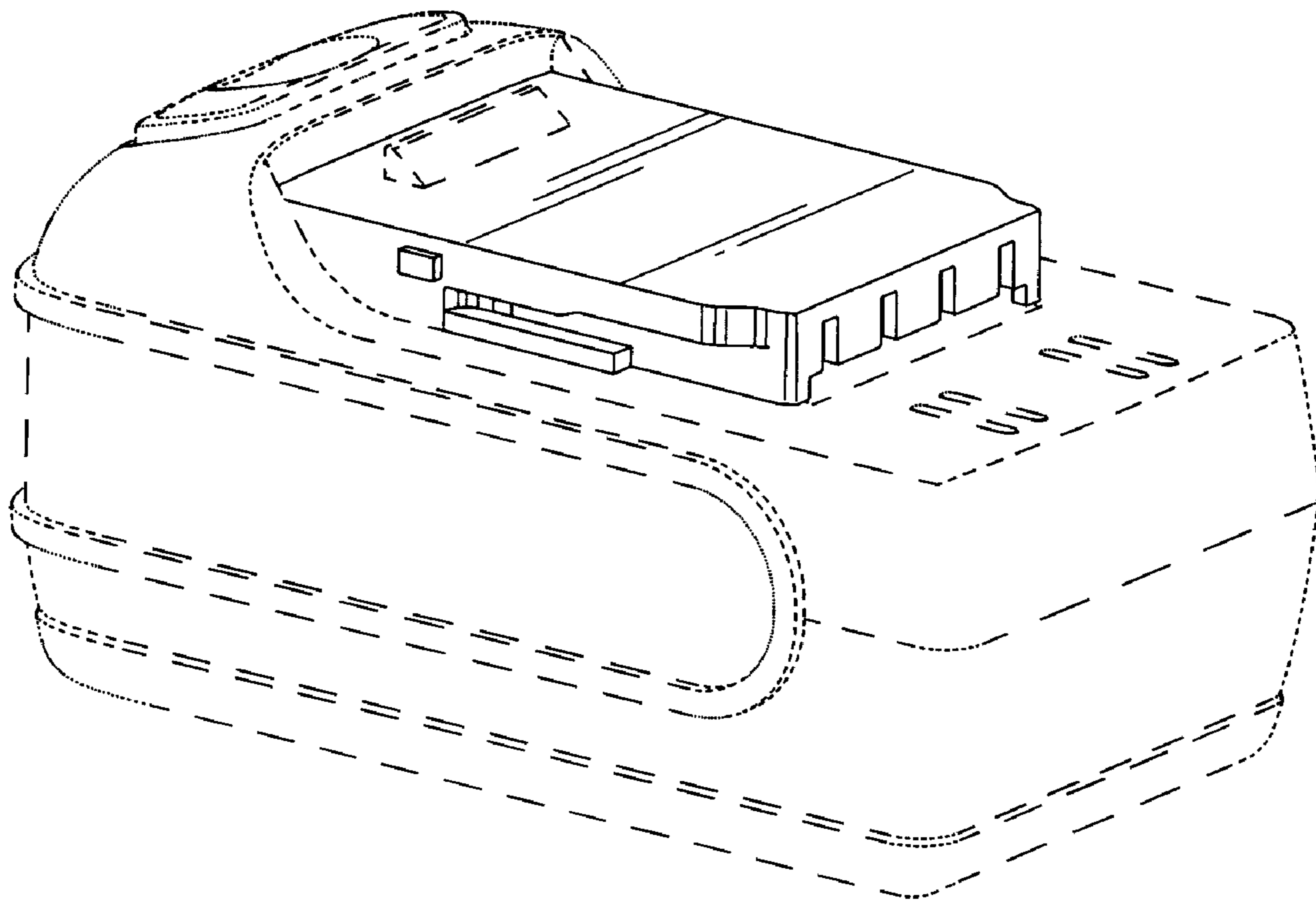

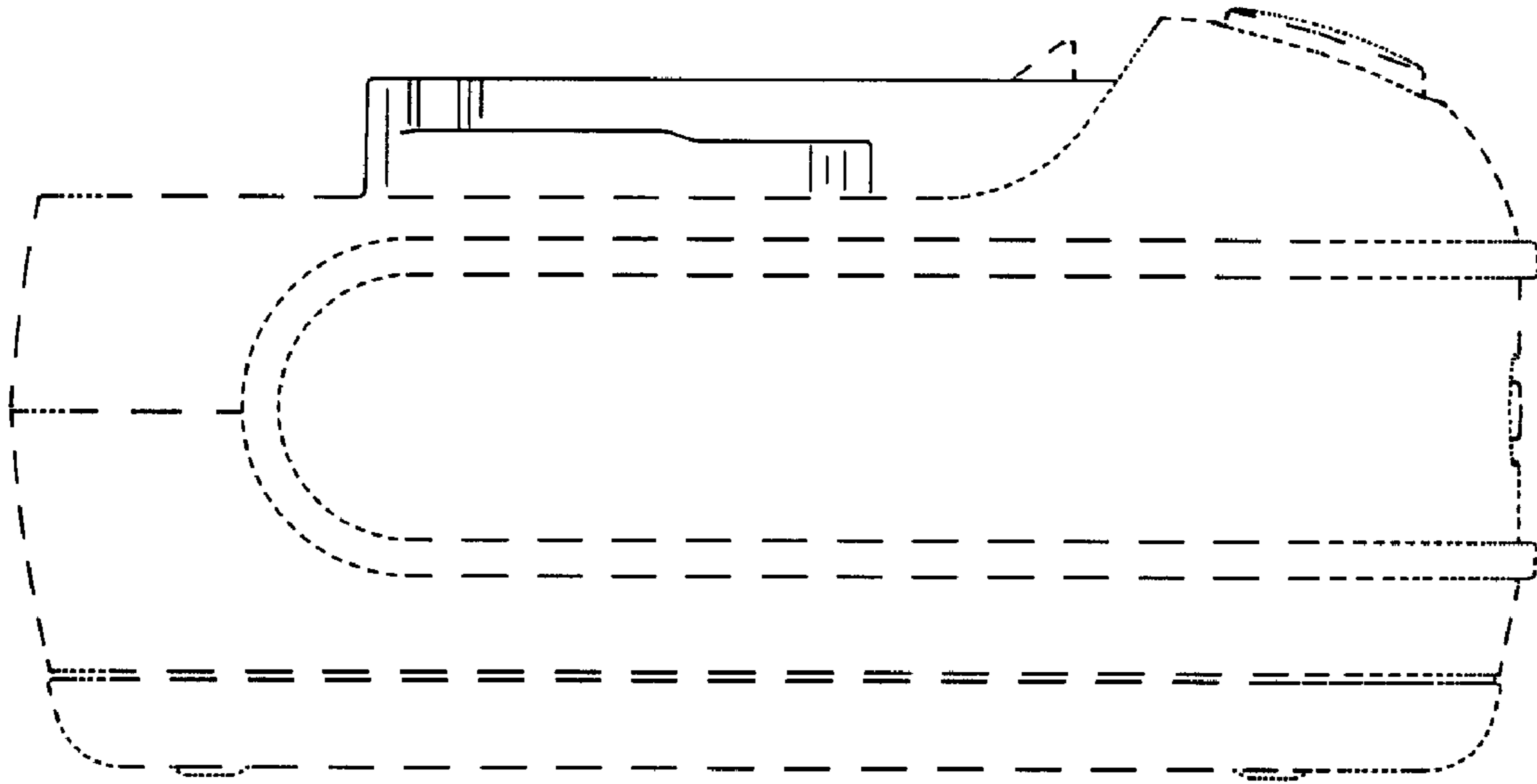

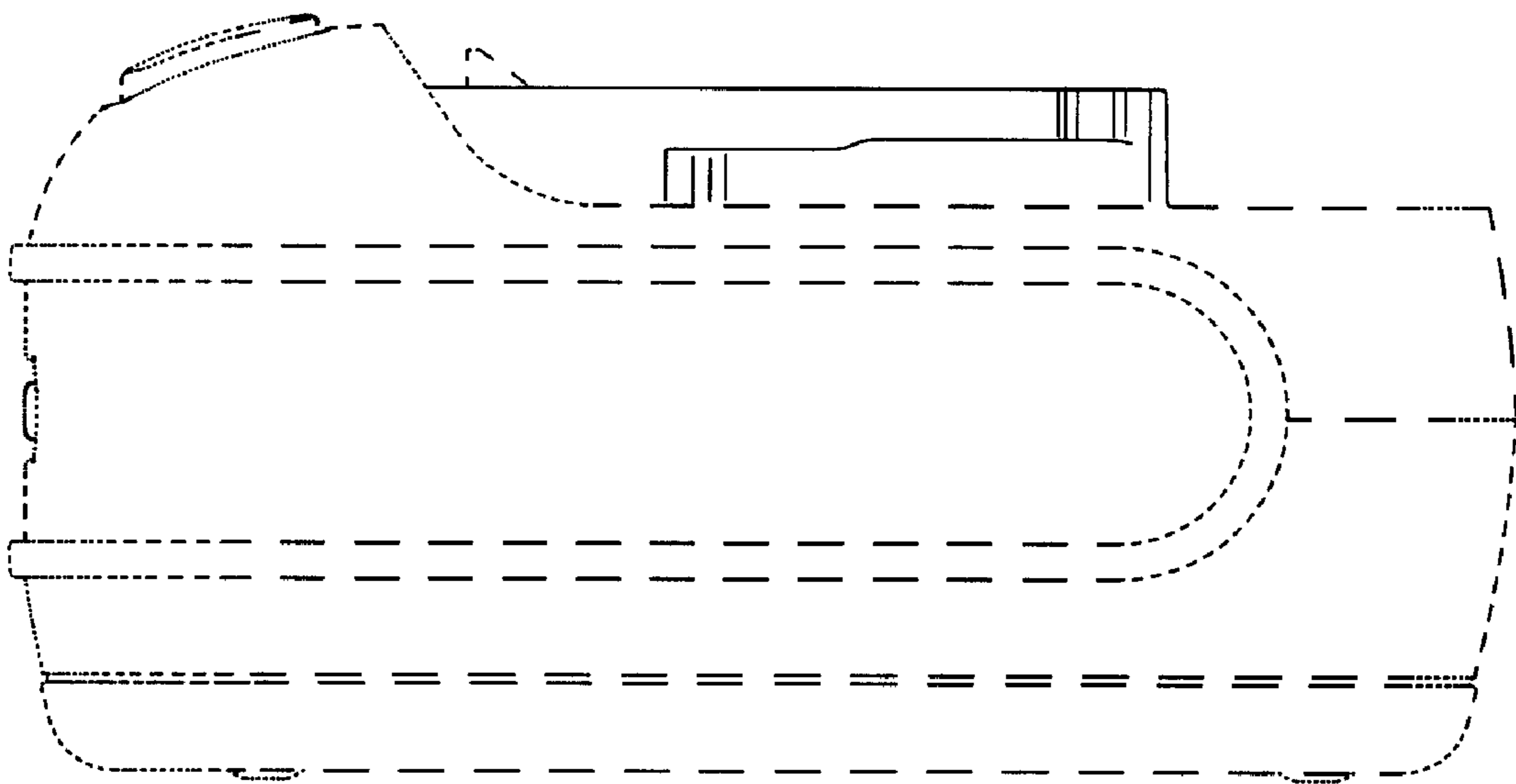

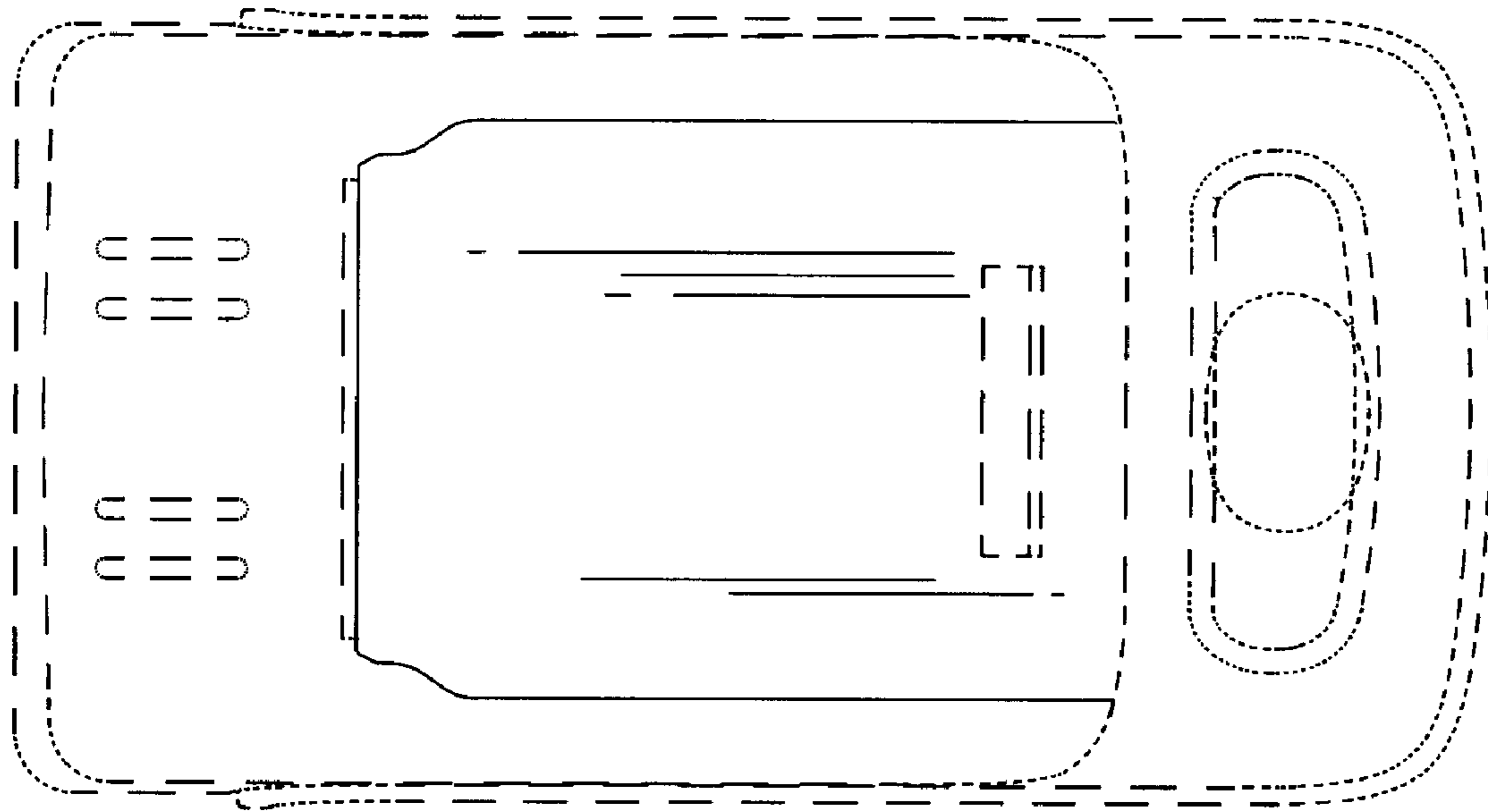

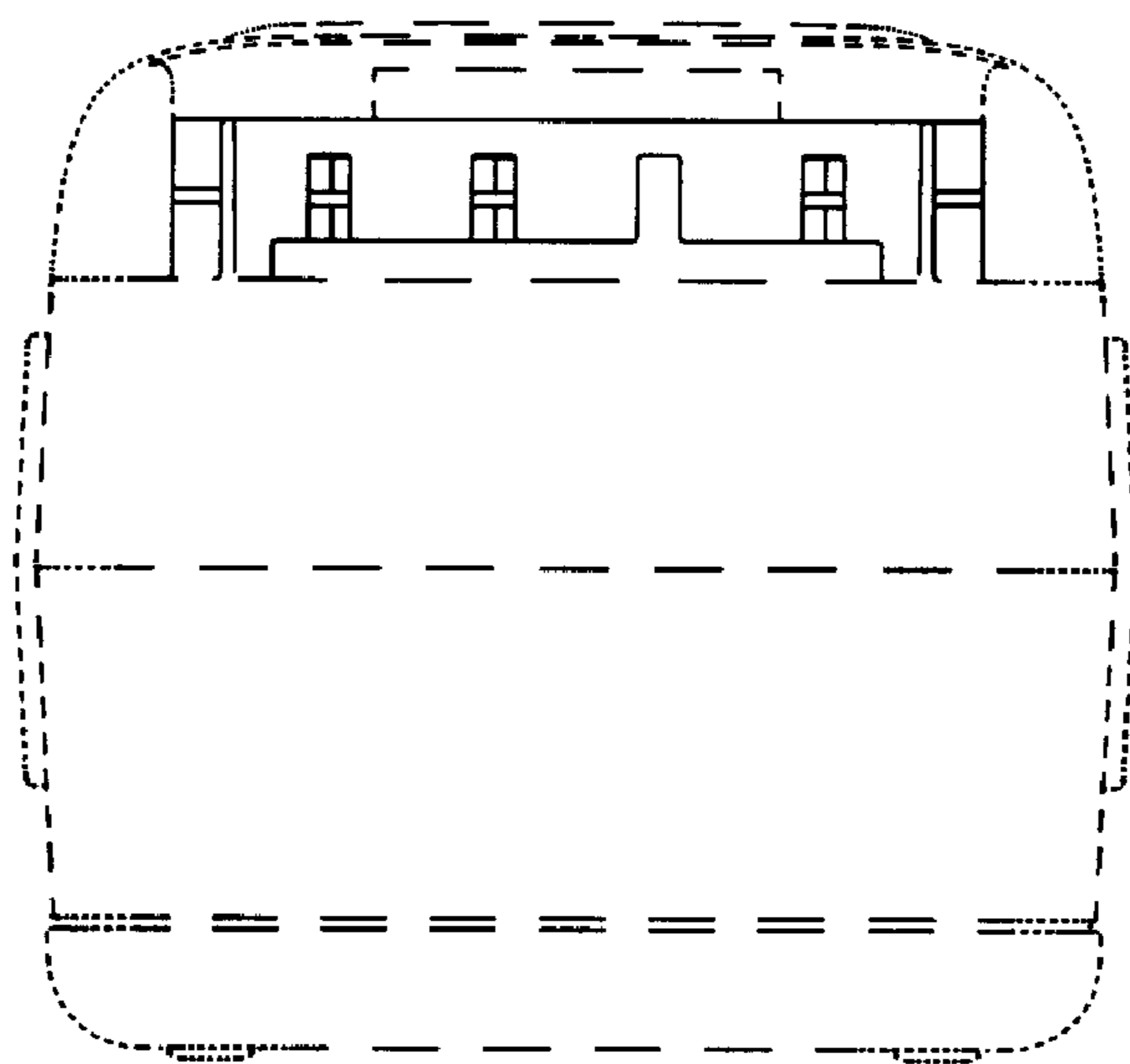

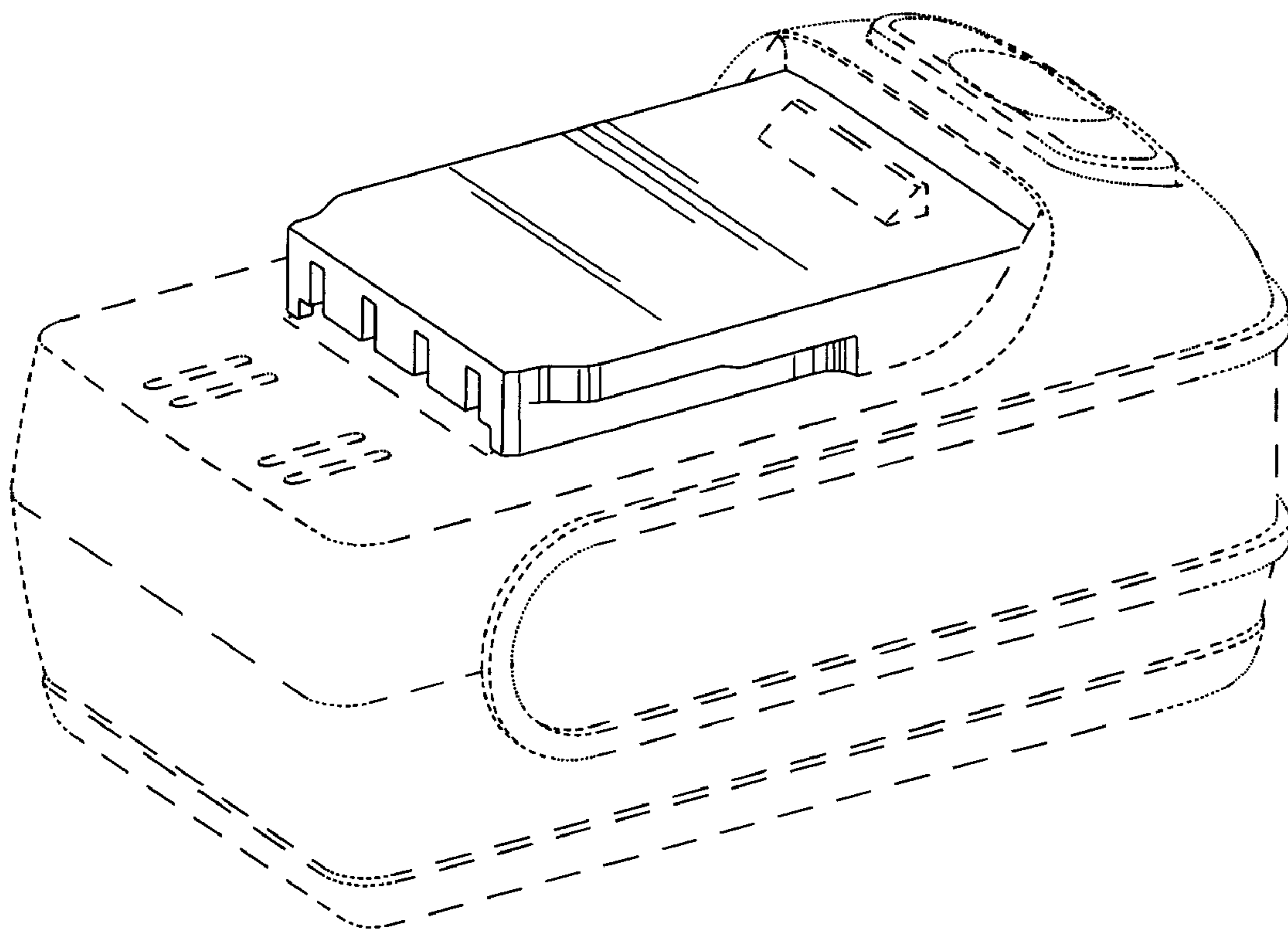

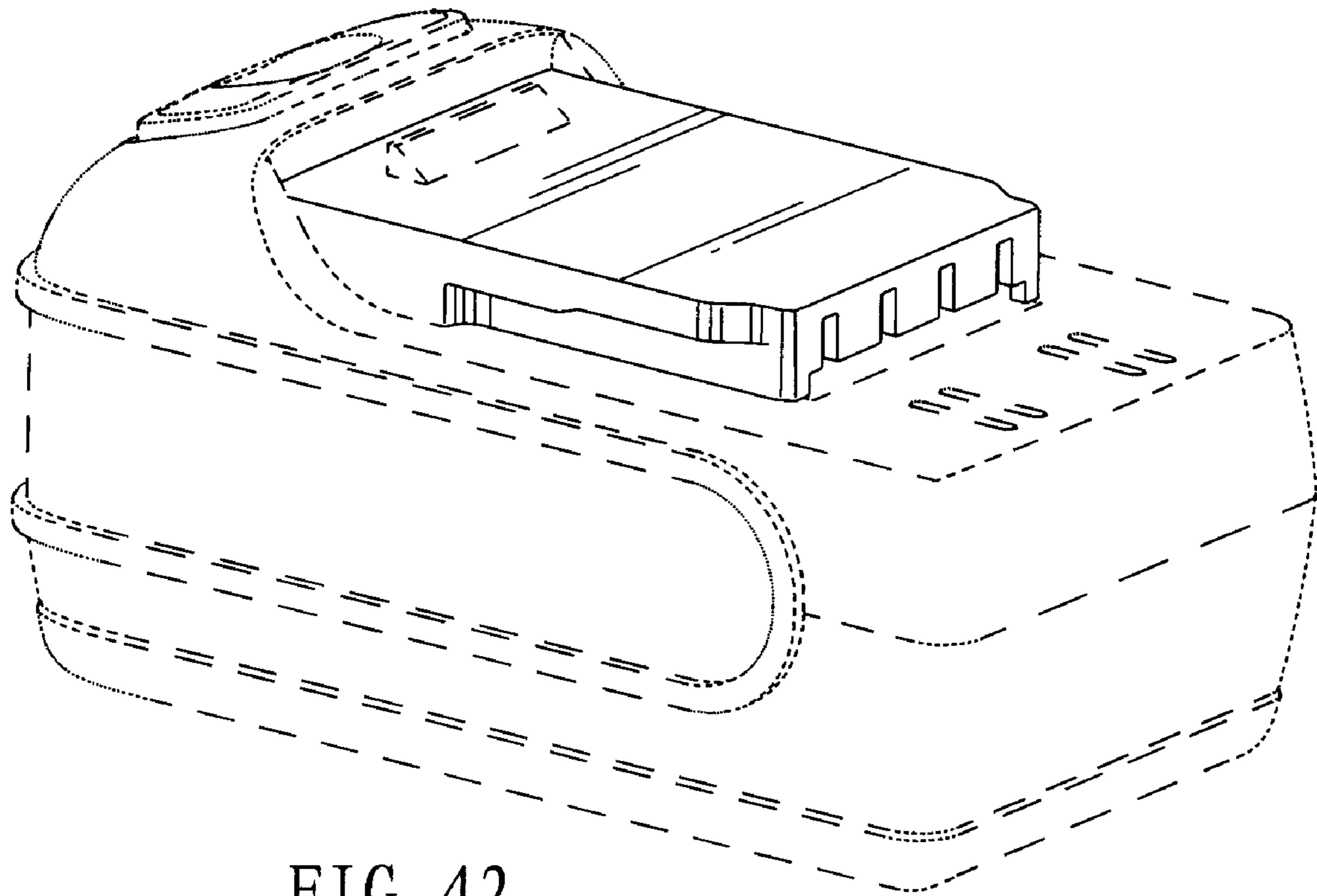
