The ornamental design for a control panel for an exercise machine, as shown and described.

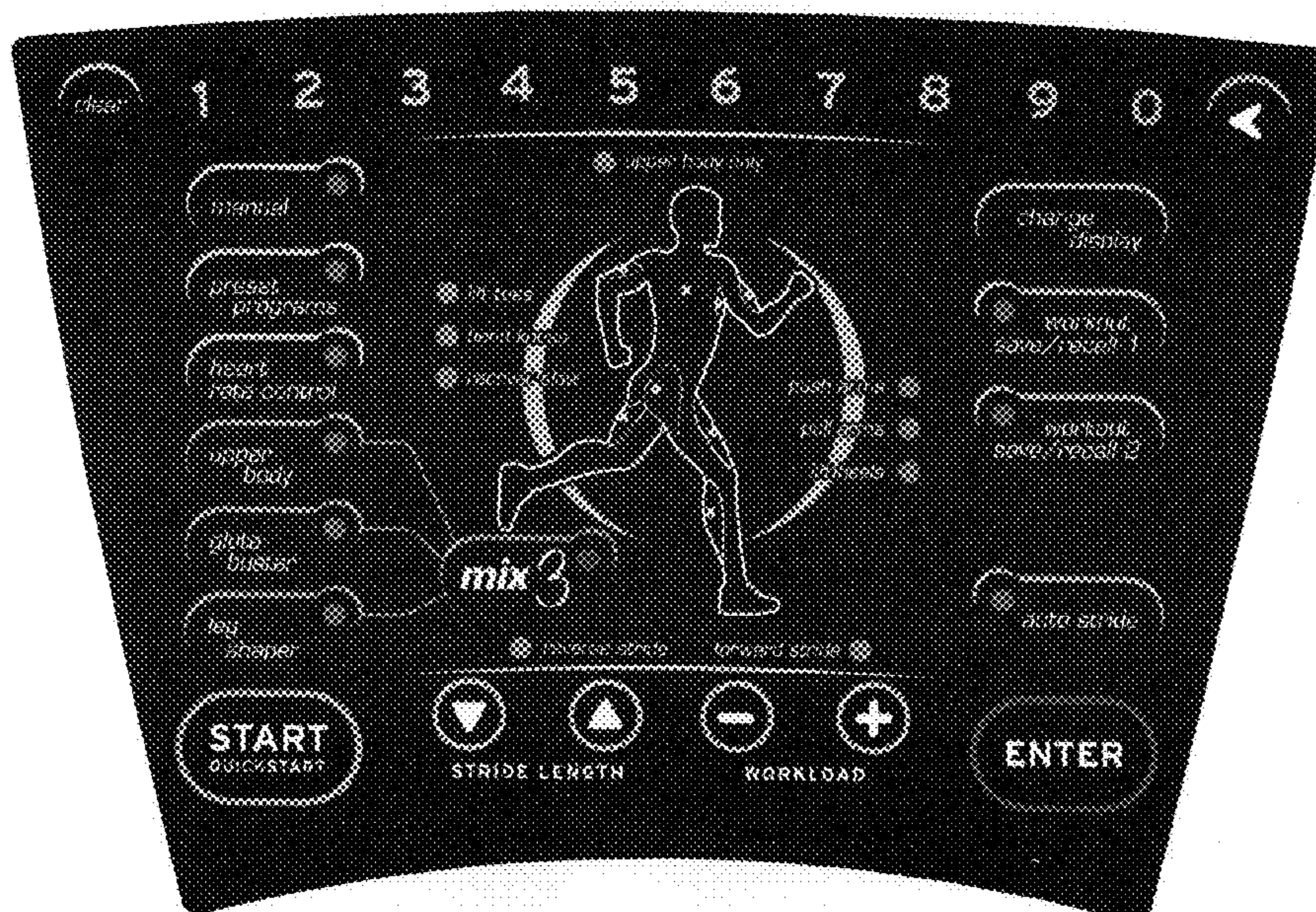
**DESCRIPTION**

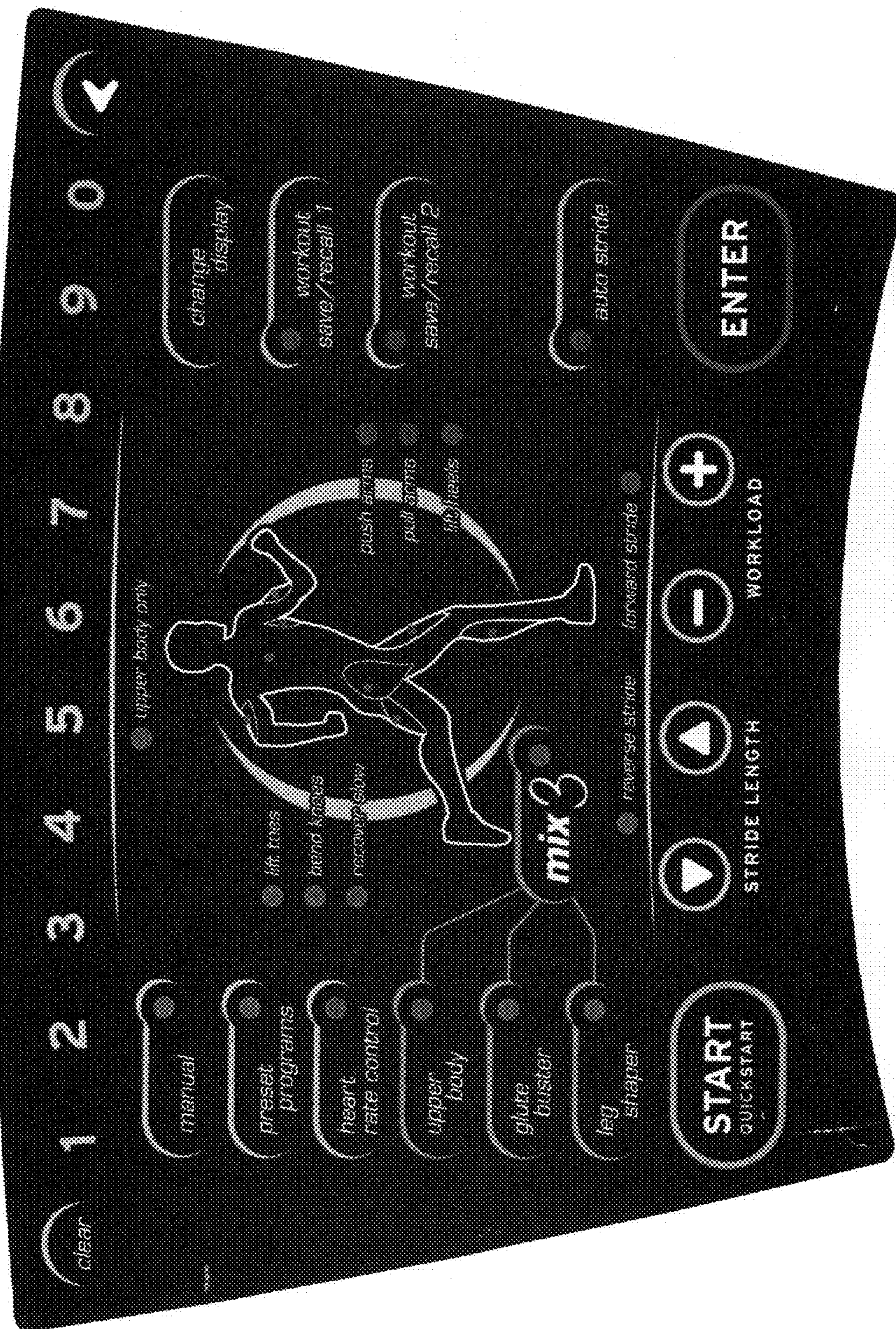

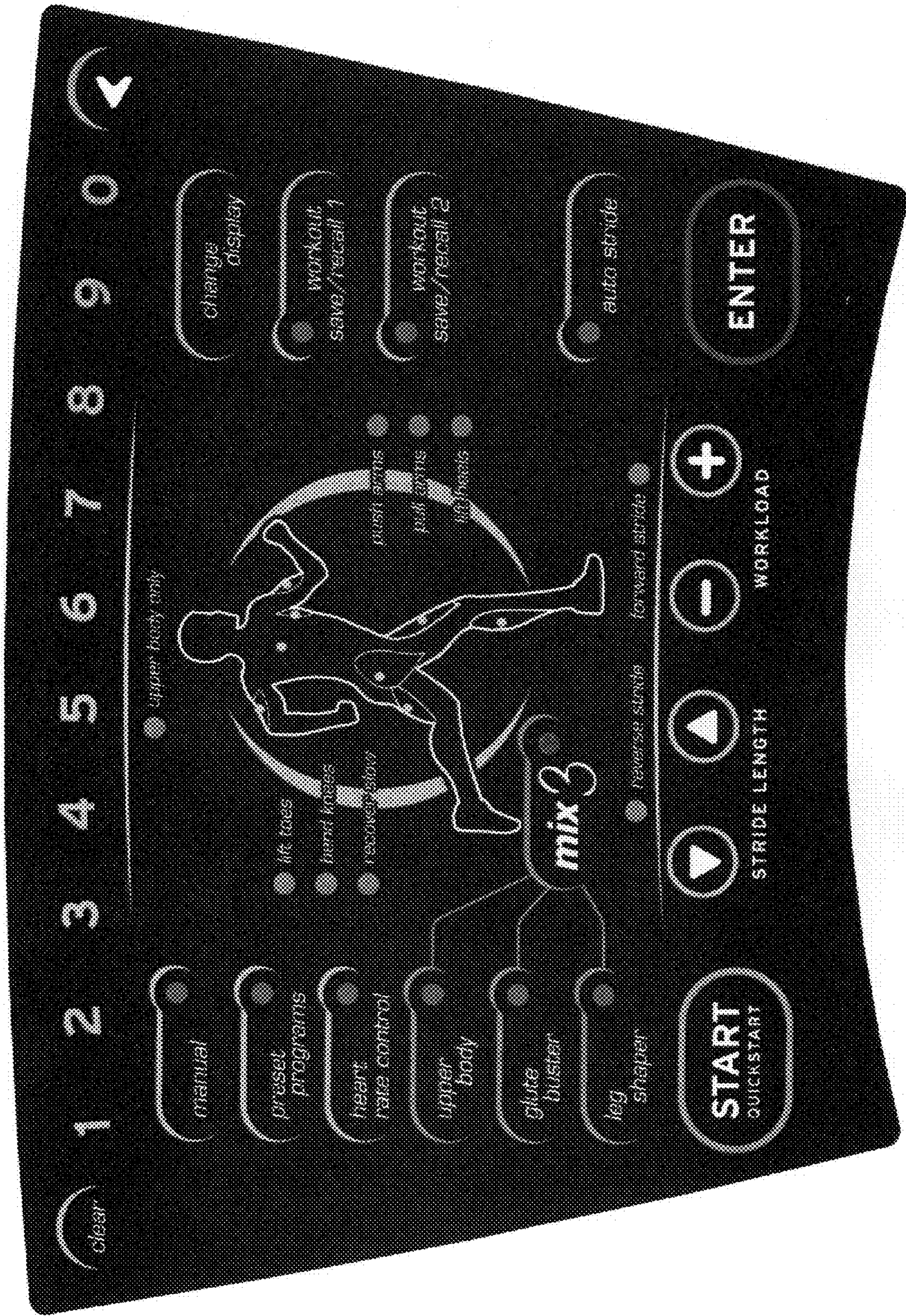
