FIG. 2 is an isometric view thereof without cap;

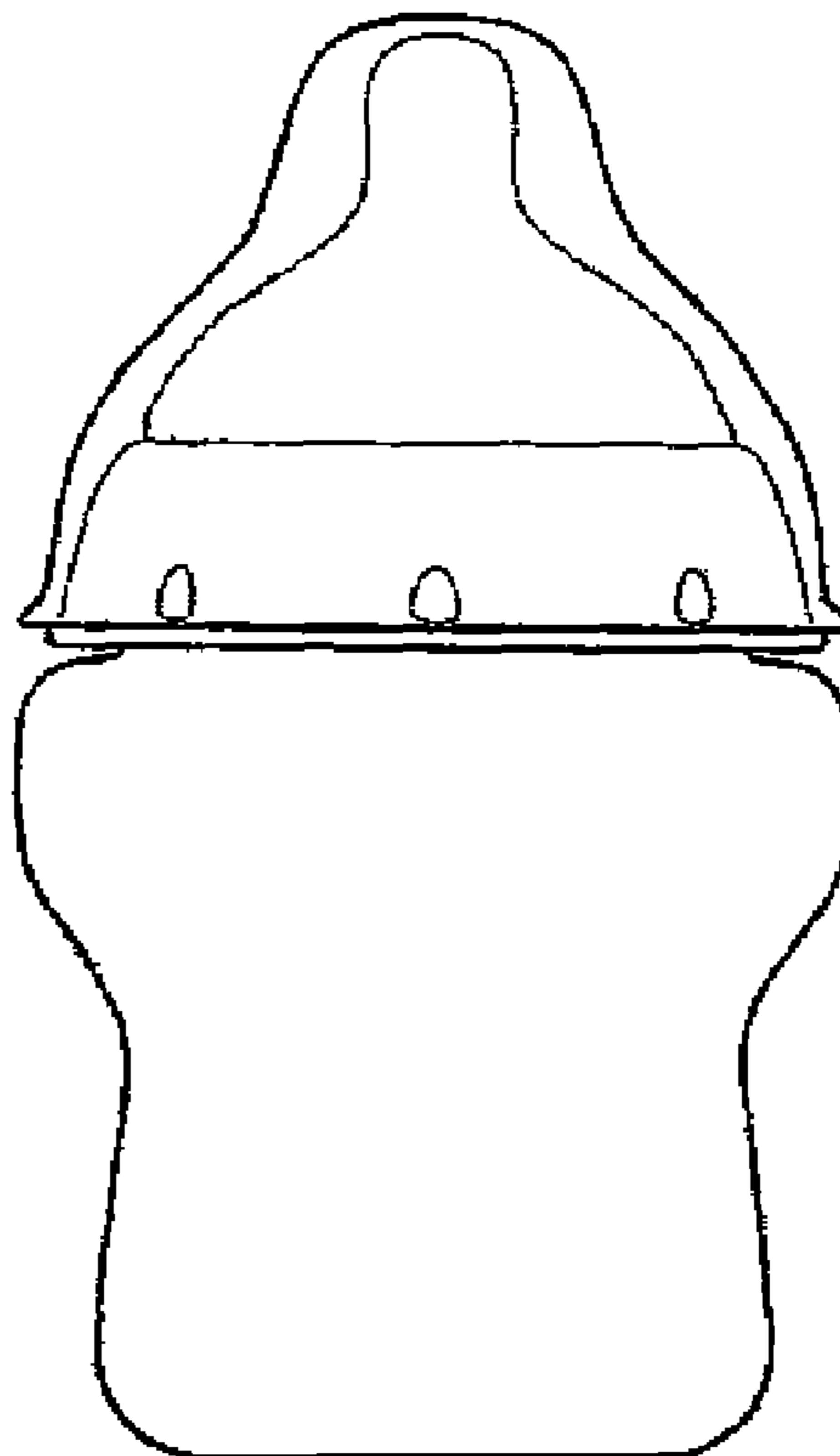
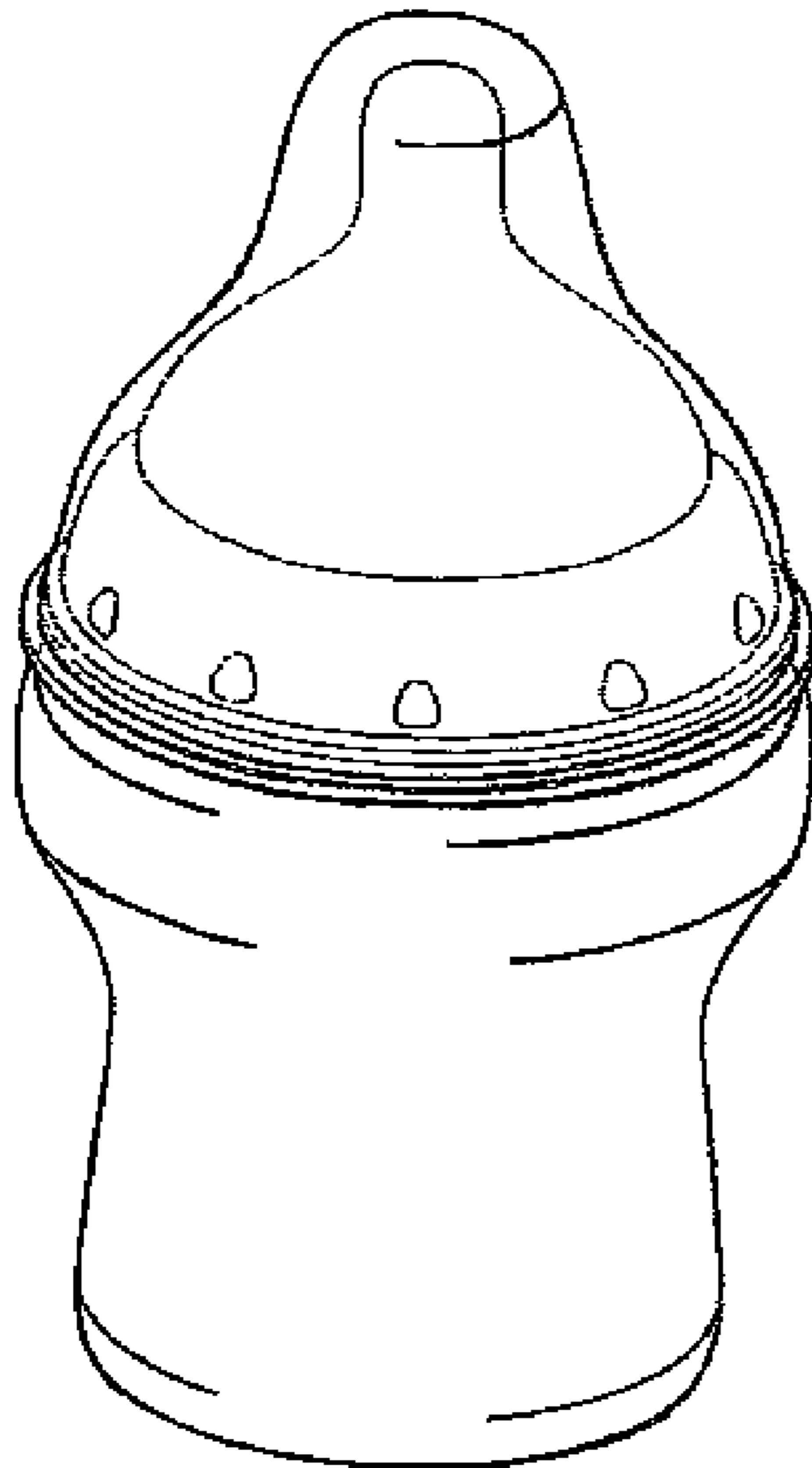
FIG. 3 is a front elevational view thereof, the rear and side views being a mirror image;

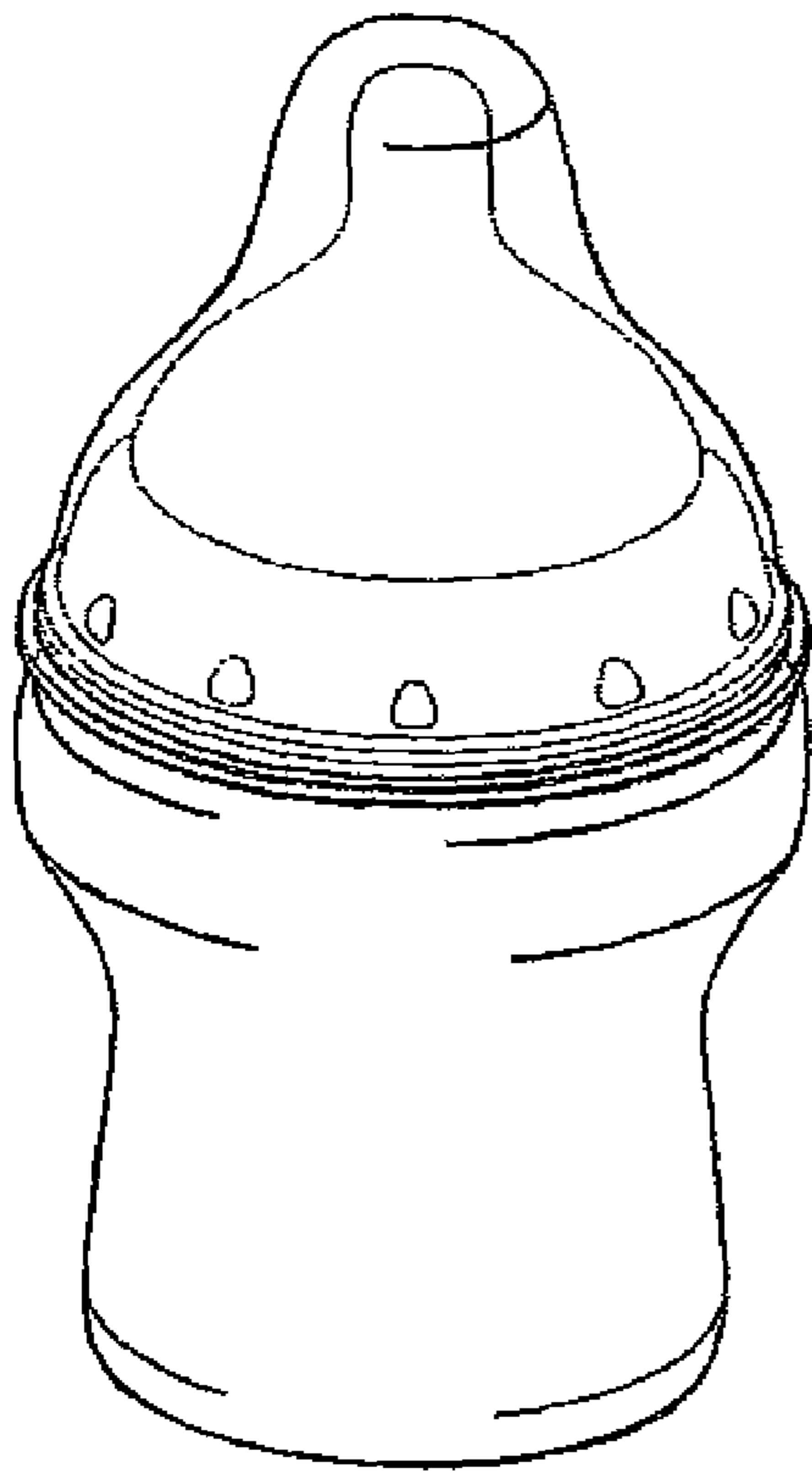

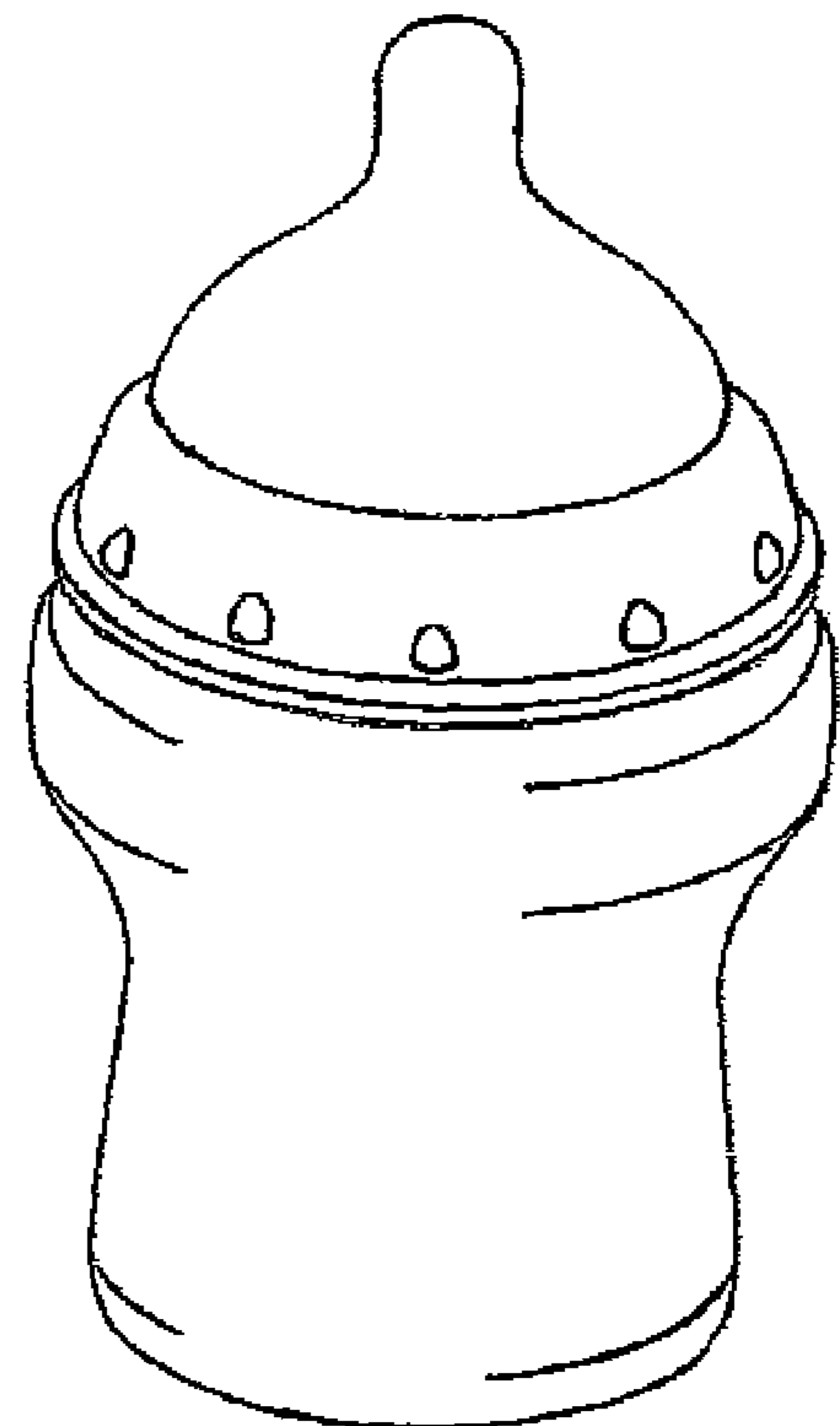

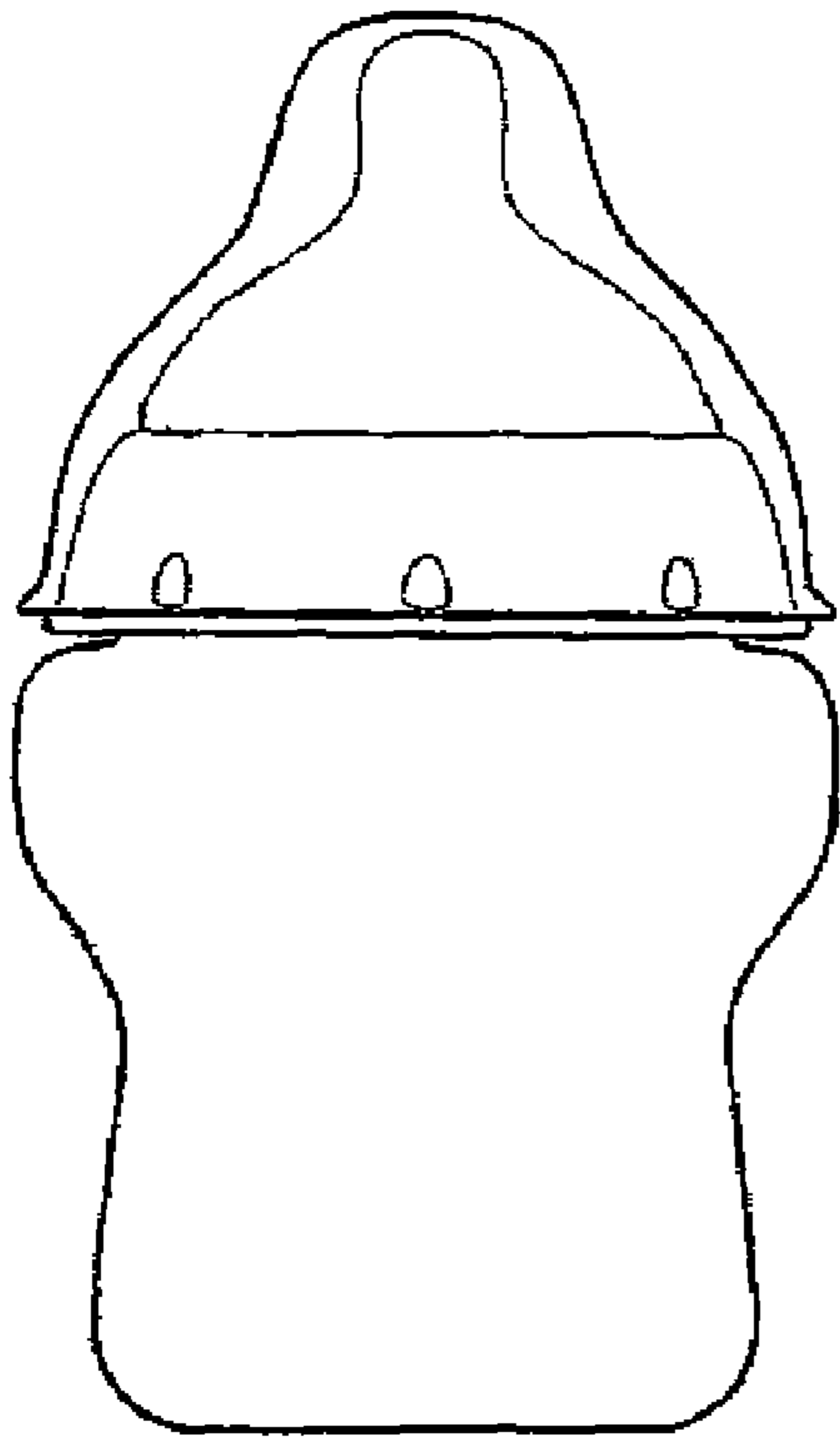

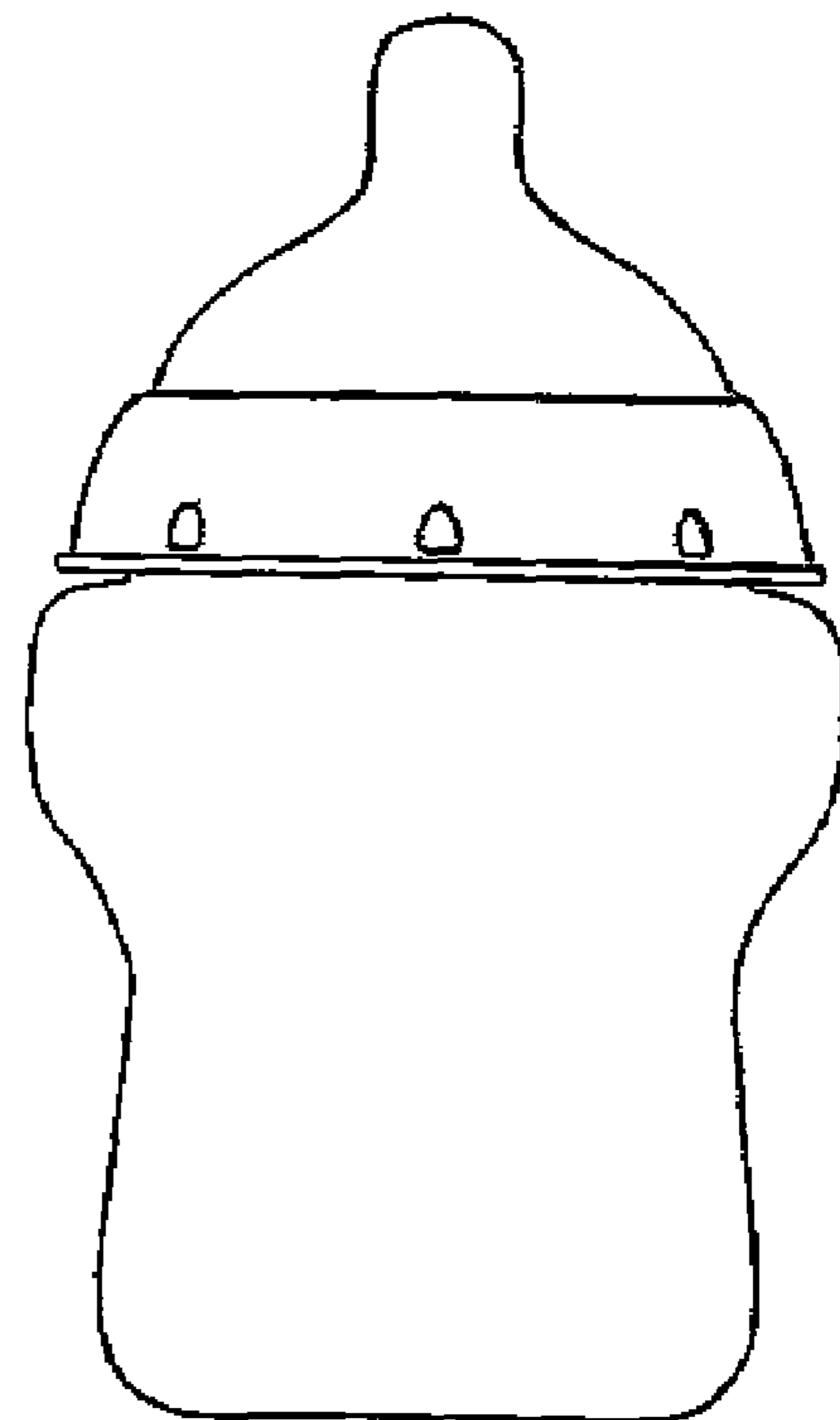

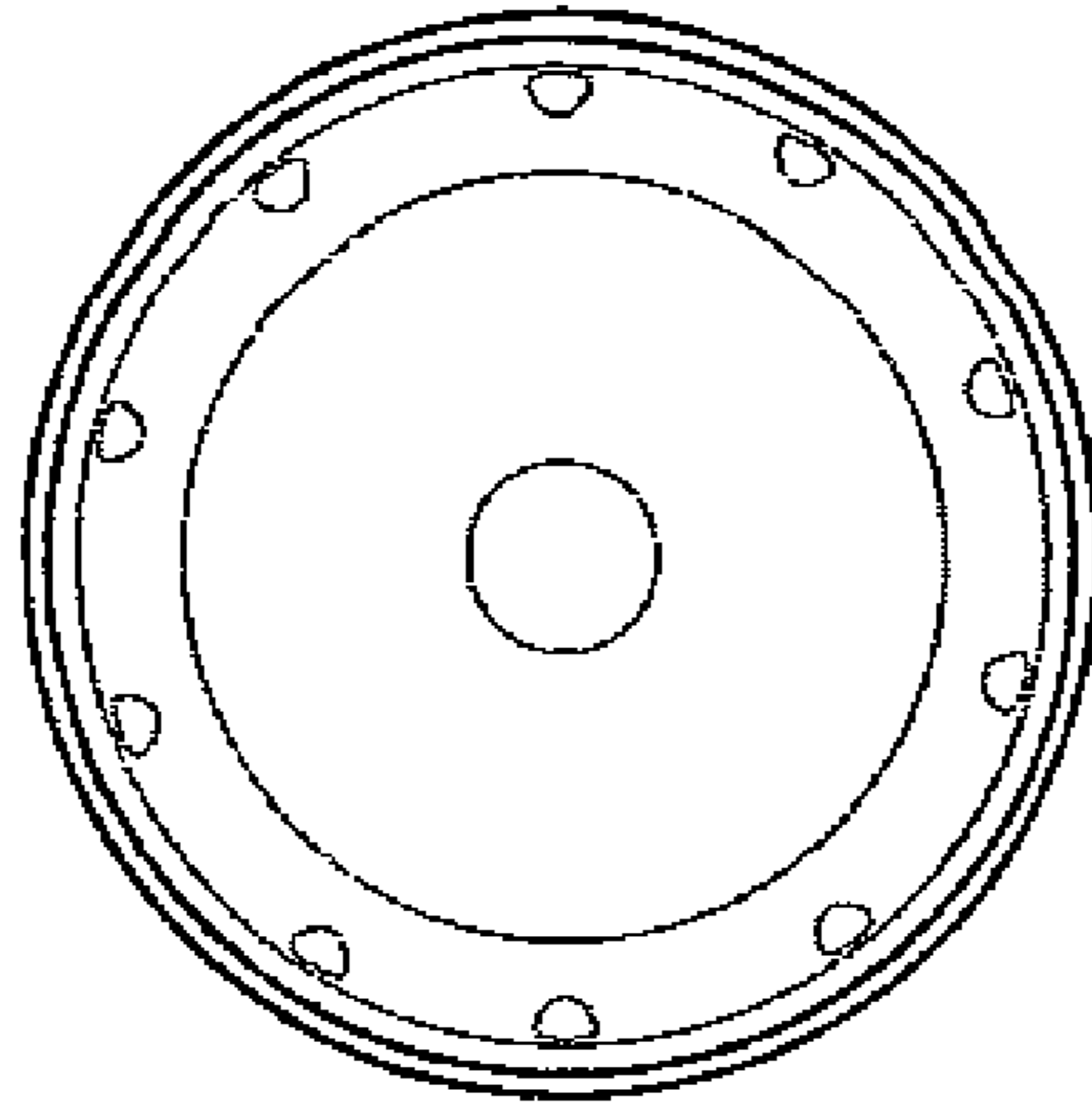

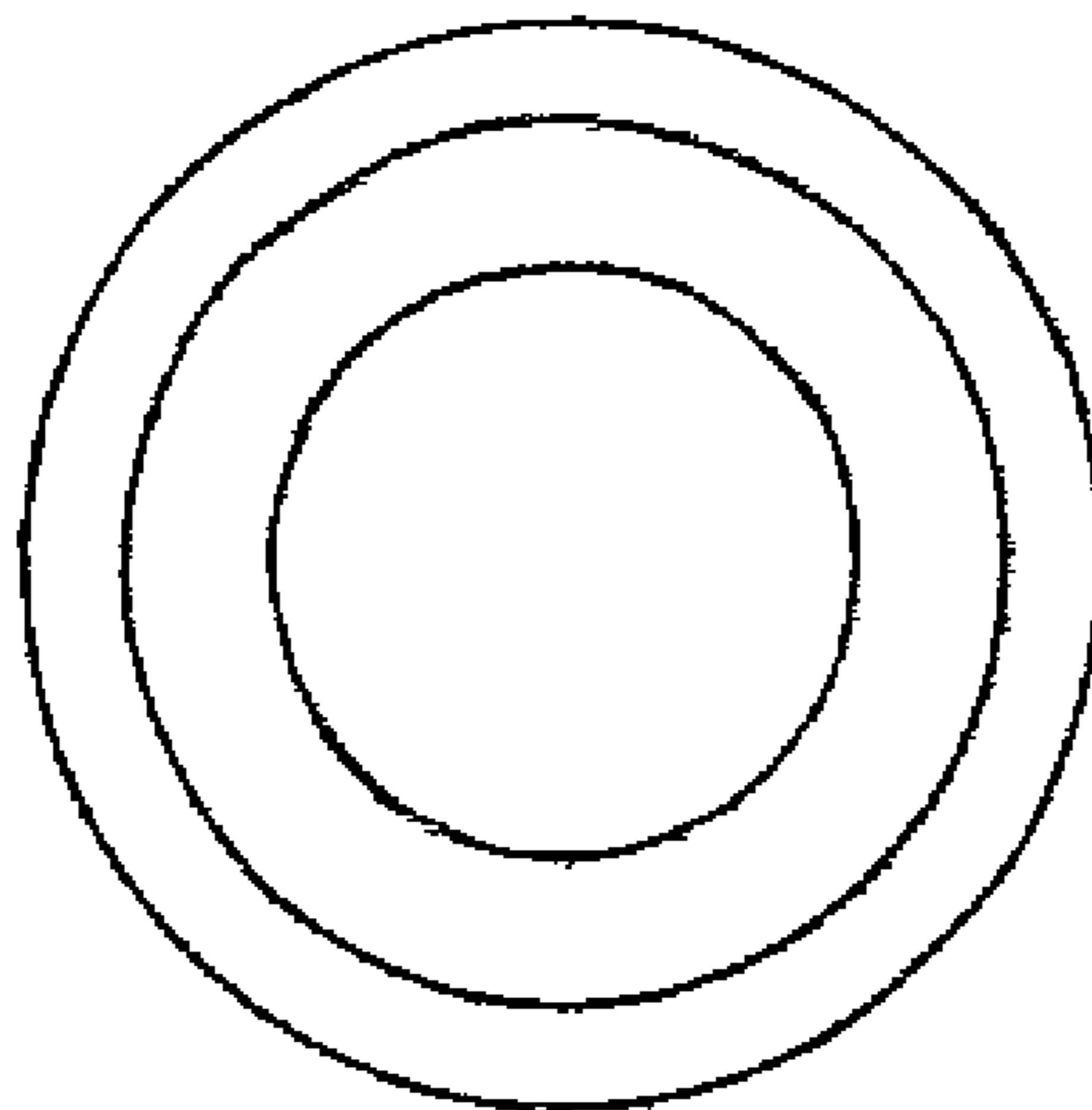
