FIG. 5 is a top plan view, thereof;

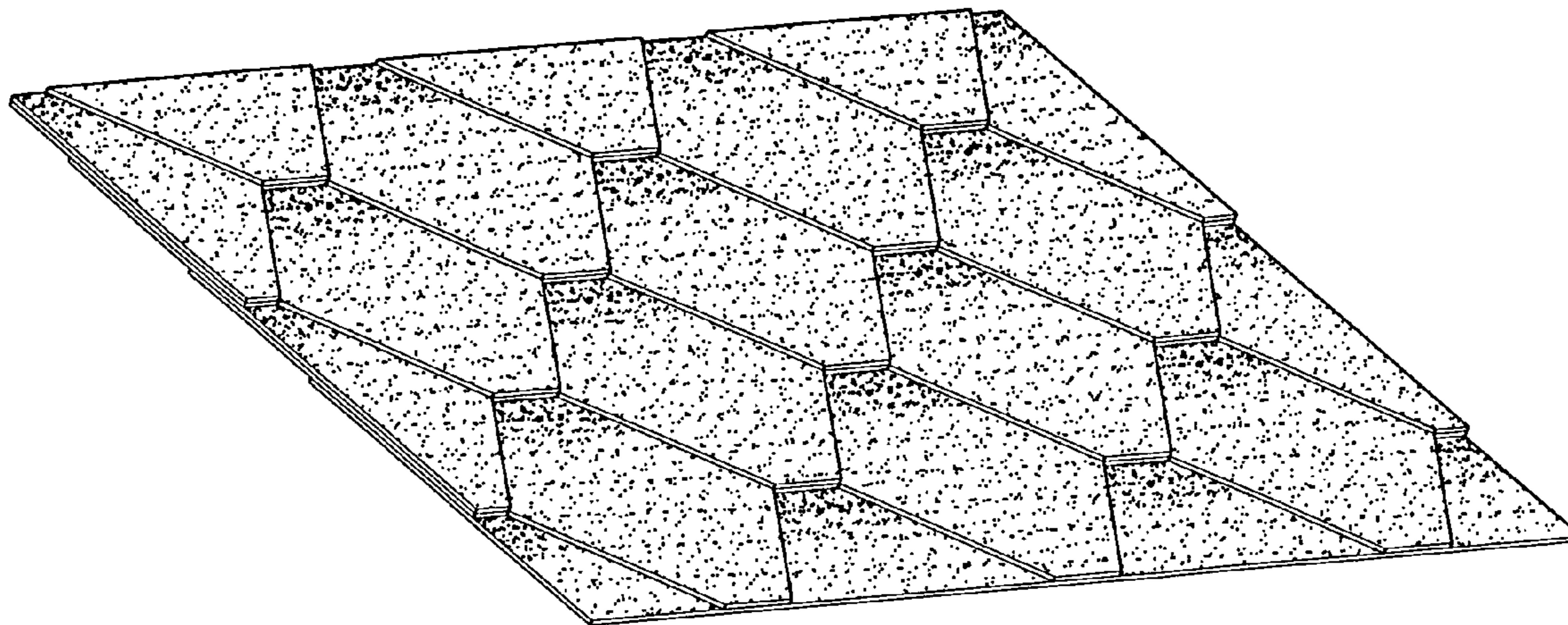
FIG. 6 is a right front perspective, thereof;

FIG. 7 is a left front perspective of a third embodiment of our roof covering;

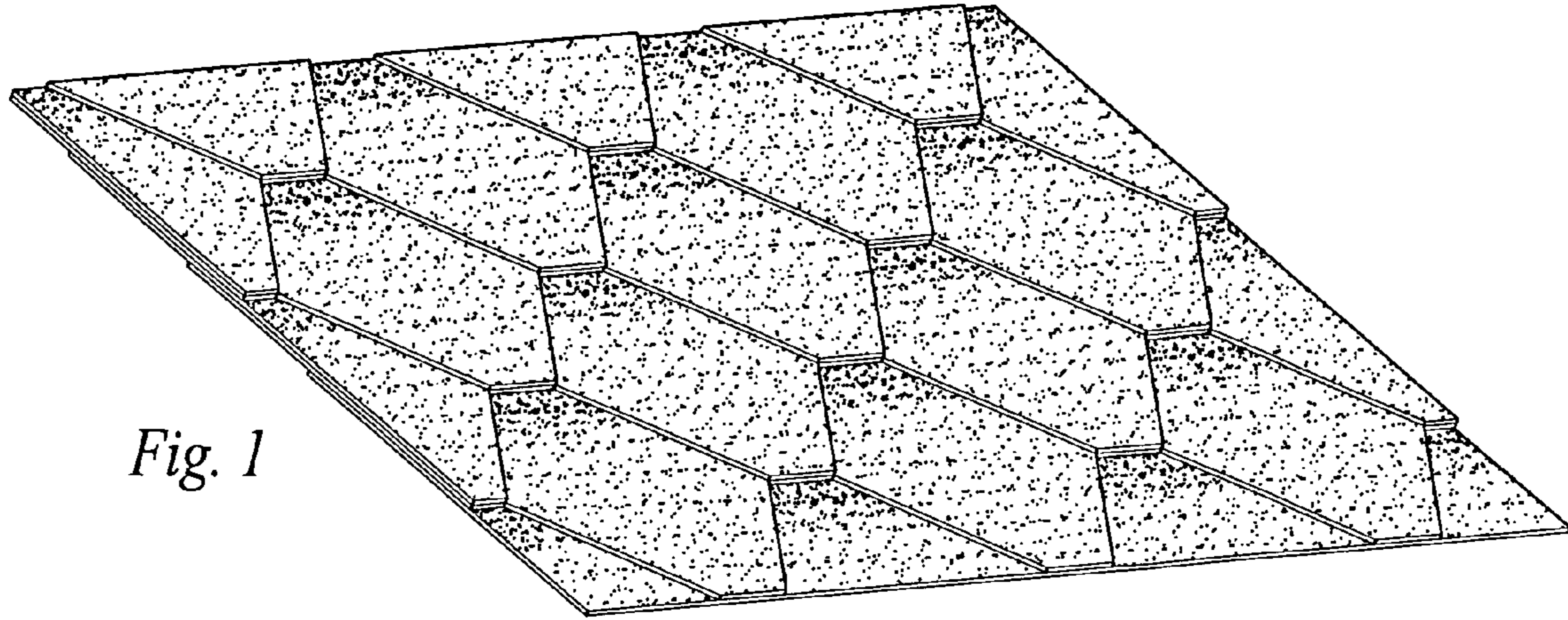
FIG. 8 is a top plan view, thereof; and,

FIG. 9 is a right front perspective, thereof.

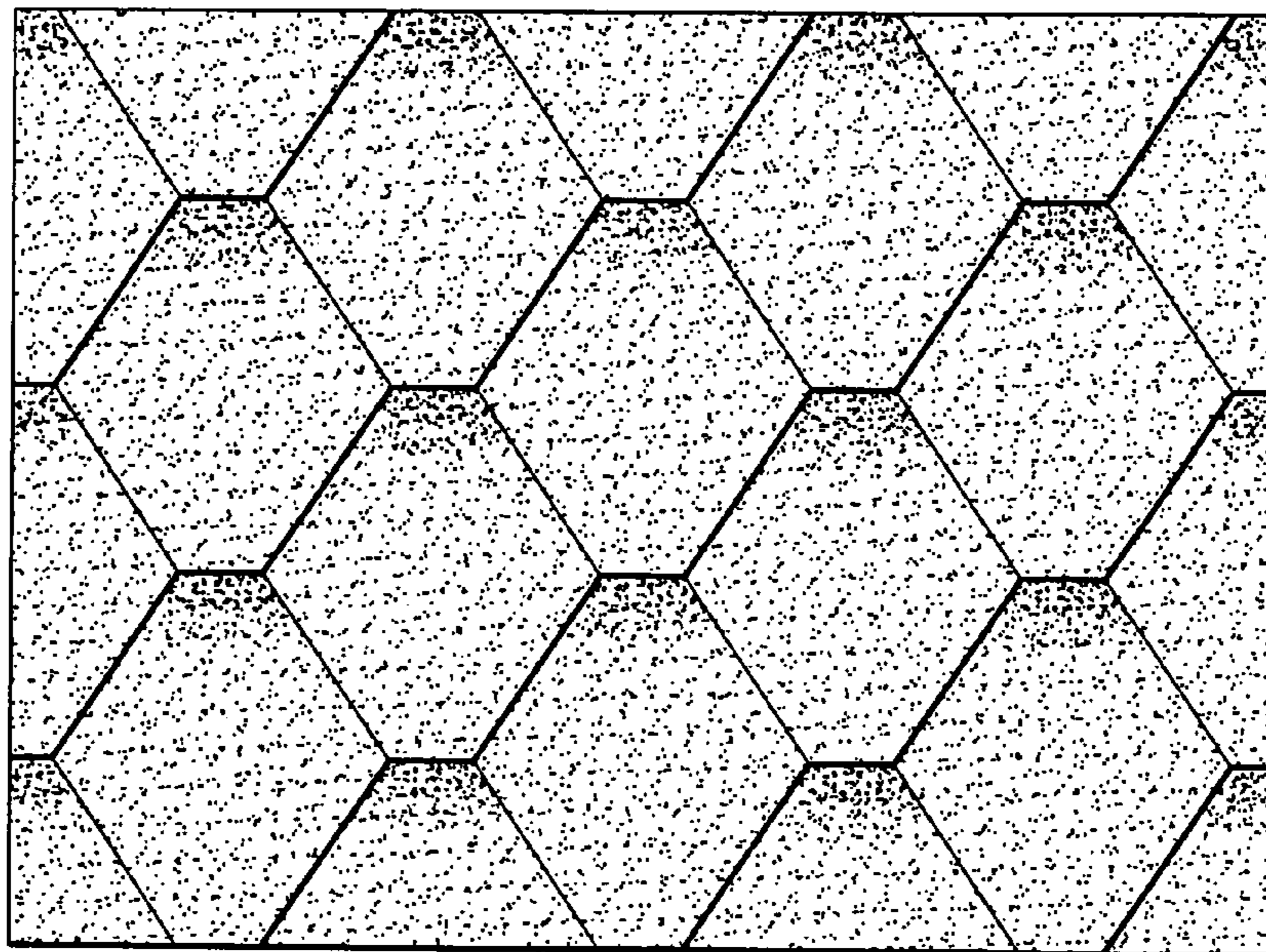

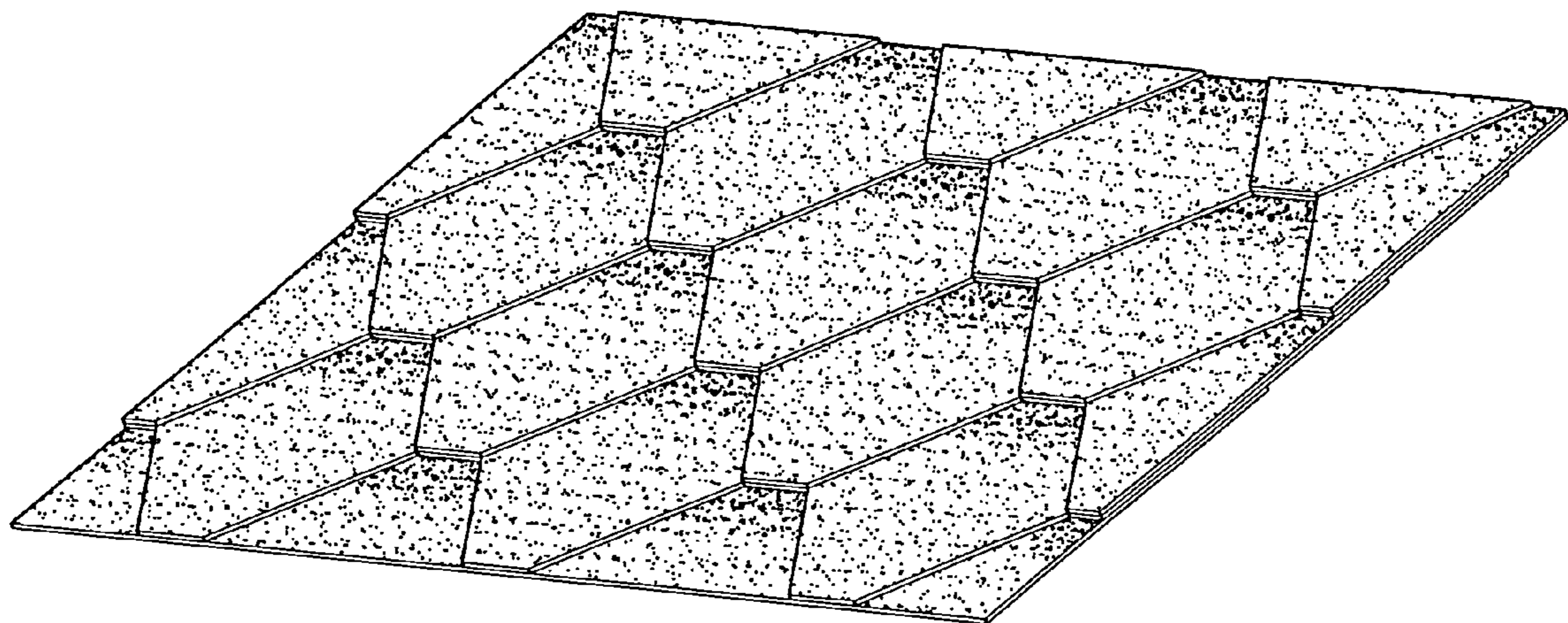

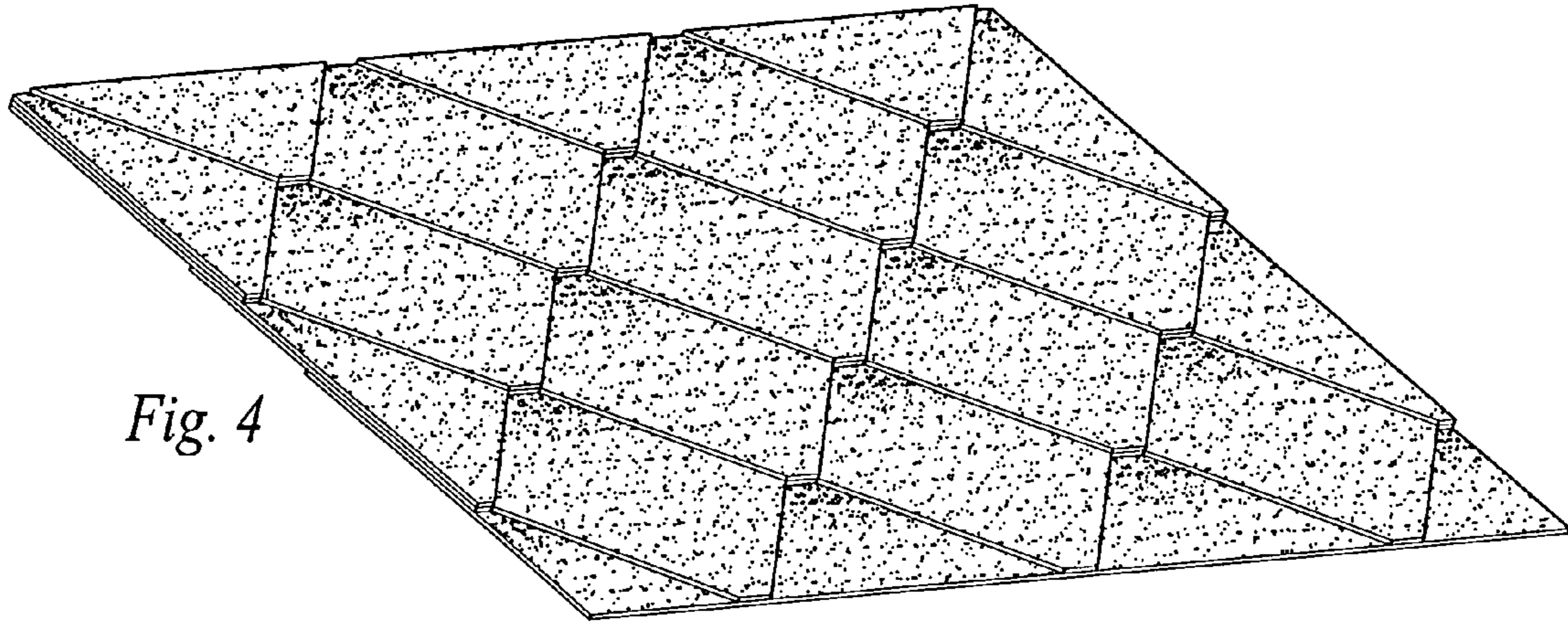

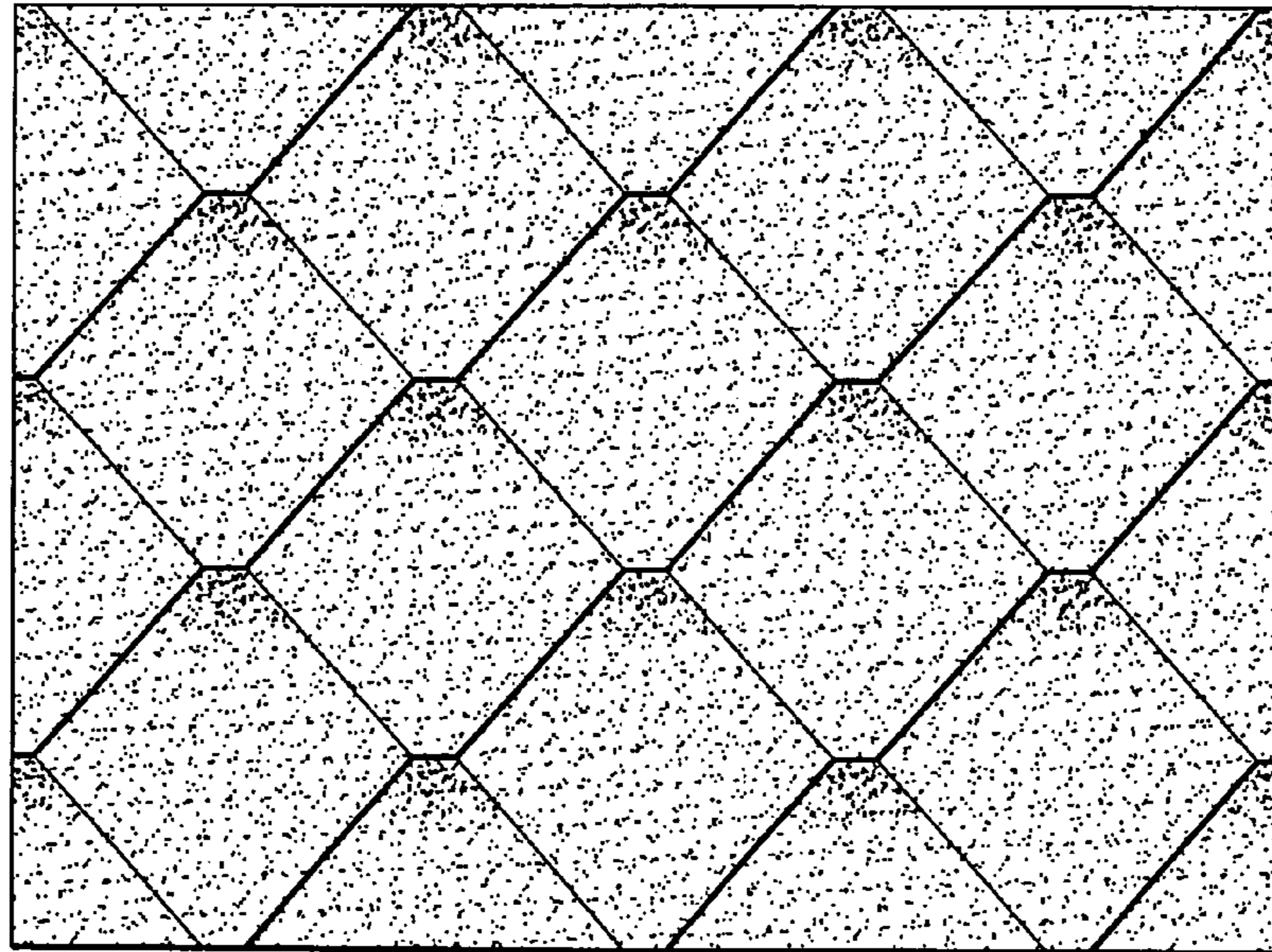

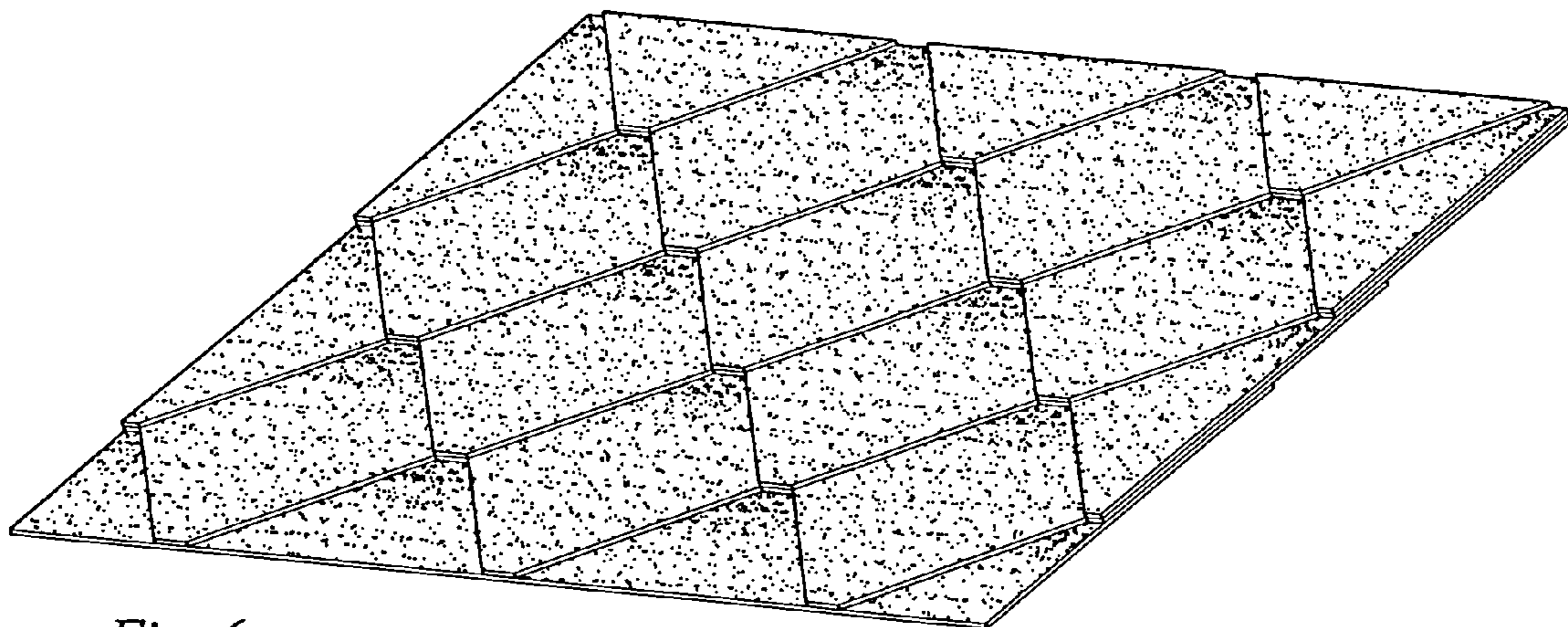

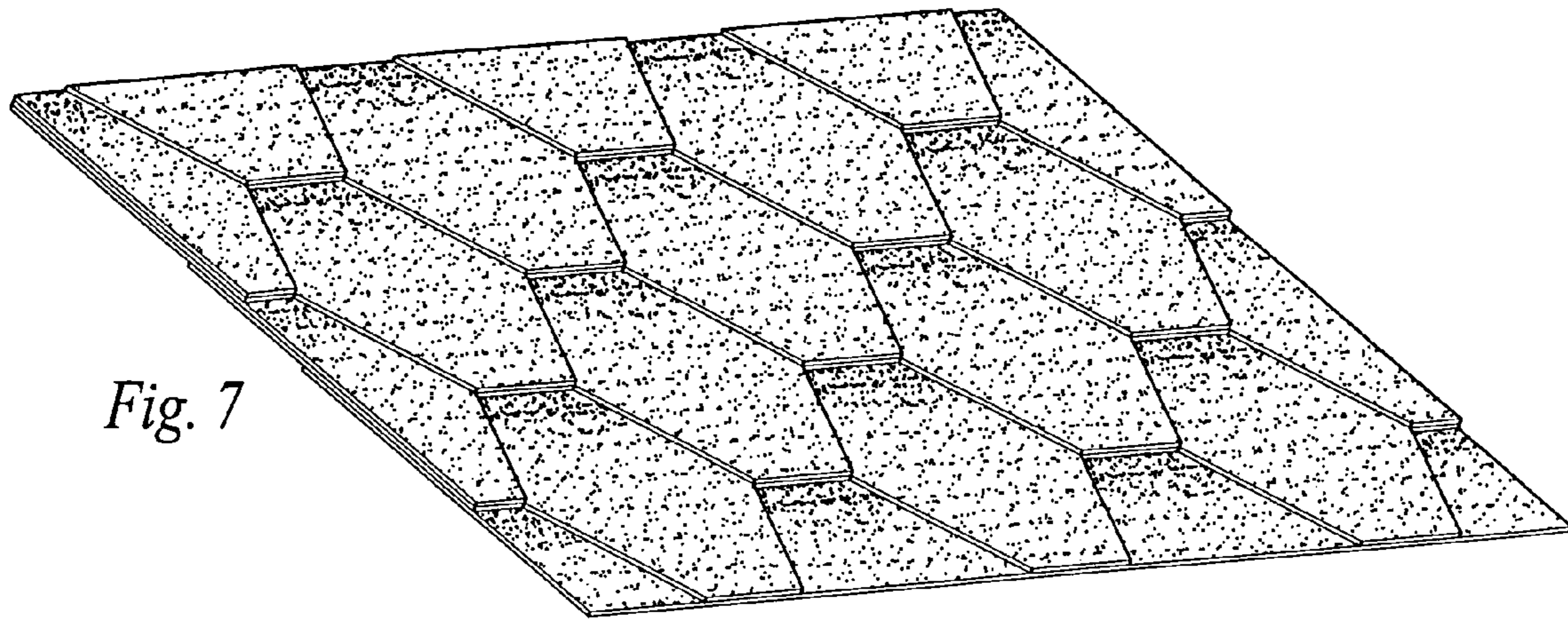

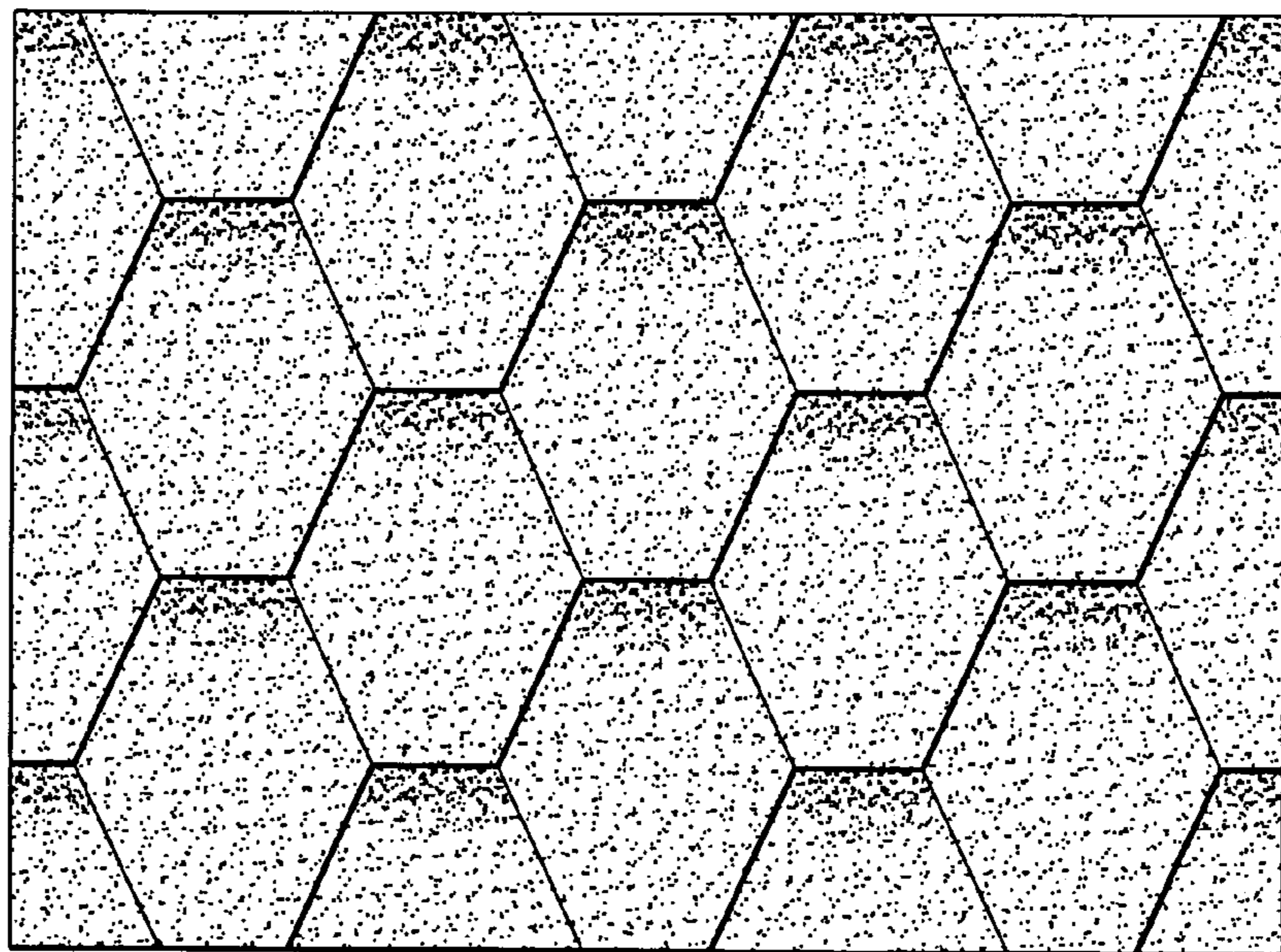

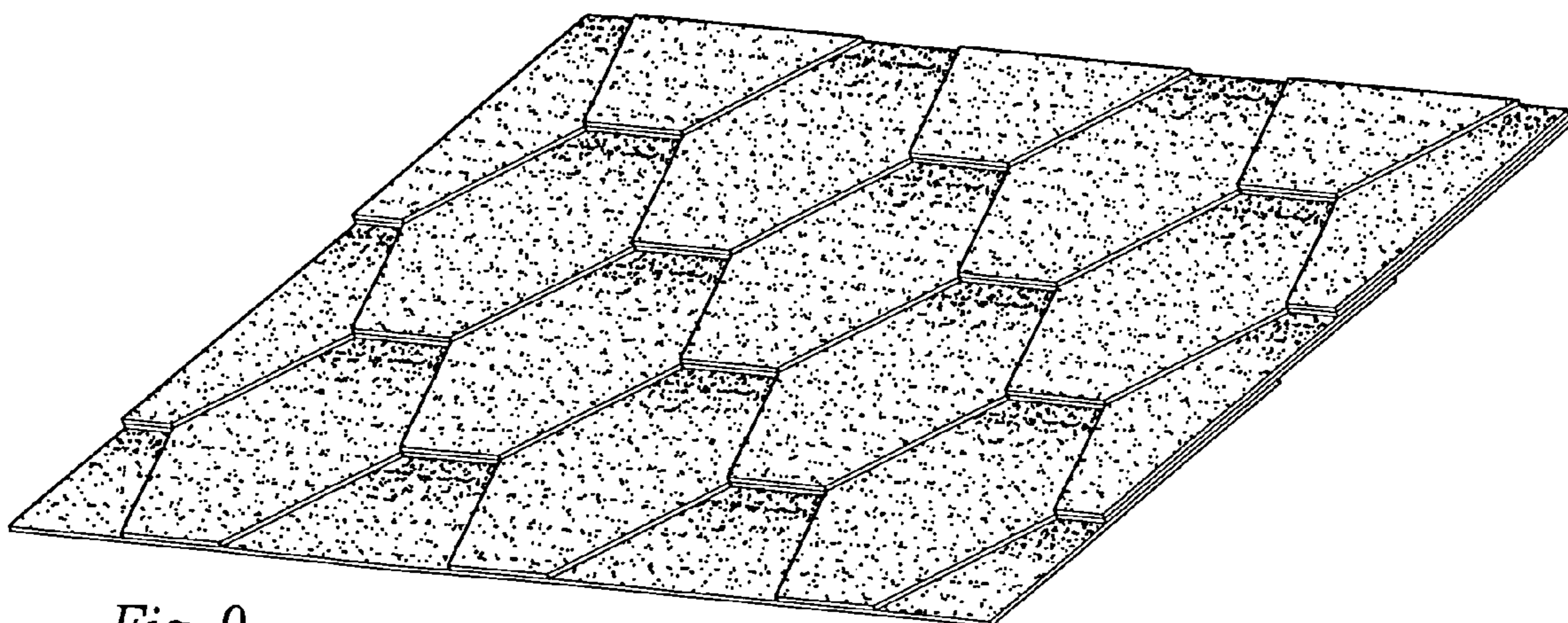
