DESCRIPTION

FIG. 1 is a bottom perspective view of a light fixture in accordance with my design, illustrating a first adjustable position of various portions of the light fixture;

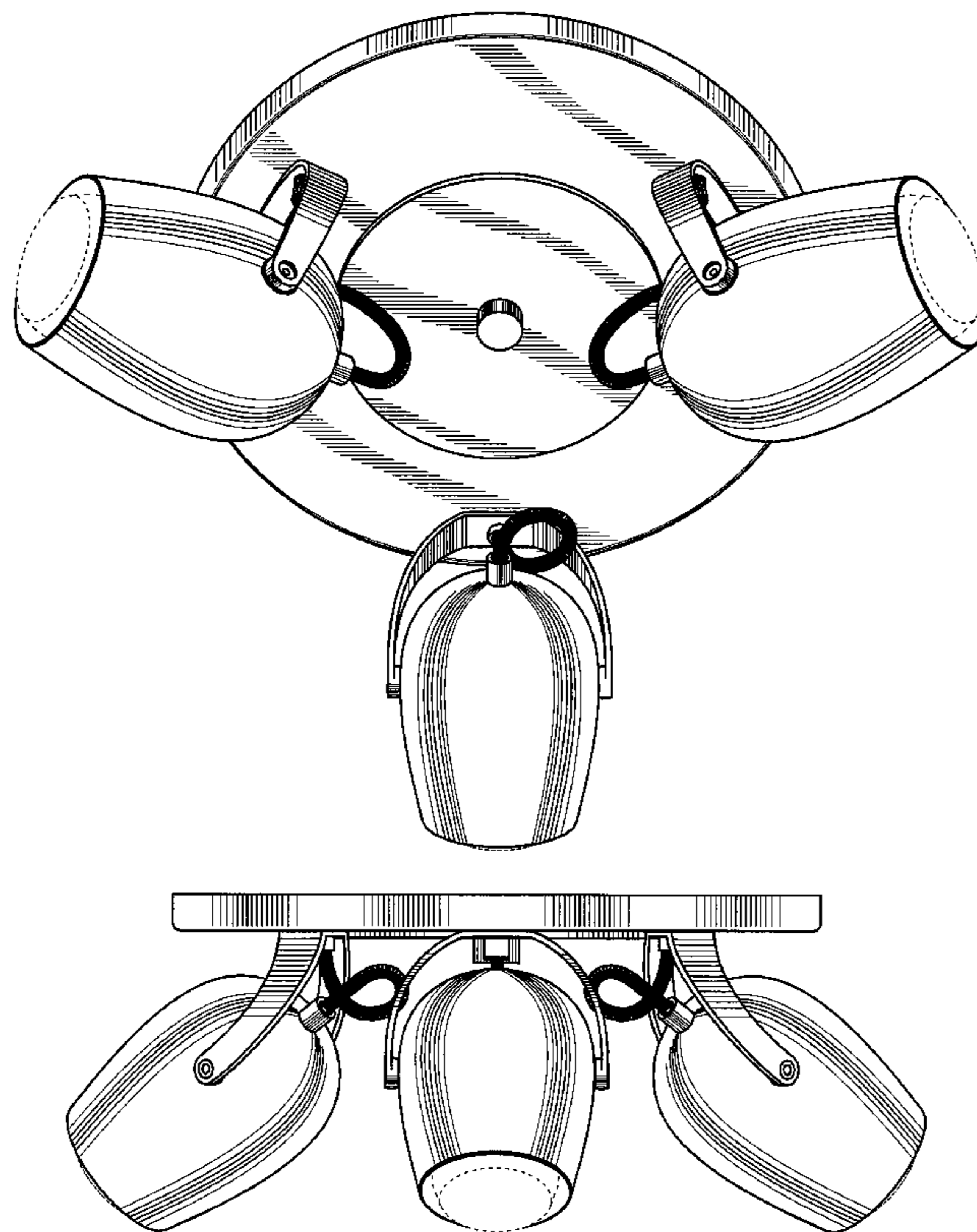
FIG. 2 is a front elevation view of the light fixture in accordance with my design, illustrating a first adjustable position of various portions of the light fixture;

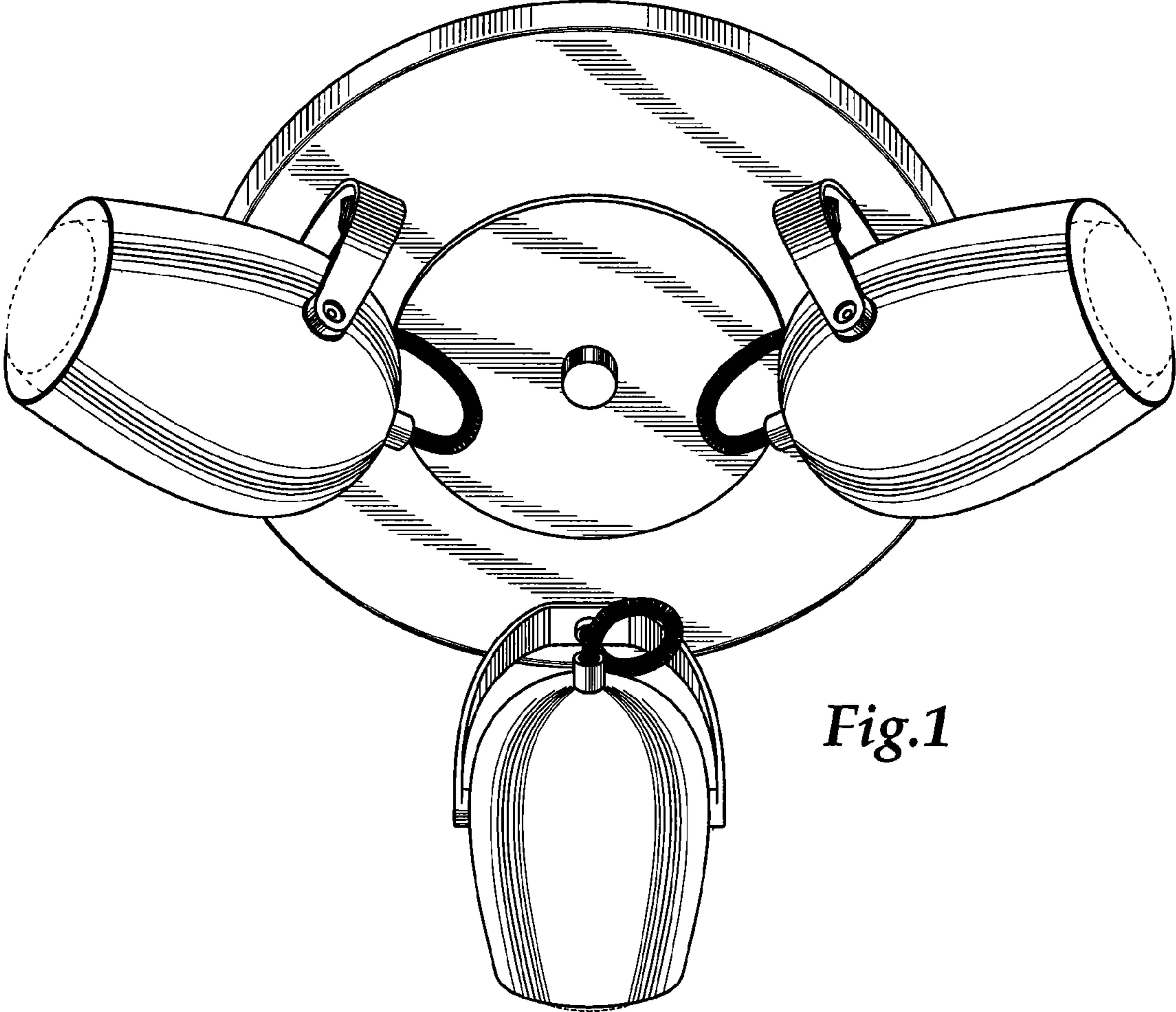

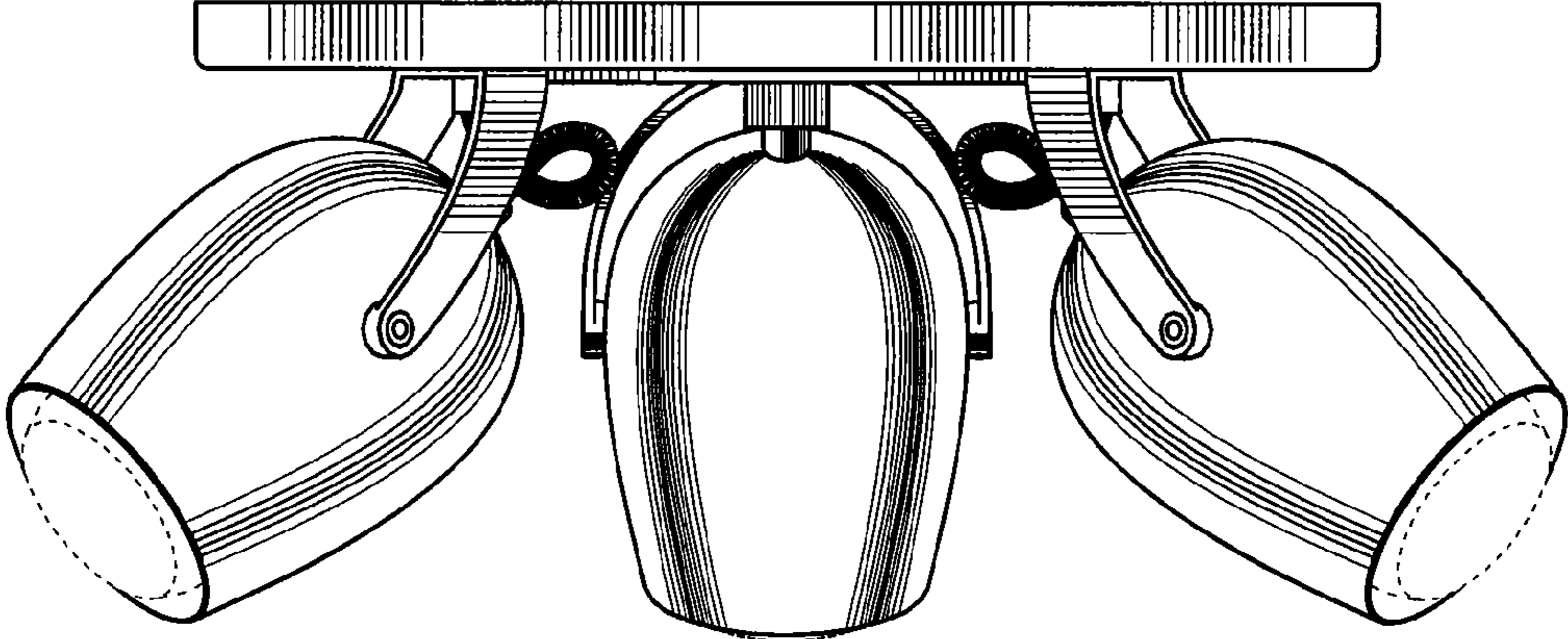

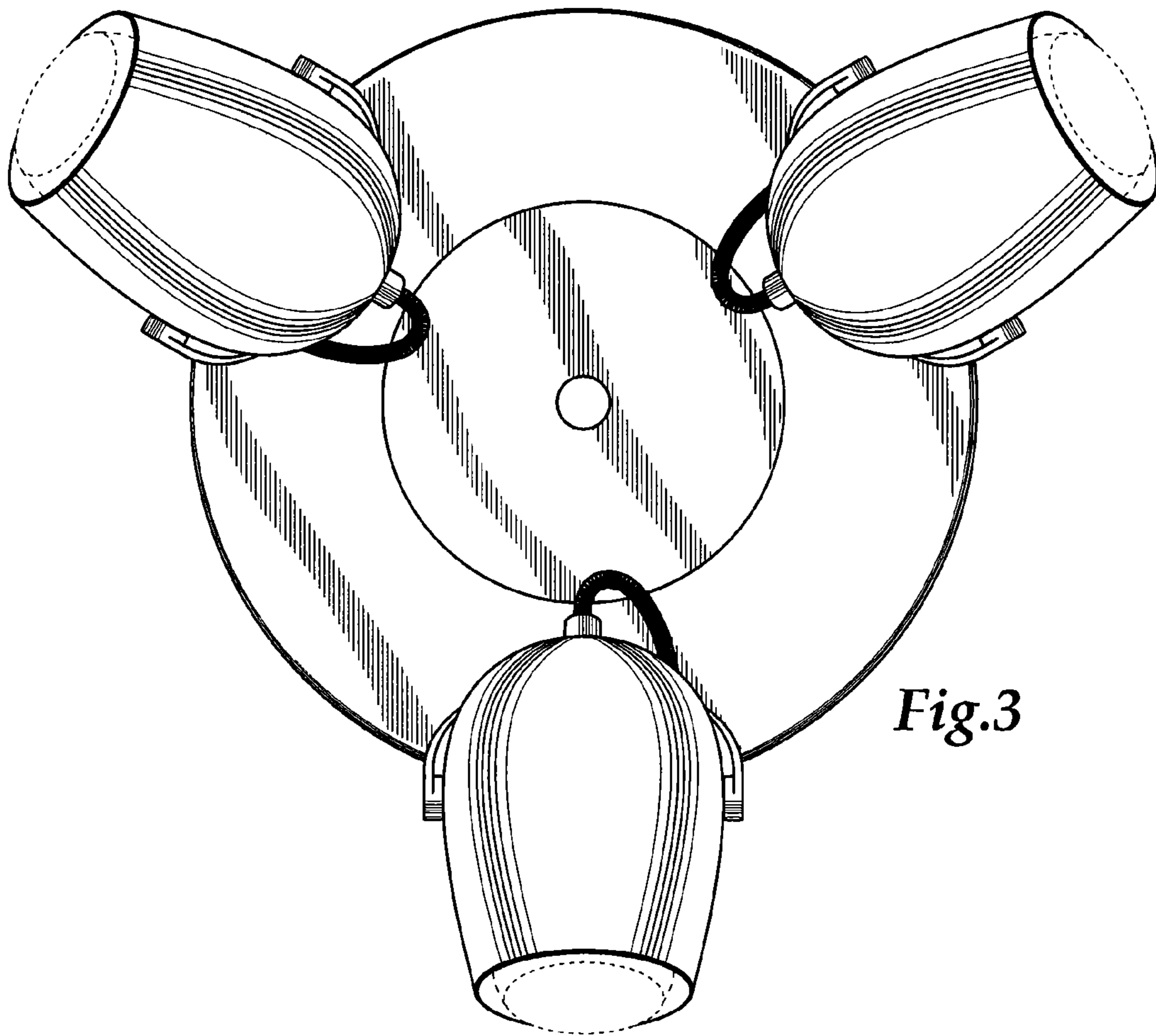

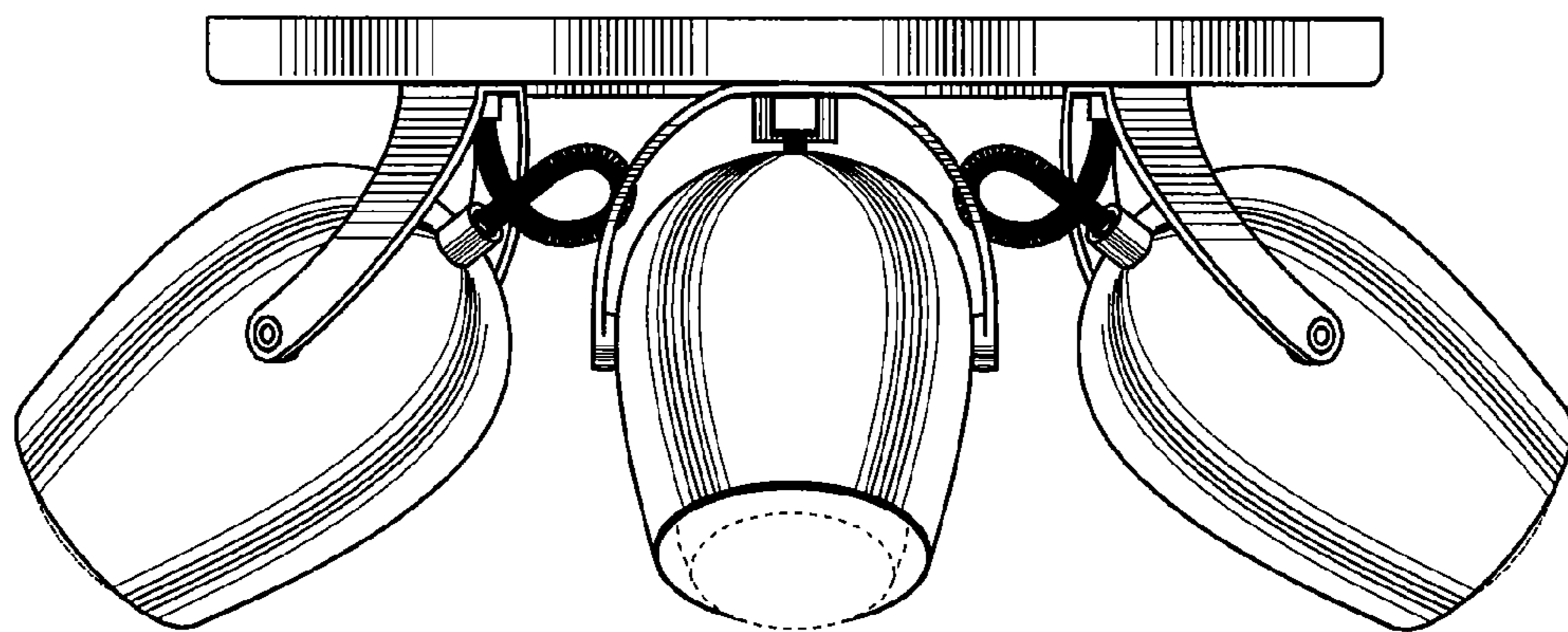
