**DESCRIPTION**

FIG. 1 is a perspective view of a light fixture in accordance with my design;

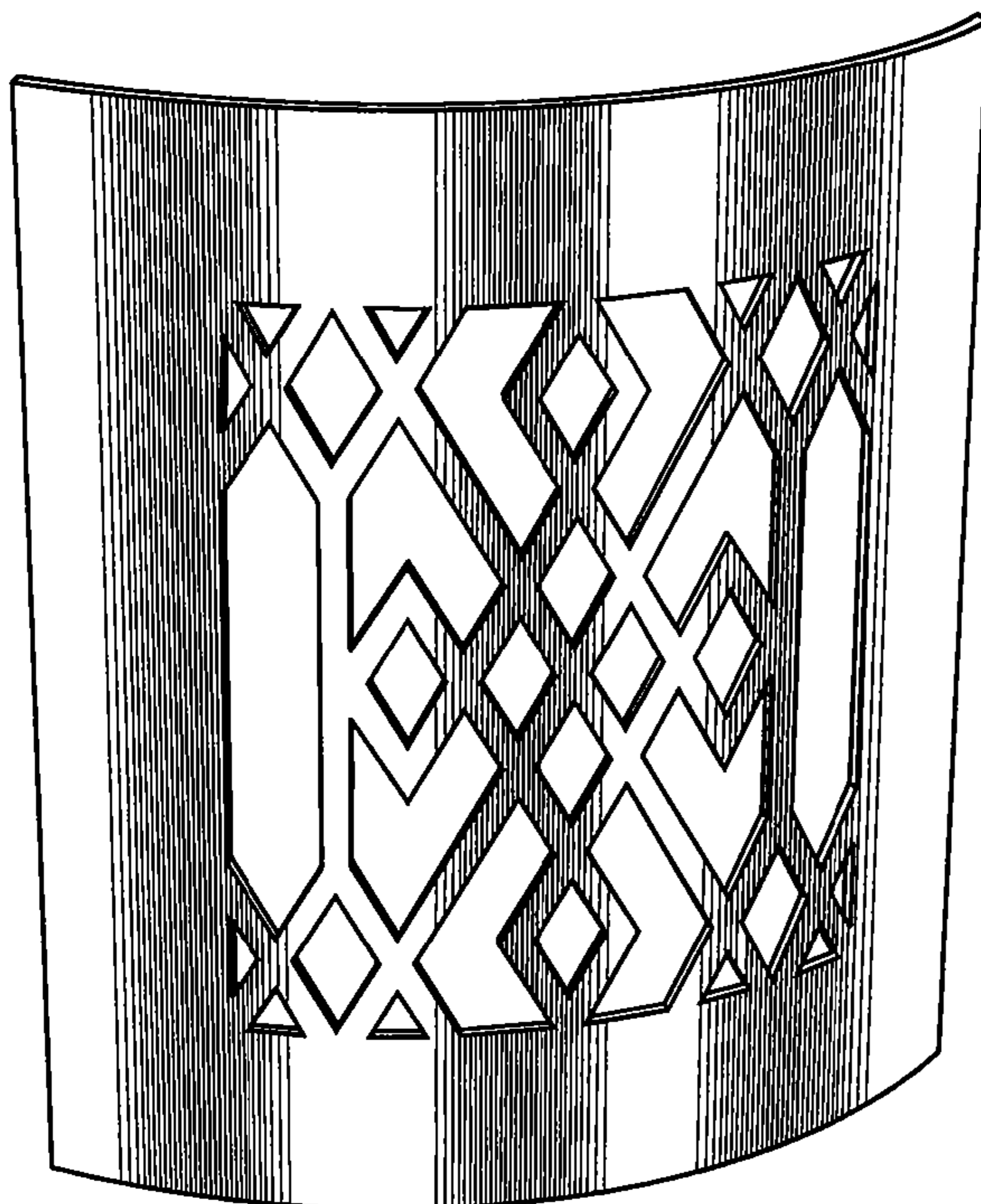
FIG. 2 is a front elevation view of the light fixture in accordance with my design;

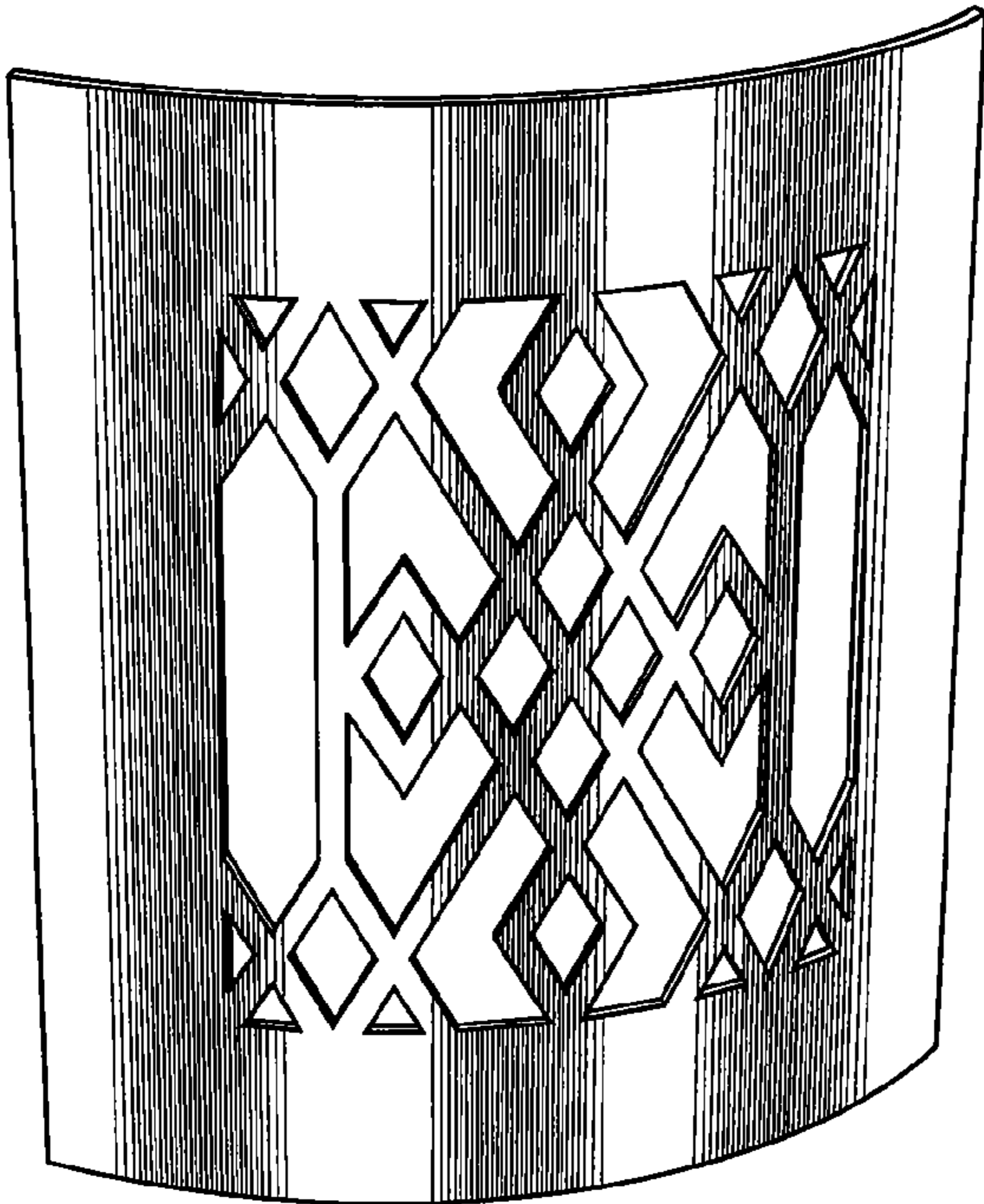
FIG. 3 is a top plan view of the light fixture in accordance with my design, the opposite view being a mirror image of that shown; and,

FIG. 4 is a side elevation view of the light fixture in accordance with my design, the opposite view being a mirror image of that shown.

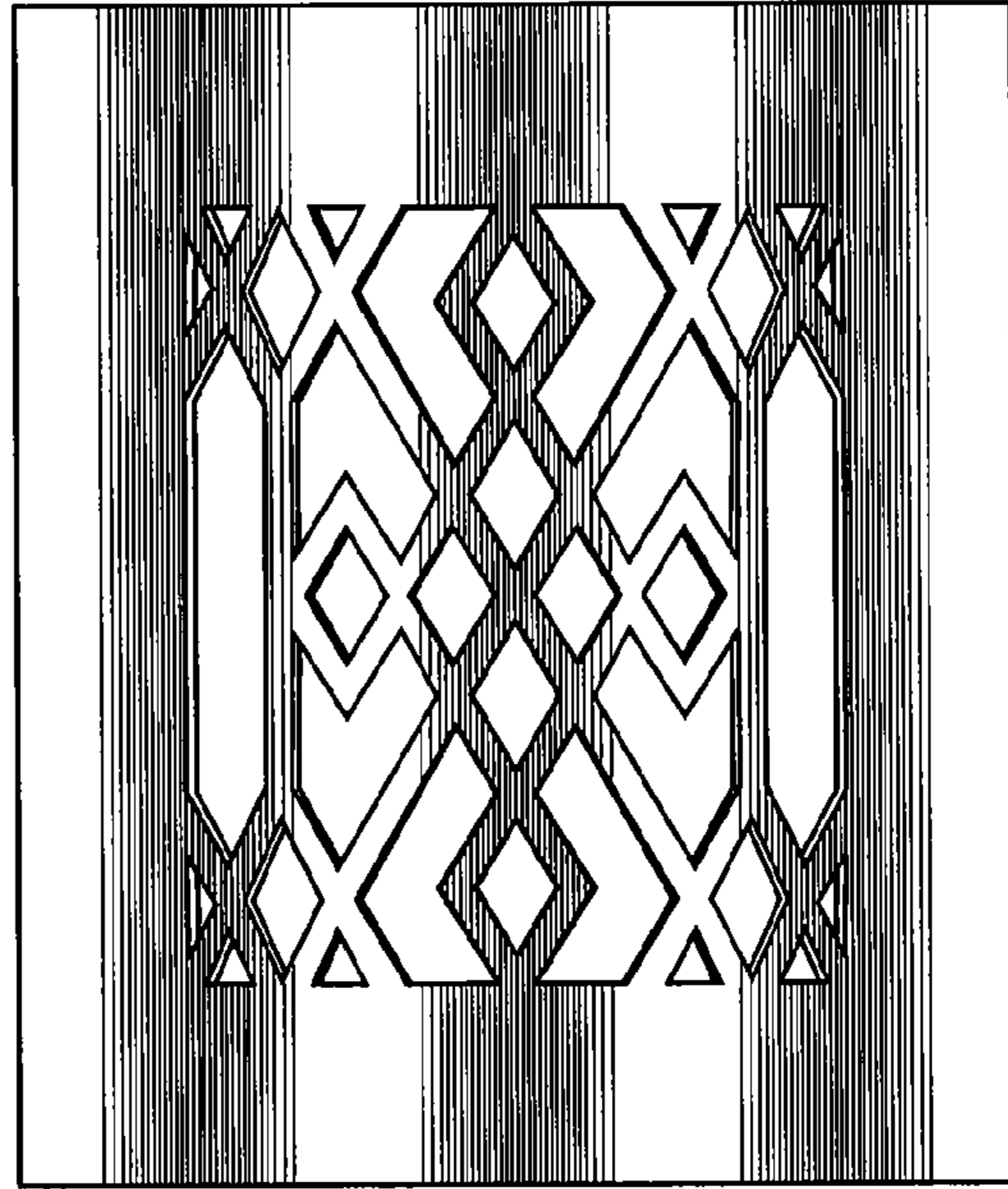
The broken lines showing environmental structure are for illustrative purposes only and form no part of the claimed design.

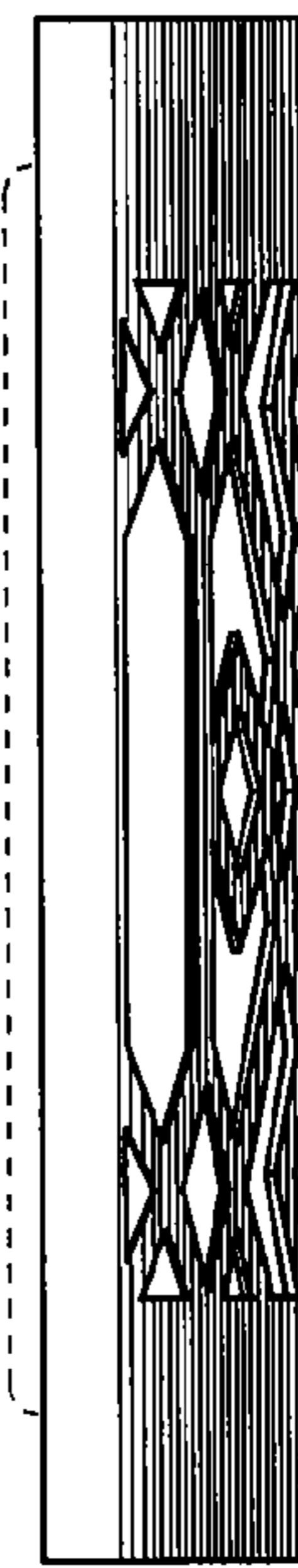
