**DESCRIPTION**

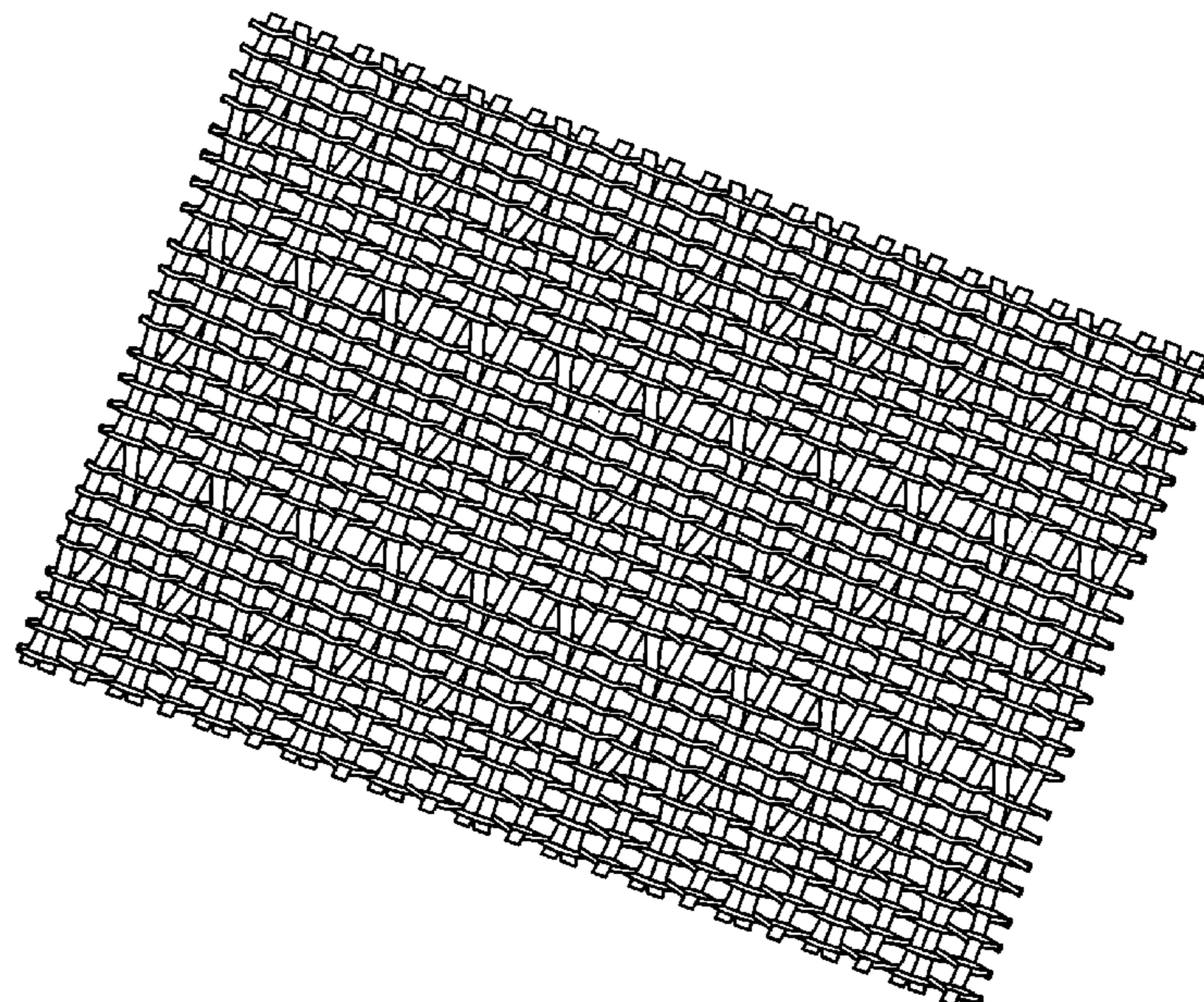
FIG. 1 is a perspective view of the mesh-chair cloth, embodying the new design;

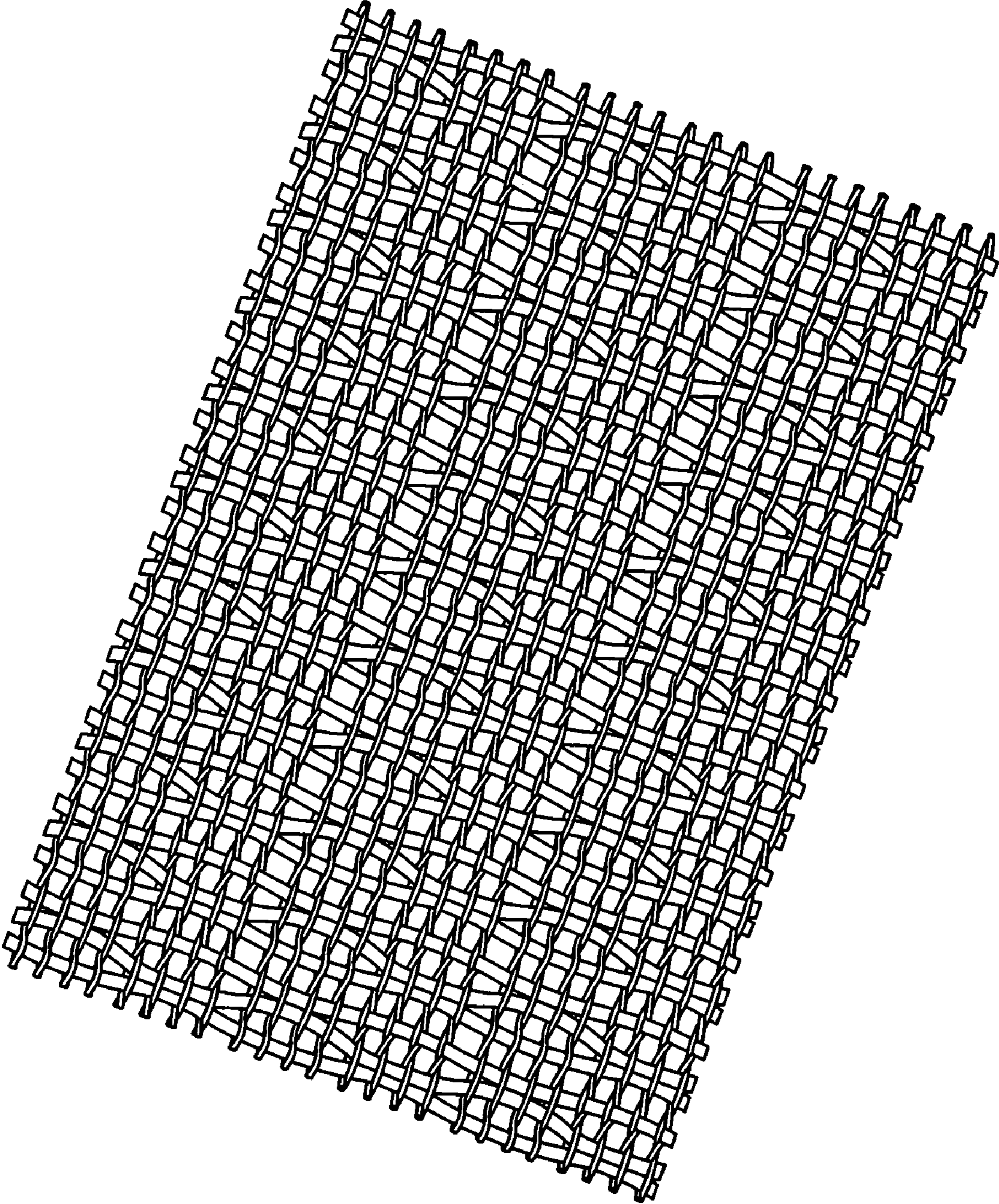

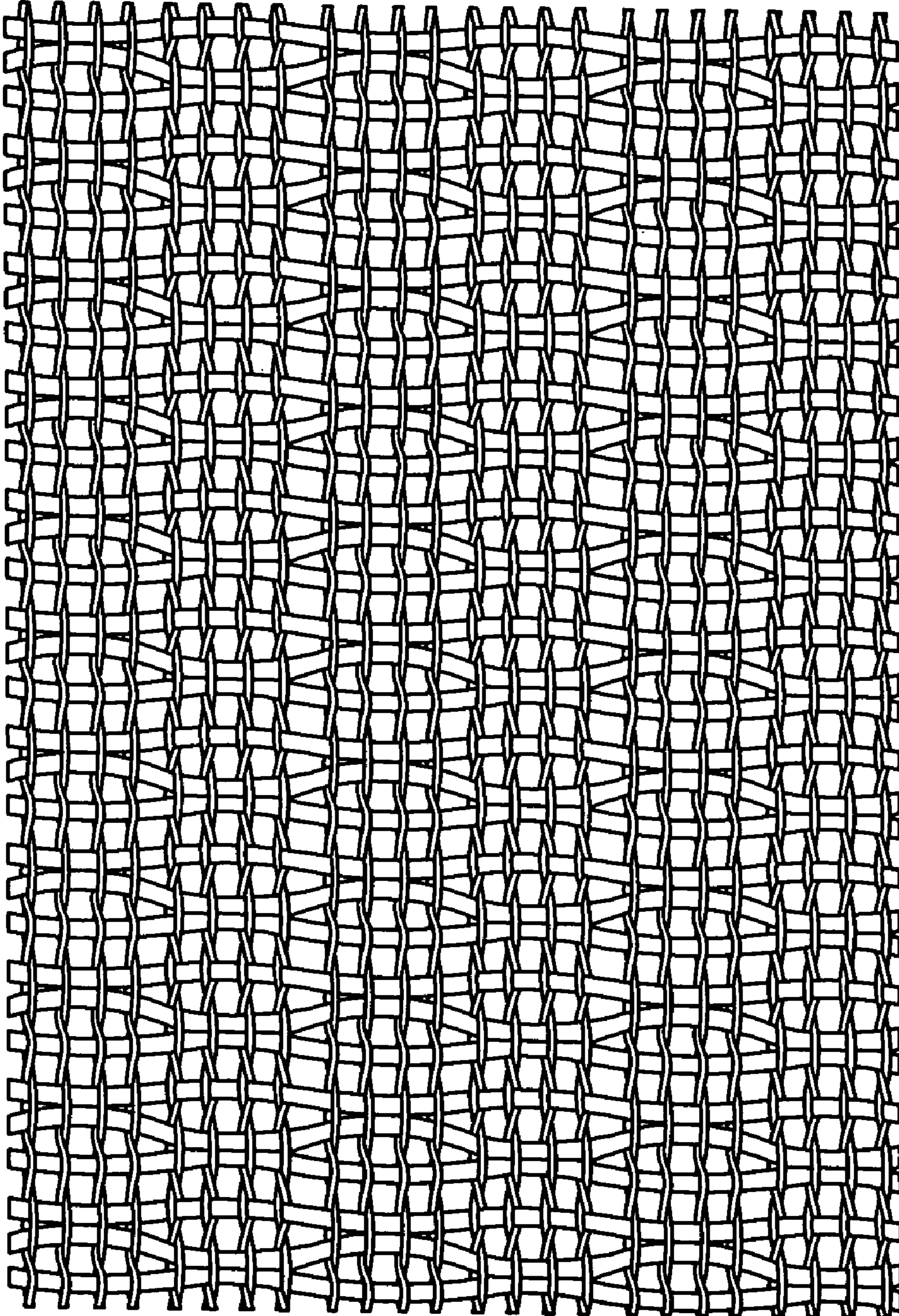
