(57) **CLAIM**

I claim the ornamental design for a carrycot, as shown and described.

**DESCRIPTION**

FIG. 1 illustrates a top, right, side perspective view of a carrycot showing my new design with the canopy in a down position;

FIG. 2 illustrates a rear perspective view of a carrycot showing my new design with the canopy in a down position;

FIG. 3 illustrates a top view of a carrycot showing my new design with the canopy in a down position;

FIG. 4 illustrates a bottom view of a carrycot showing my new design;

FIG. 5 illustrates a front perspective view of a carrycot showing my new design with the canopy in the upright position;

FIG. 6 illustrates a rear perspective view of a carrycot showing my new design with the canopy in the upright position;

FIG. 7 illustrates a right side perspective view of a carrycot showing my new design with the canopy in the upright position;

FIG. 8 illustrates a front view of a carrycot showing my new design with the canopy in the upright position; and,

FIG. 9 illustrates a rear view of a carrycot showing my new design with the canopy in the upright position.

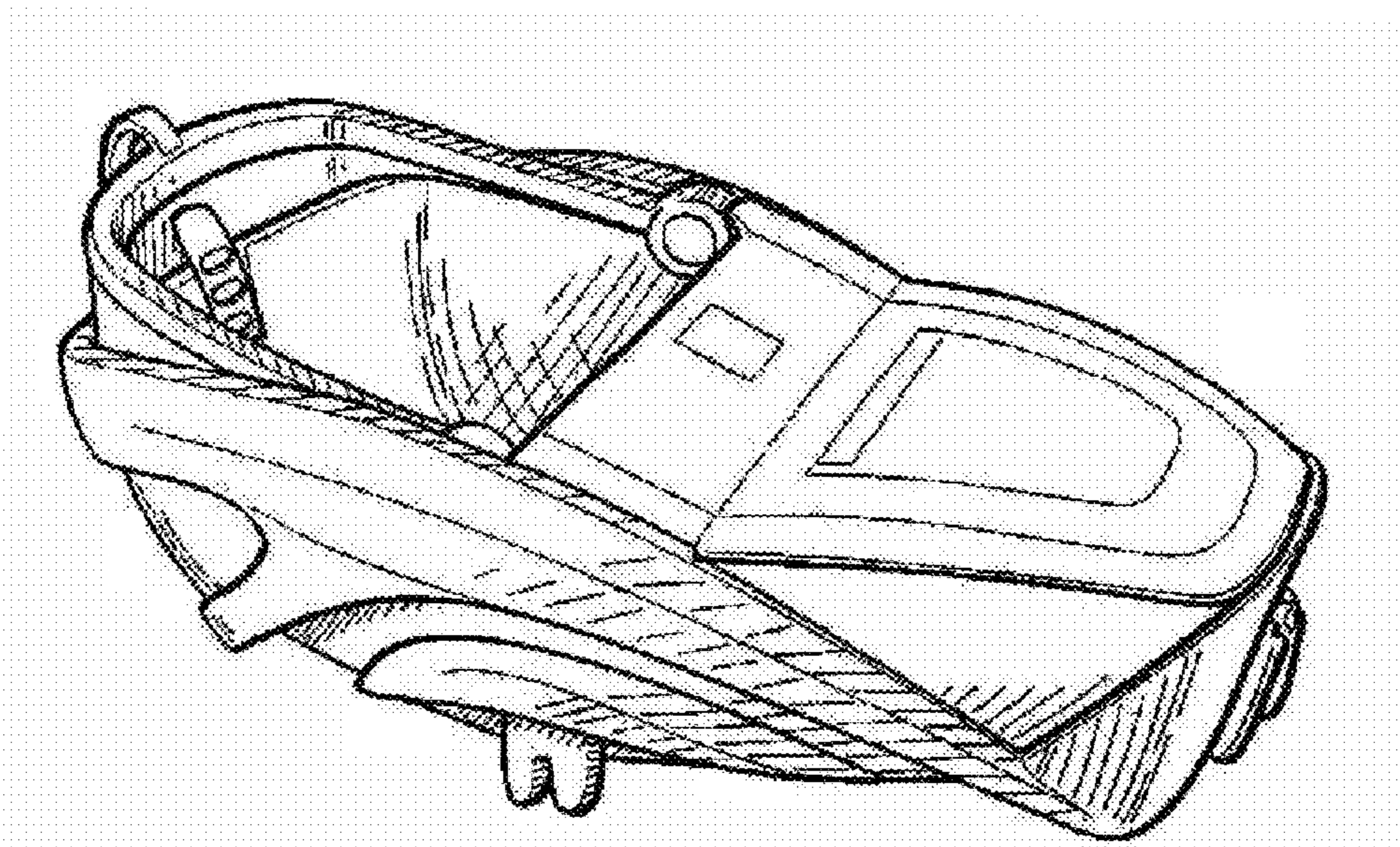

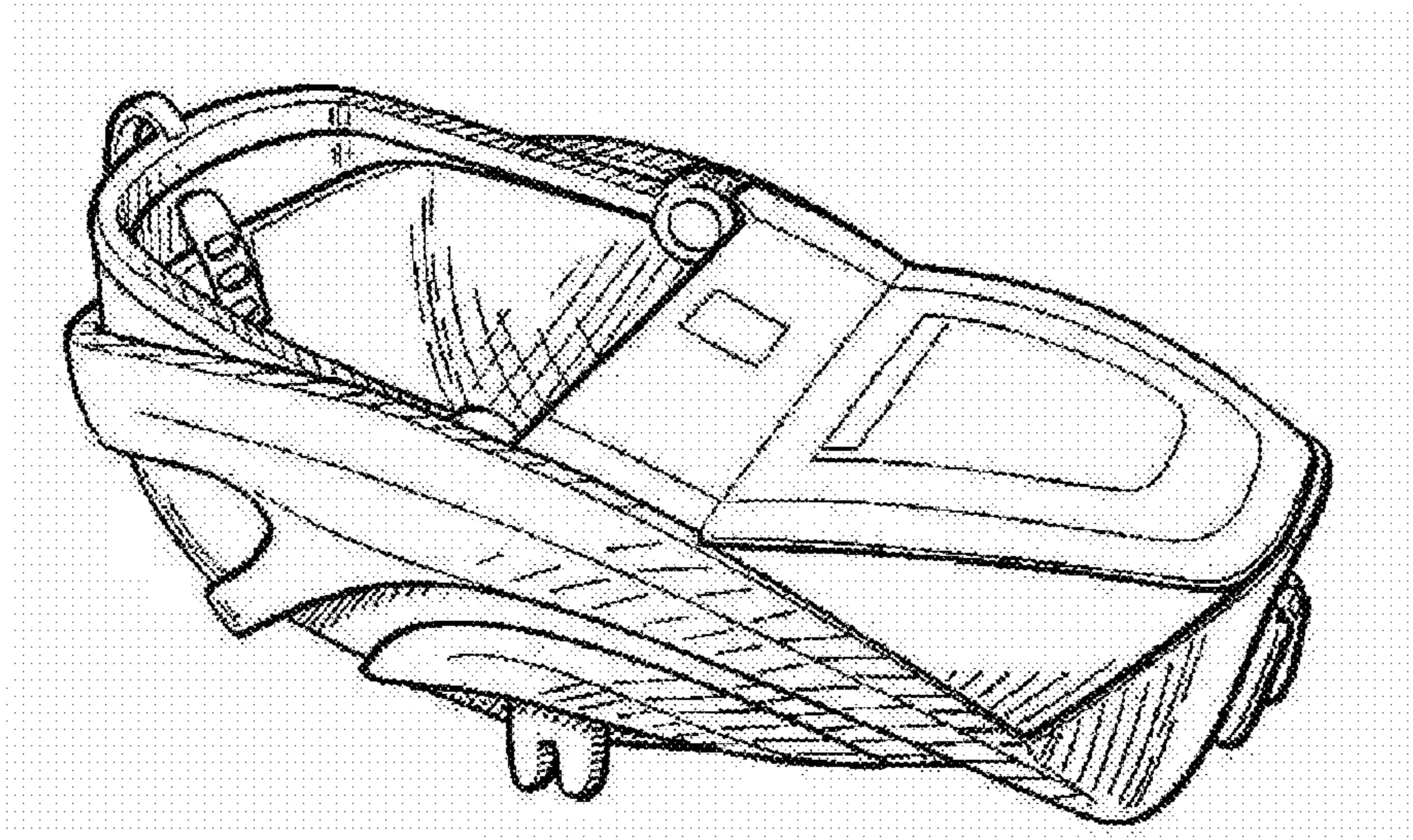

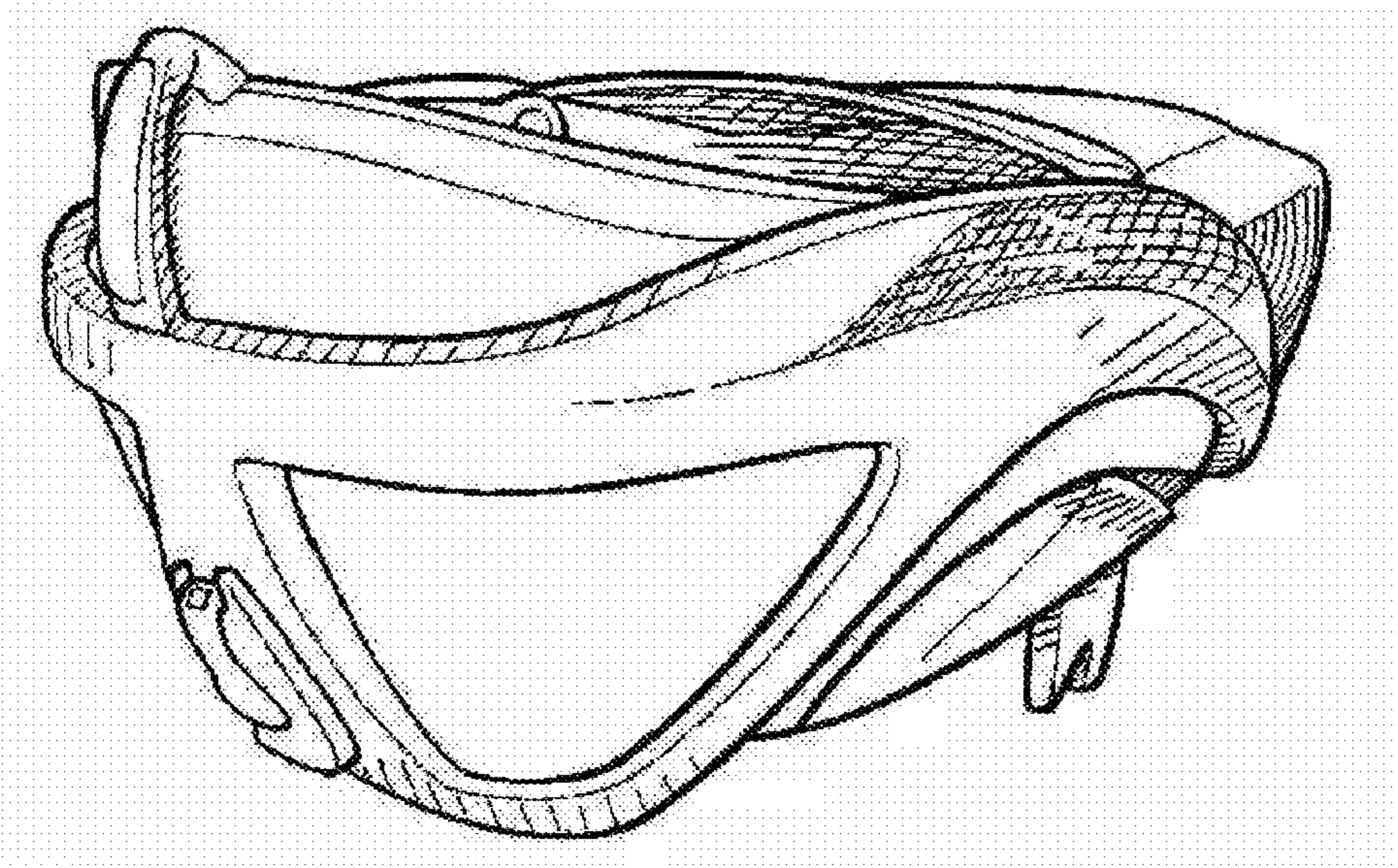

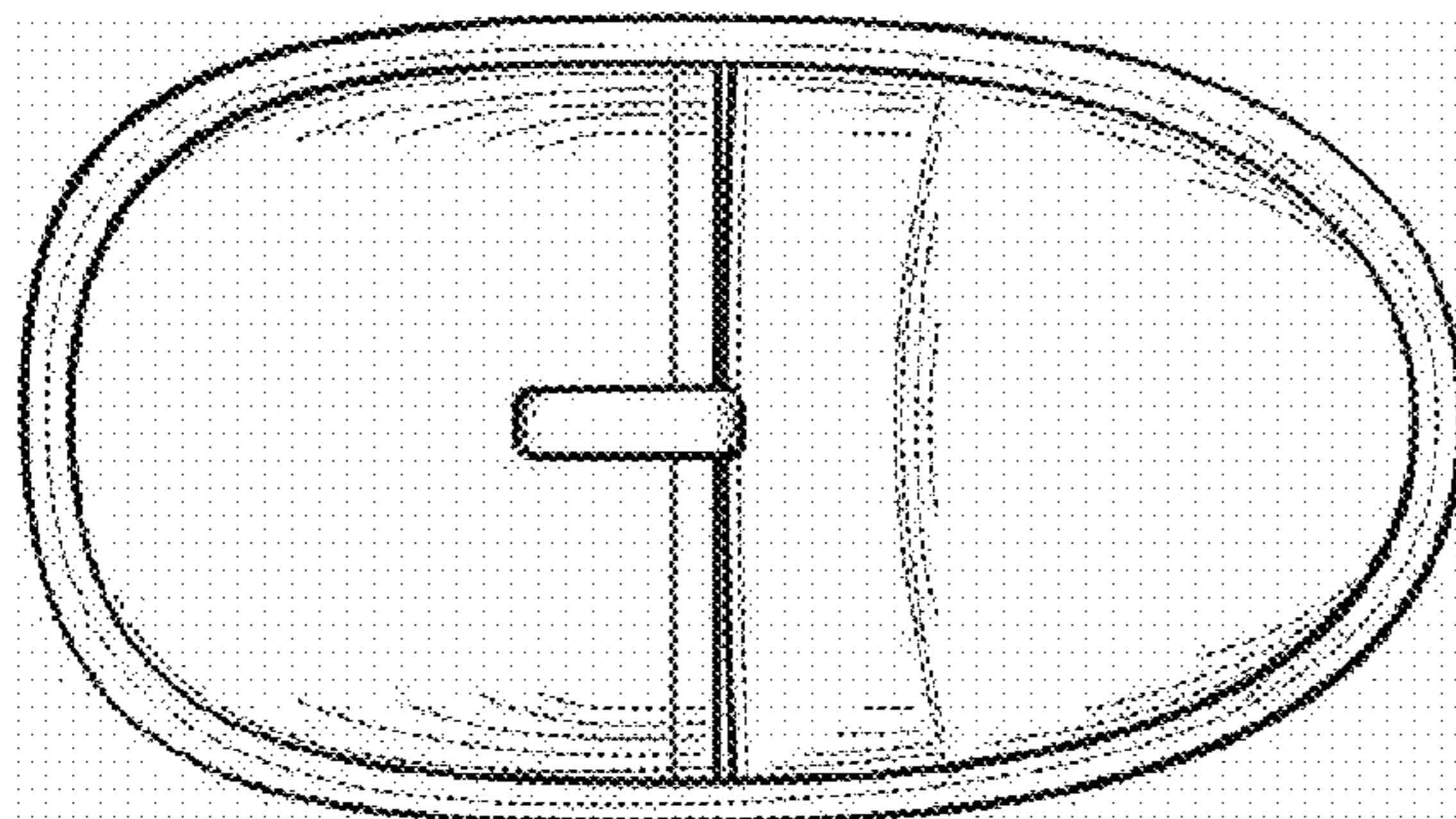

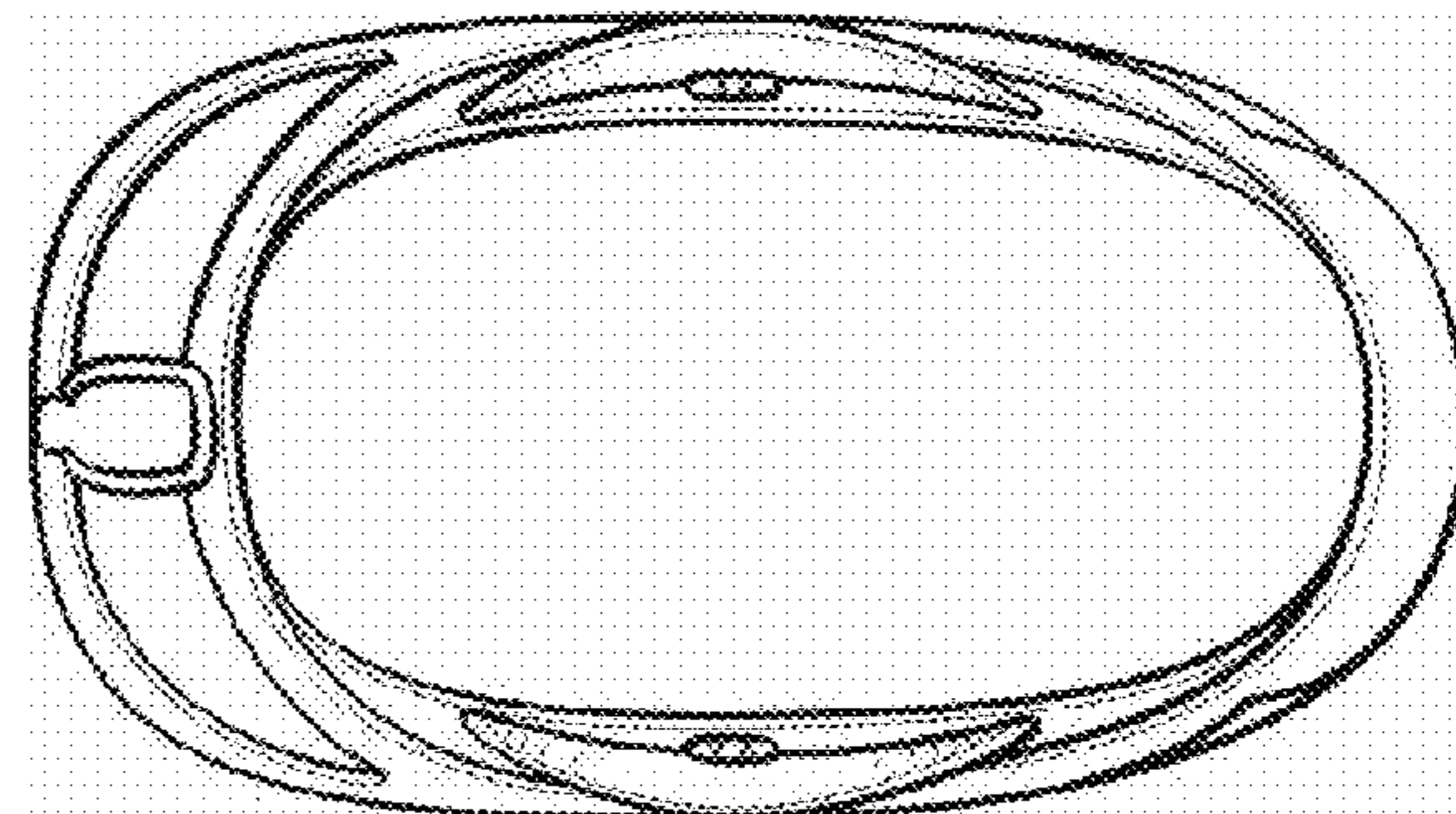

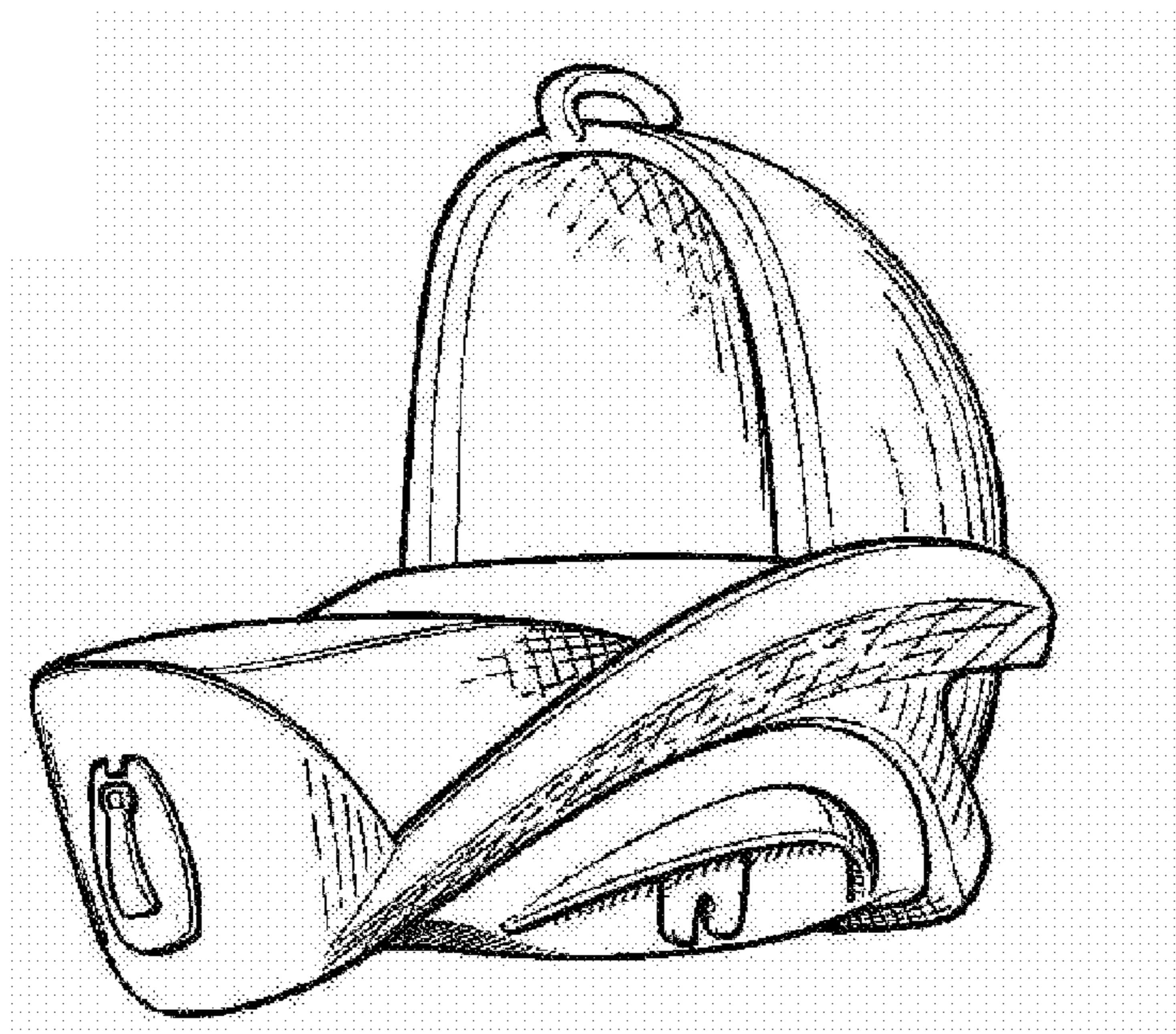

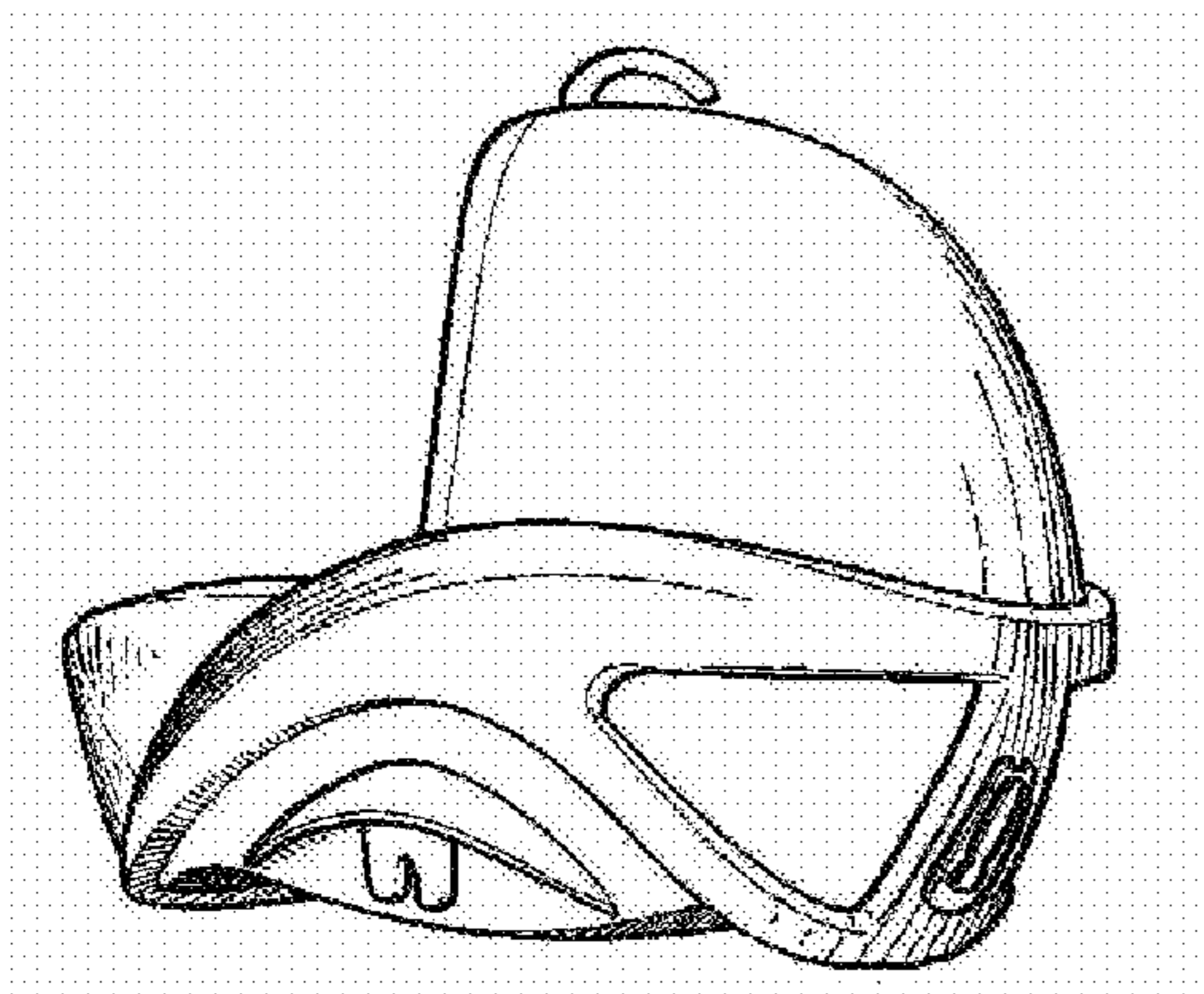

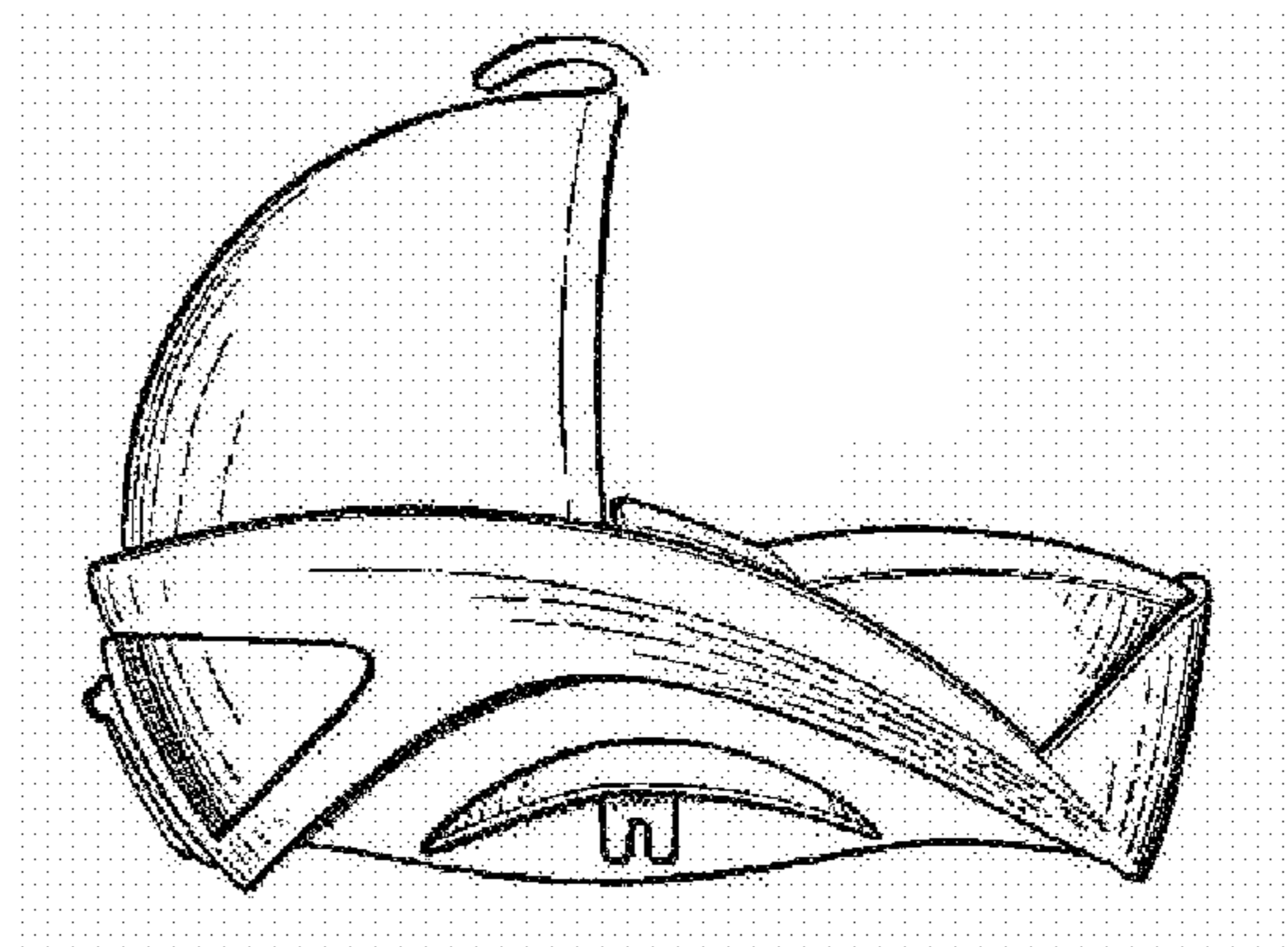

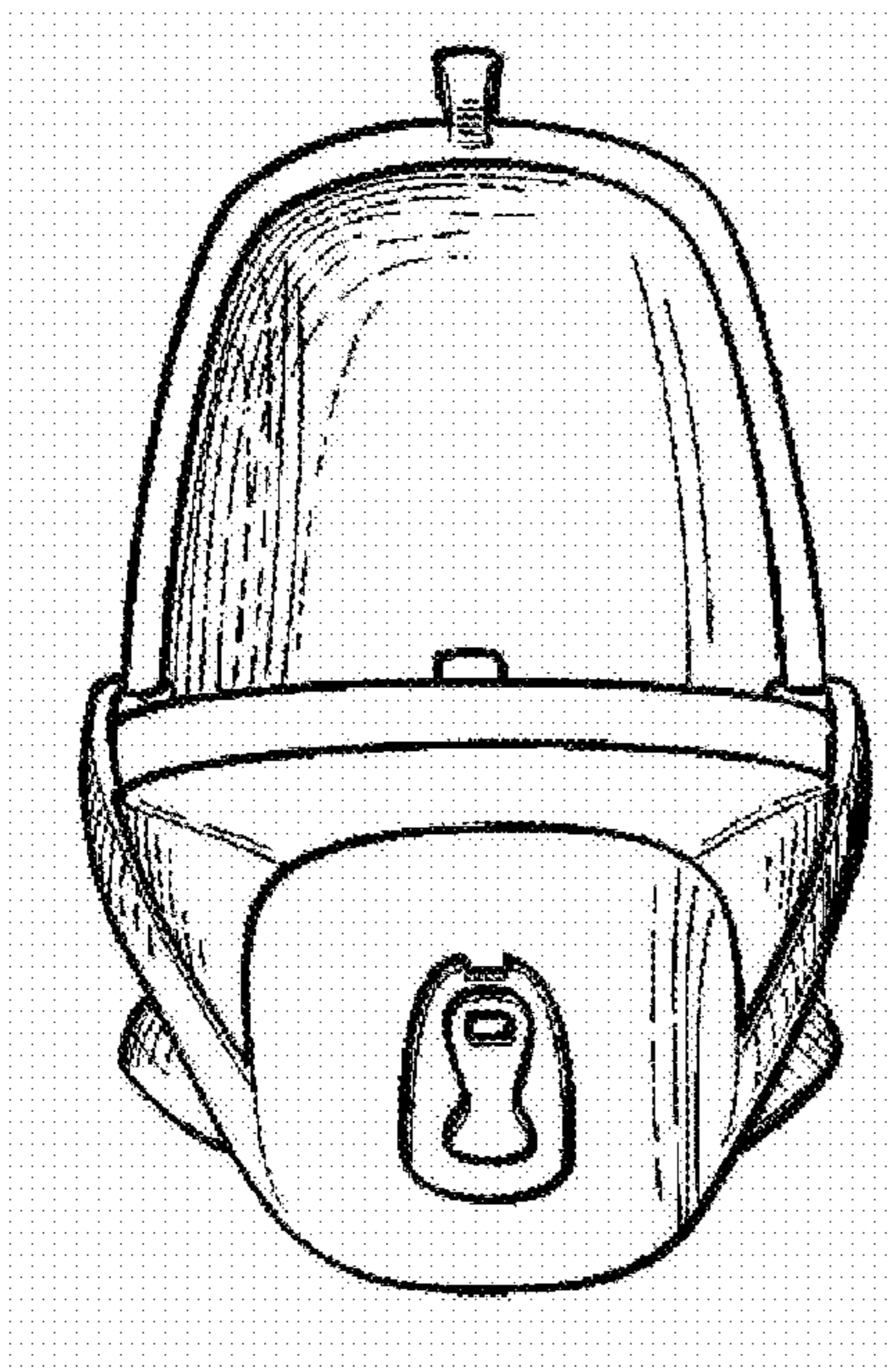
