(57) **CLAIM**

The ornamental design for a waffle iron, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and side perspective view of a waffle iron showing my new design, in the open position;

FIG. 2 is a view similar to FIG. 1 but in the closed position;

FIG. 3 is a top plan view thereof in the open position;

FIG. 4 is a top plan view thereof in the closed position;

FIG. 5 is a bottom plan view thereof in the open position;

FIG. 6 is a bottom plan view thereof in the closed position;

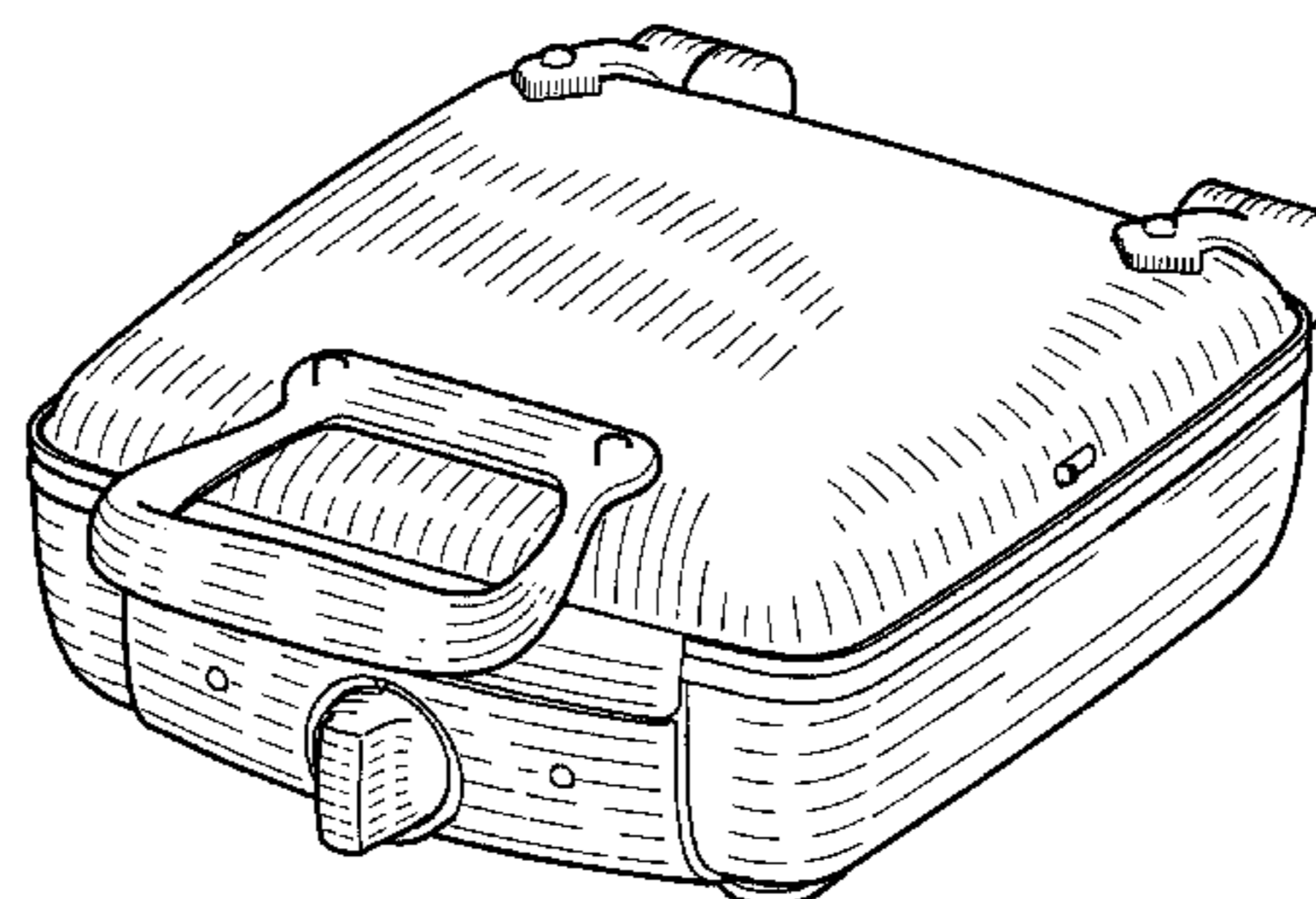
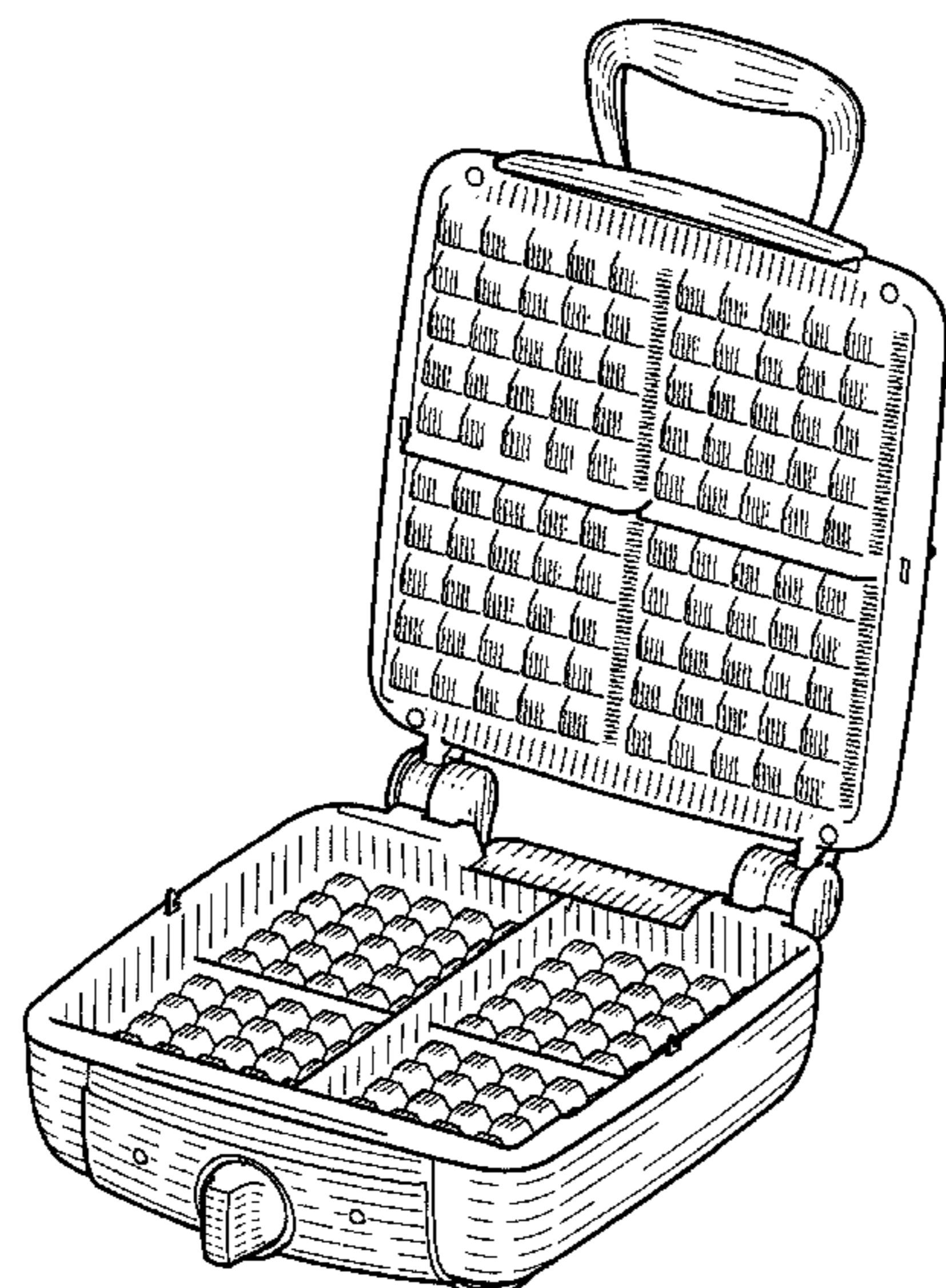
FIG. 7 being the mirror image thereof;

FIG. 7 is front elevational view thereof in the open position;

FIG. 8 is a front elevational view thereof in the closed position;

FIG. 9 is a side elevational view thereof from the right of FIG. 7, the side elevational view from the left of

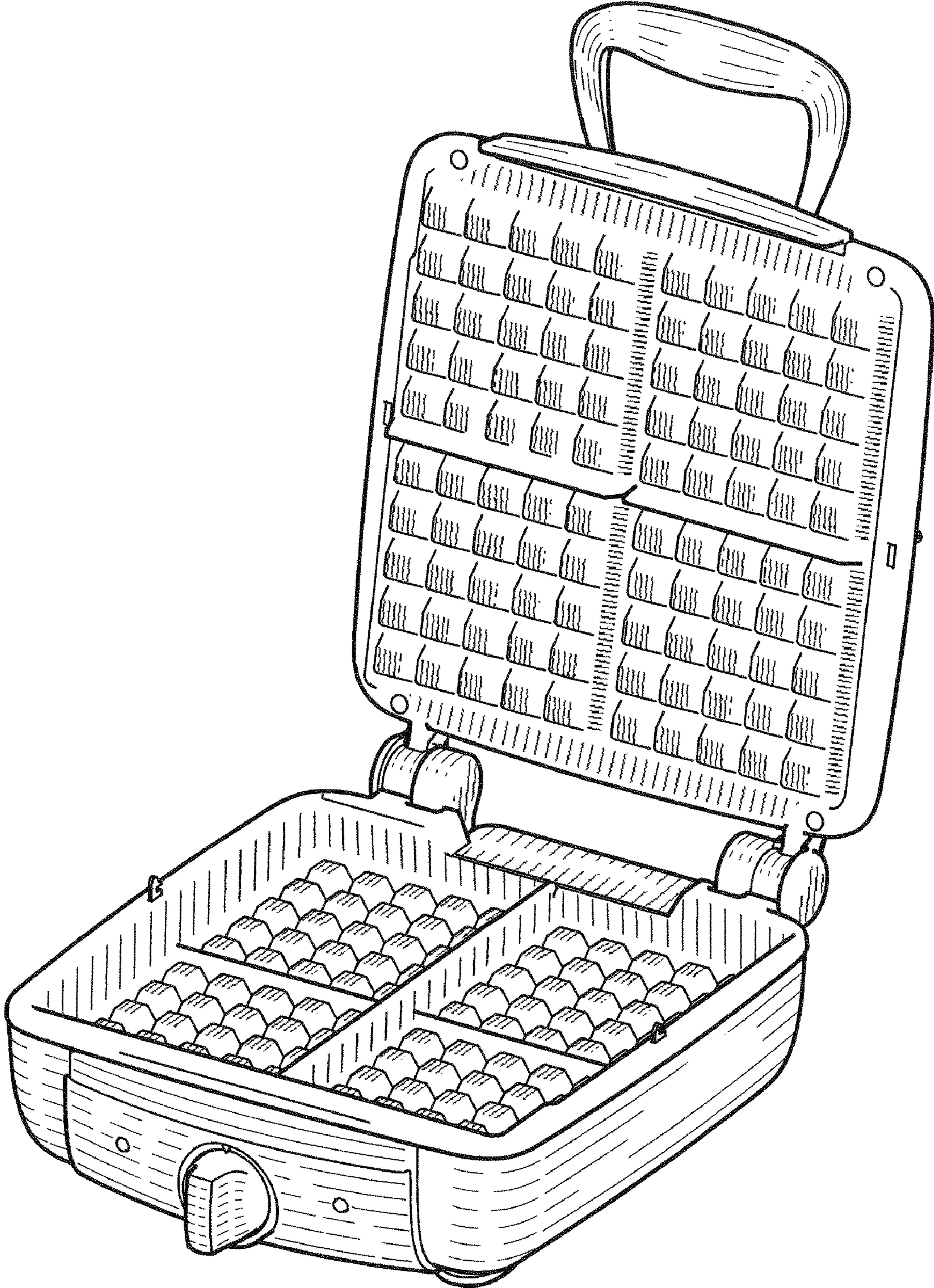

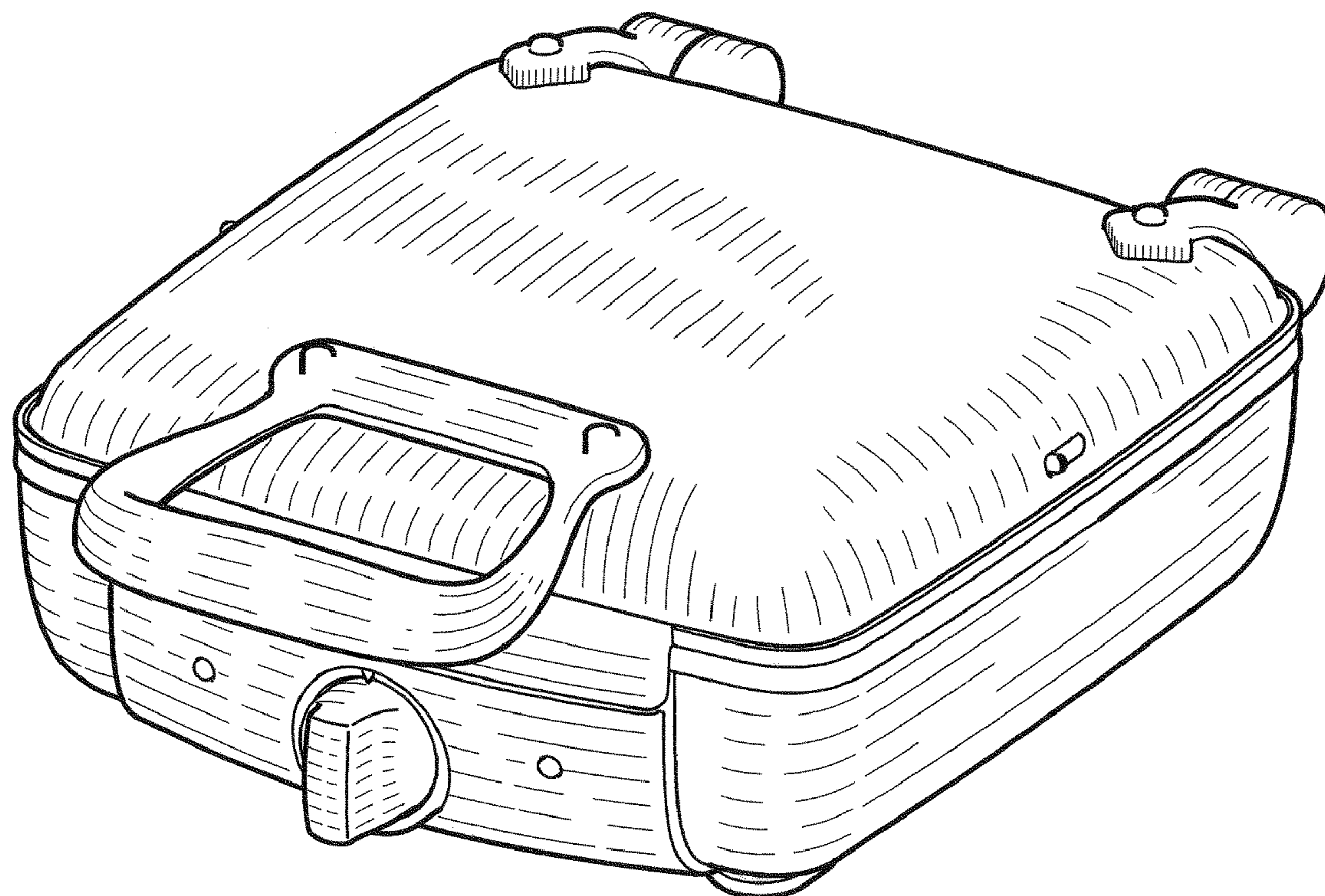

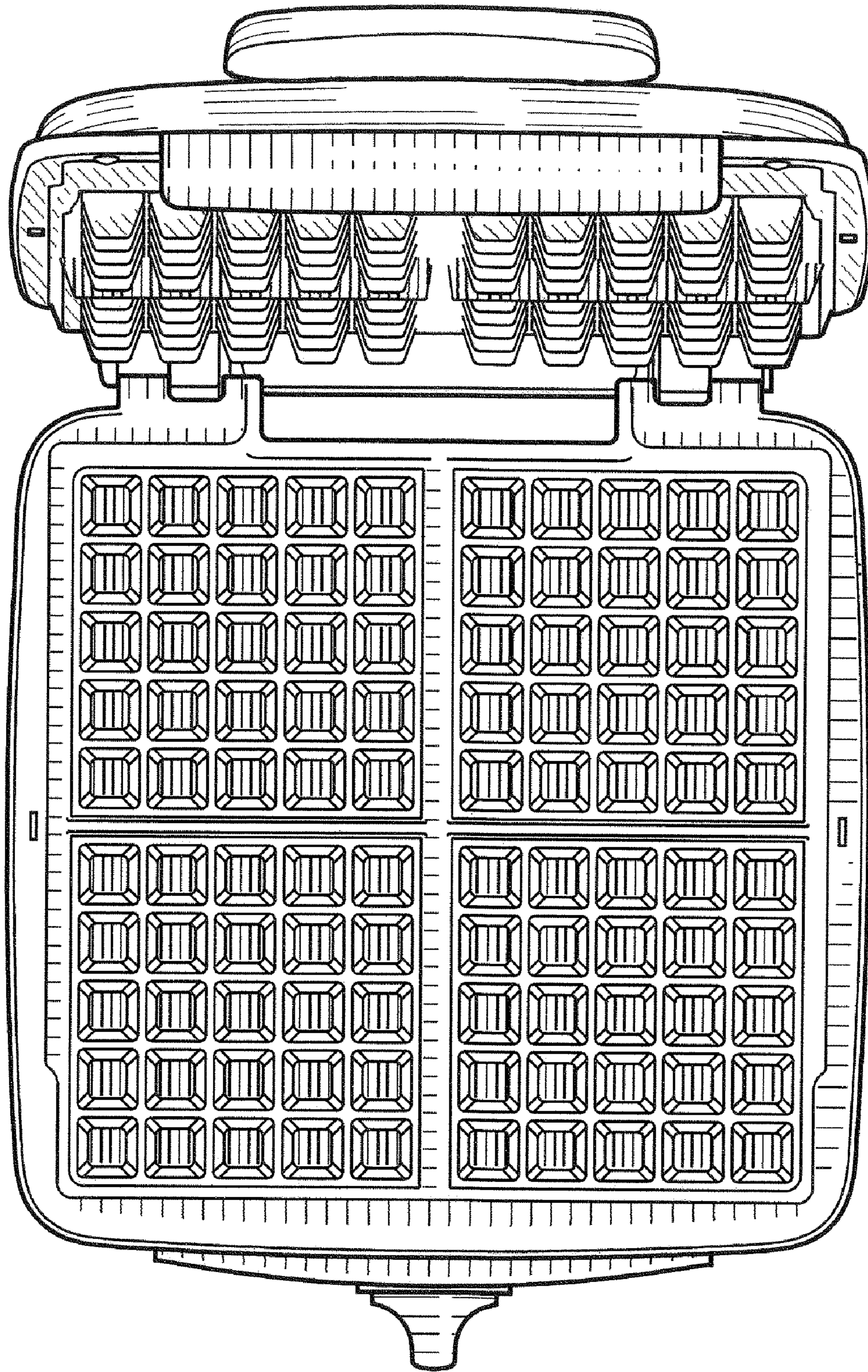

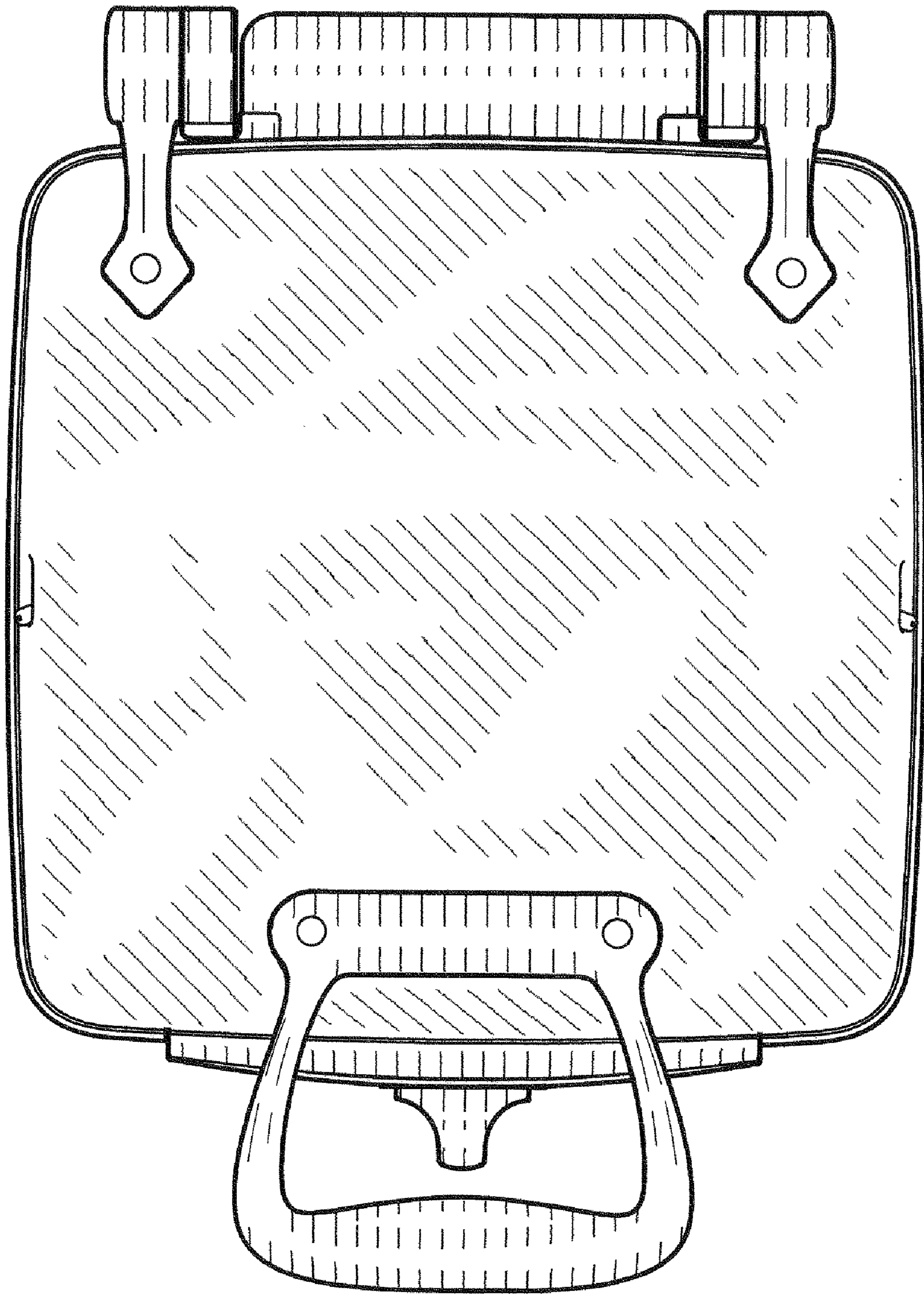

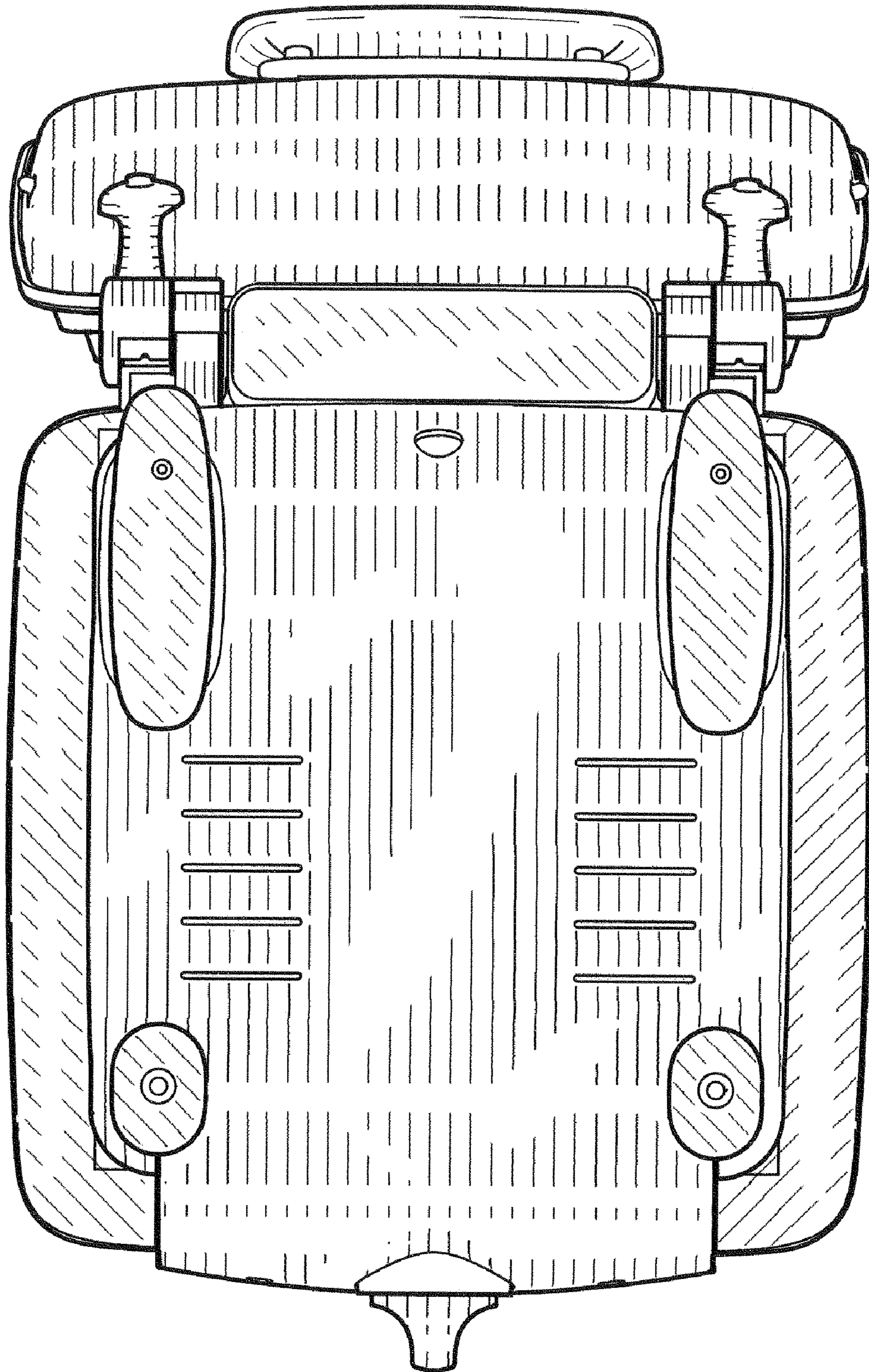

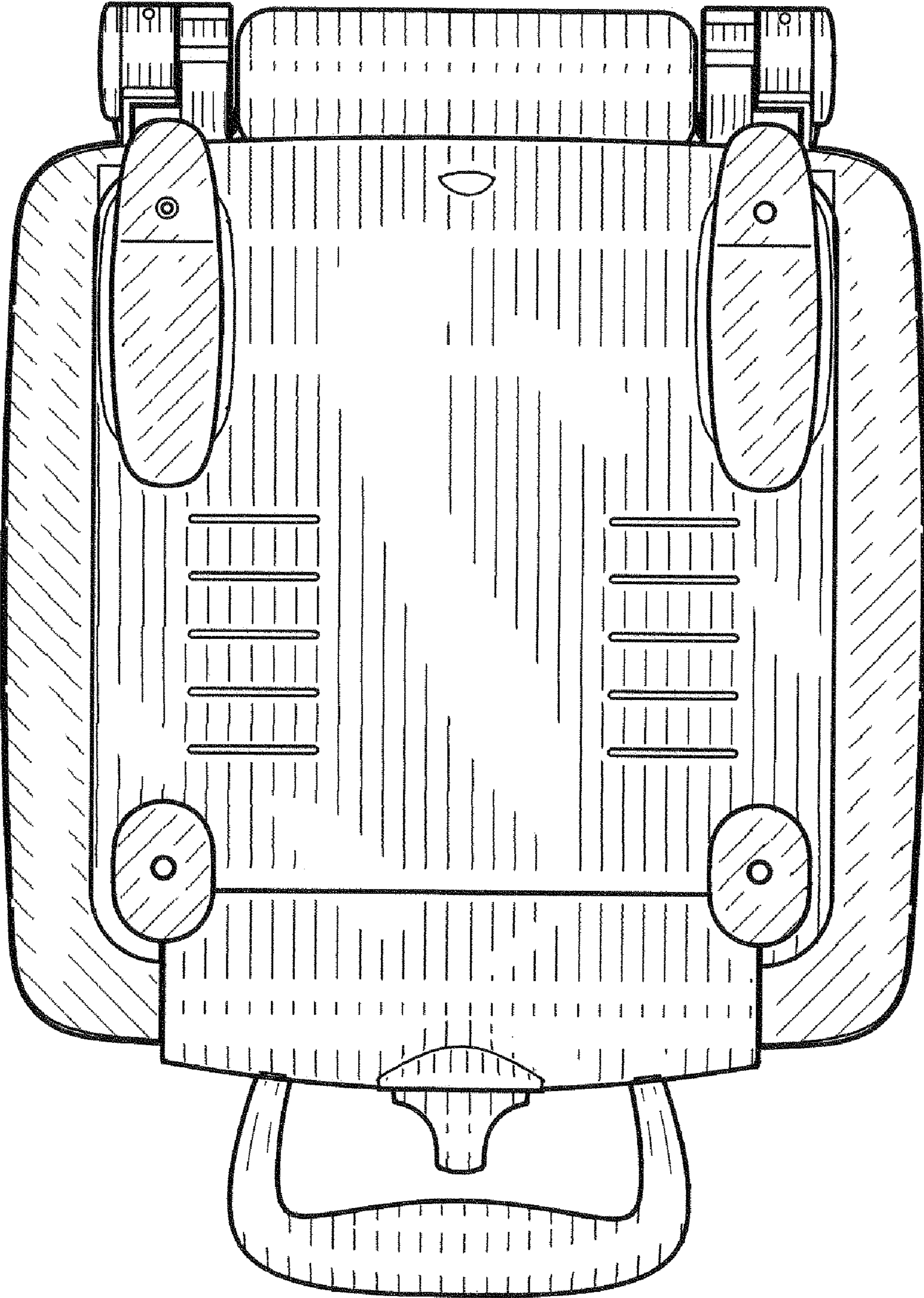

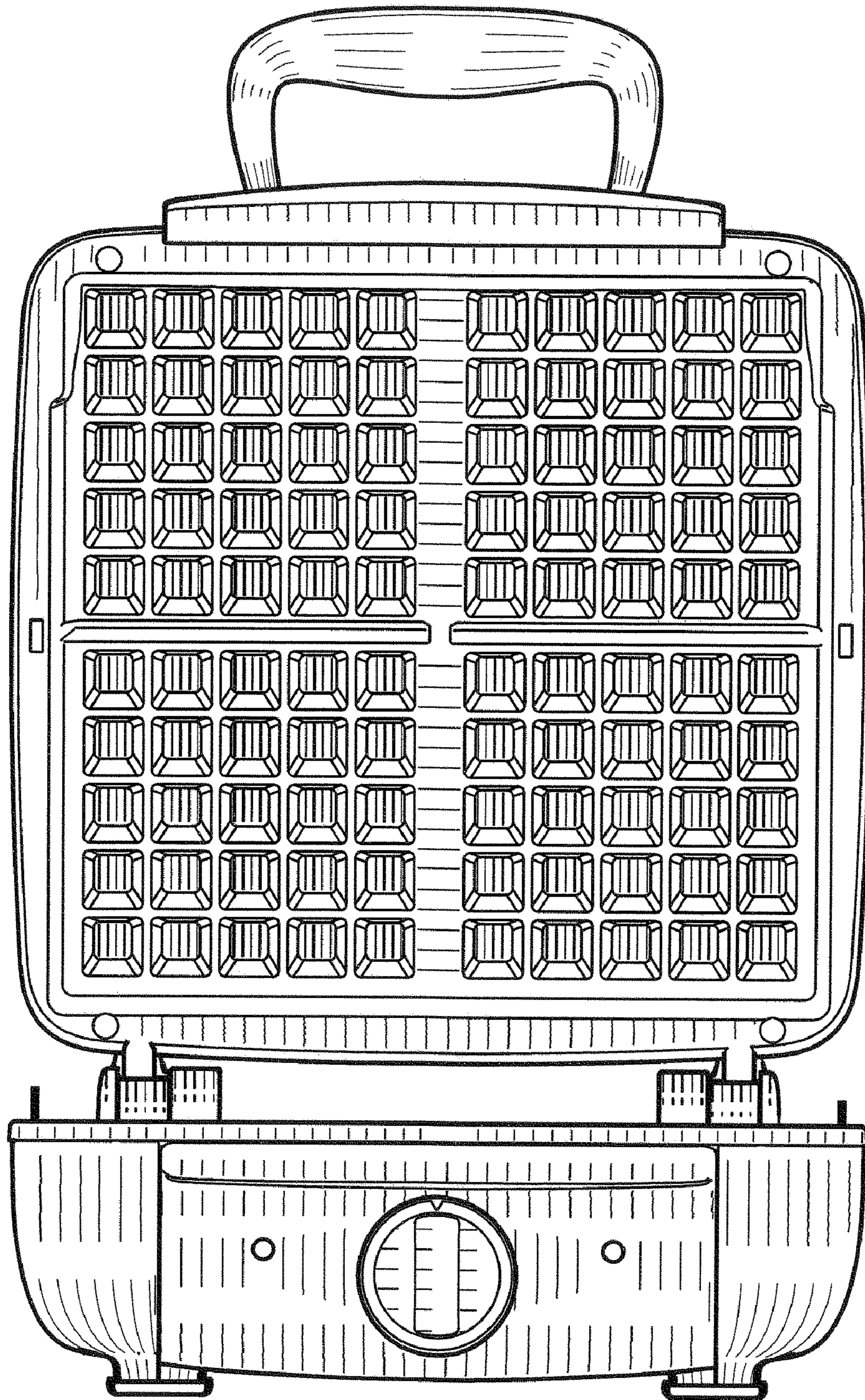

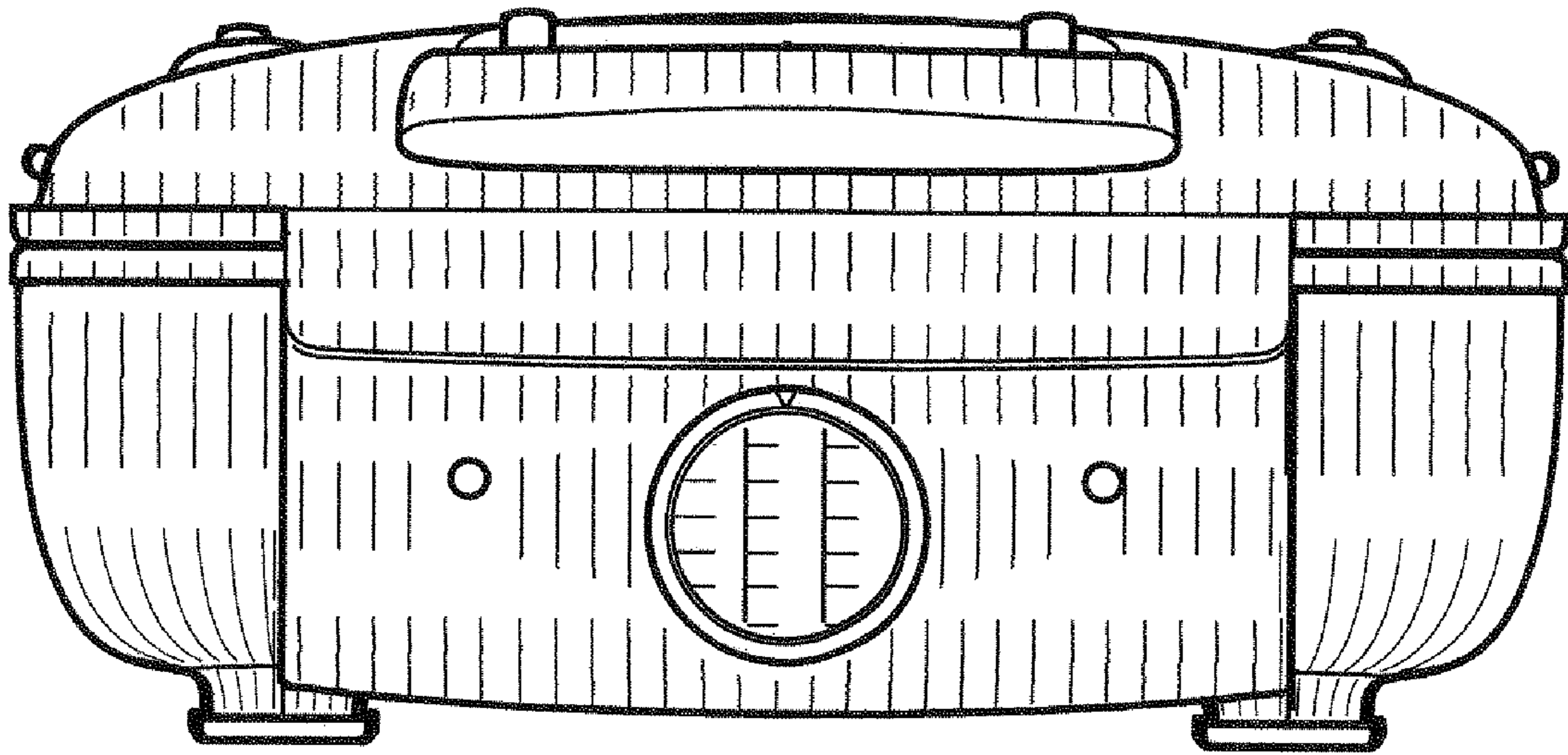

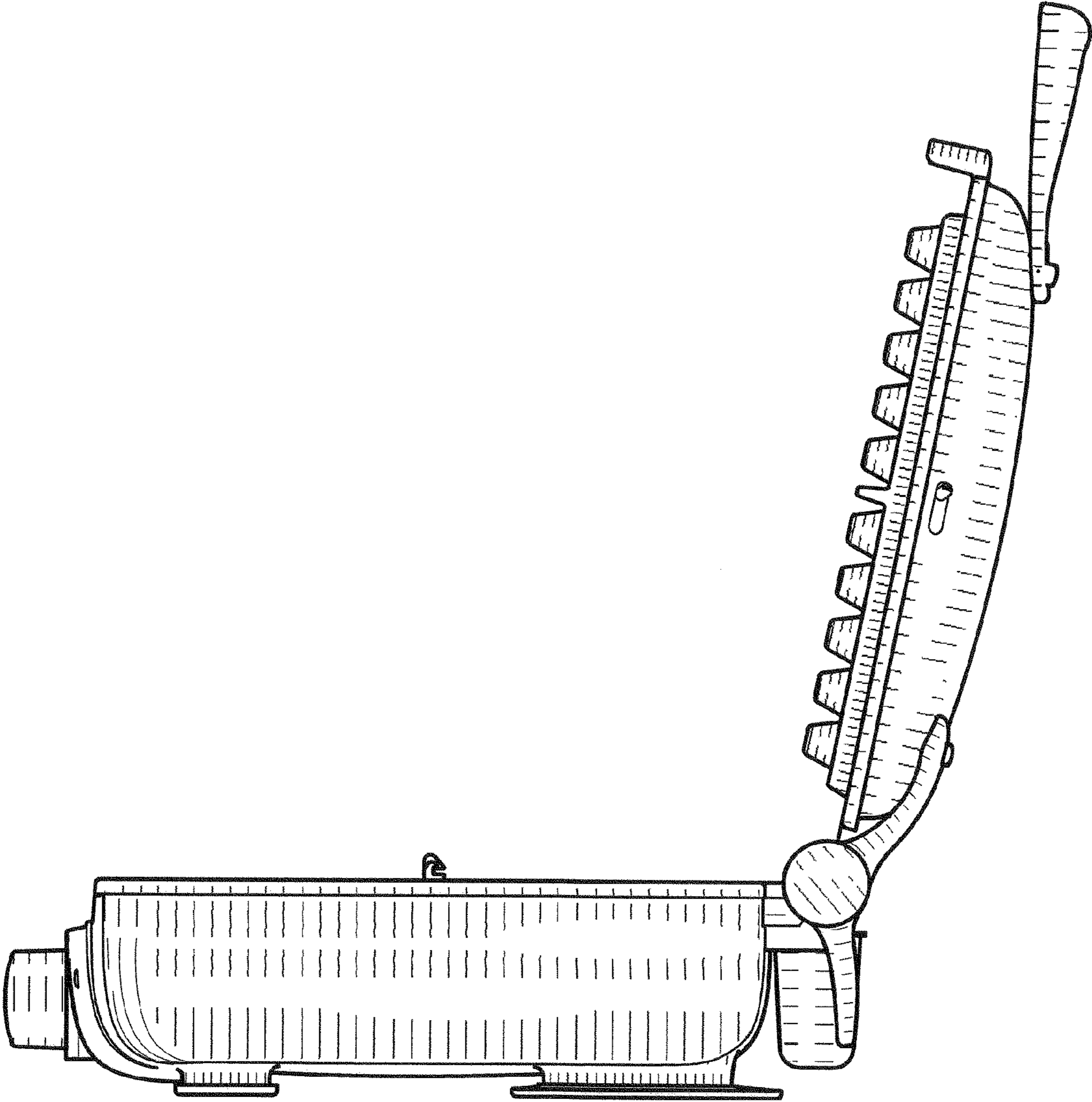

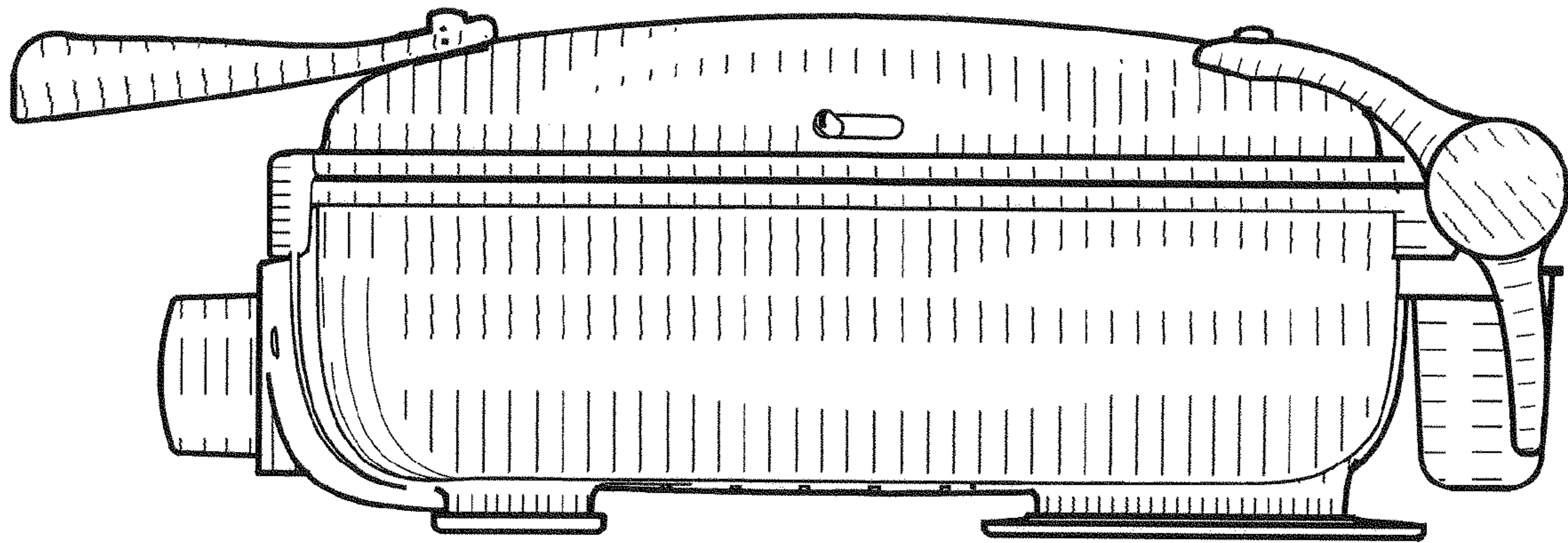

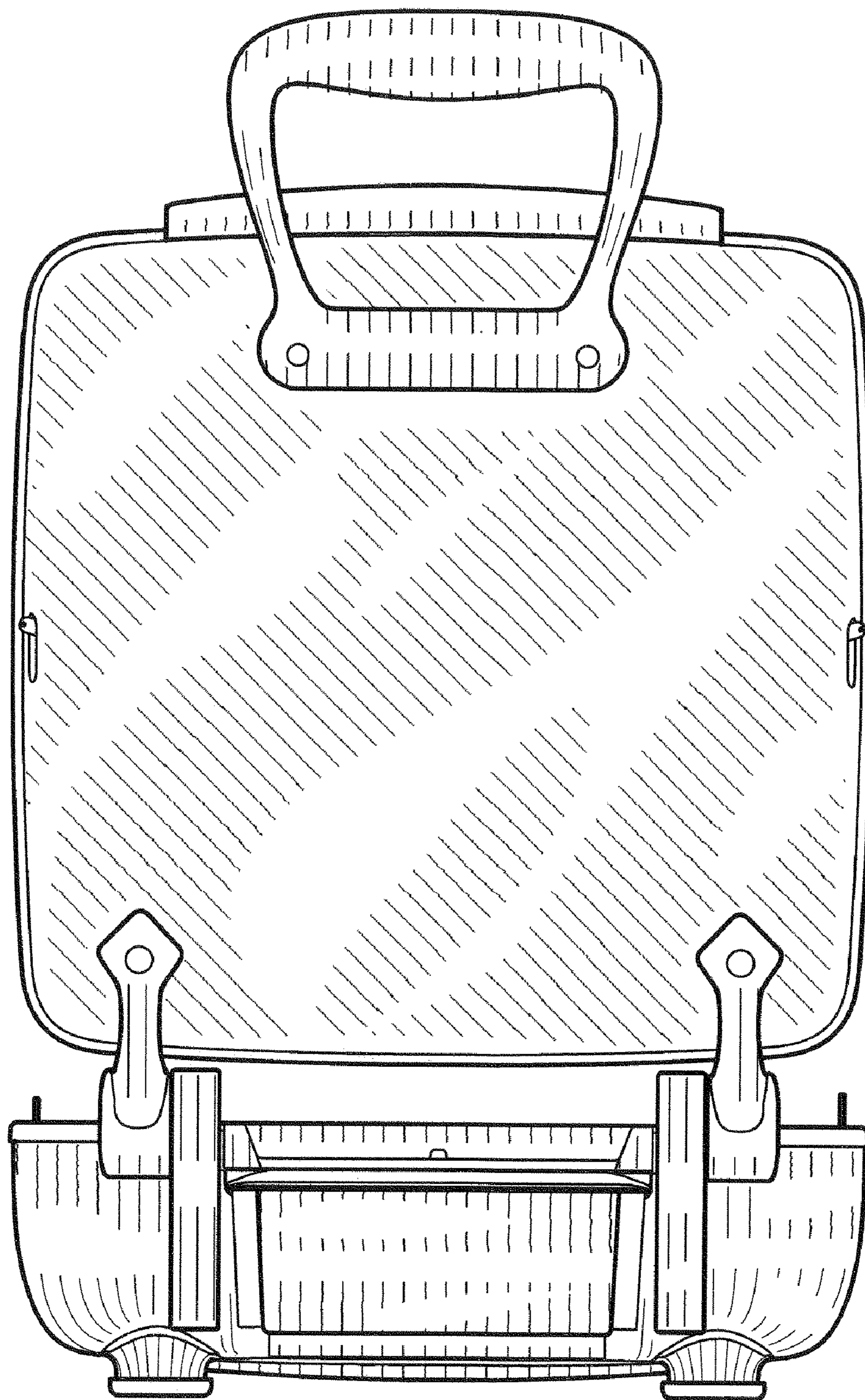

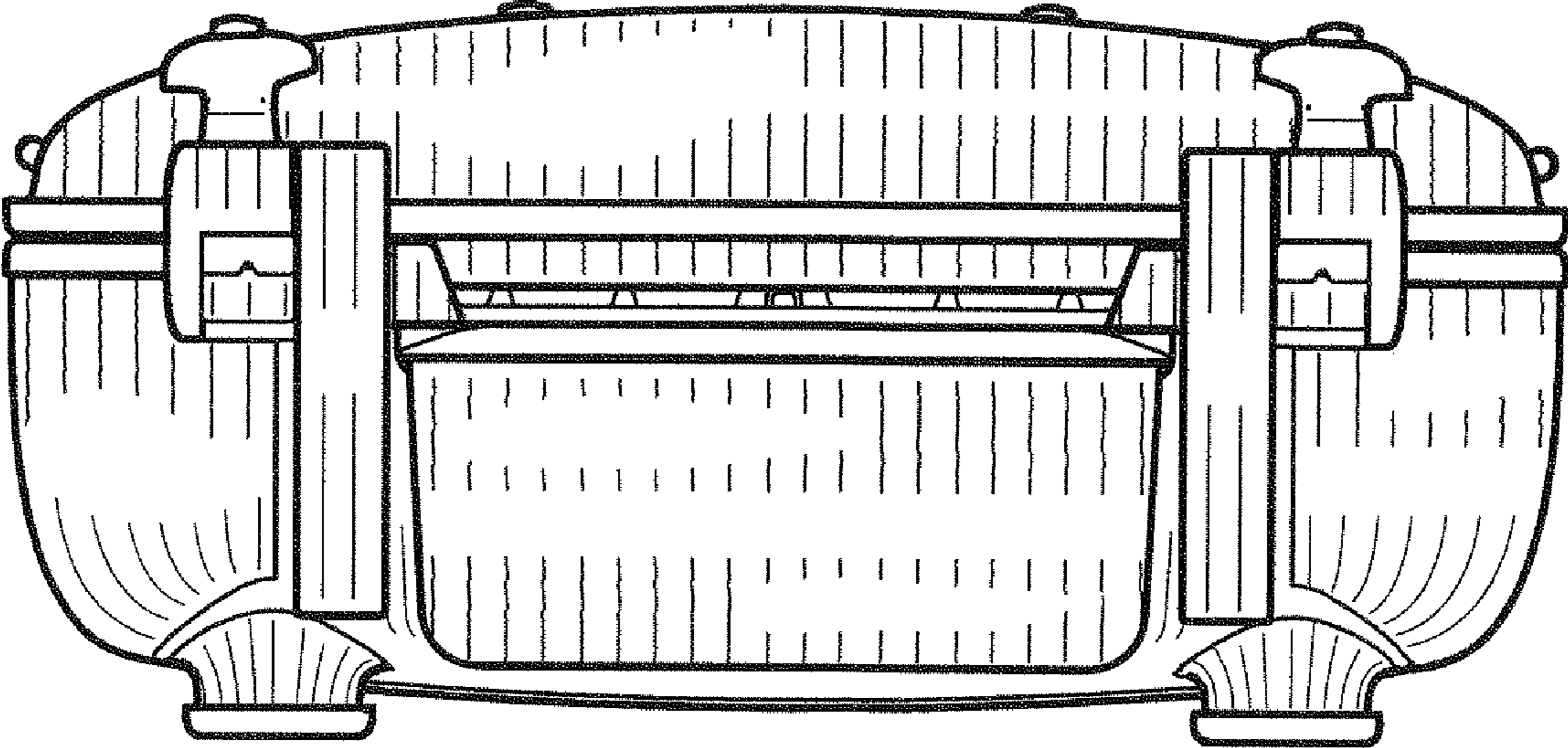
