FIG. 1 is a perspective view of cabinet handle showing our new design;

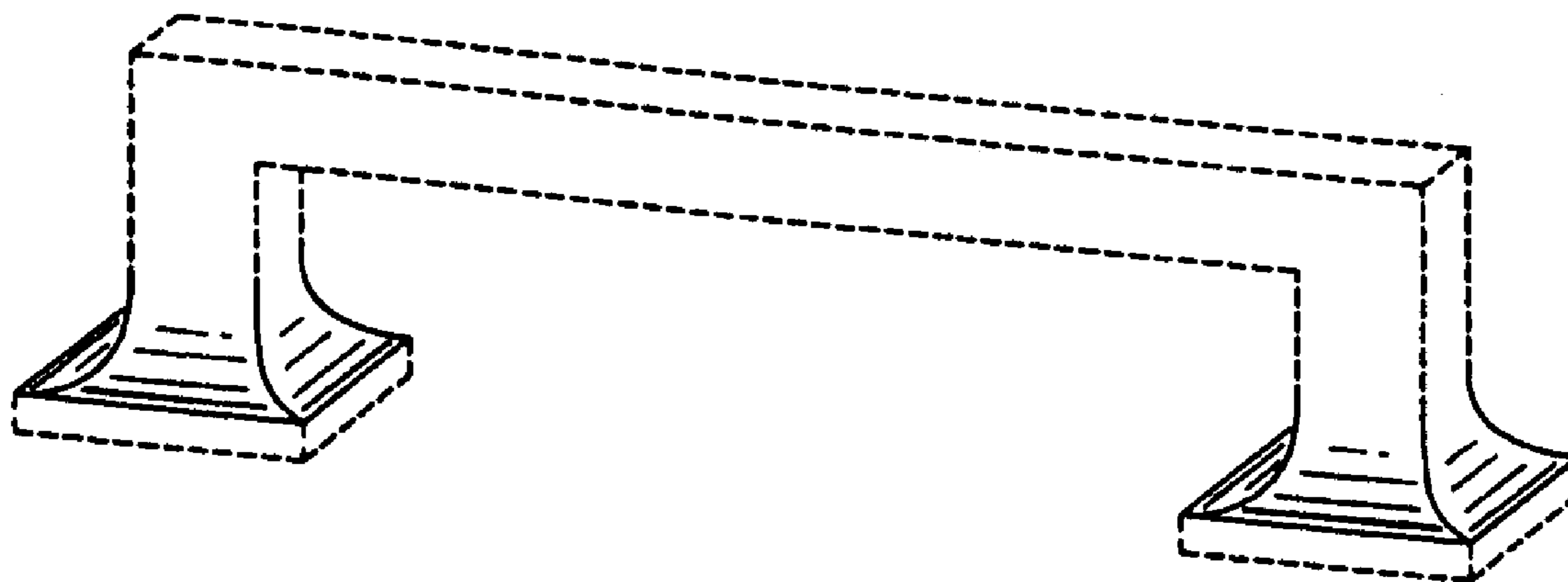
FIG. 2 is a top view thereof;

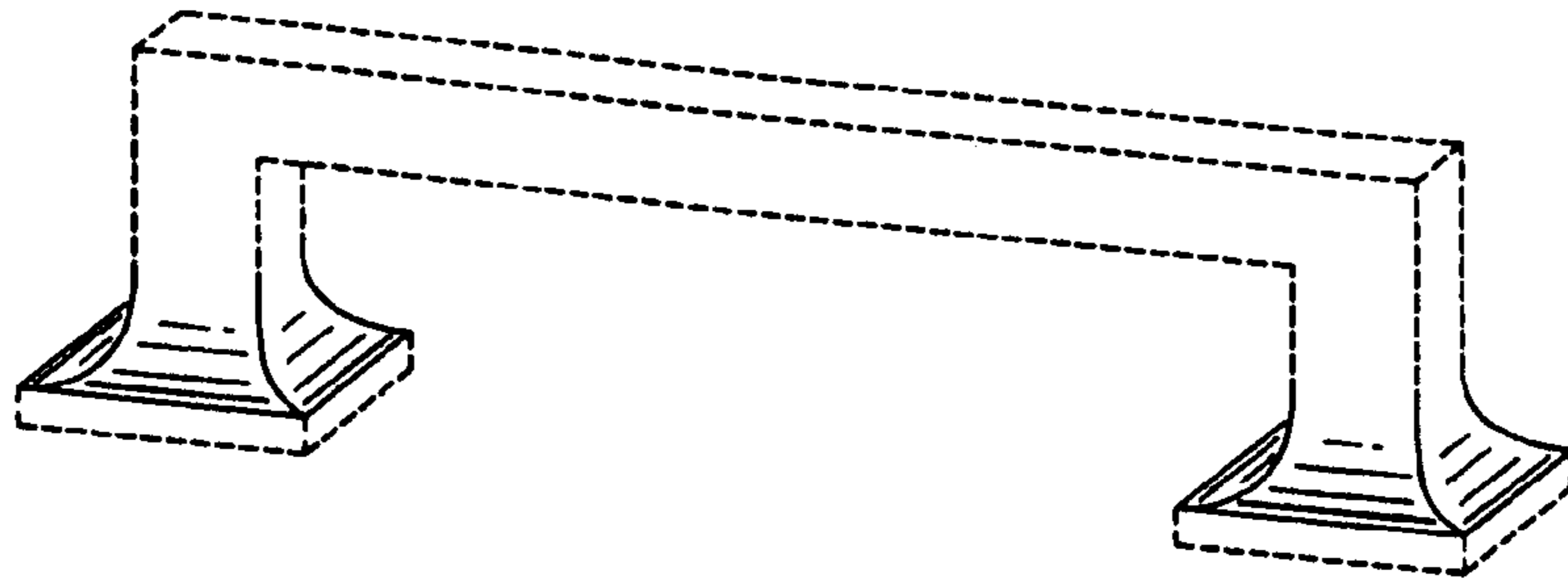

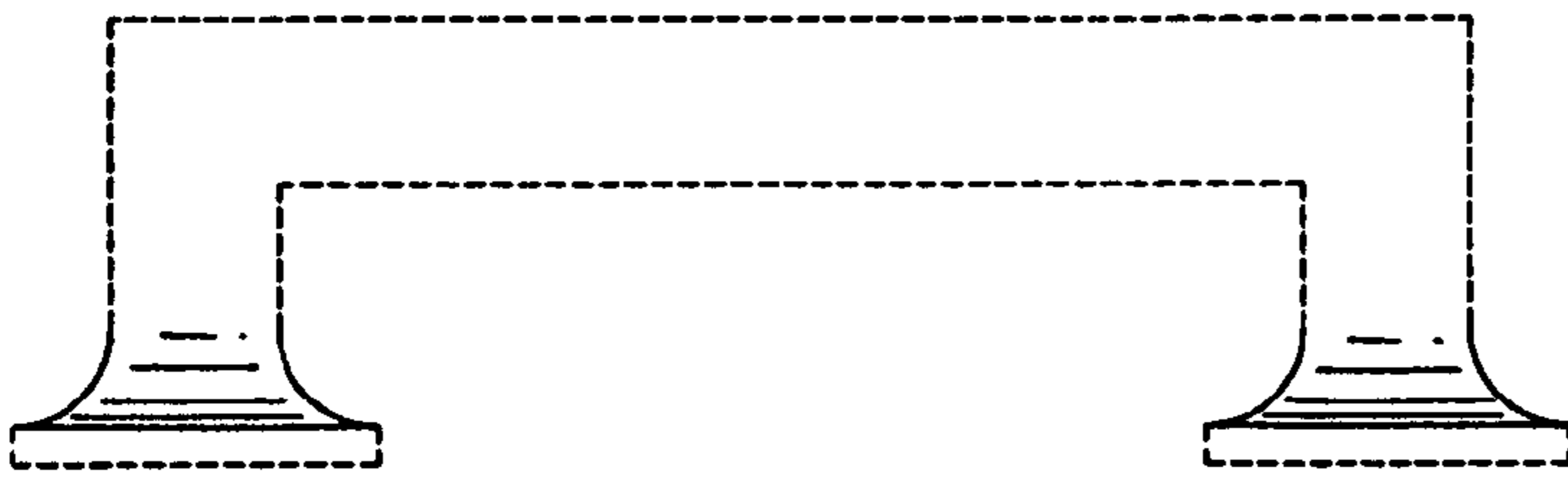

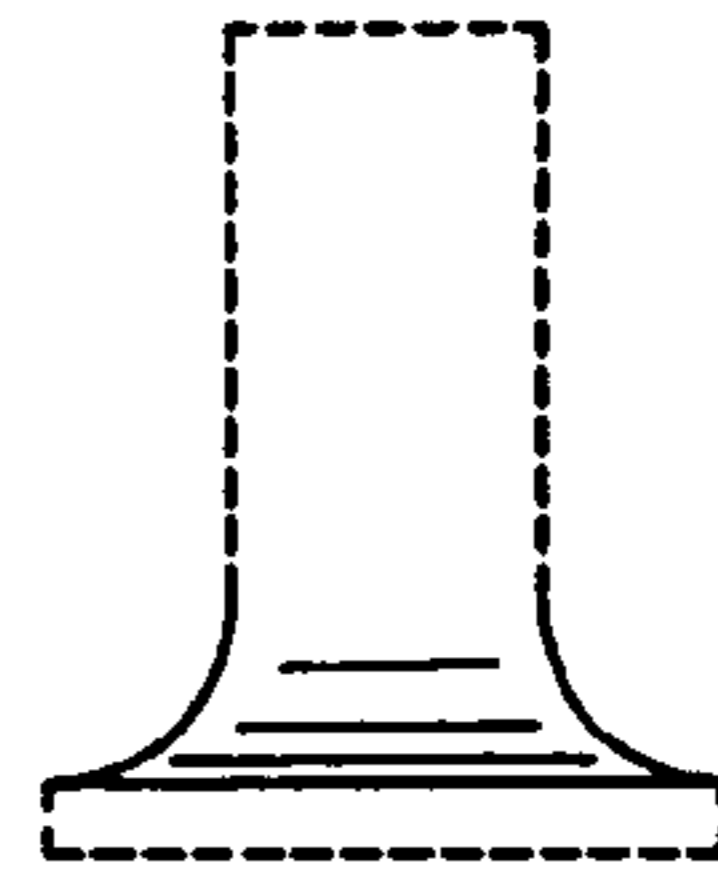

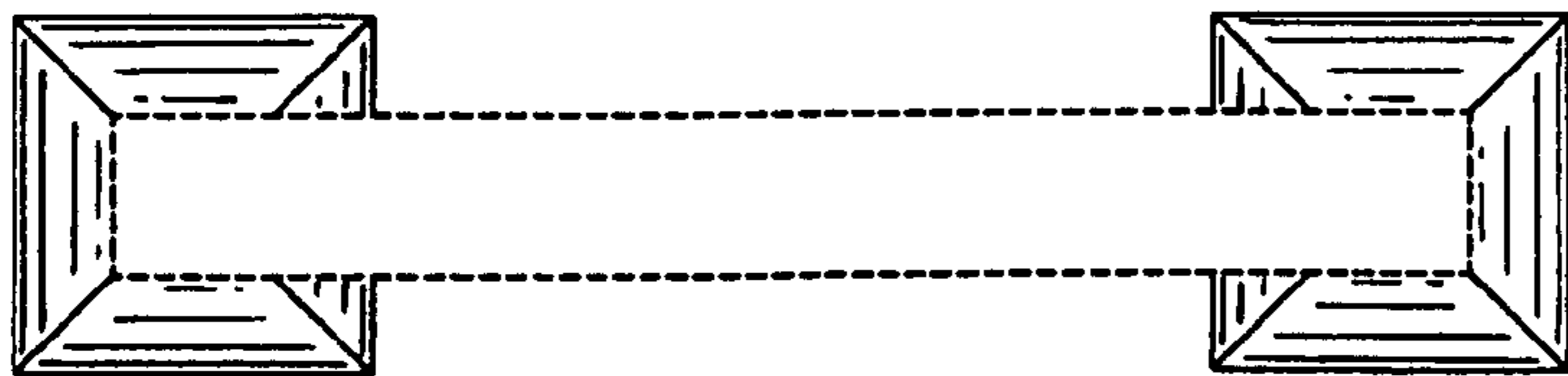
