(57) **CLAIM**

I claim the ornamental design for a jet spike, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the jet spike of the present invention;

FIG. 2 is a front elevational view of the jet spike shown in FIG. 1;

FIG. 3 is a left elevational view of the jet spike shown in FIG. 2; and

FIG. 4 is a back elevational view of the jet spike shown in FIG. 2.

FIG. 5 is a top plan view of the jet spike shown in FIG. 3; and,

FIG. 6 is a bottom plan view of the jet spike shown in FIG. 3.

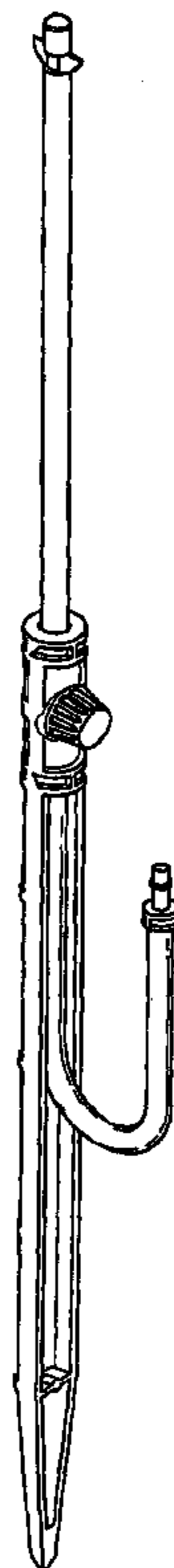

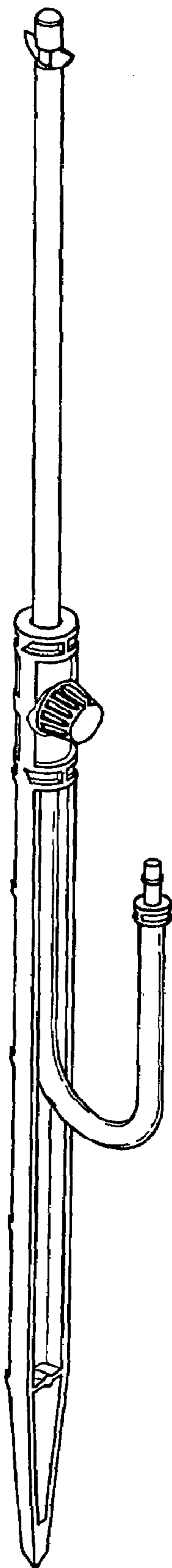

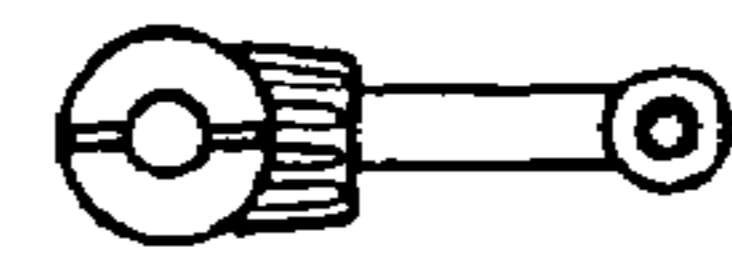
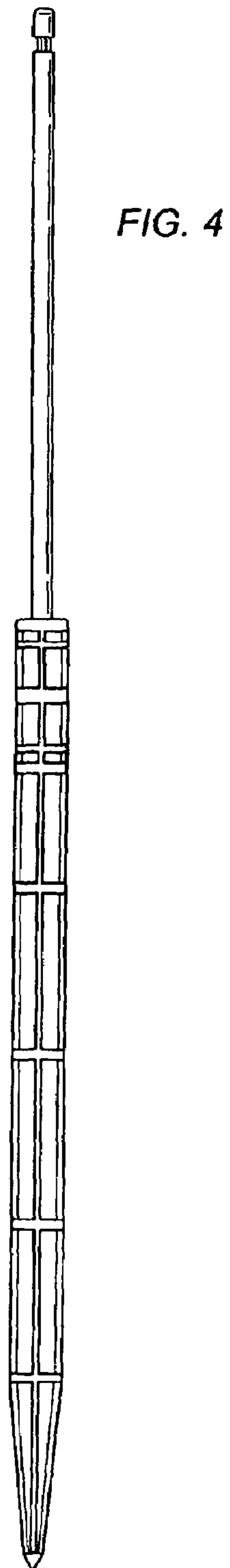
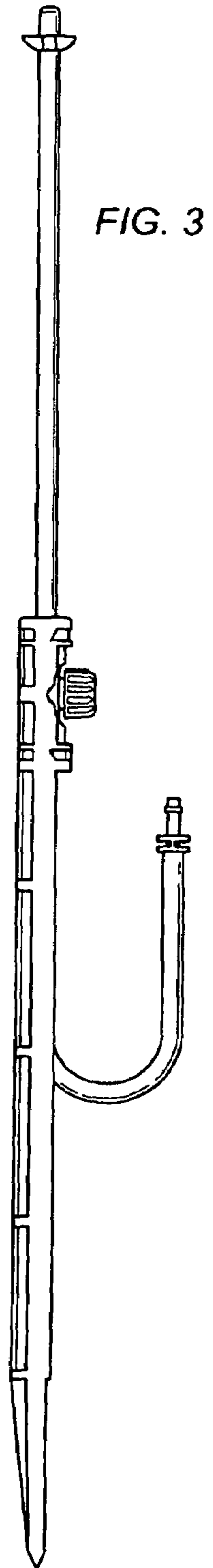

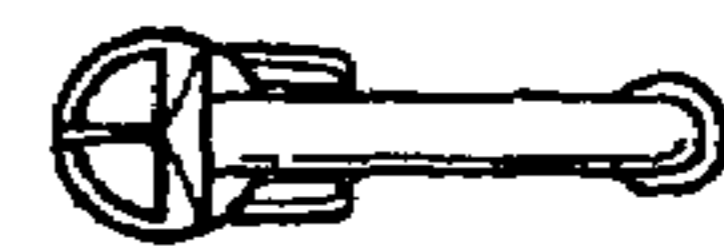
