(57) **CLAIM**

The ornamental design for a package for holding surgical implants, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a package for holding surgical implants showing the new design;

FIG. 2 is a top view thereof;

FIG. 3 is a bottom view thereof; and,

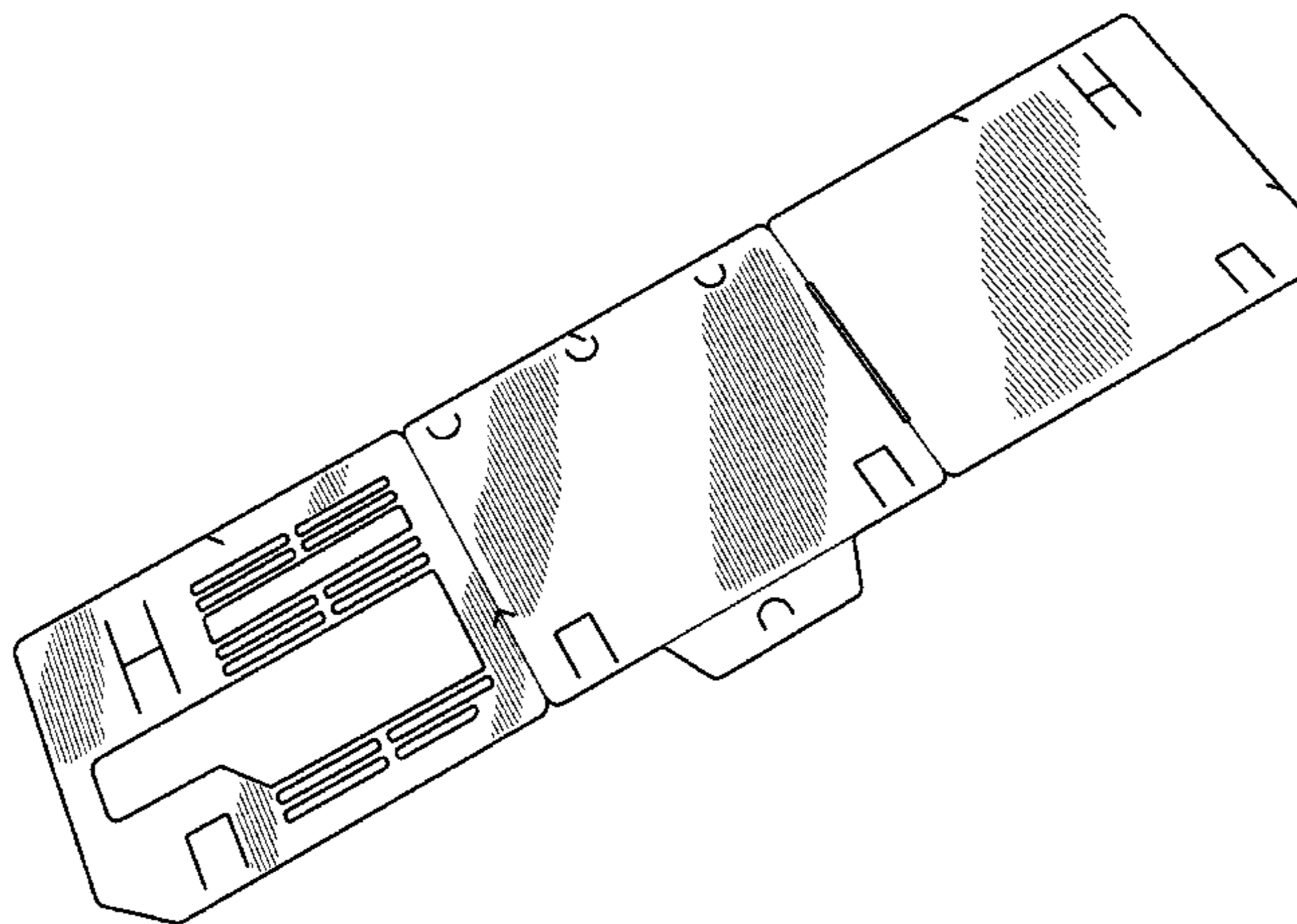


FIG. 4 is a top view of the package of FIGS. 1-3 having a surgical implant therein.

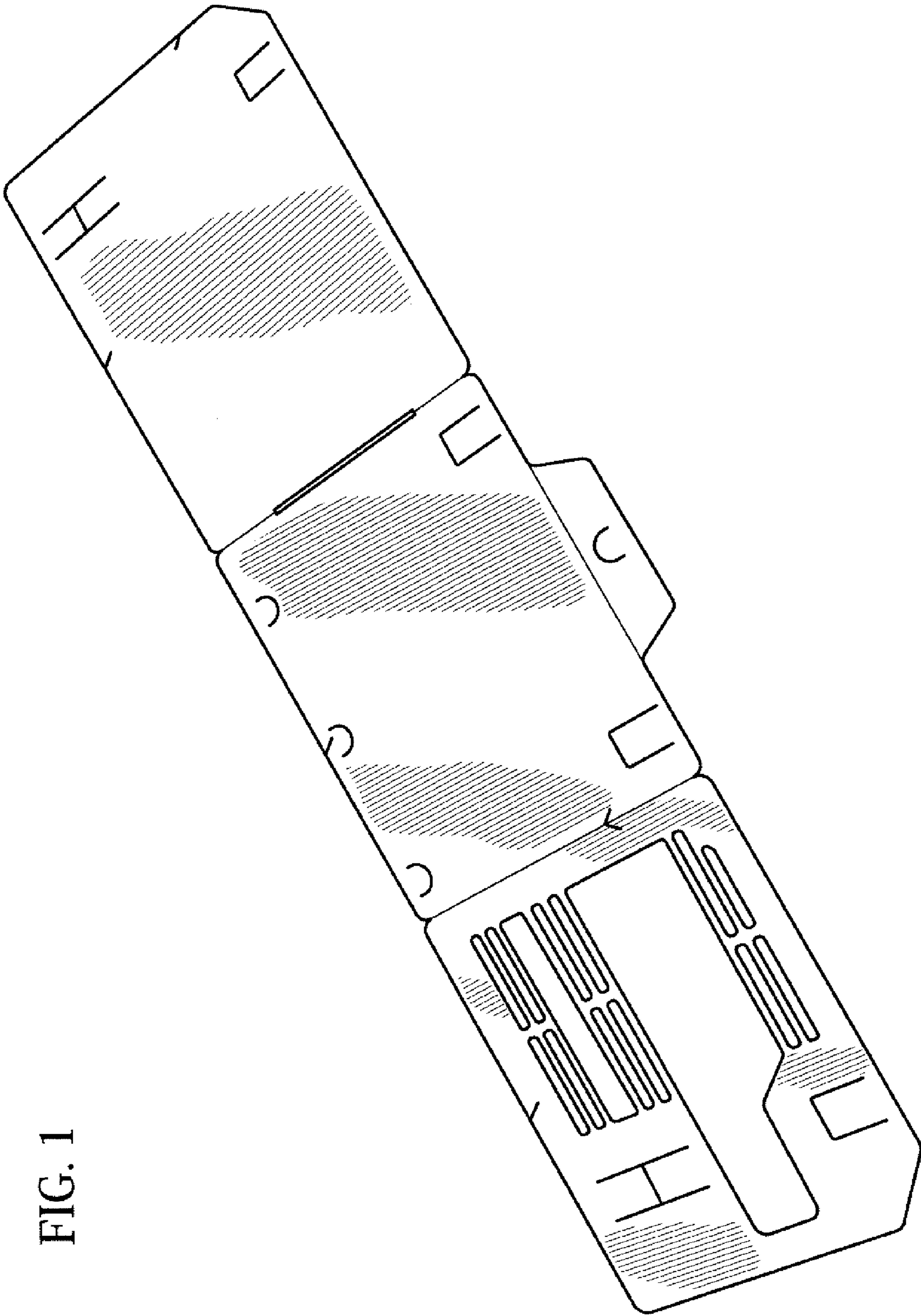
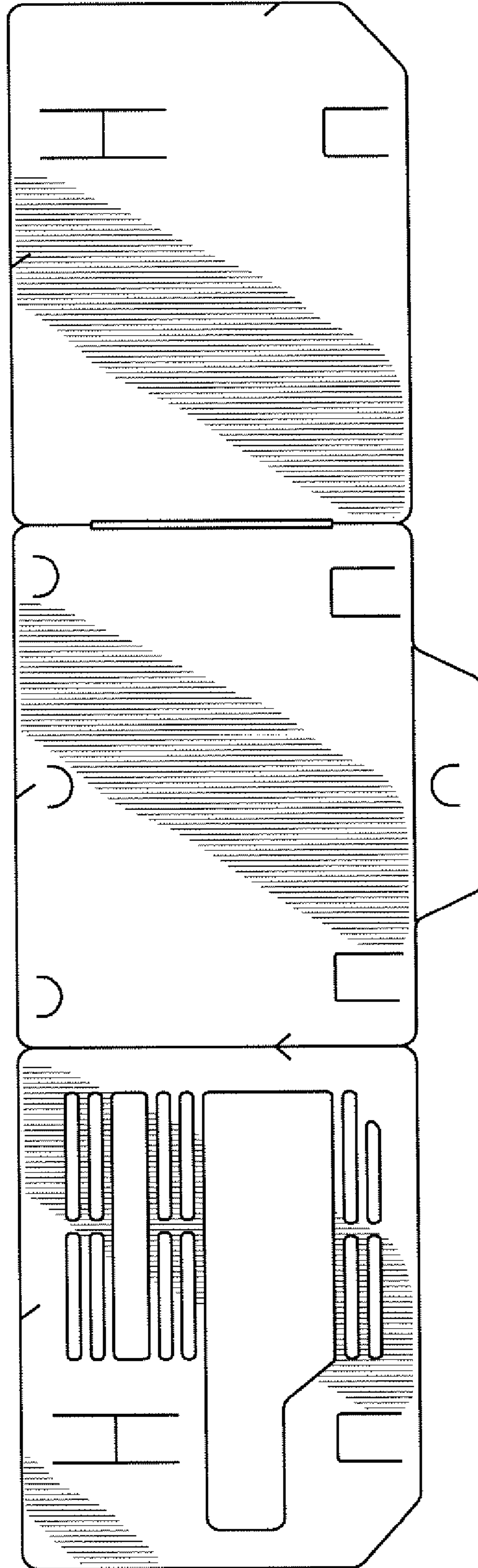

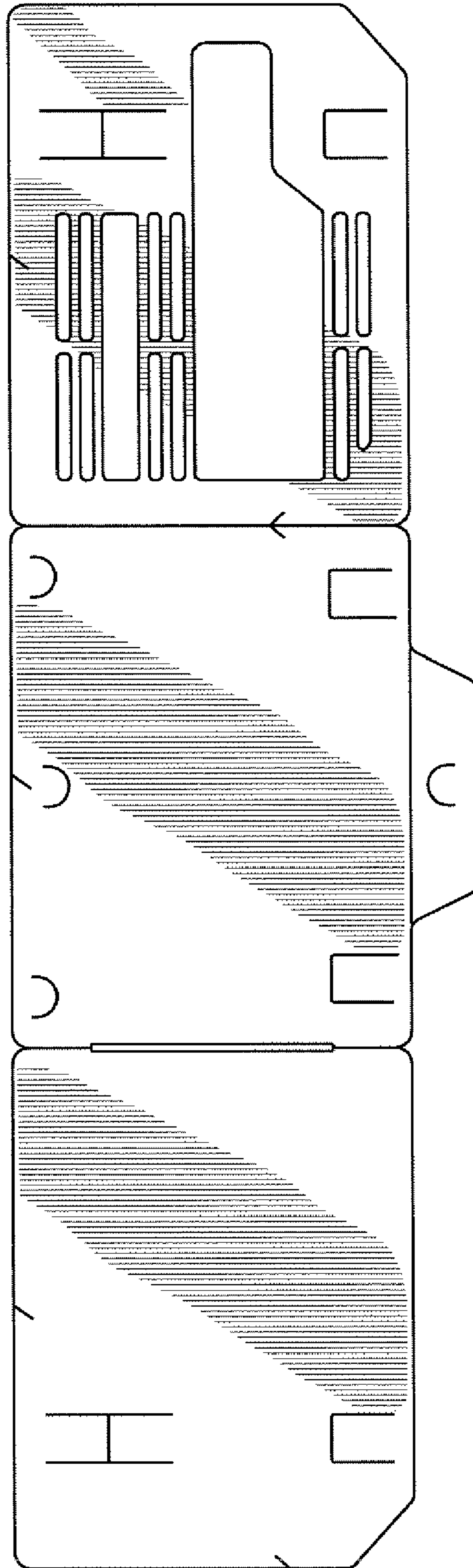
