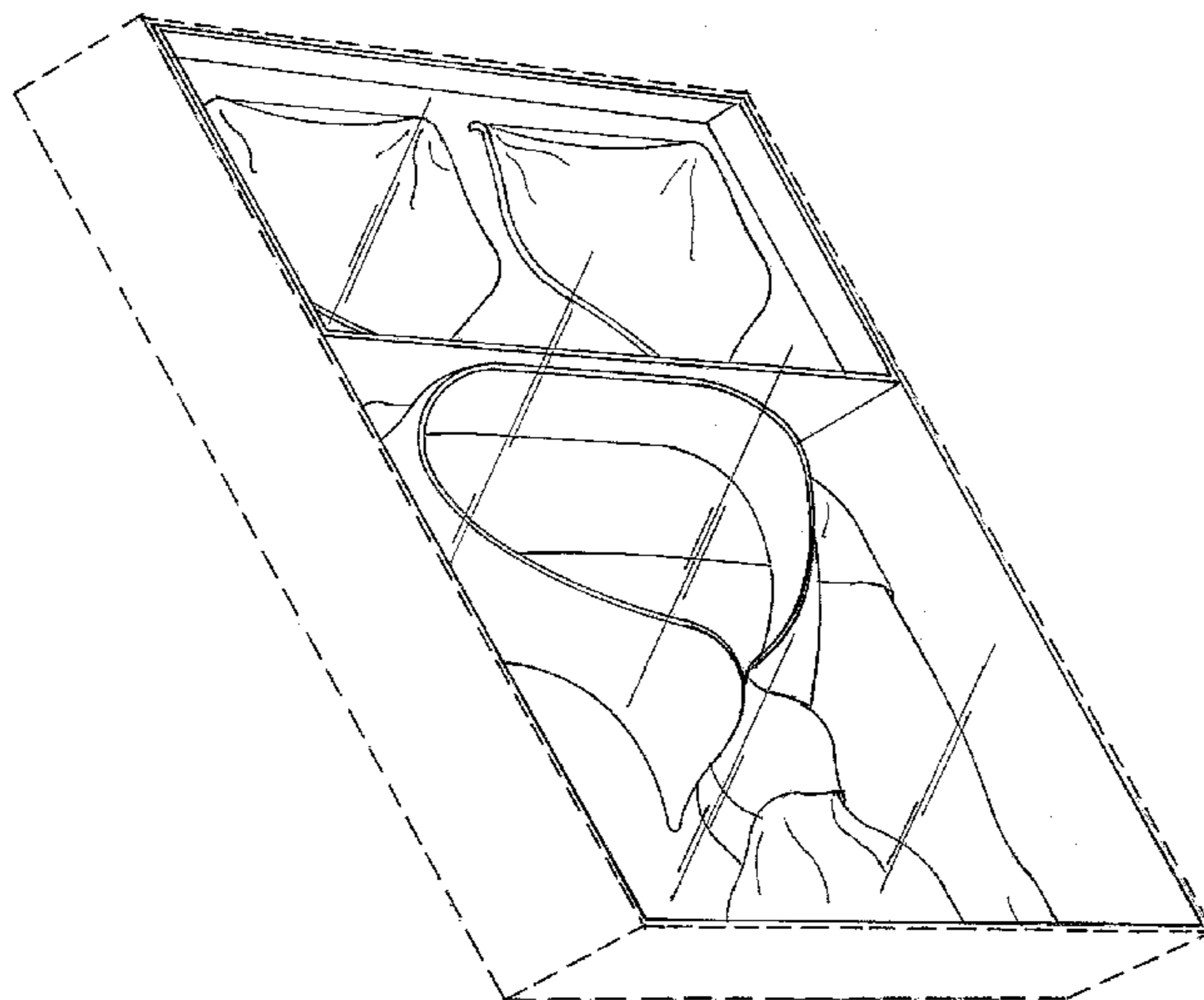
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top, front and side perspective view of a shirt and ties arranged in a box showing my new design;  
FIG. 2 is a front elevation view thereof, the rear view being a mirror image thereof;  
FIG. 3 is a right side elevation view thereof, the left side being a mirror image thereof;

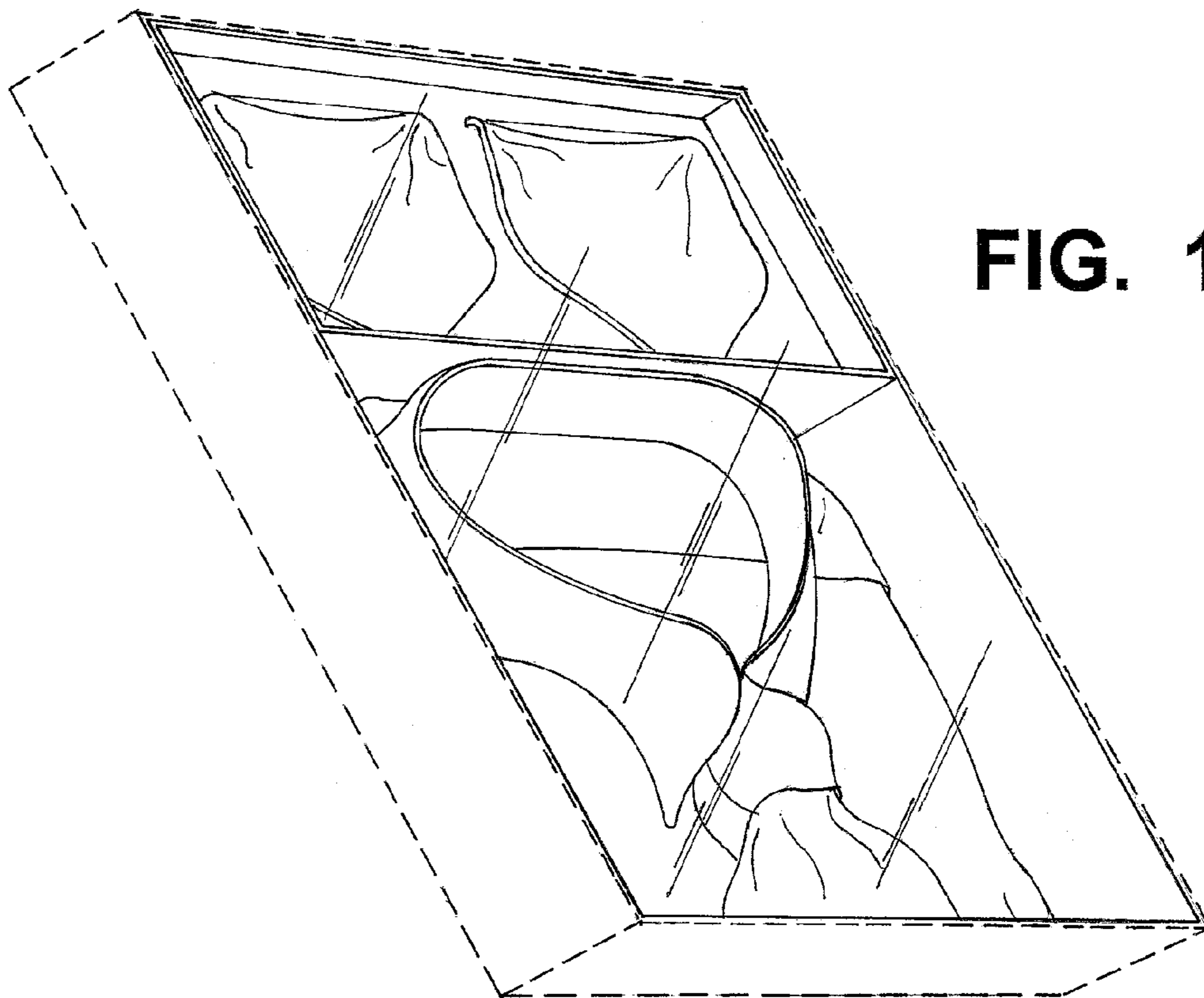

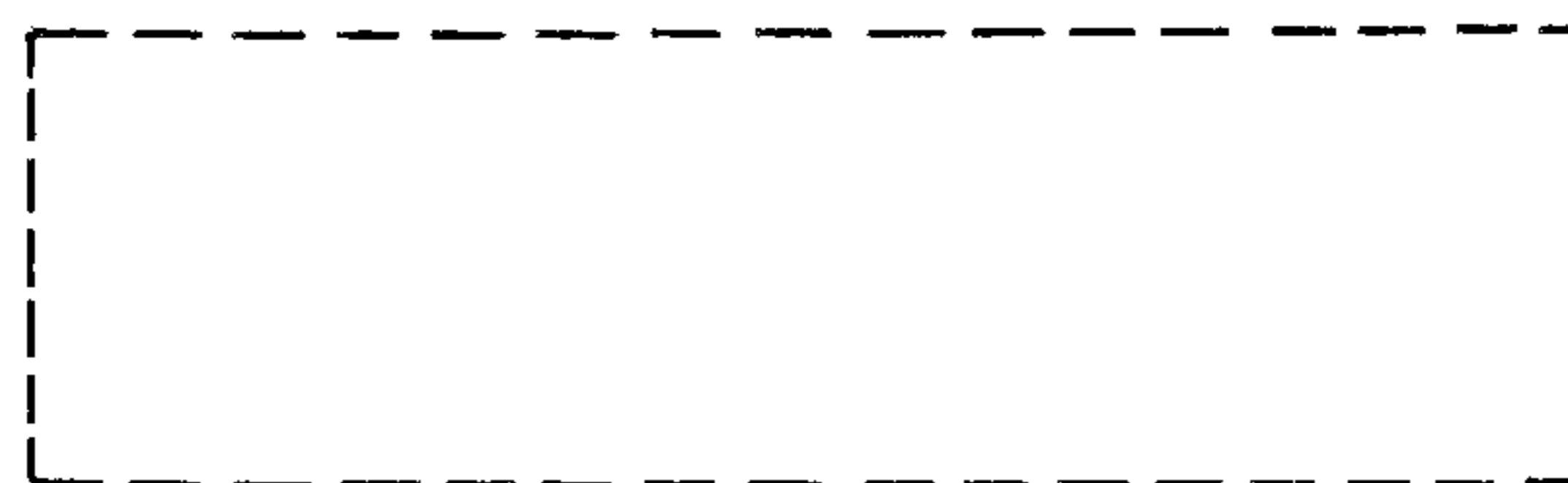

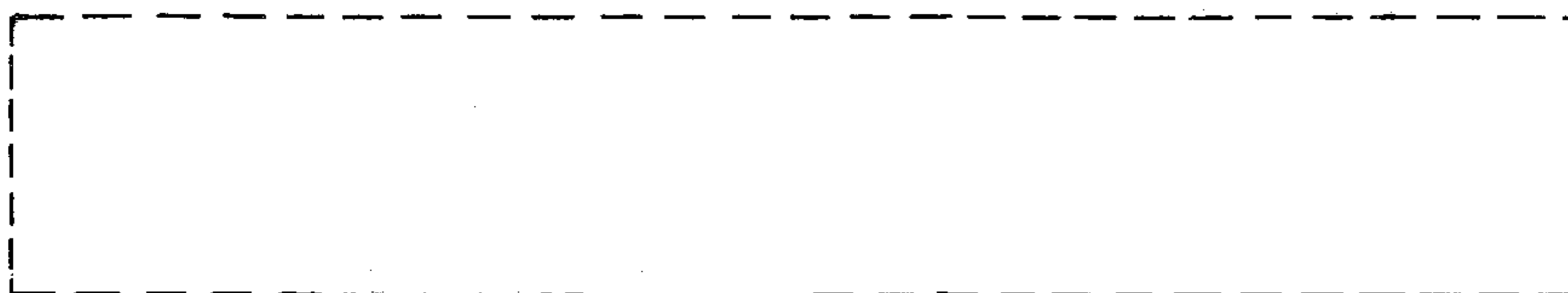

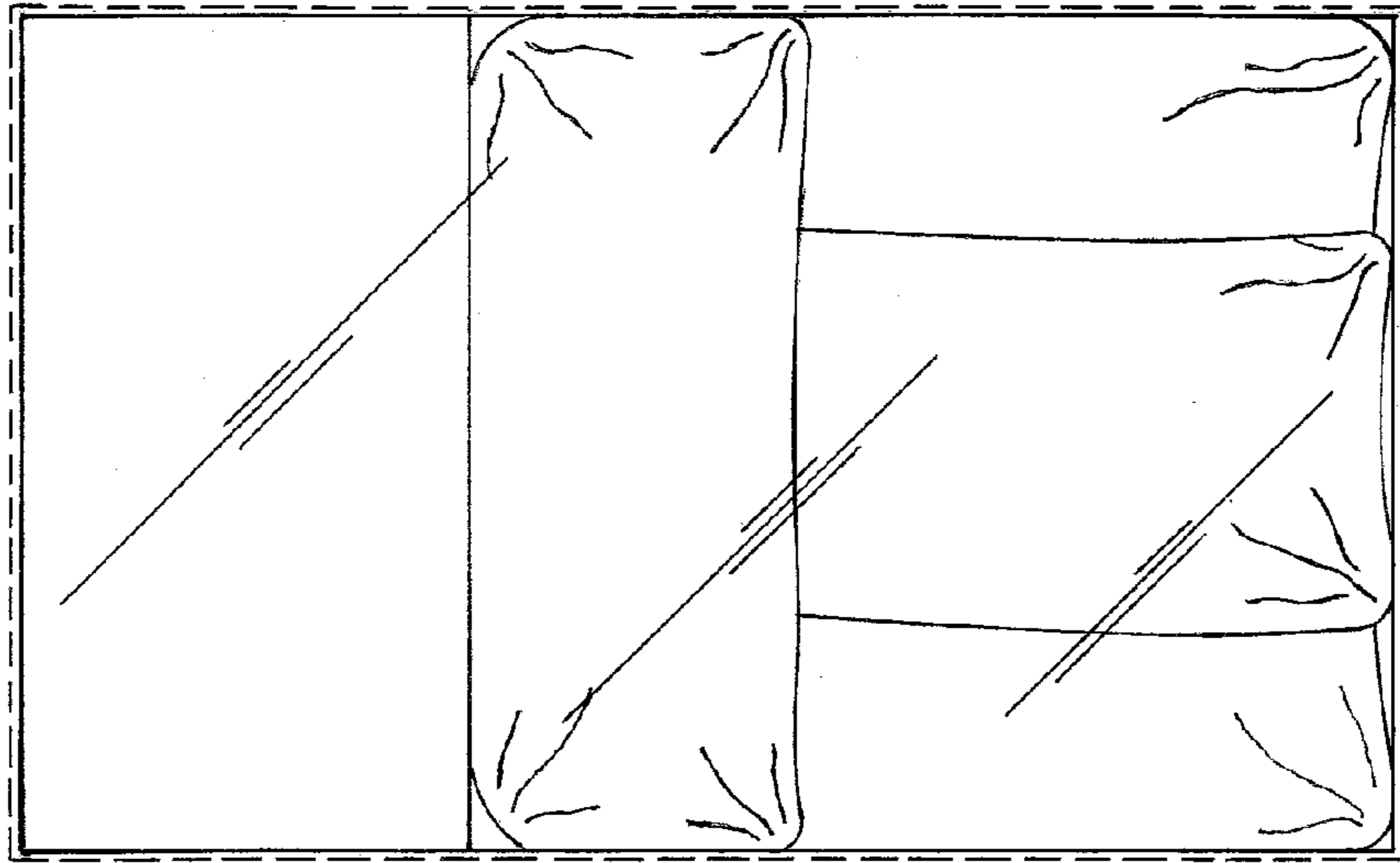
