**DESCRIPTION**

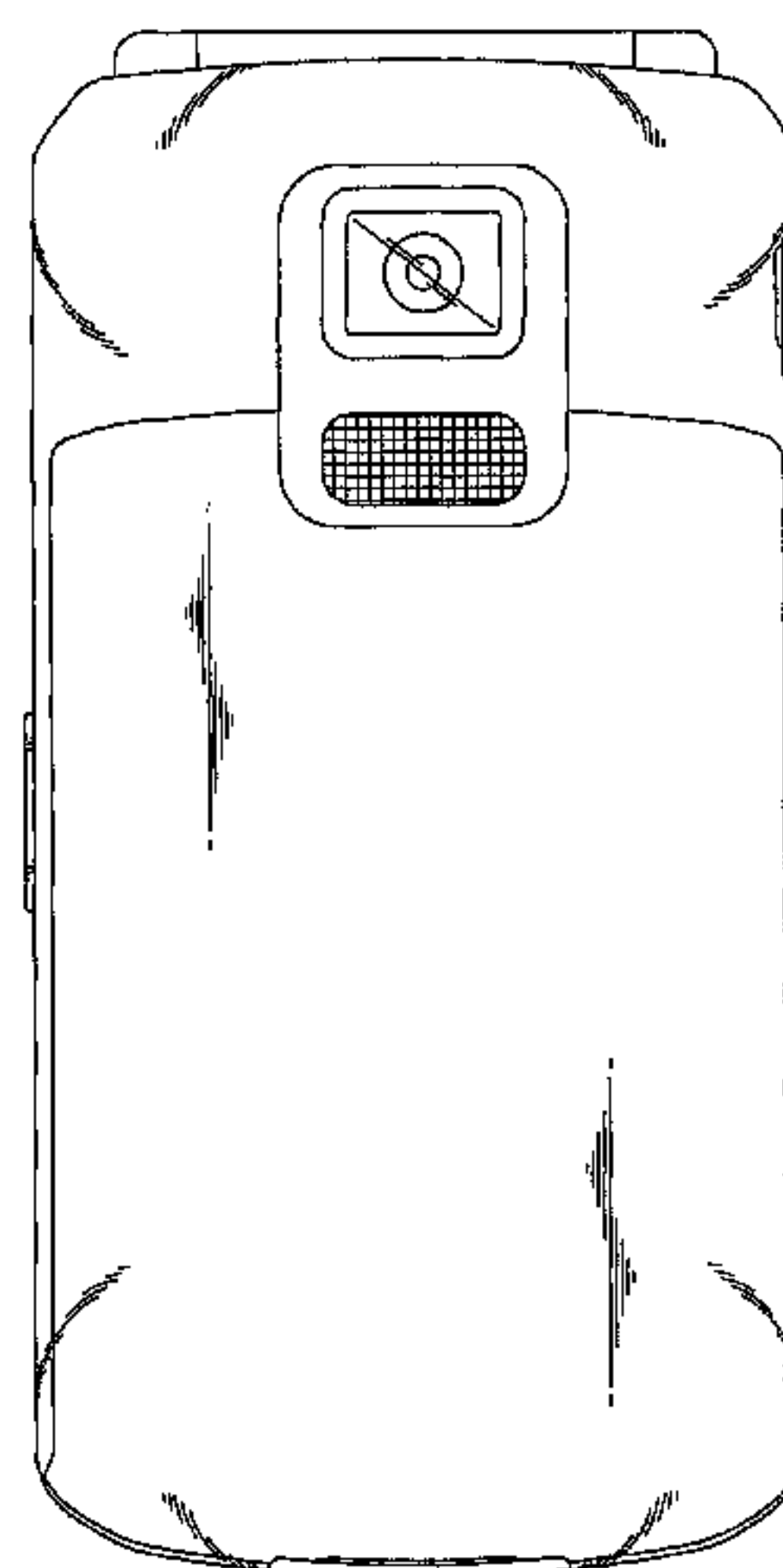
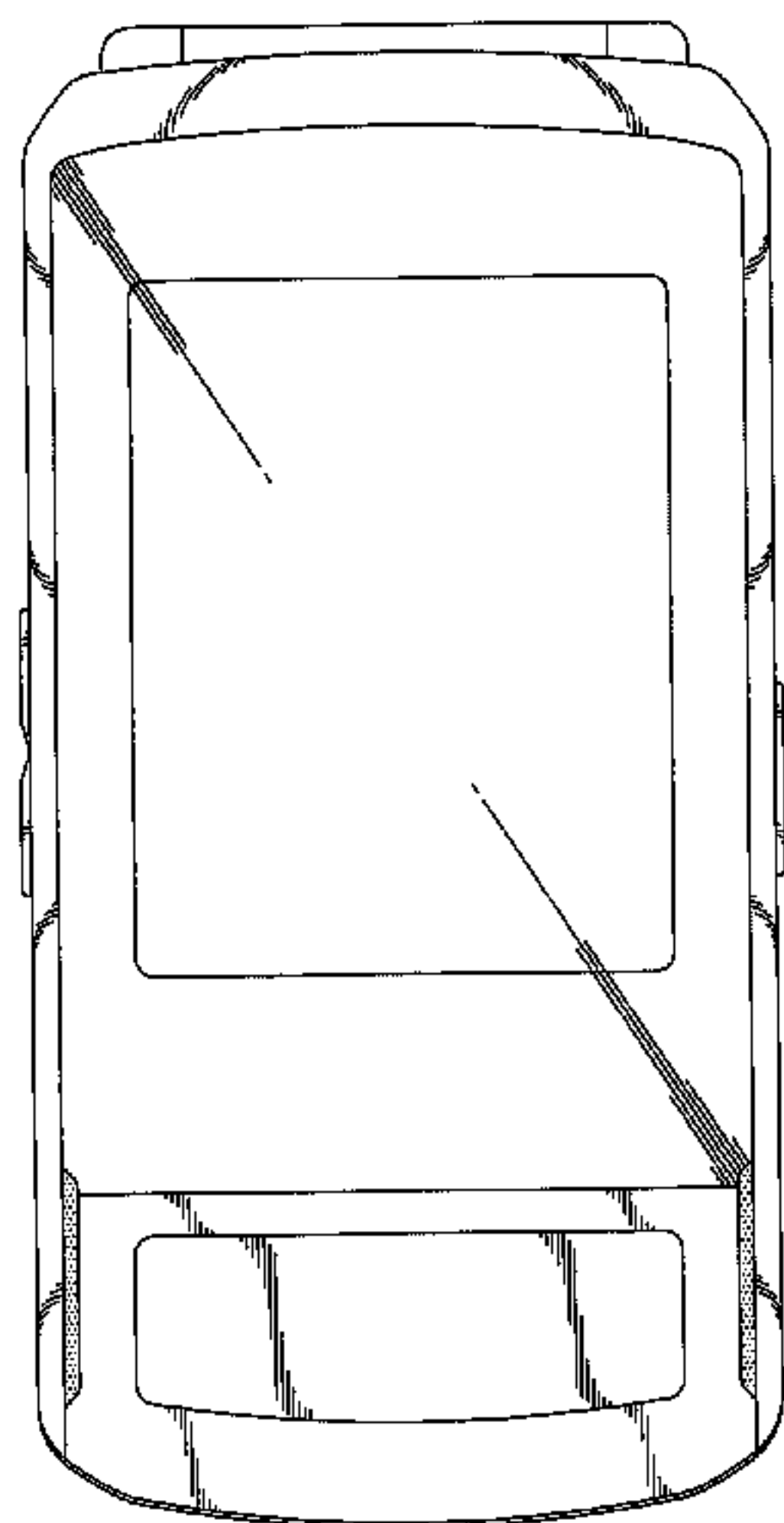

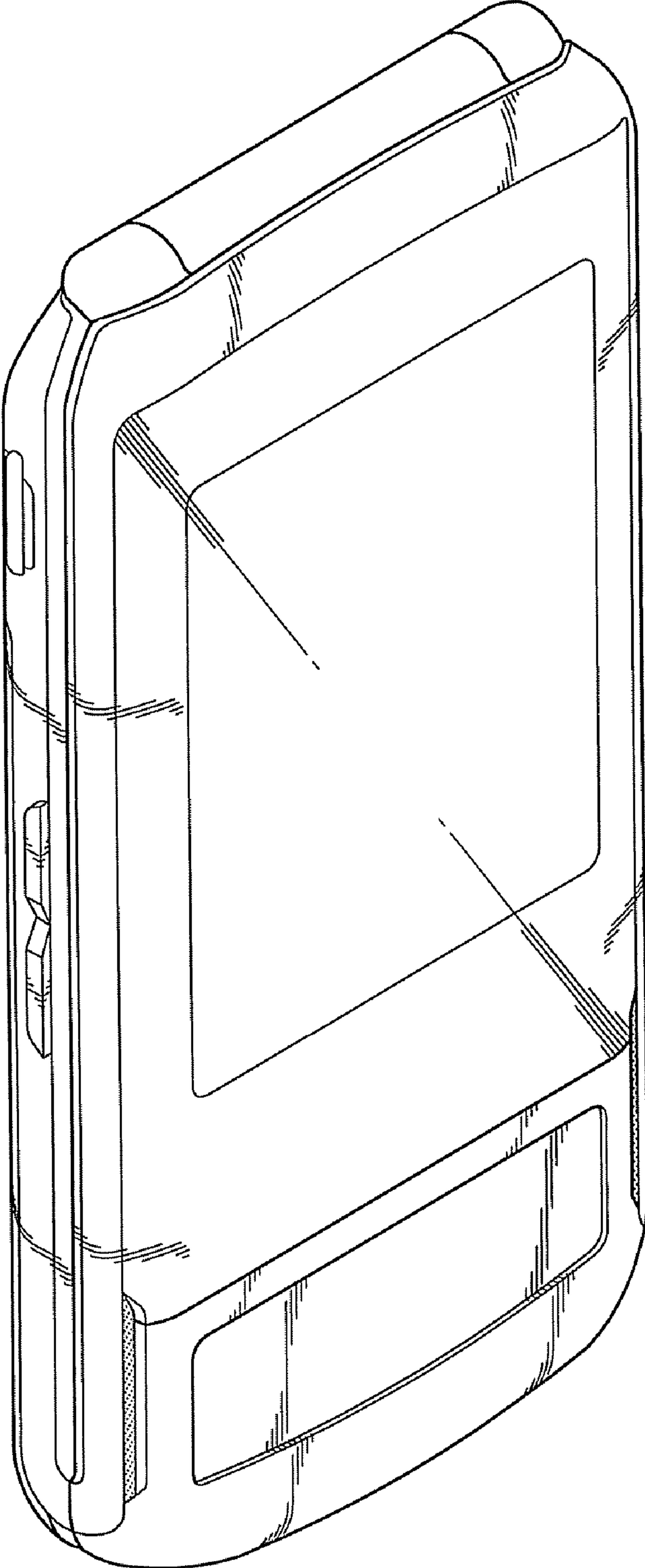

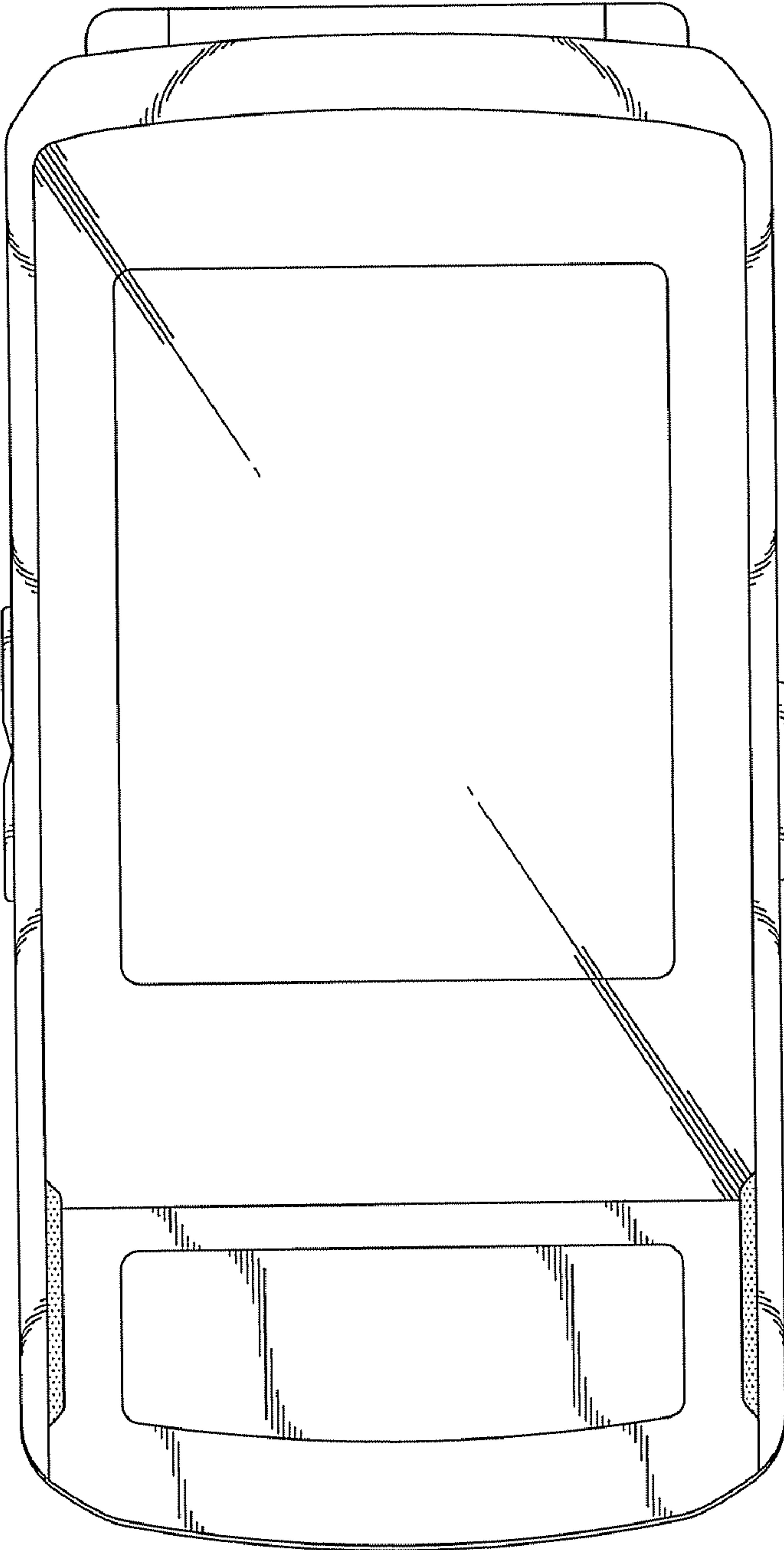

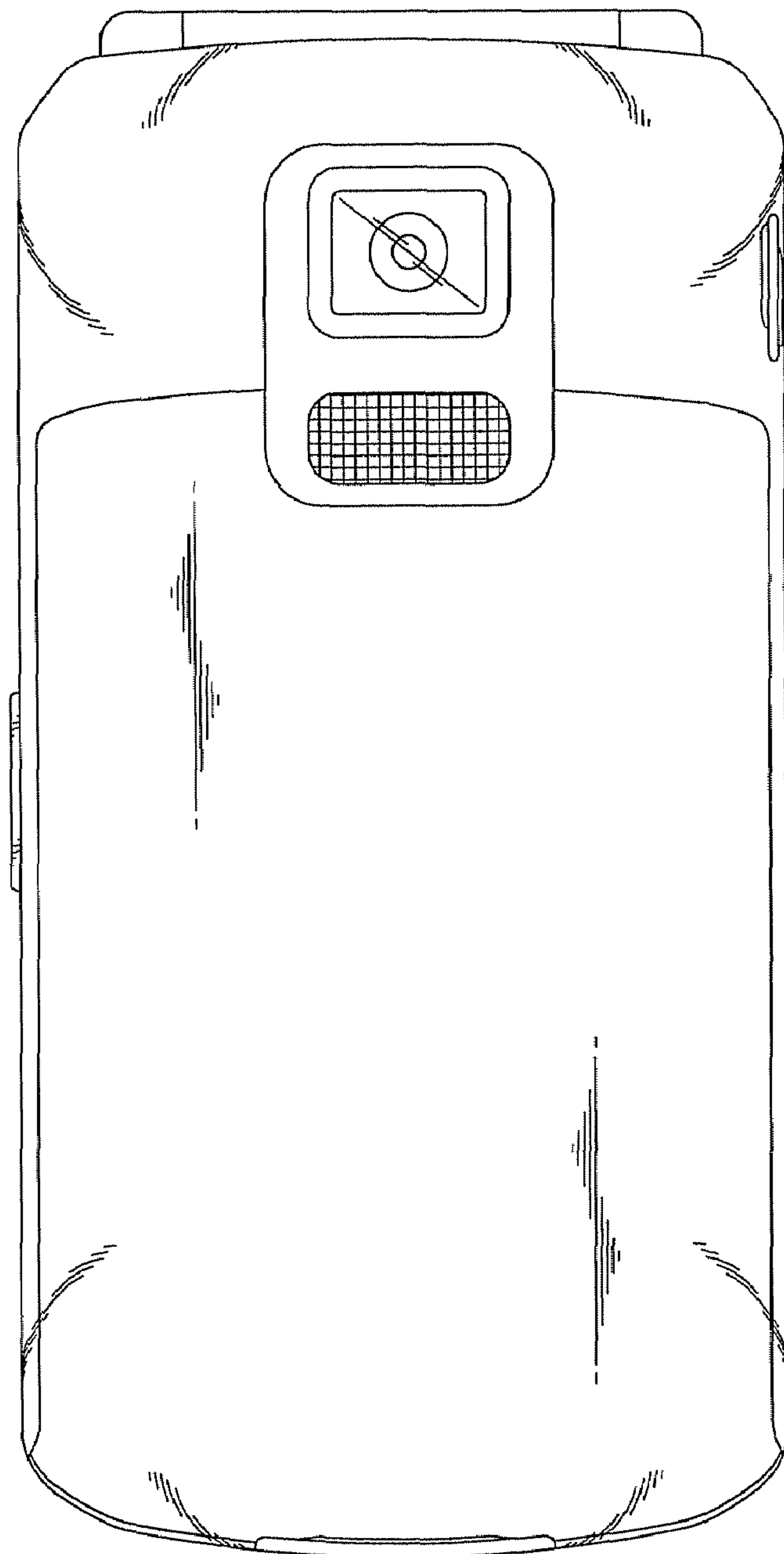

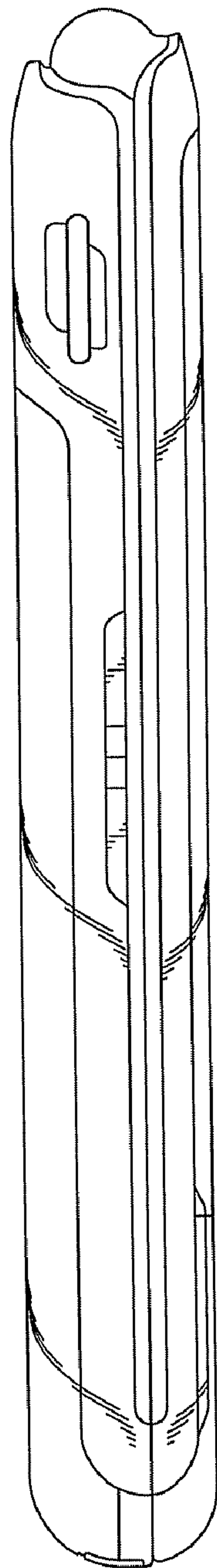

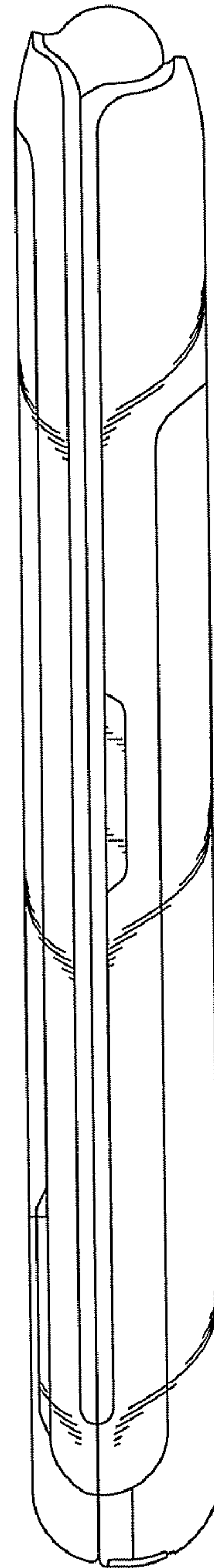

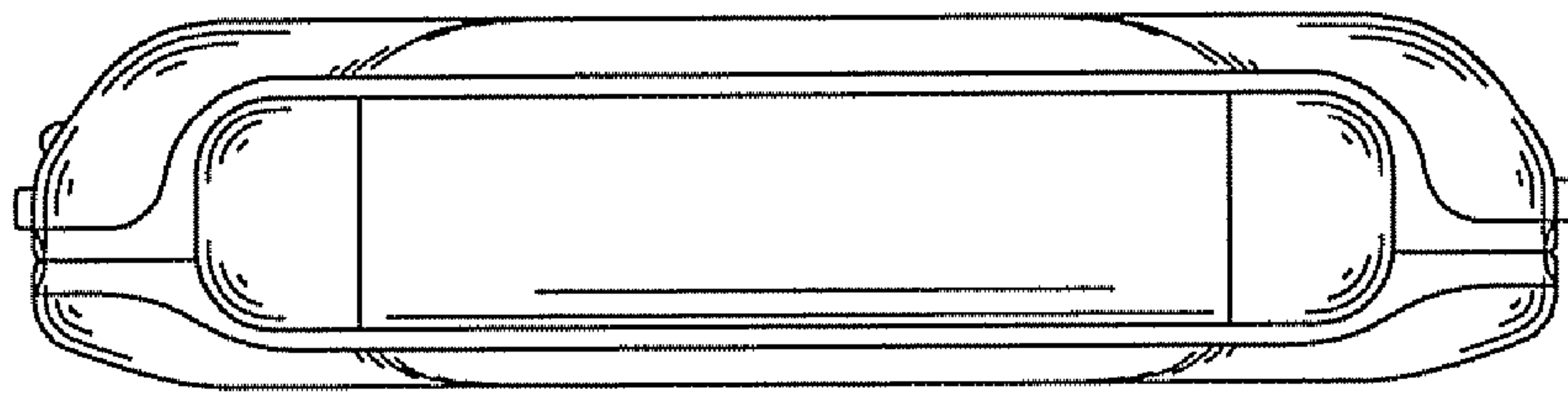

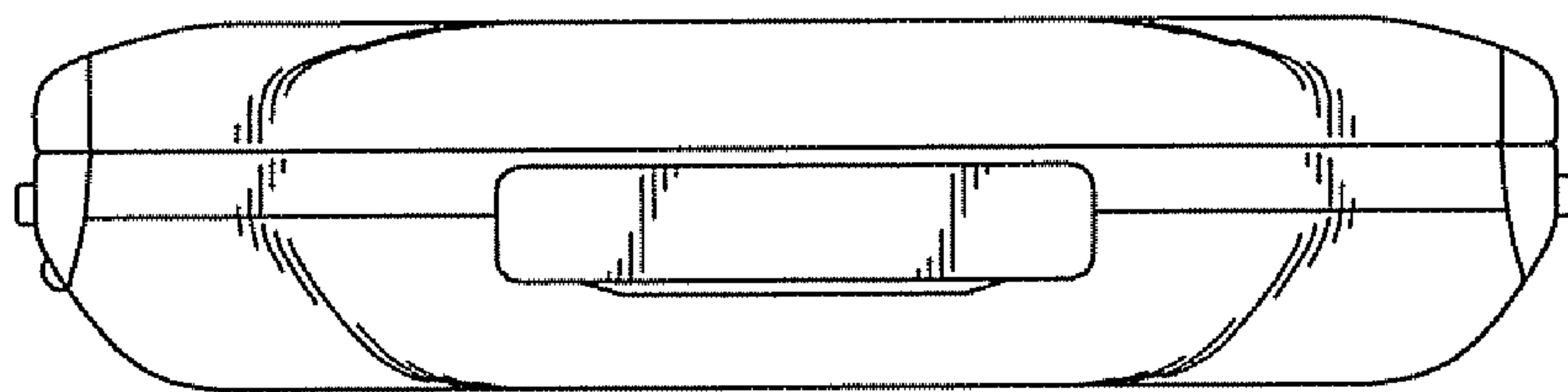
