(57) **CLAIM**

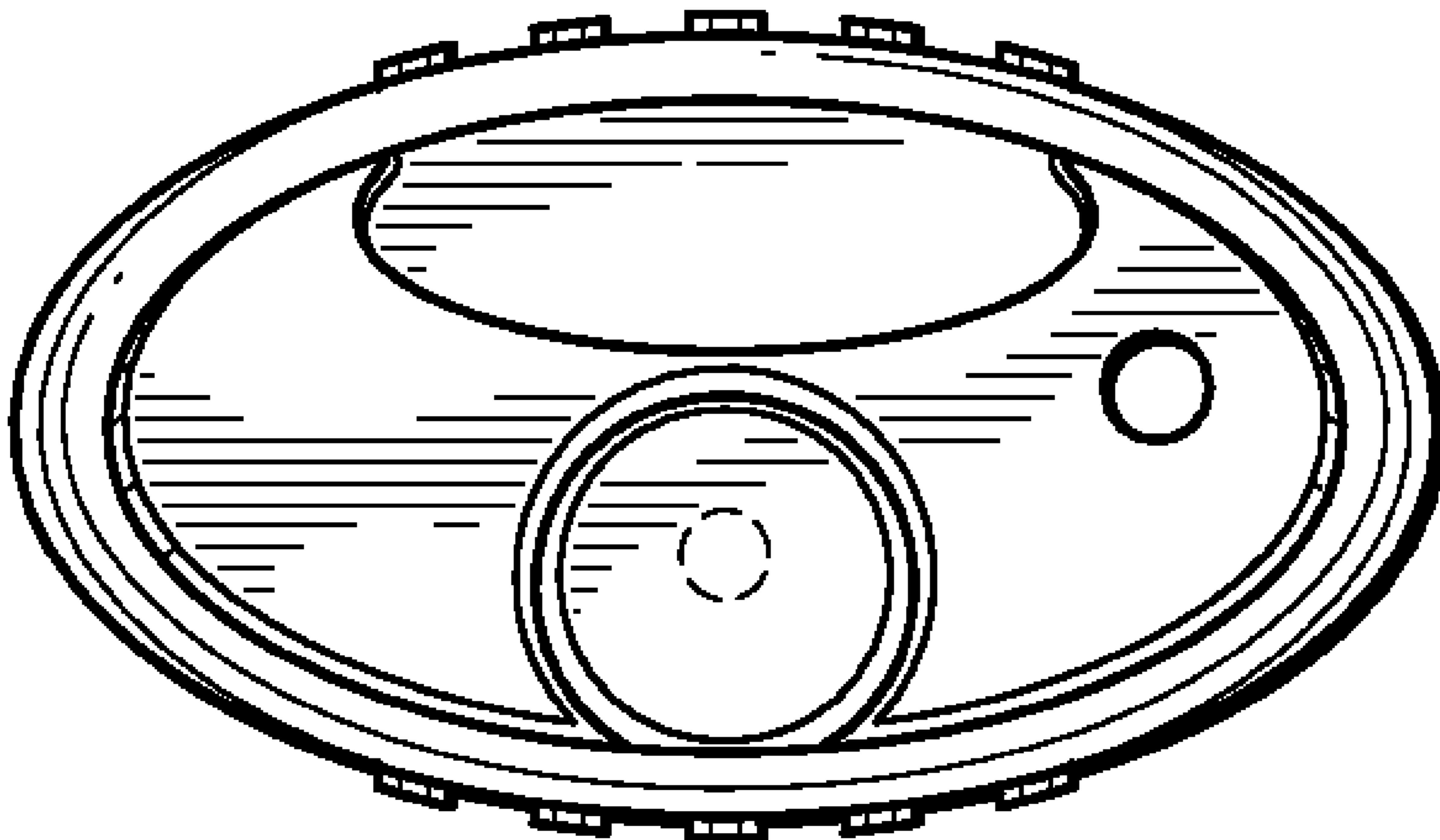
The ornamental design for a cell phone repeater, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of our design;
FIG. 2 is a second perspective view thereof;
FIG. 3 is a first top view thereof;

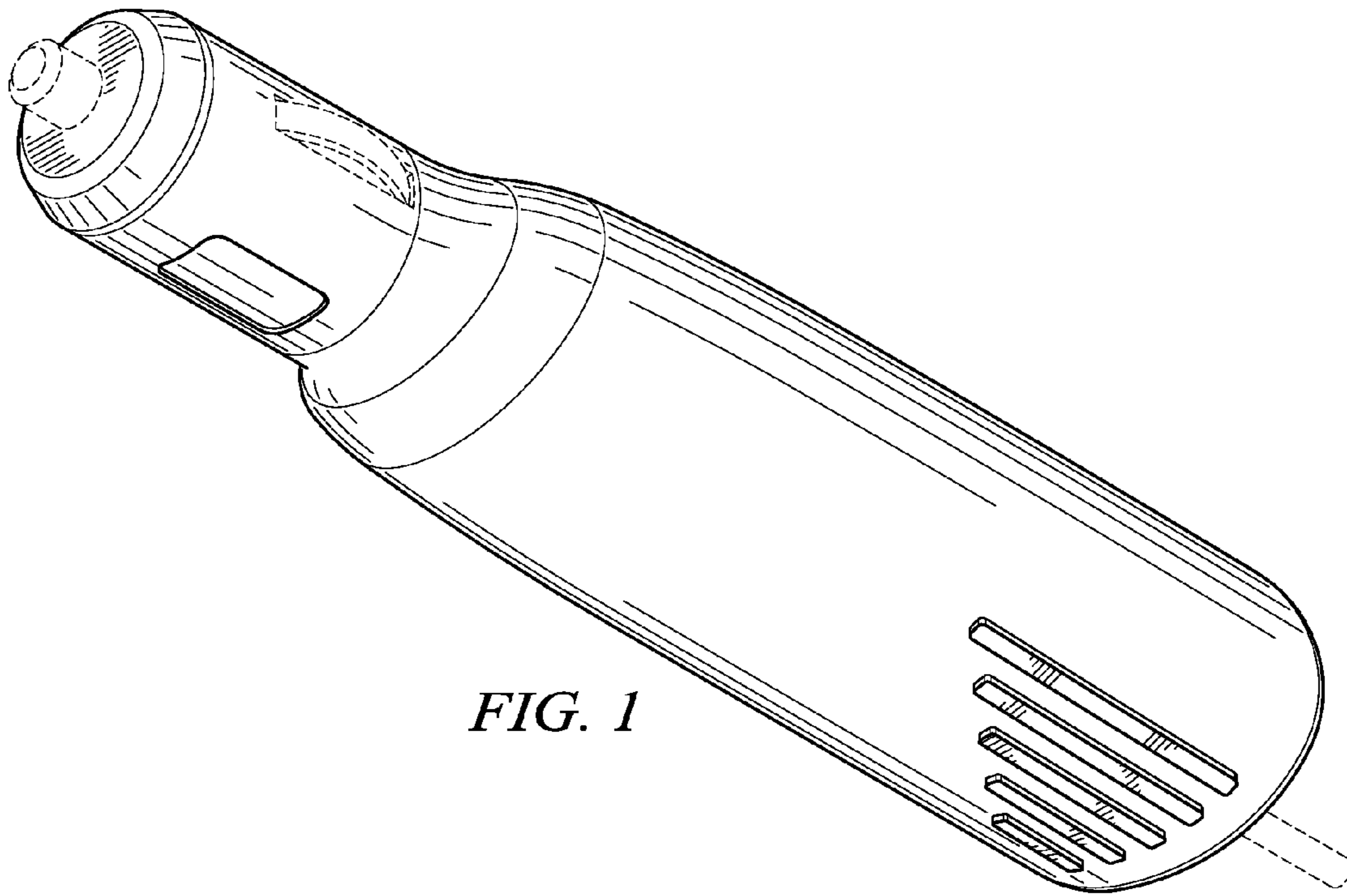

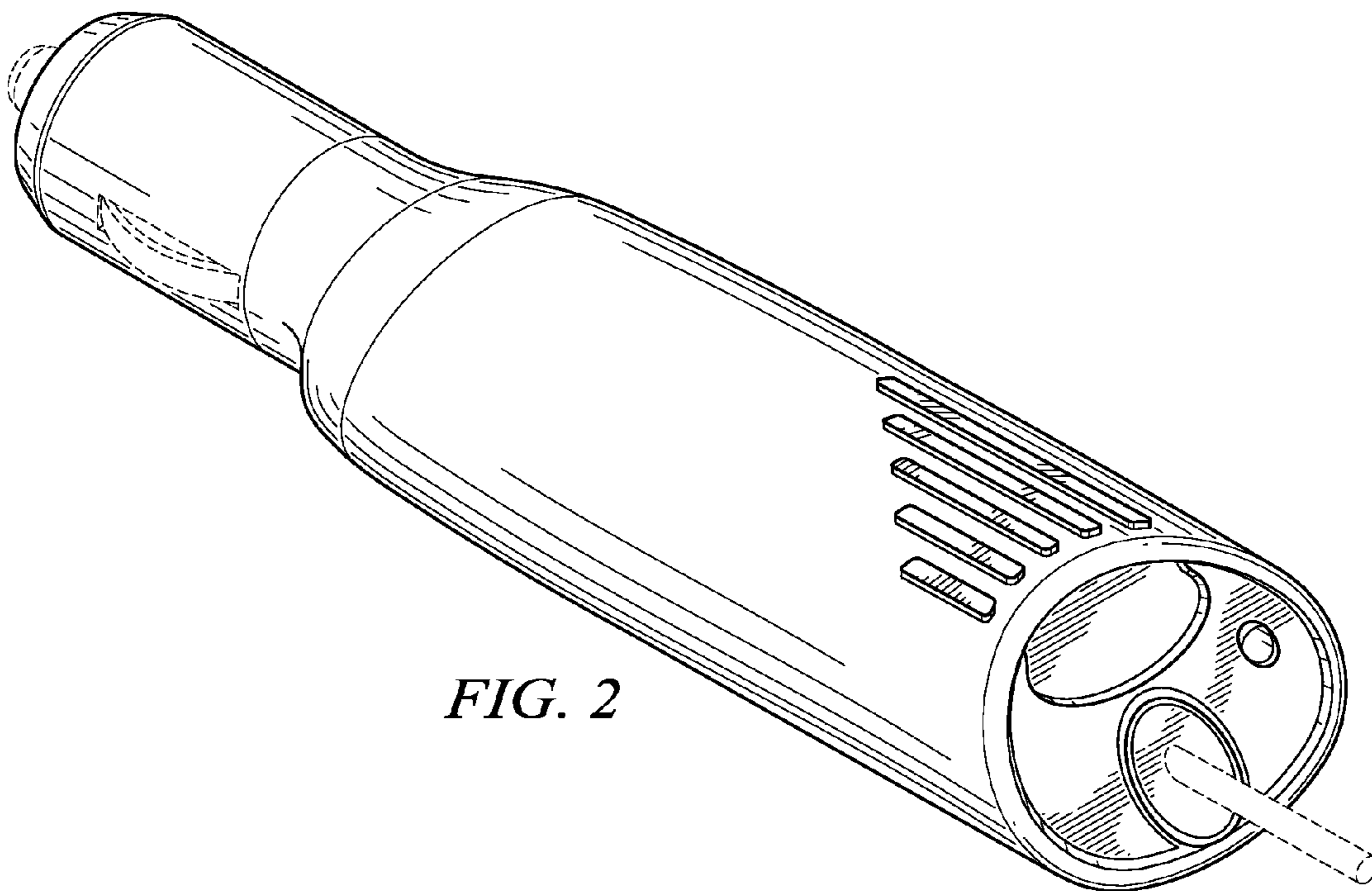

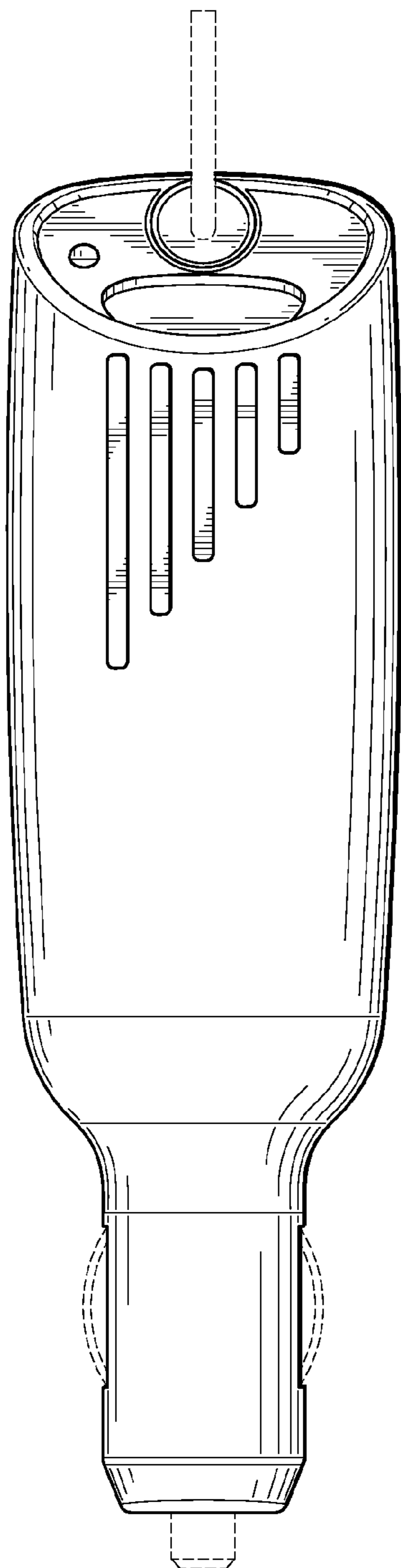

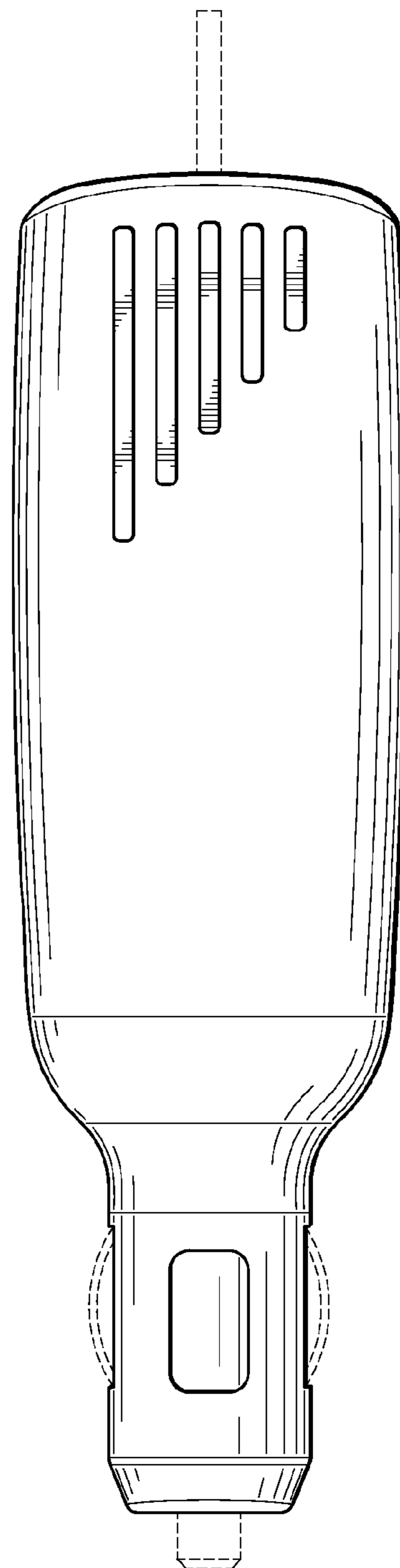

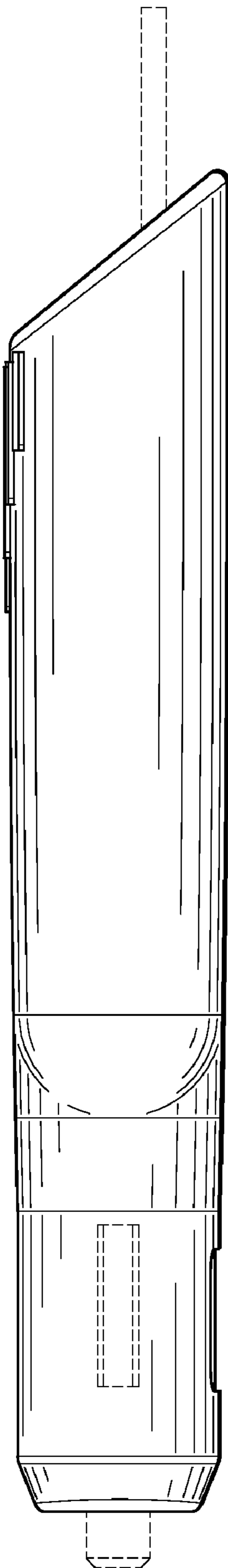

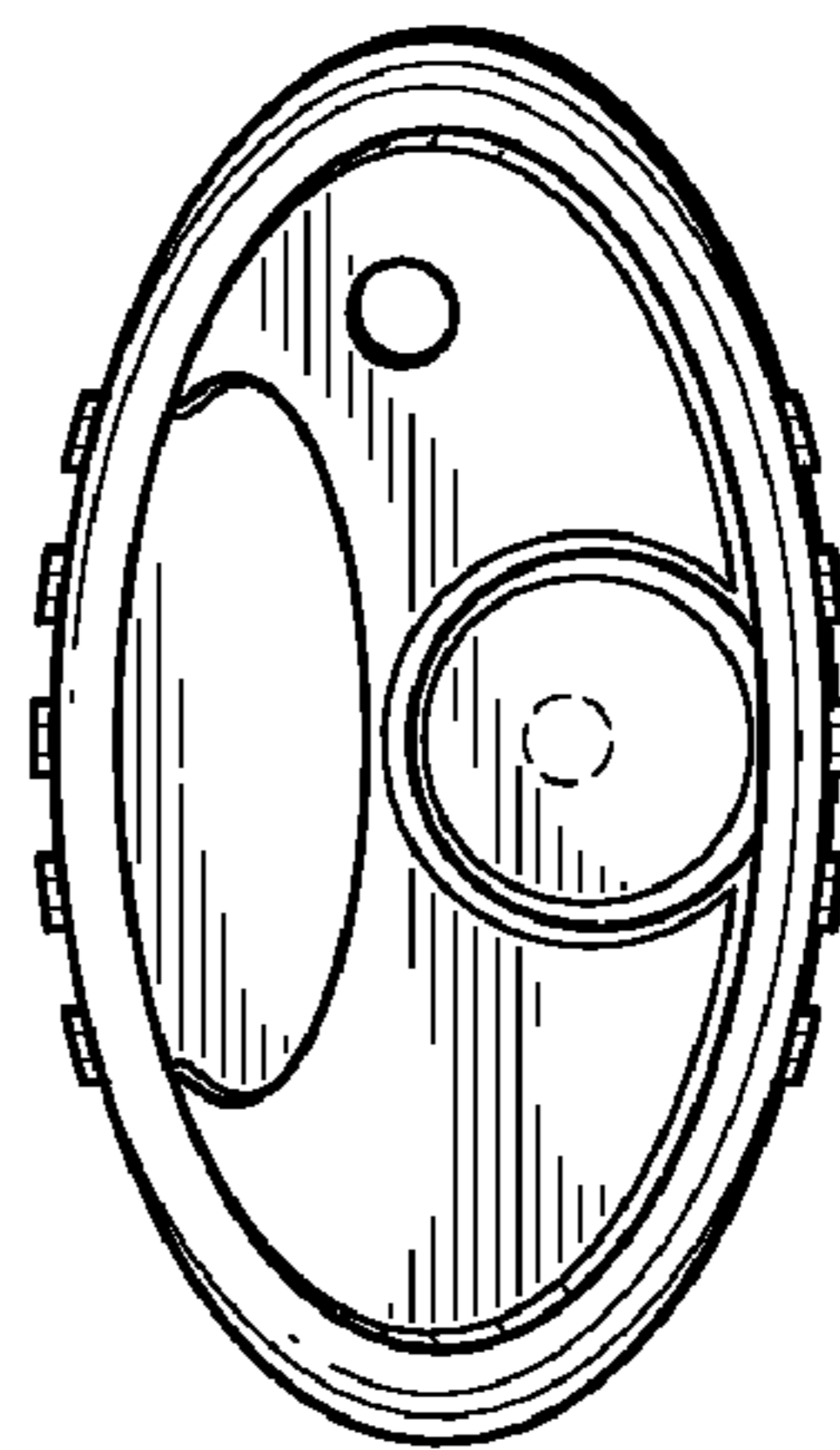

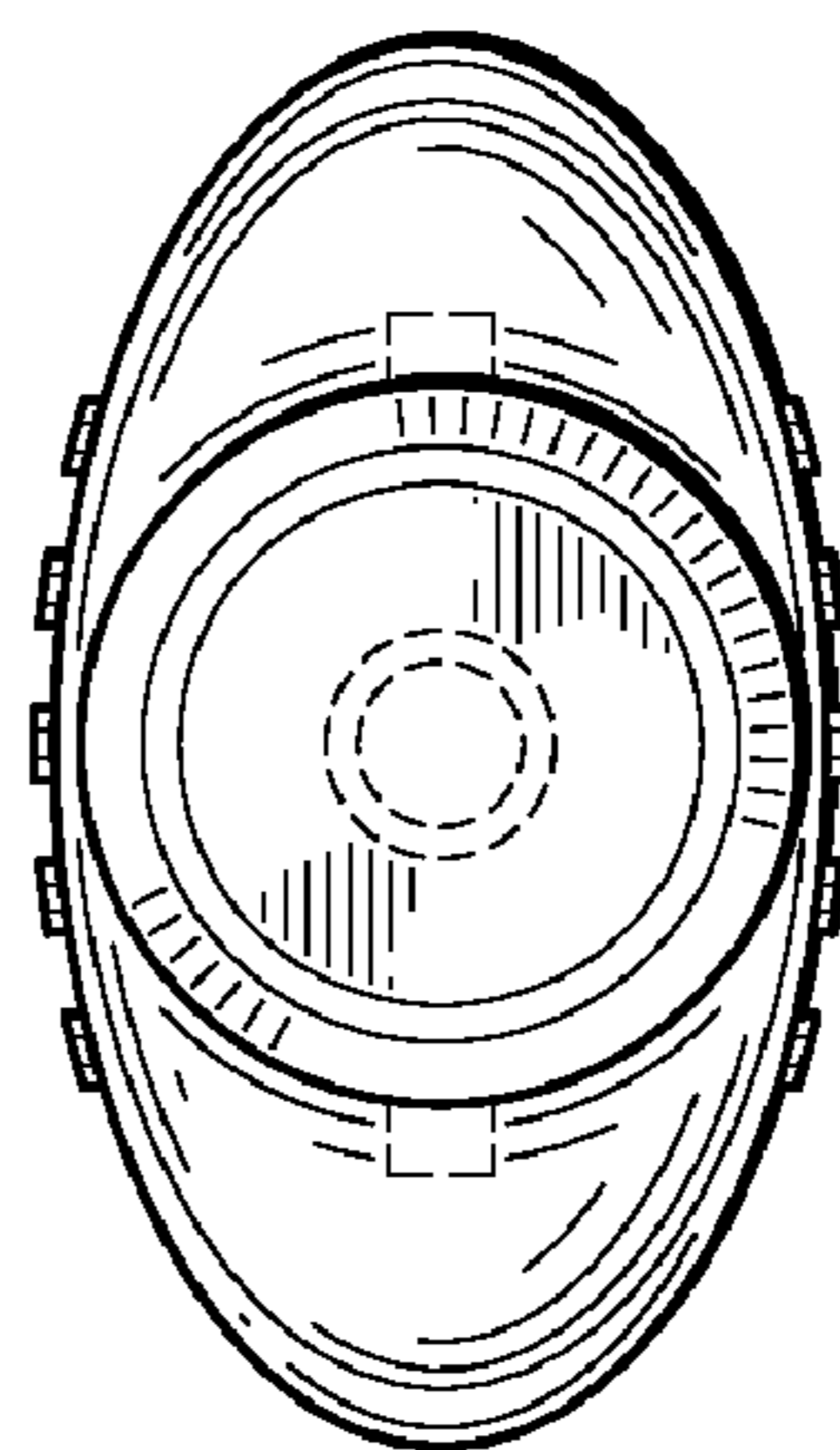
