(57) **CLAIM**

The ornamental design for an optical filter assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an optical filter assembly showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a perspective view of the optical filter assembly of FIG. 1, with the frame portion rotated 180 degrees from its position in FIG. 1.

FIG. 9 is a front elevational view of the optical filter assembly in the position shown in FIG. 8.

FIG. 10 is a rear elevational view of the optical filter assembly in the position shown in FIG. 8;

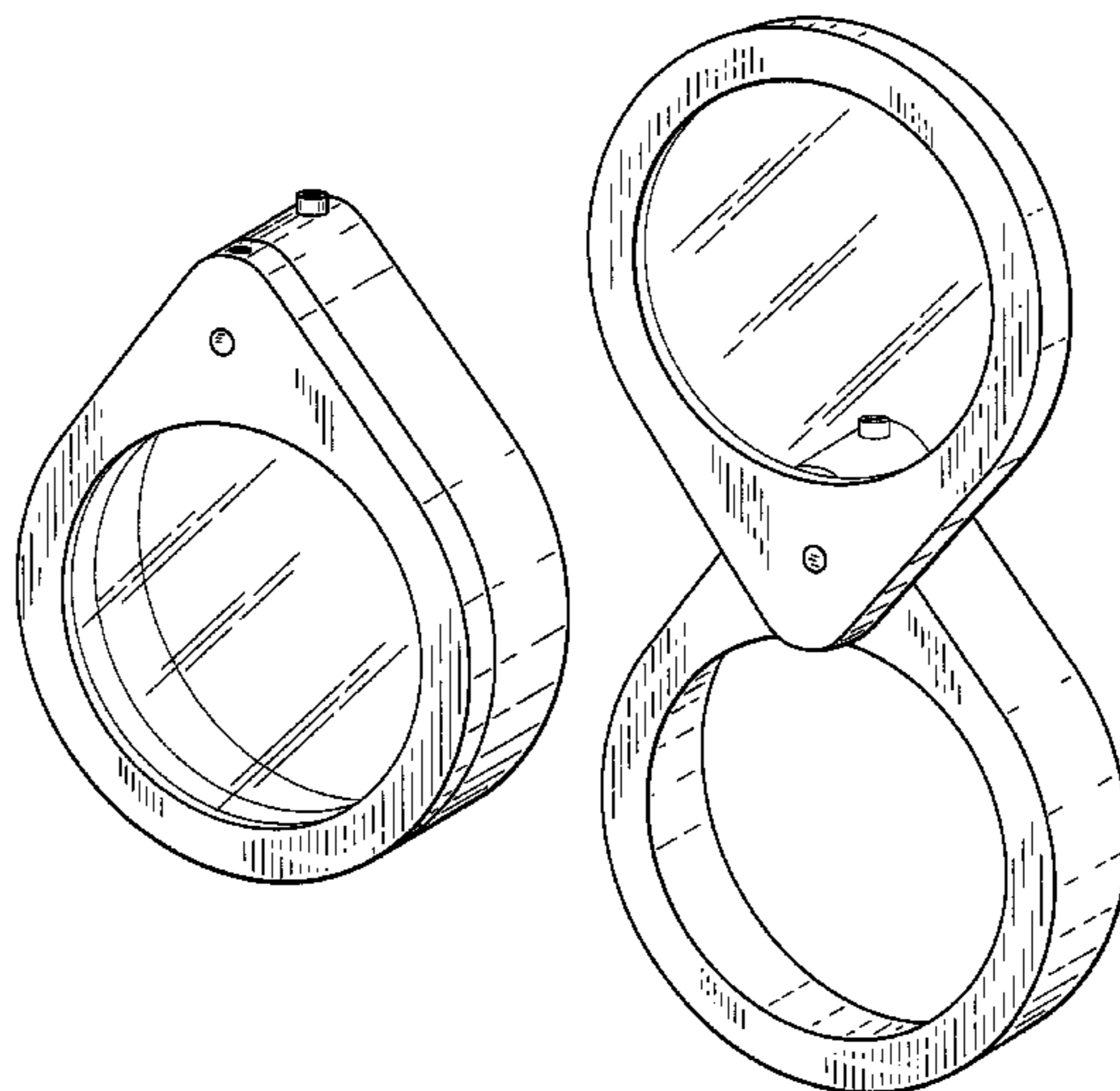
FIG. 11 is a left side elevational view of the optical filter assembly in the position shown in FIG. 8;

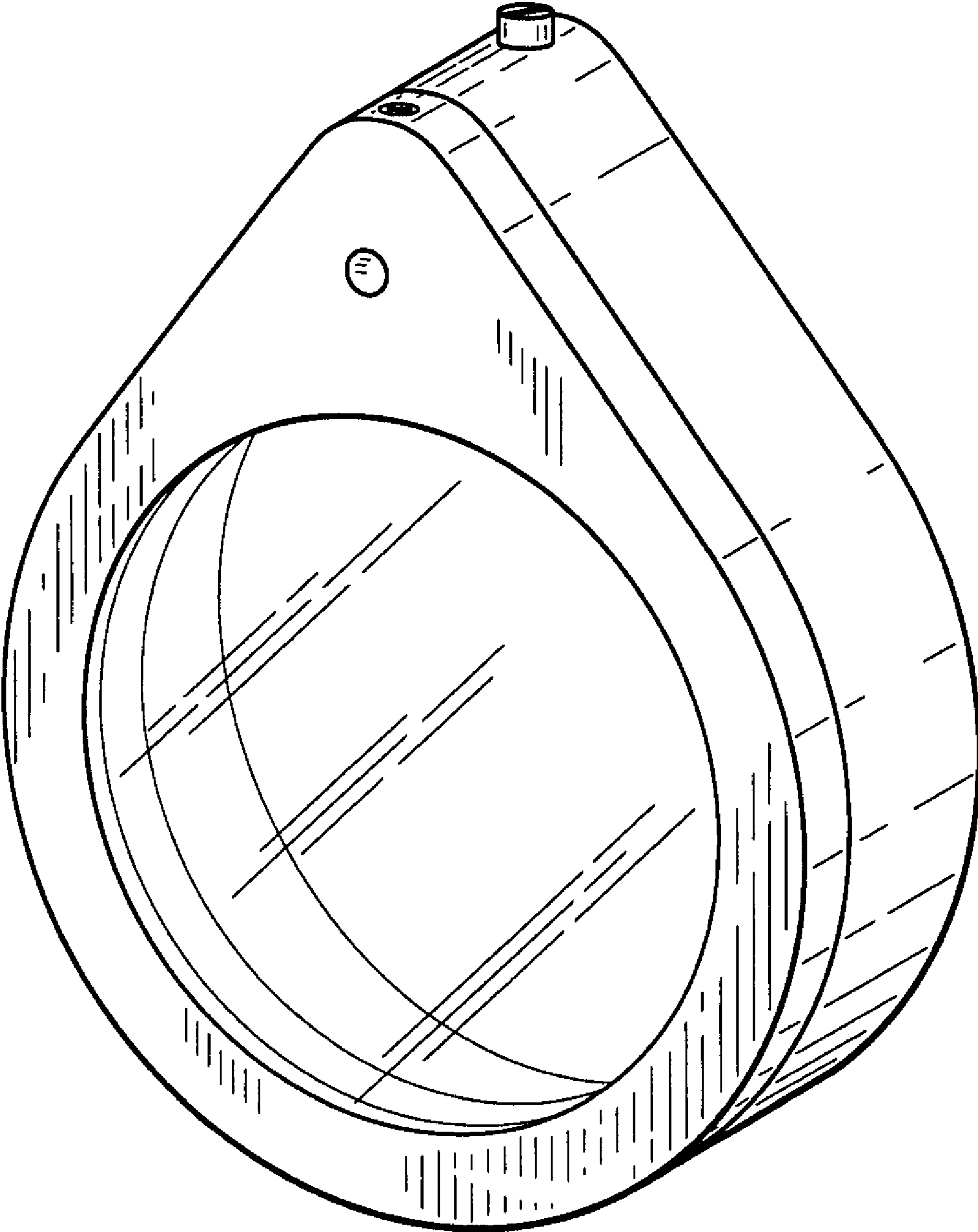

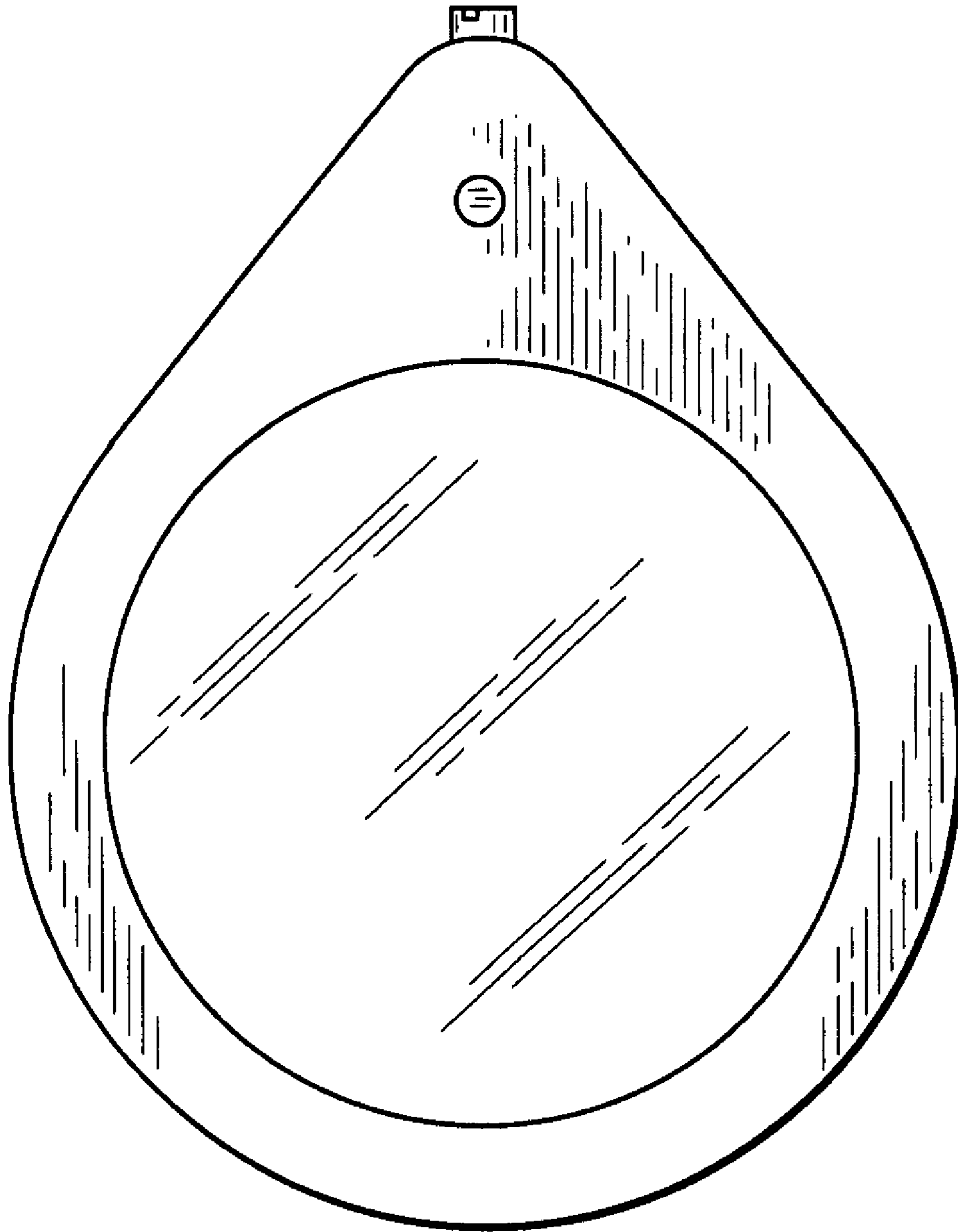

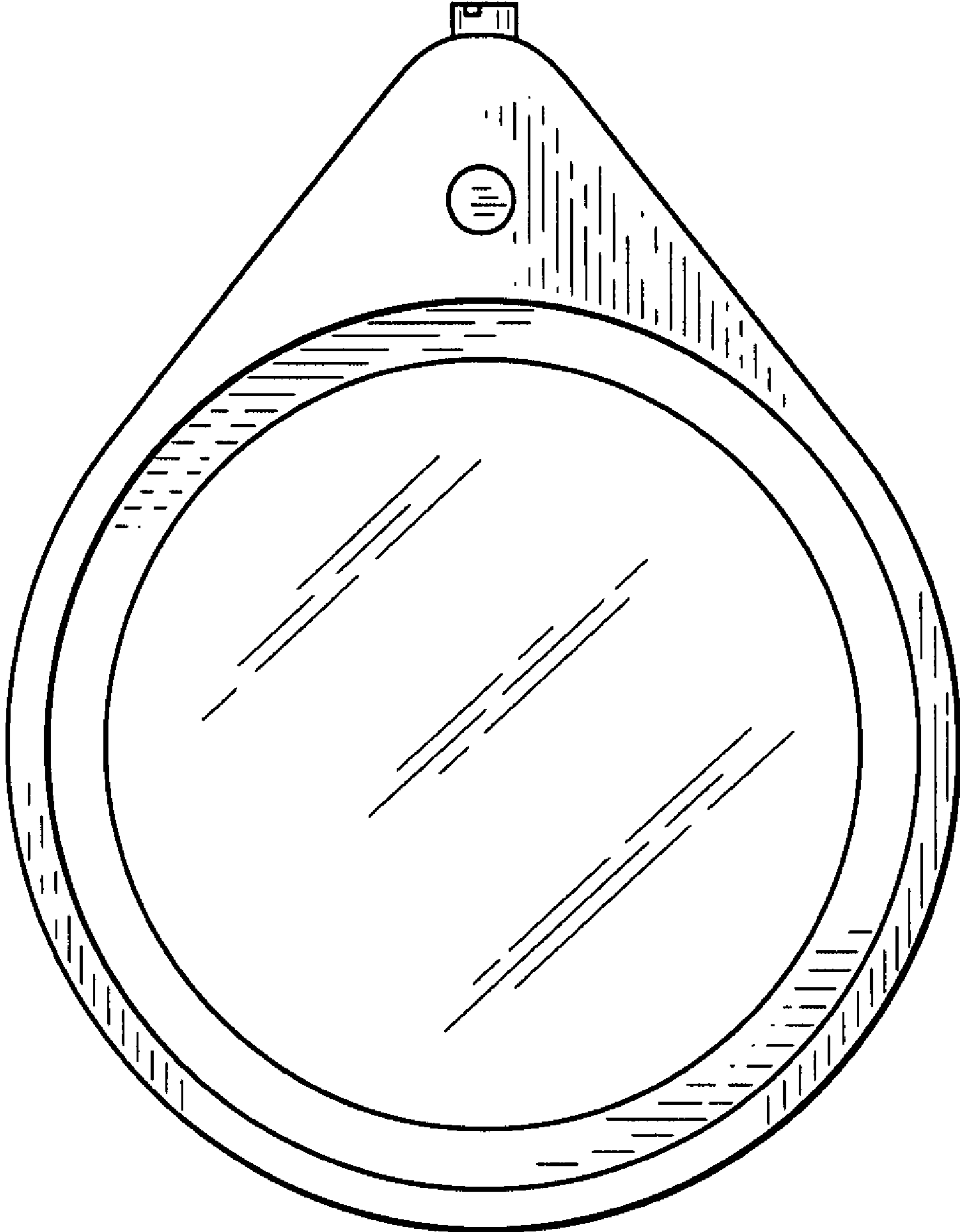

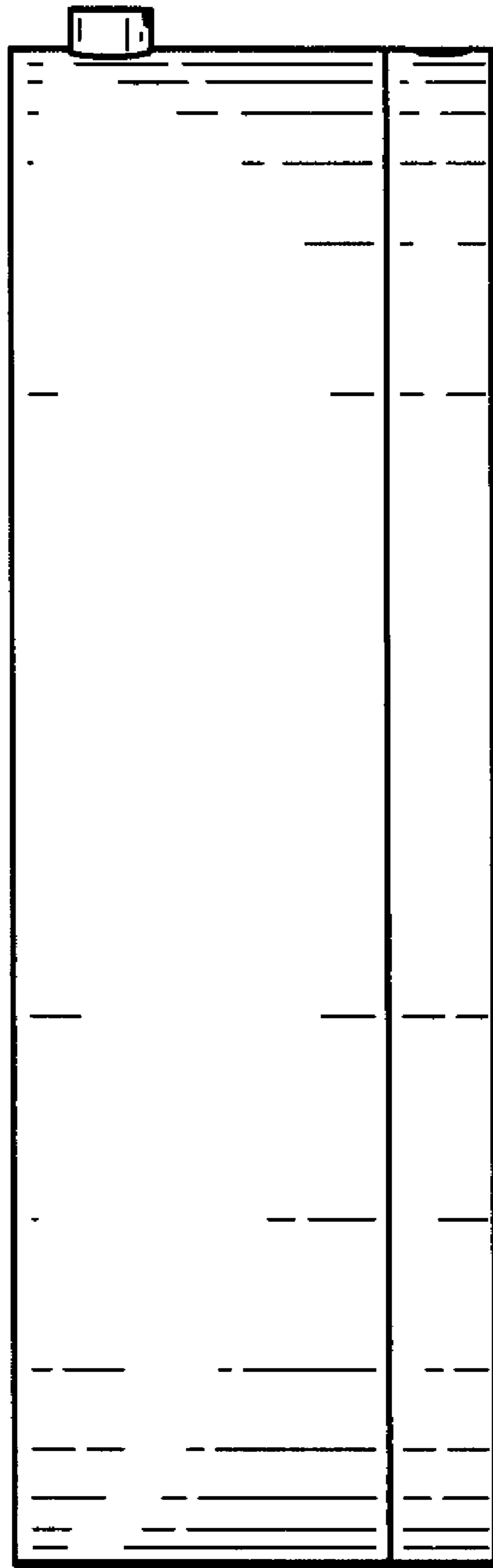

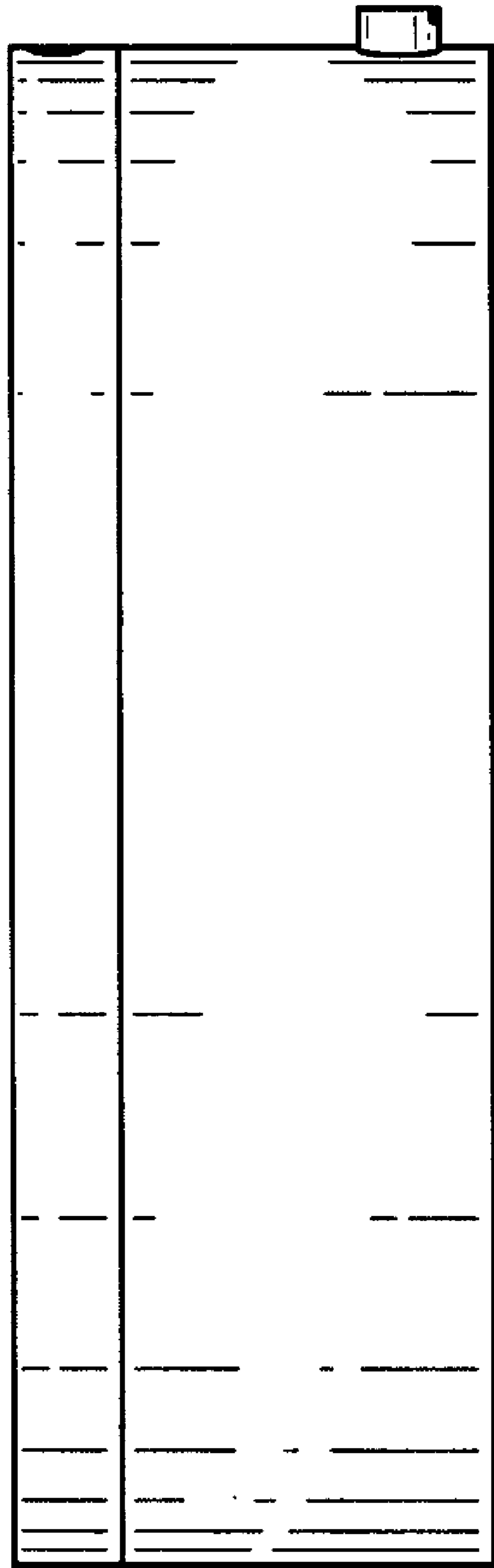

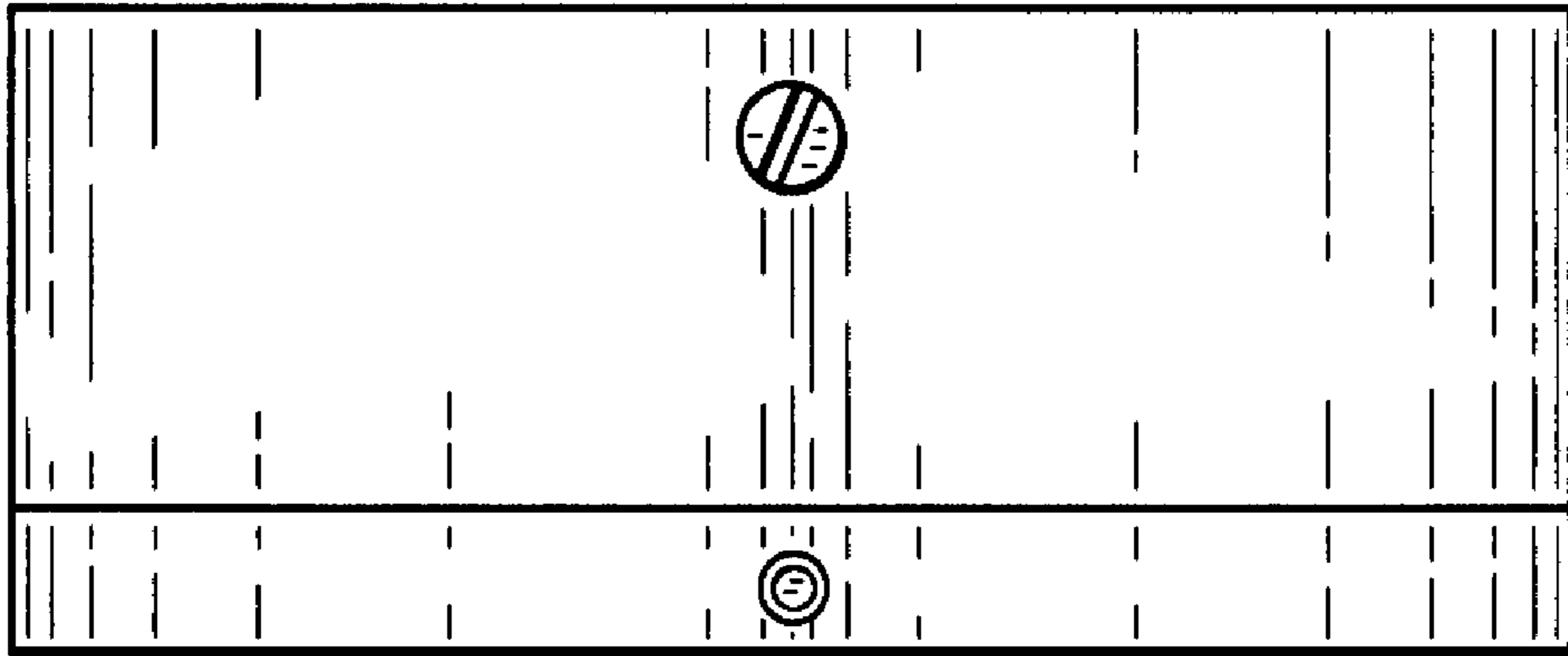

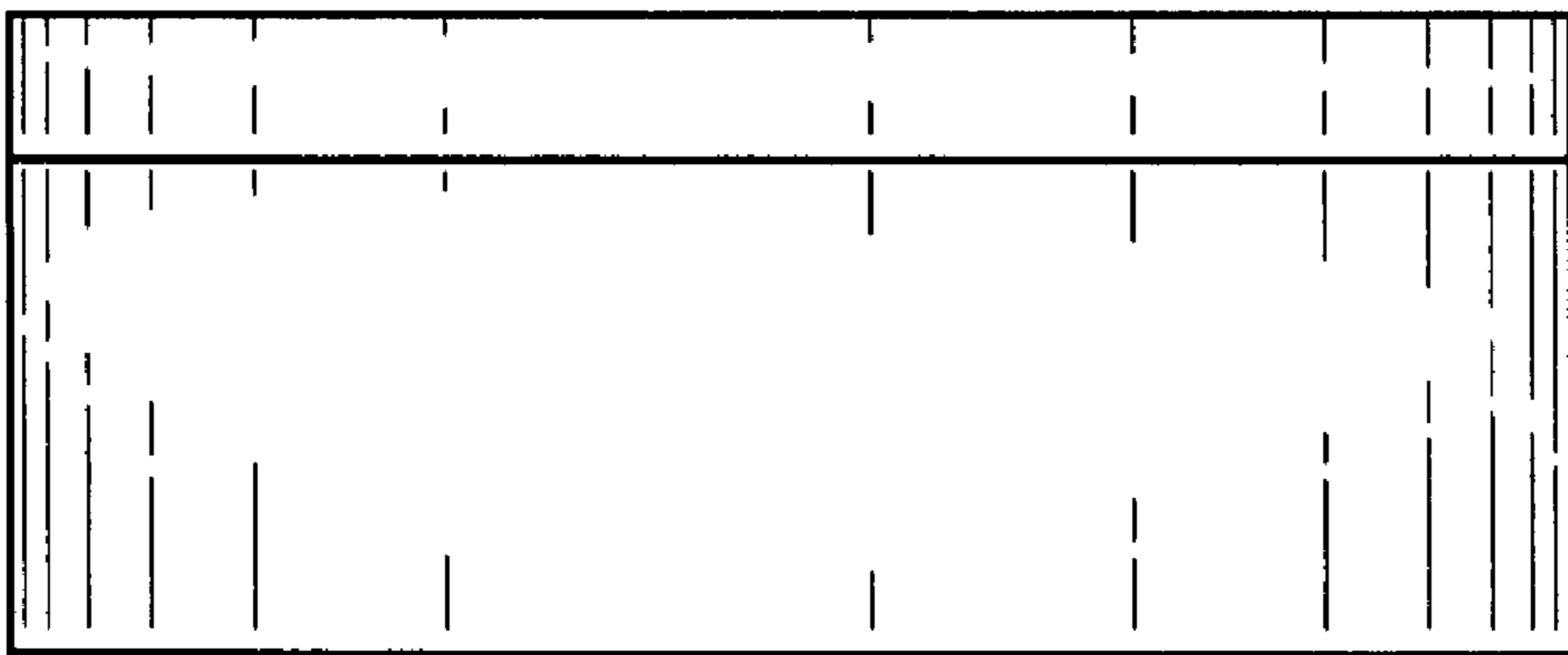

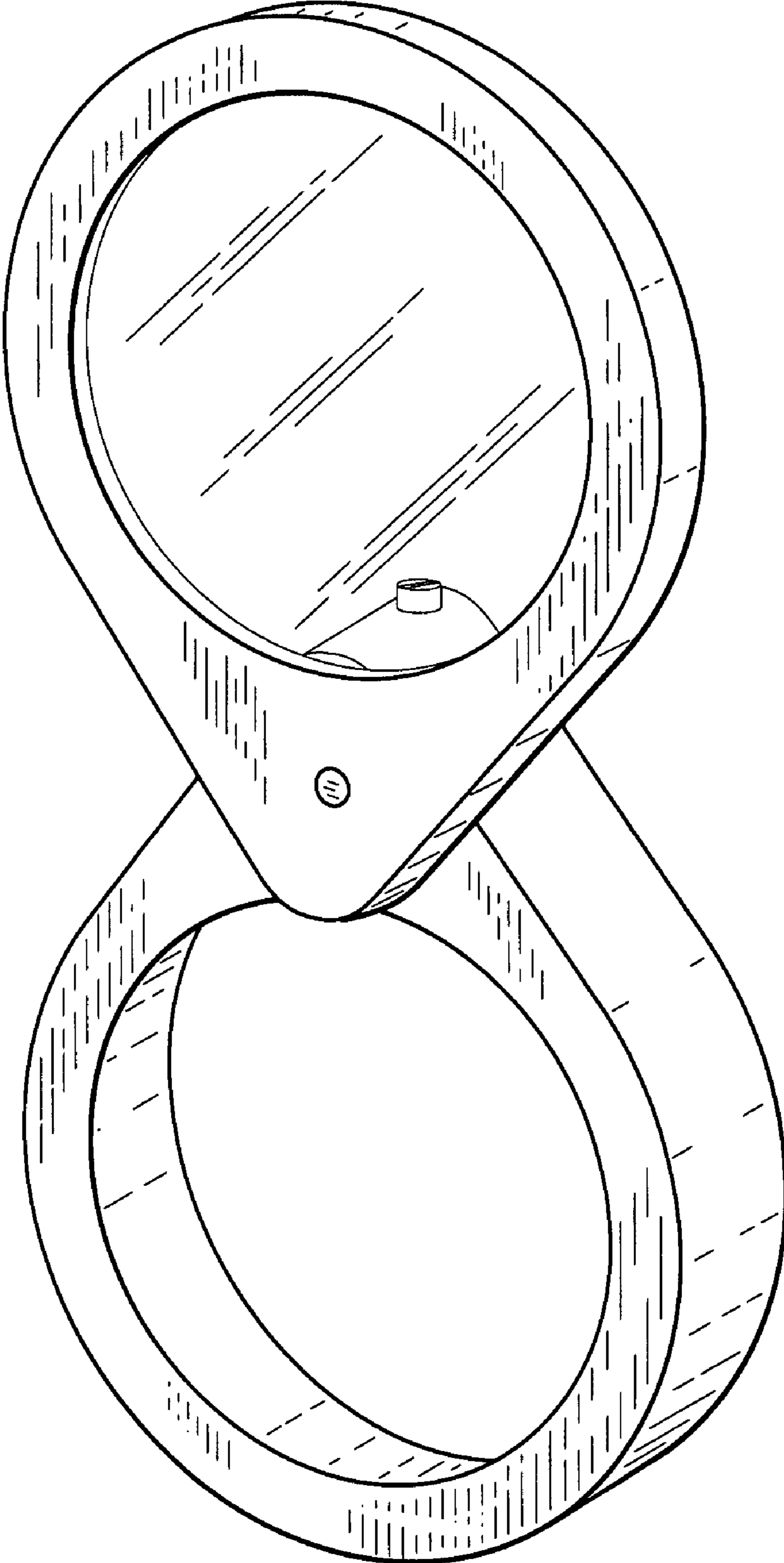

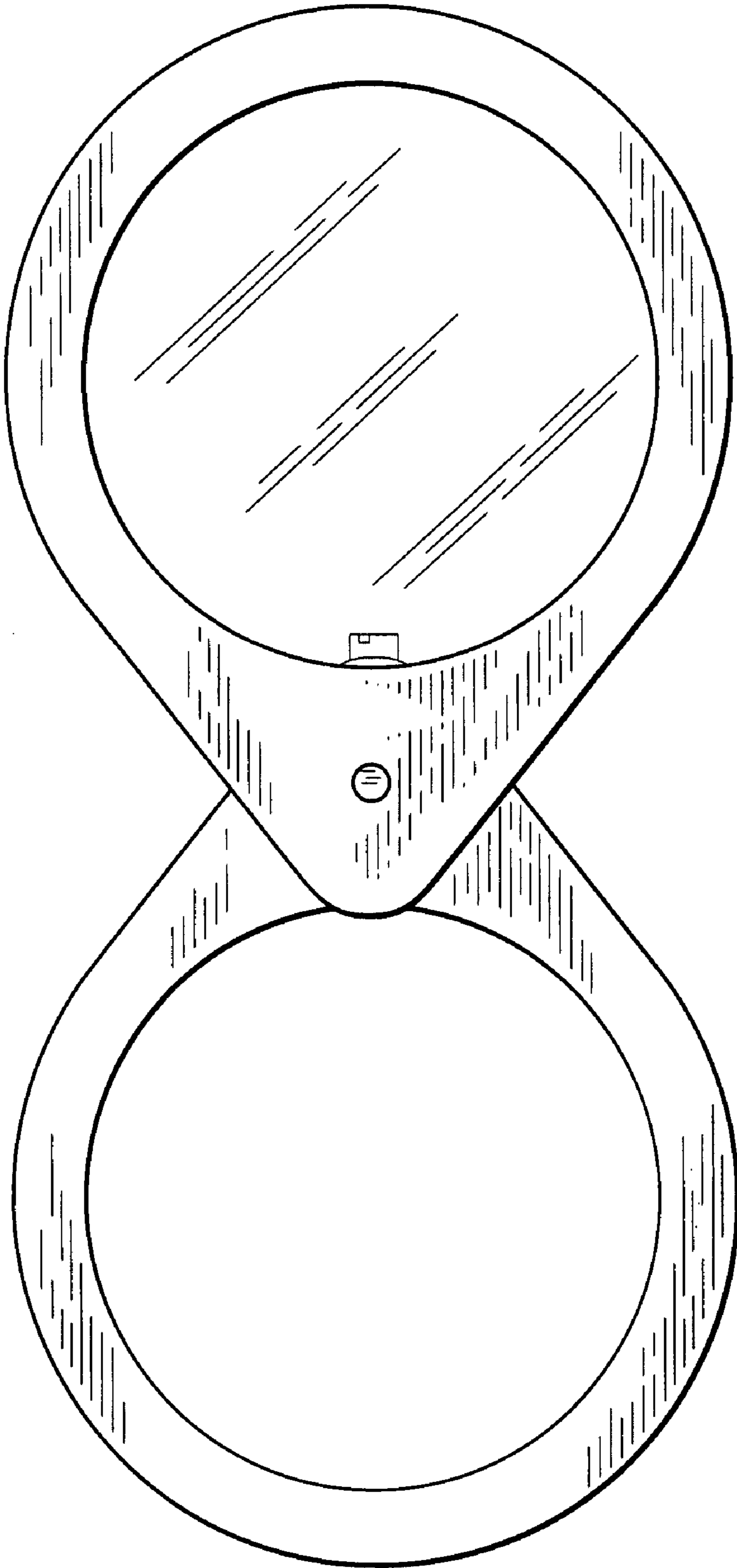

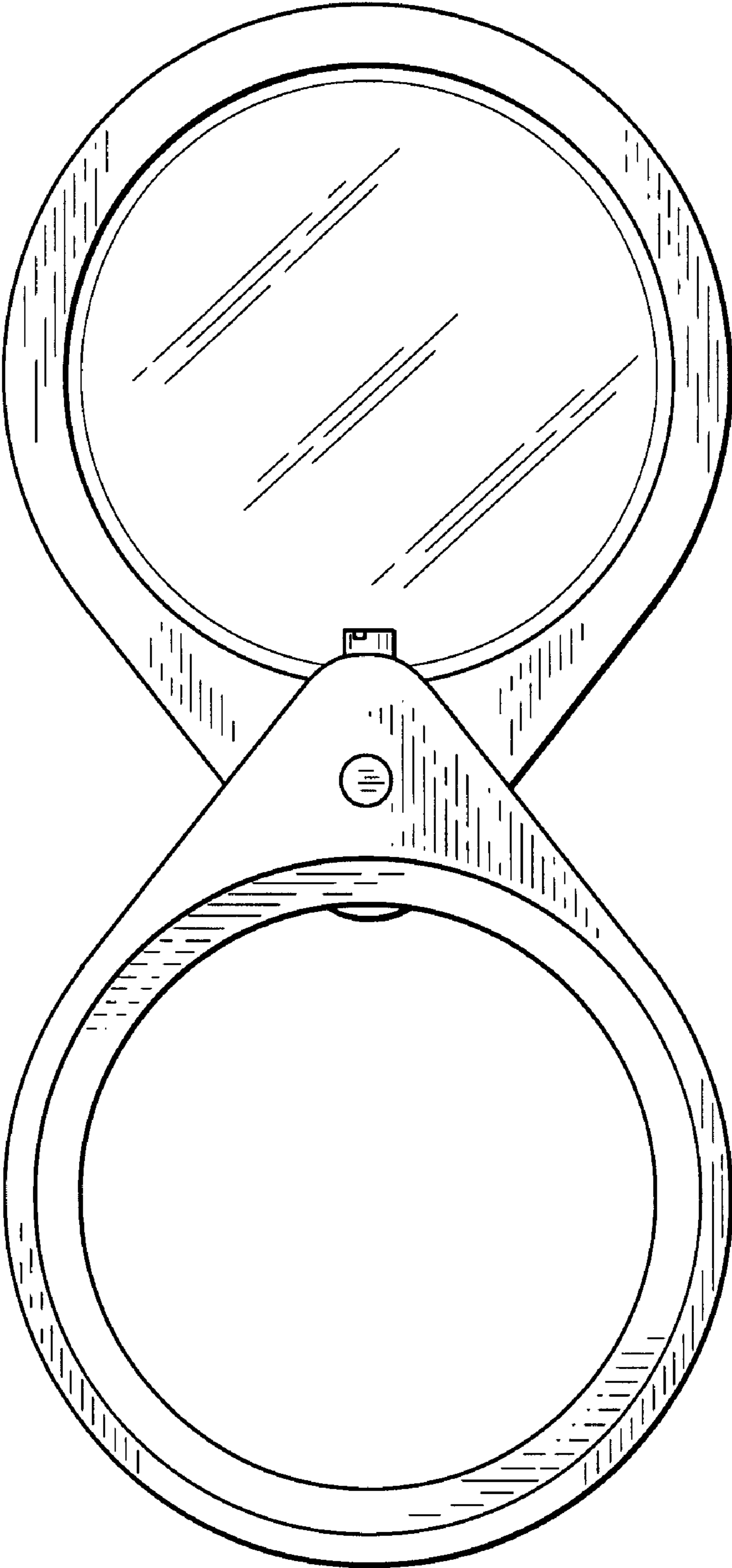

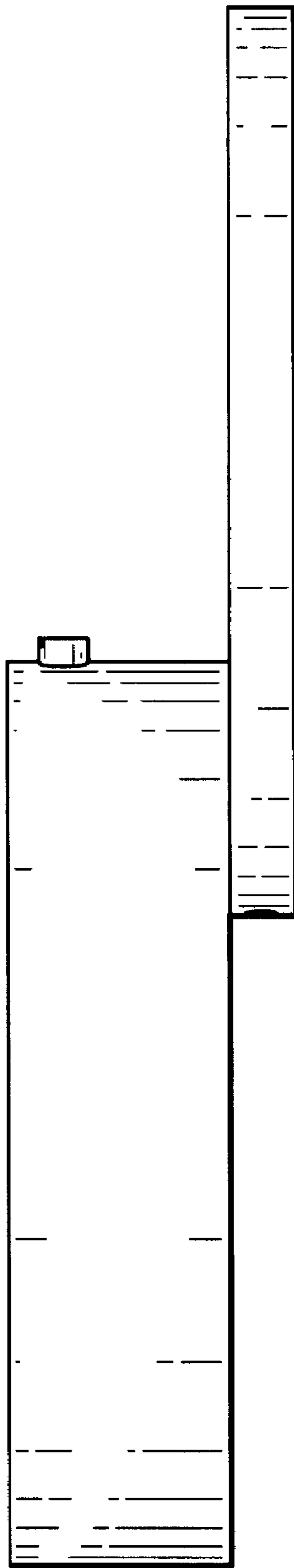

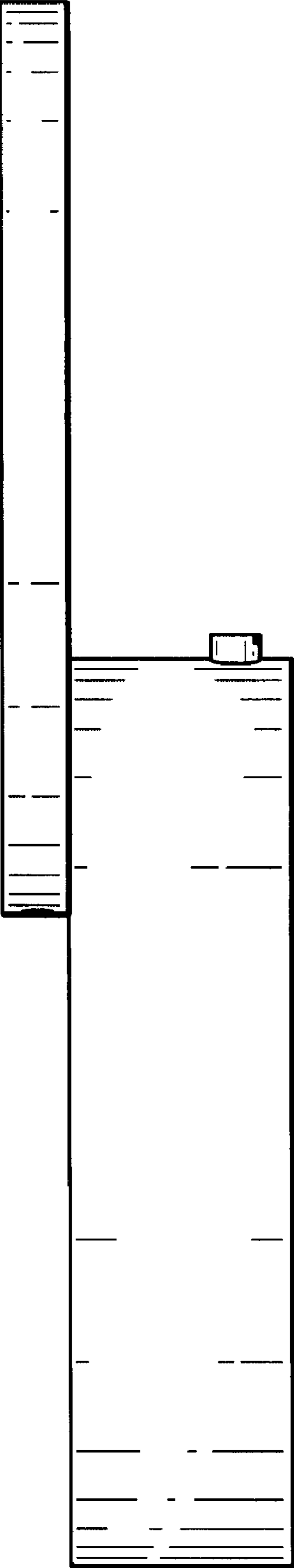

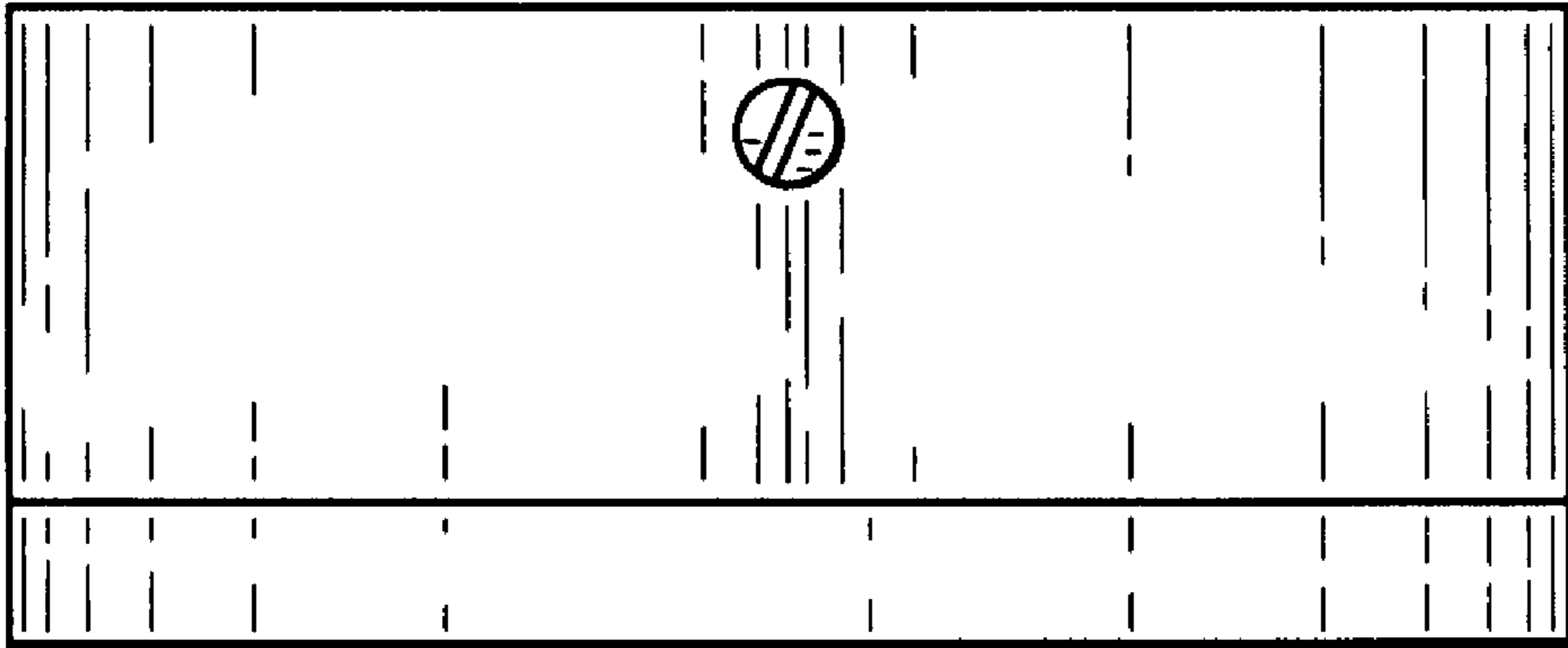

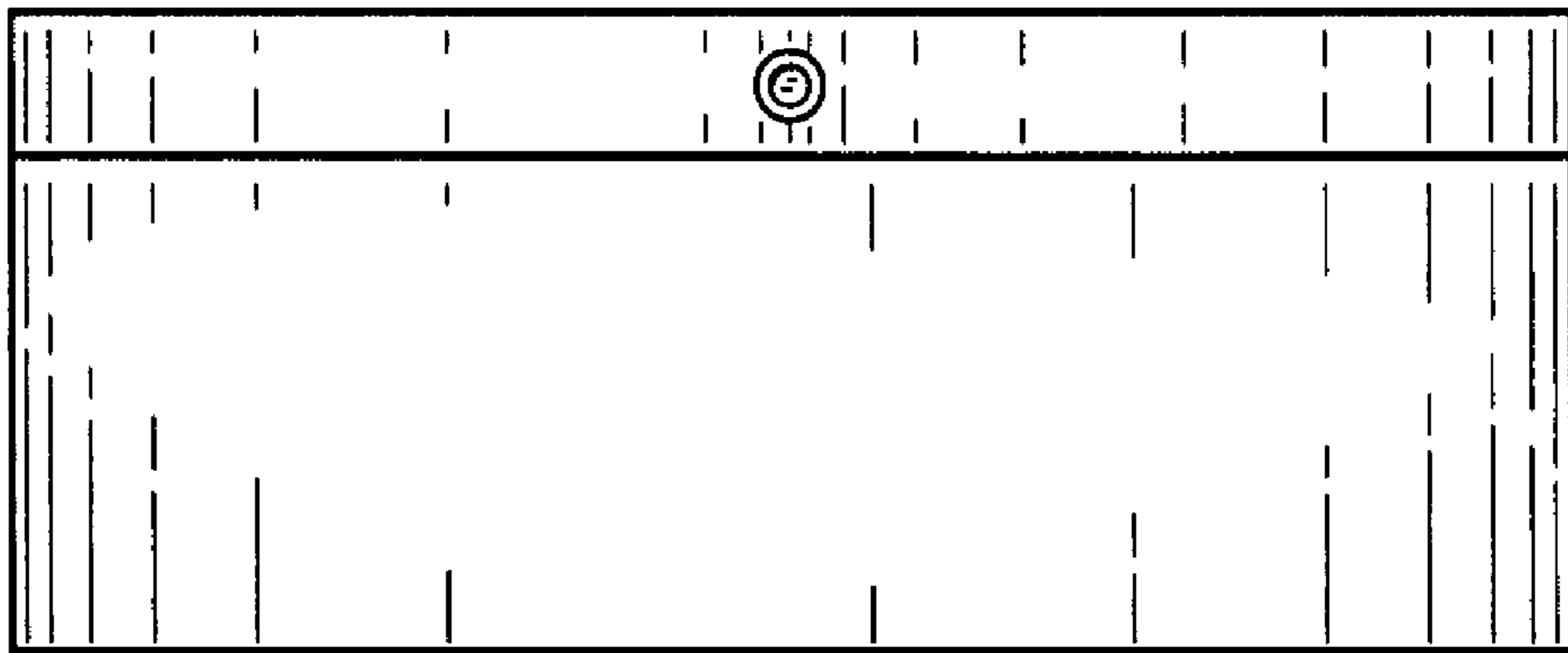
