FIG. 2 is a top plan view of the light fixture in accordance with my design;

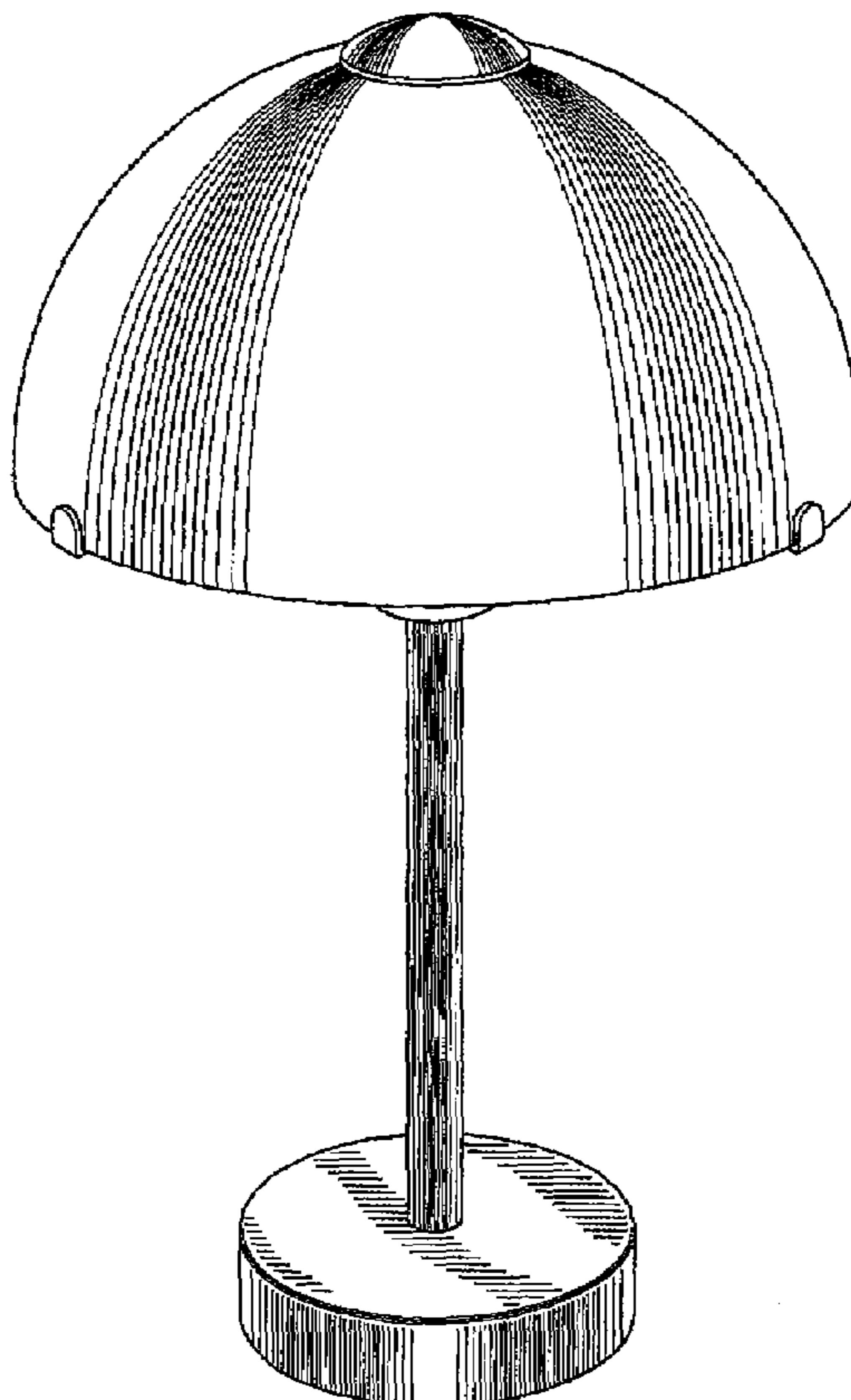
FIG. 3 is a bottom plan view of the light fixture in accordance with my design;

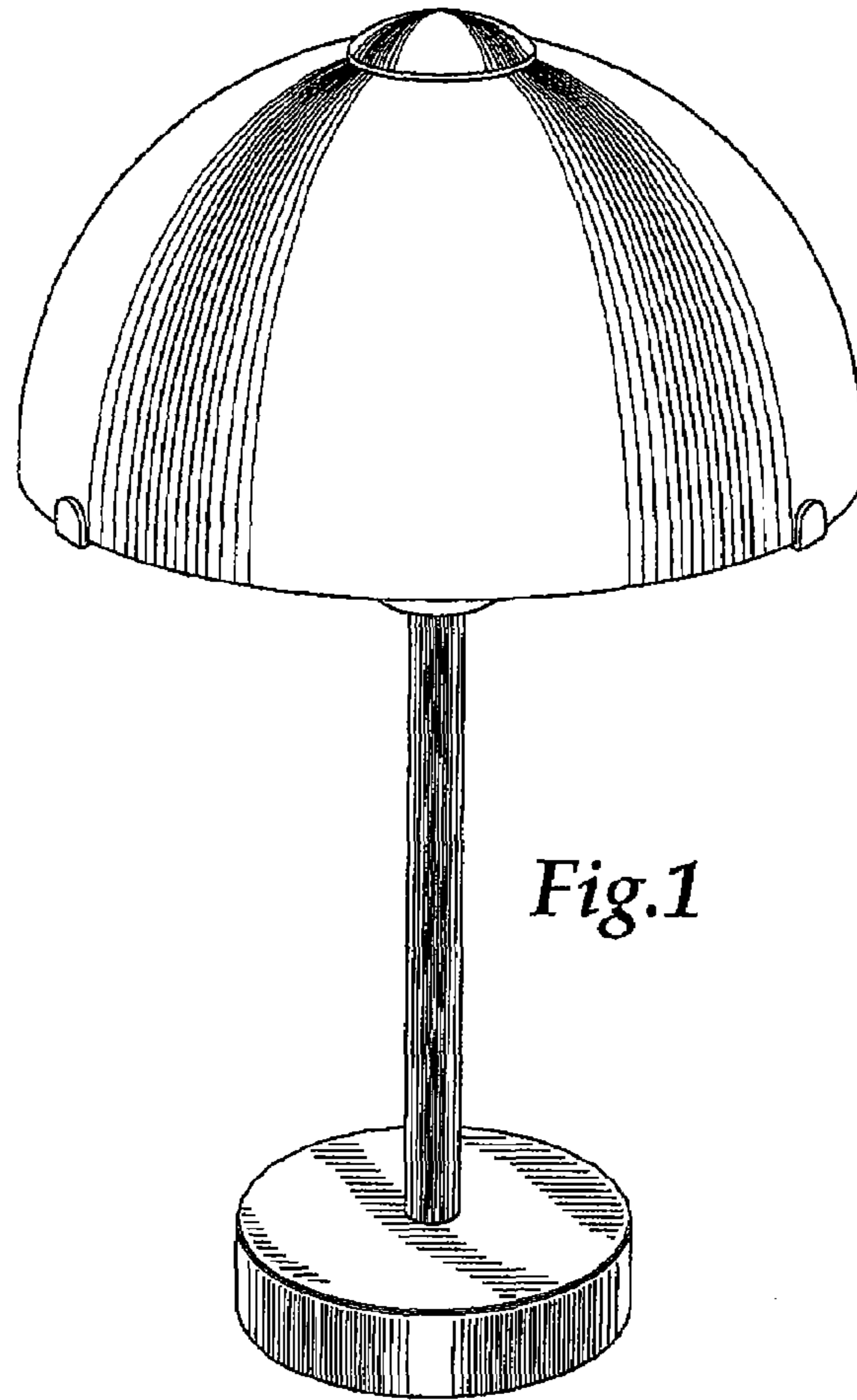
FIG. 4 is a front elevation view of the light fixture in accordance with my design;

FIG. 5 is a back elevation view of the light fixture in accordance with my design; and,

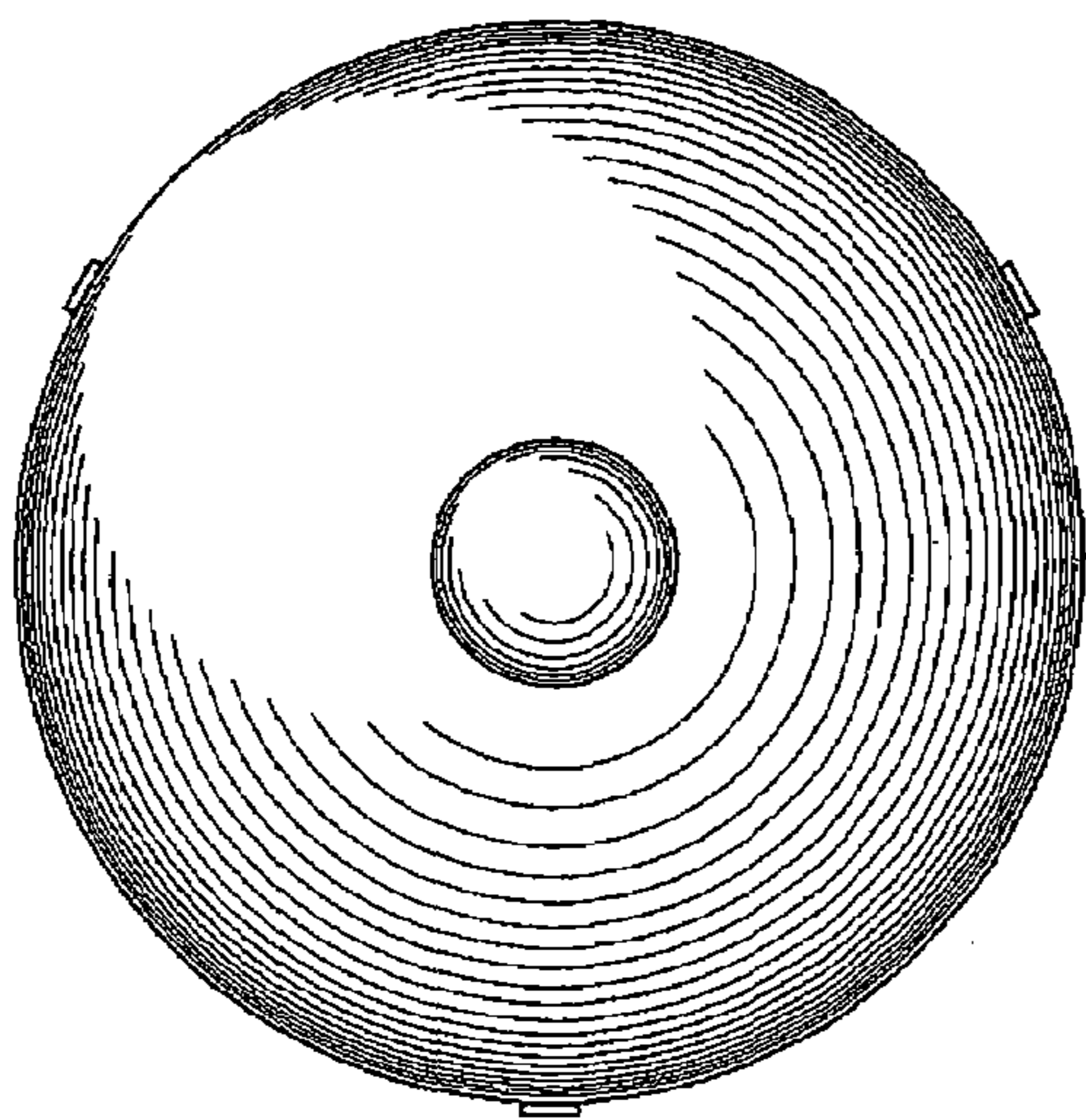
FIG. 6 is a side elevation view of the light fixture in accordance with my design, the opposite side being a mirror image of that shown.

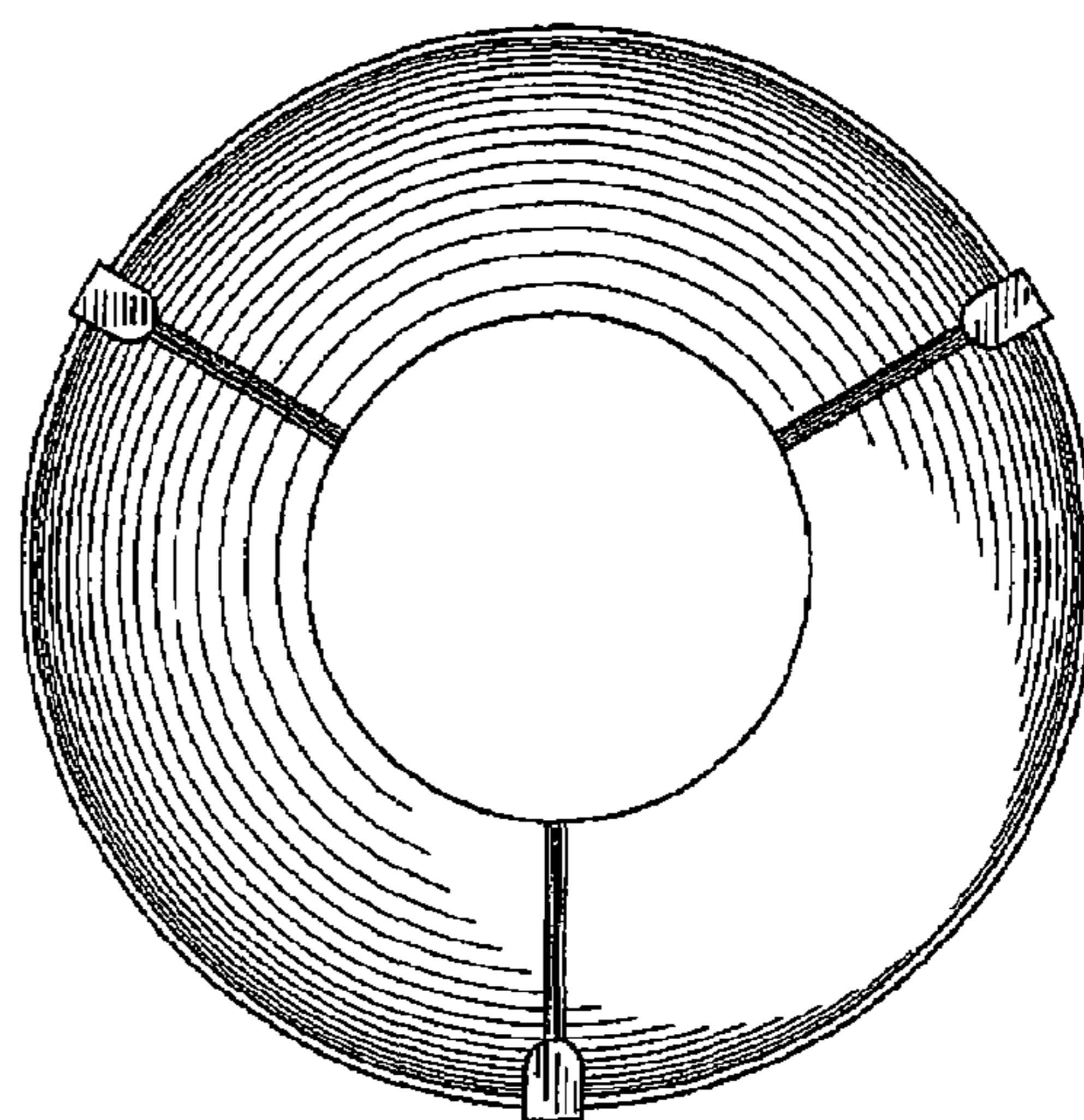




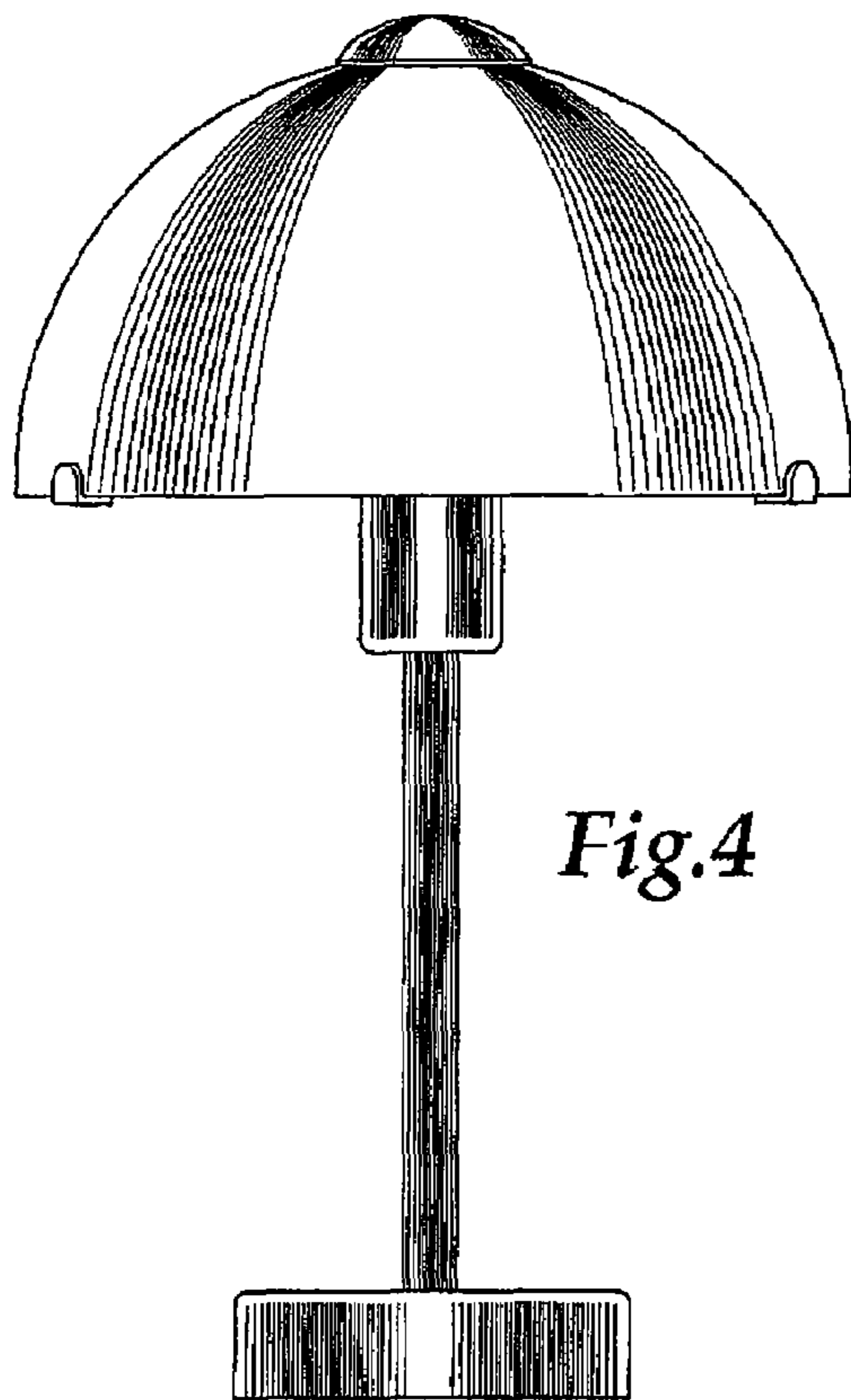

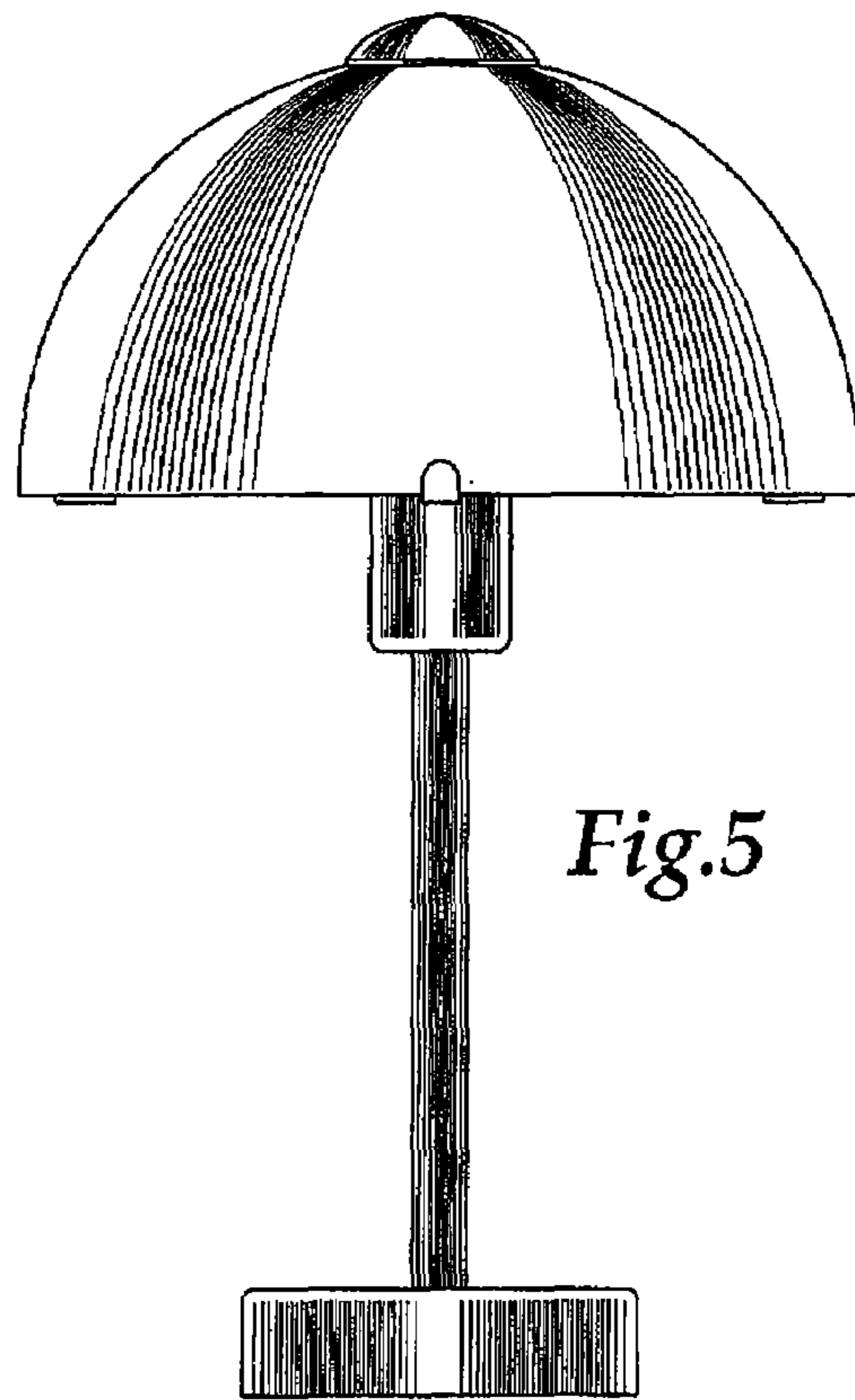

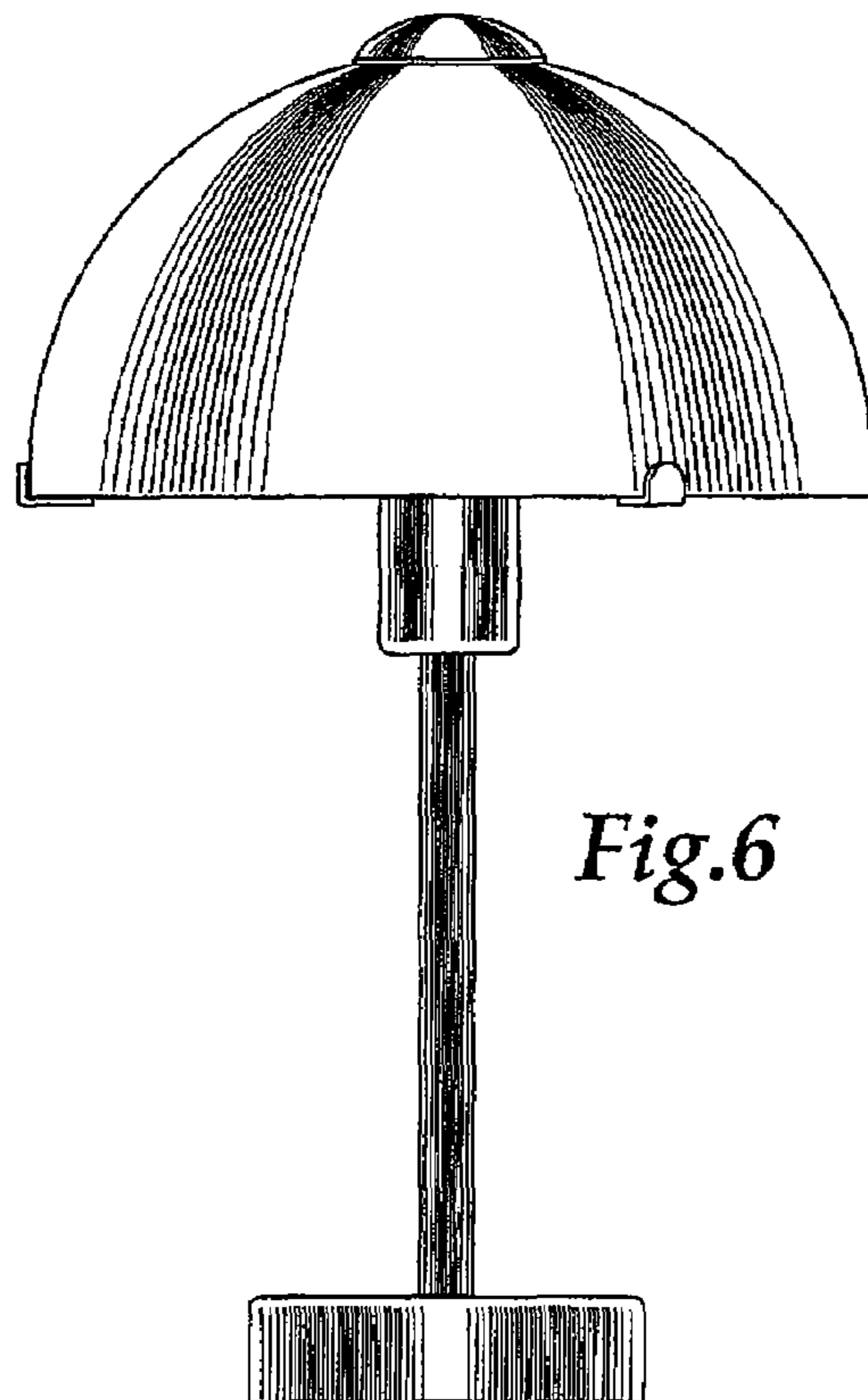
