DESCRIPTION

FIG. 6 is top view thereof;

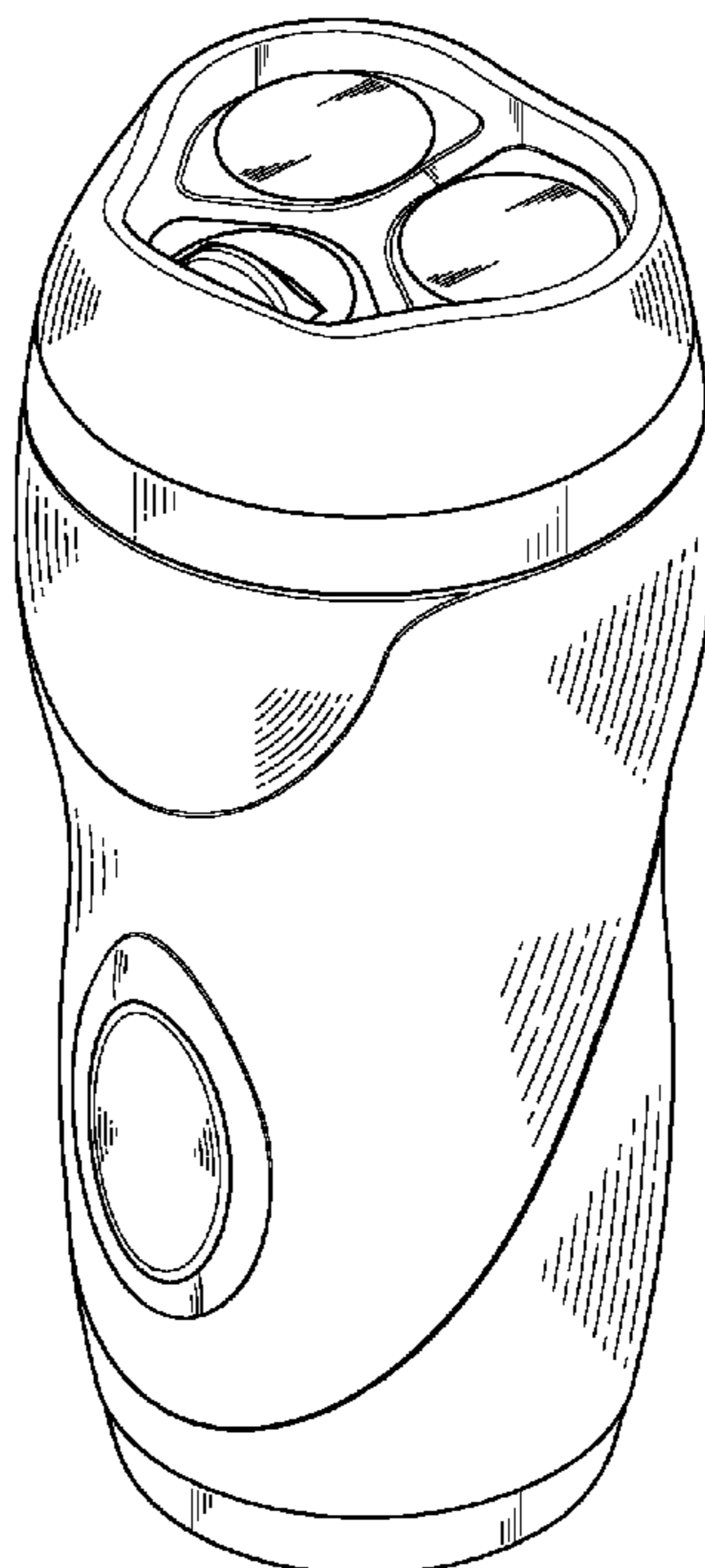
FIG. 7 is a bottom view thereof;

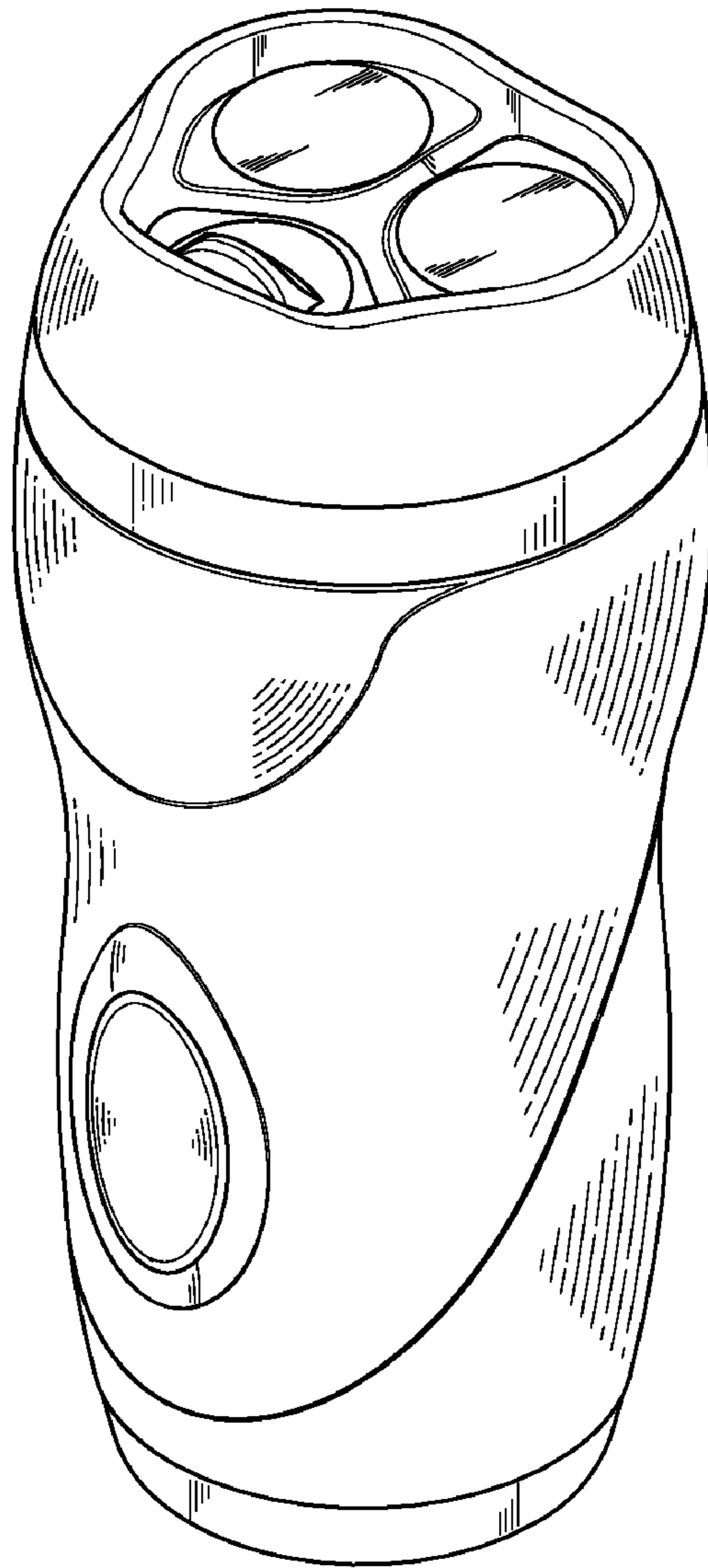

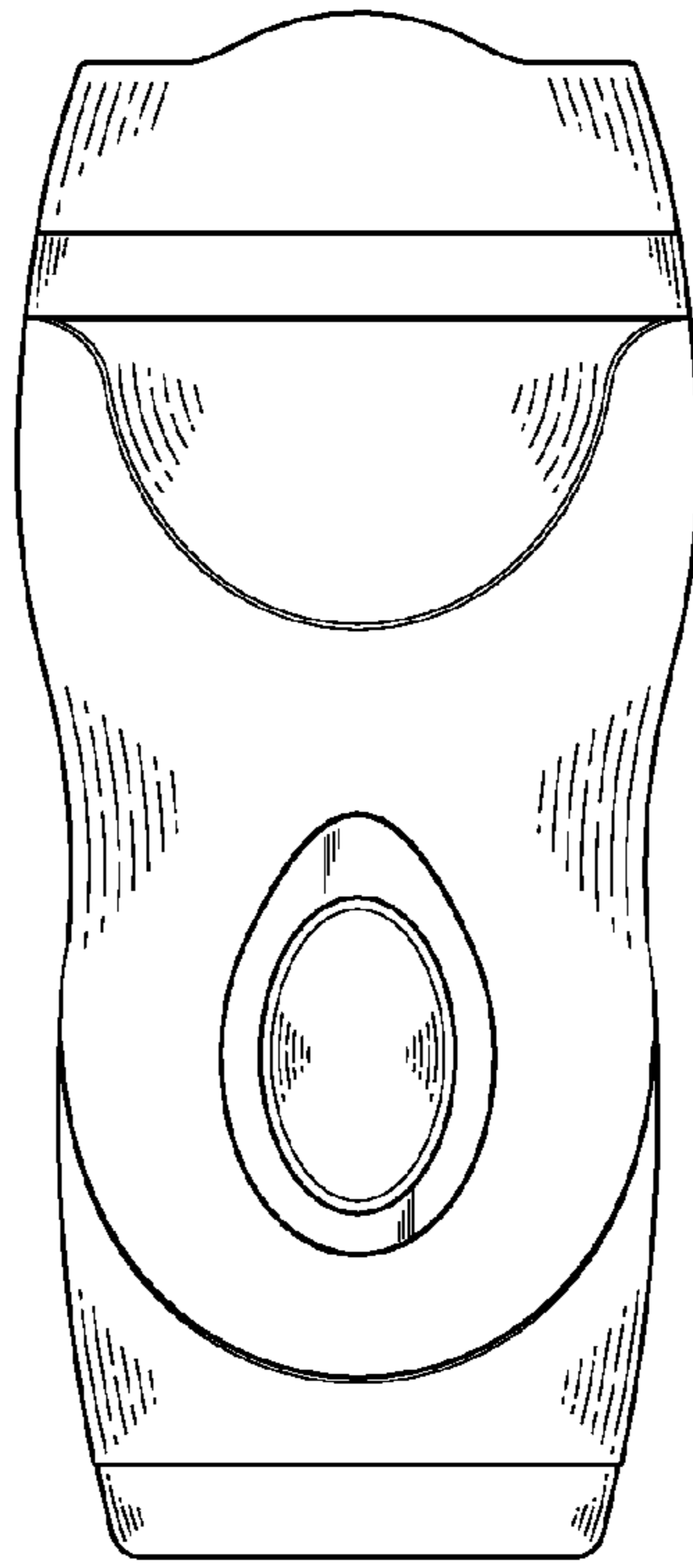

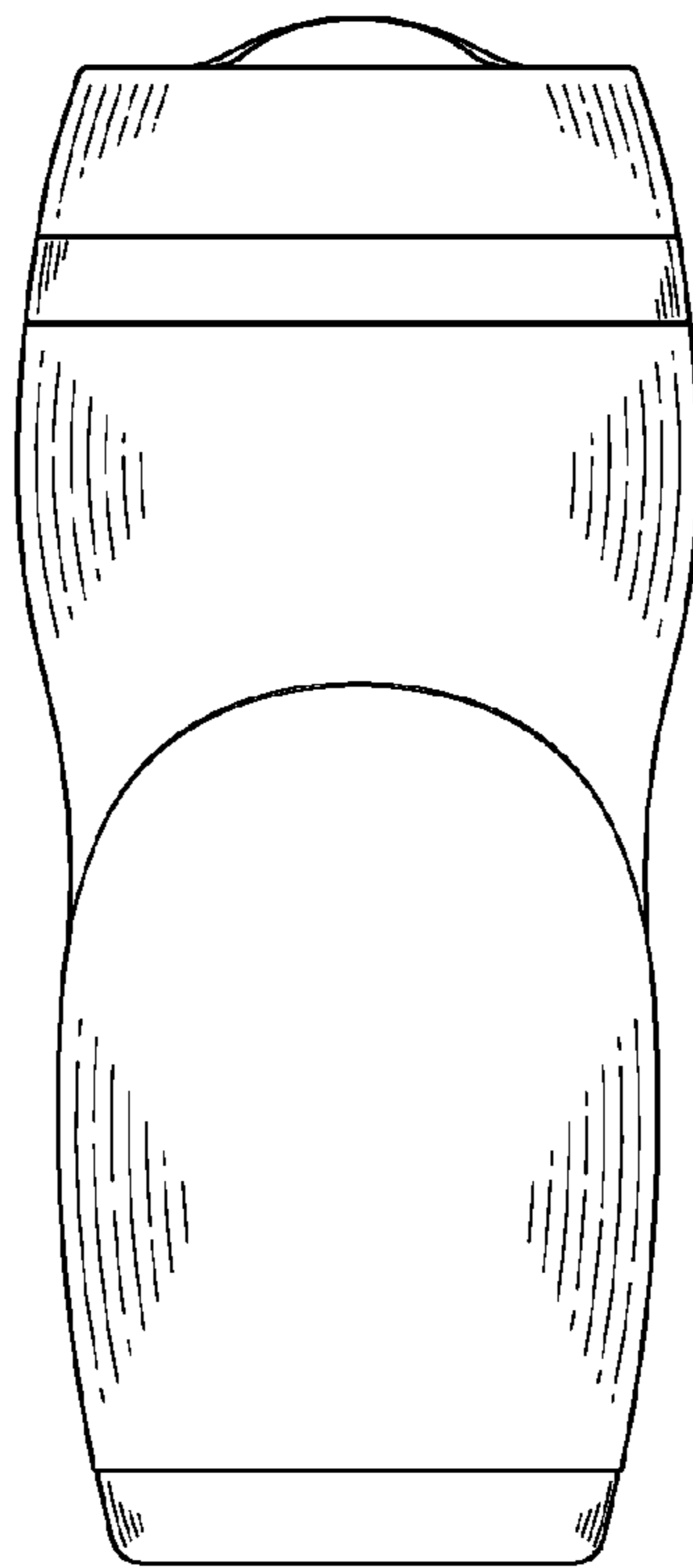

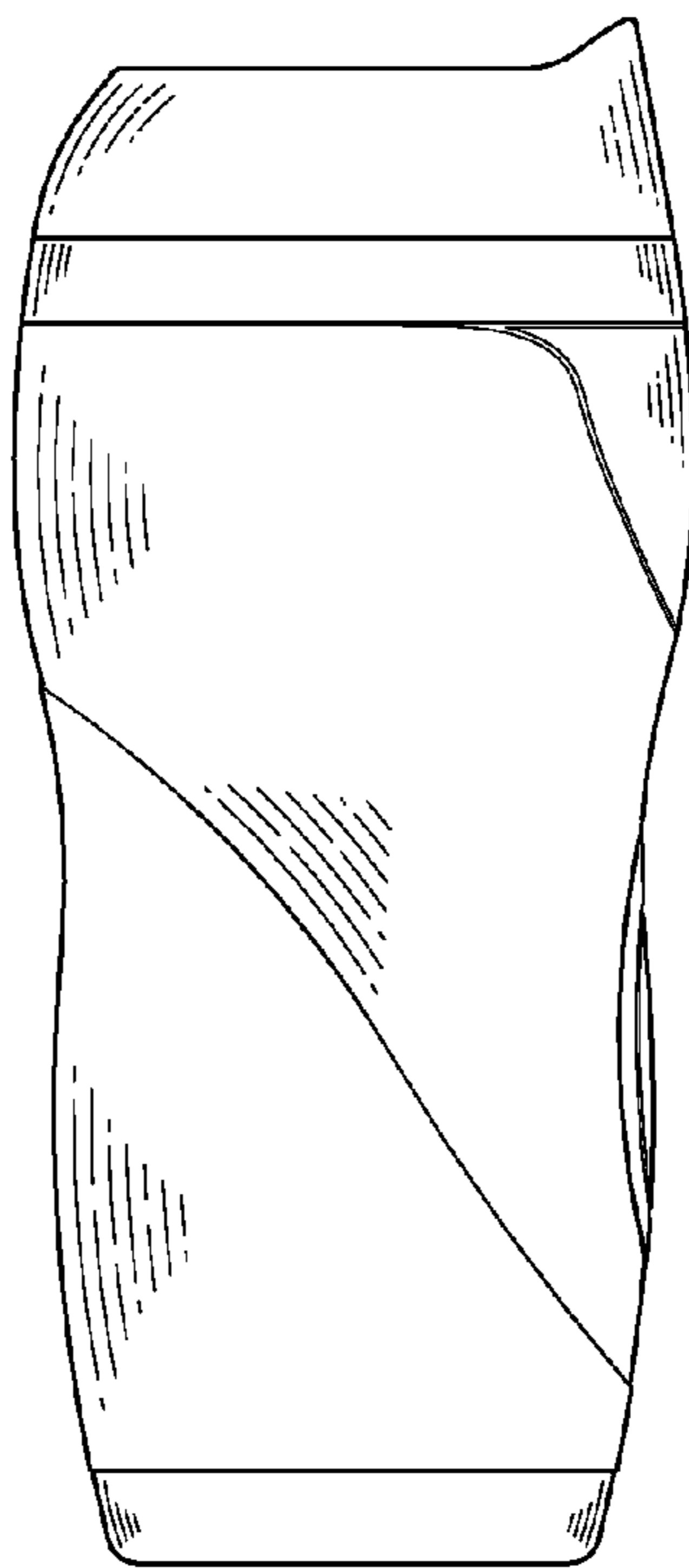

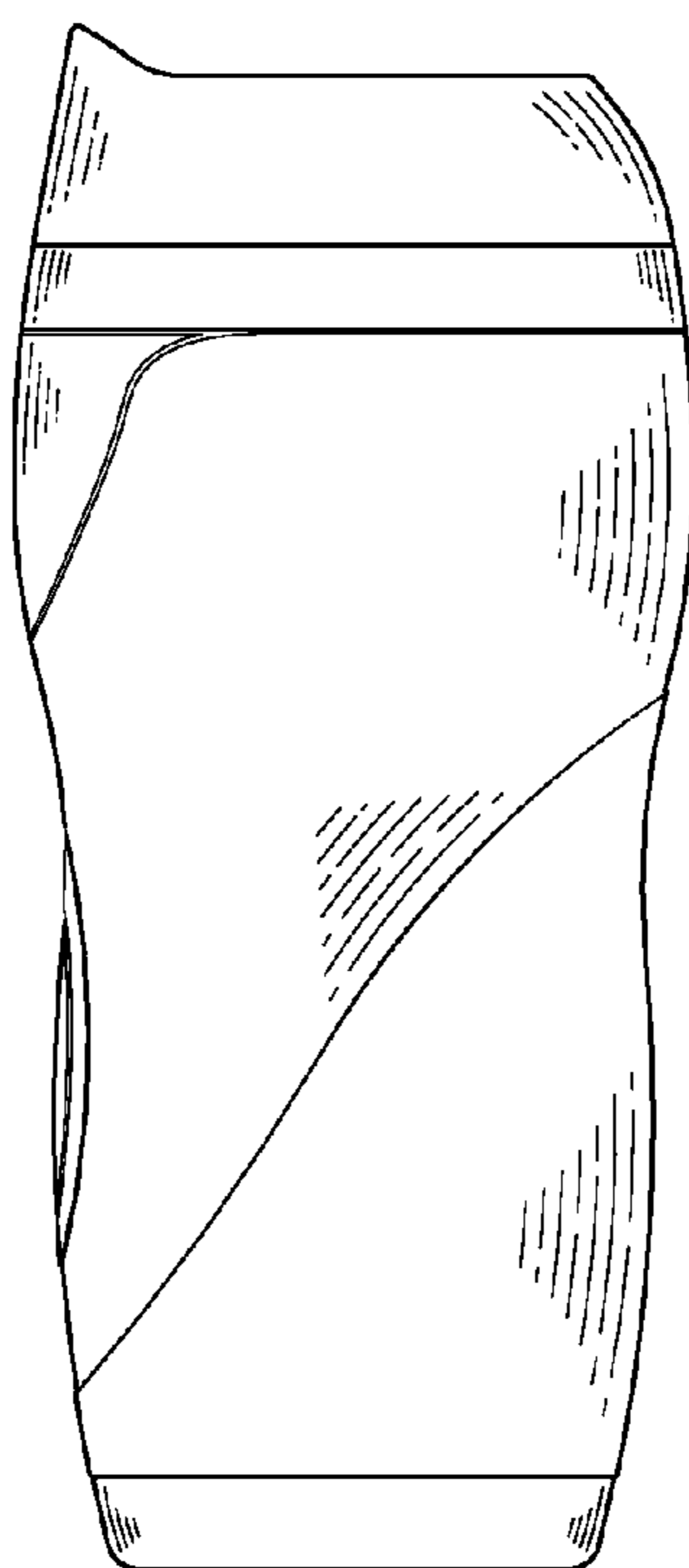

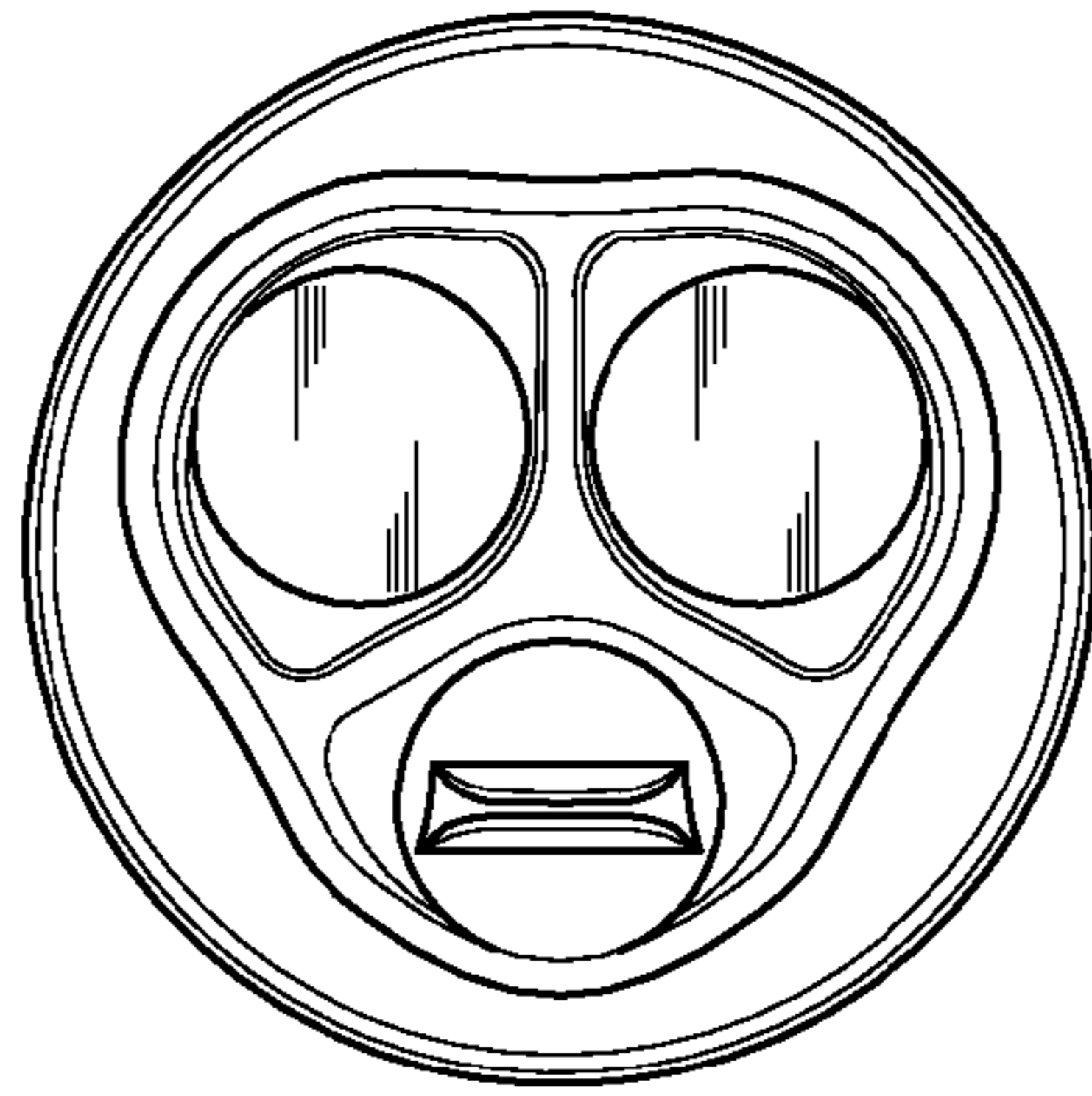

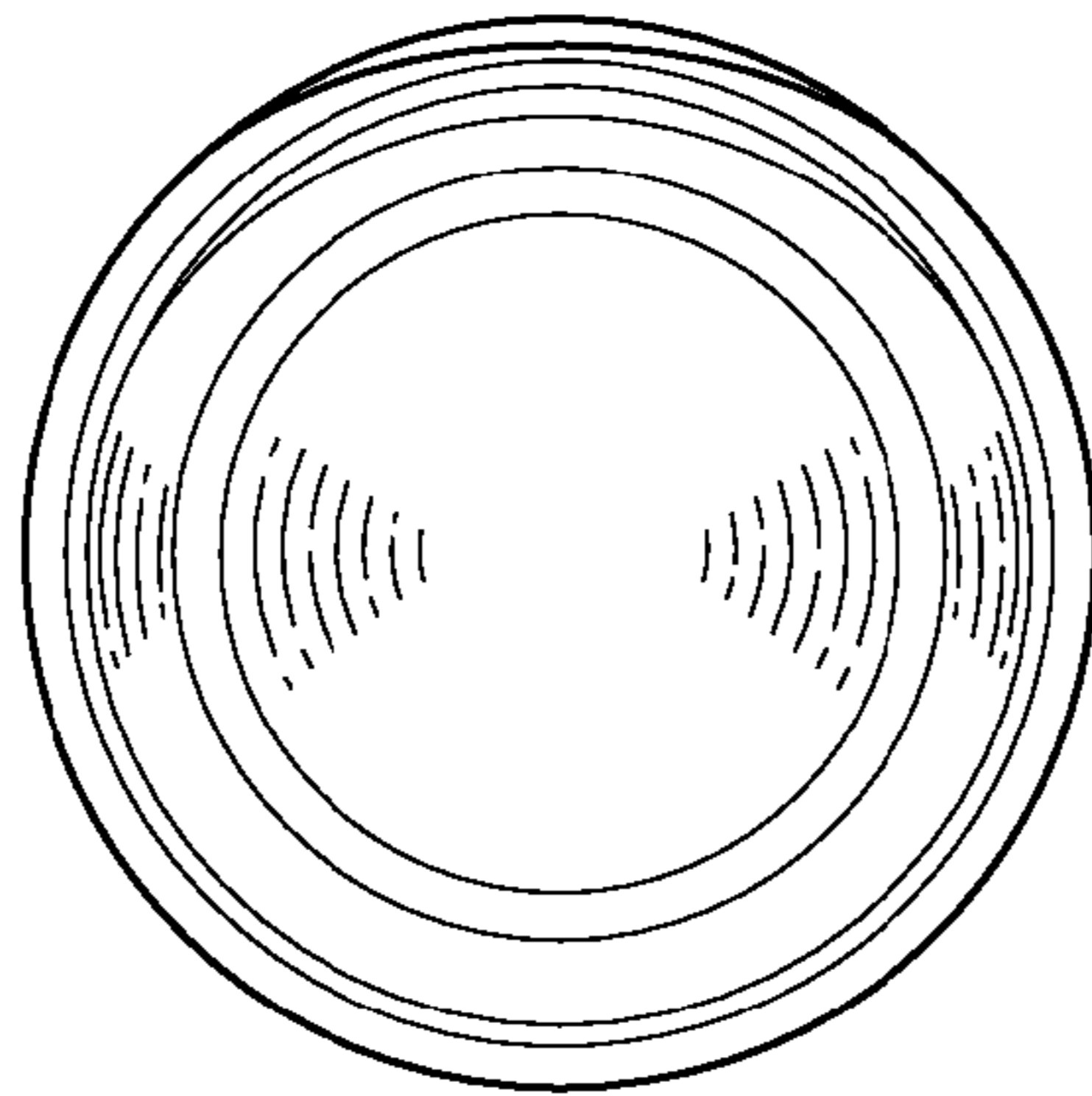

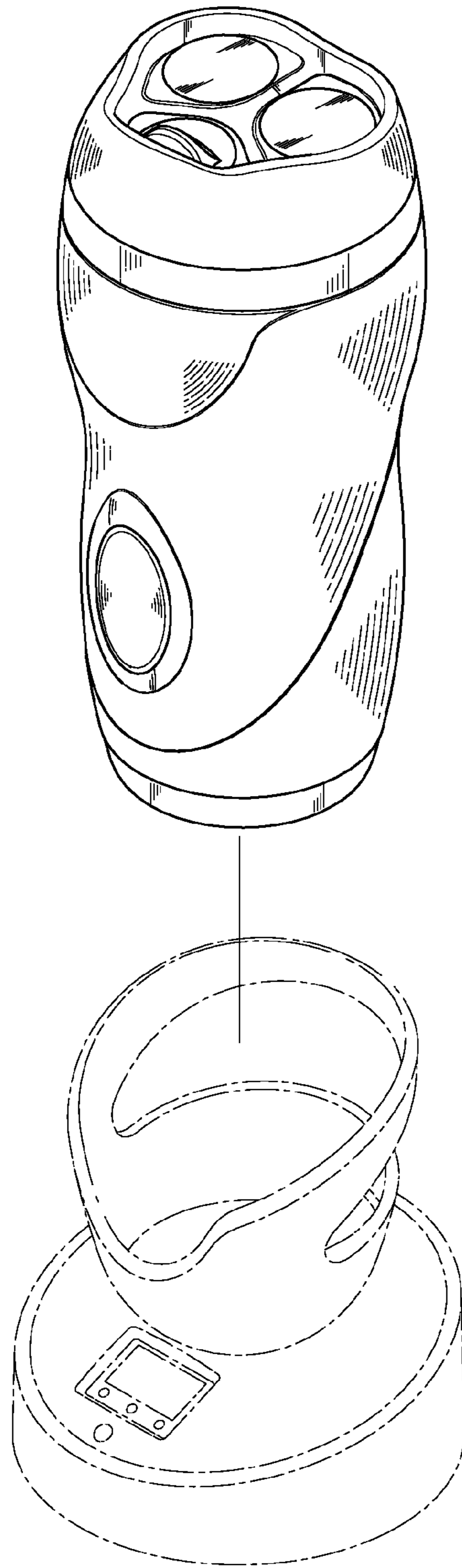

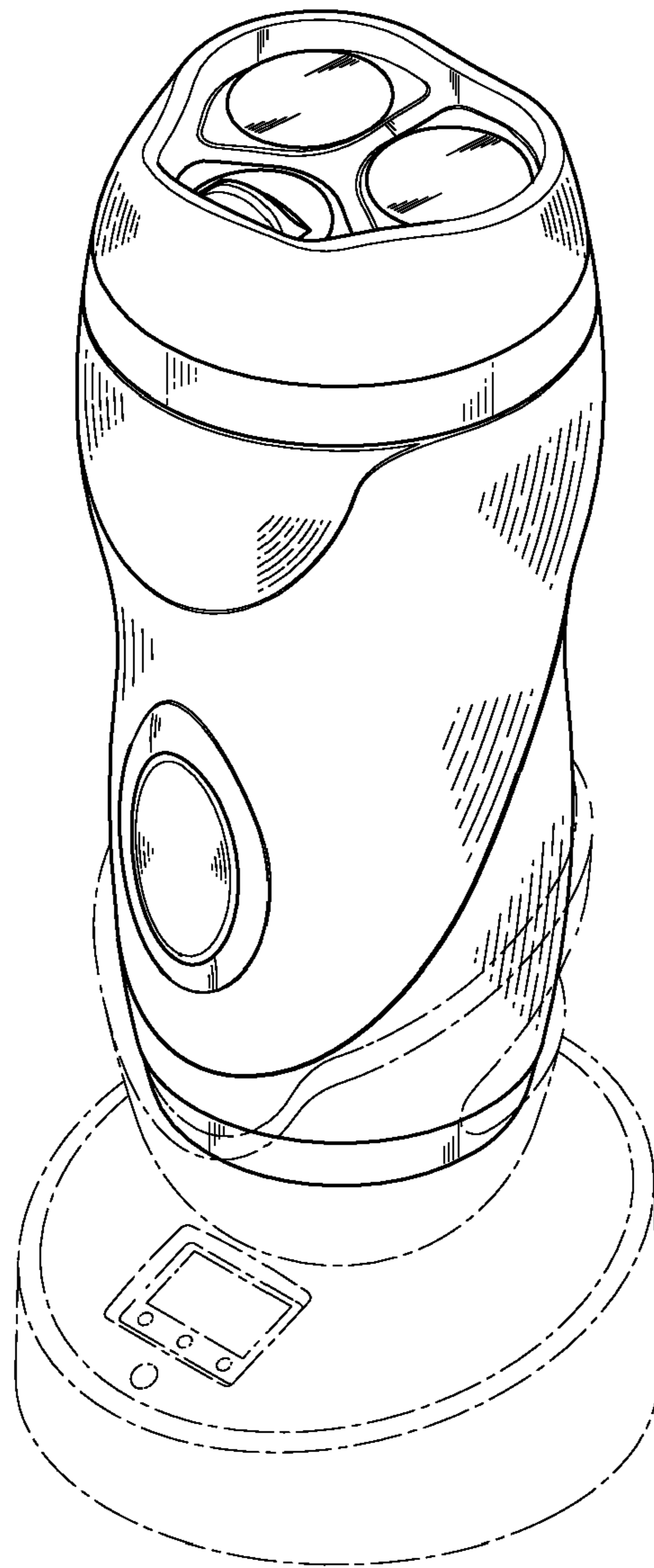
