FIG. 12 is a right side elevation view thereof.

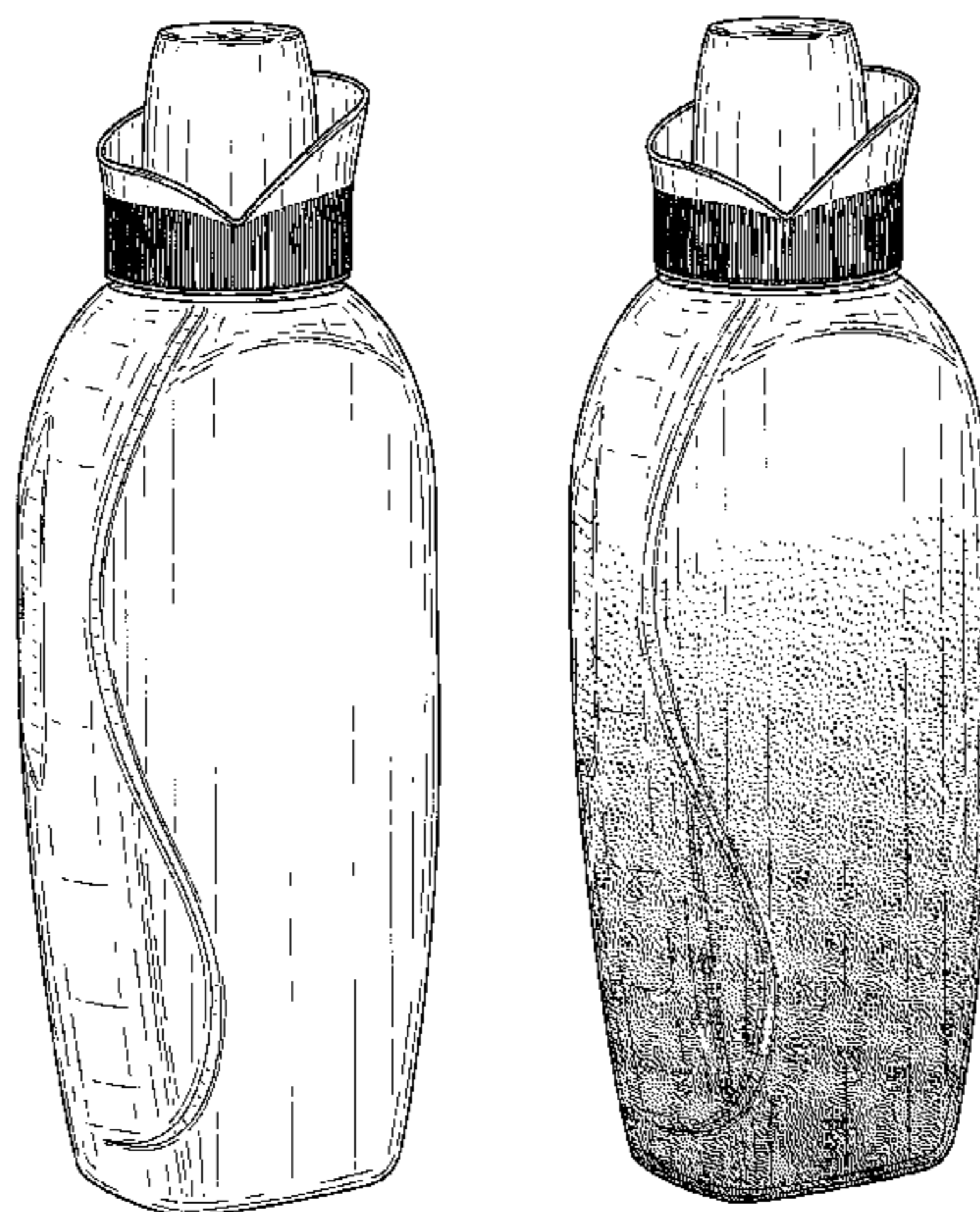
FIG. 13 is a top plan view thereof; and,

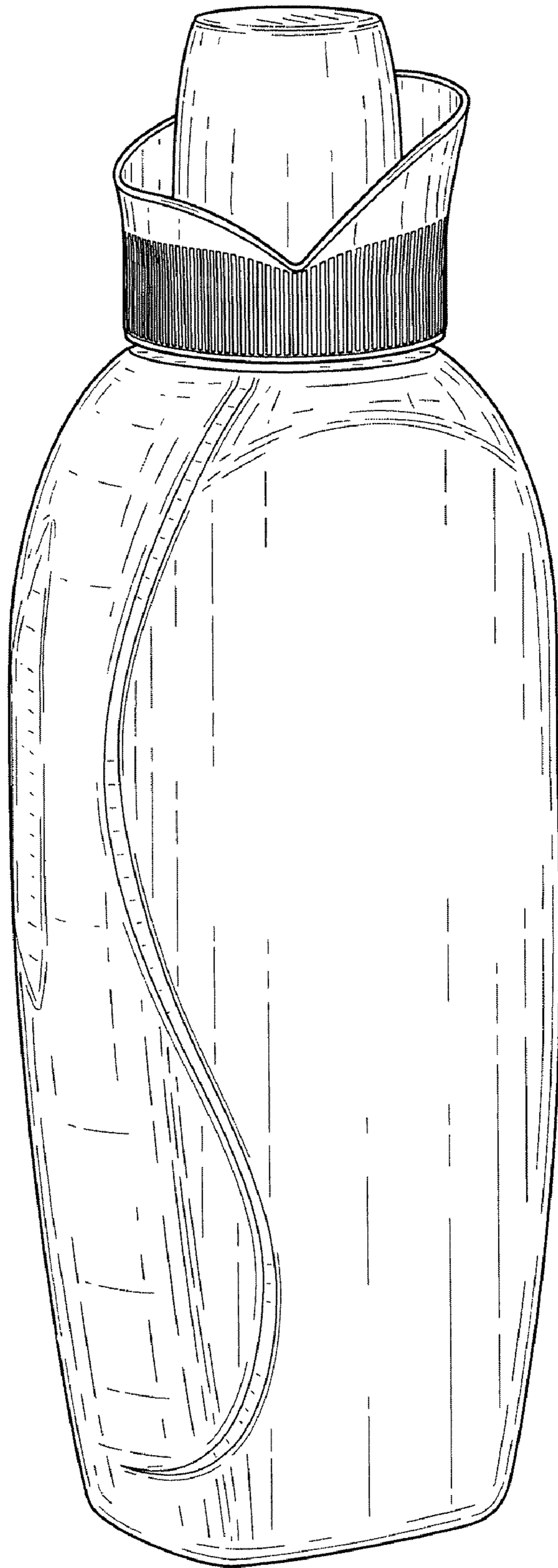

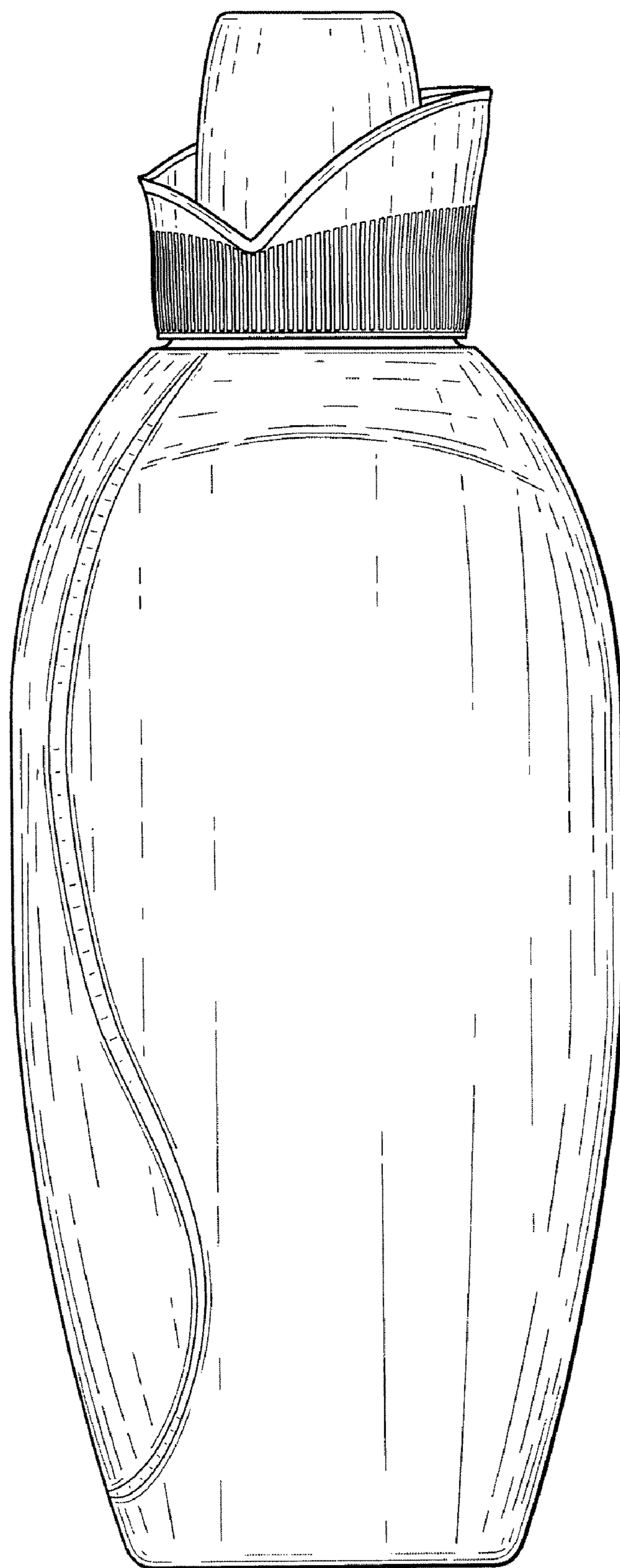

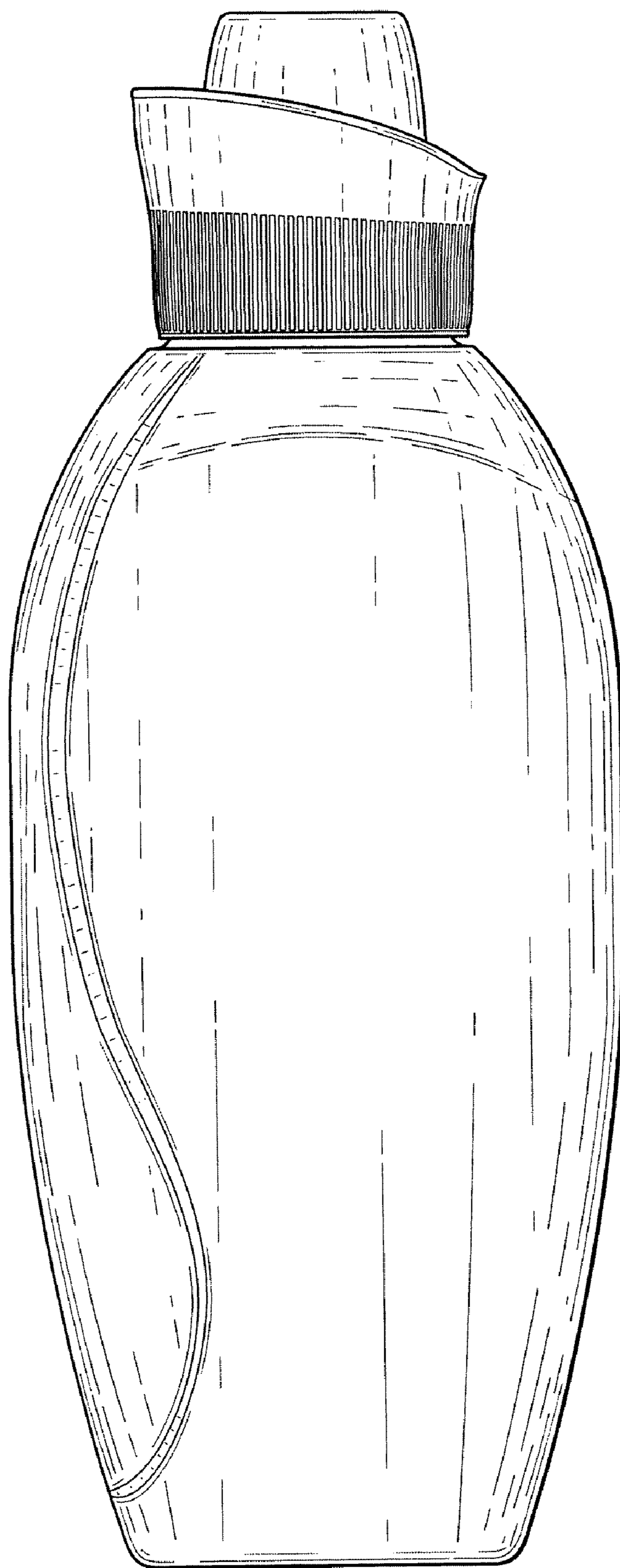

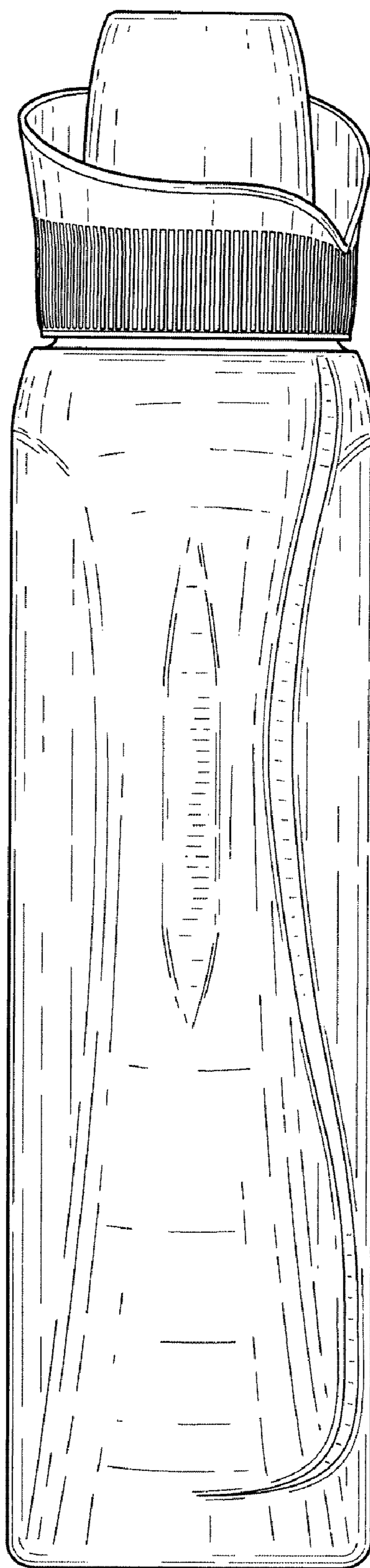

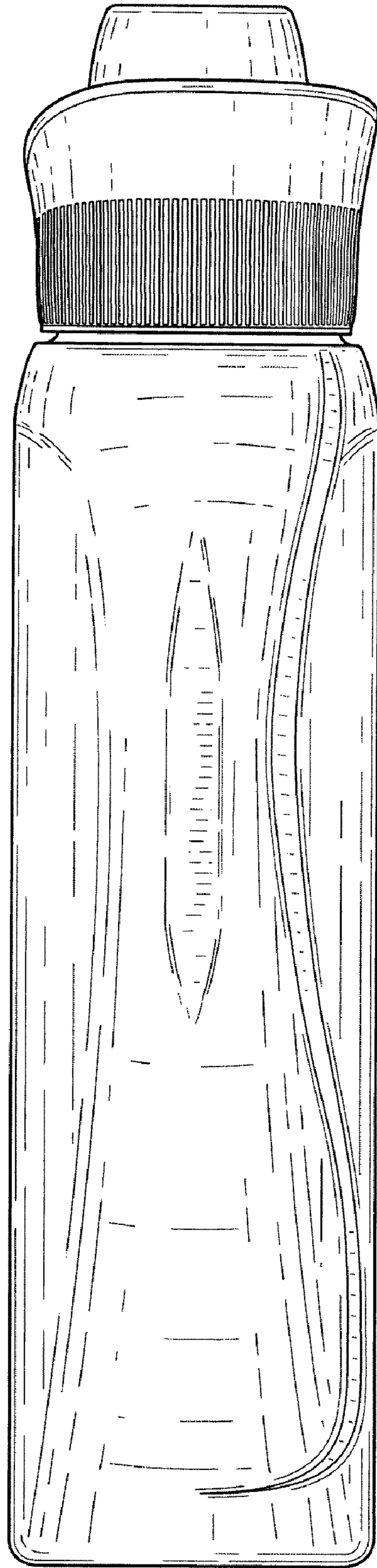

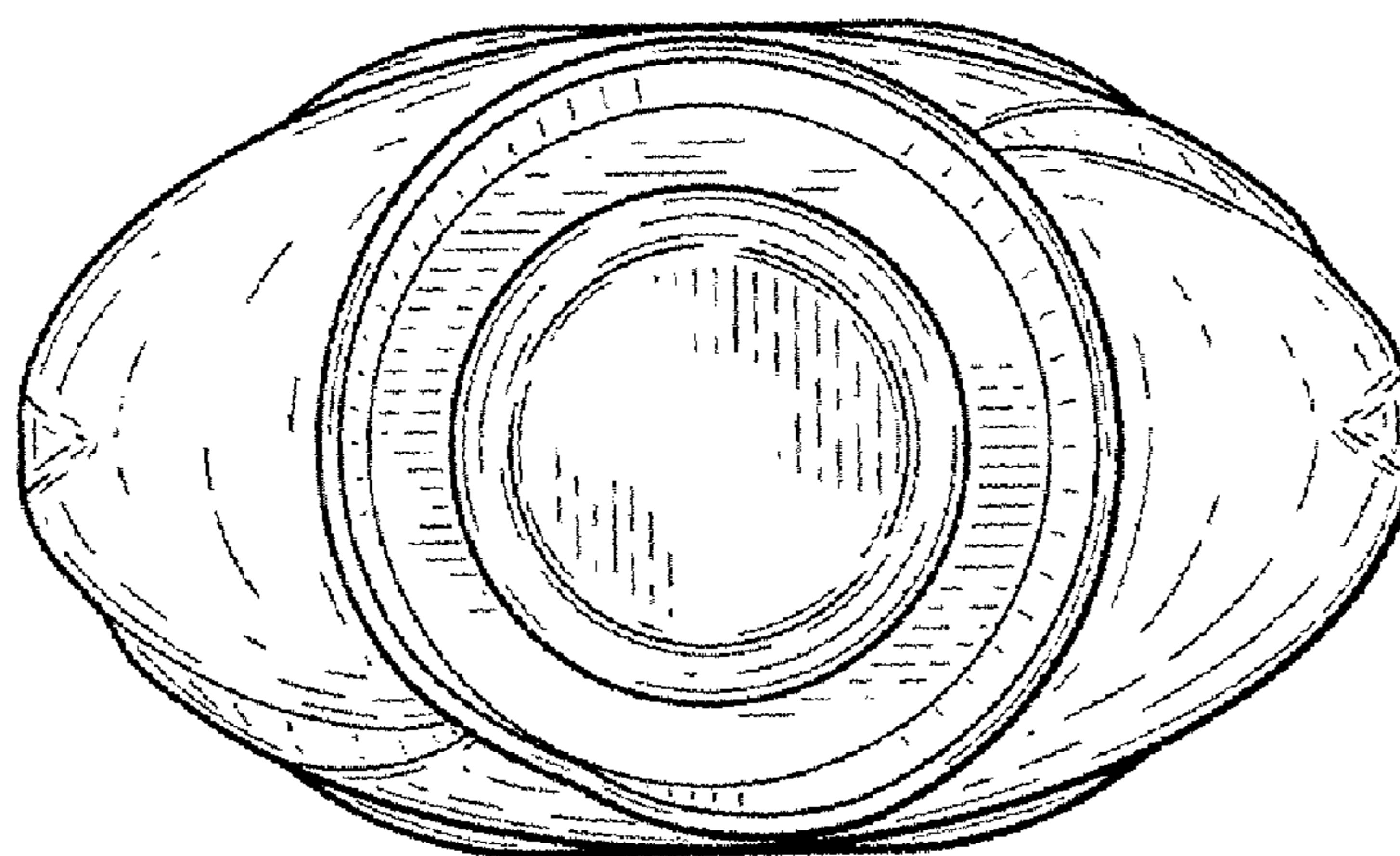

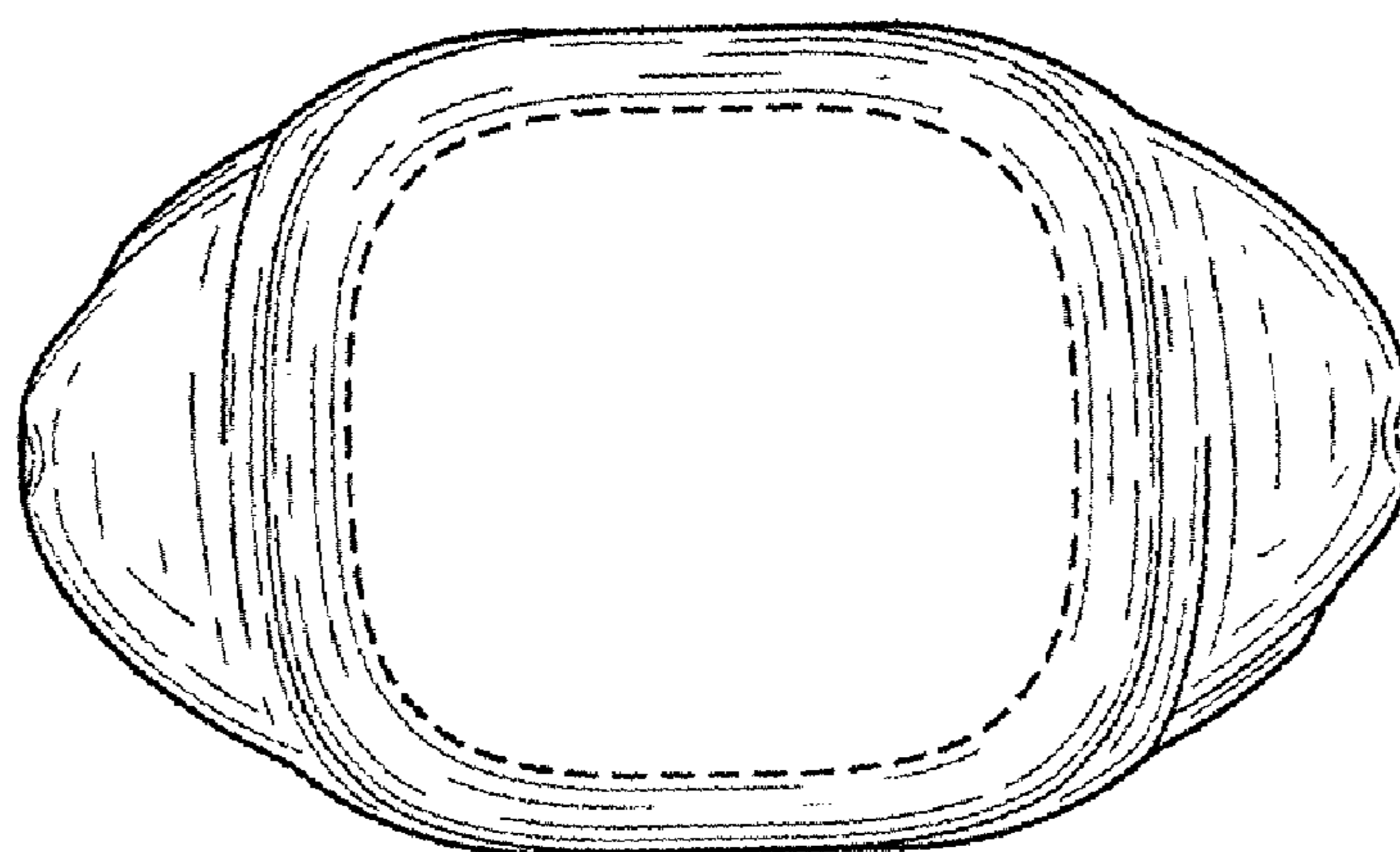

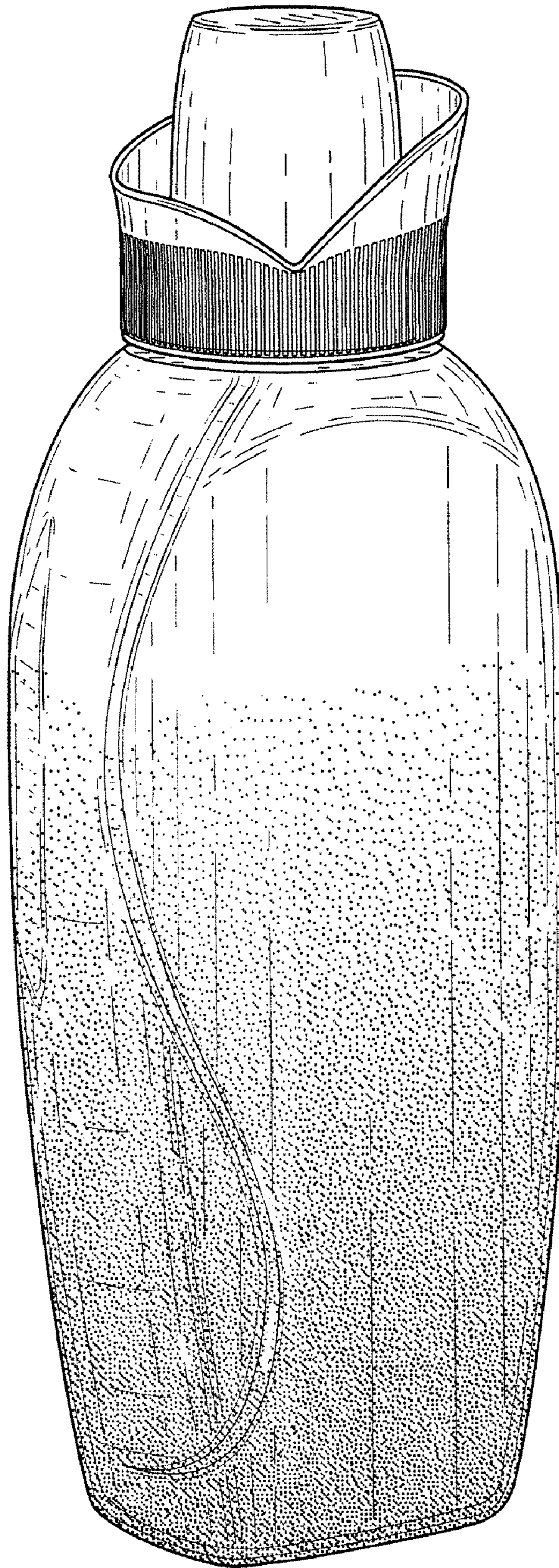

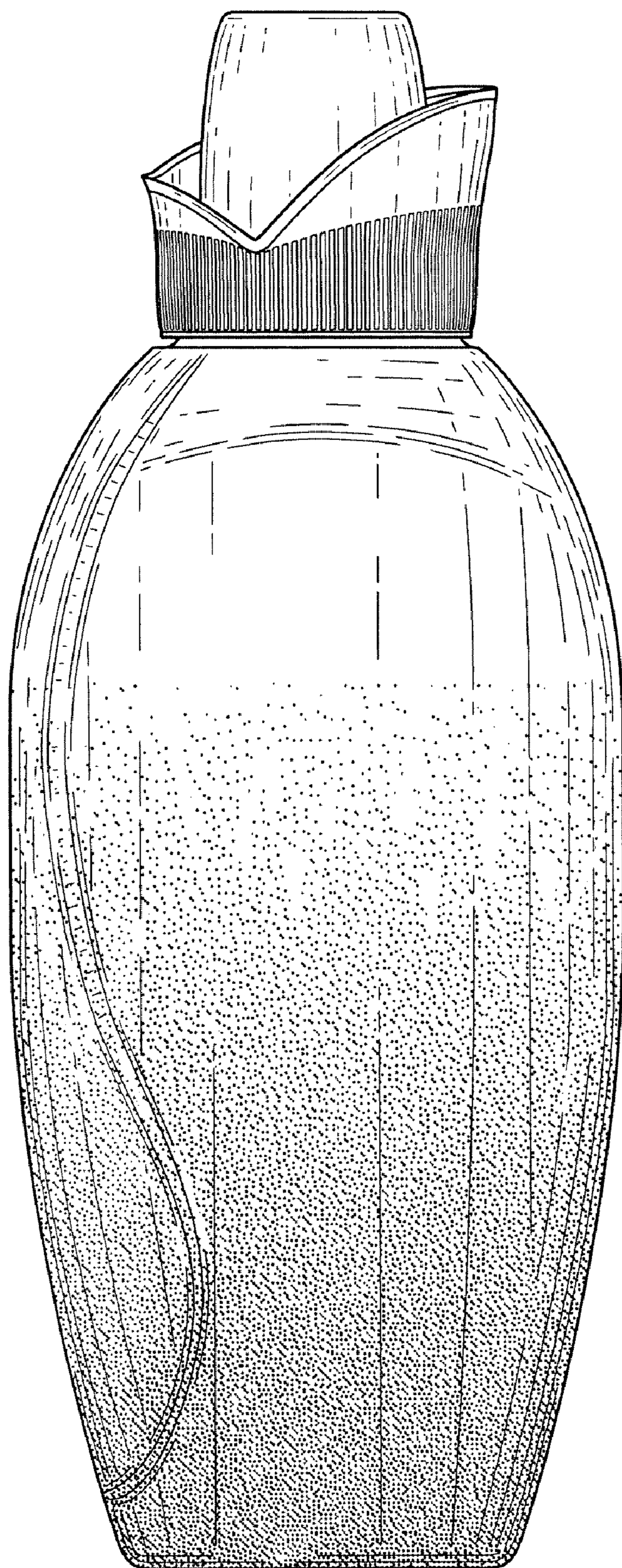

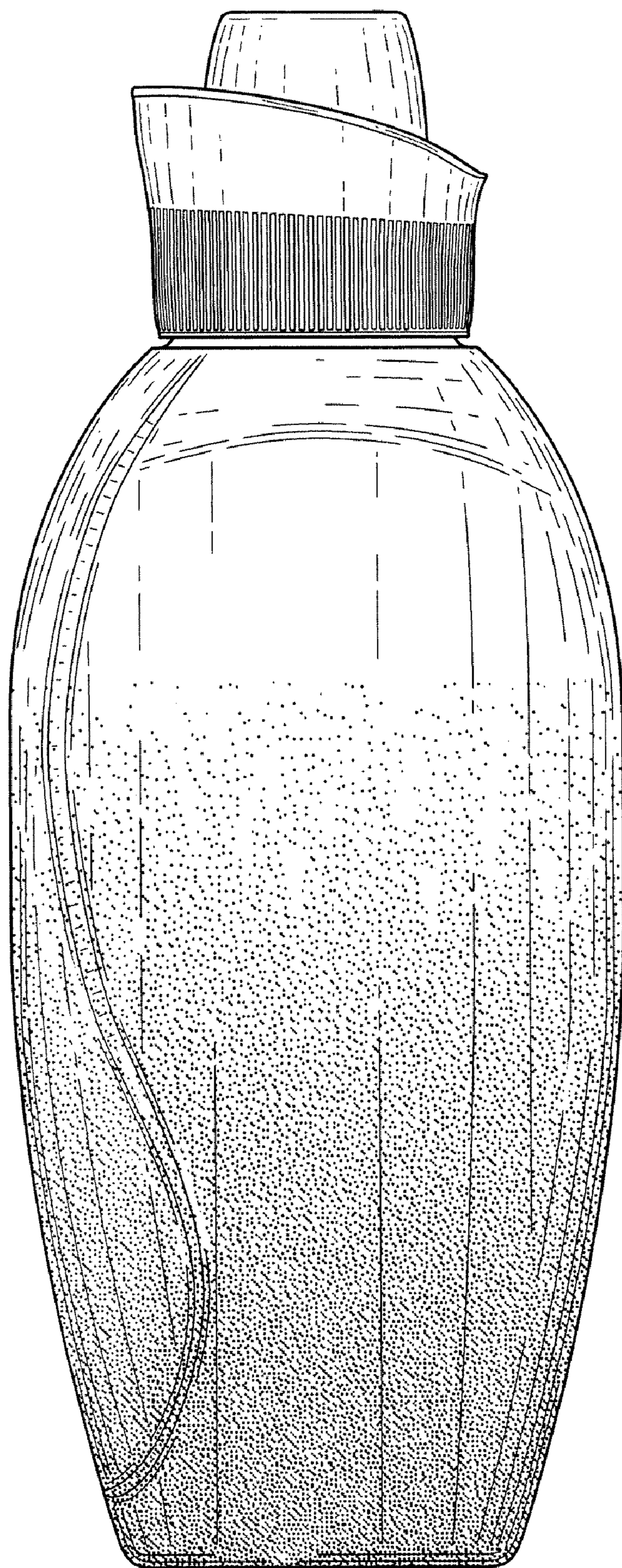

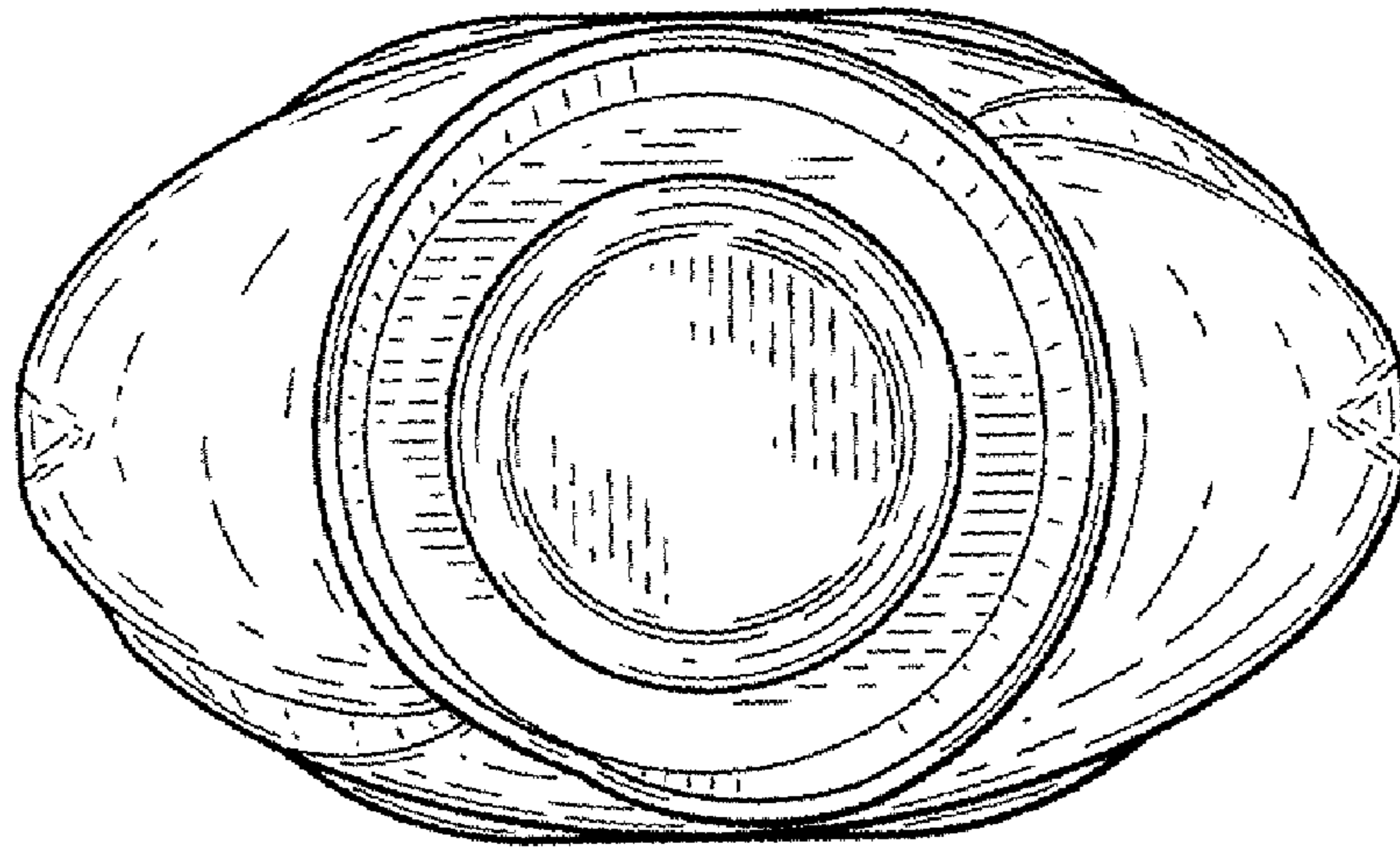

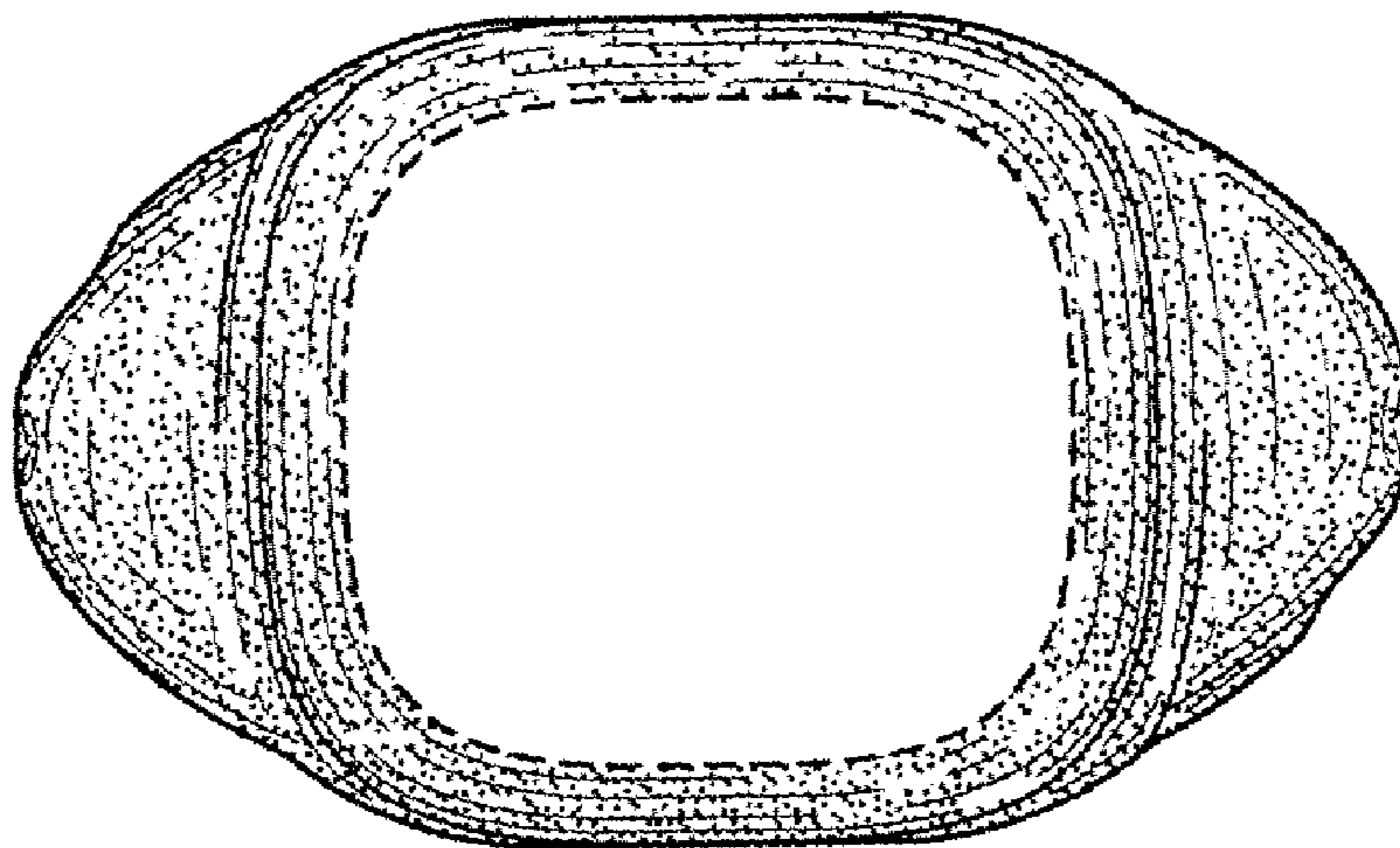
