(57) **CLAIM**

The ornamental design for a perfume bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a perfume bottle showing my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a side elevational view thereof from the left of FIG. 1;

FIG. 4 is a side elevational view thereof from the right of FIG. 1;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIGS. 7-12 are views similar to FIGS. 1-6, respectively, but showing a modified embodiment thereof.

The broken lines shown in FIGS. 5 and 11 are included for the purpose of illustrating a portion of the perfume bottle that forms no part of the claimed design.

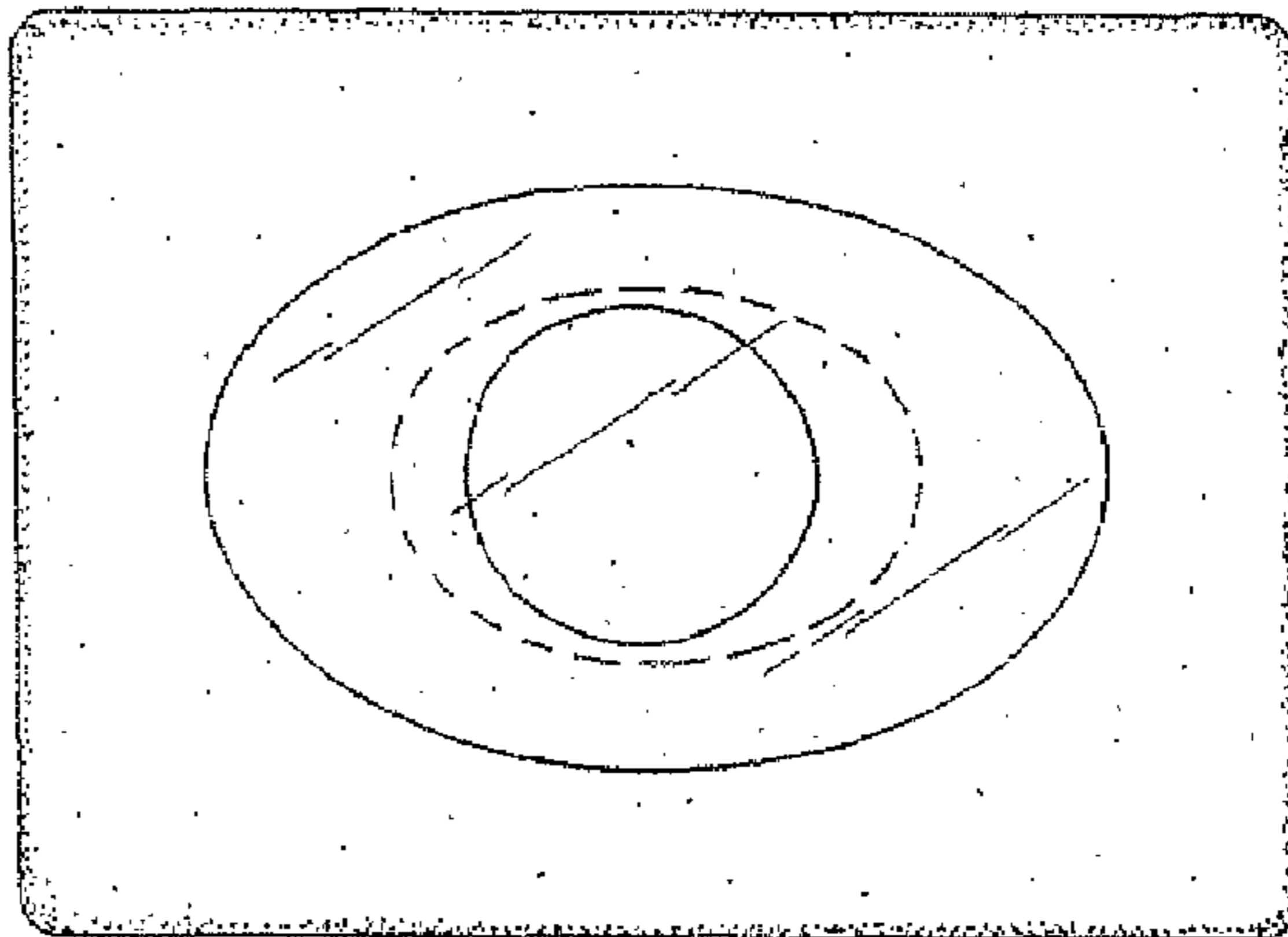
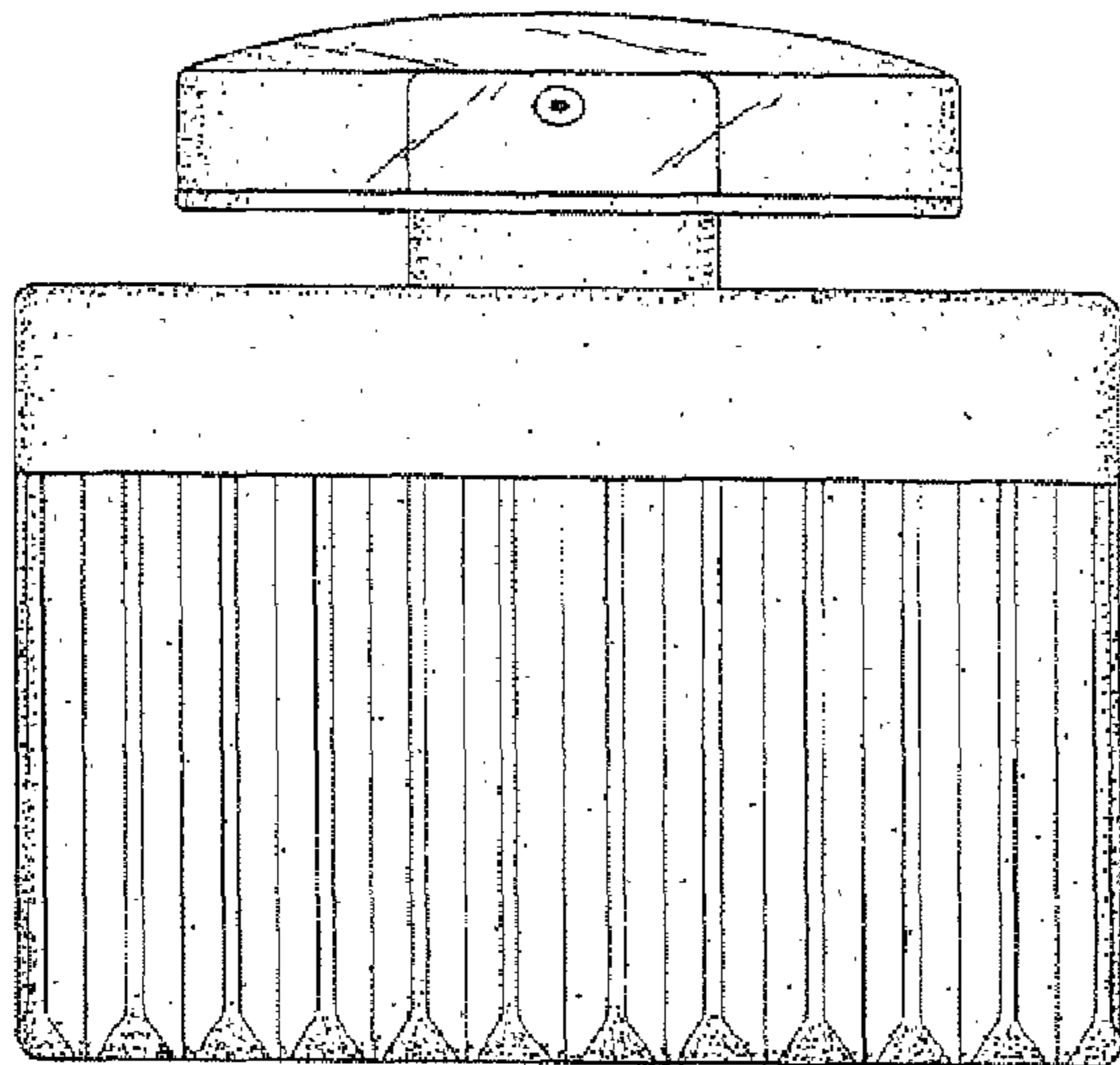

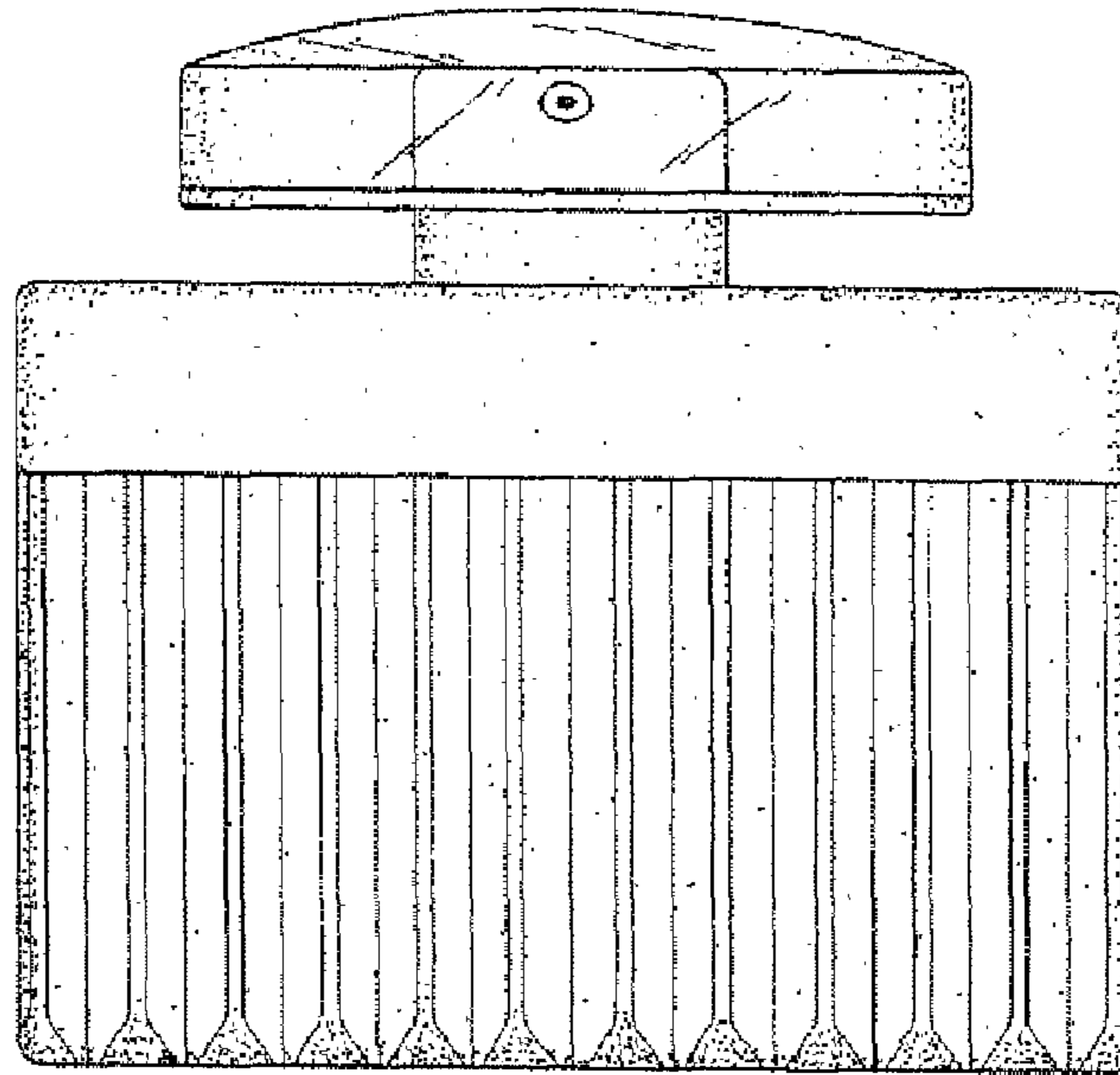

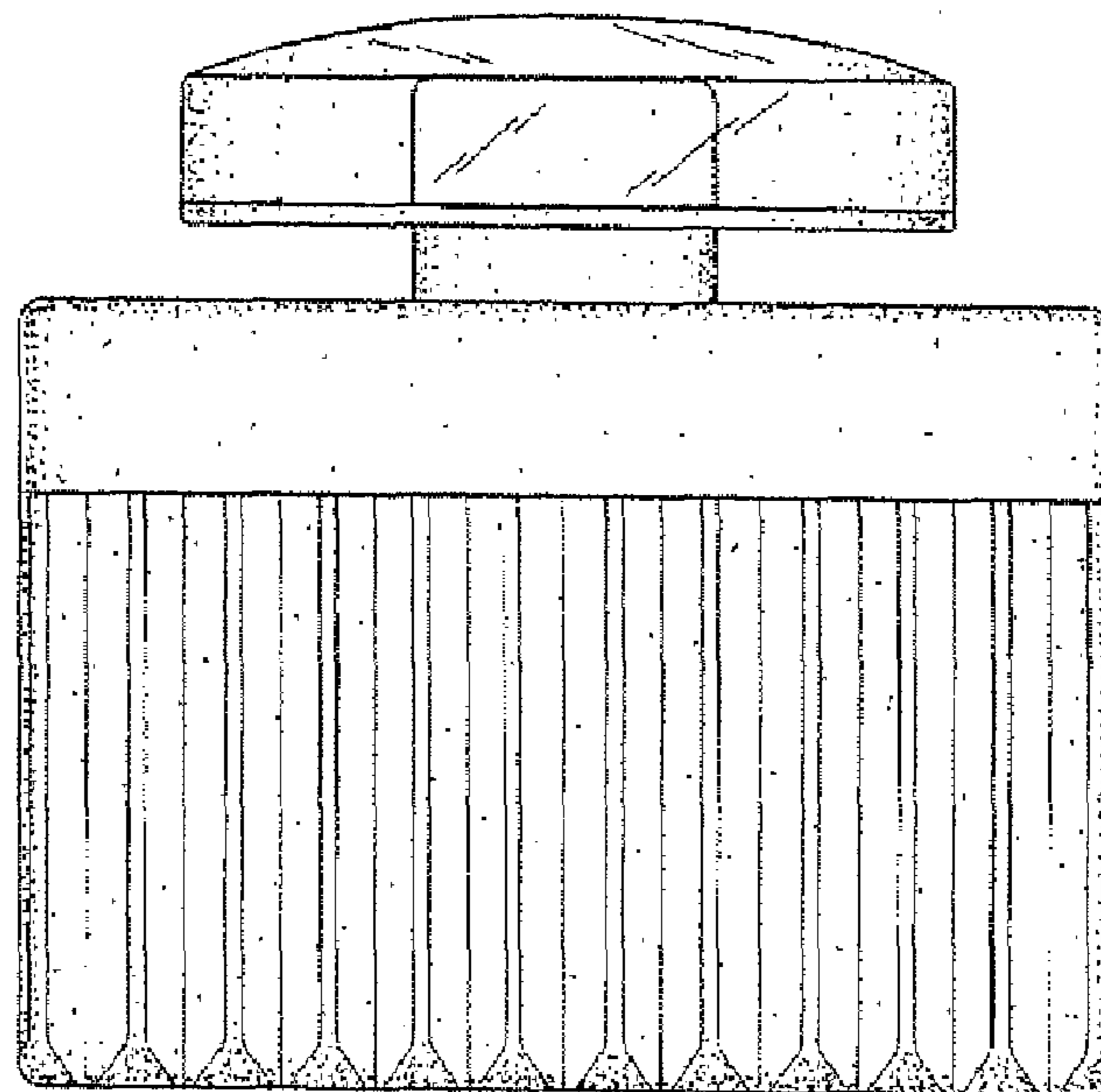

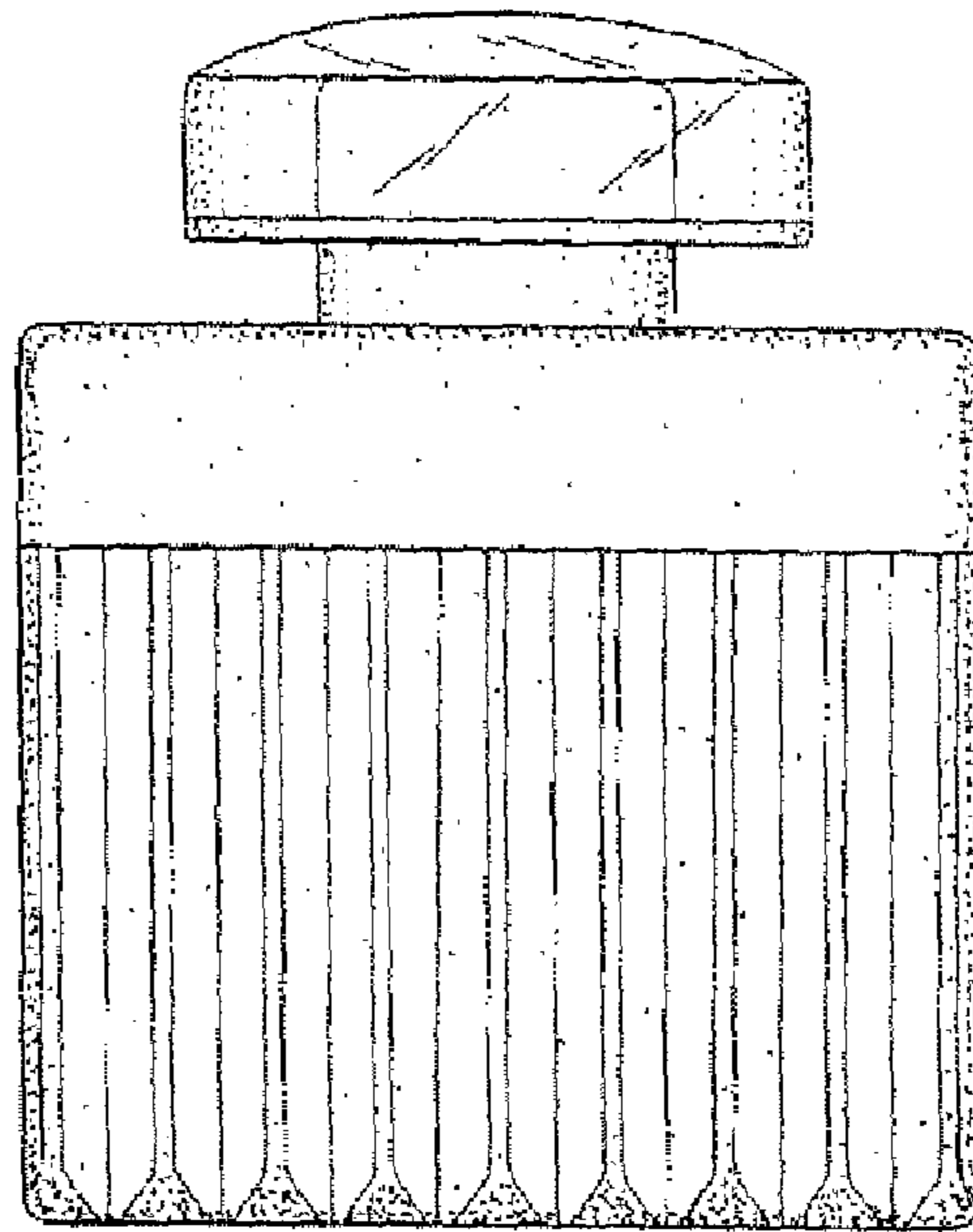

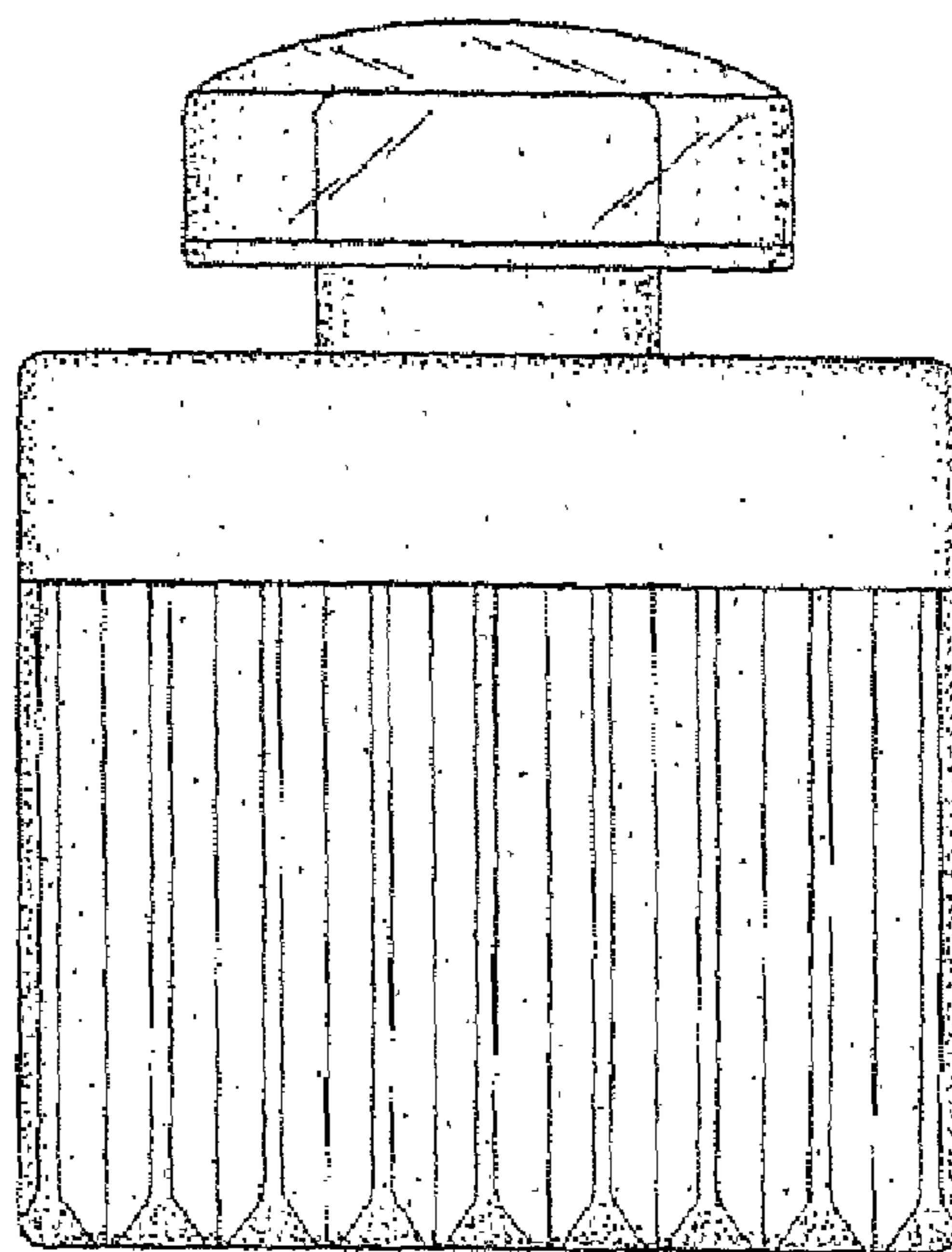

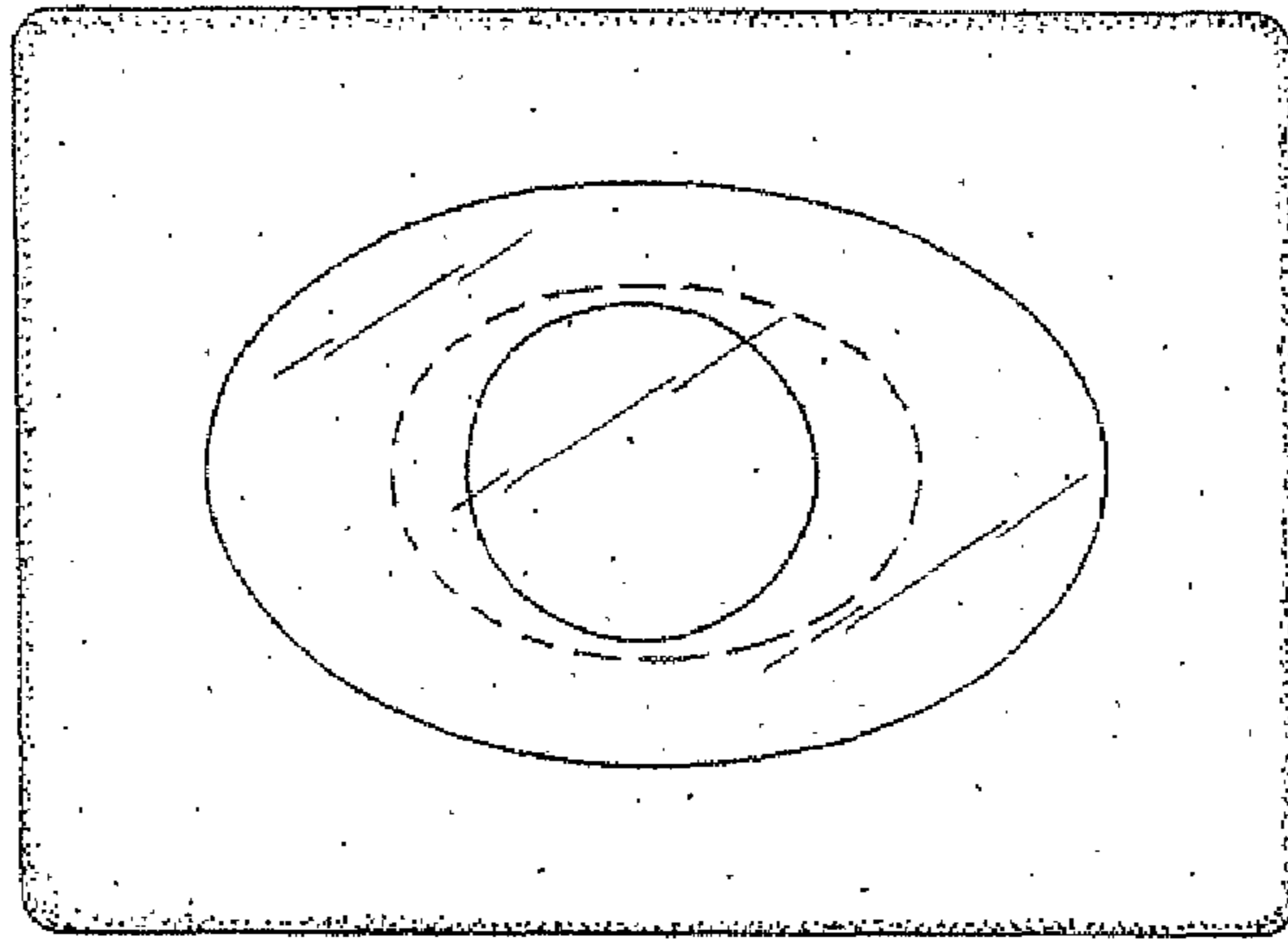

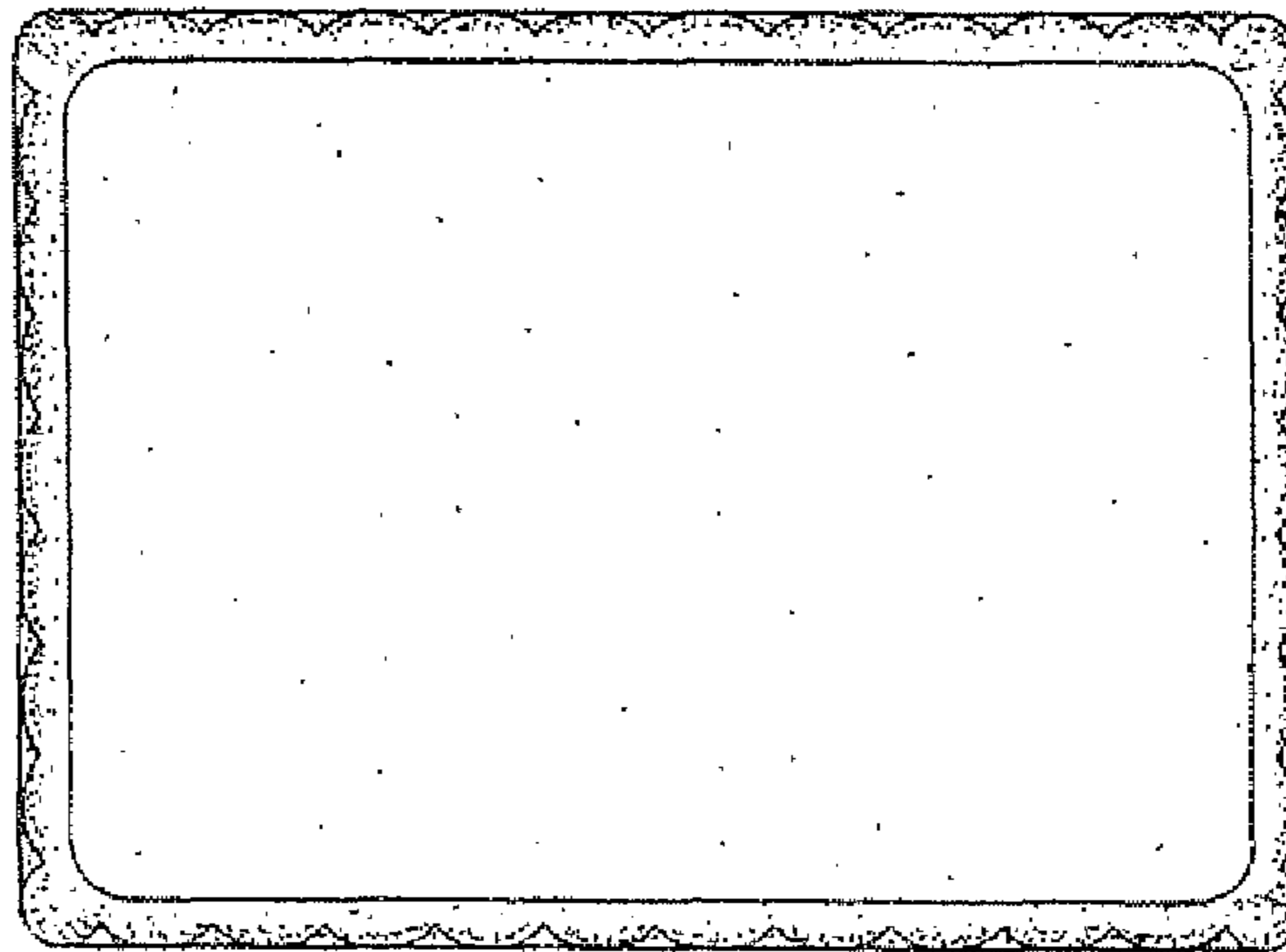

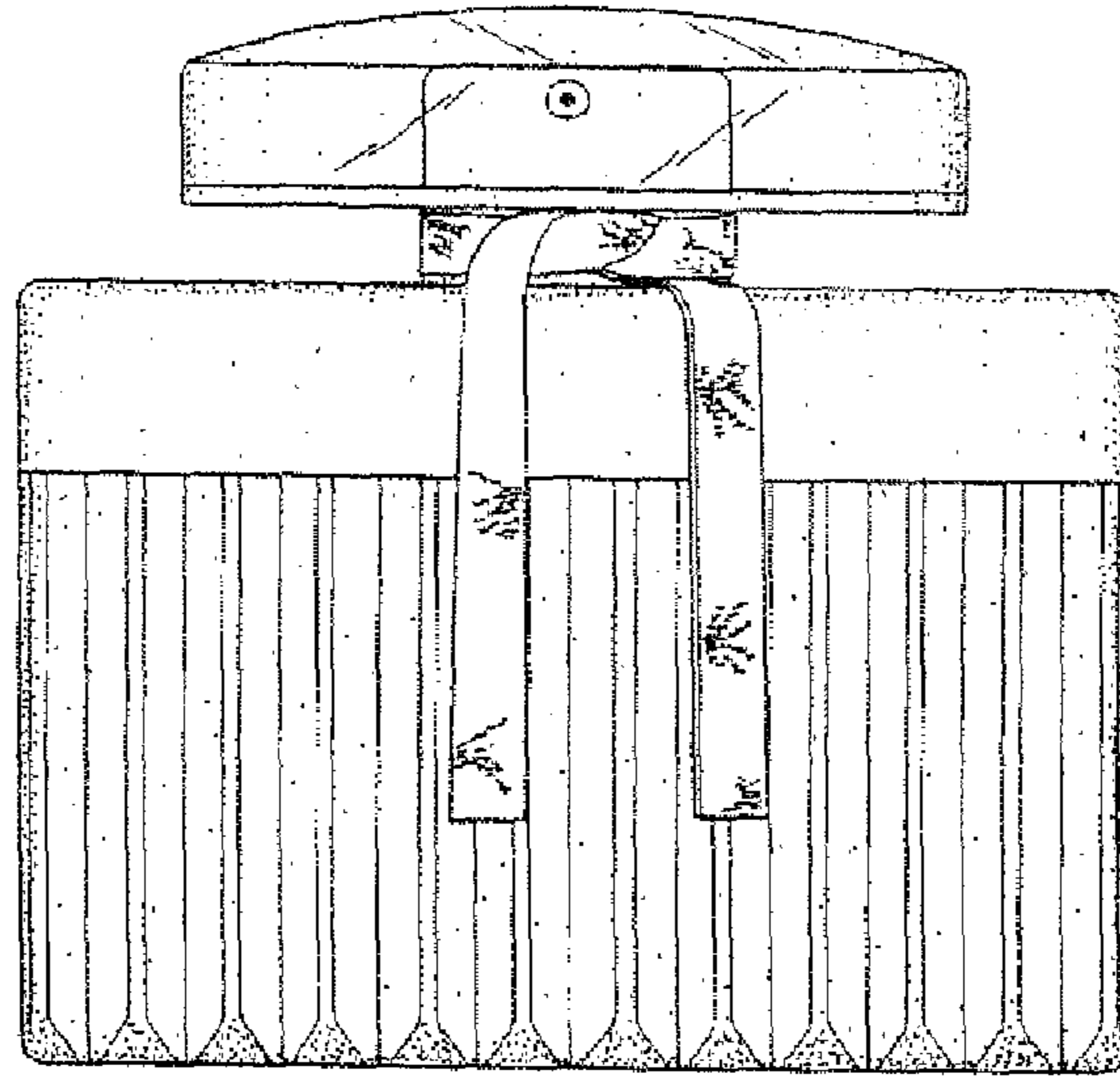

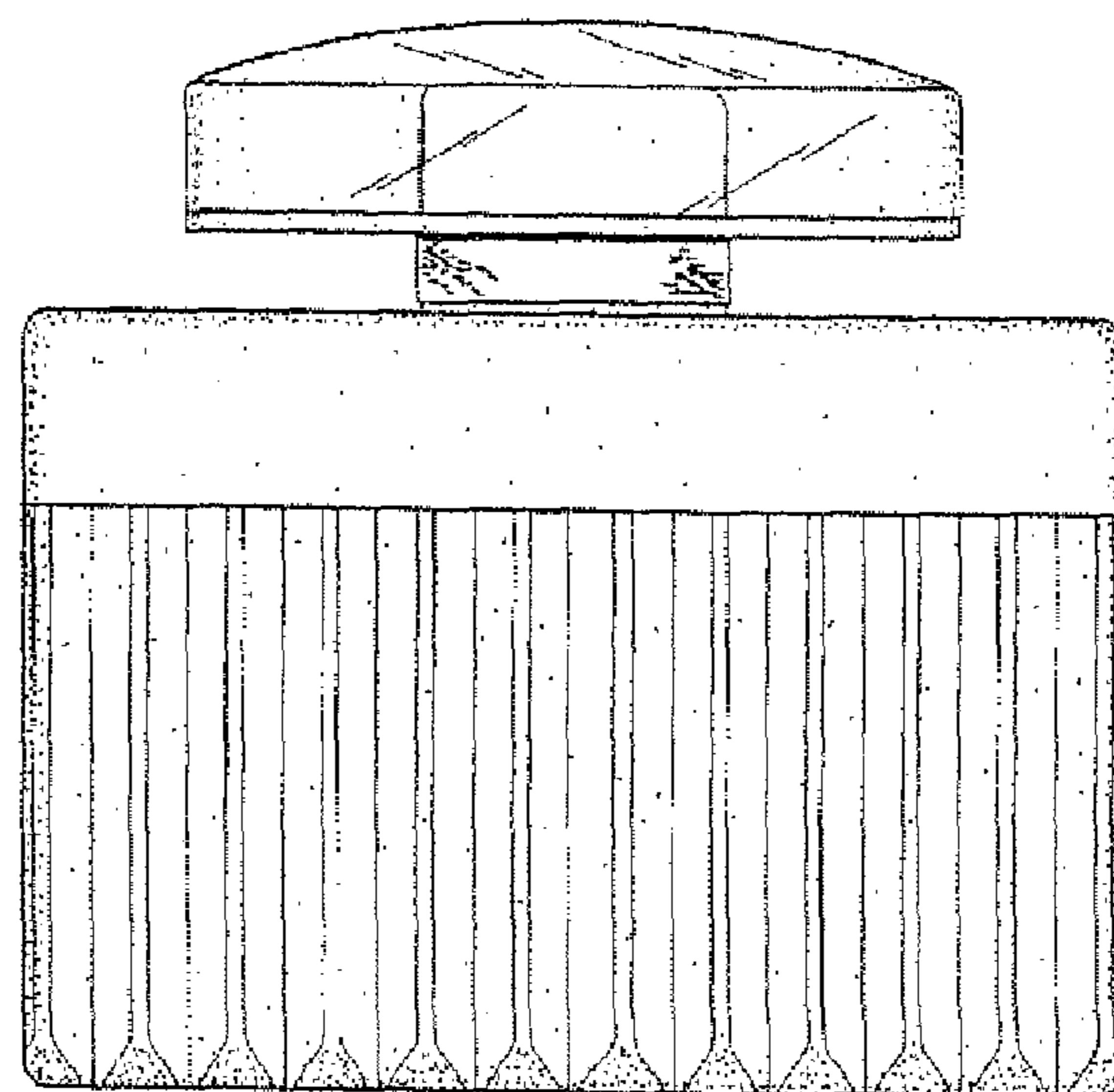

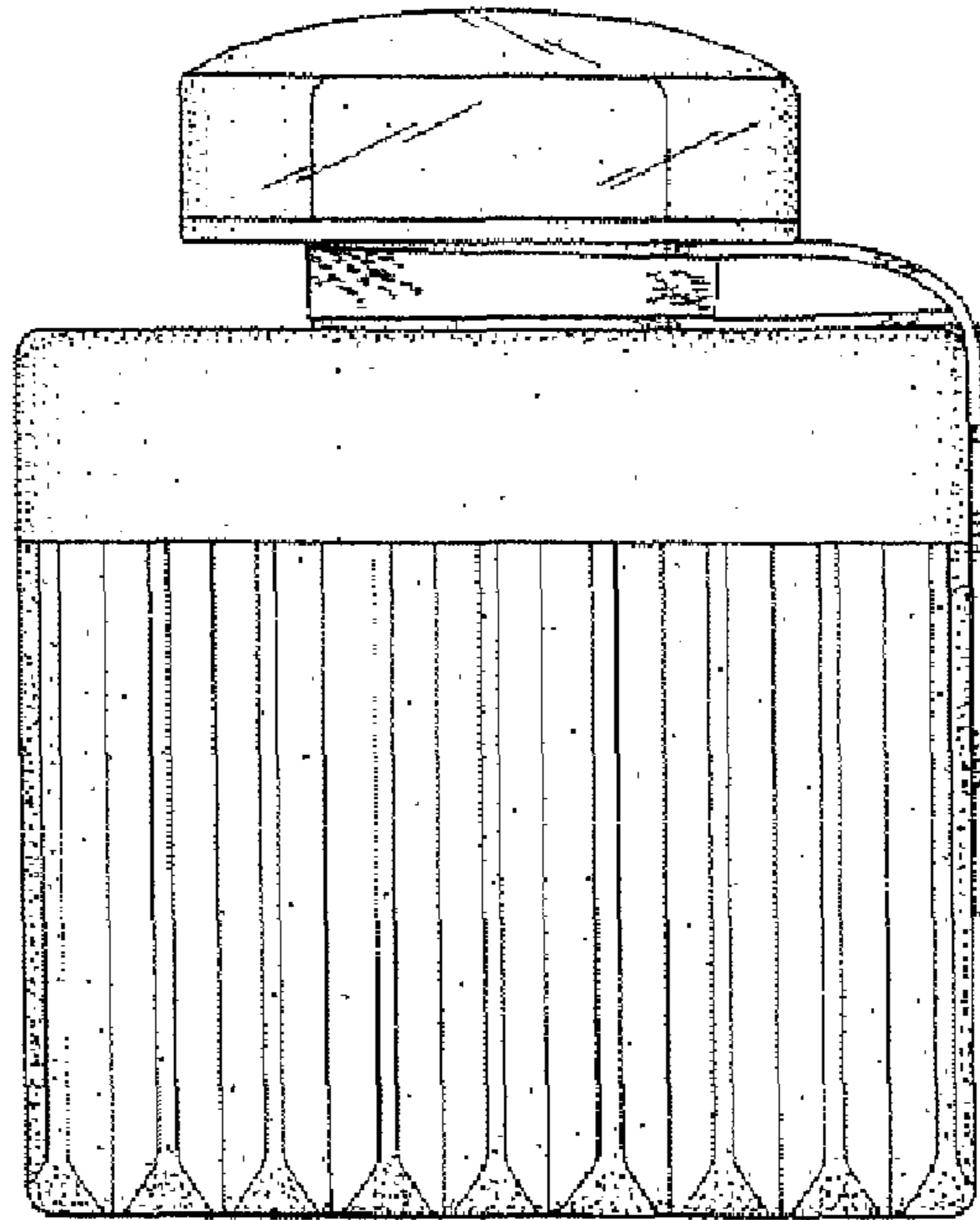

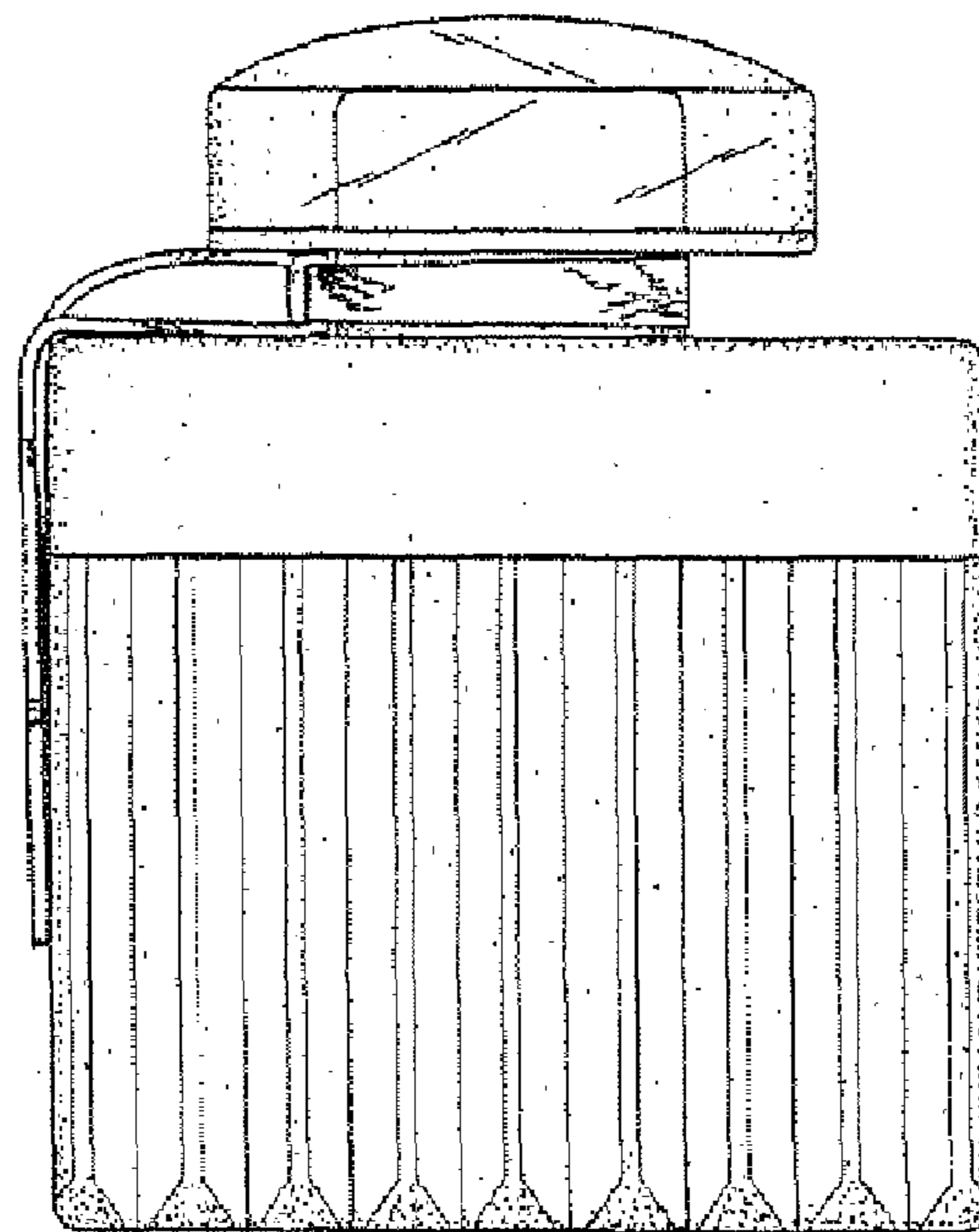

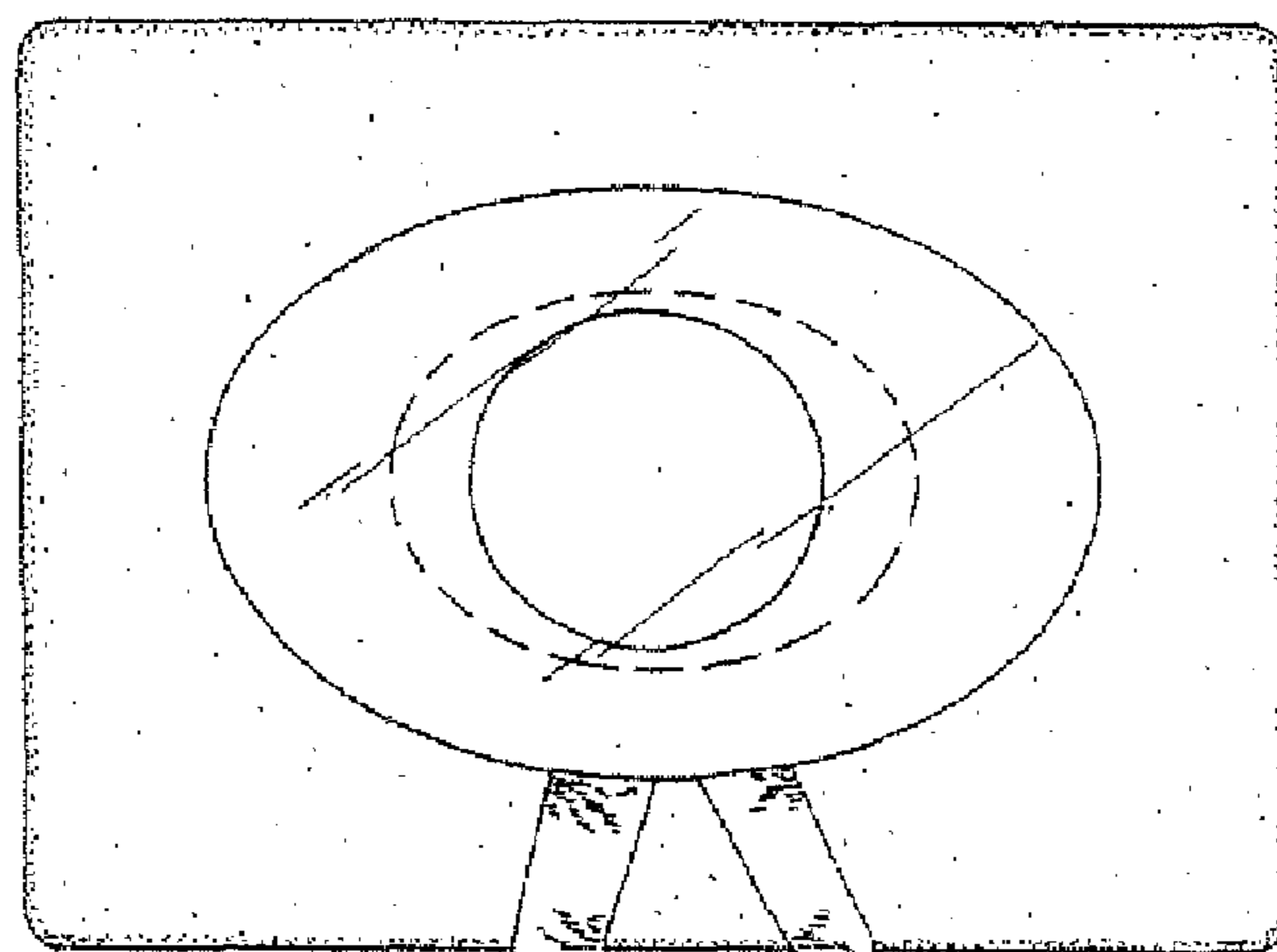
