FIG. 1 is a perspective view of the trailer showing my new design;

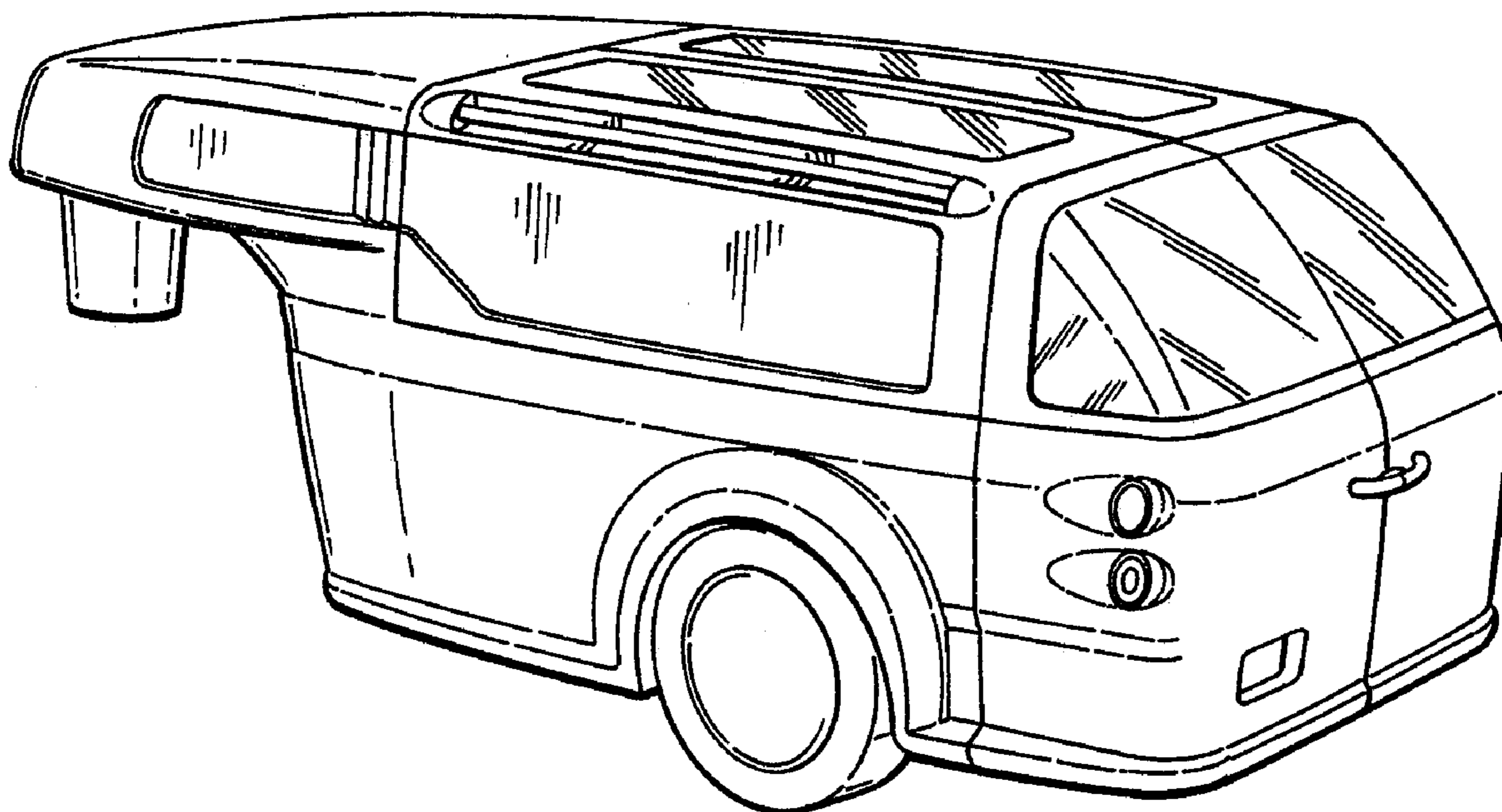
FIG. 2 is a side view thereof;

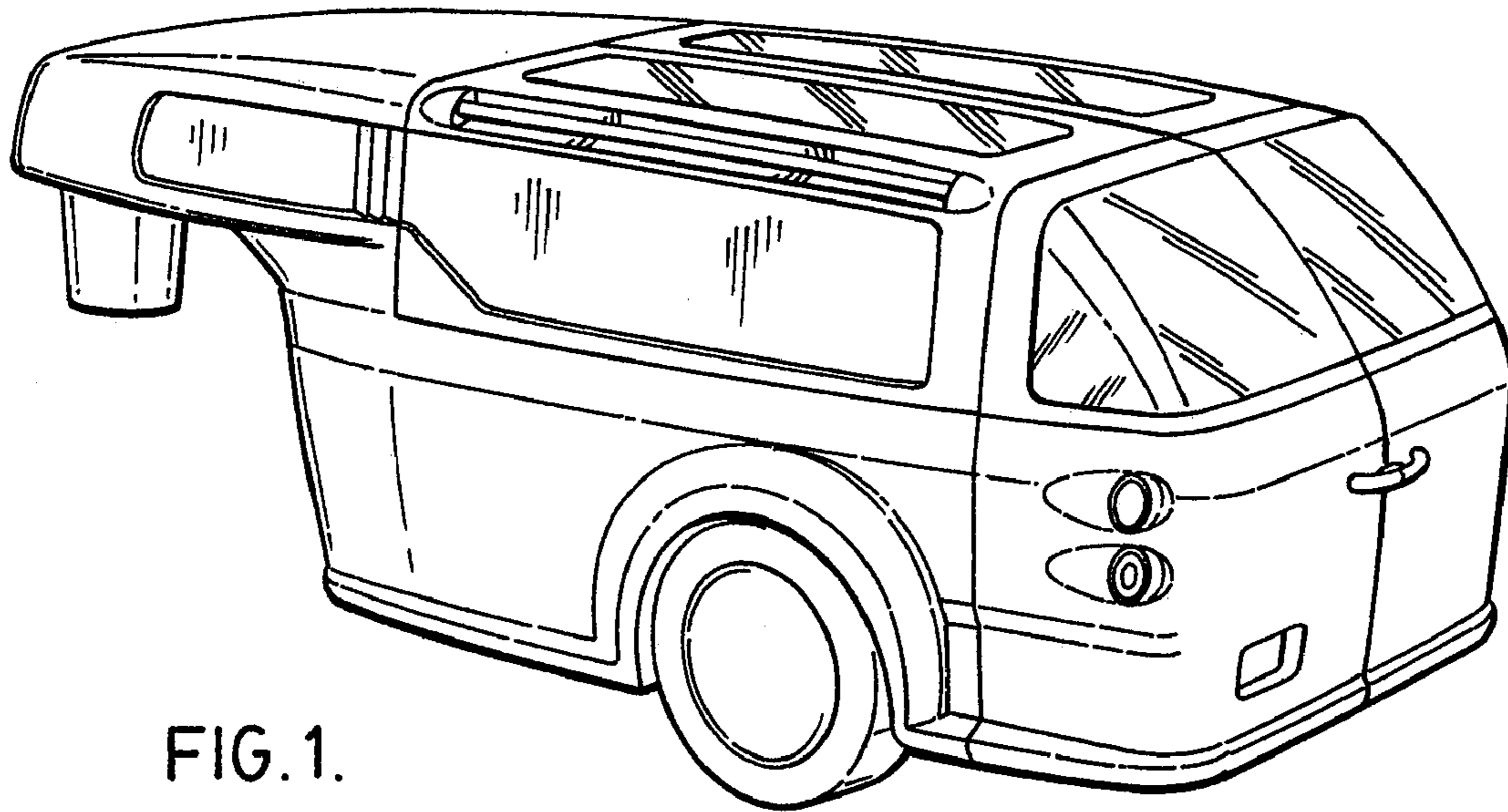

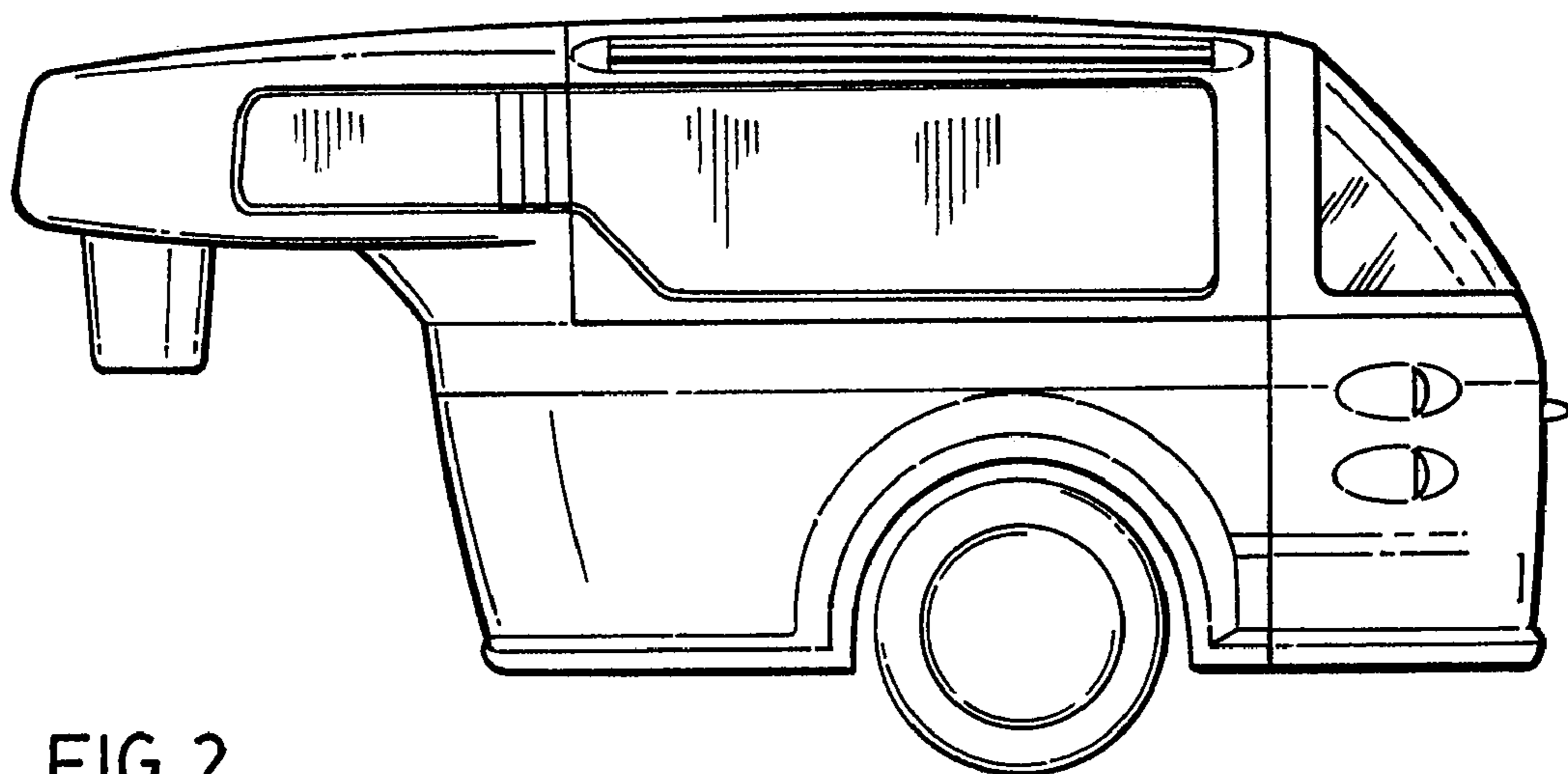

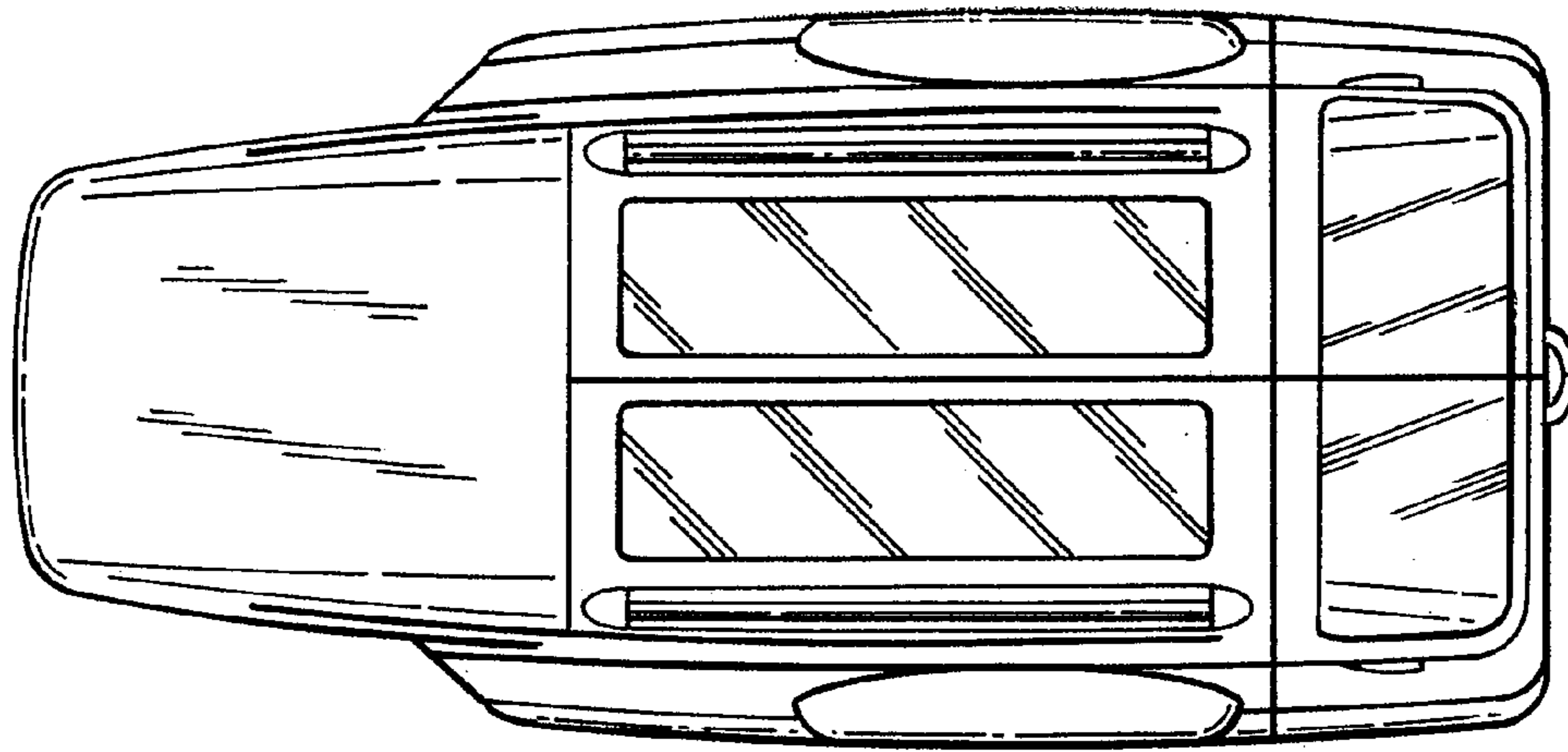

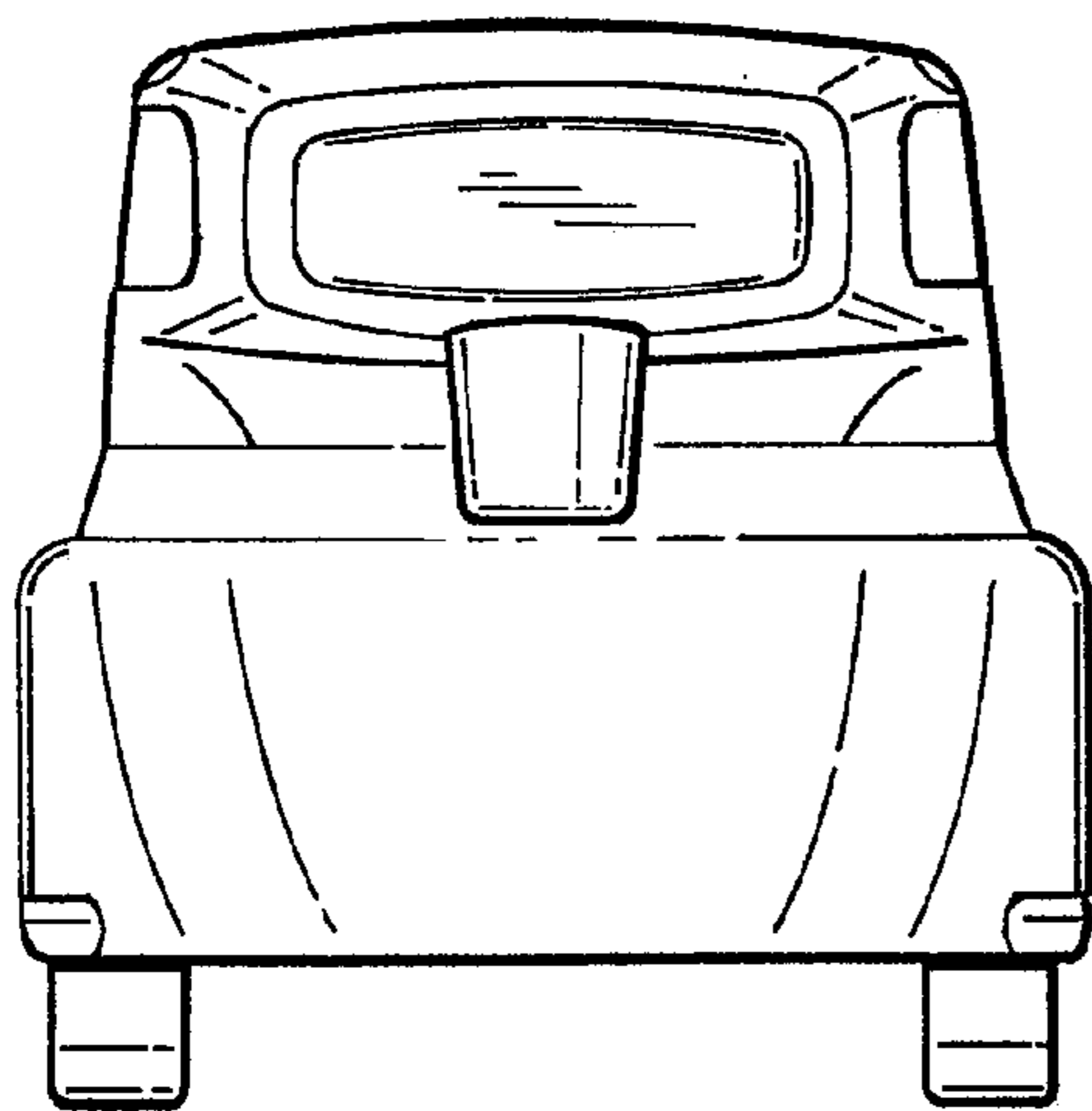

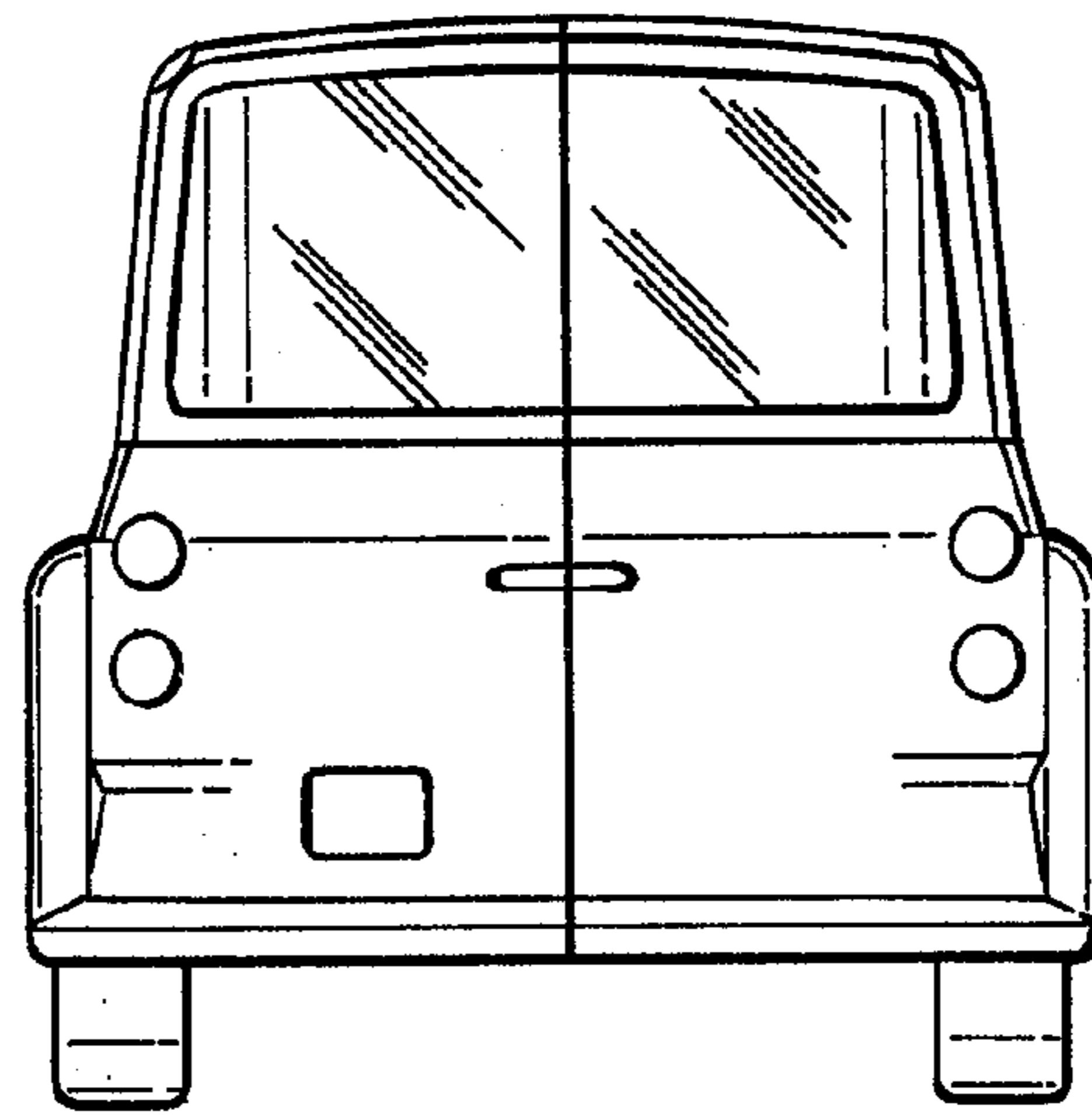
