(57) **CLAIM**

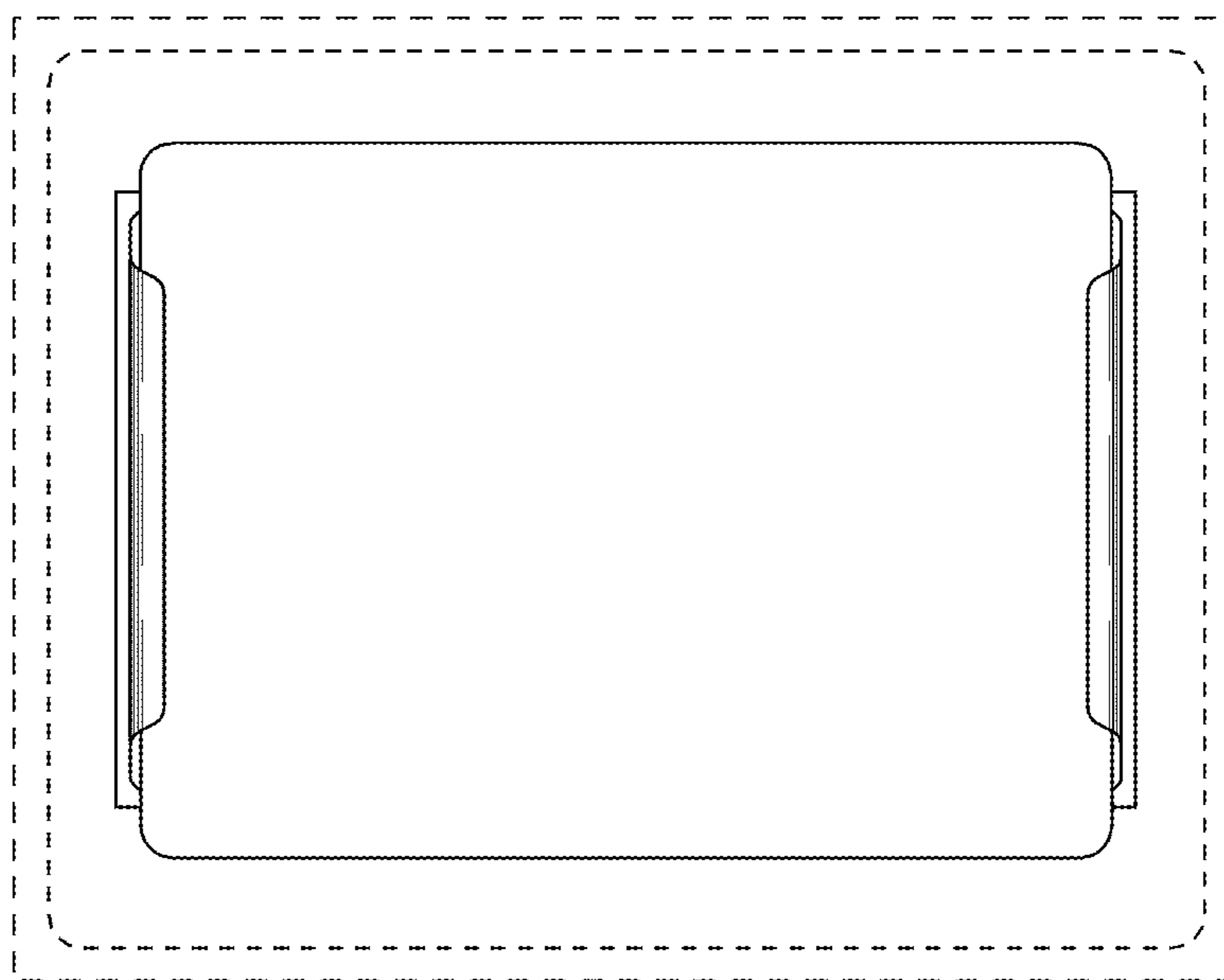
We claim the ornamental design for a display panel with a  
computer-generated icon, as shown and described.

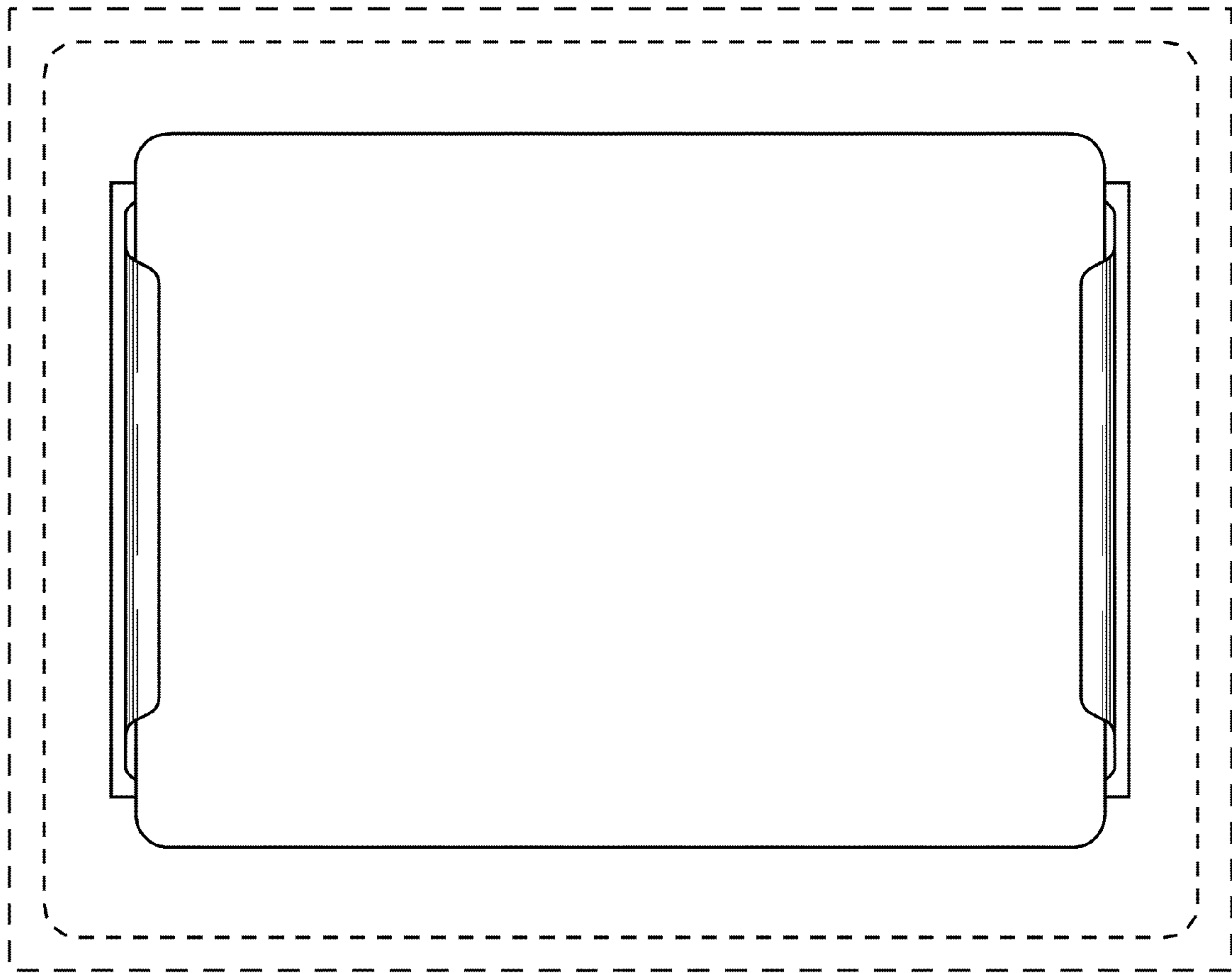
**DESCRIPTION**
