The ornamental design for a computer generated image for a display panel or screen, as shown and described.

DESCRIPTION

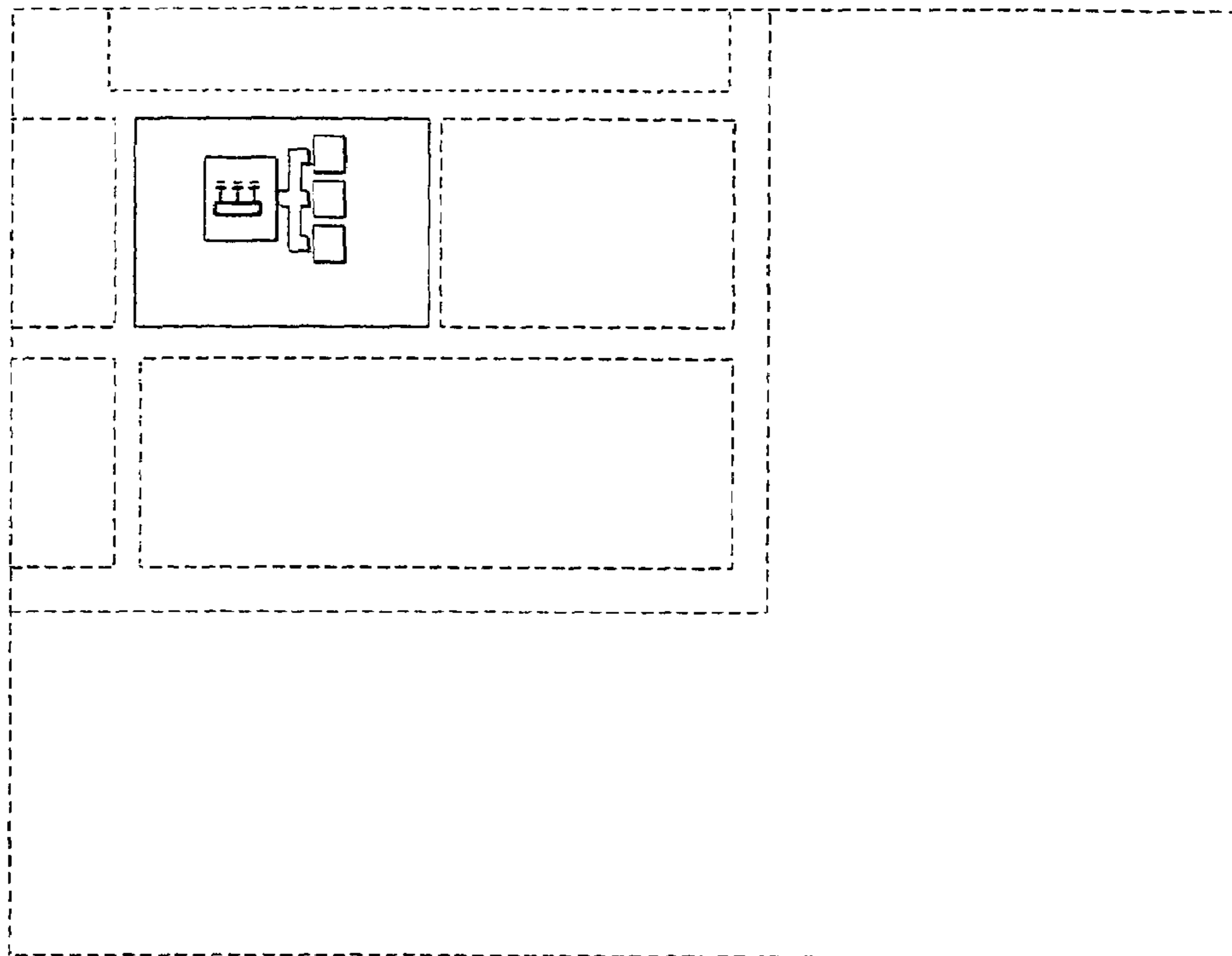
FIG. 1 is a front elevational view of a computer generated image for a display panel or screen showing my new design;

FIG. 2 is a front elevational view of another embodiment of a computer generated image for a display panel or screen showing my new design; and,

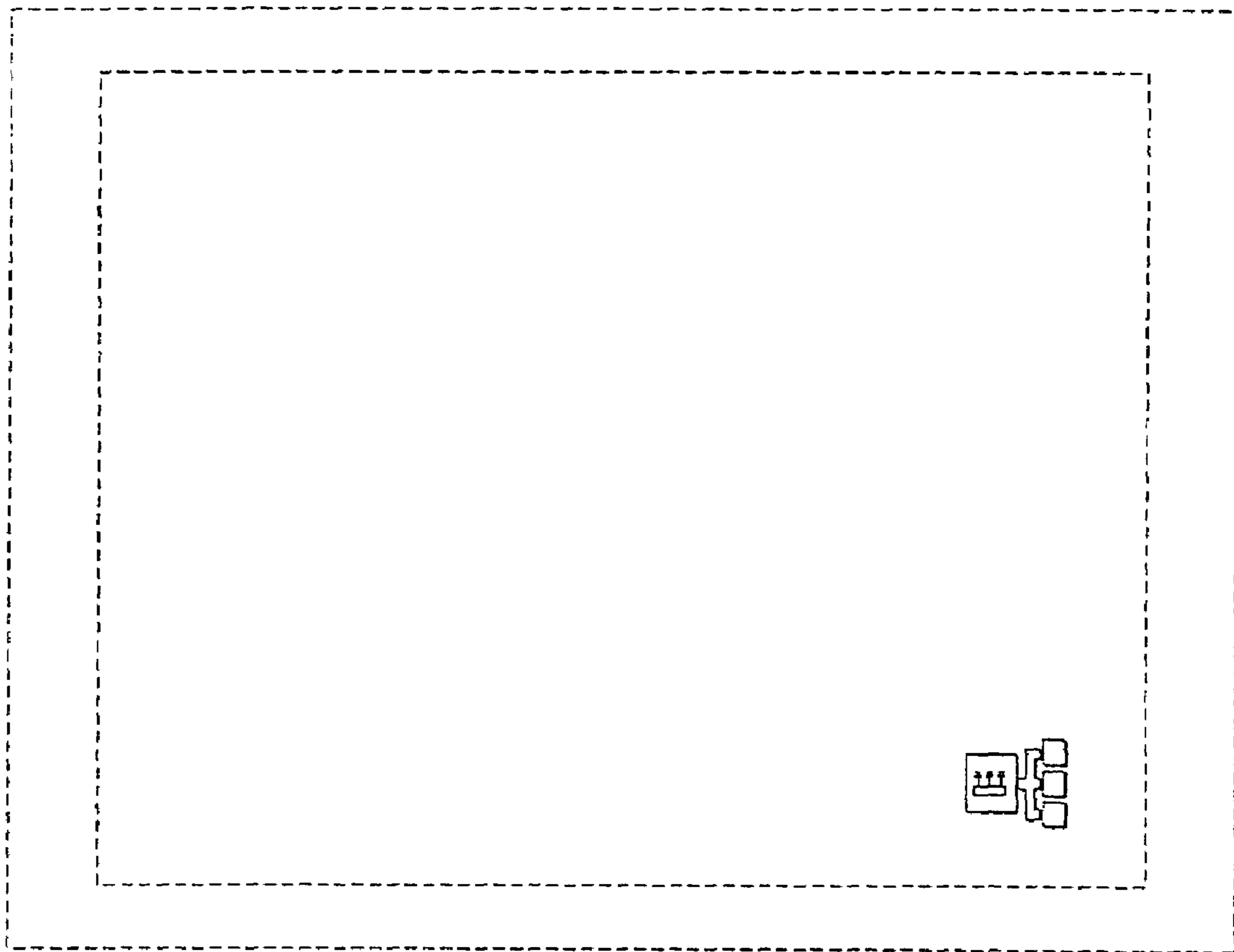

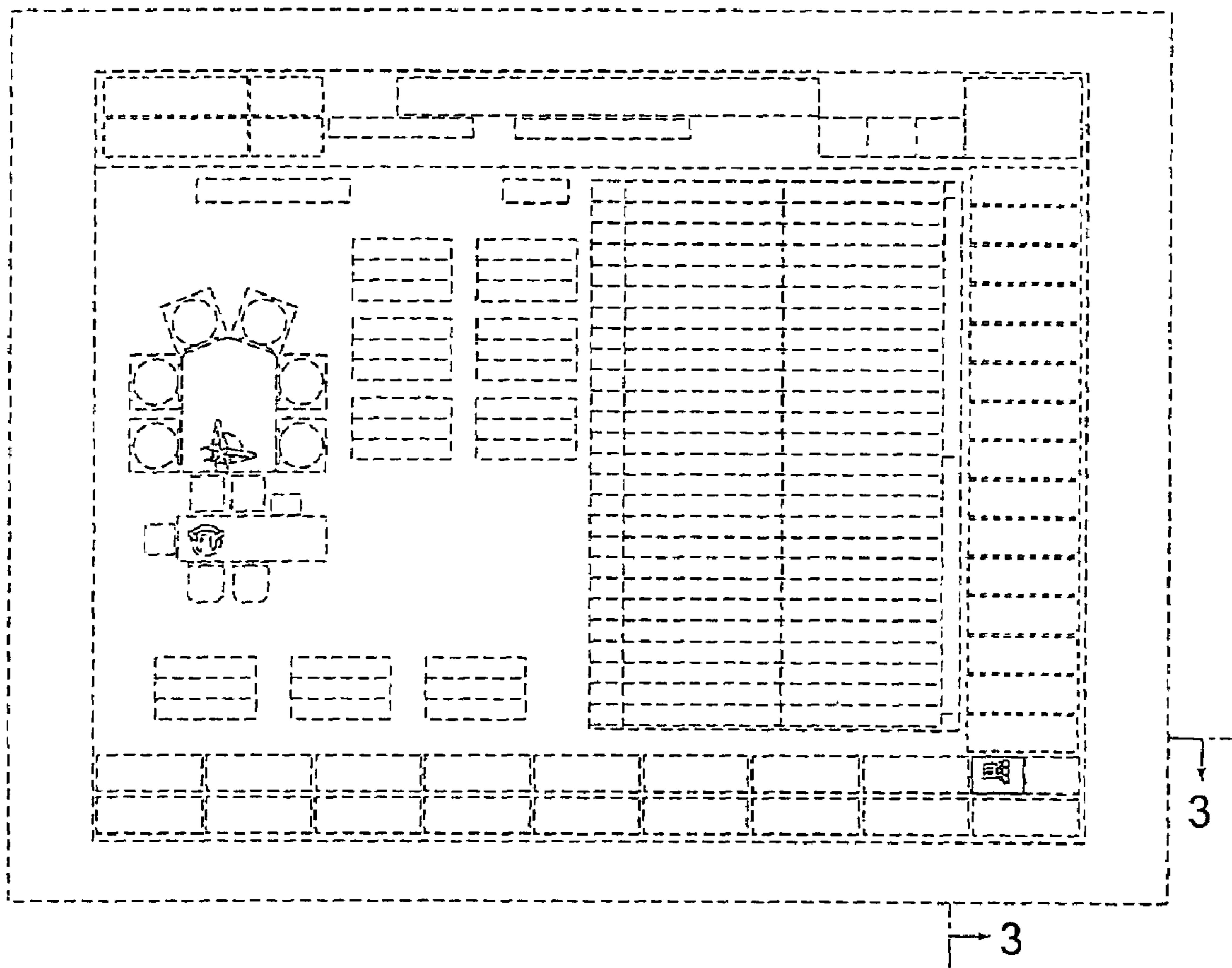

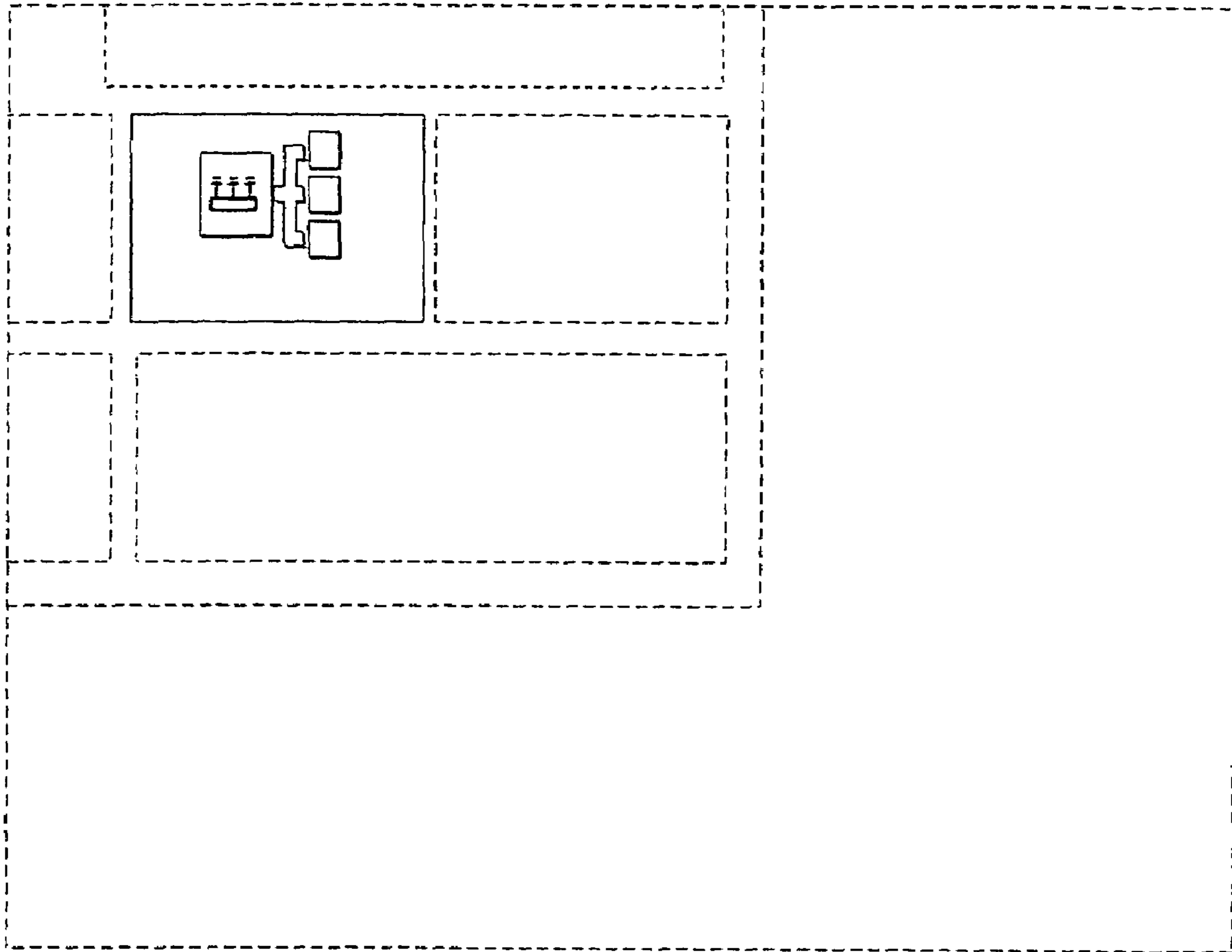
