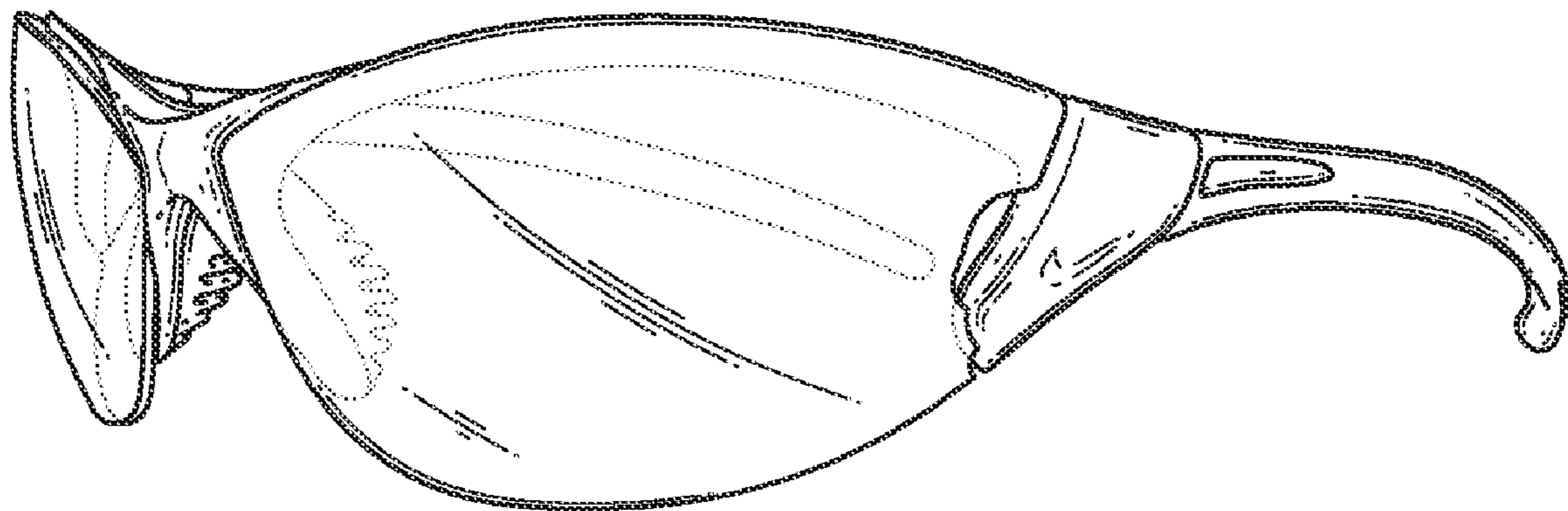
The ornamental design for eyewear, as shown and described.

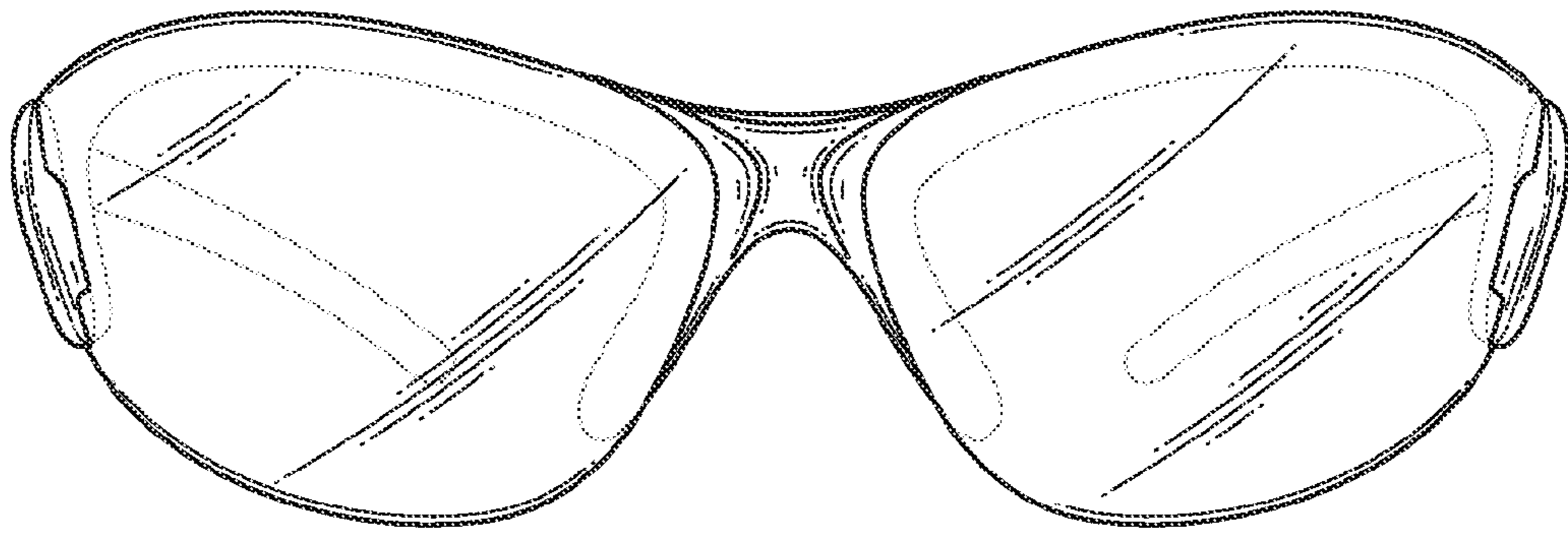

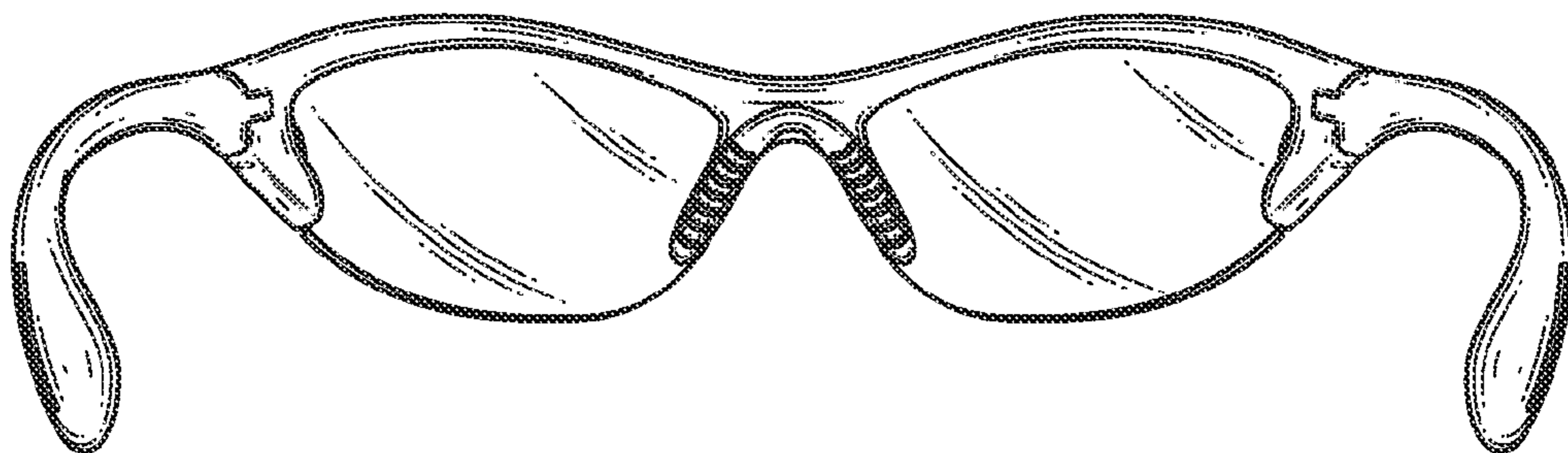

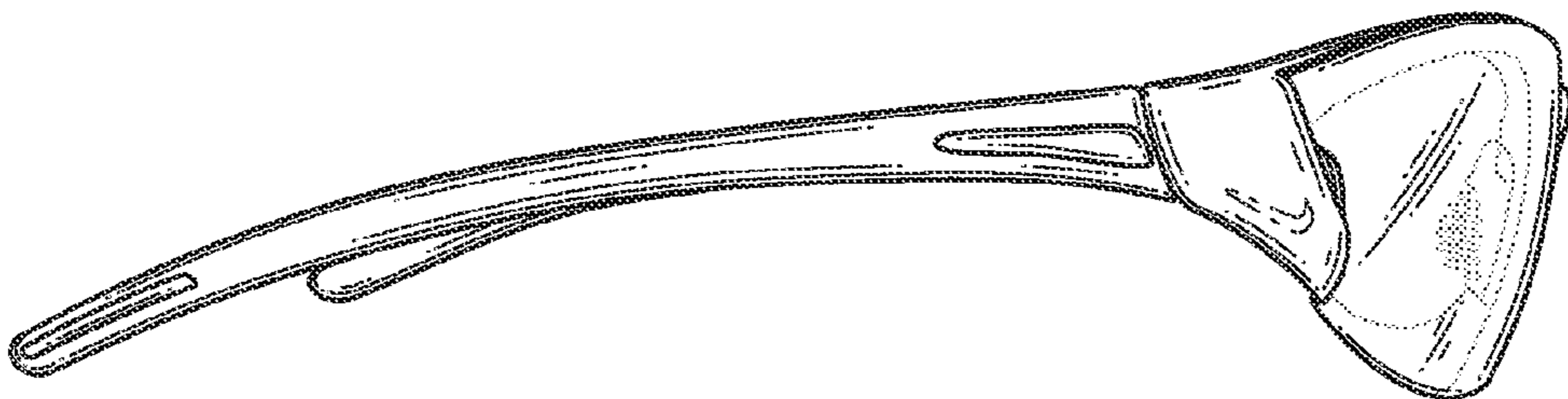

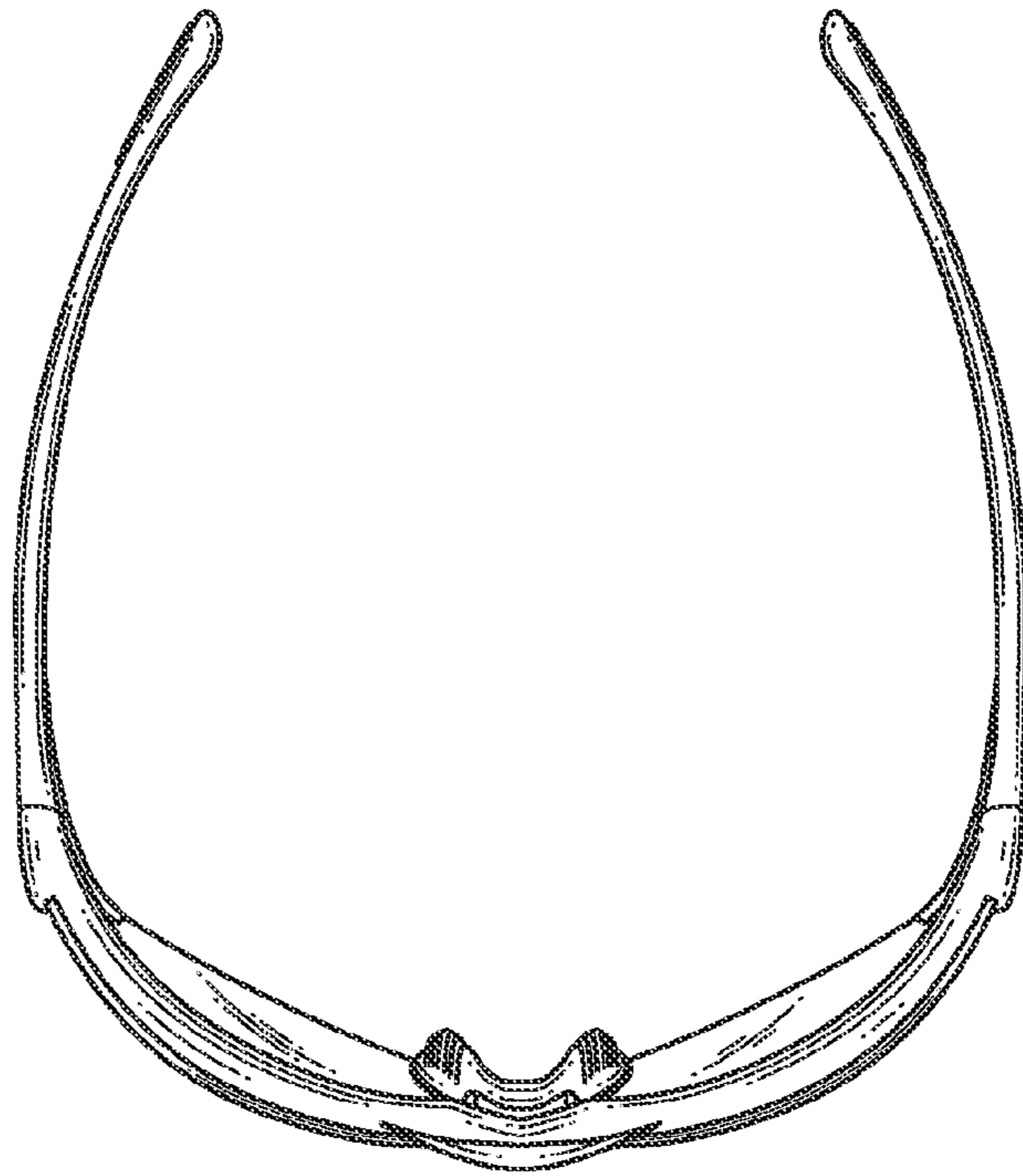

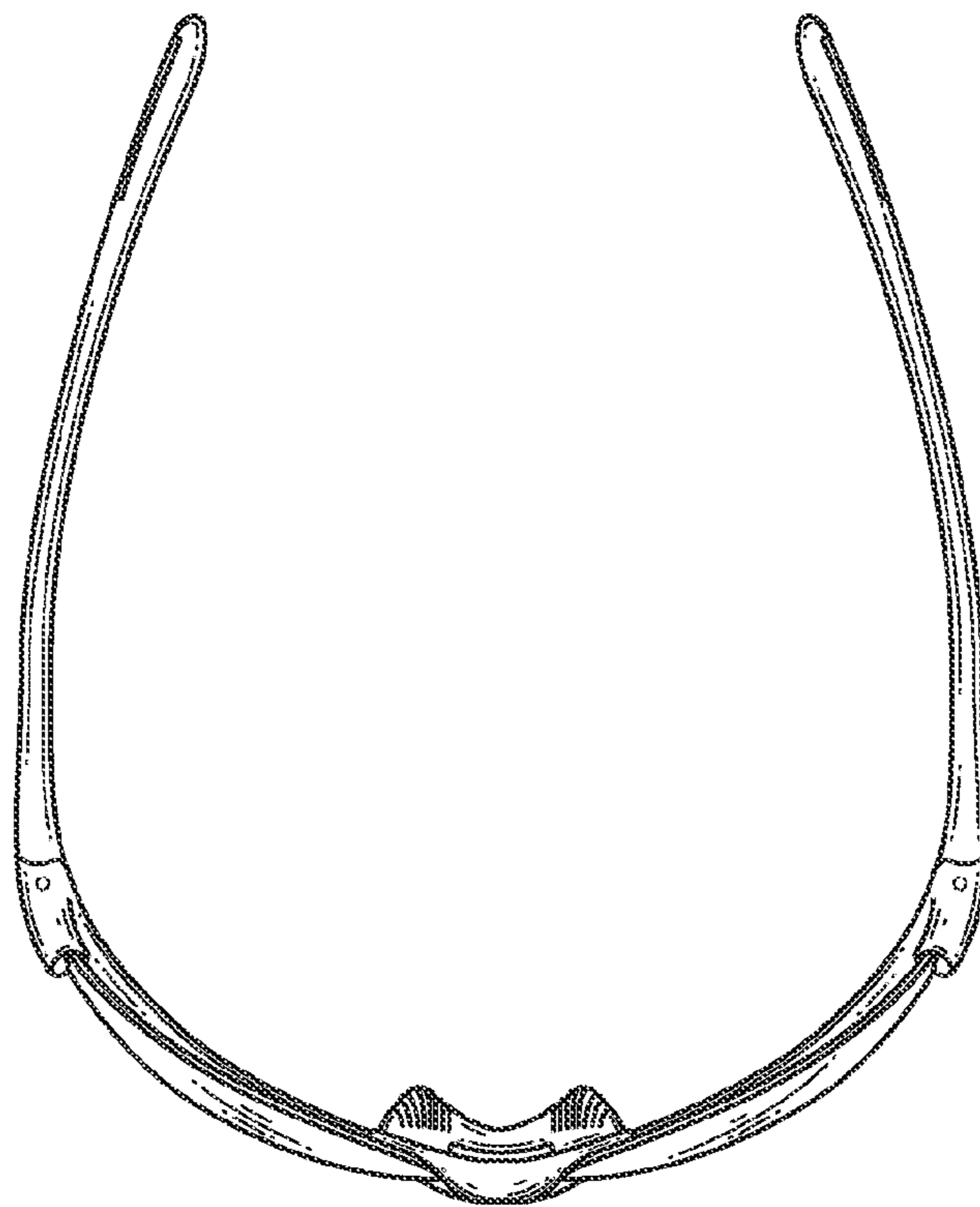

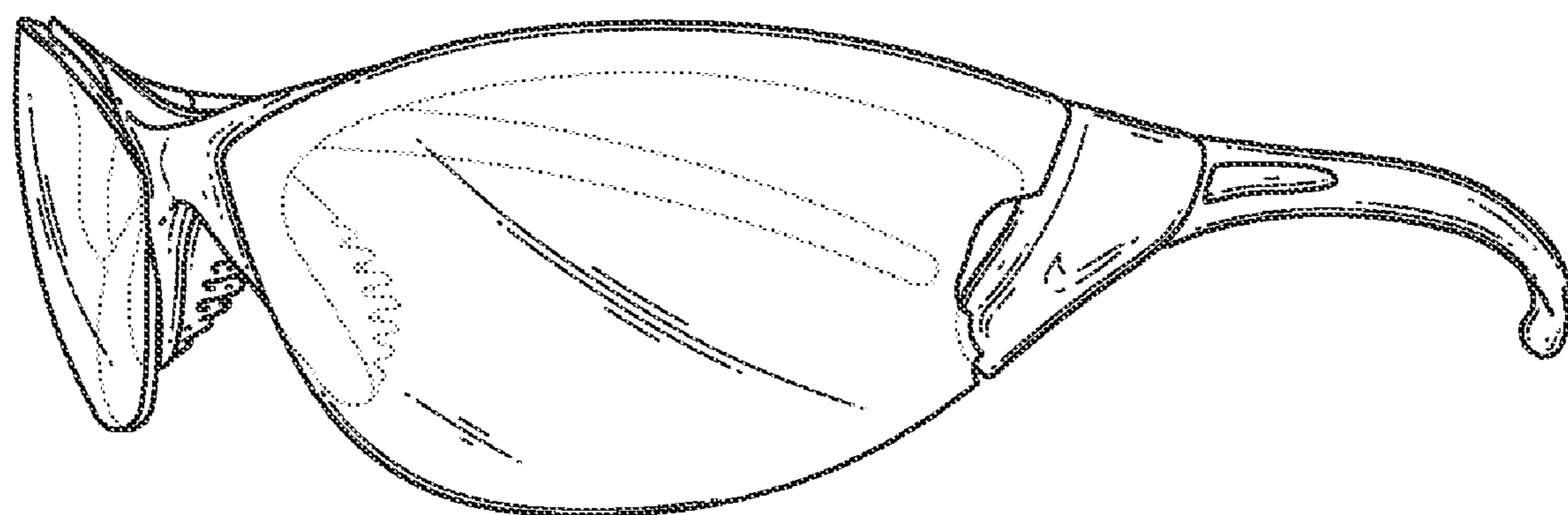
