FIG. 9 is a front view of the card file of FIG. 1;

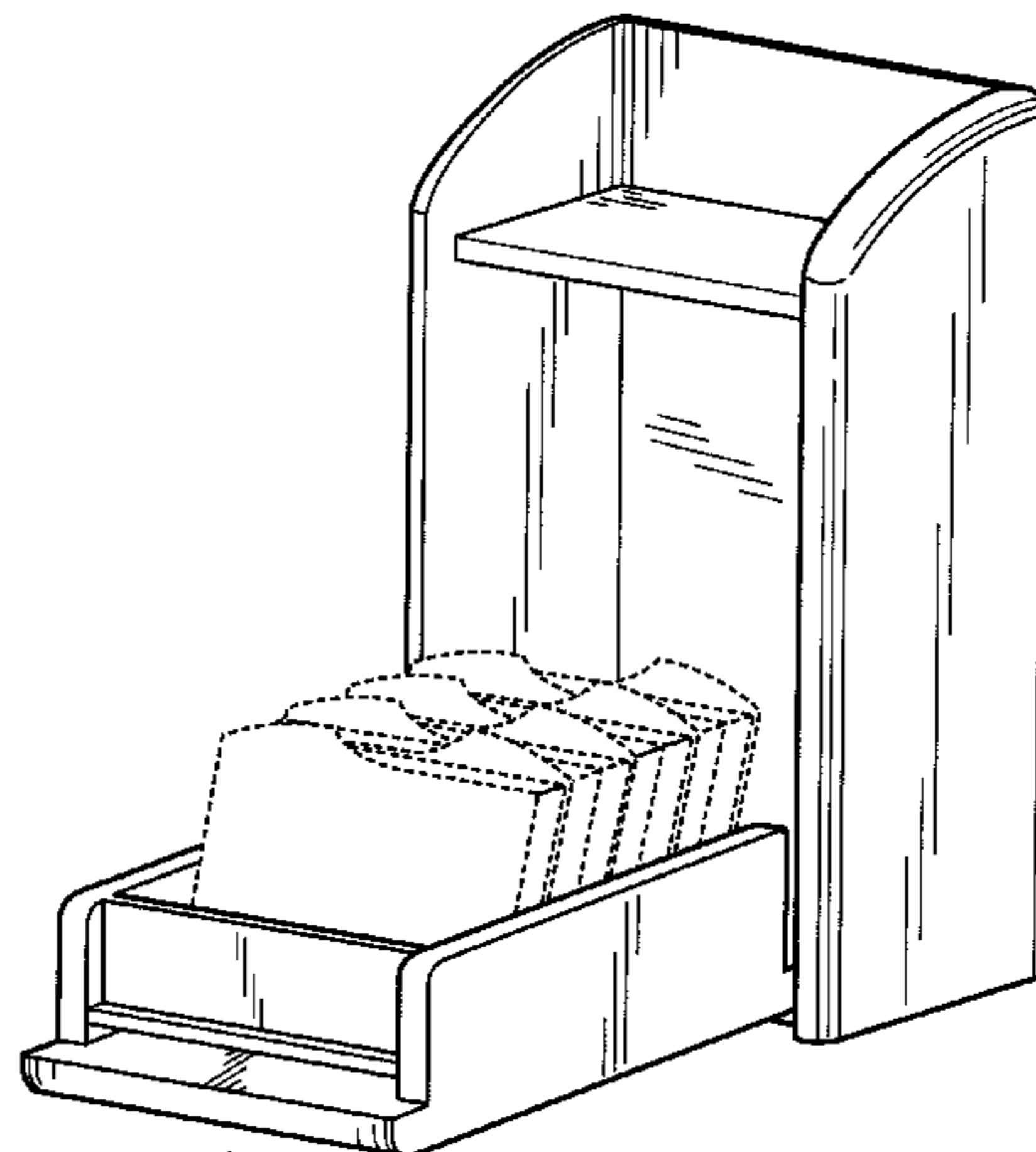
FIG. 10 is a rear view of the card file of FIG. 1;

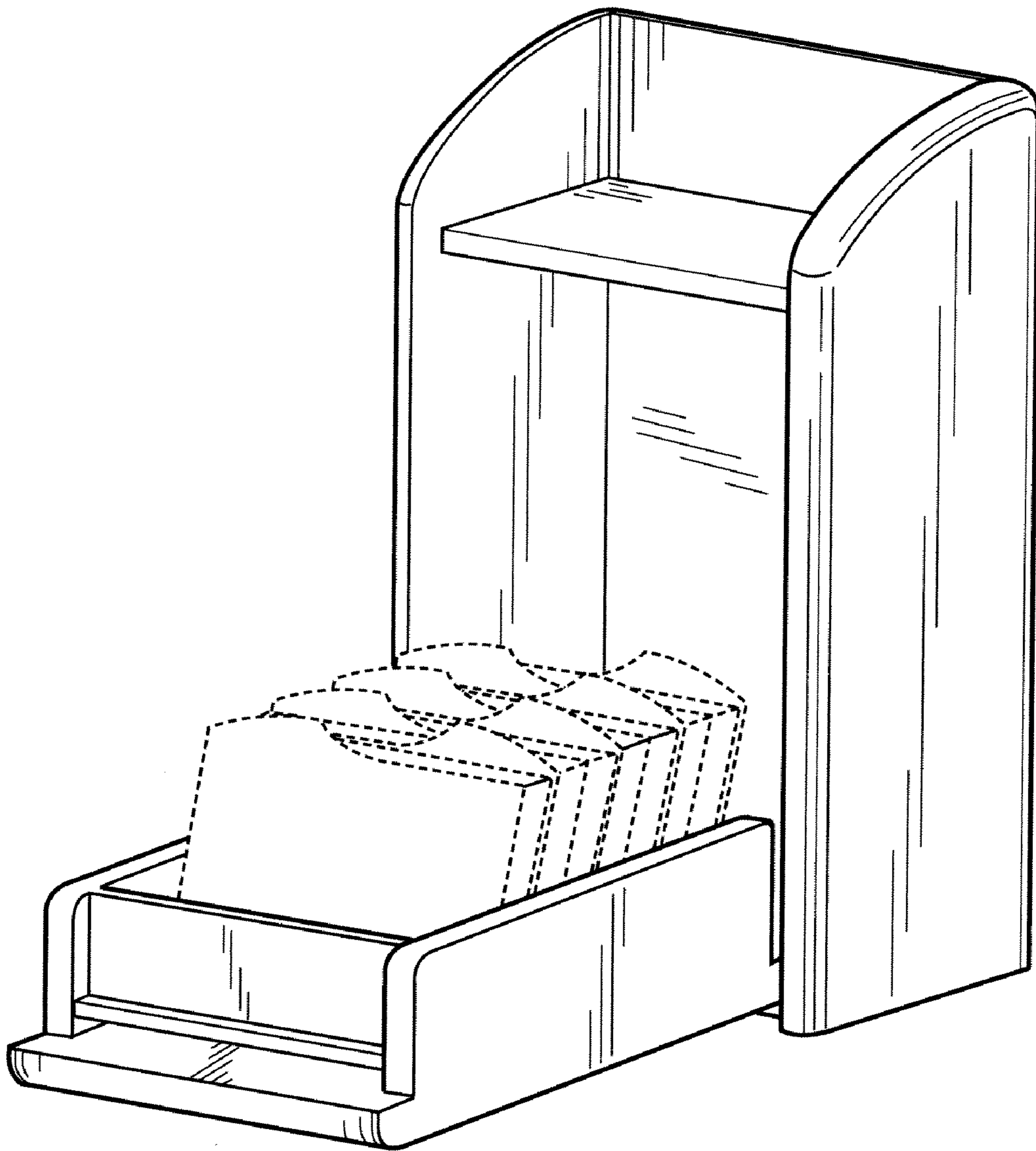

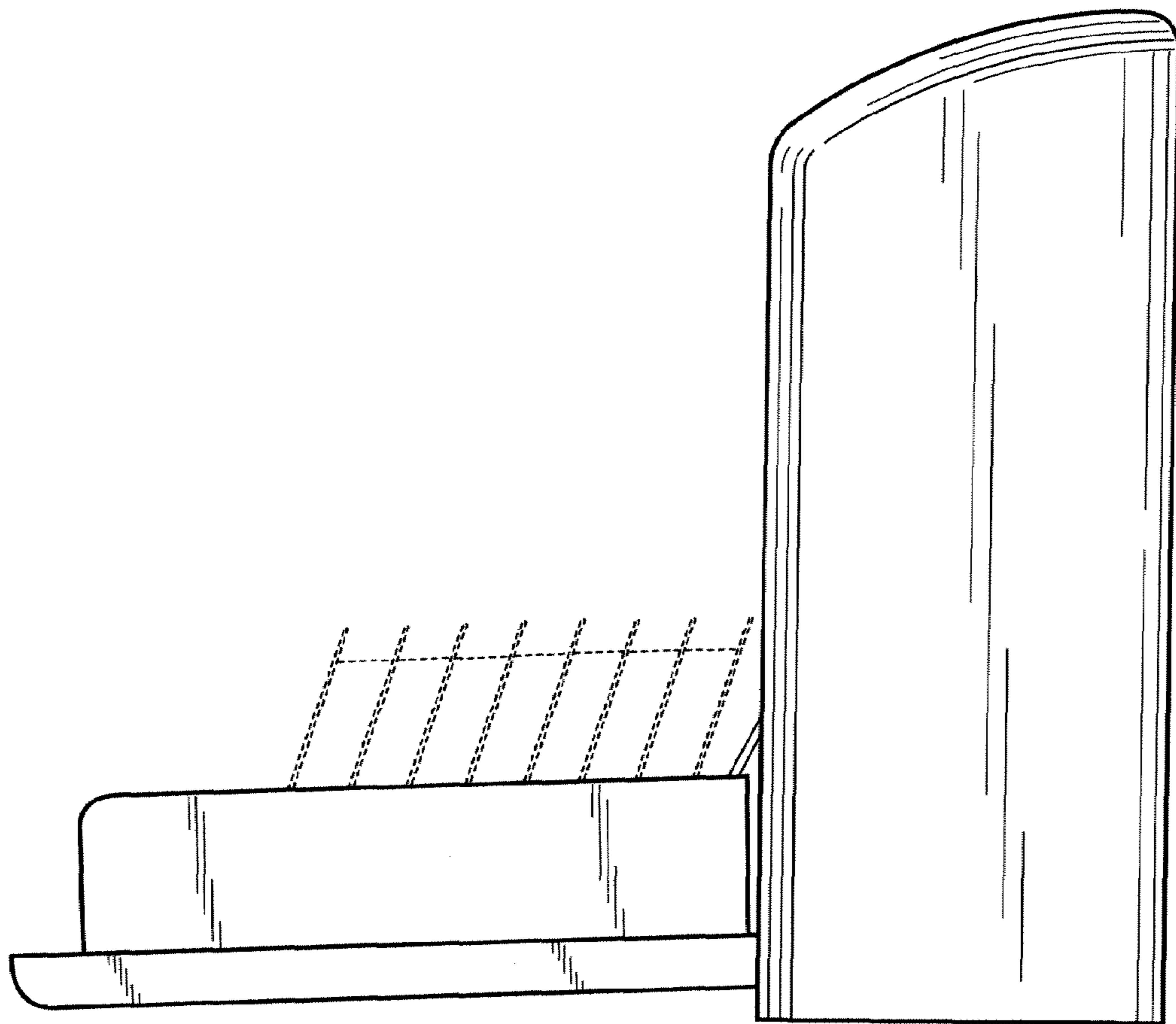

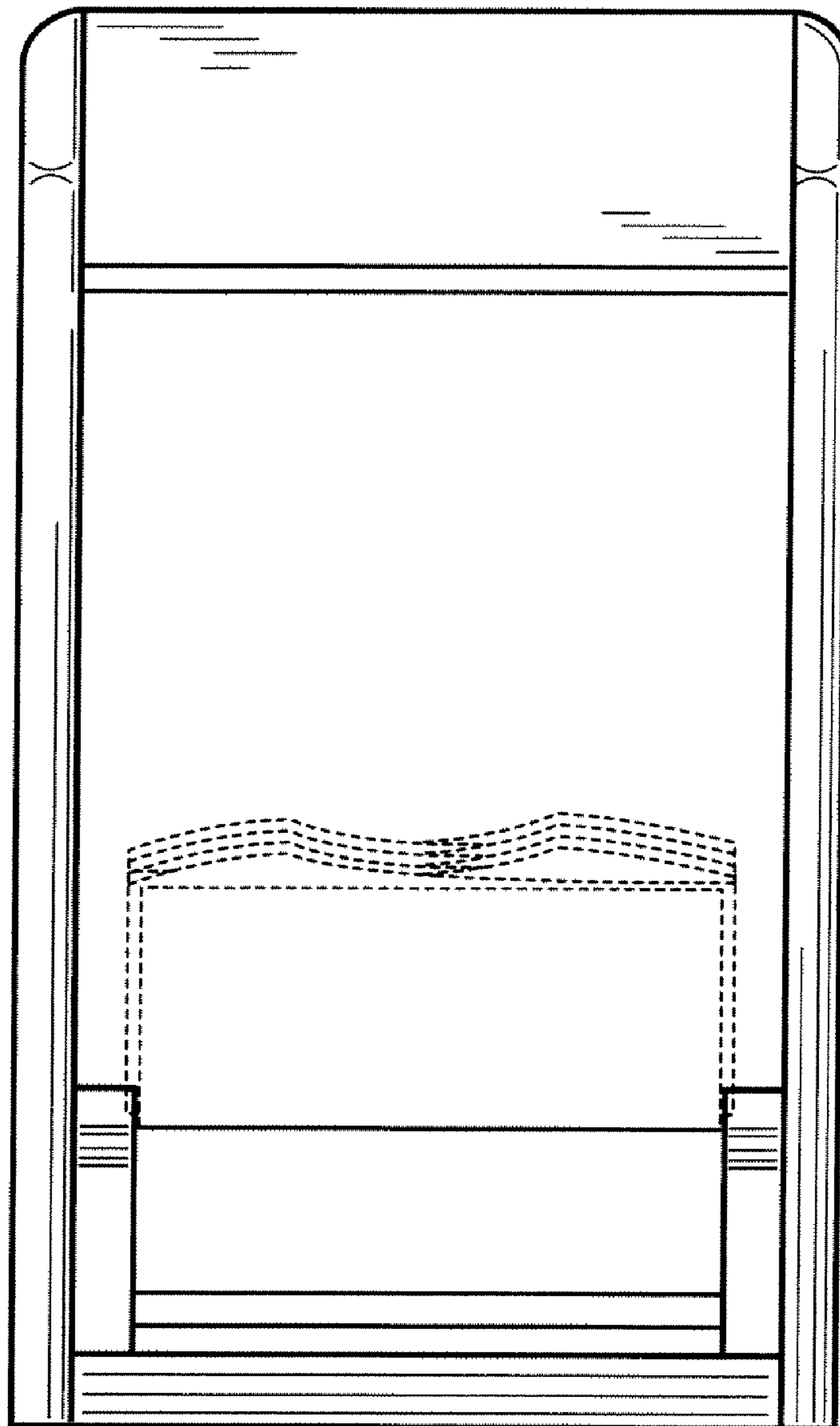

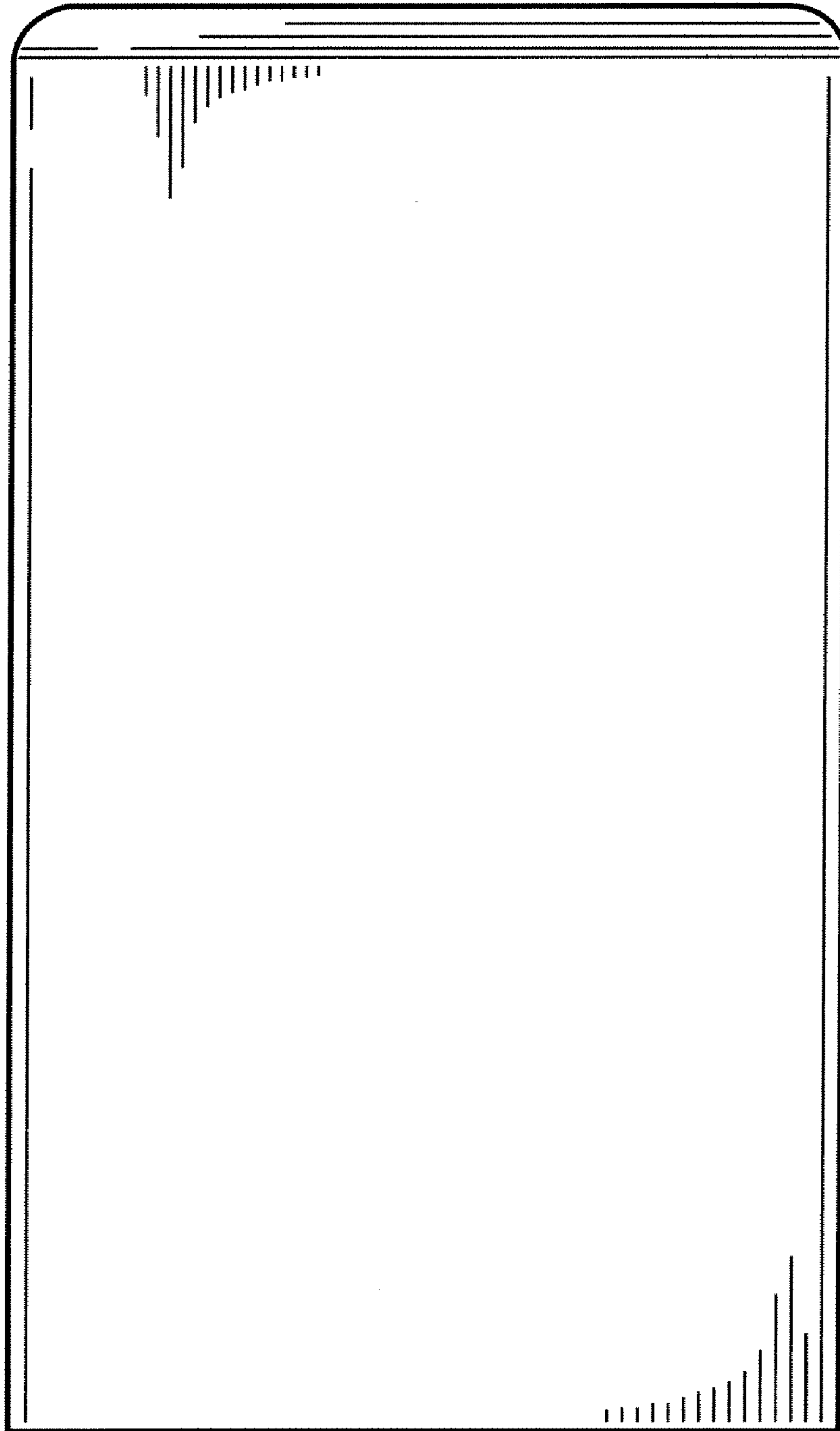

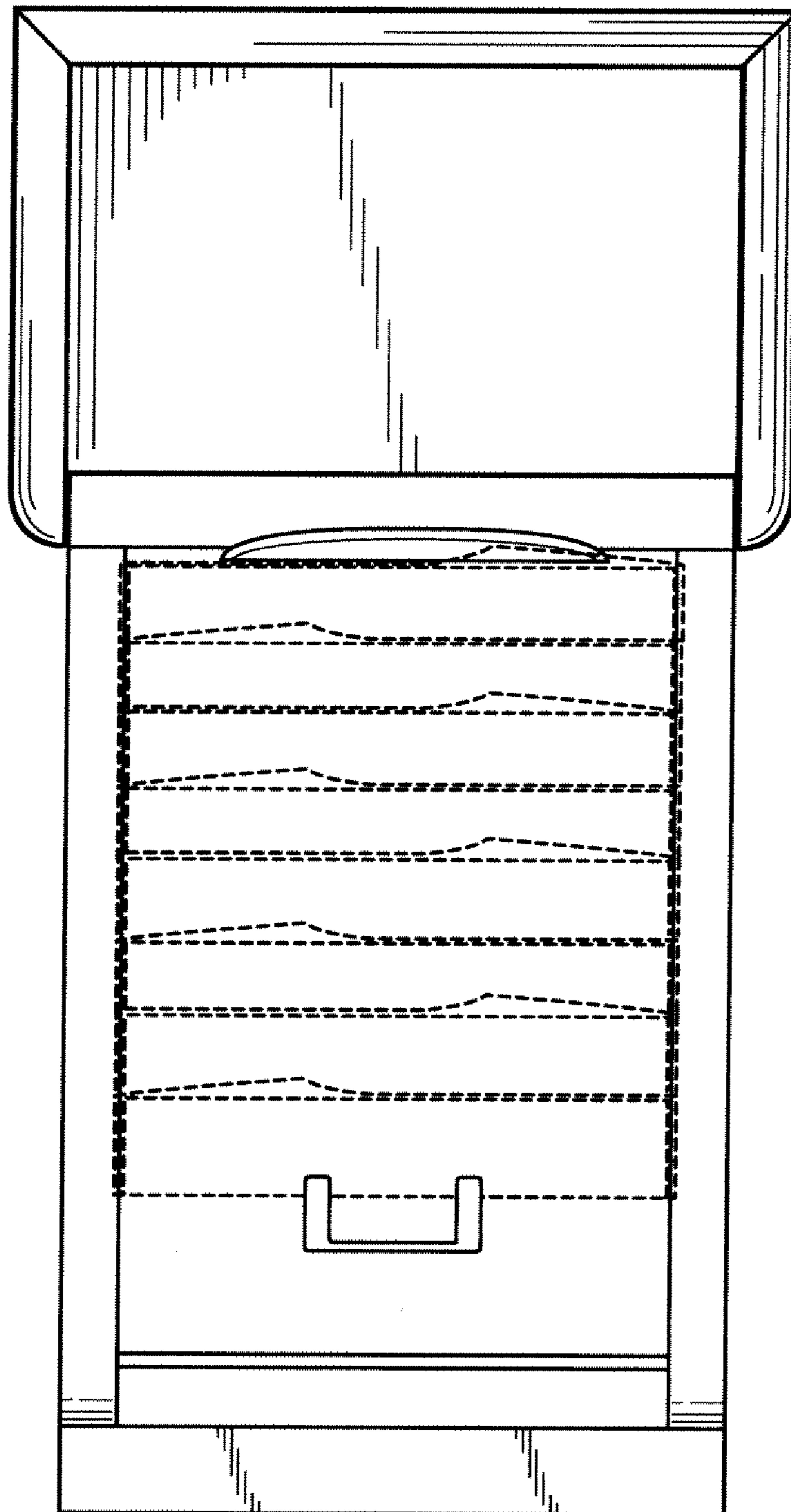

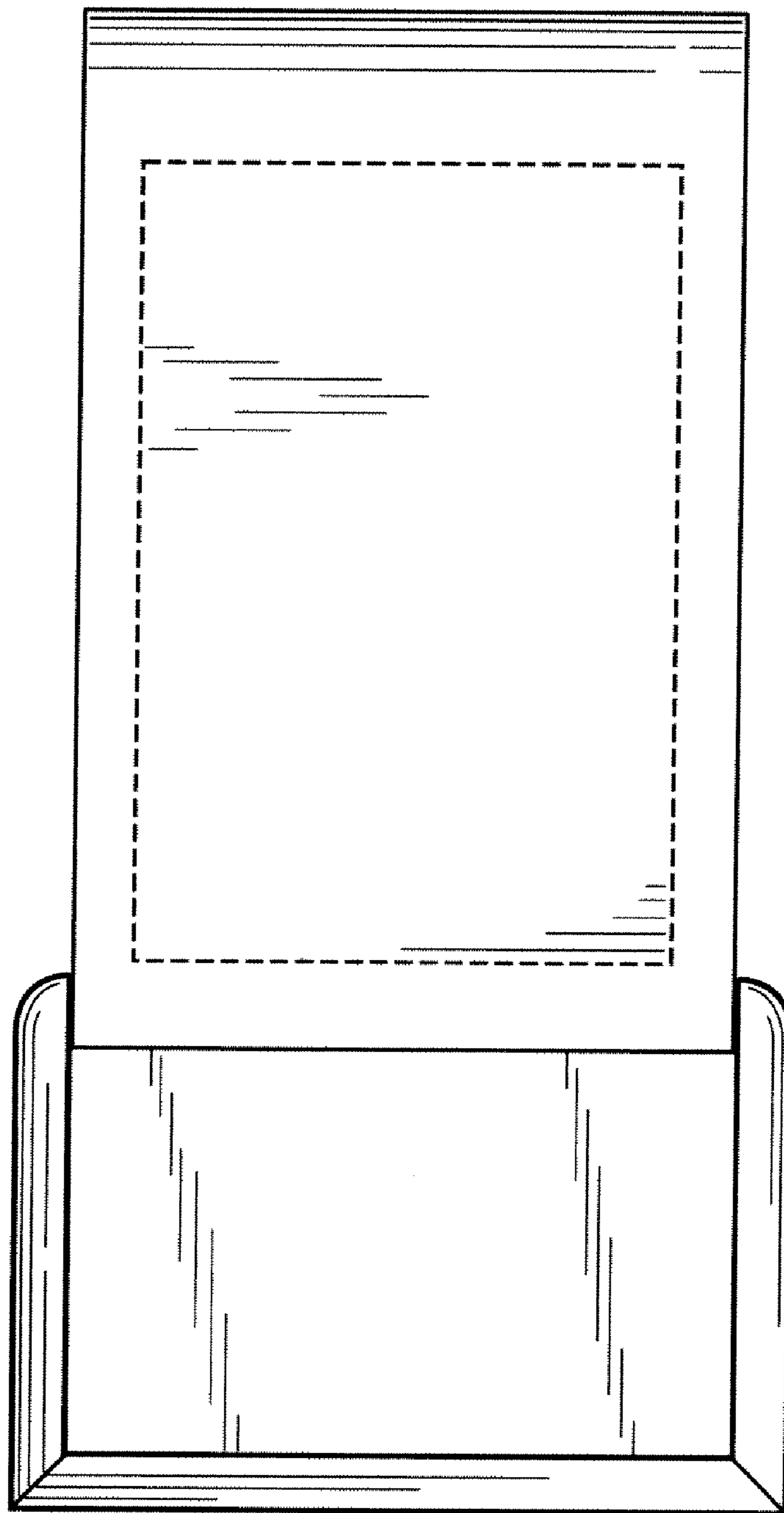

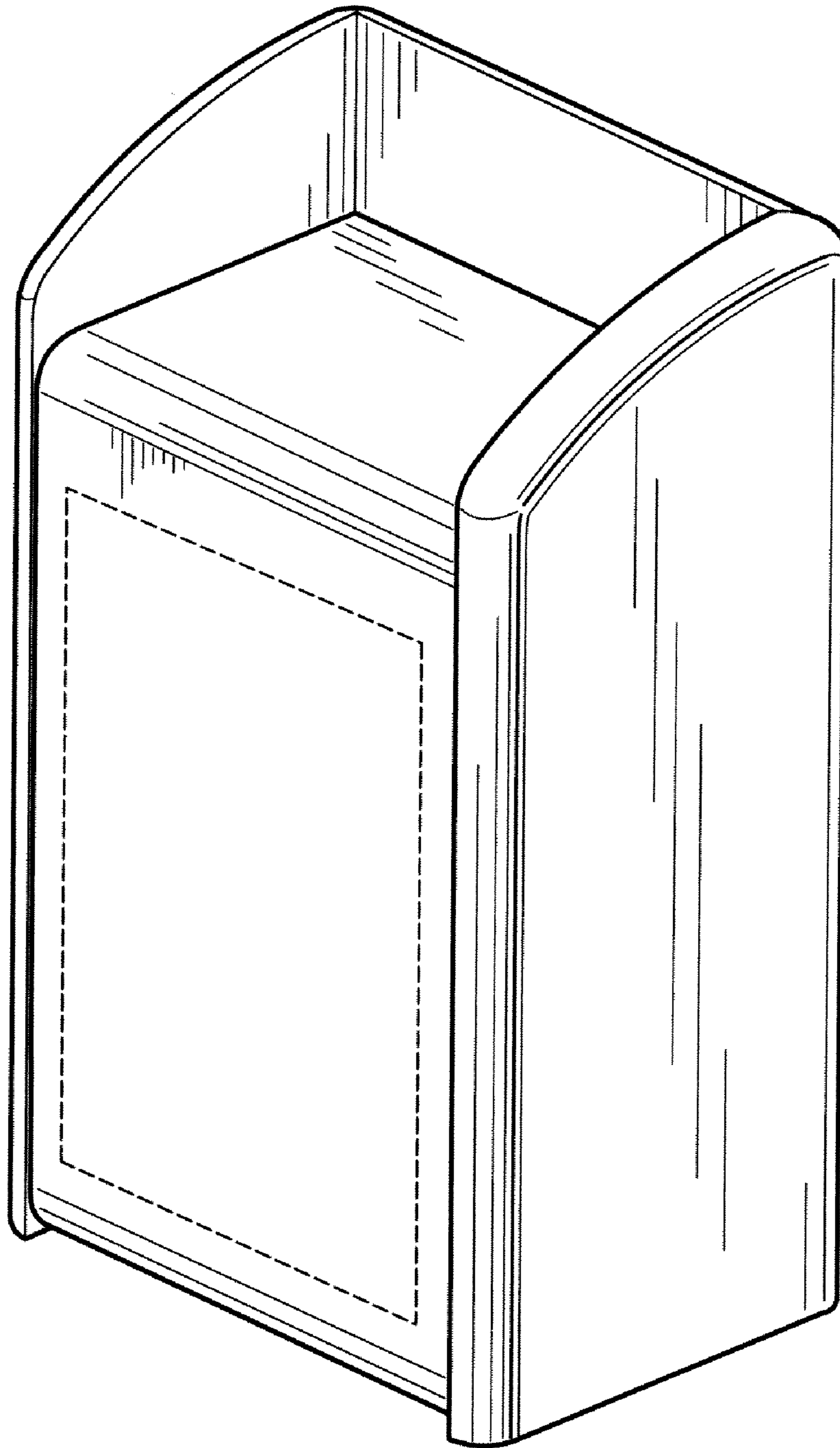

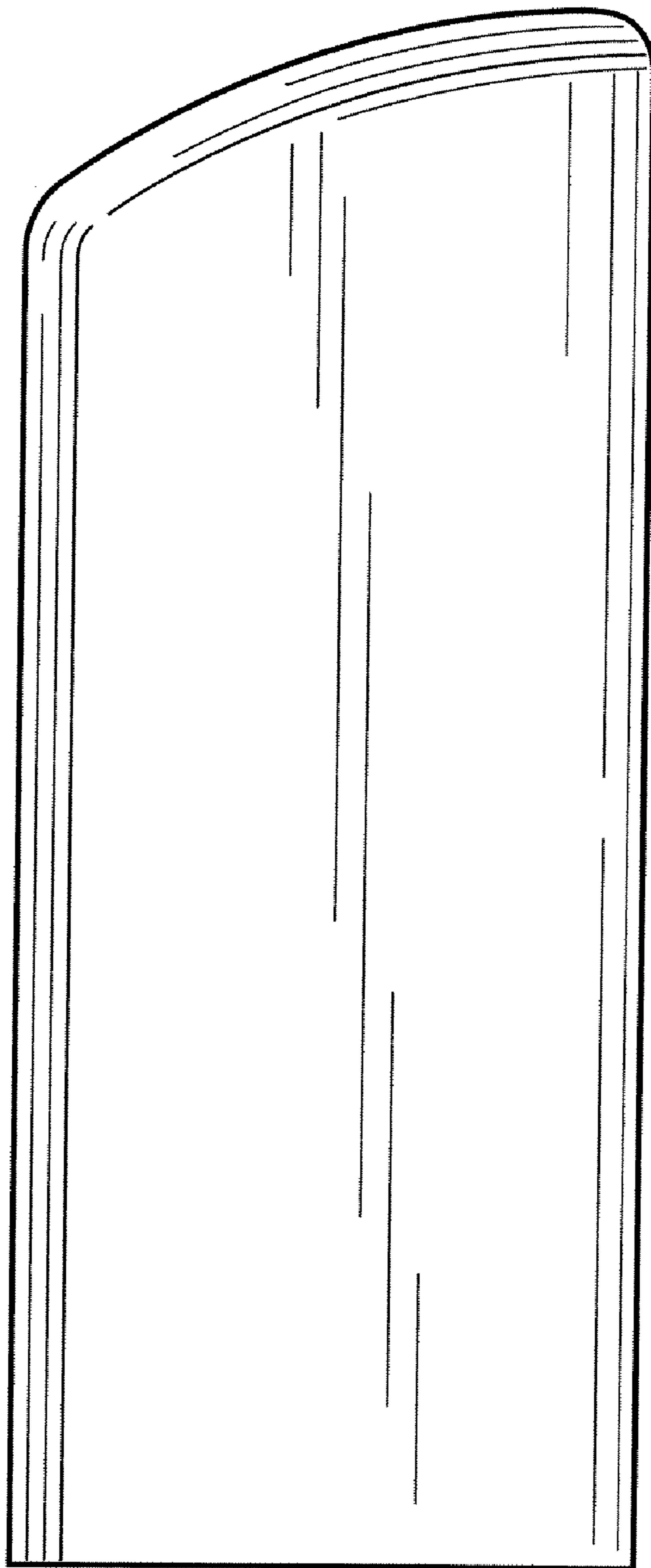

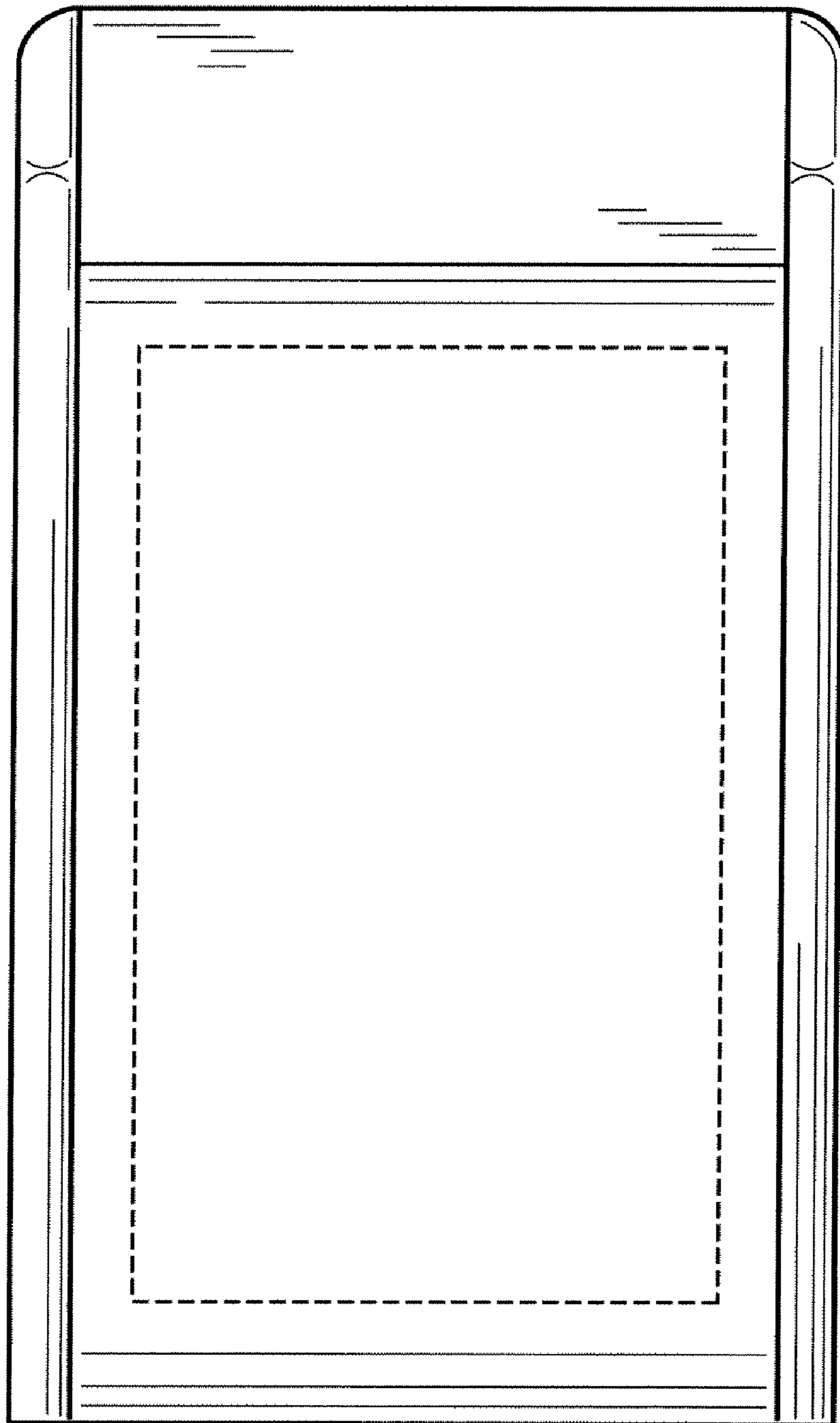

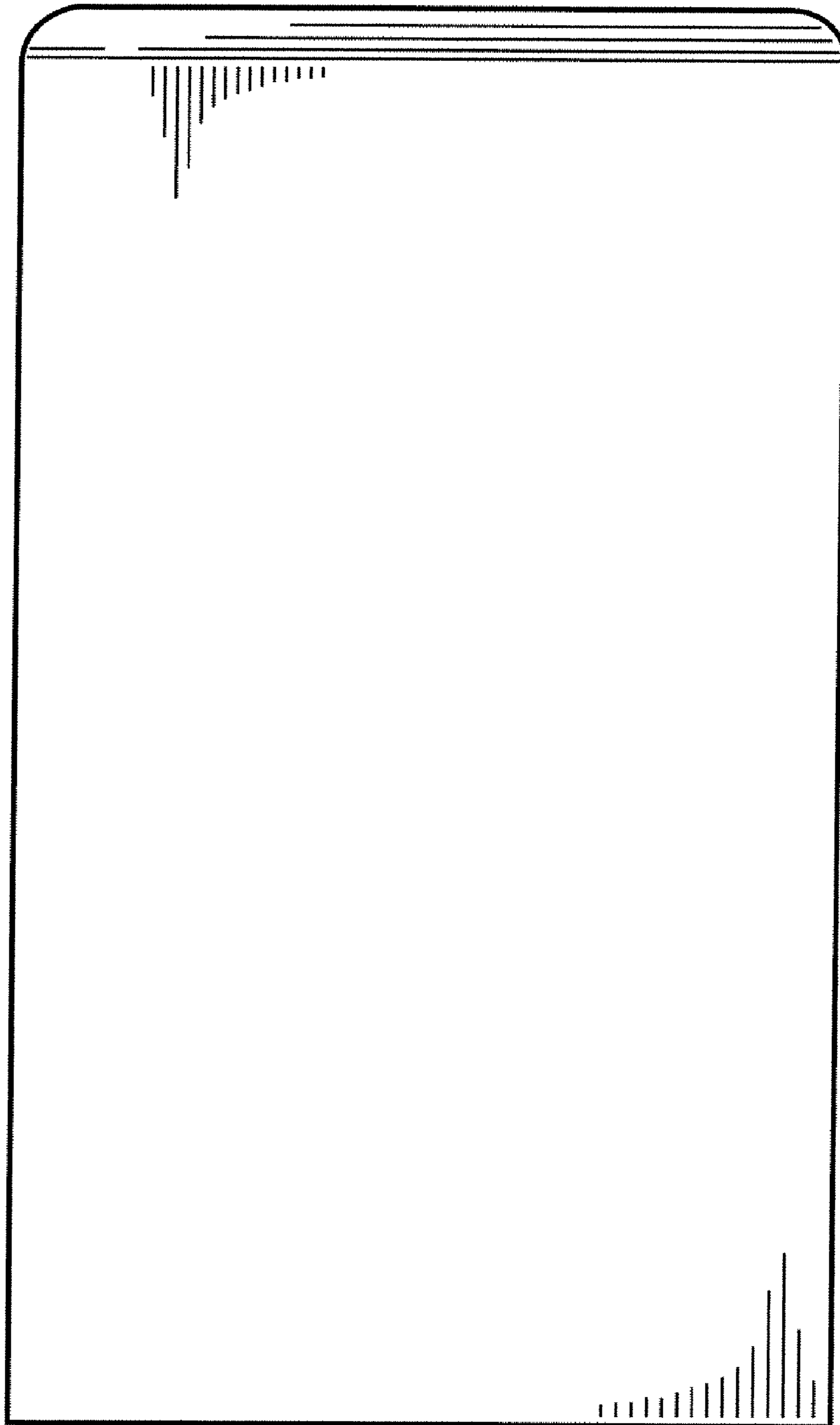

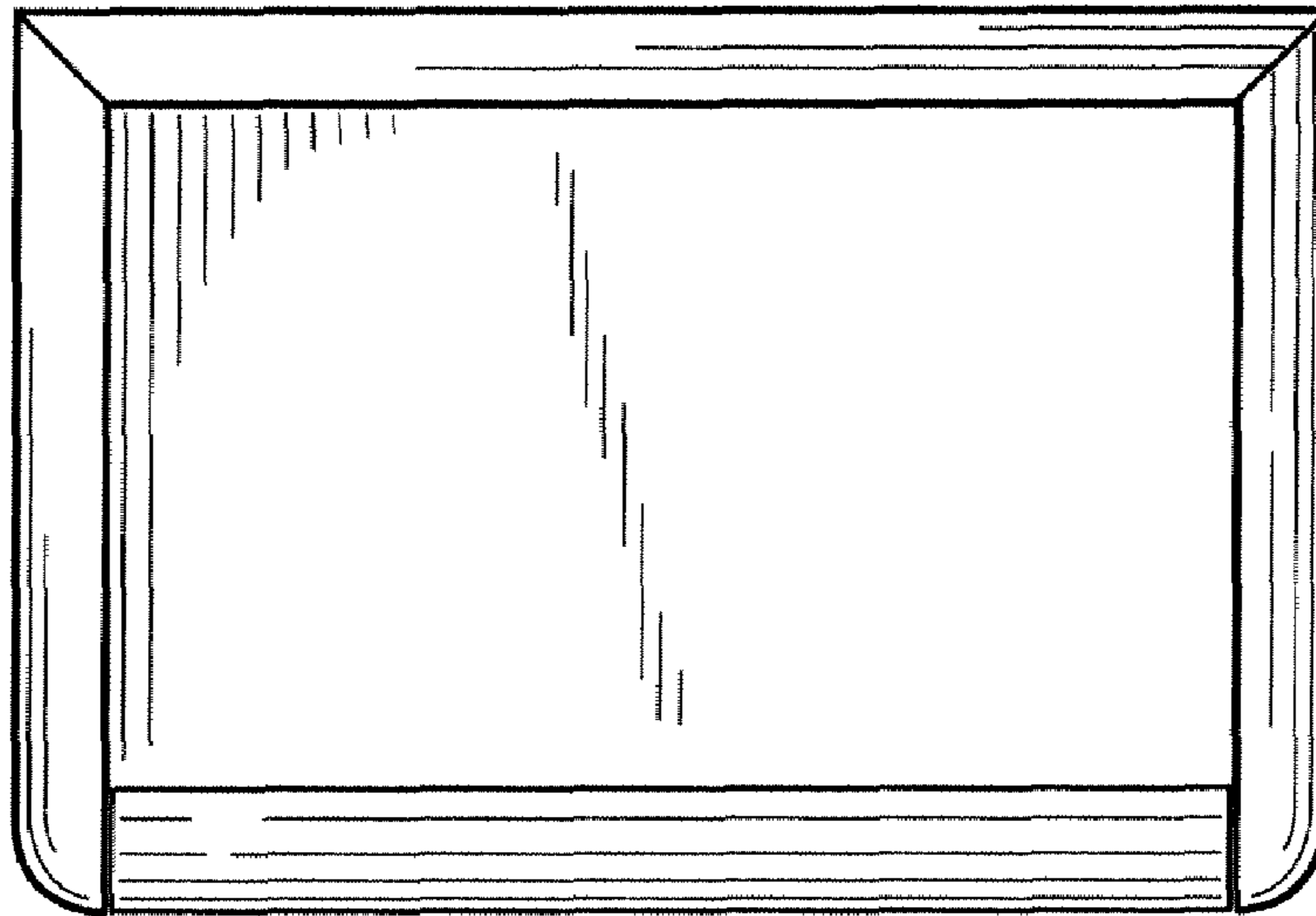
