FIG. 3 is a top view of the contoured massager shown in FIG. 1;

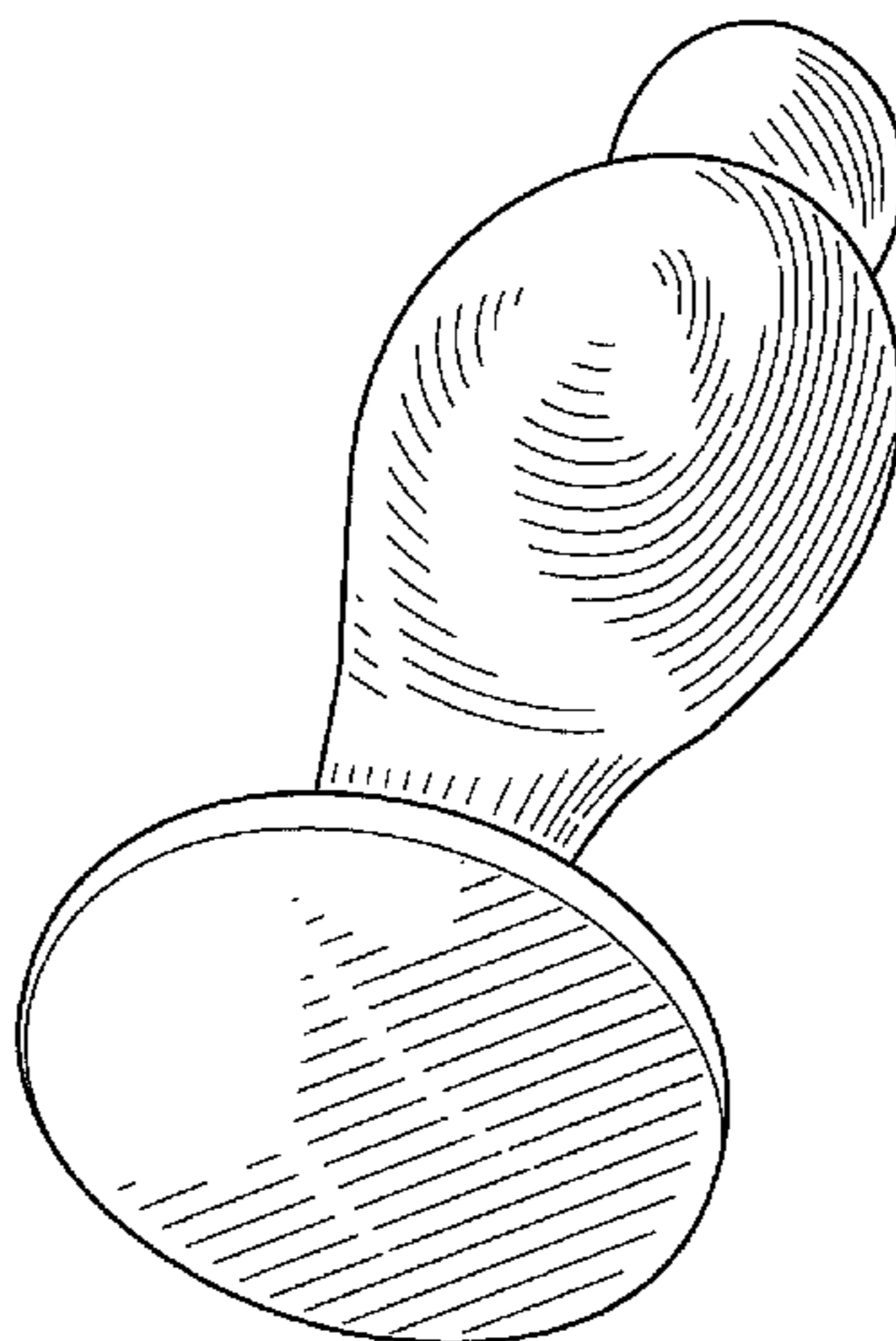
FIG. 4 is front view of the contoured massager shown in FIG. 1;

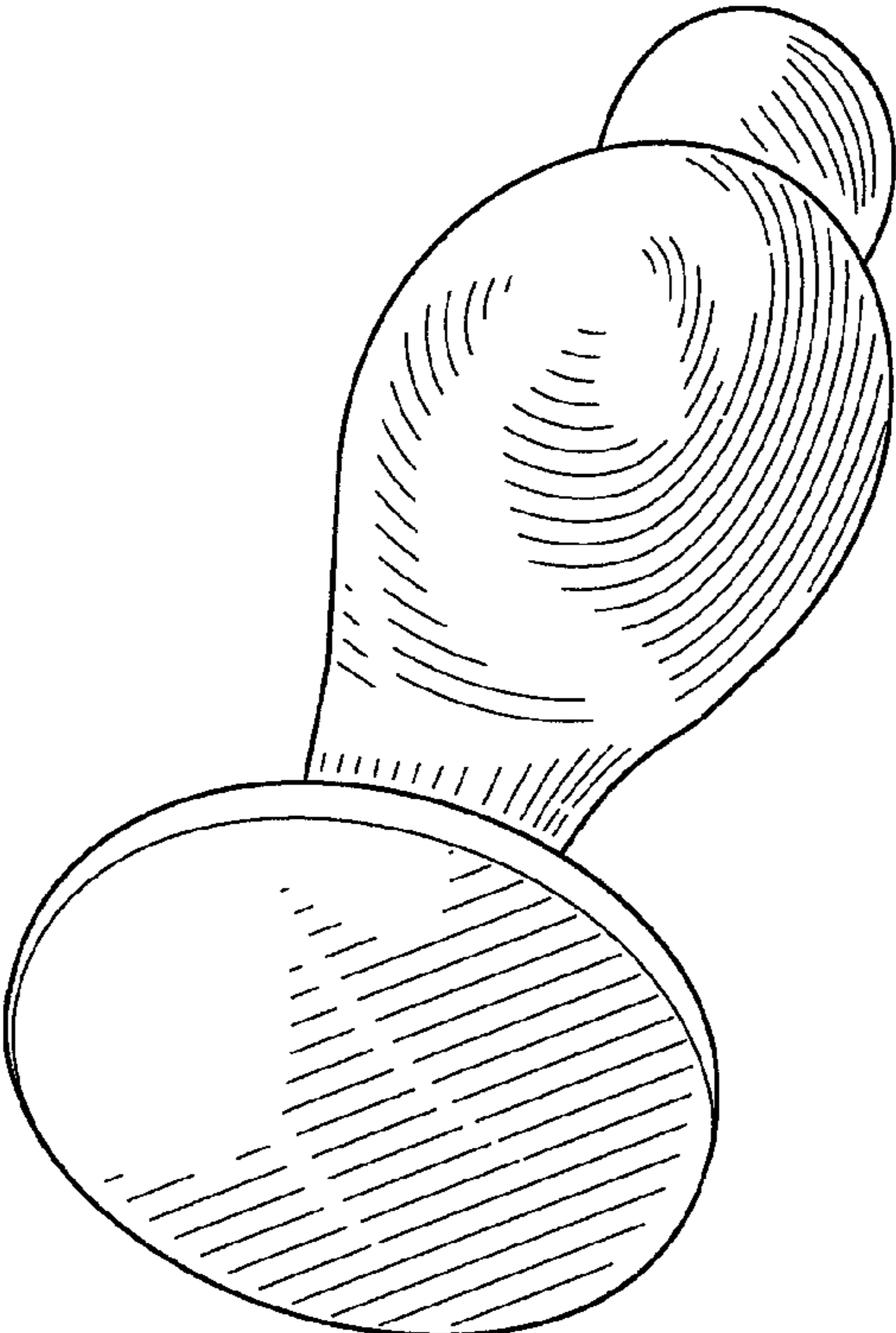

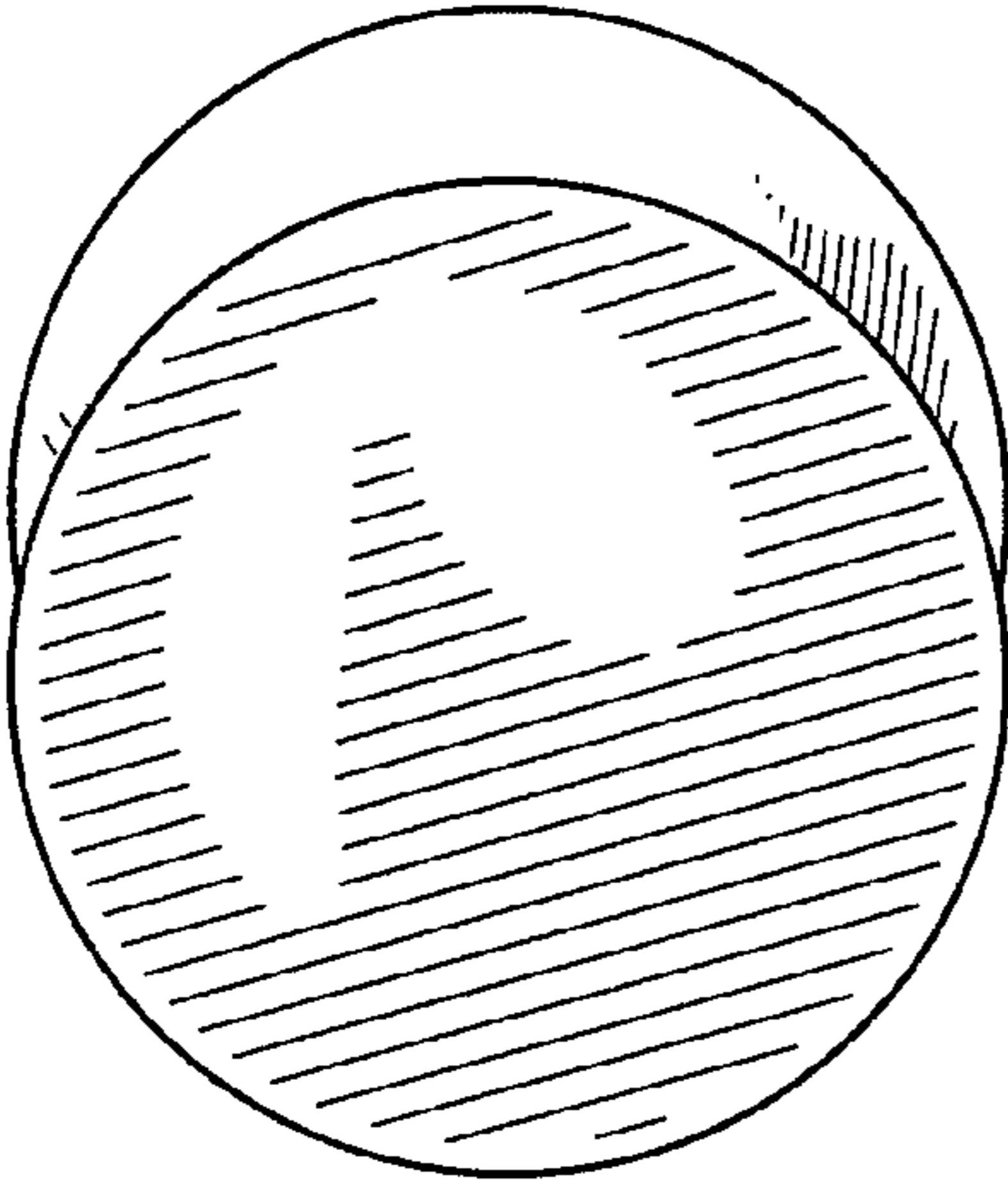

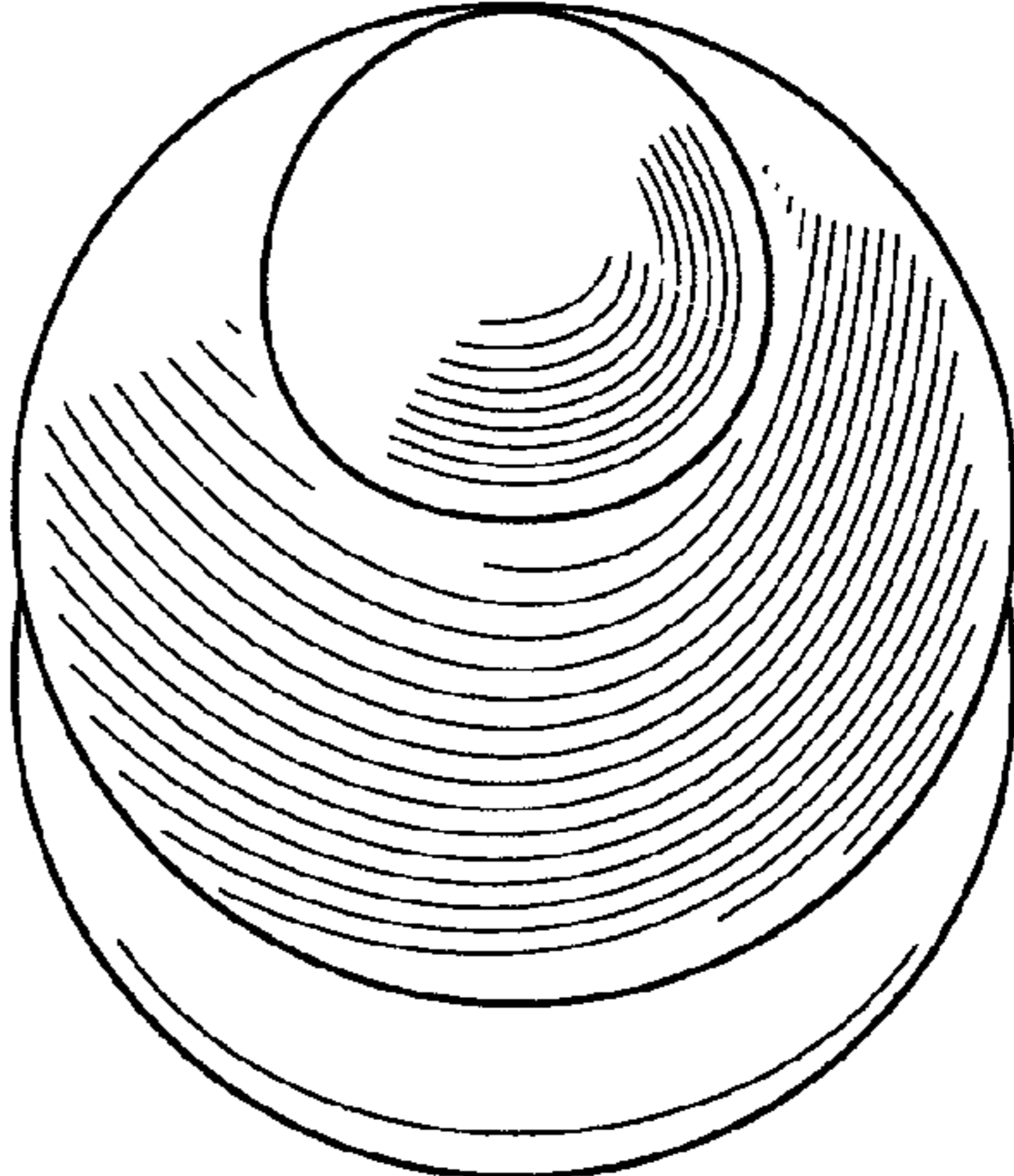

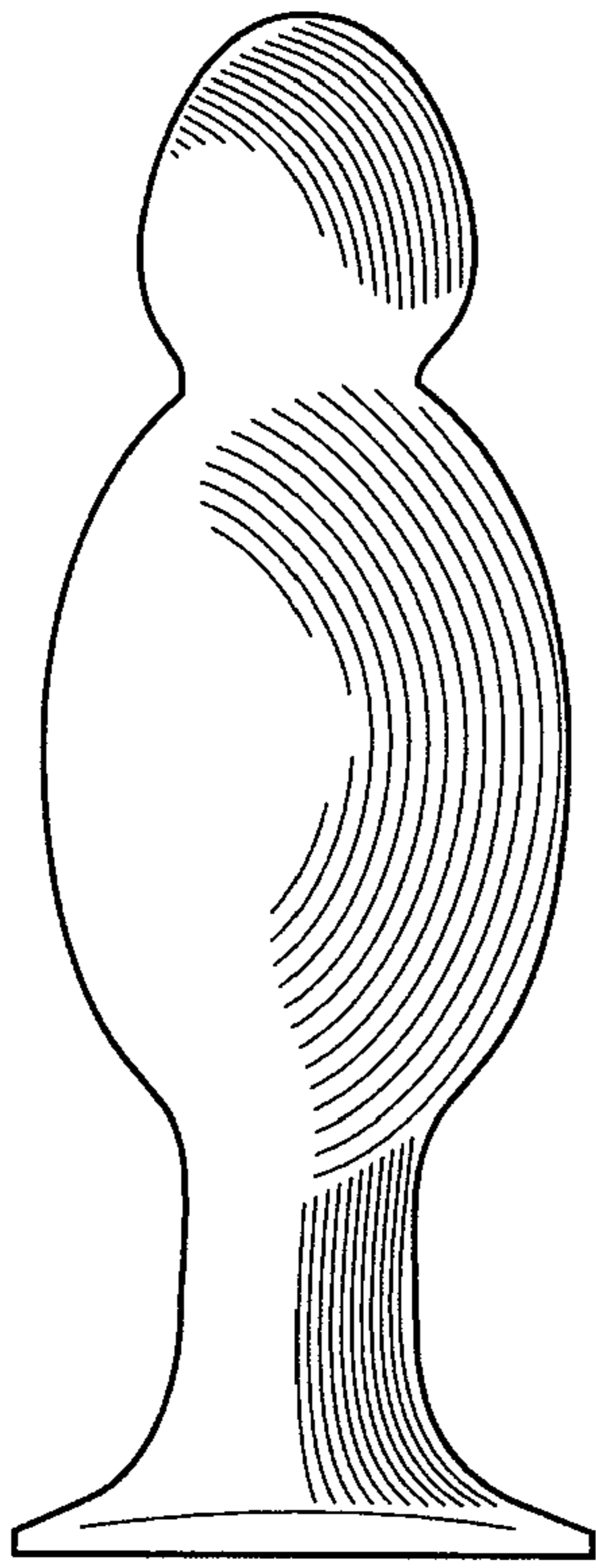

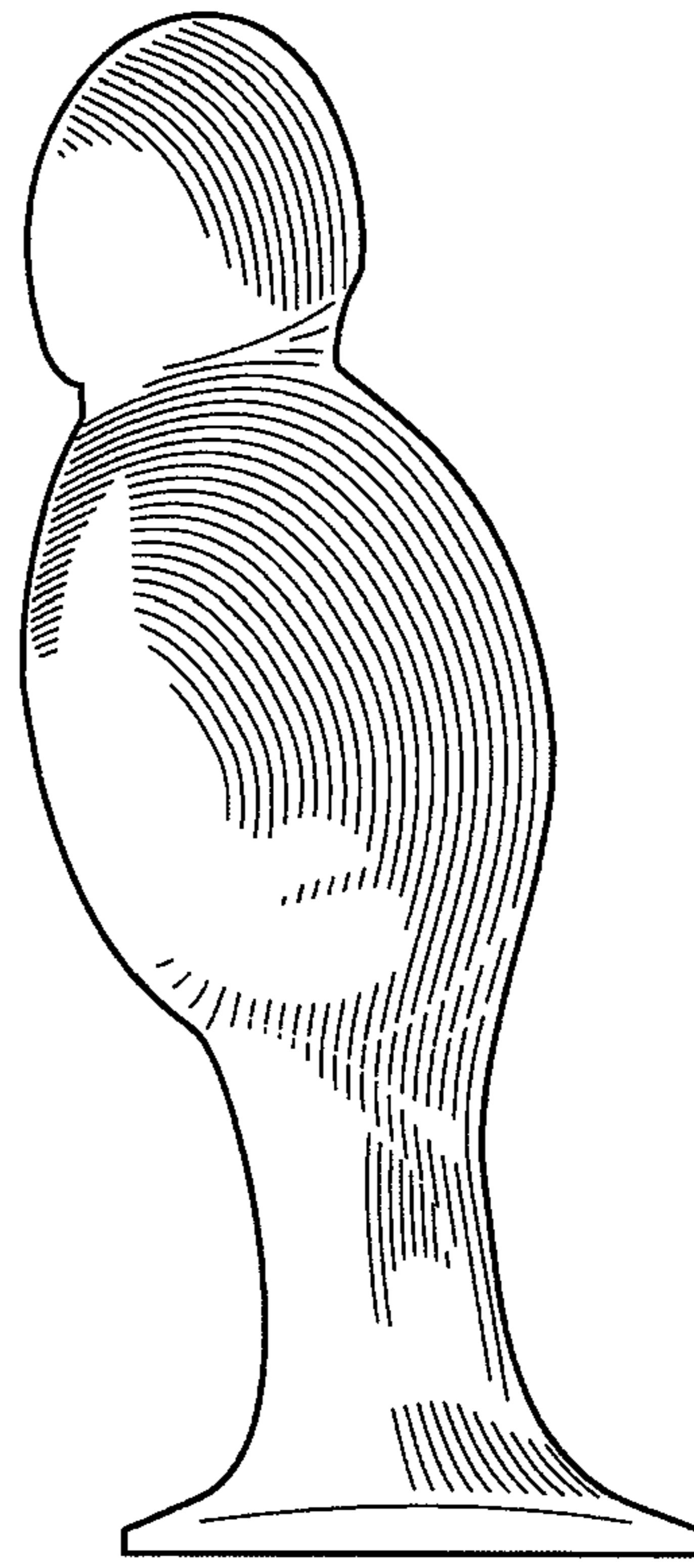

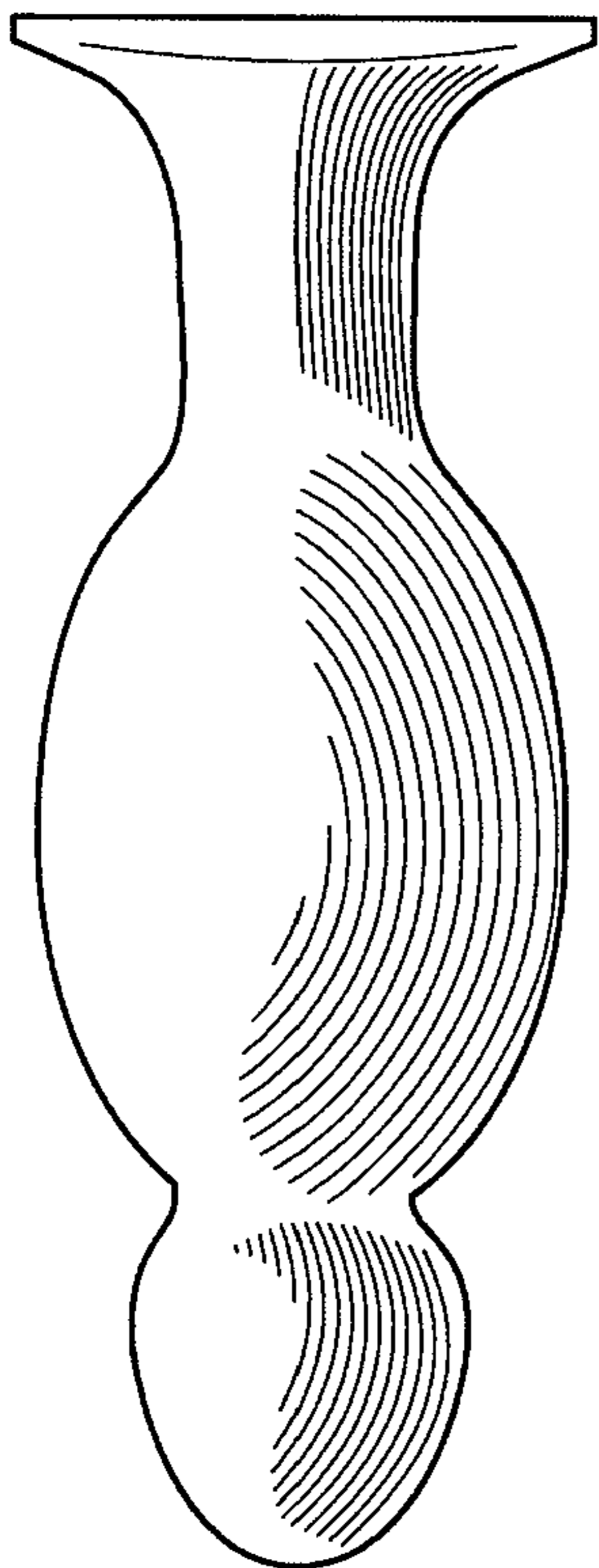

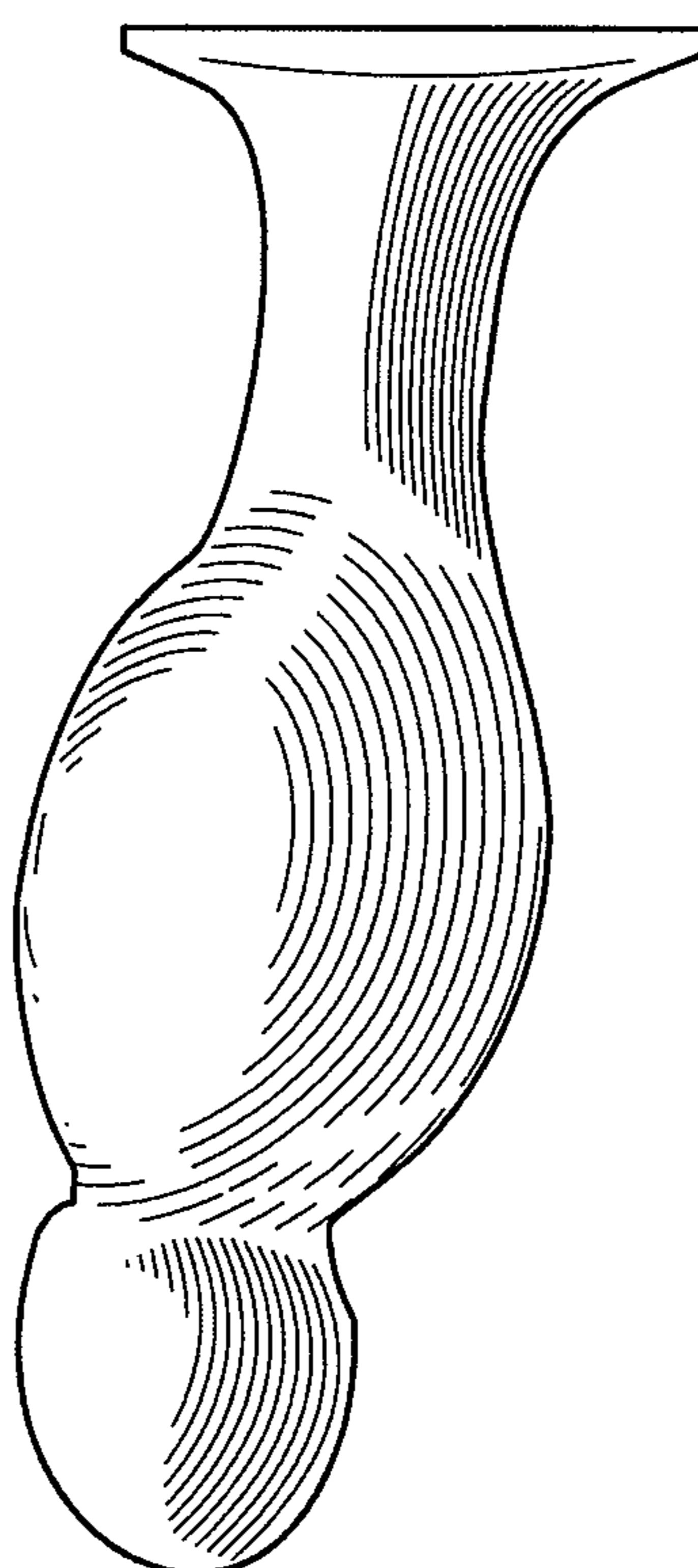
