FIG. 5 is a back view thereof;

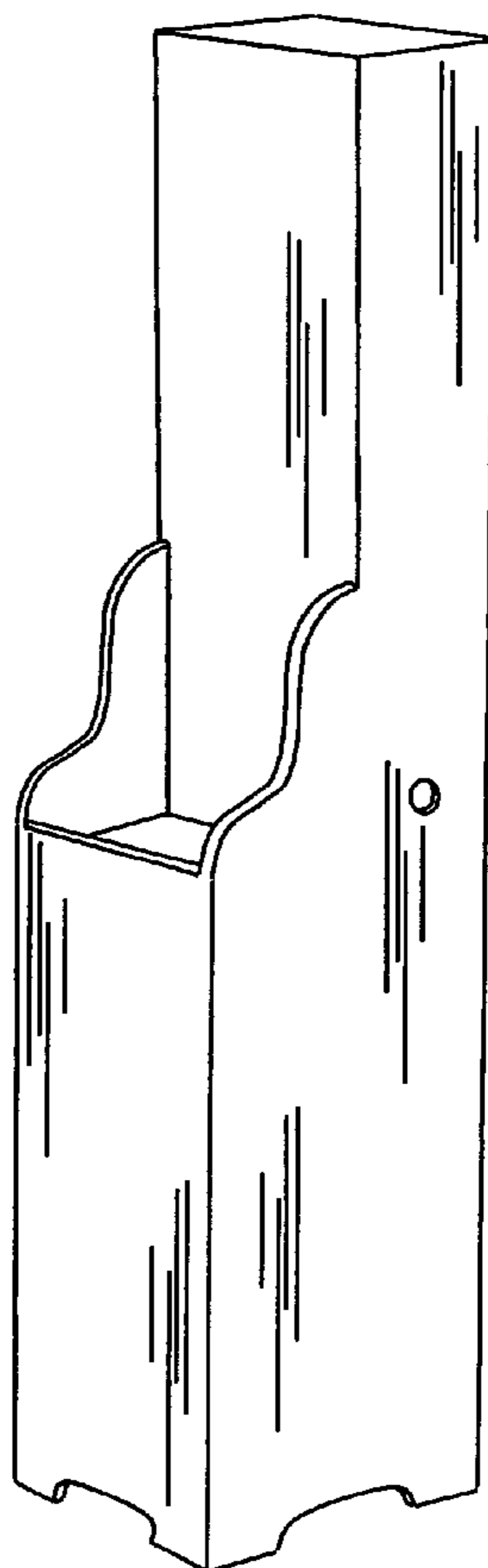
FIG. 6 is a left, side-view thereof;

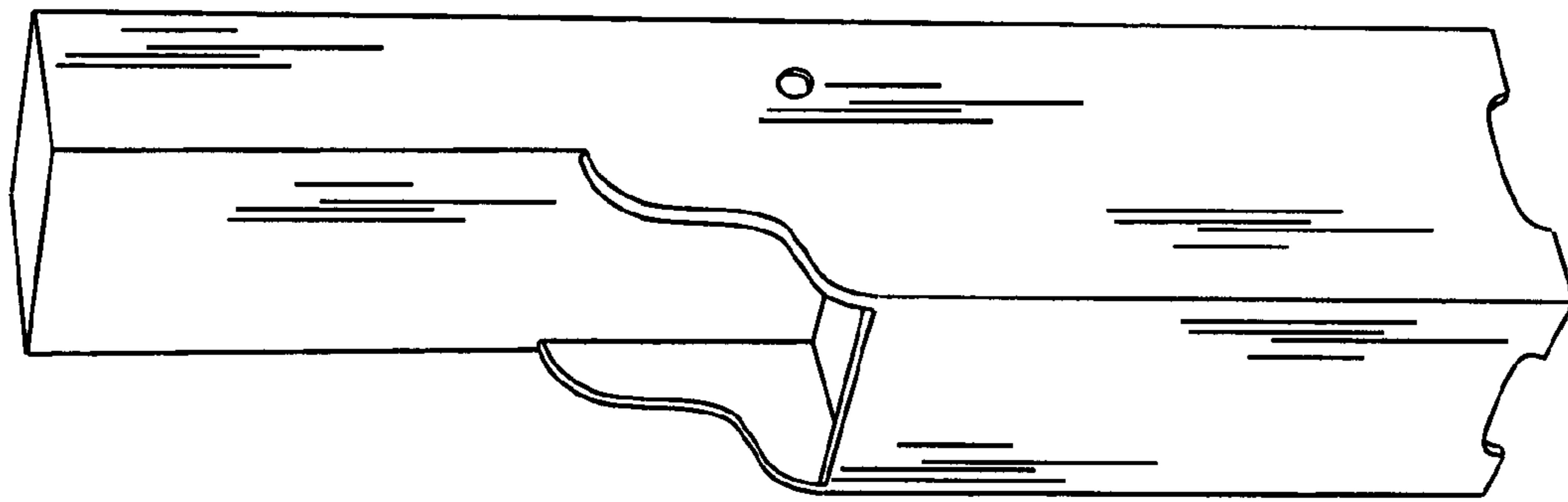

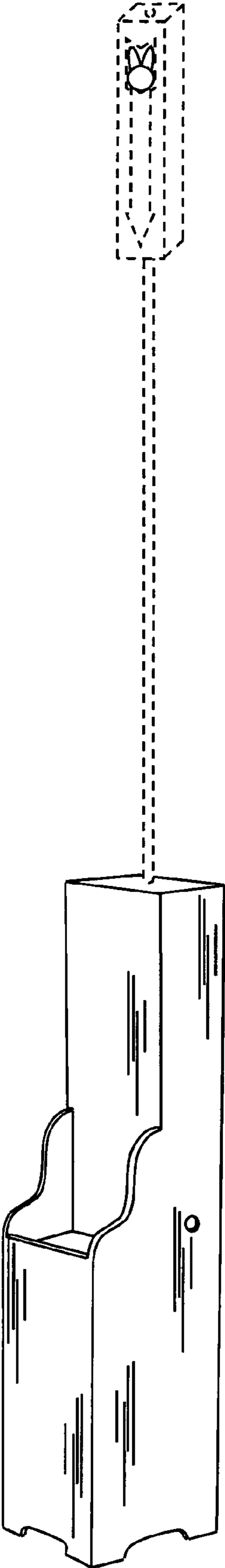

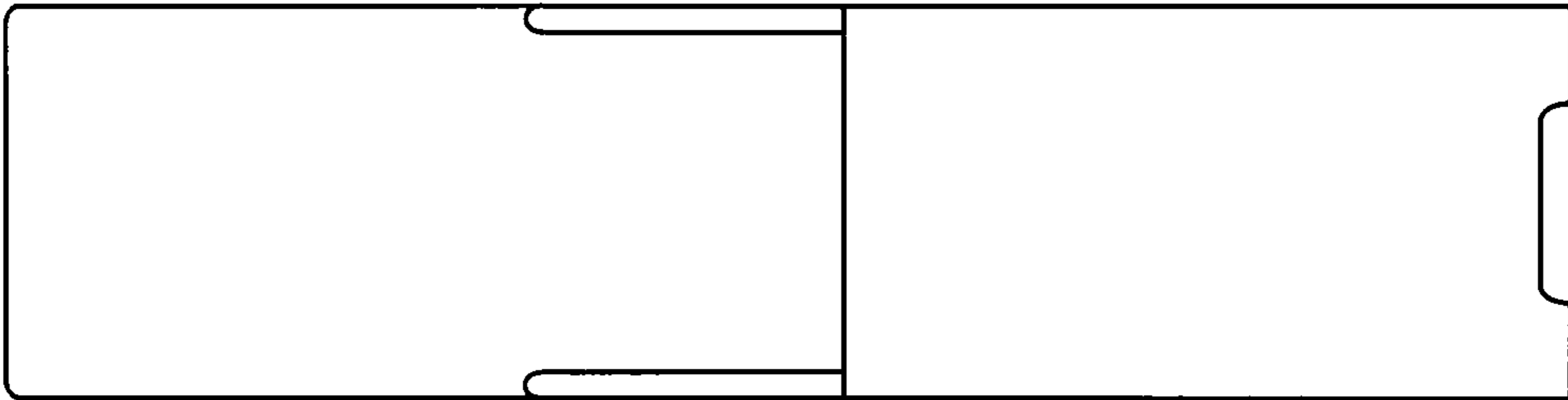

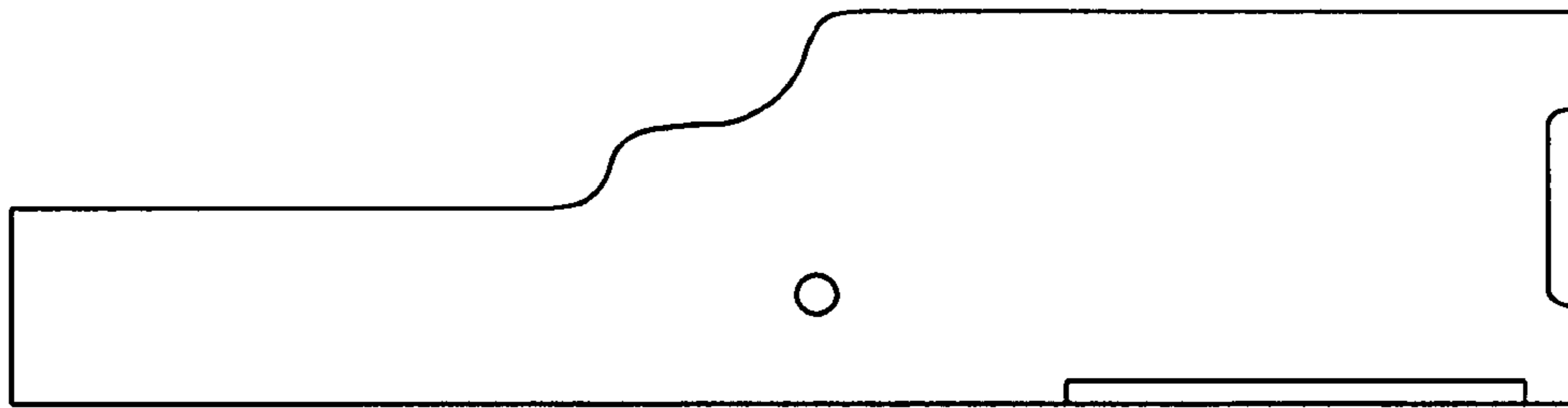

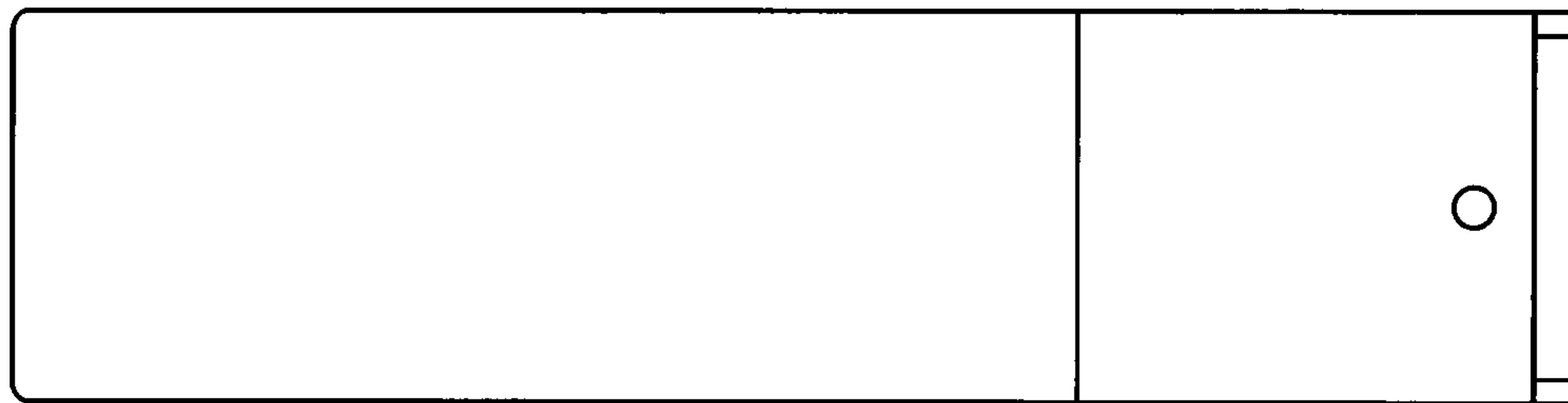

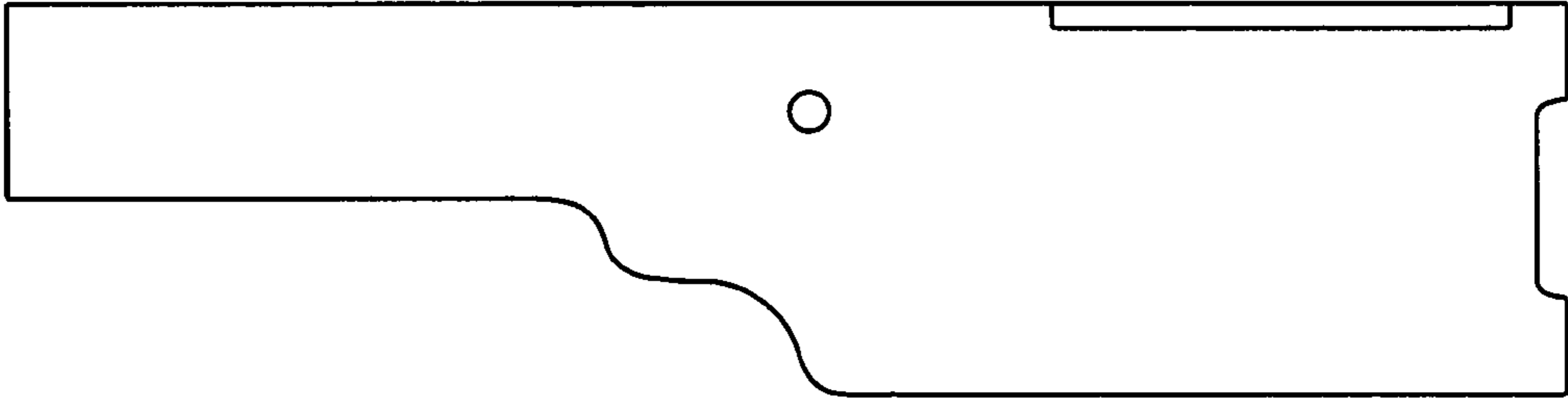

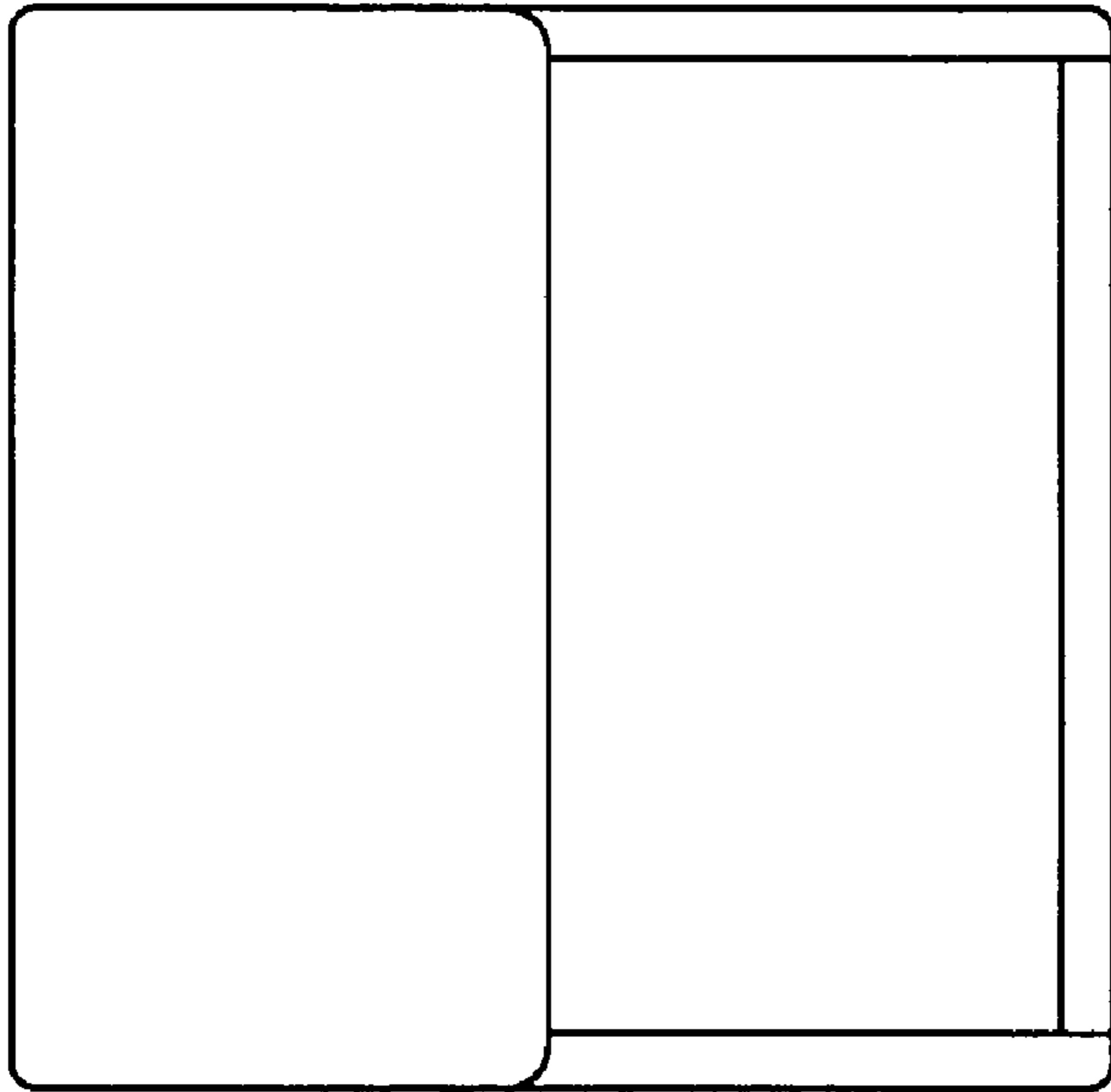

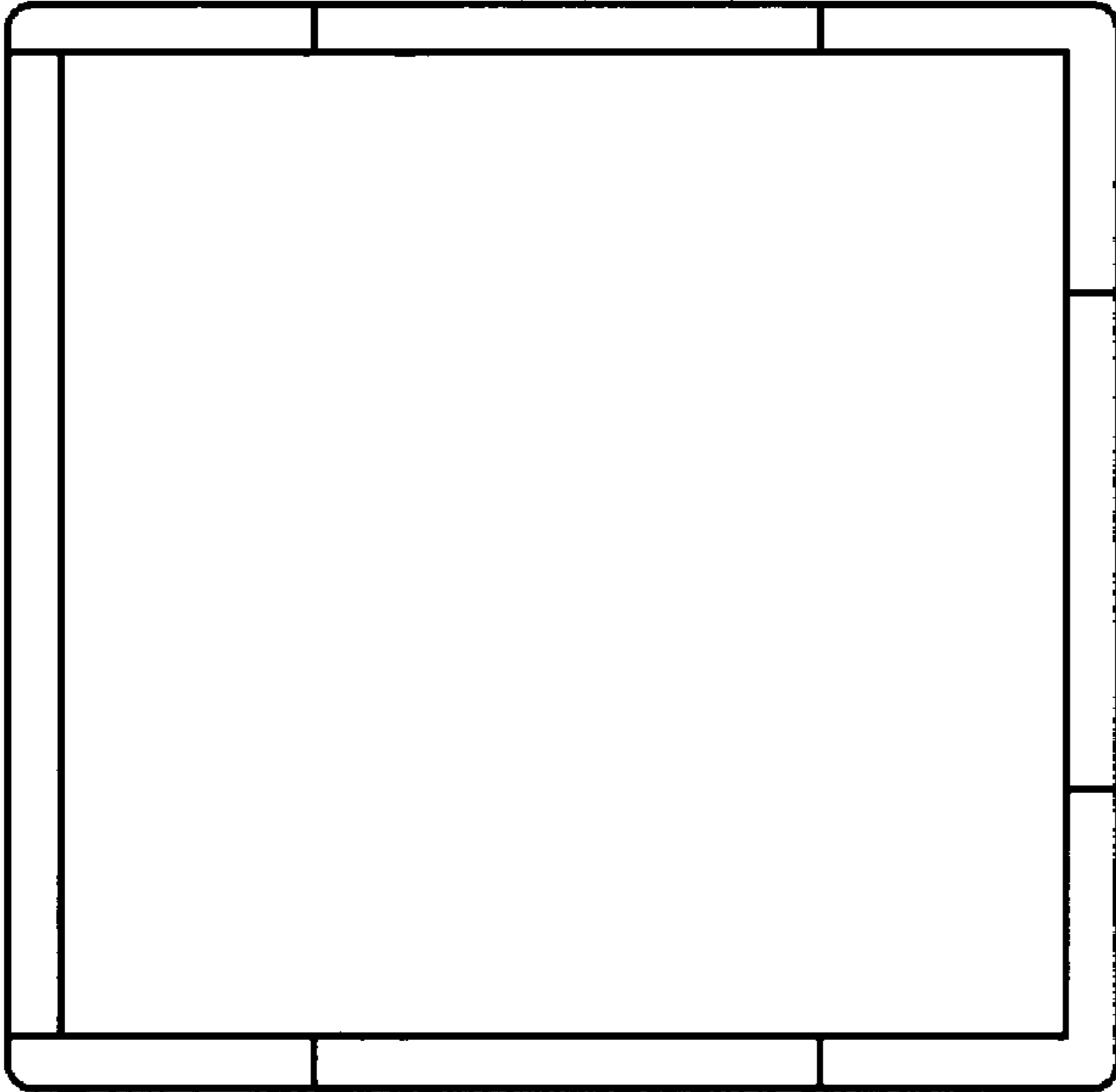
