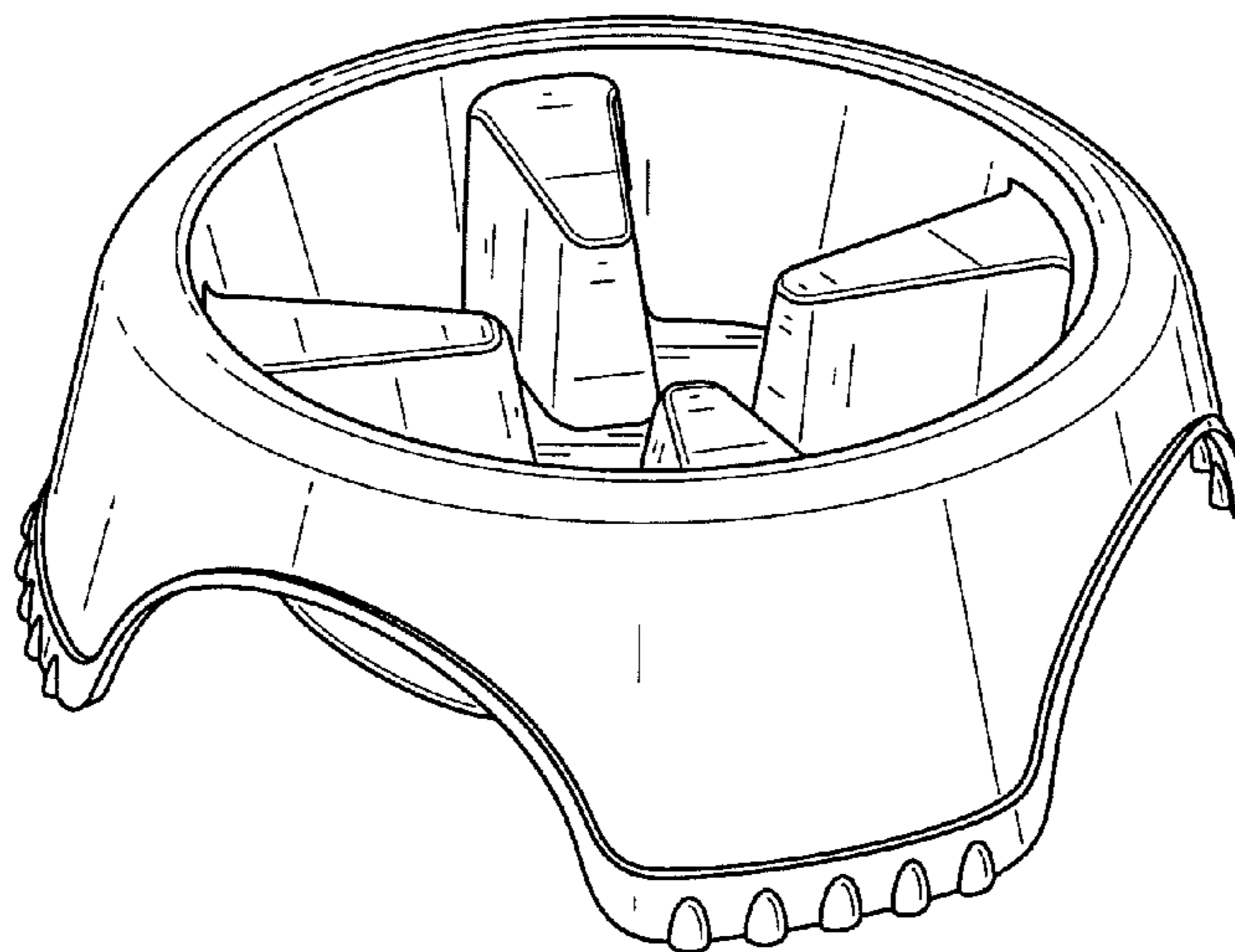
(57) **CLAIM**

The ornamental design for a bowl, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the bowl;
 FIG. 2 is a front view thereof, the rear, left-side, and right-side views being identical to the front view;
 FIG. 3 is an intermediate view thereof, the intermediate view being between the front and left-side views; and,
 FIG. 4 is a top view thereof.

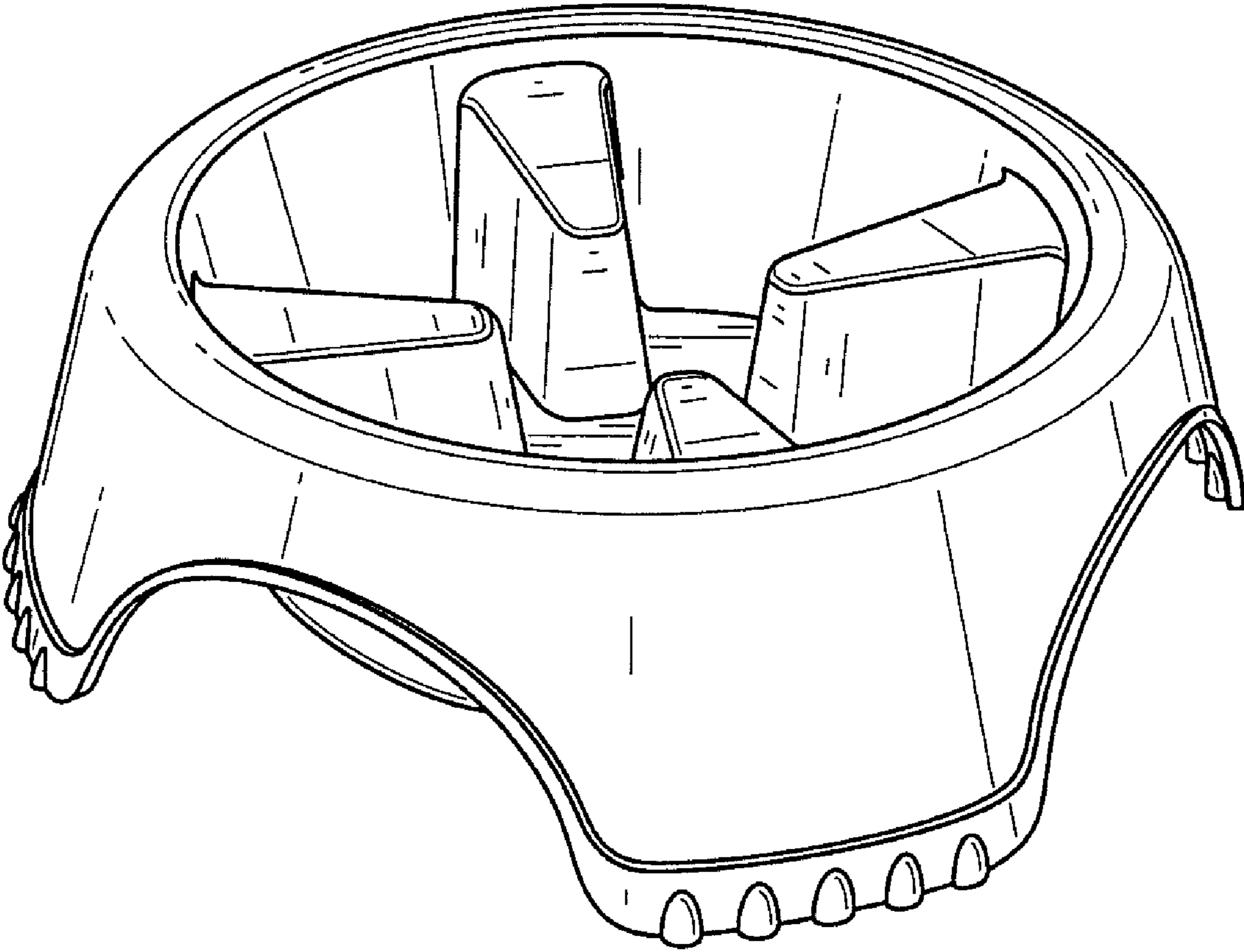

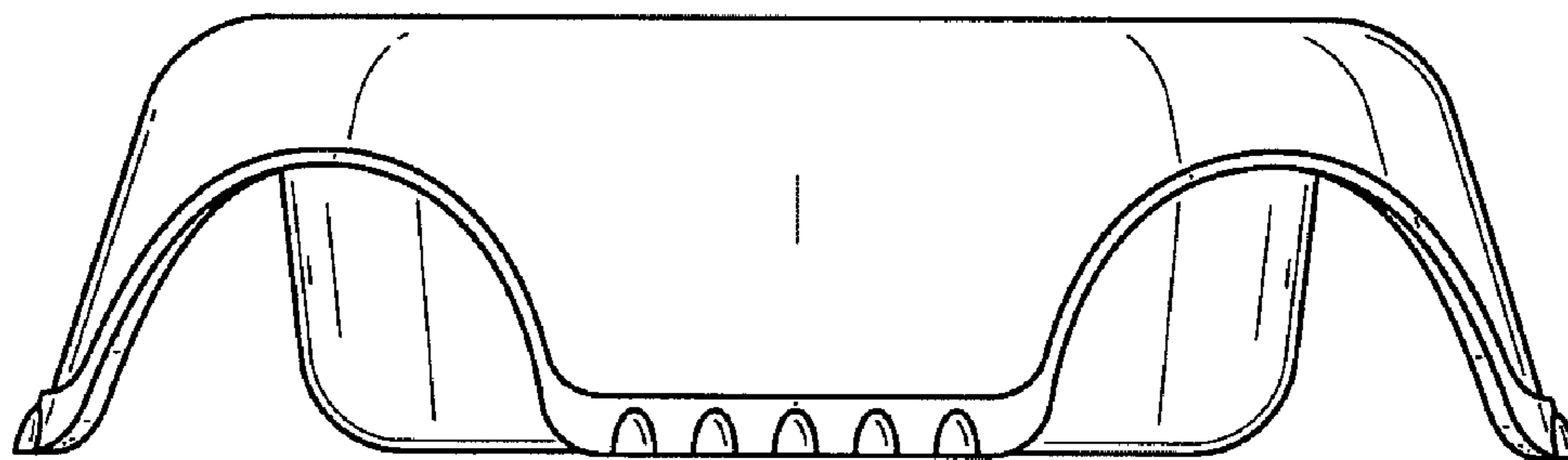

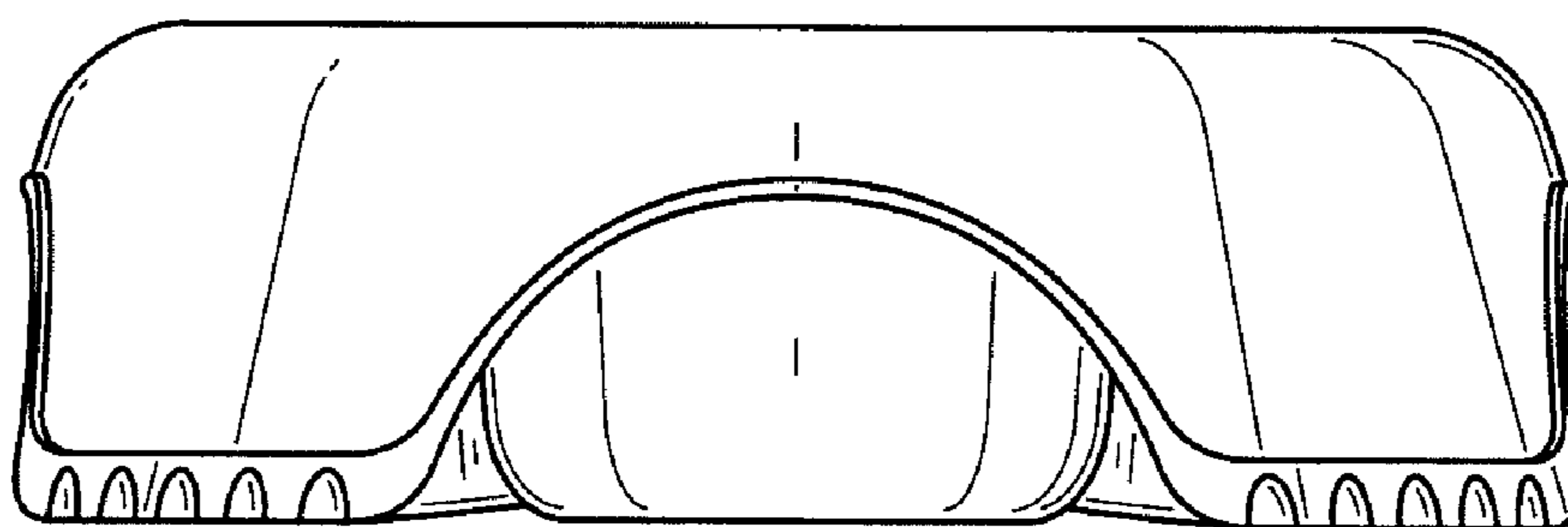

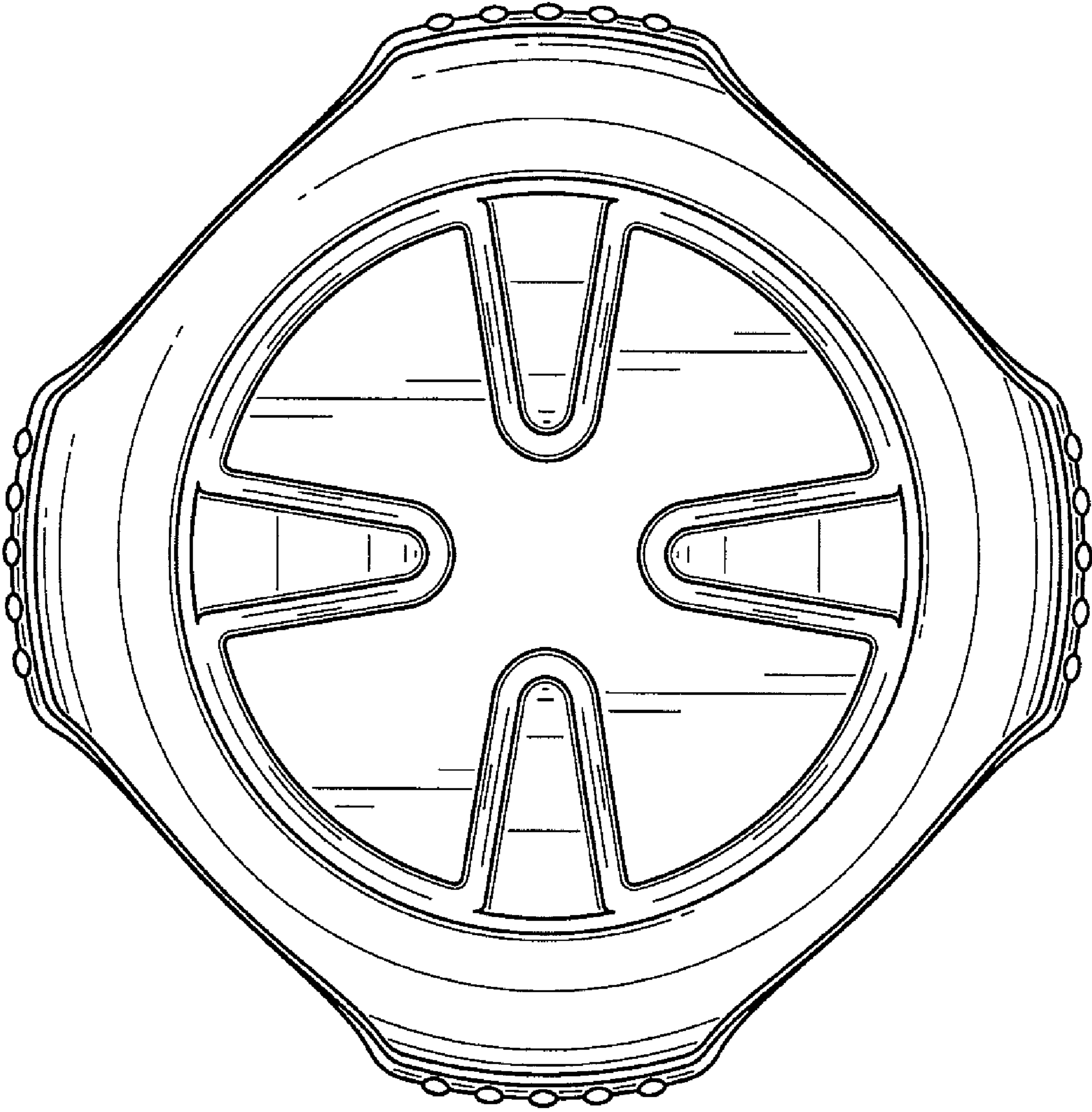
