FIG. 1 is a top front right side perspective view of a plinth showing my new design;

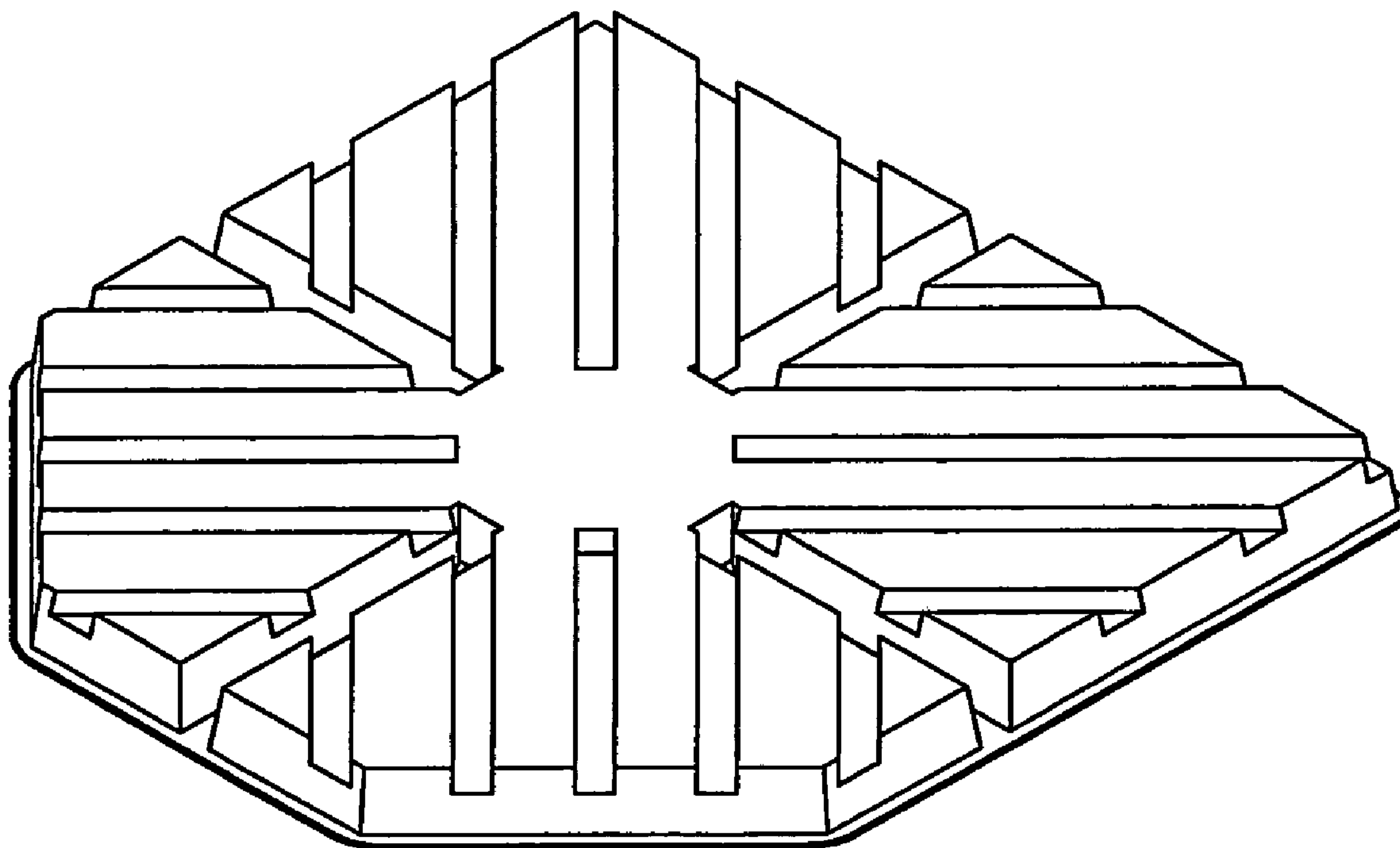
FIG. 2 is a top plan view thereof;

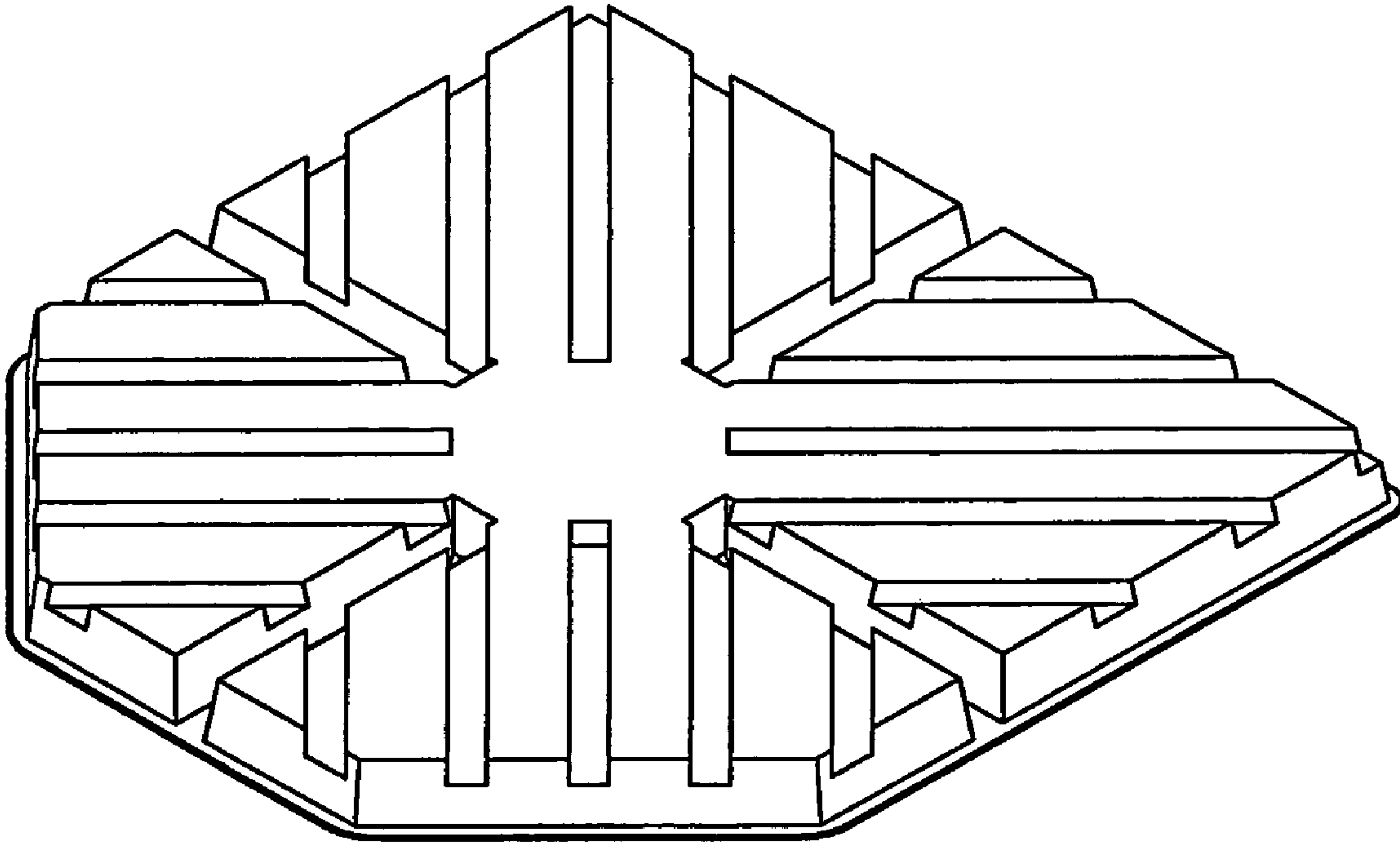

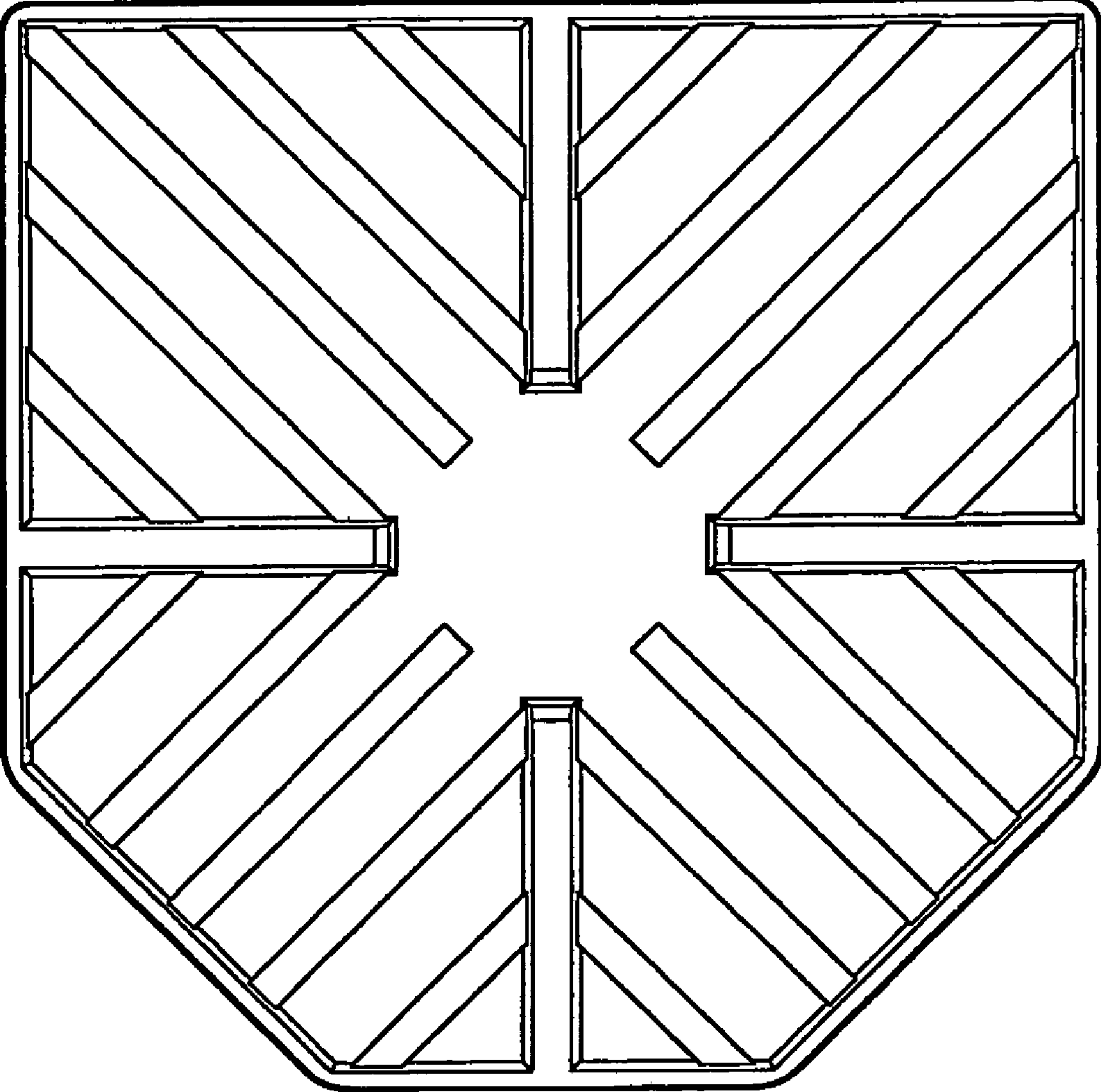

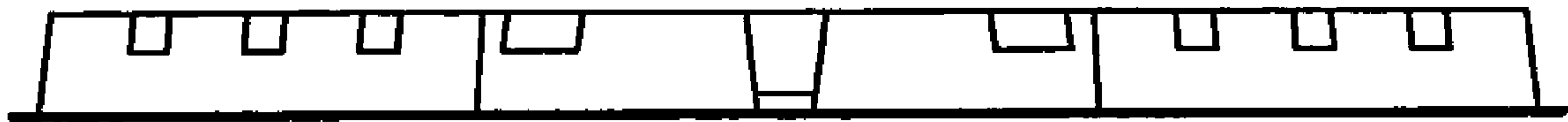

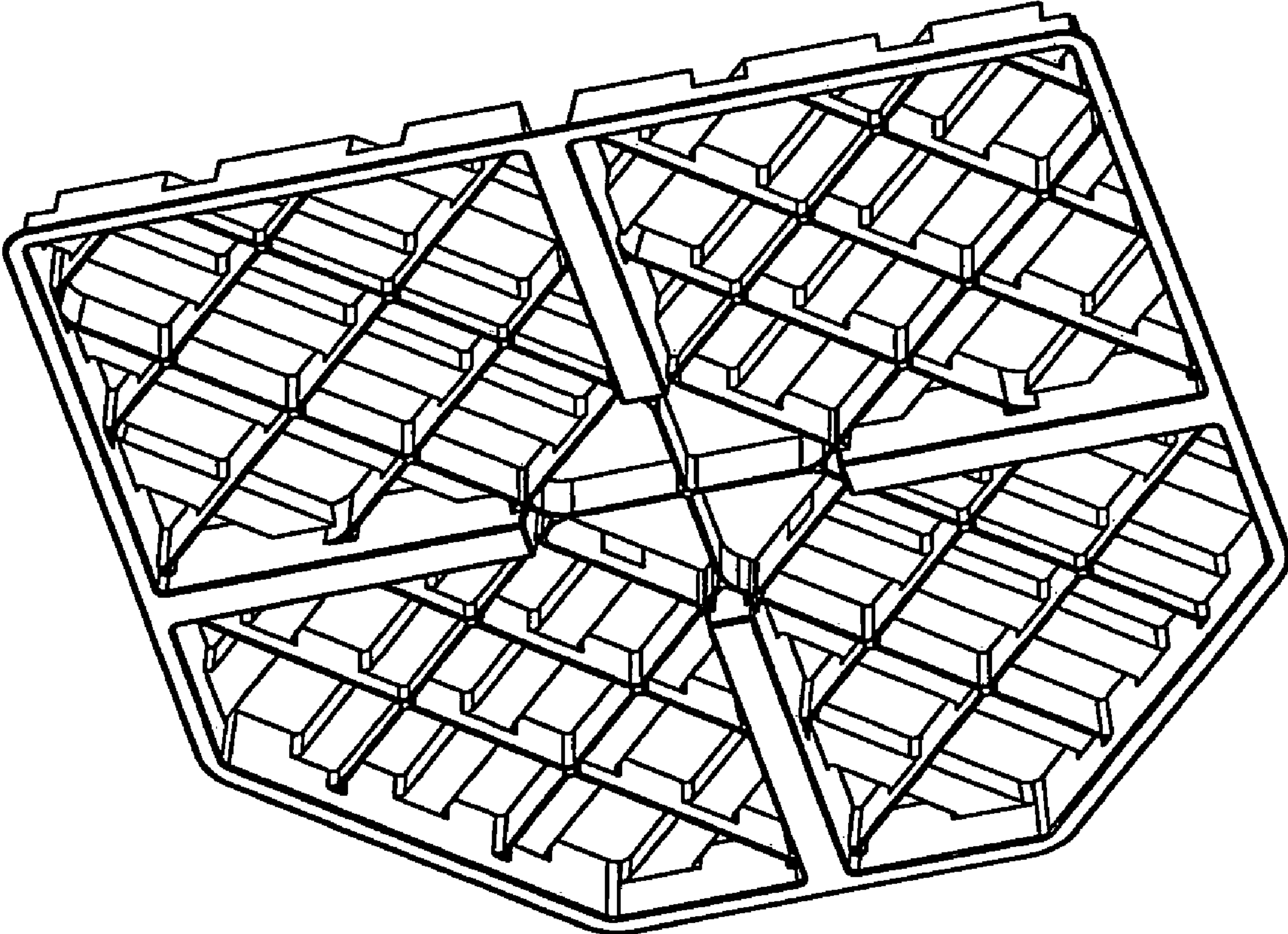

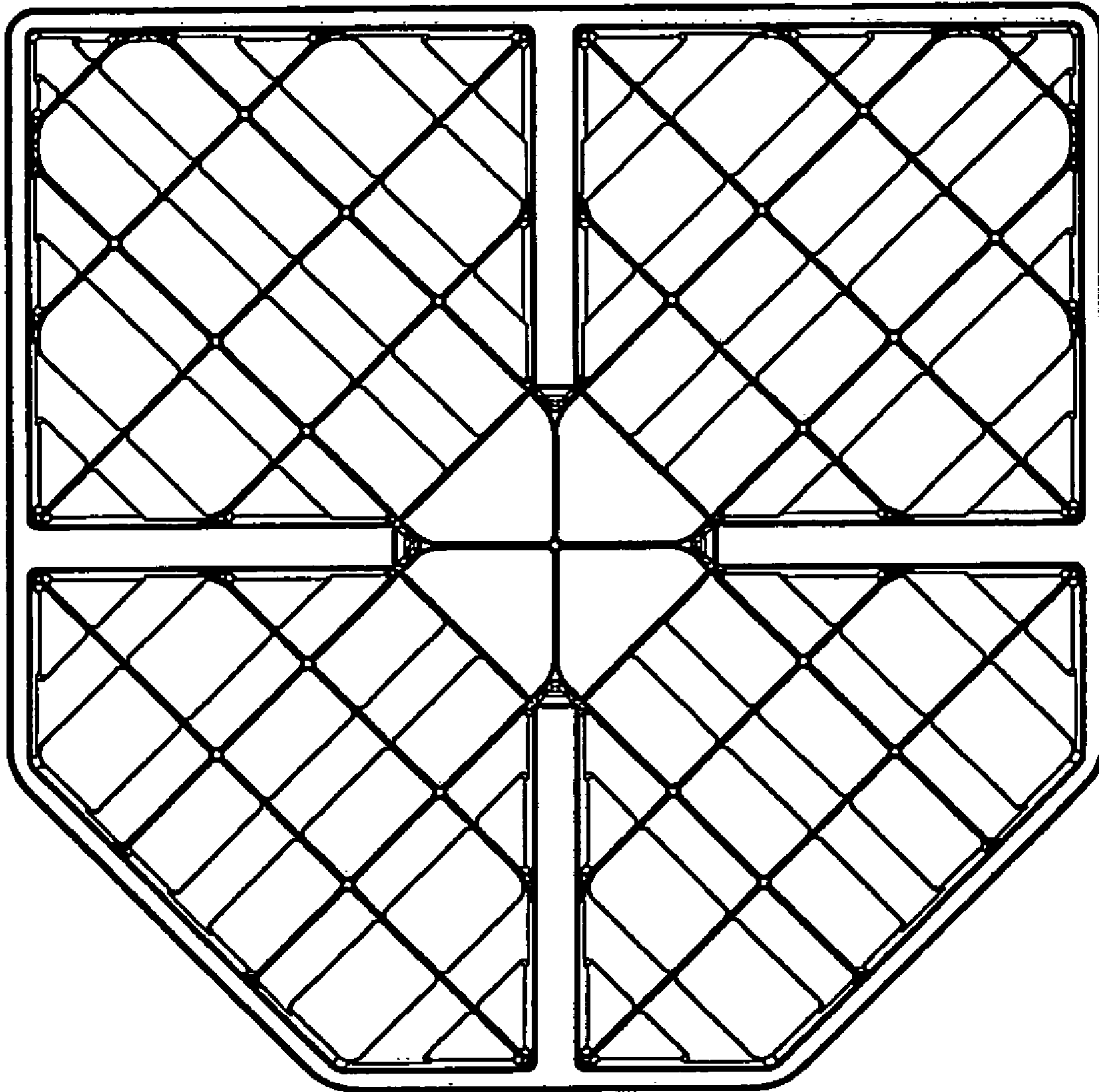
