FIG. 1 is a front elevational view of a T-shirt with shoulder pocket showing my new design;

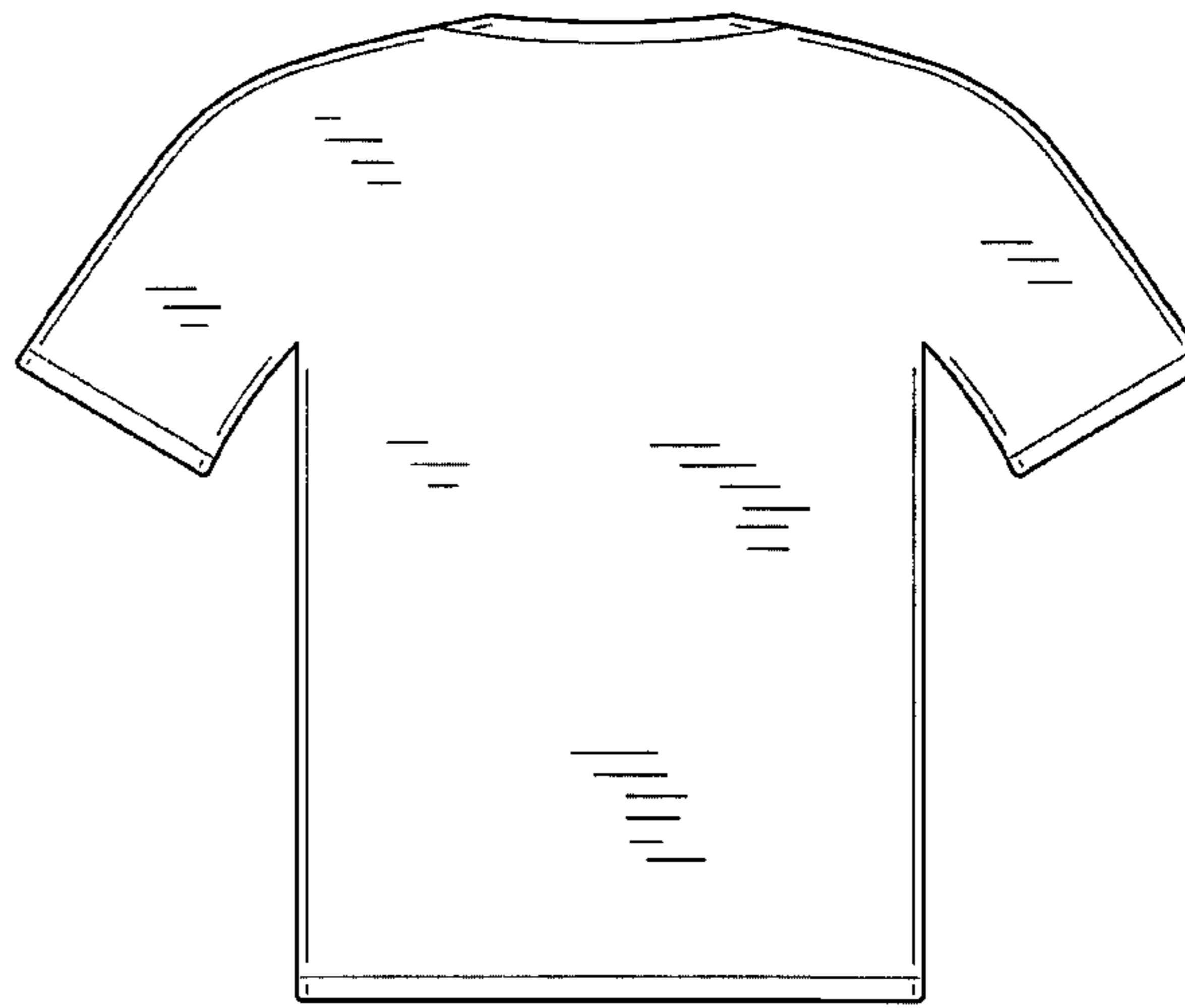
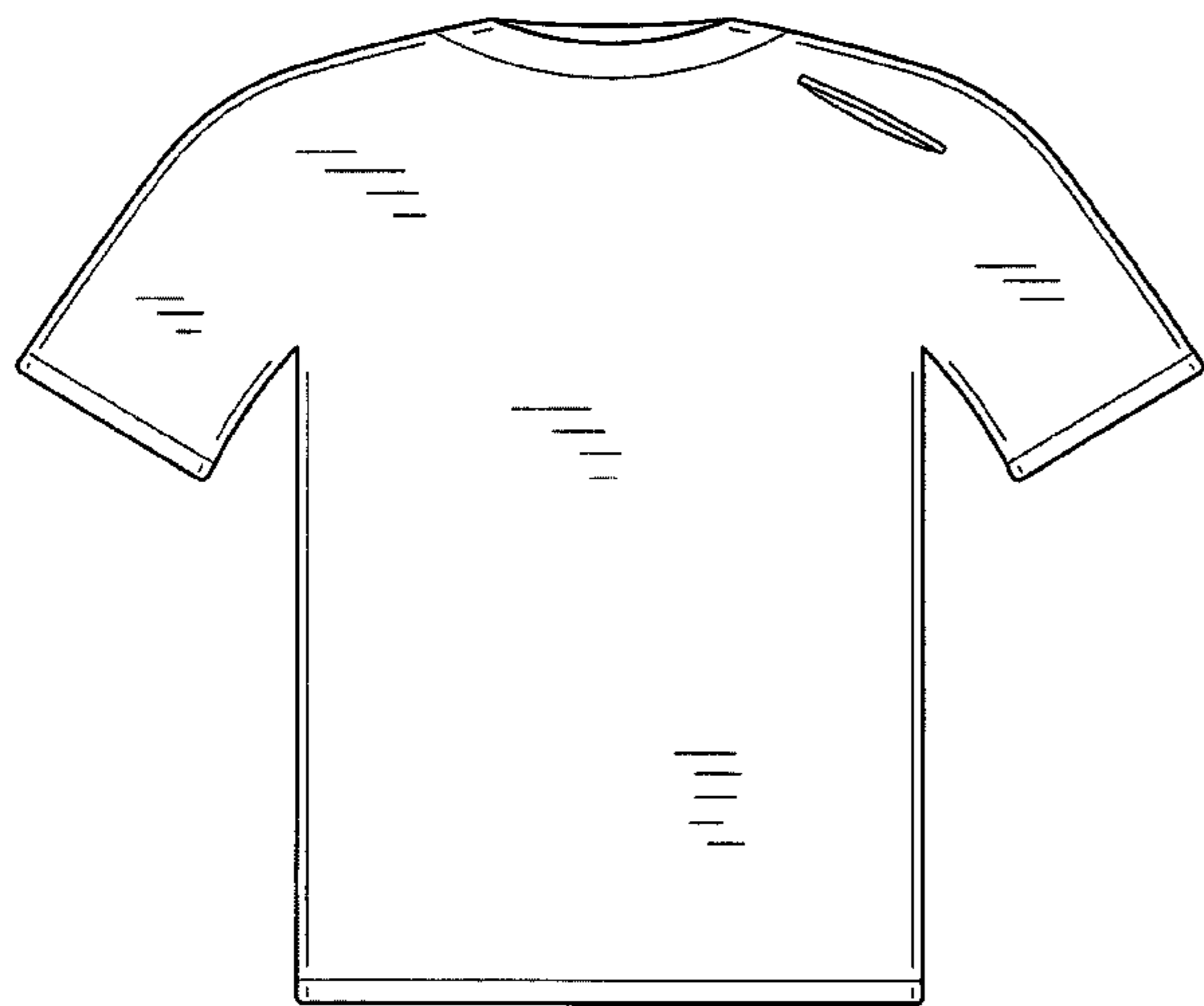
FIG. 2 is a rear elevational view thereof.

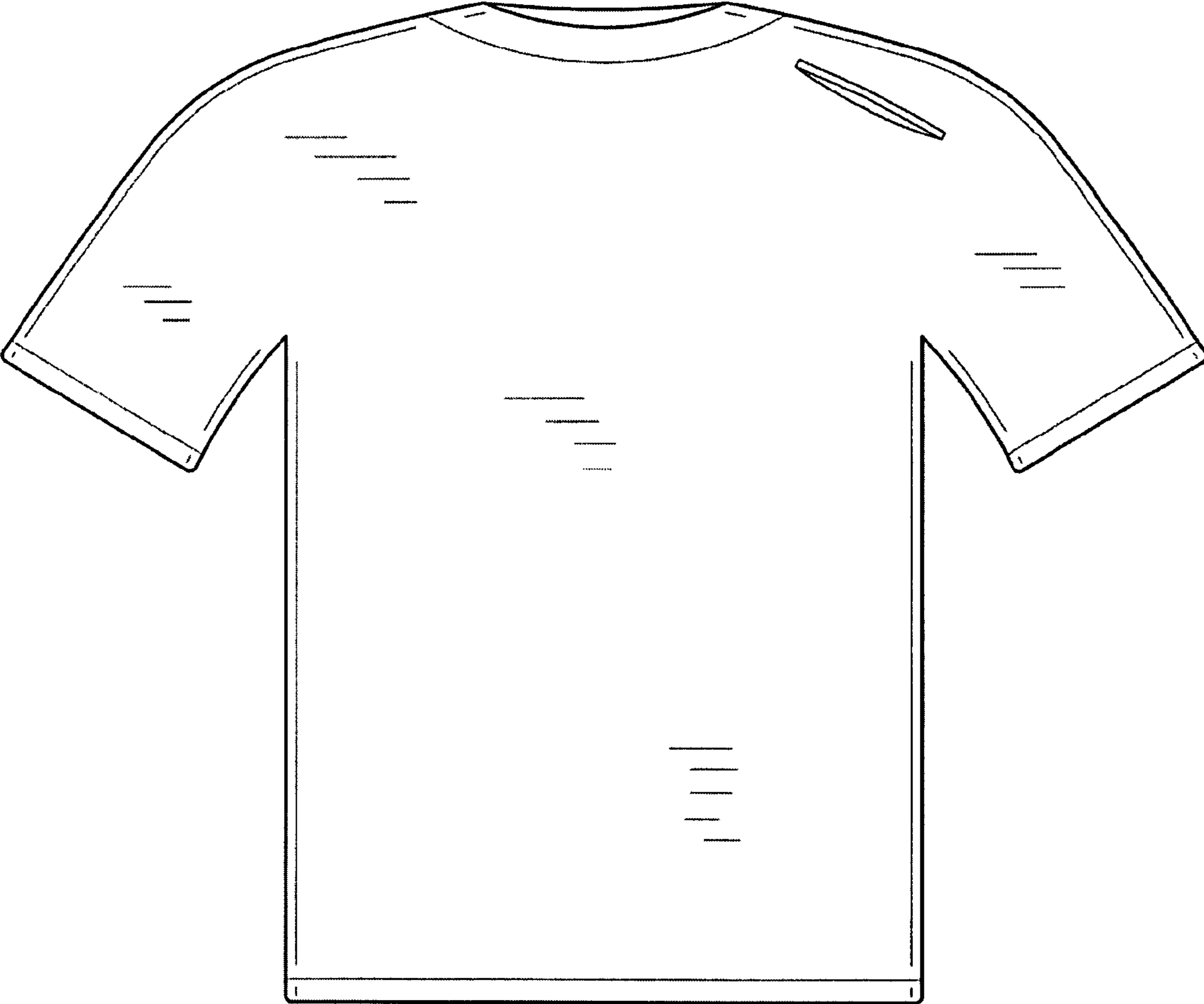

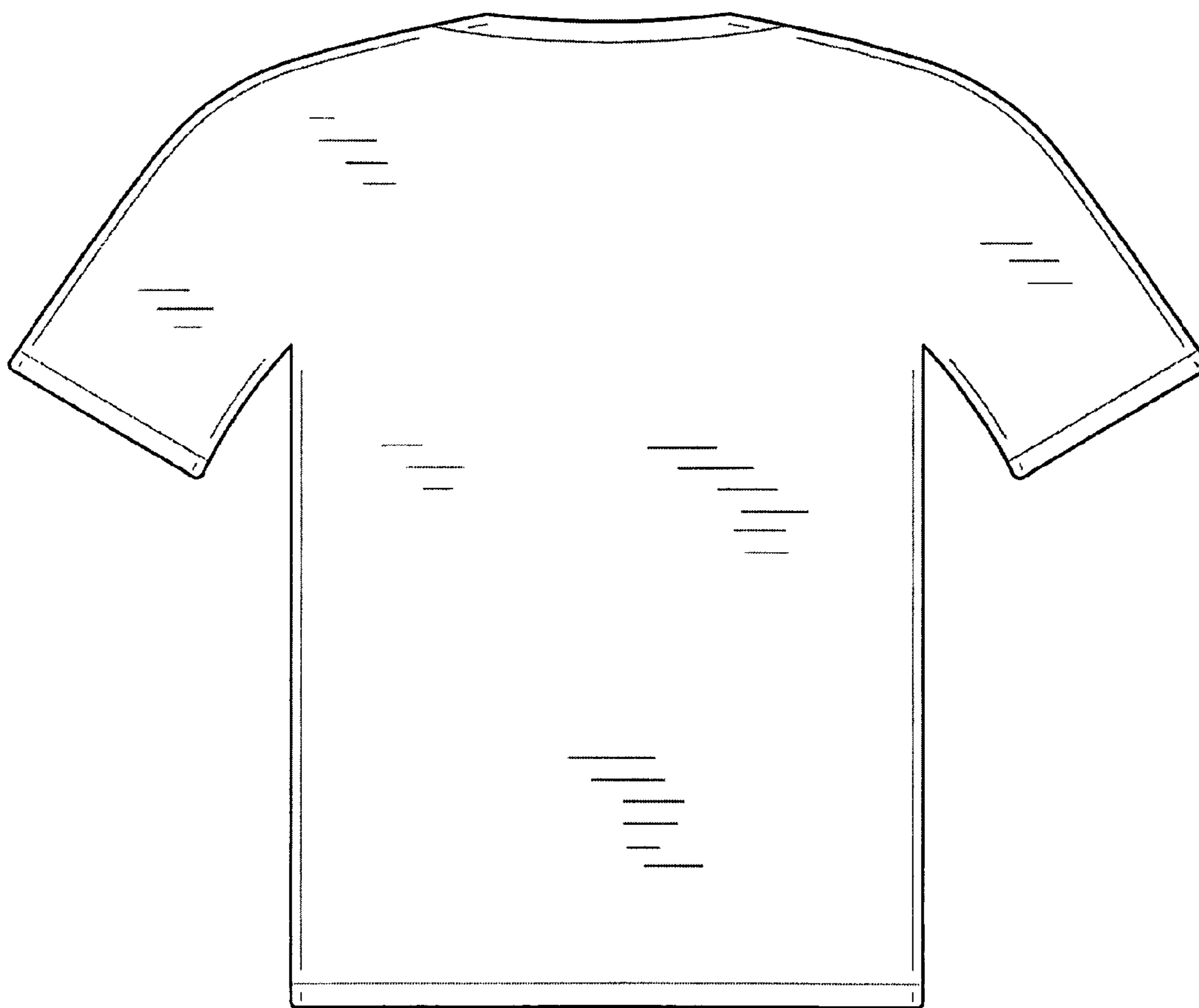

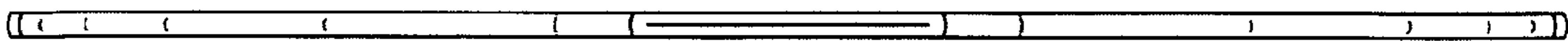

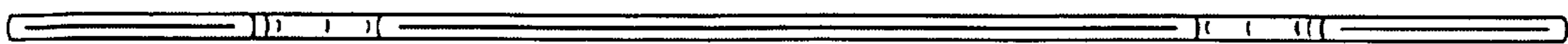
