(57) **CLAIM**

The ornamental design for a shoe with strap and buckle decoration, as shown and described.

DESCRIPTION

FIG. 3 is a left side plan view of the design of FIG. 1.

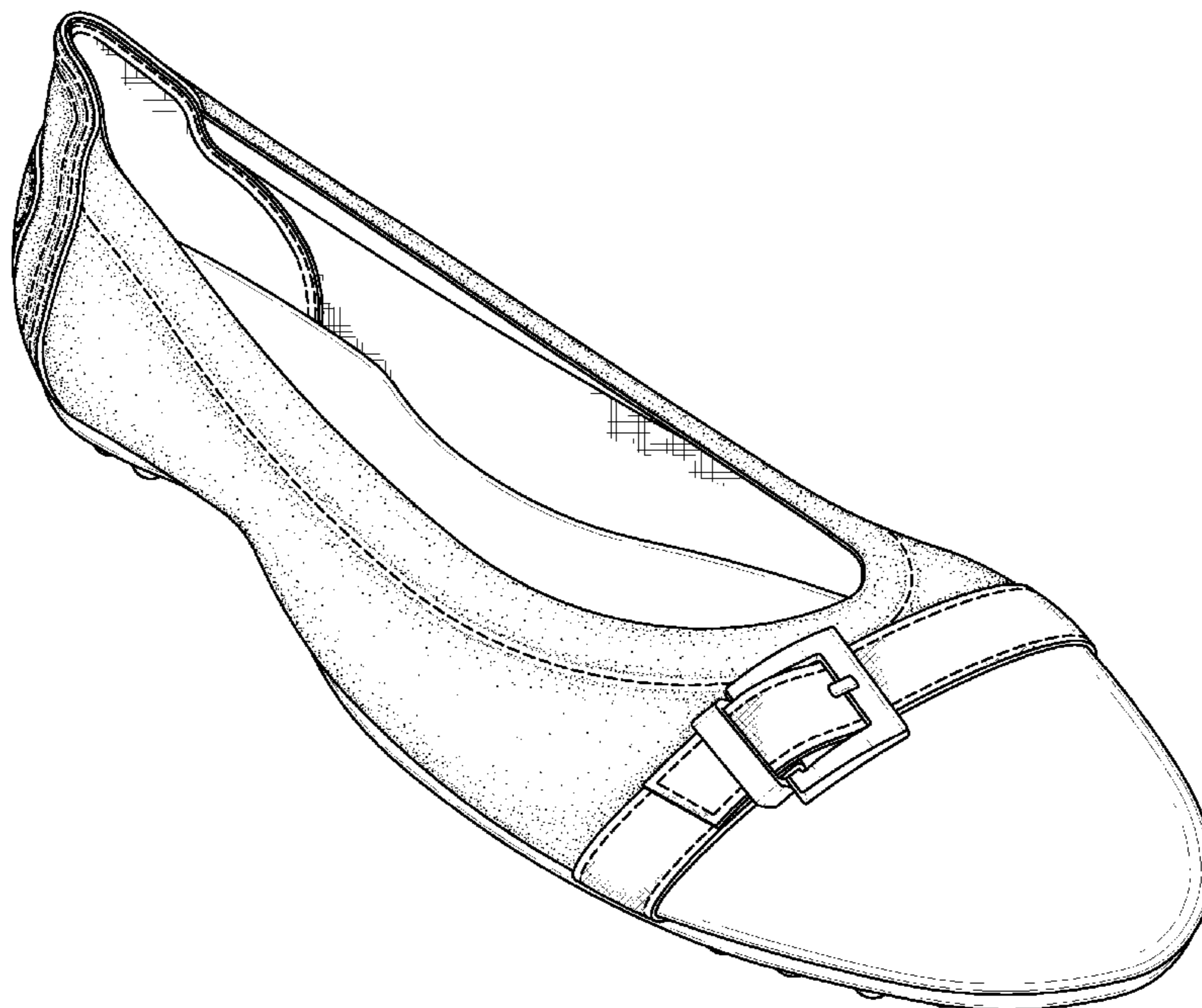
FIG. 4 is a right side plan view of the design of FIG. 1.

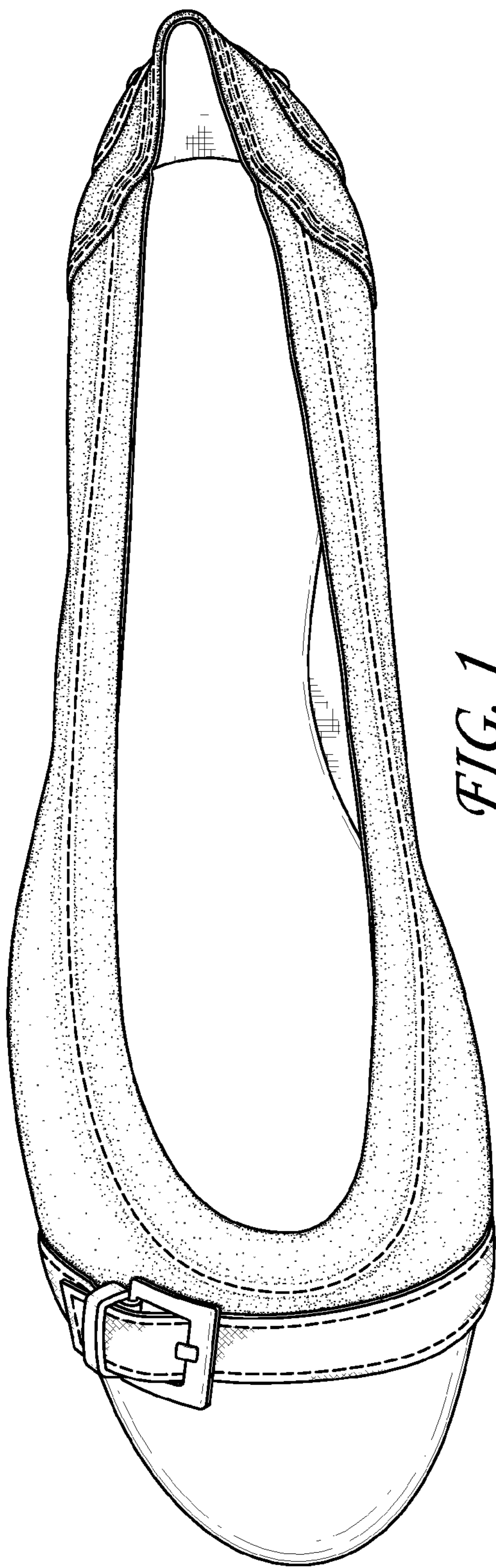

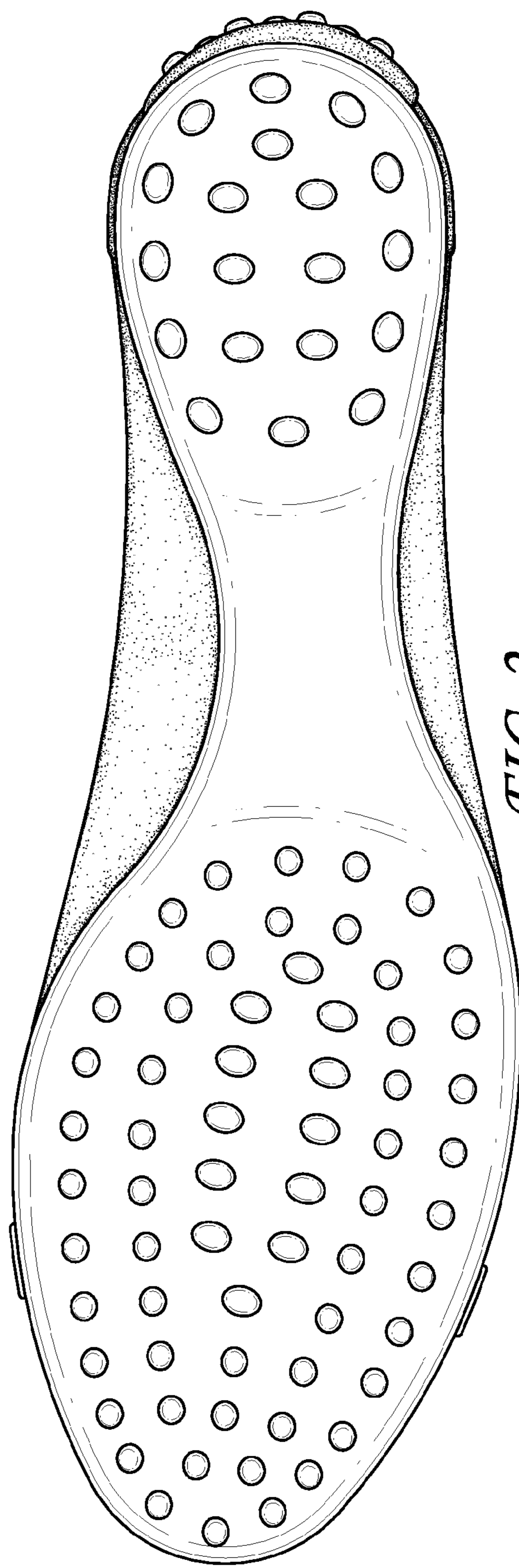

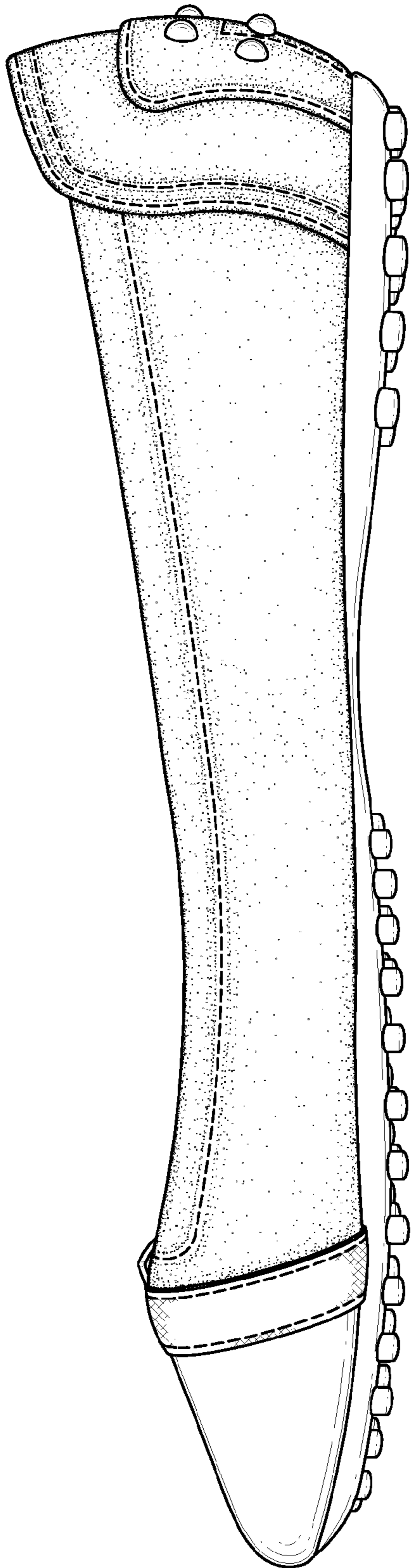

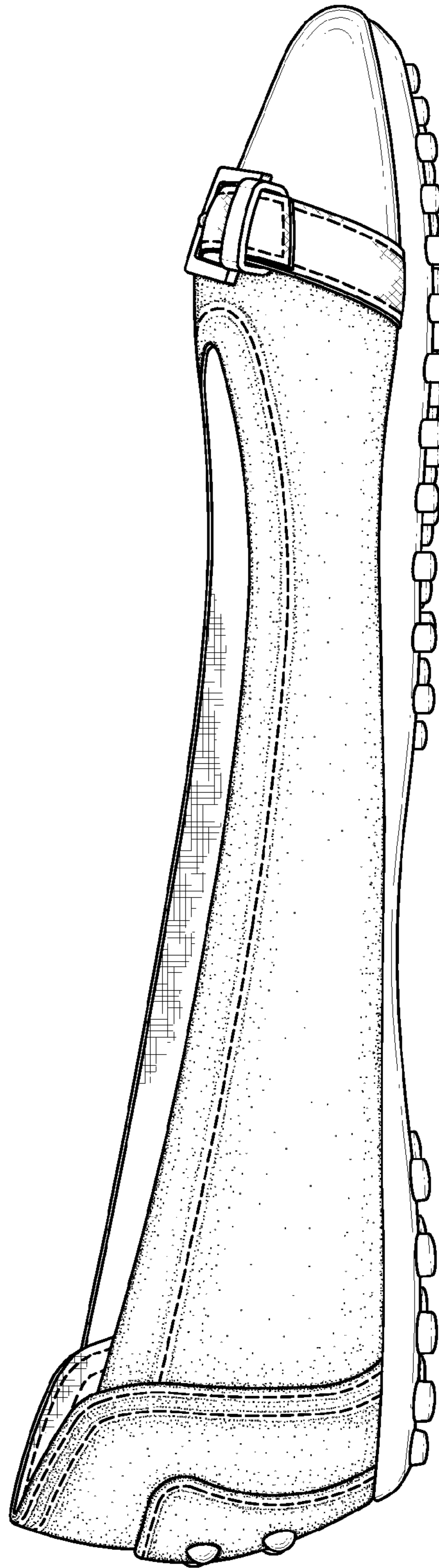

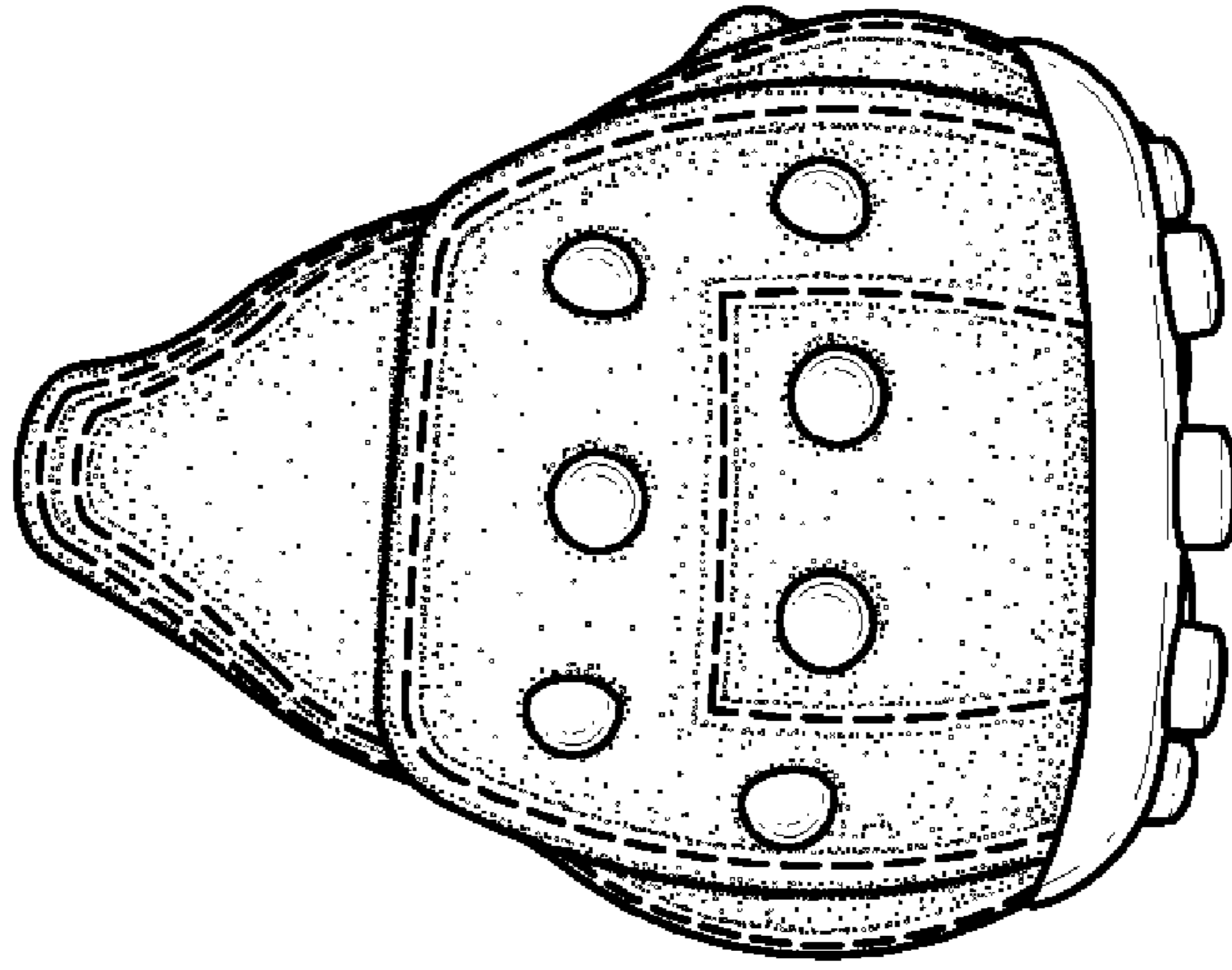

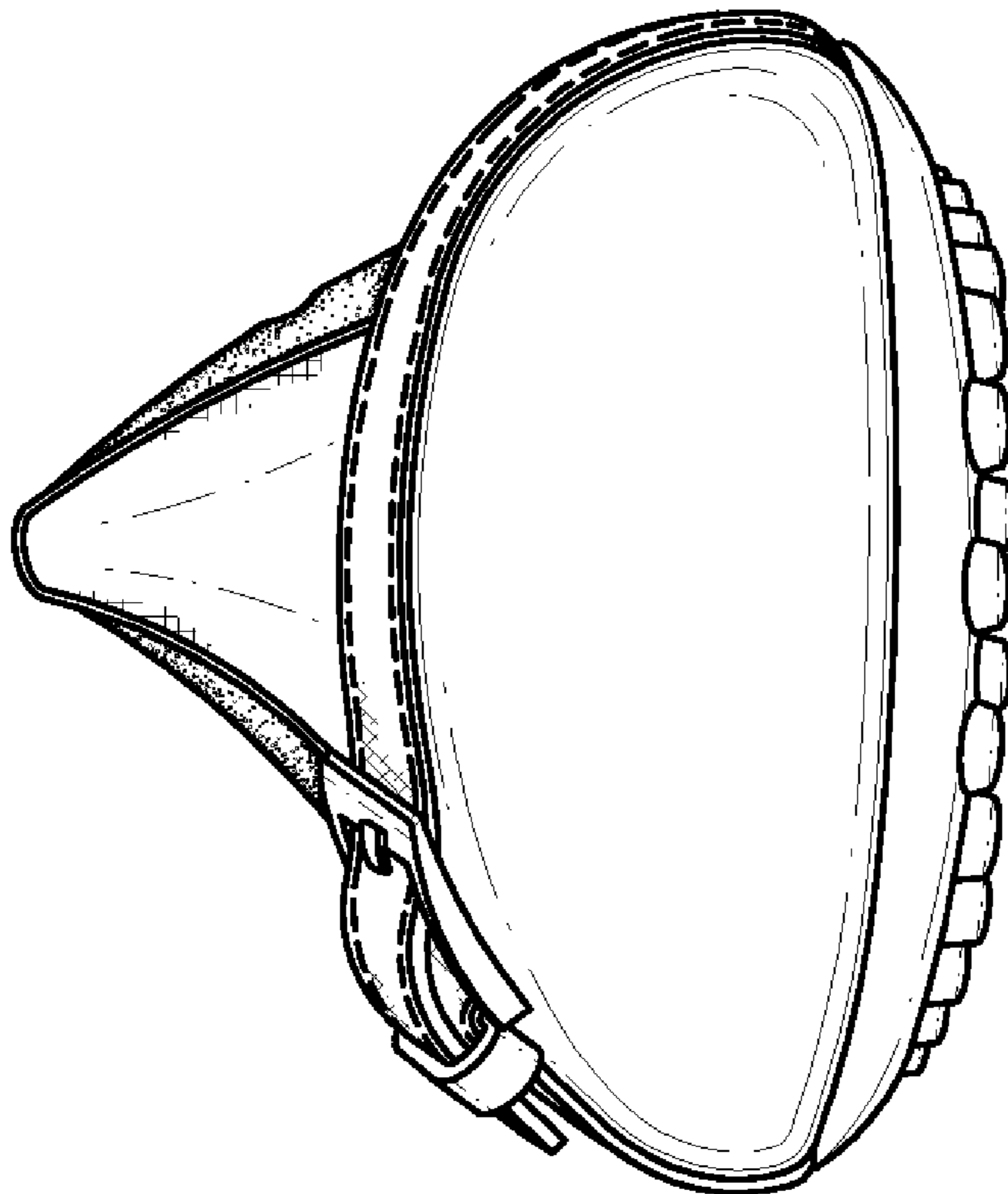

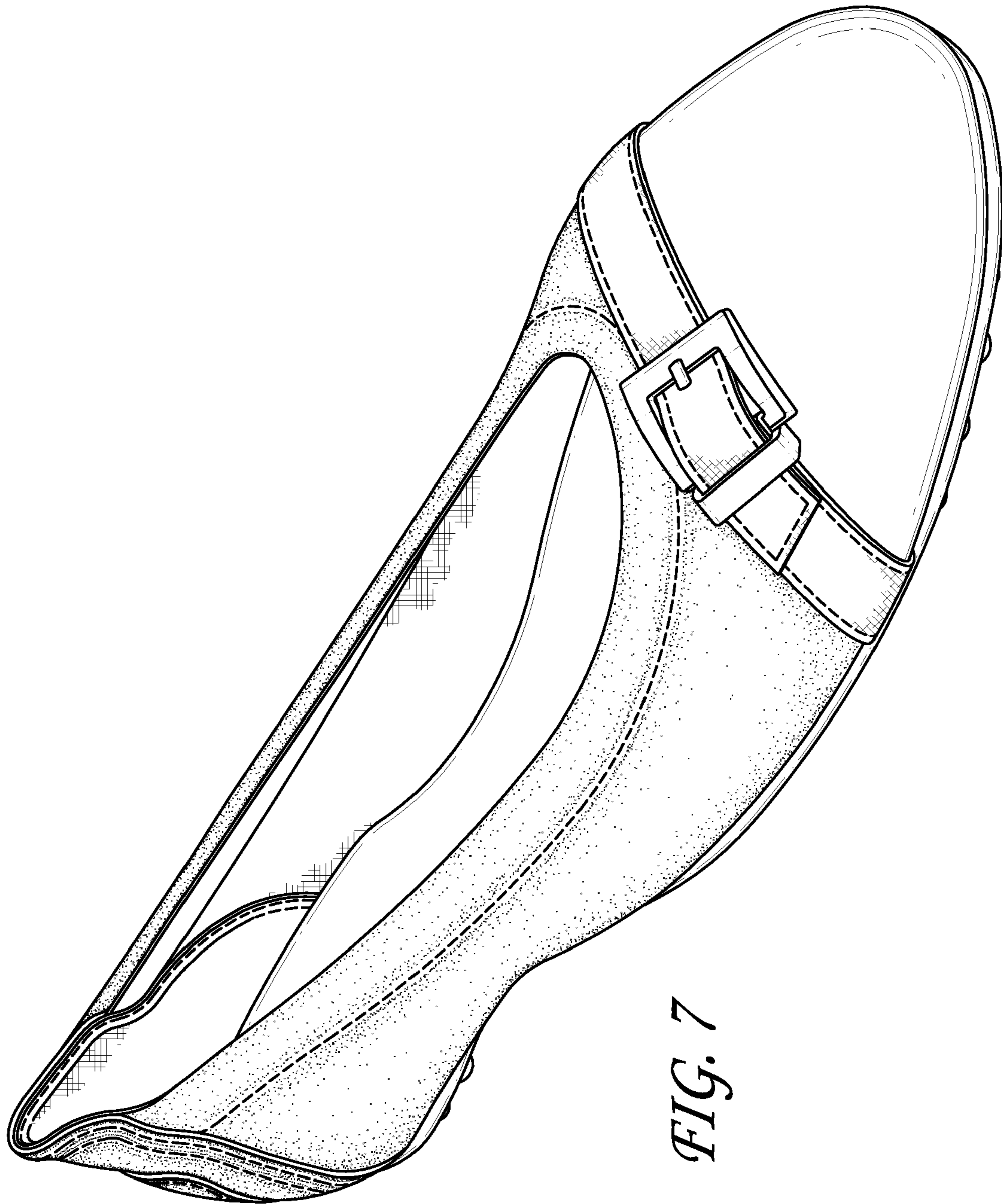
