FIG. 4 is a side view thereof, an opposite side view being a mirror image thereof.

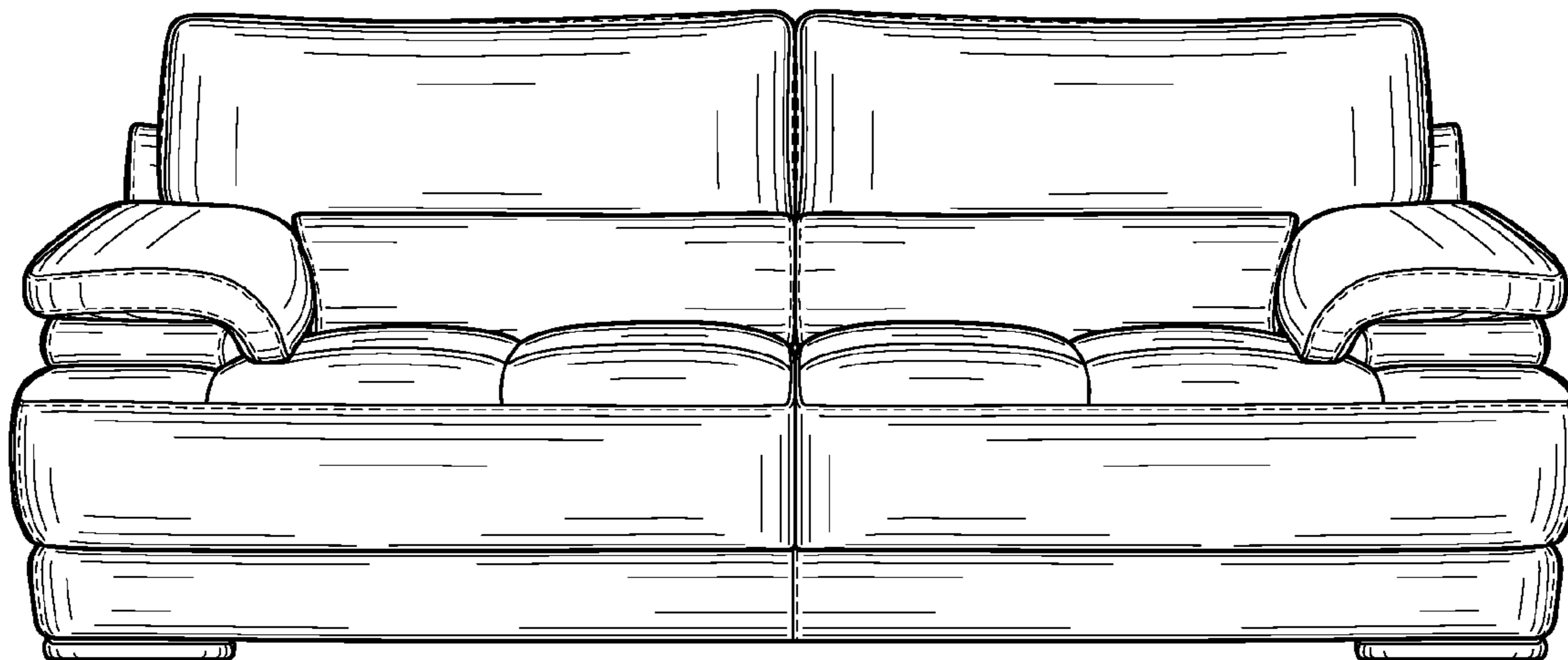
The broken lines shown on the sofa are understood to represent stitching.

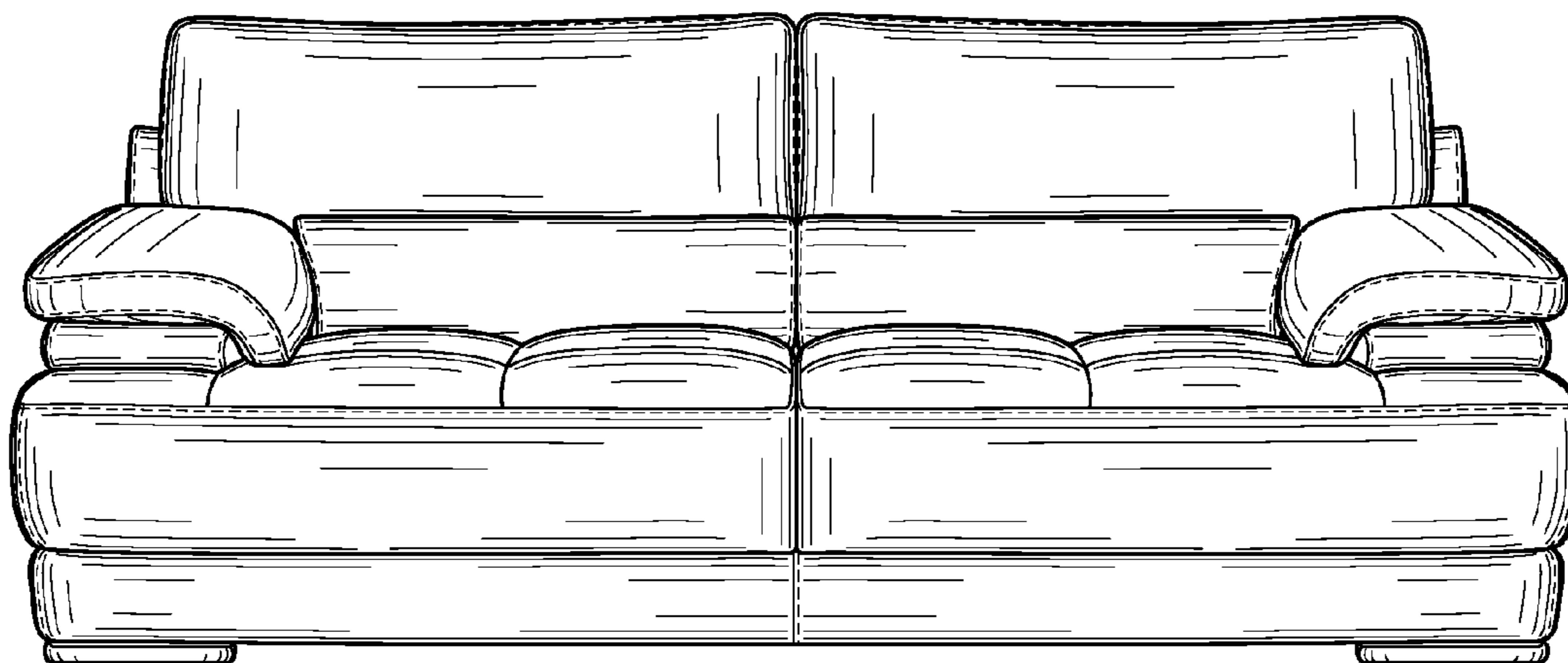

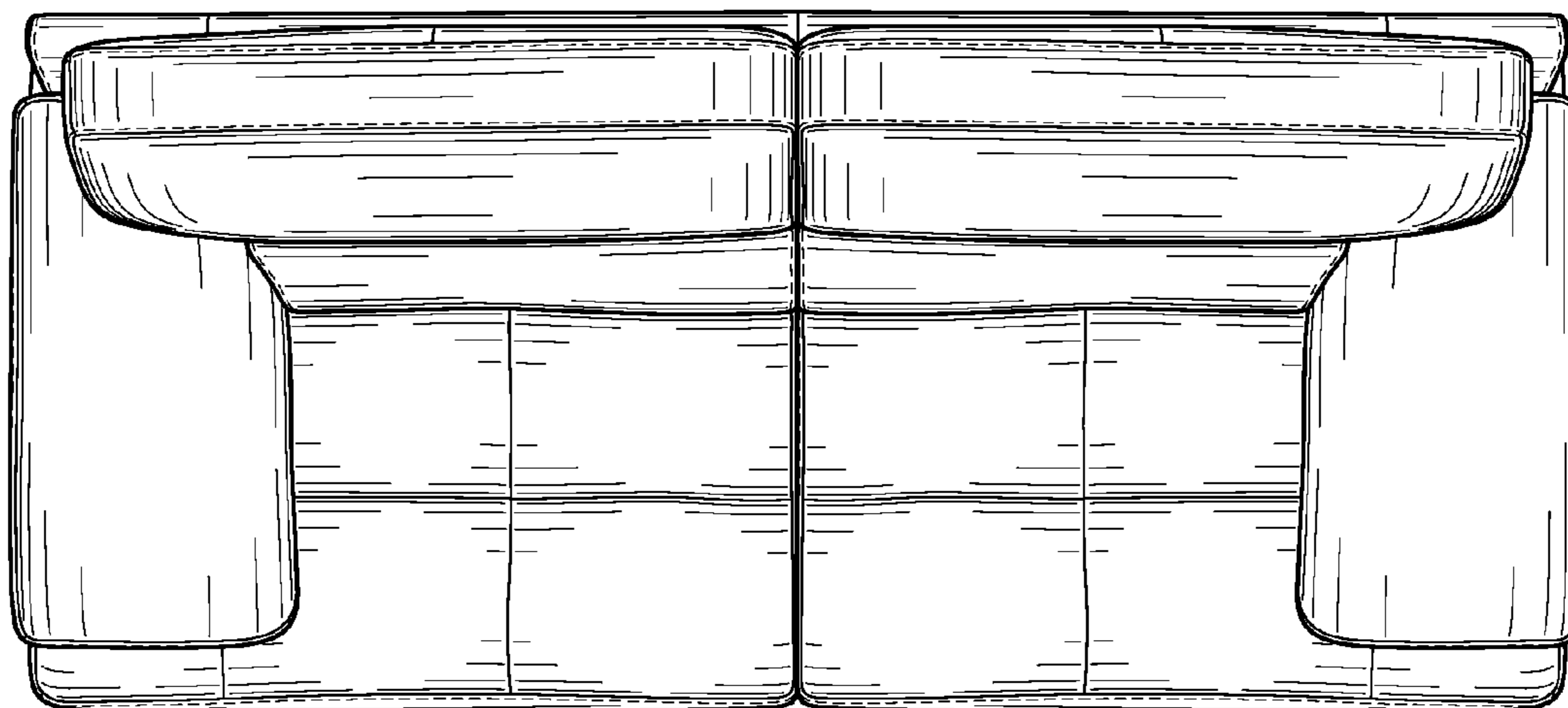

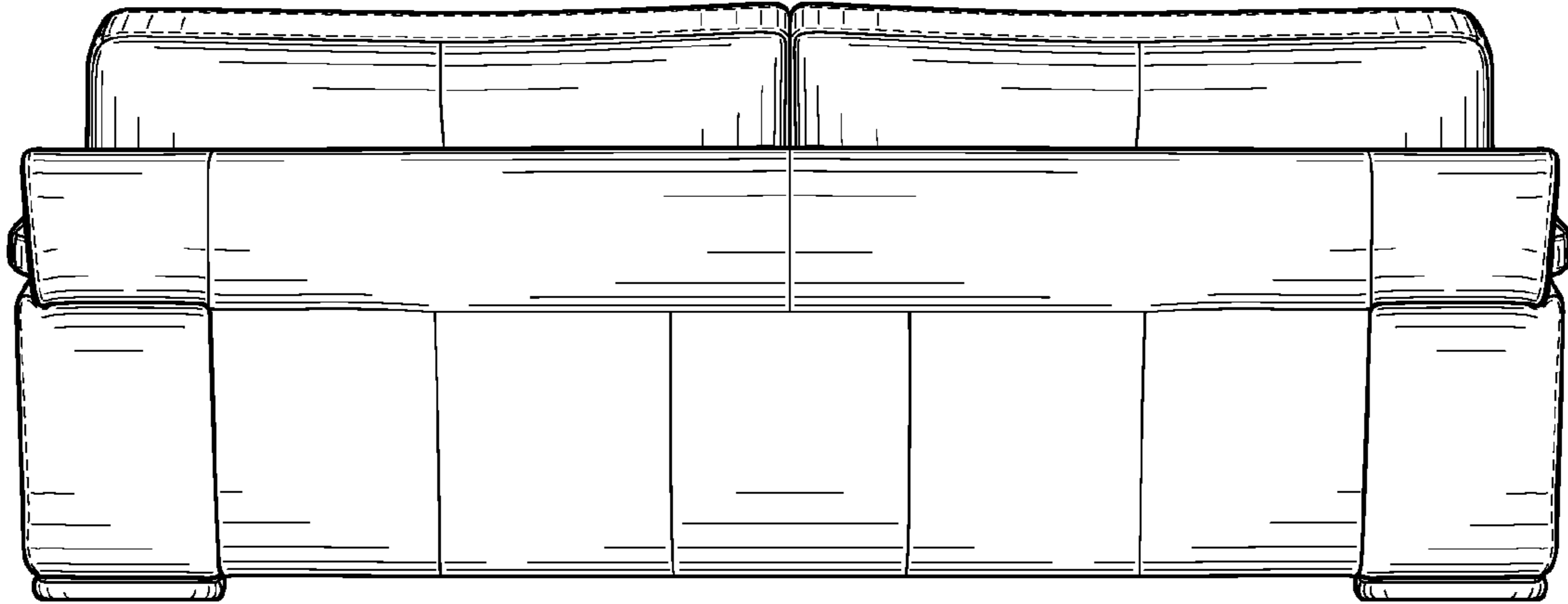




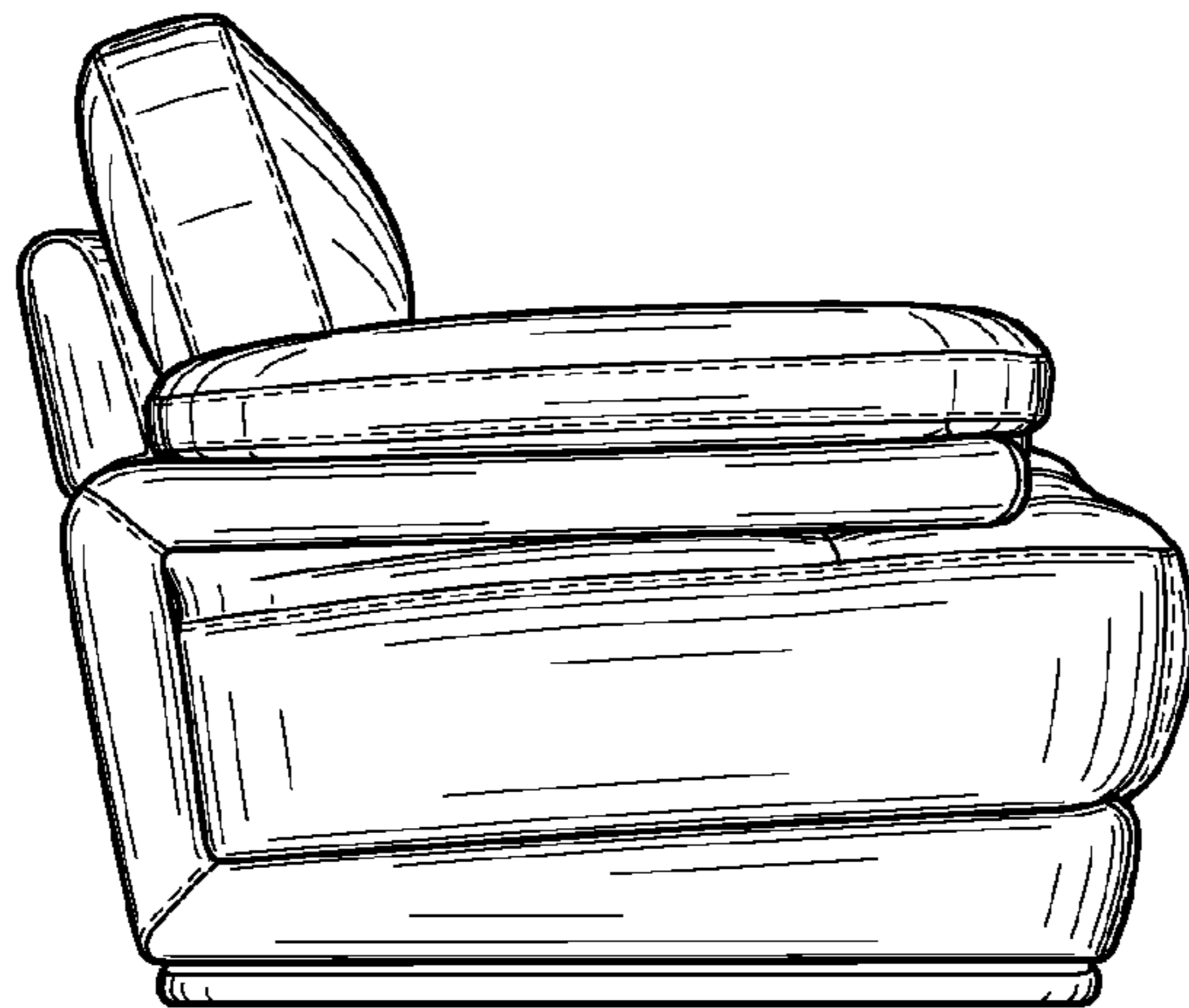
