FIG. 3 is a right-hand side view thereof;

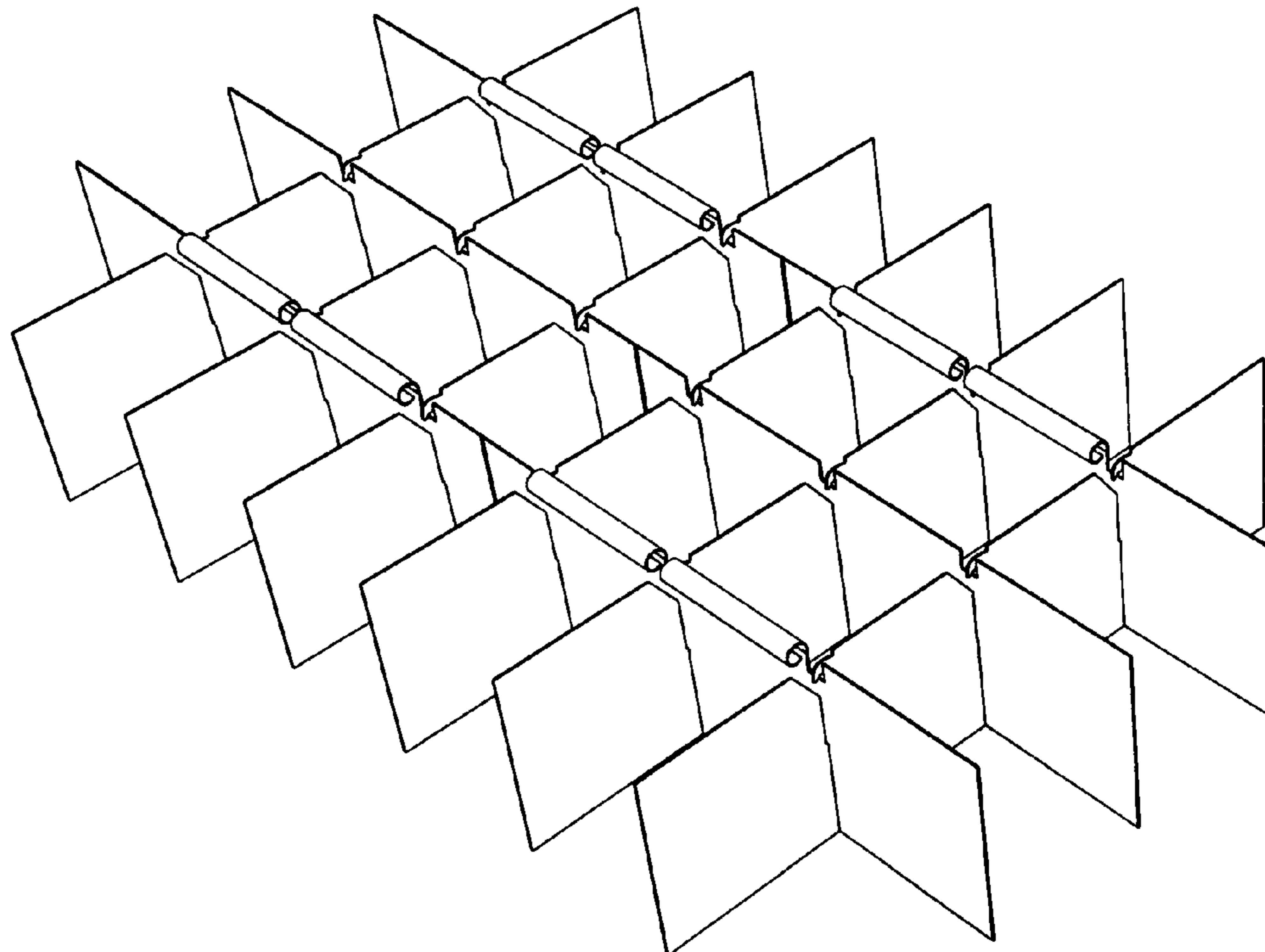
FIG. 4 is a front view thereof;

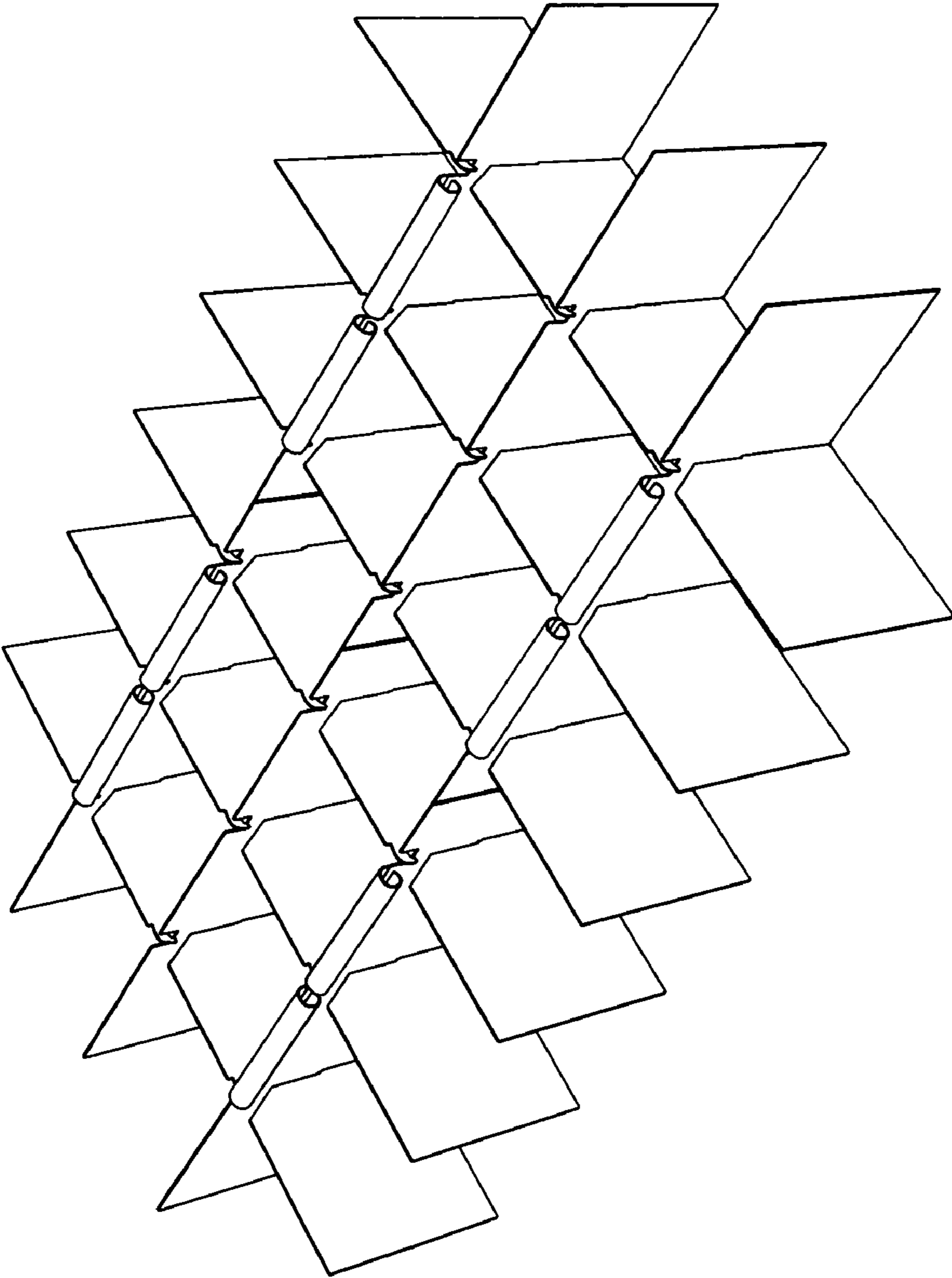

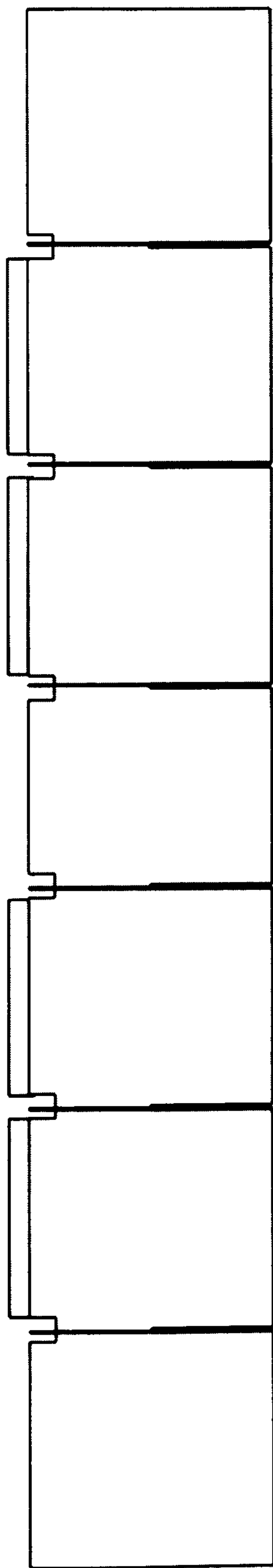

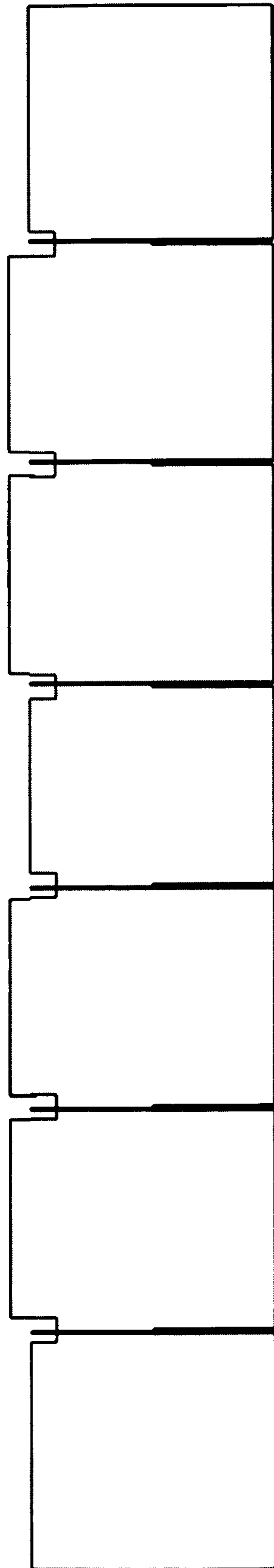

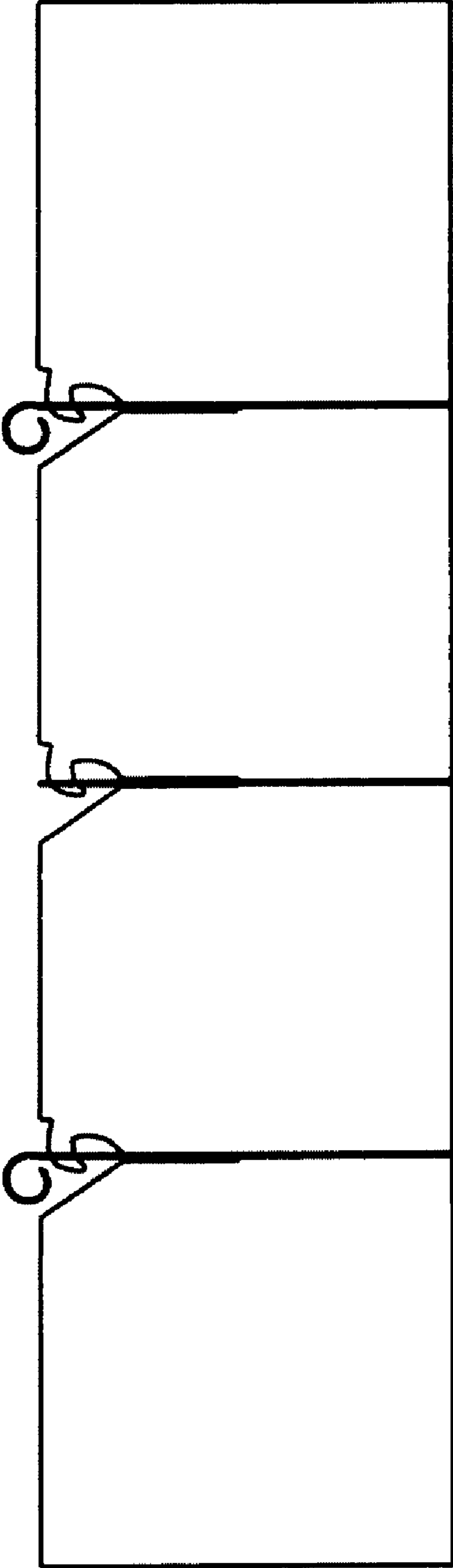

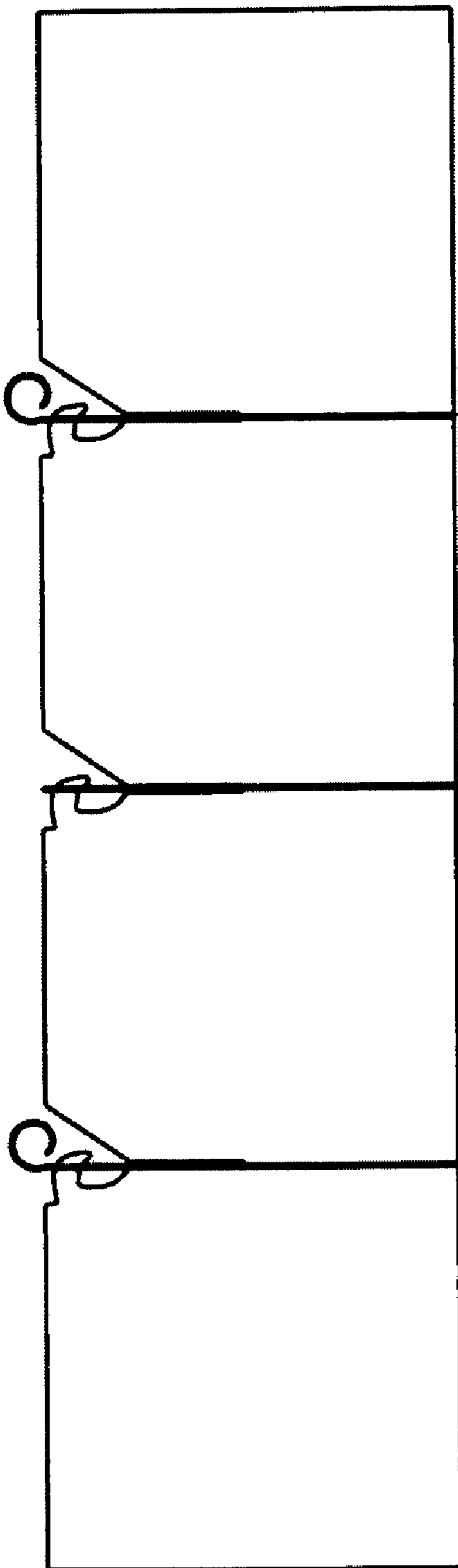

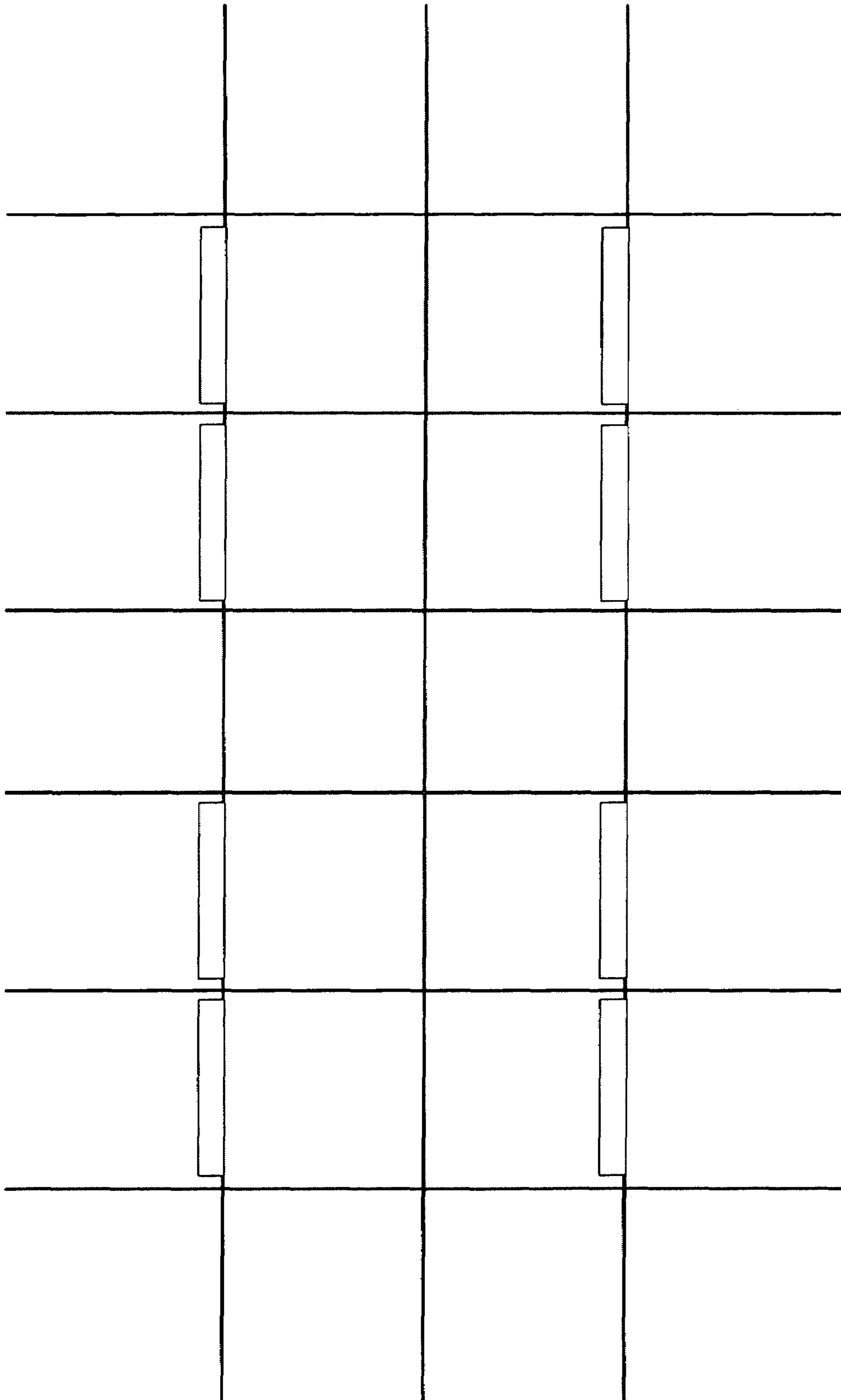

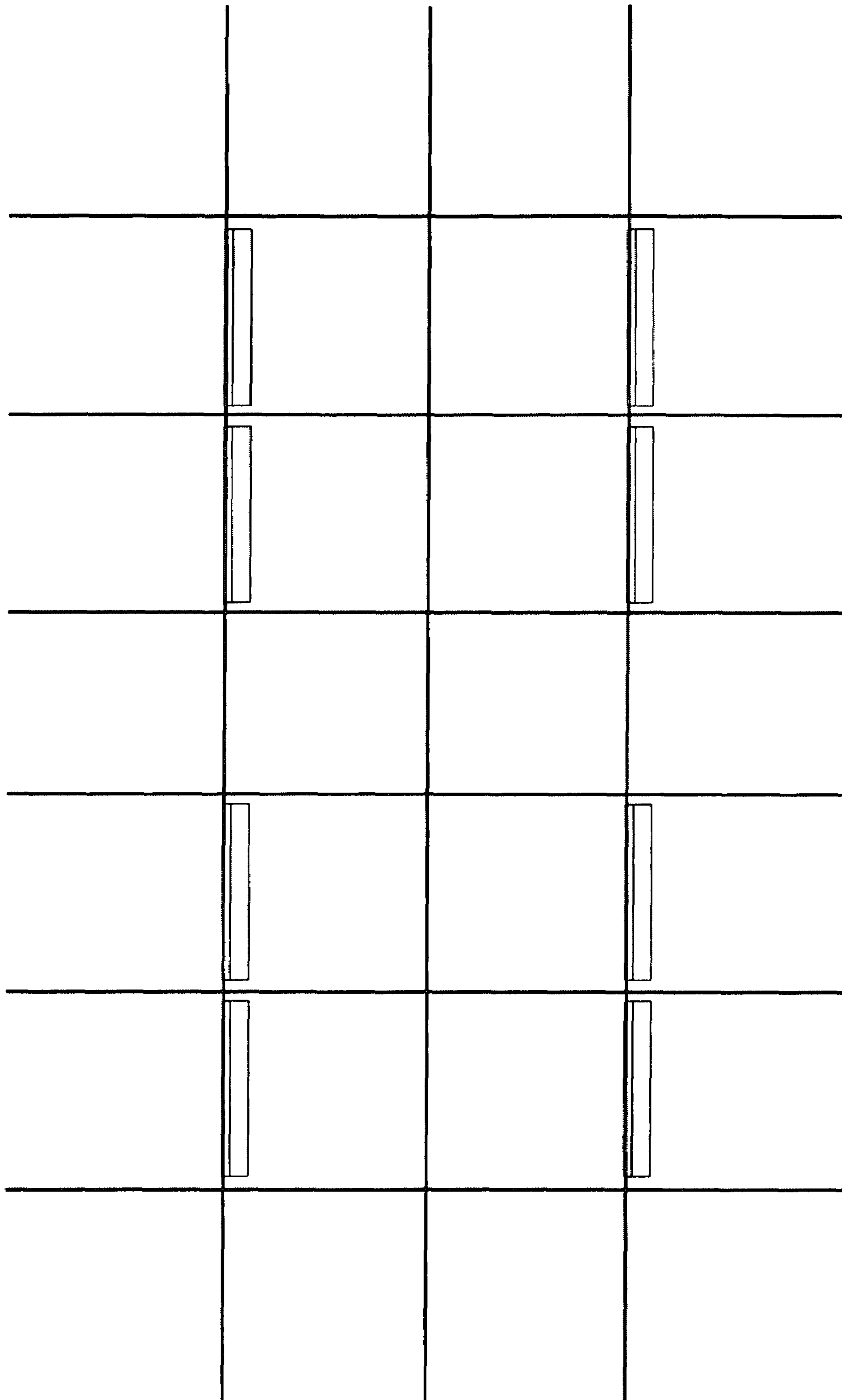
