FIG. 4 is a right side elevational view thereof;

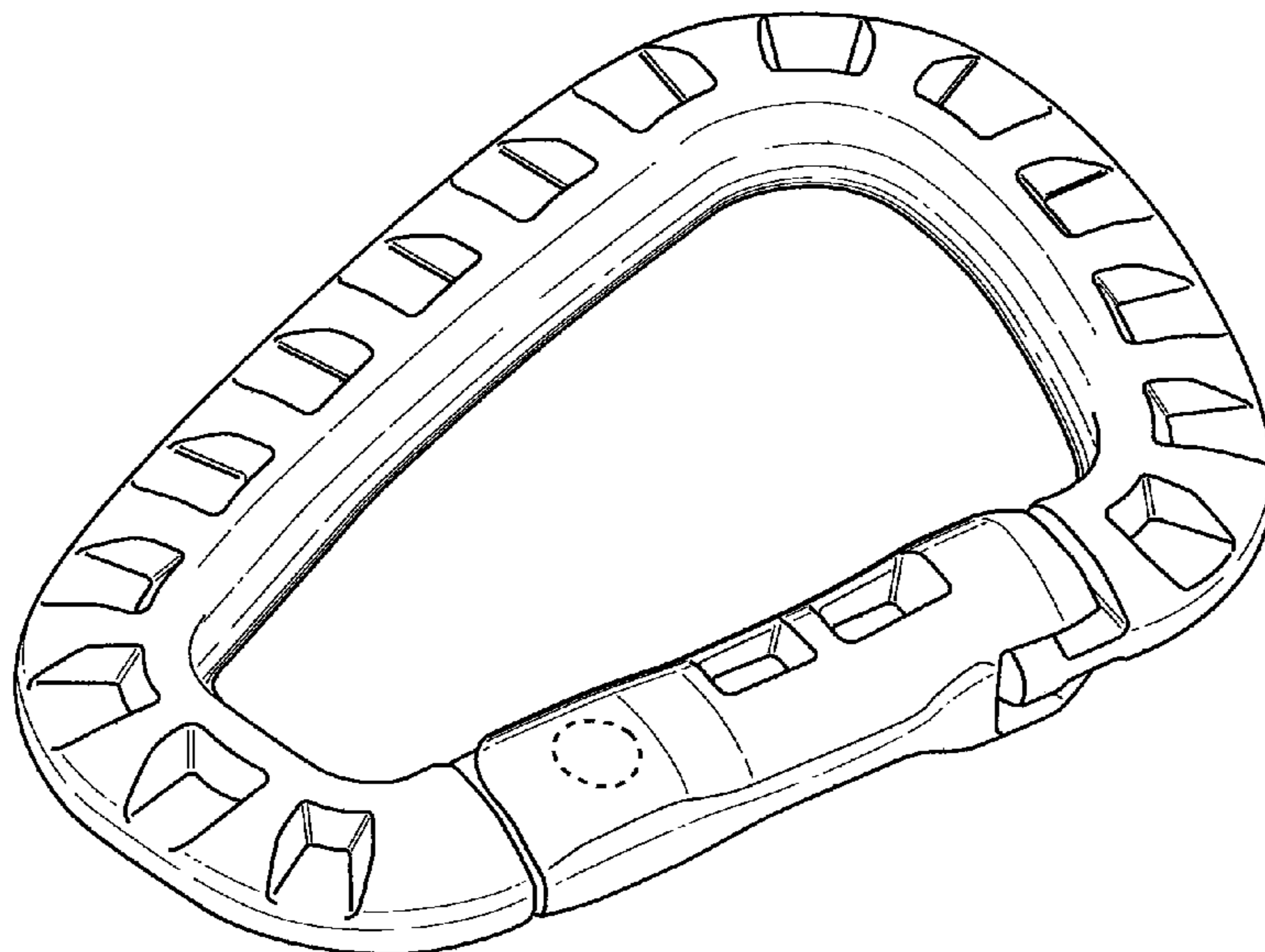
FIG. 5 is a left side elevational view thereof;

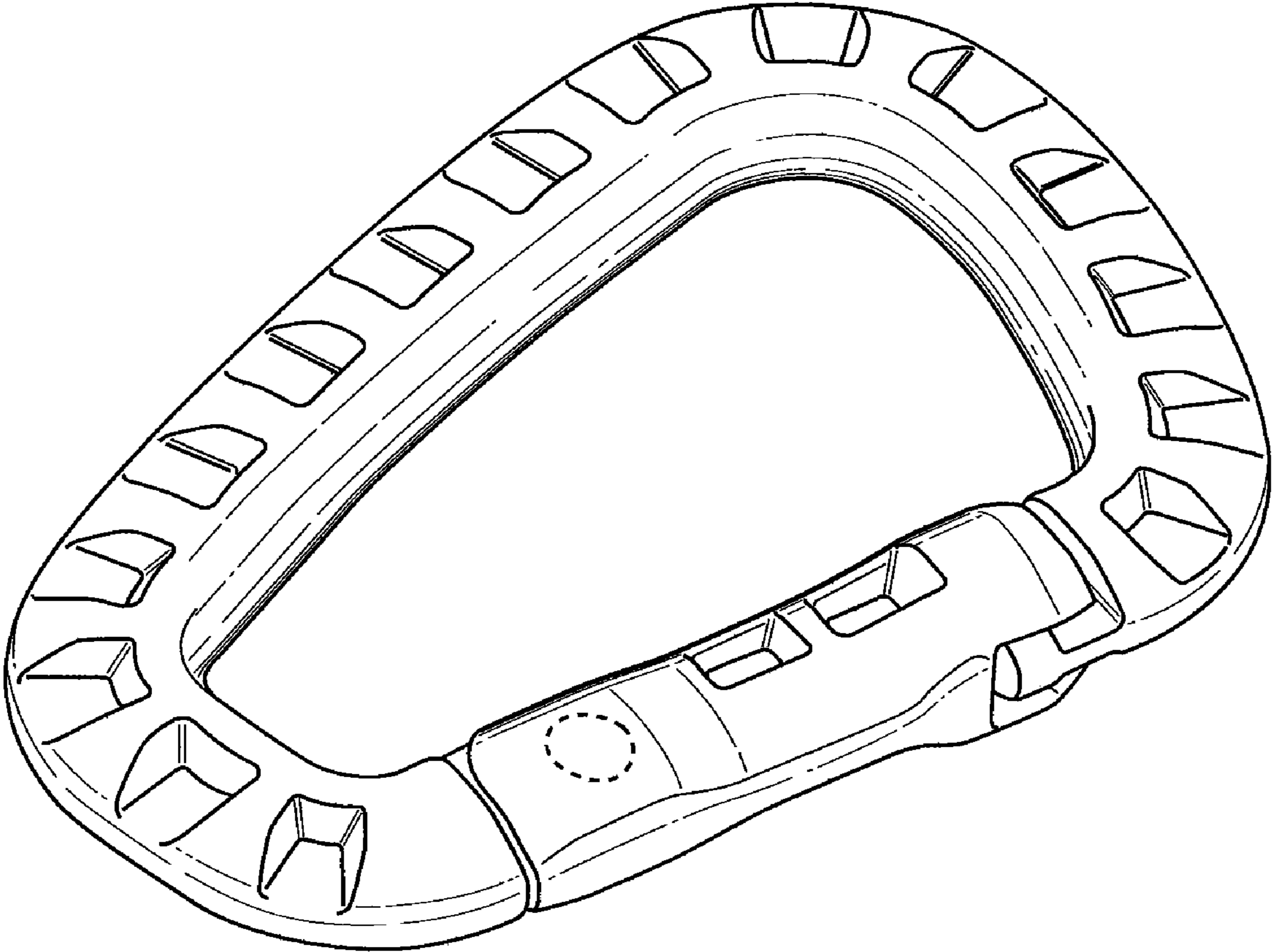
FIG. 6 is an end plan view thereof; and,

FIG. 7 is the reverse end plan view thereof.

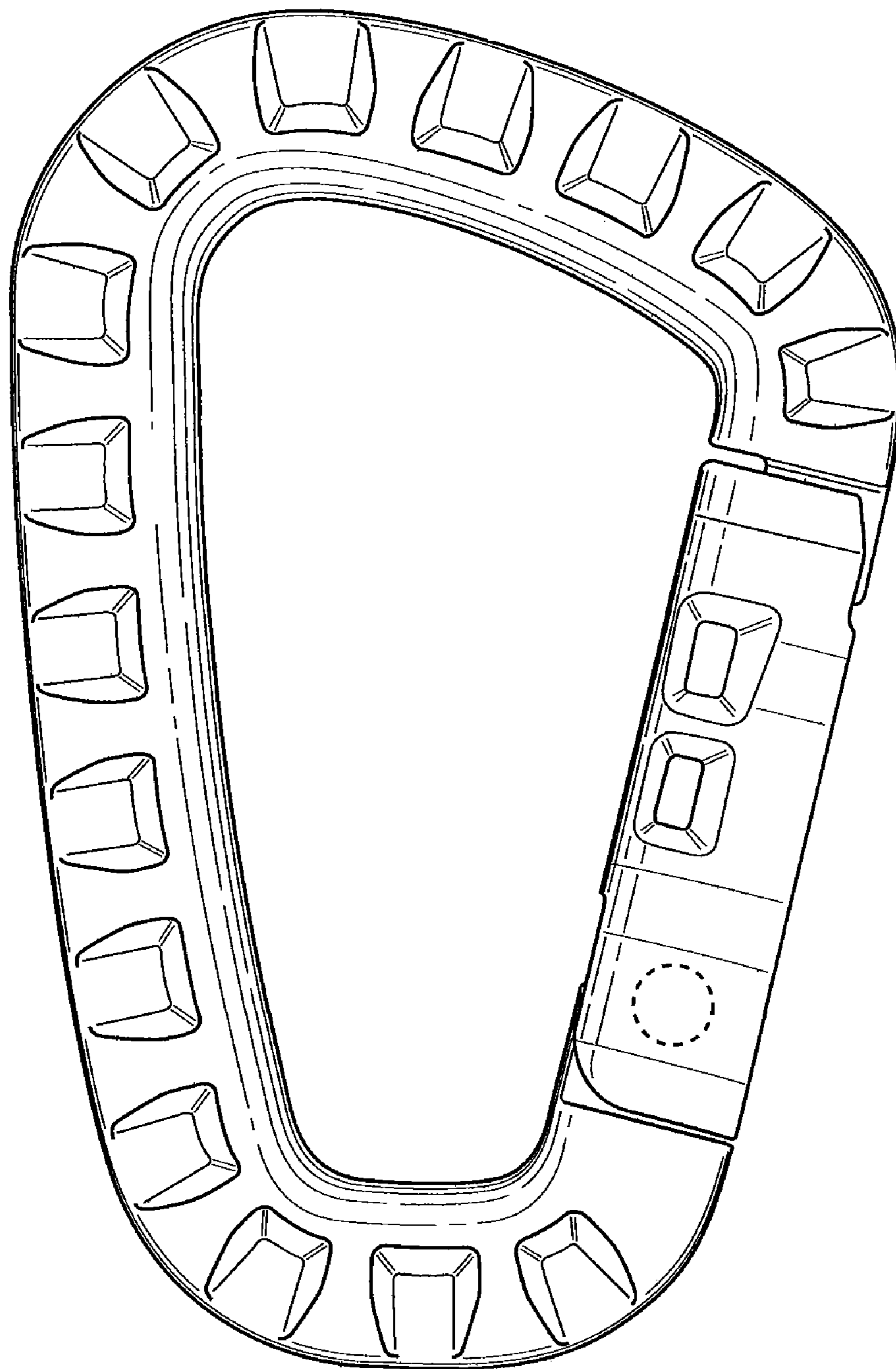

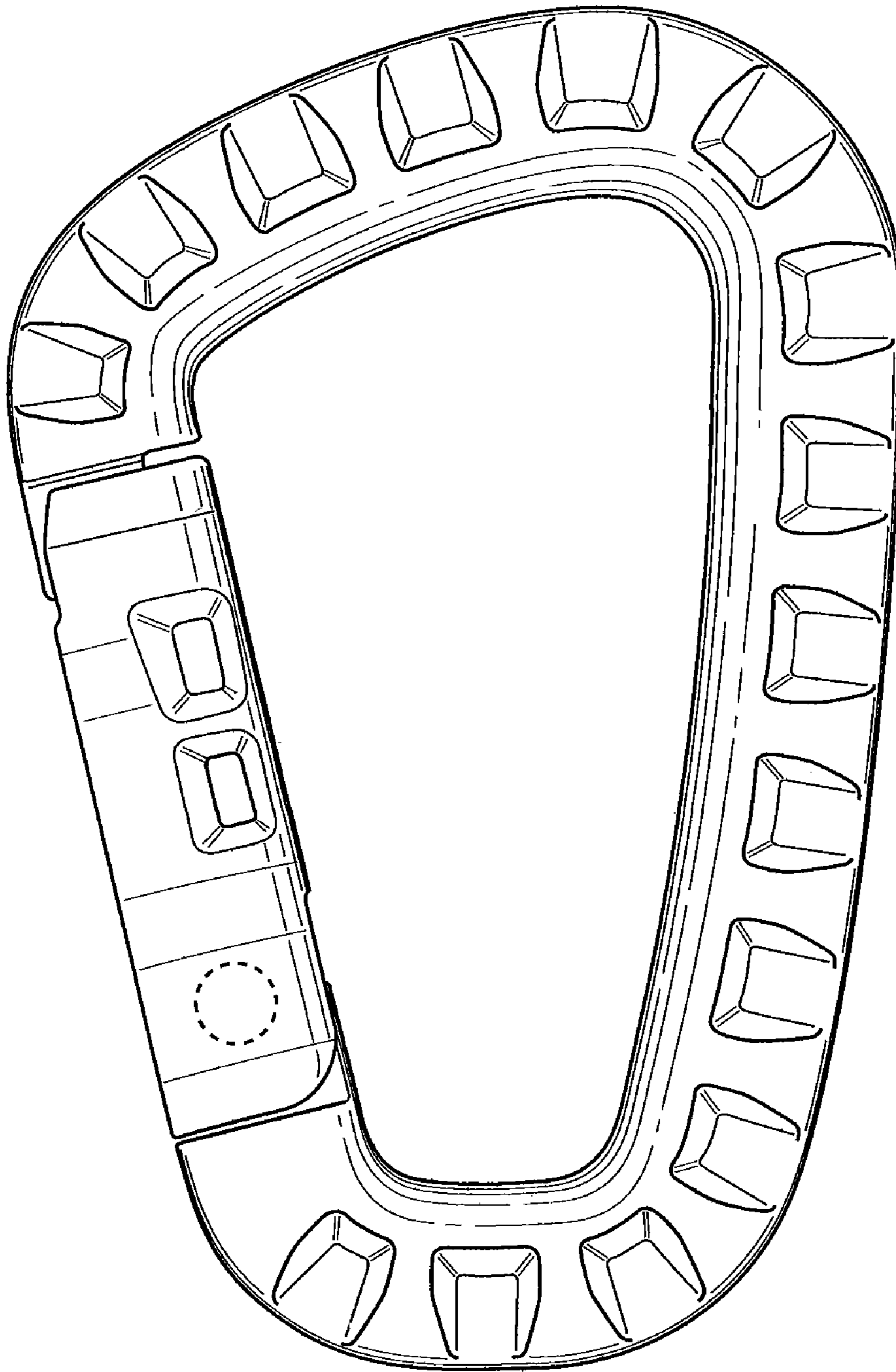




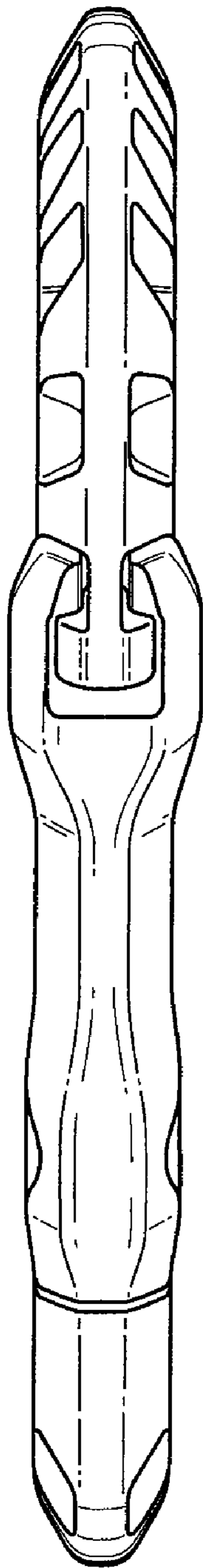

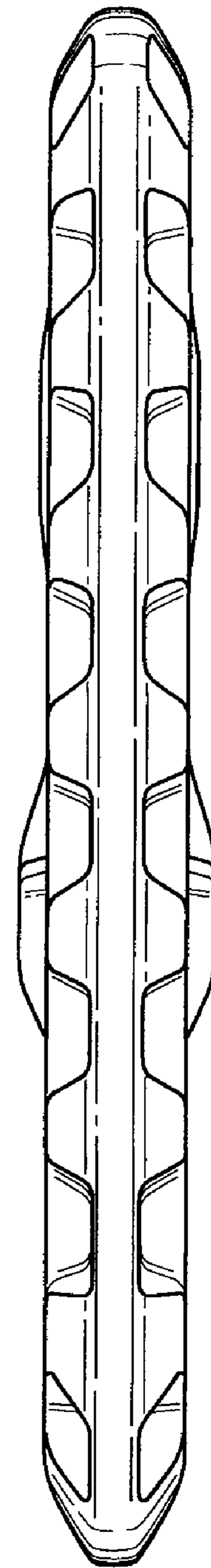

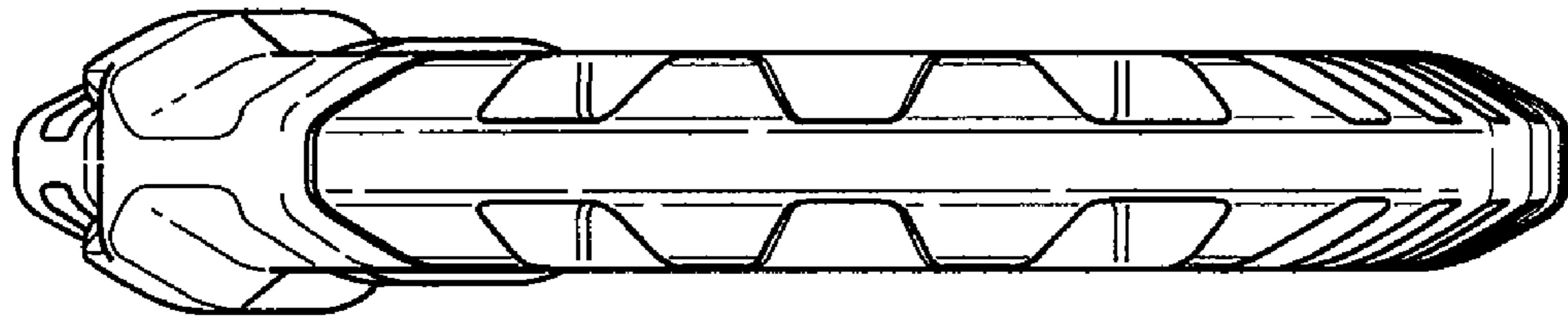

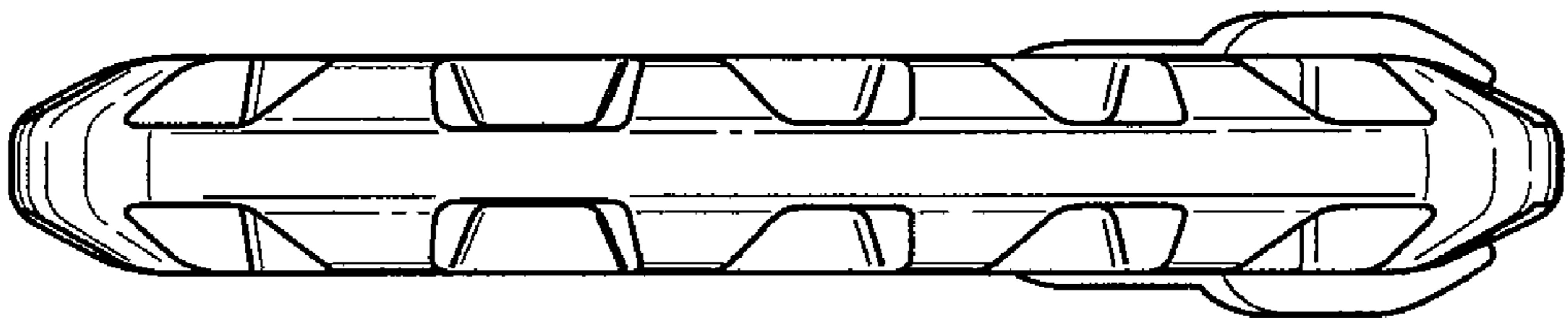
