The ornamental design for bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a bottle showing our new design;

FIG. 2 is a front elevation view thereof, shown at an enlarged scale, the rear elevation view being identical;

FIG. 3 is a side view, the opposing side elevation being identical;

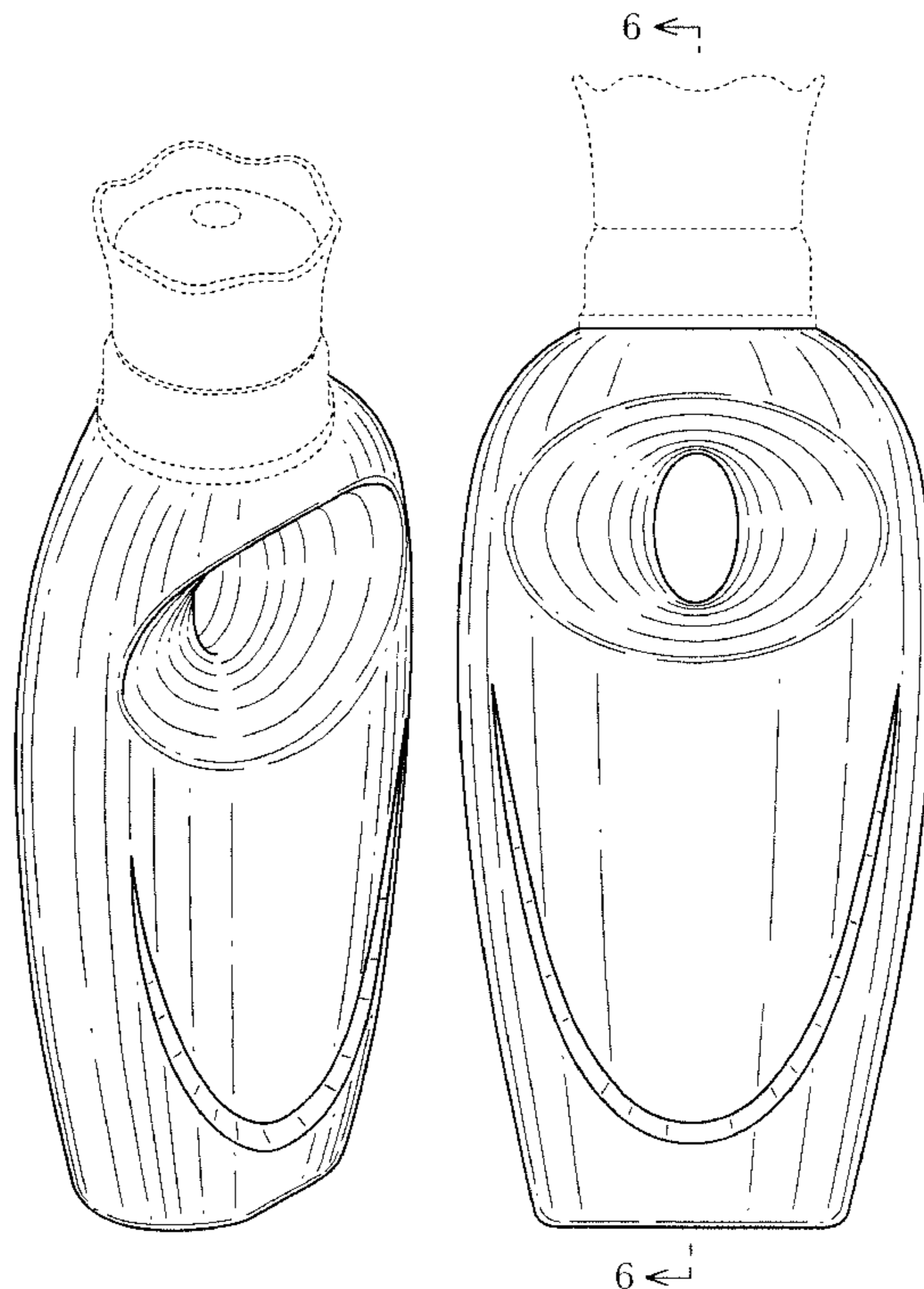
FIG. 4 is a top plan view thereof;

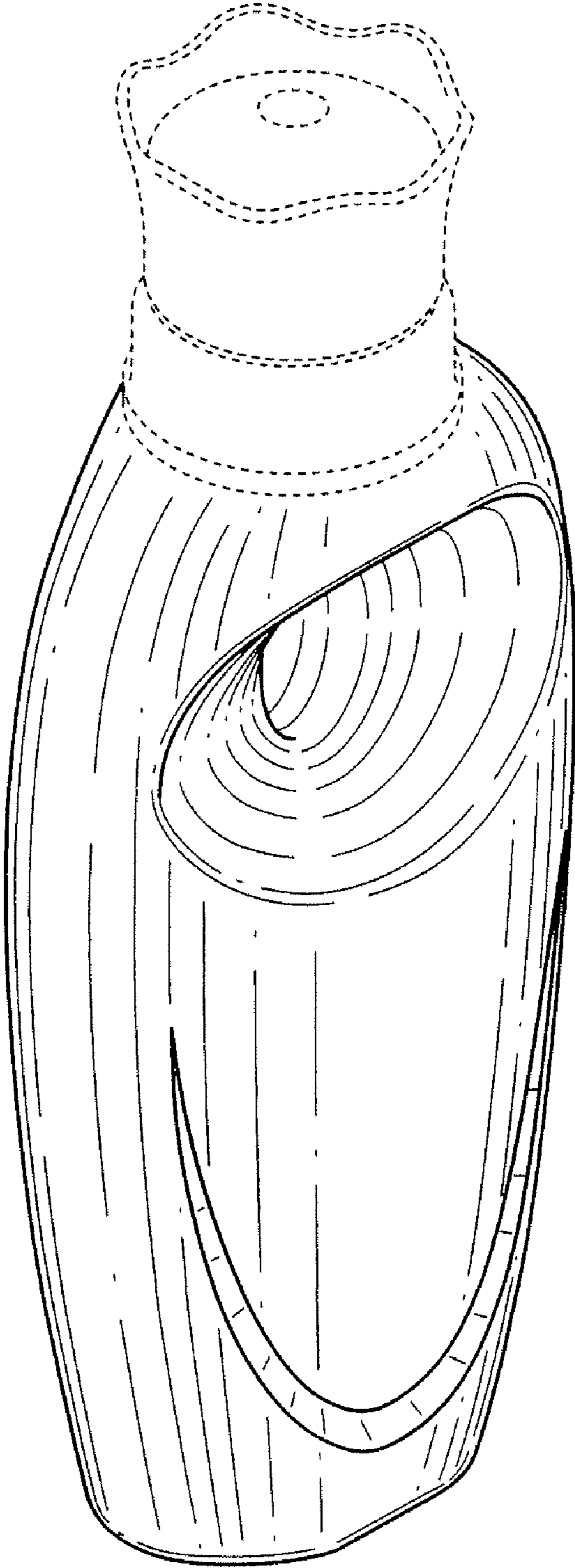

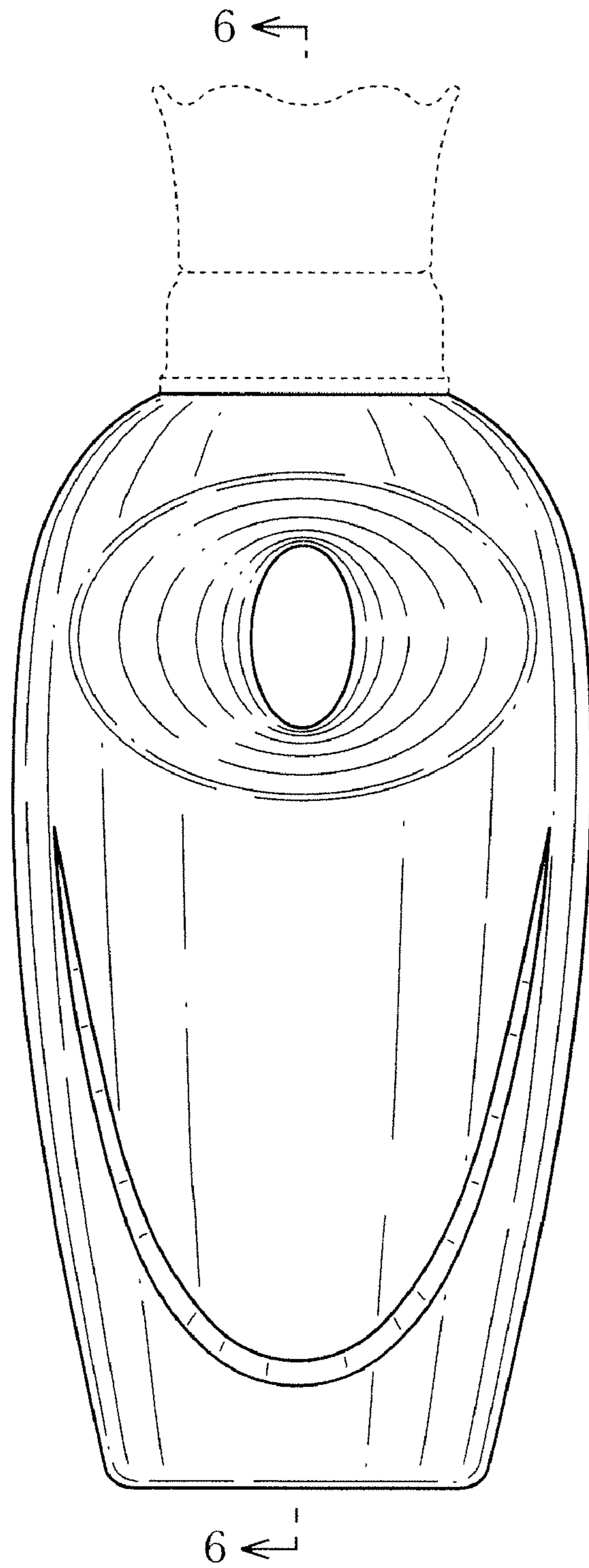

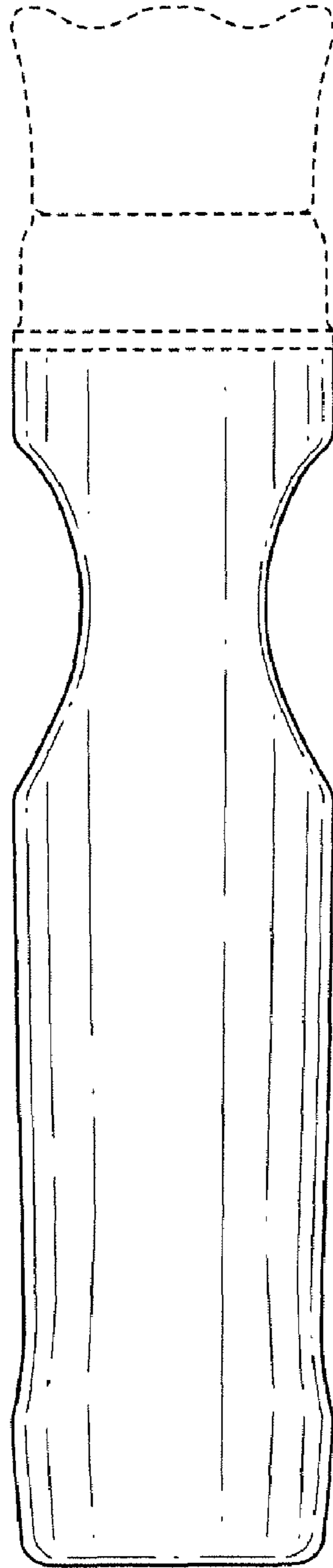

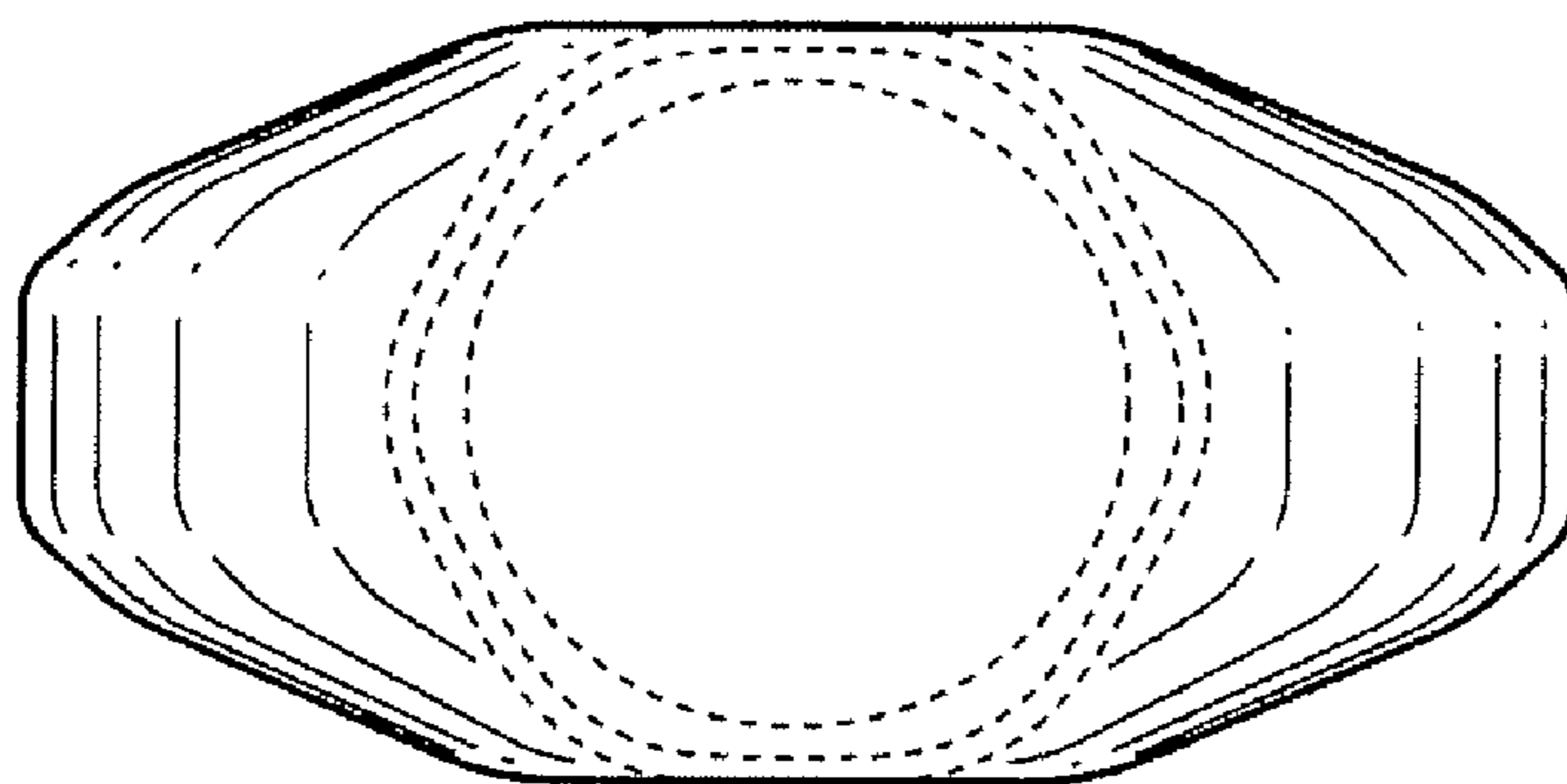

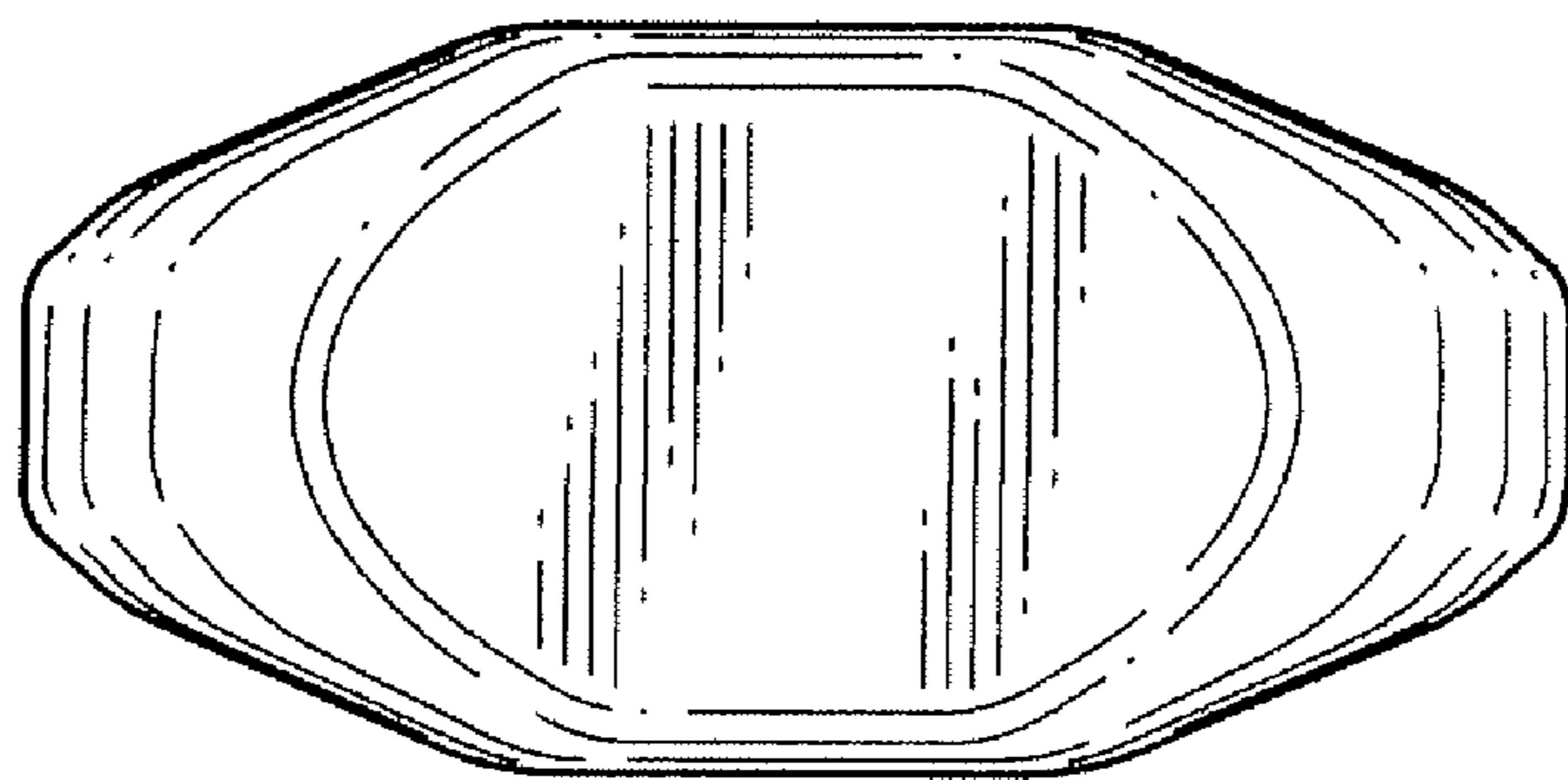

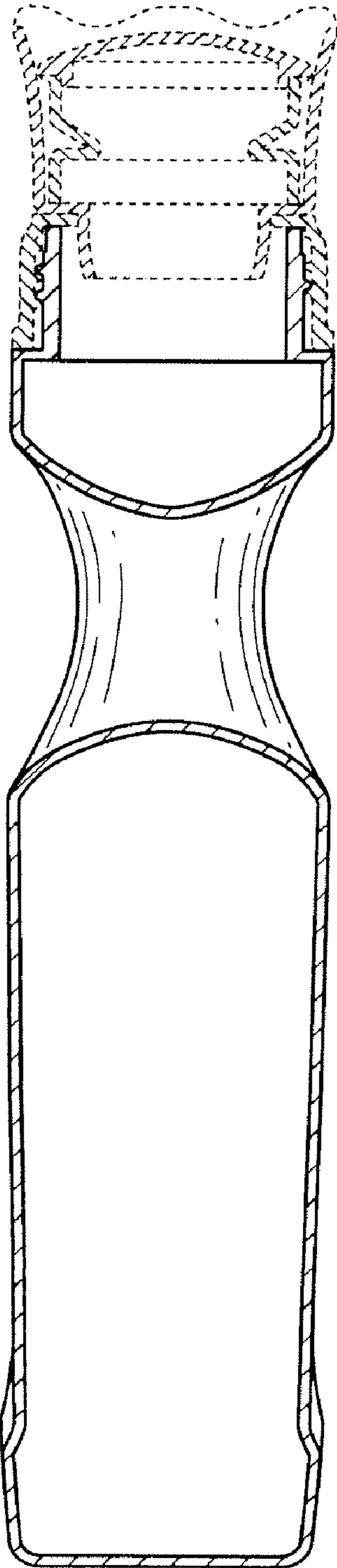
