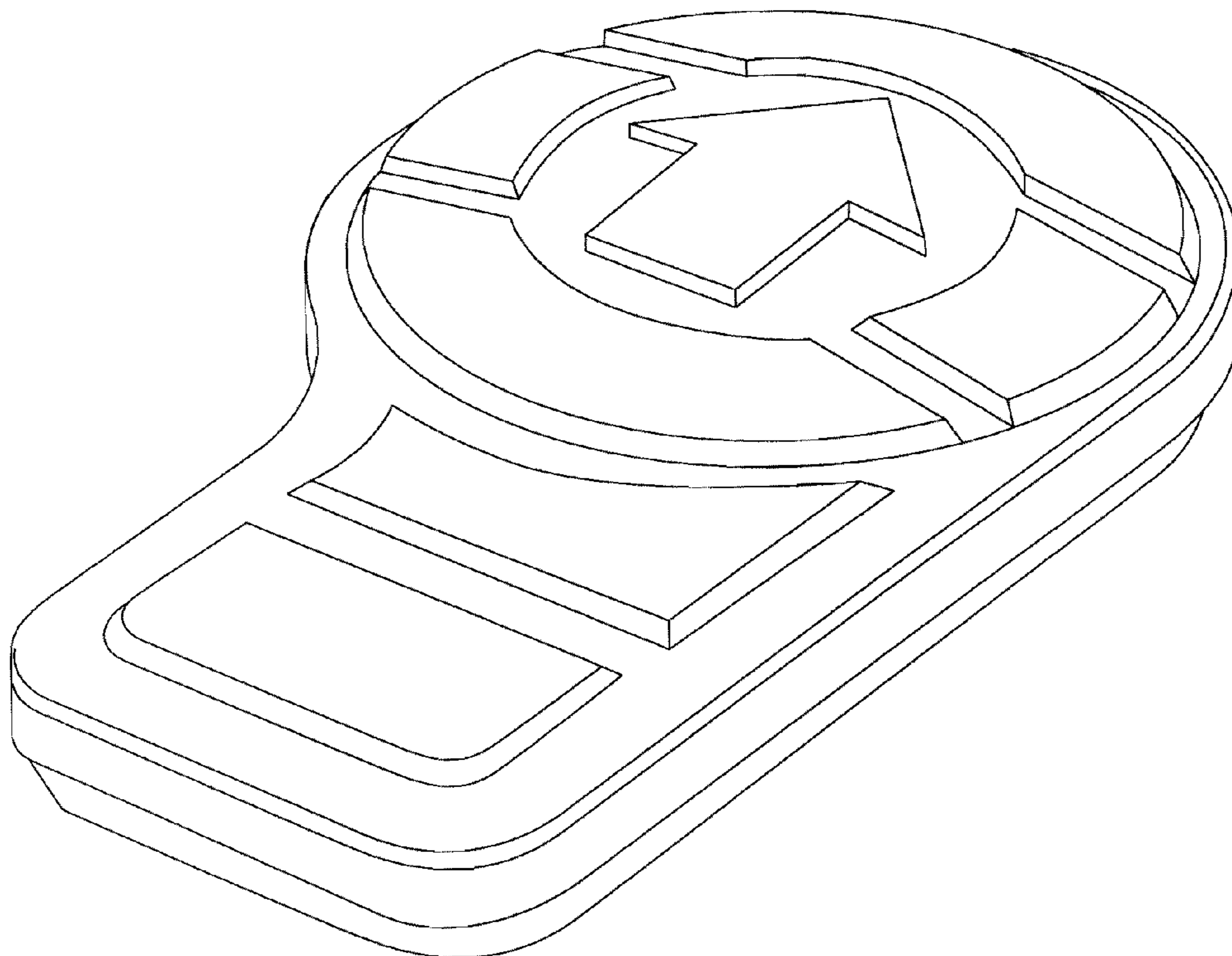
The ornamental design for a pedal cover for a vehicle, as shown and described.

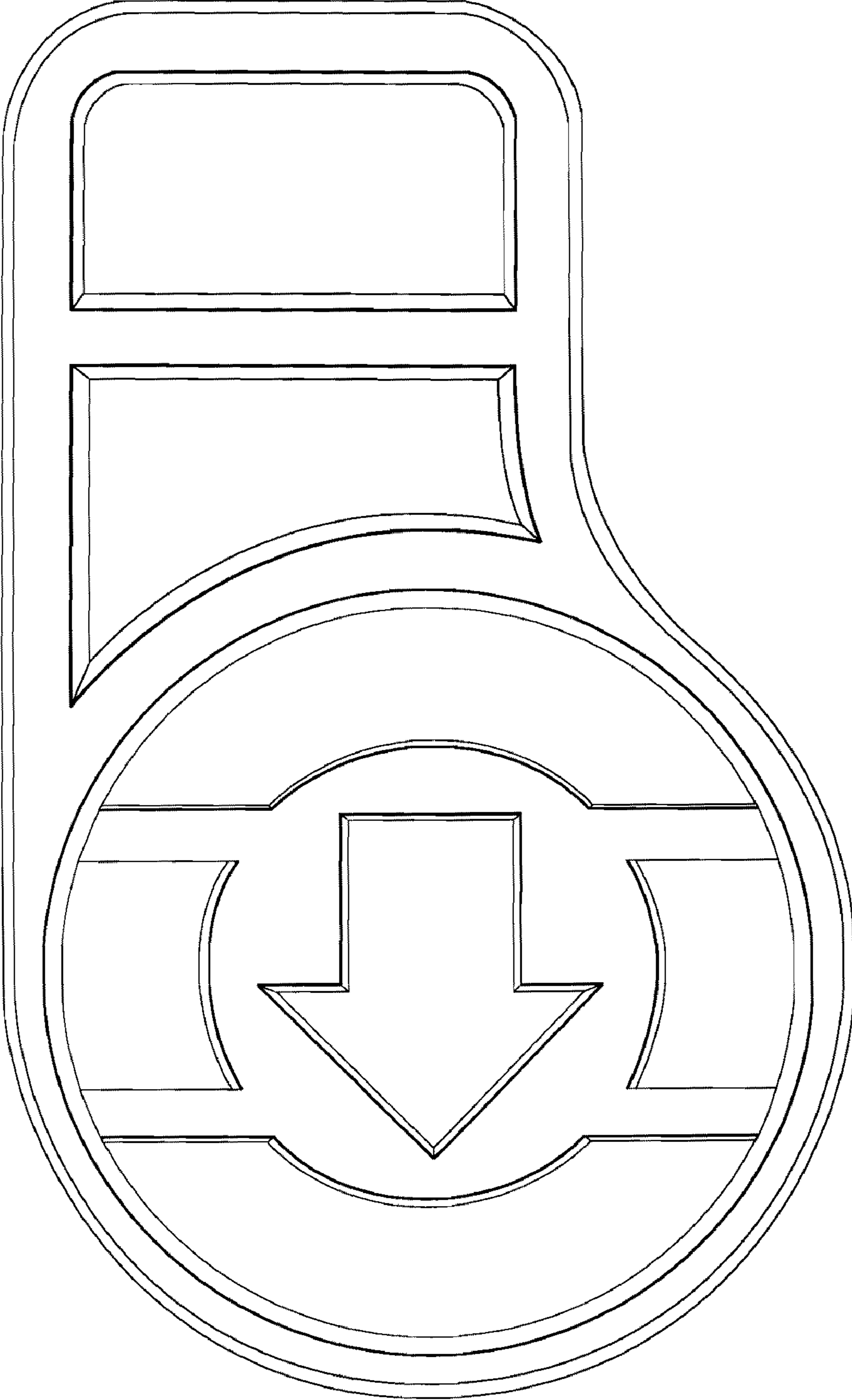
**DESCRIPTION**

The broken line showing in FIG. 7 is environmental only and not part of the claimed design.

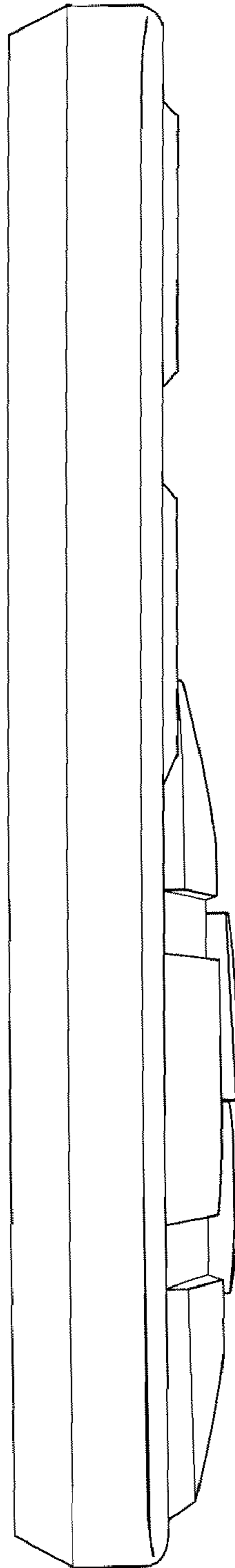

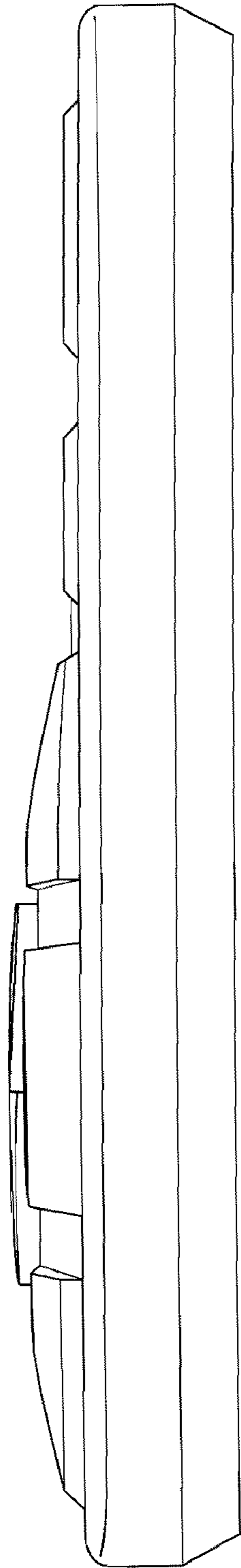




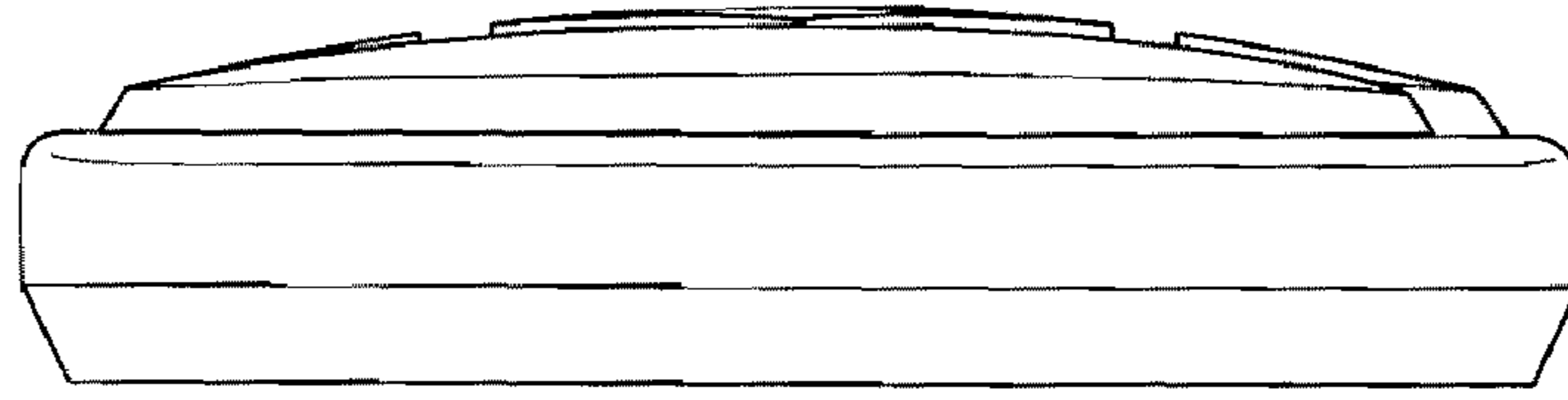

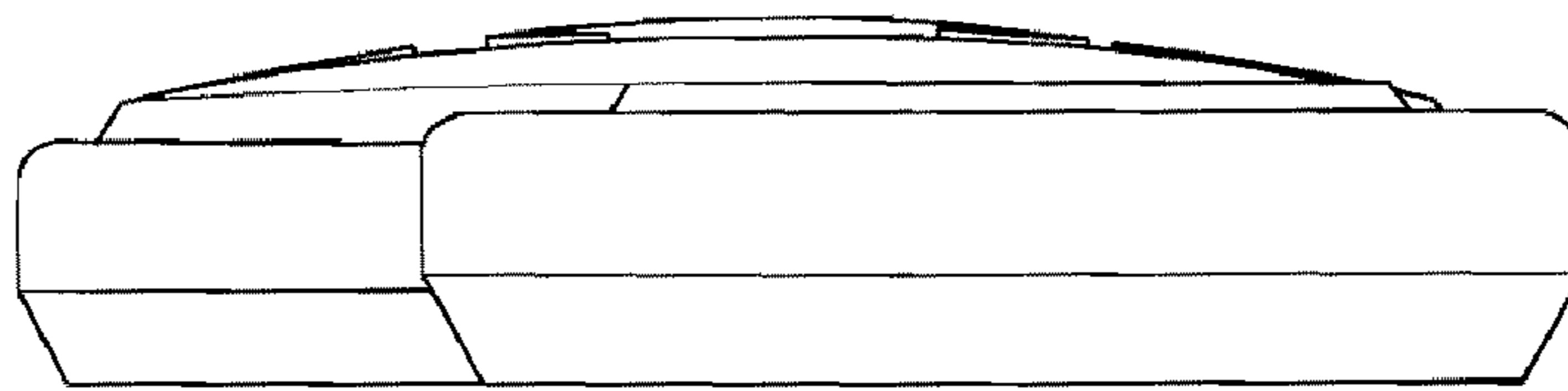

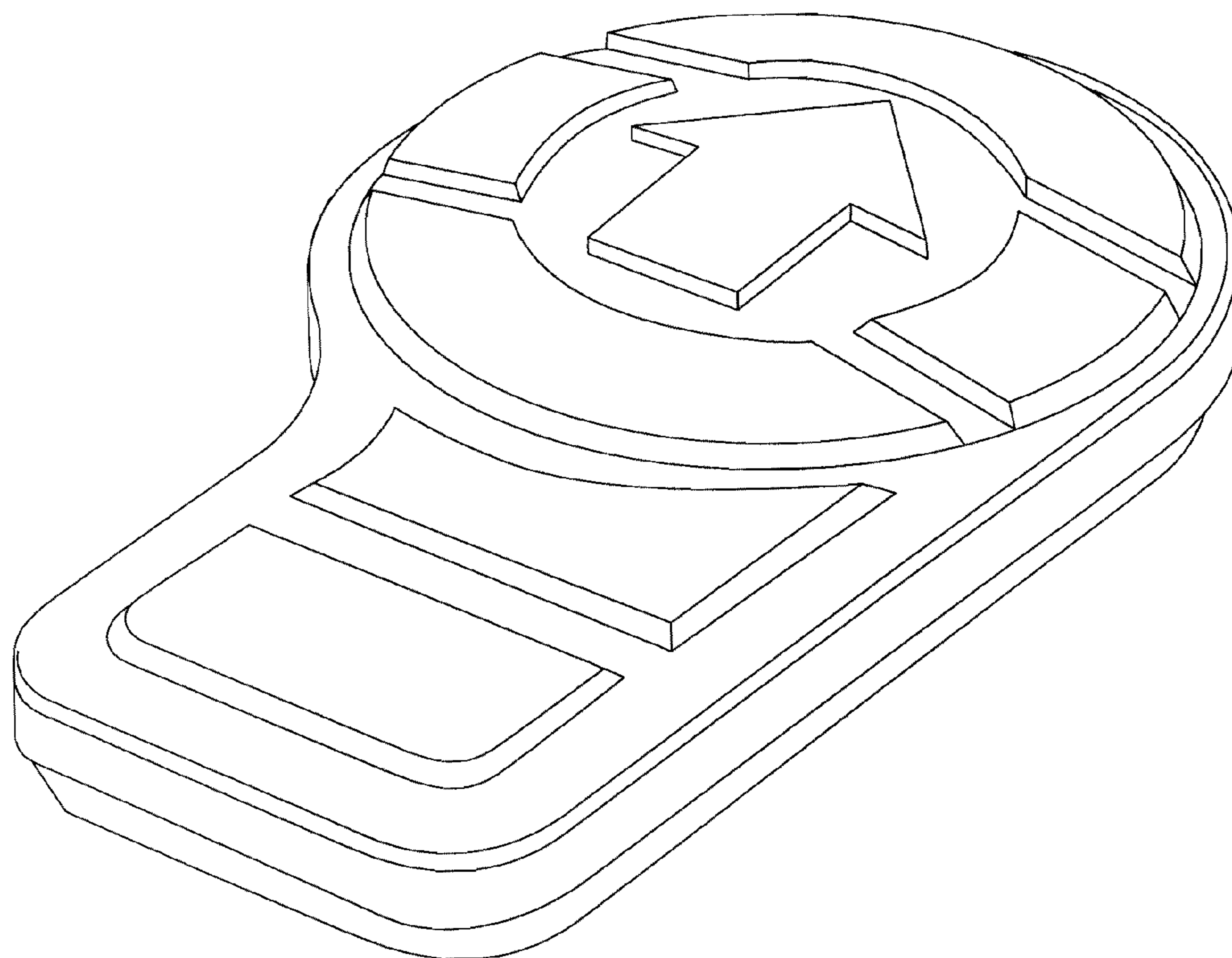

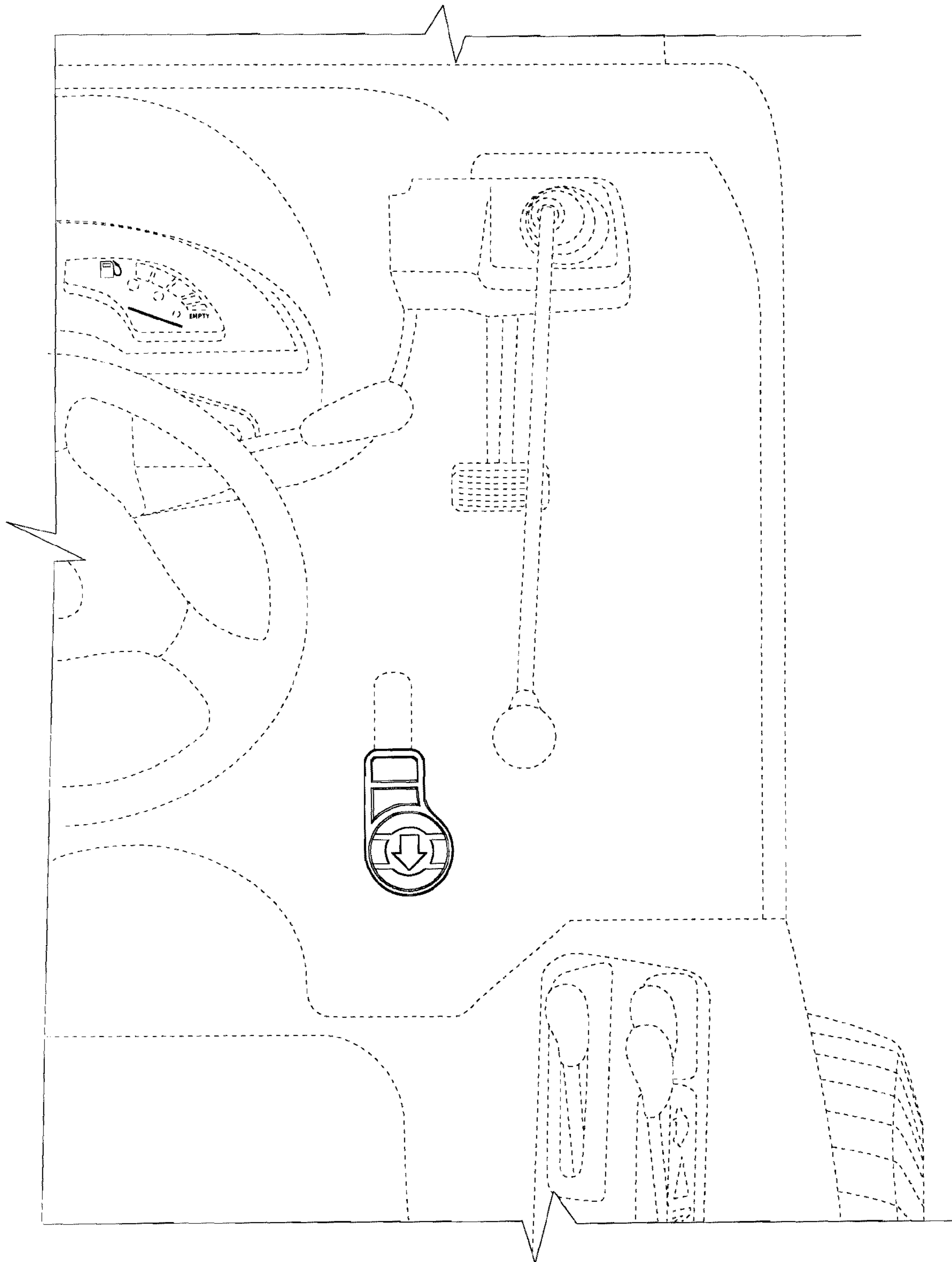
