The ornamental design for a rechargeable battery, as shown and described.

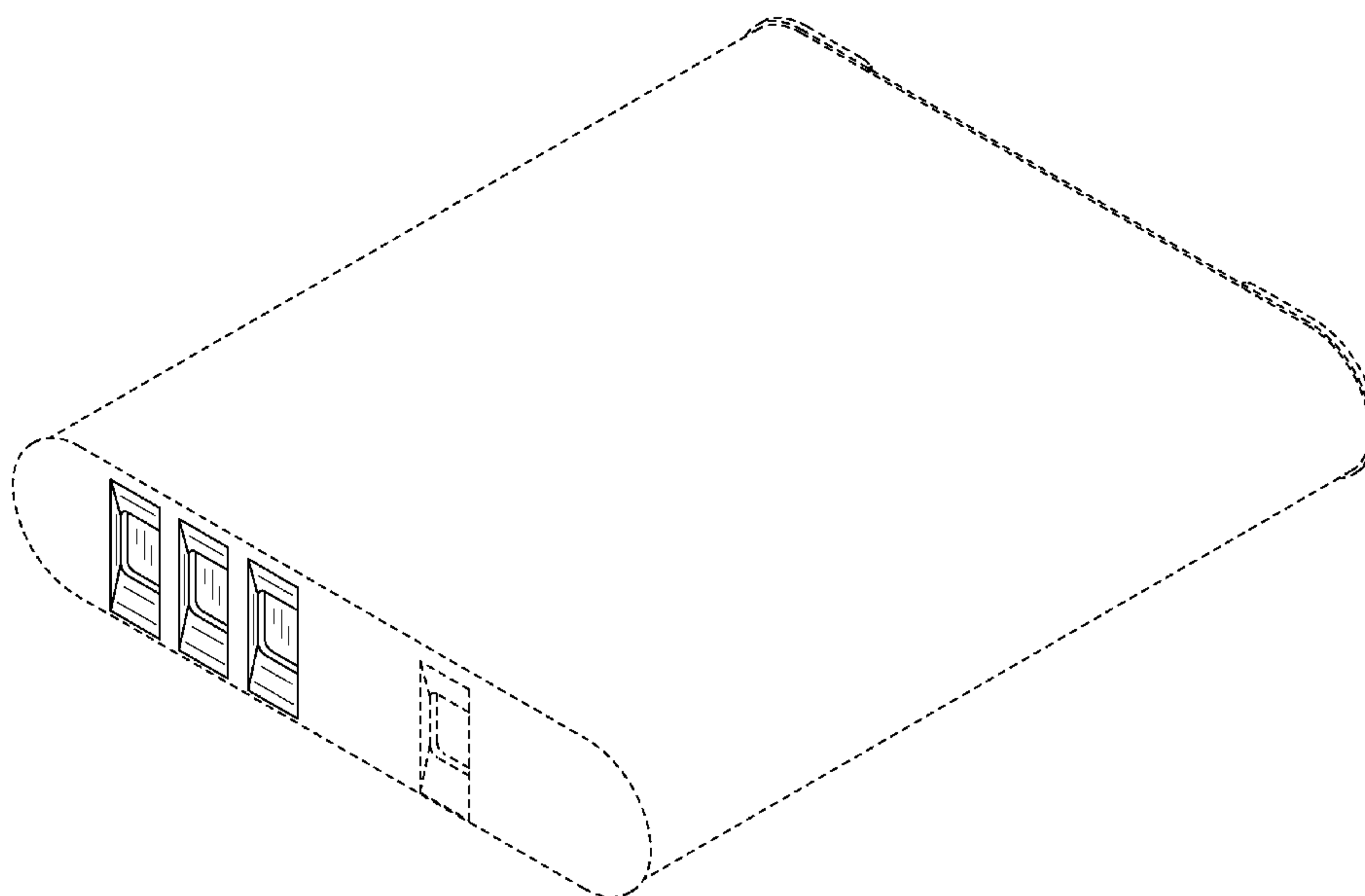
DESCRIPTION

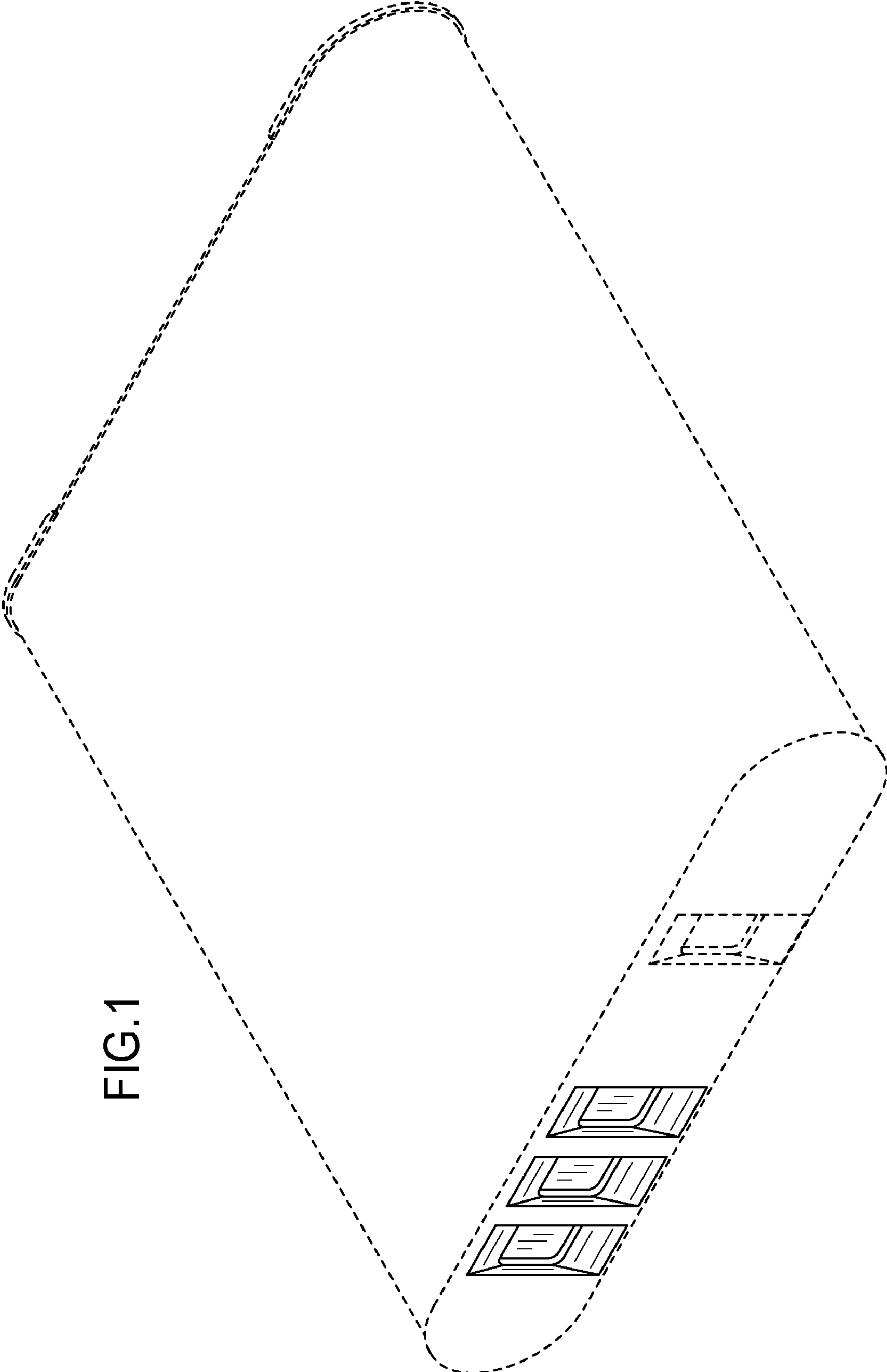
