FIG. 3 is a right side plan view of thereof.

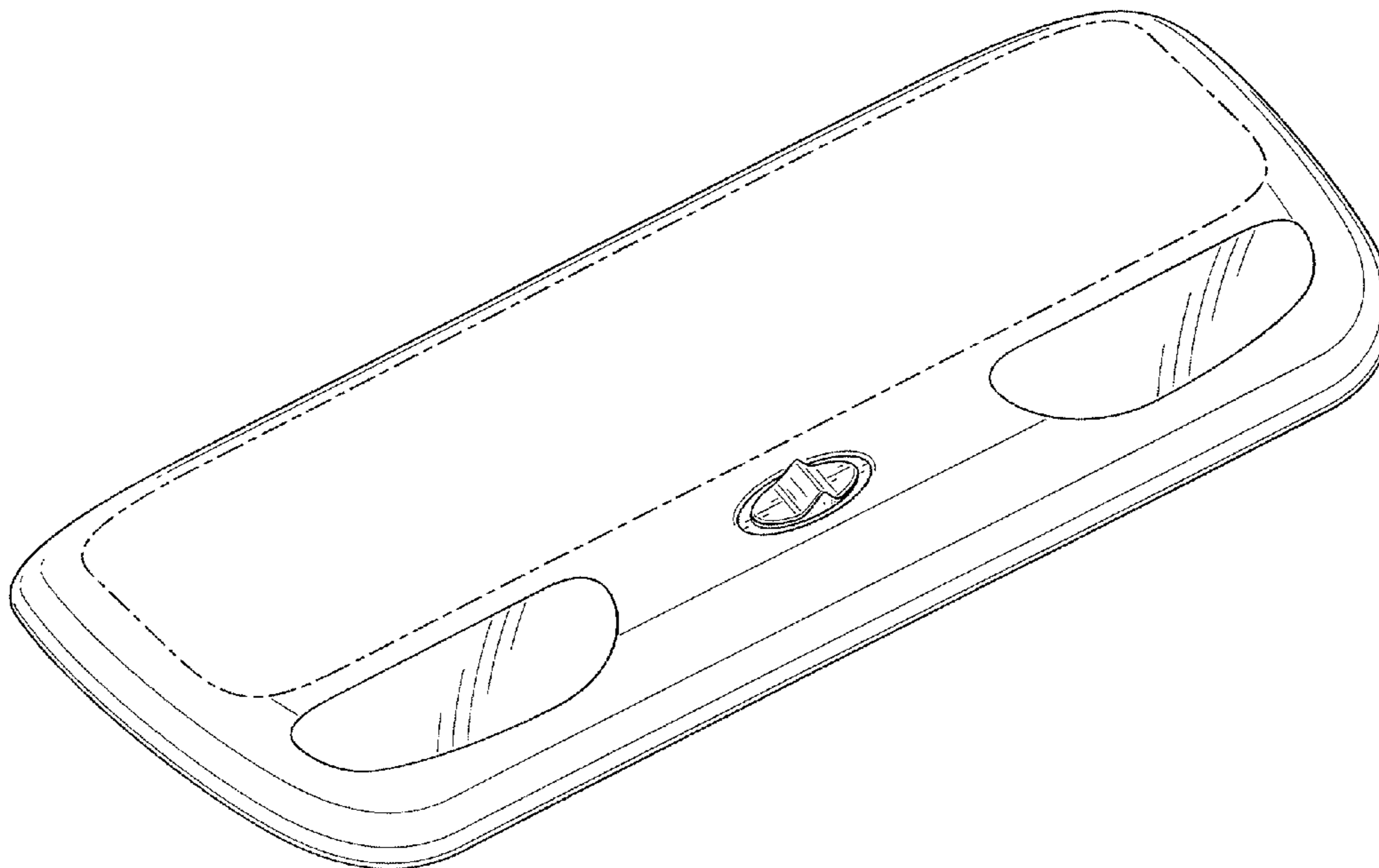
FIG. 4 is a left side plan view of thereof.

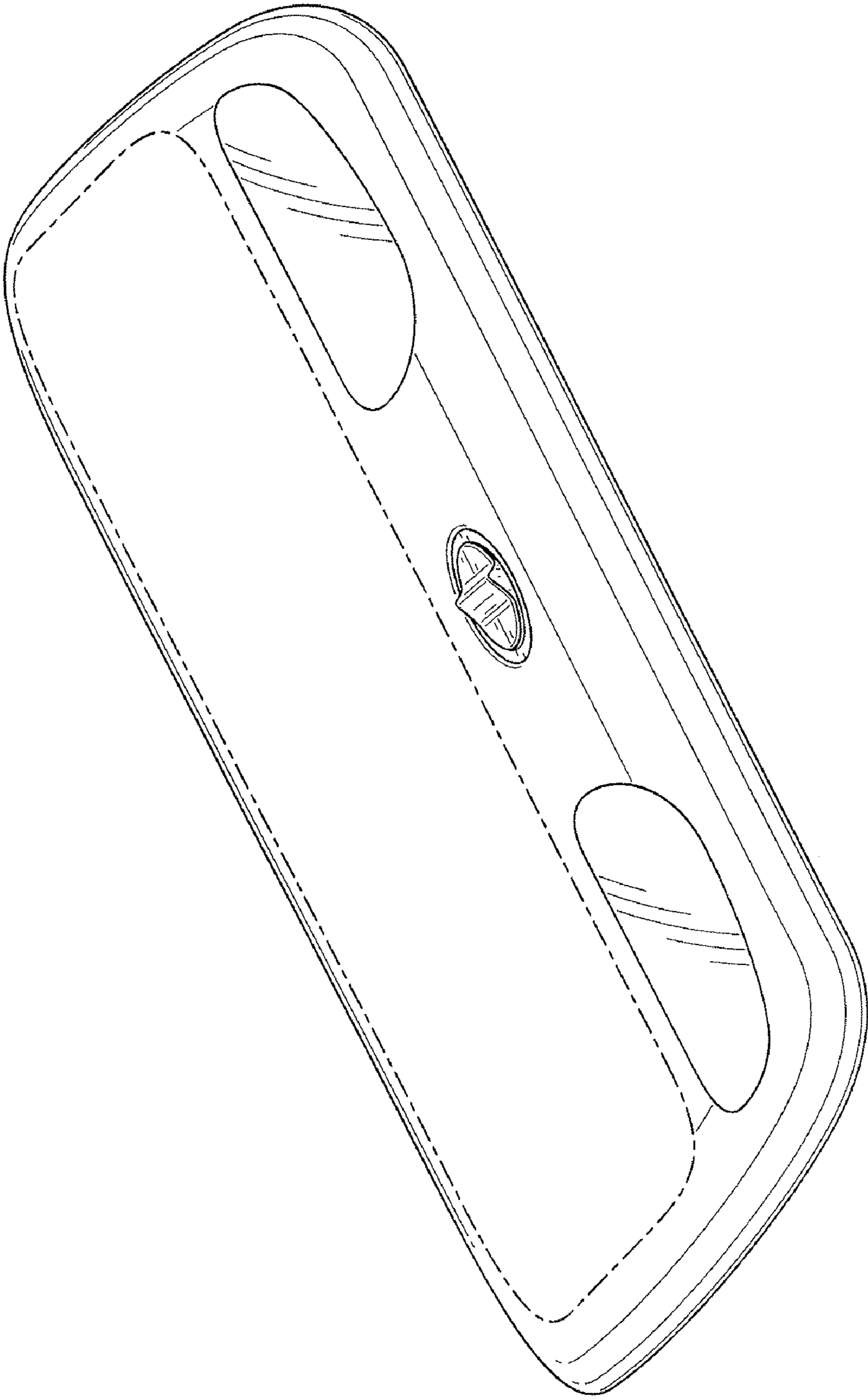

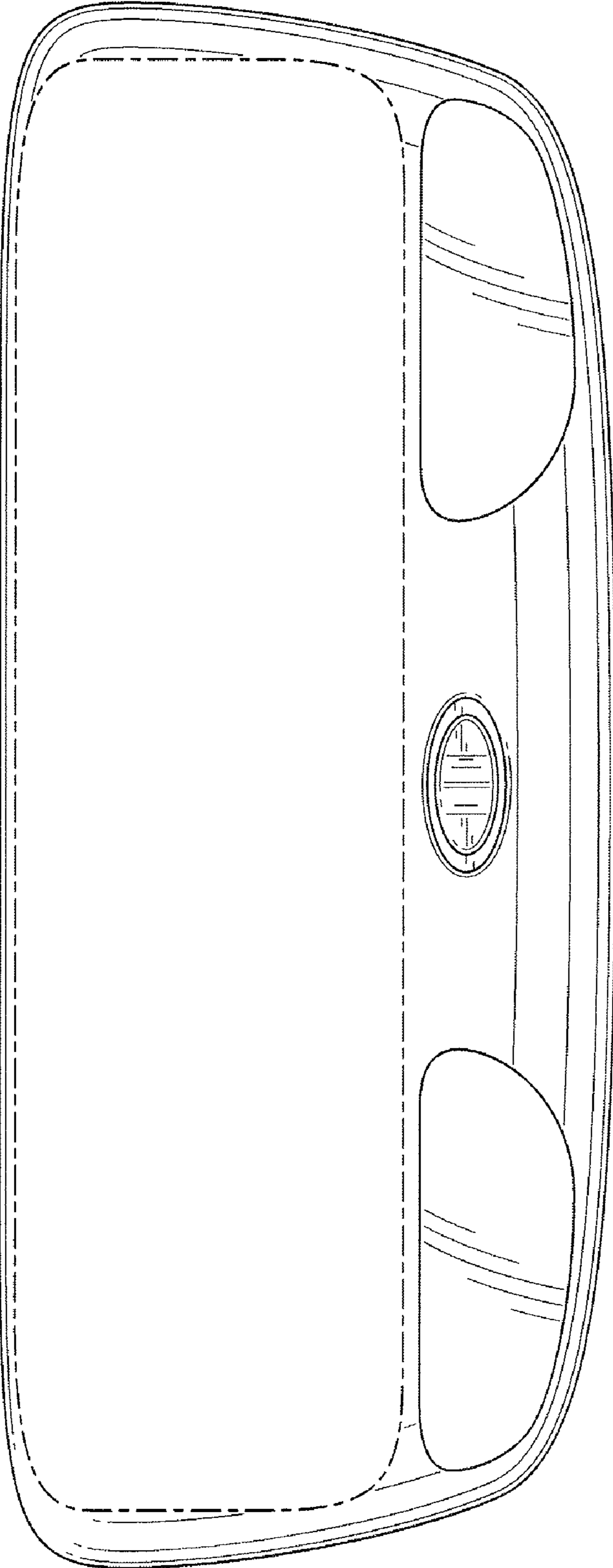

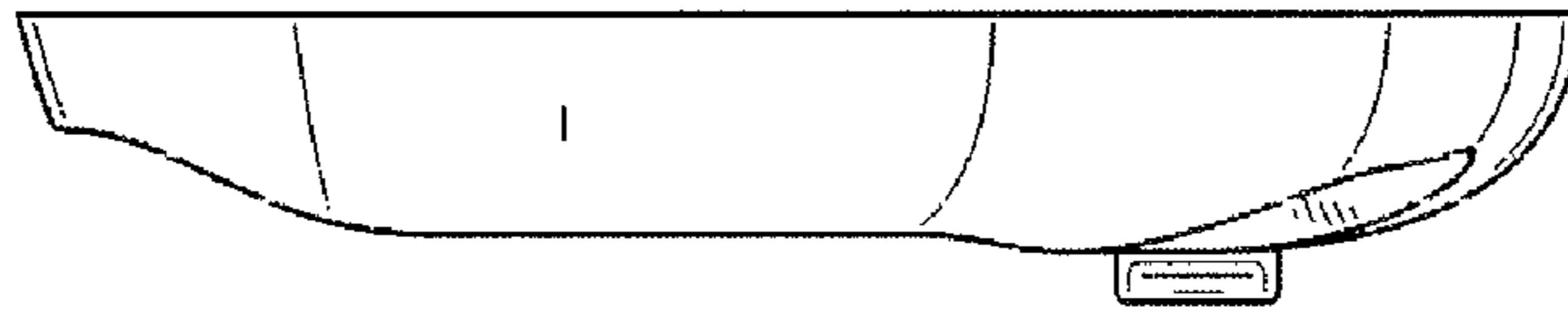

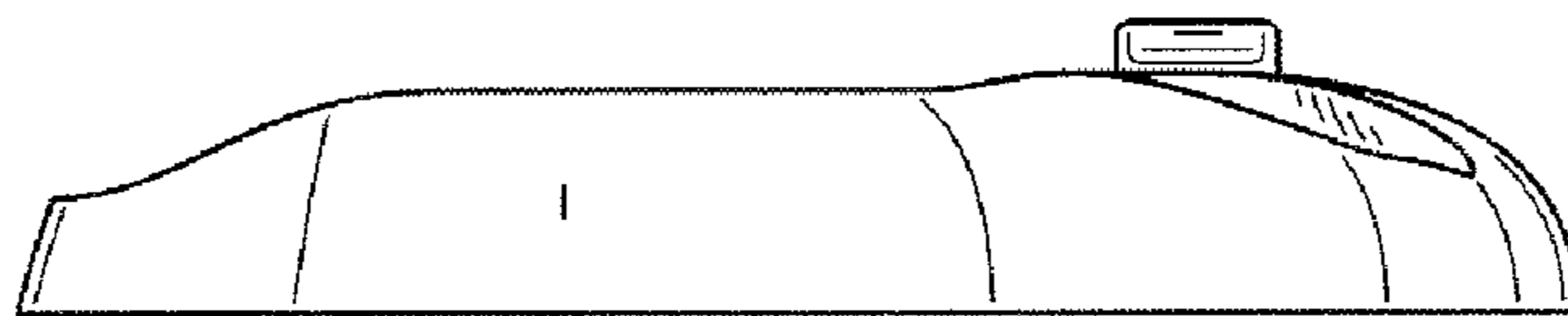

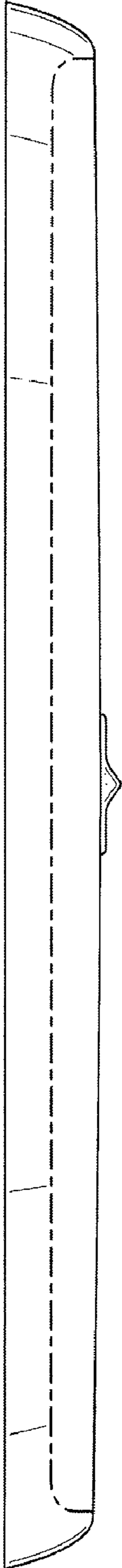

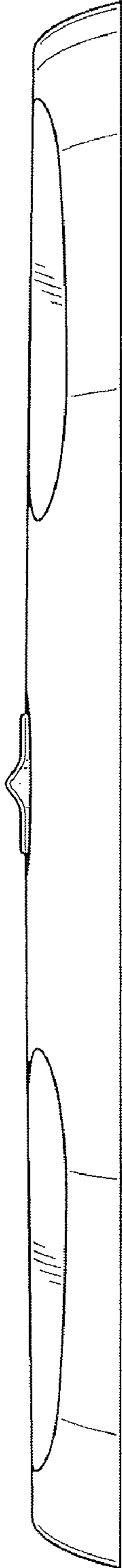
