**DESCRIPTION**

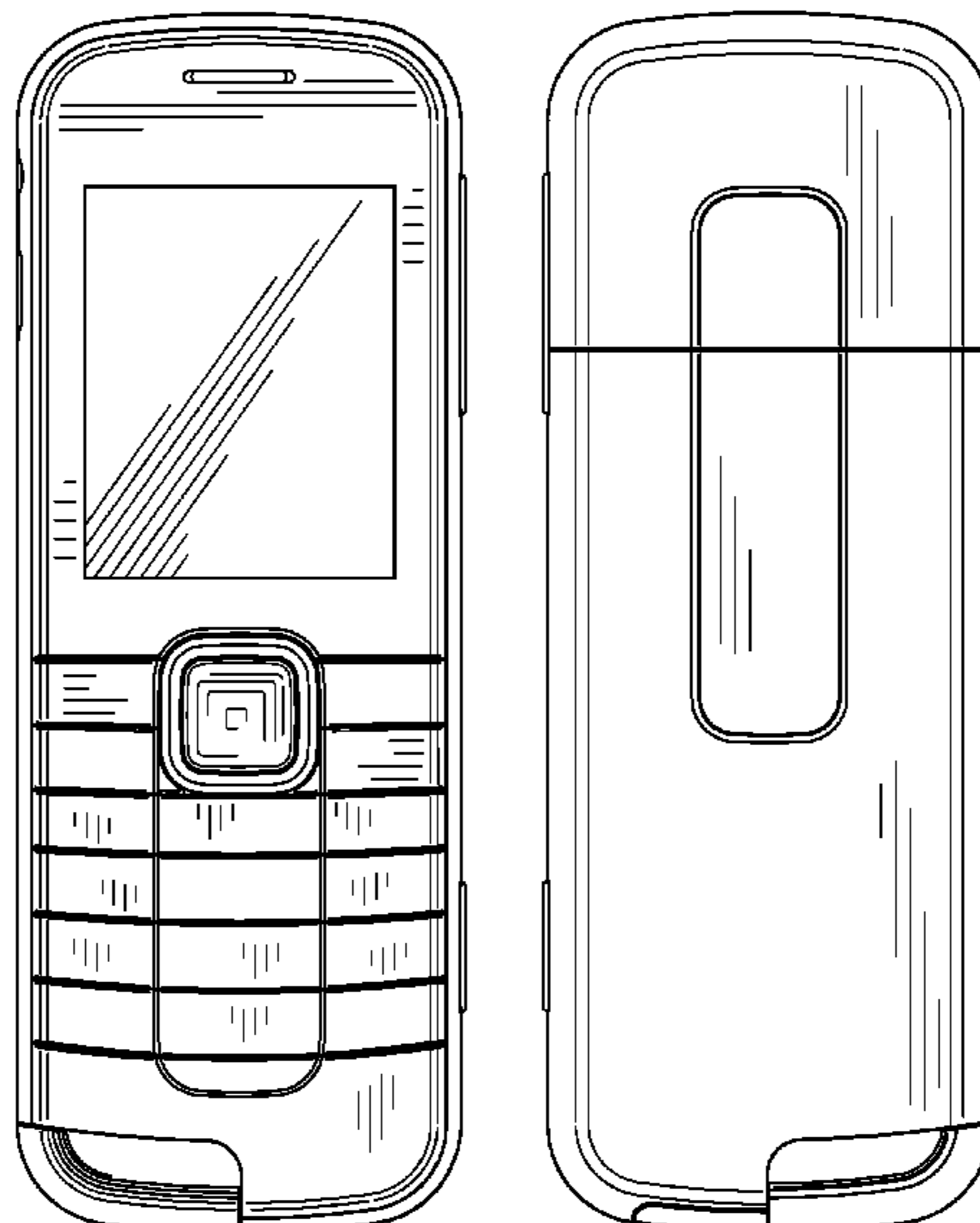

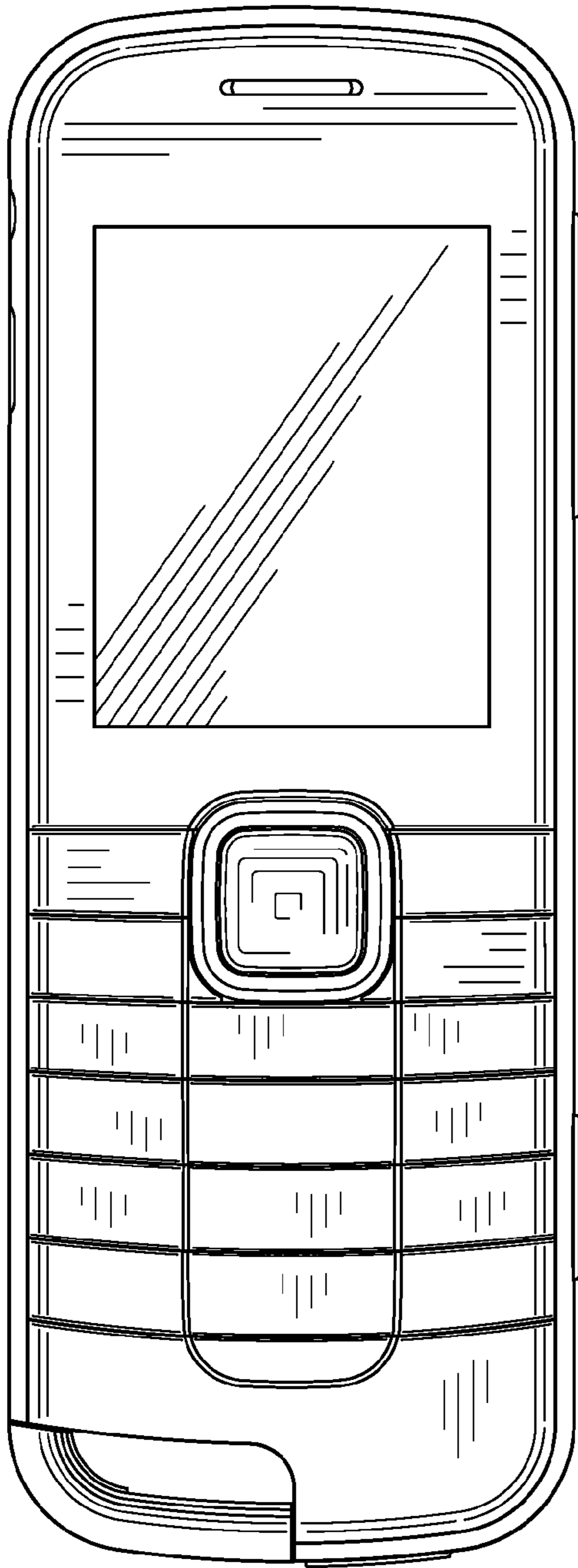

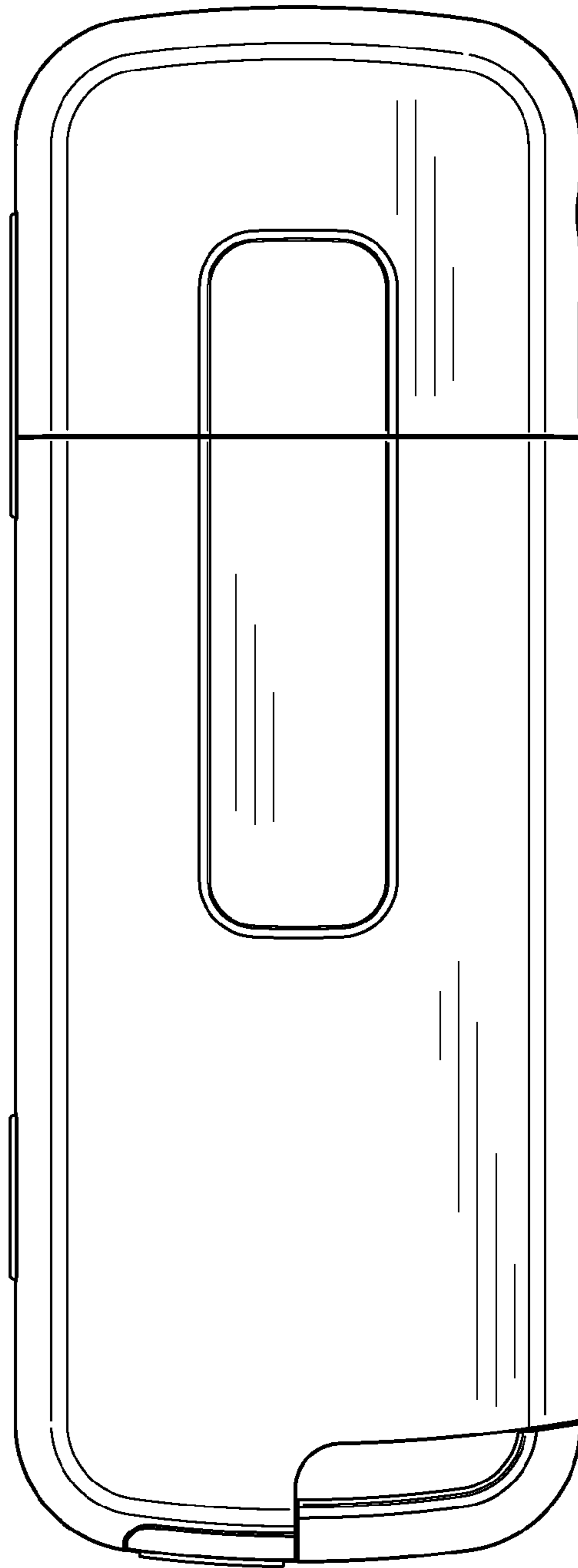

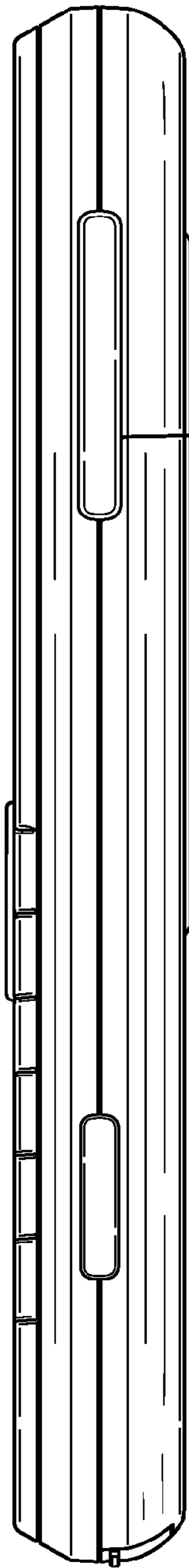

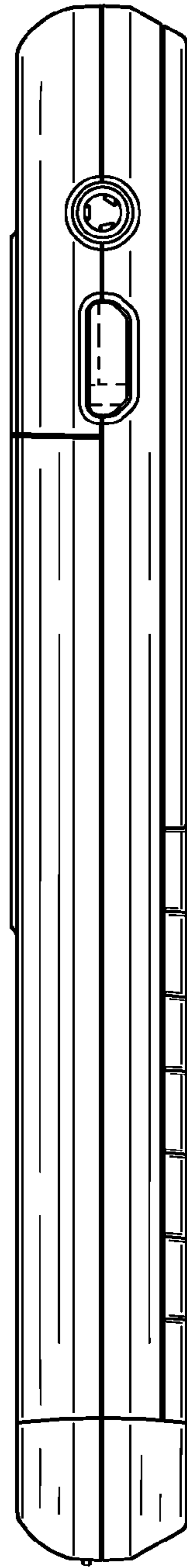

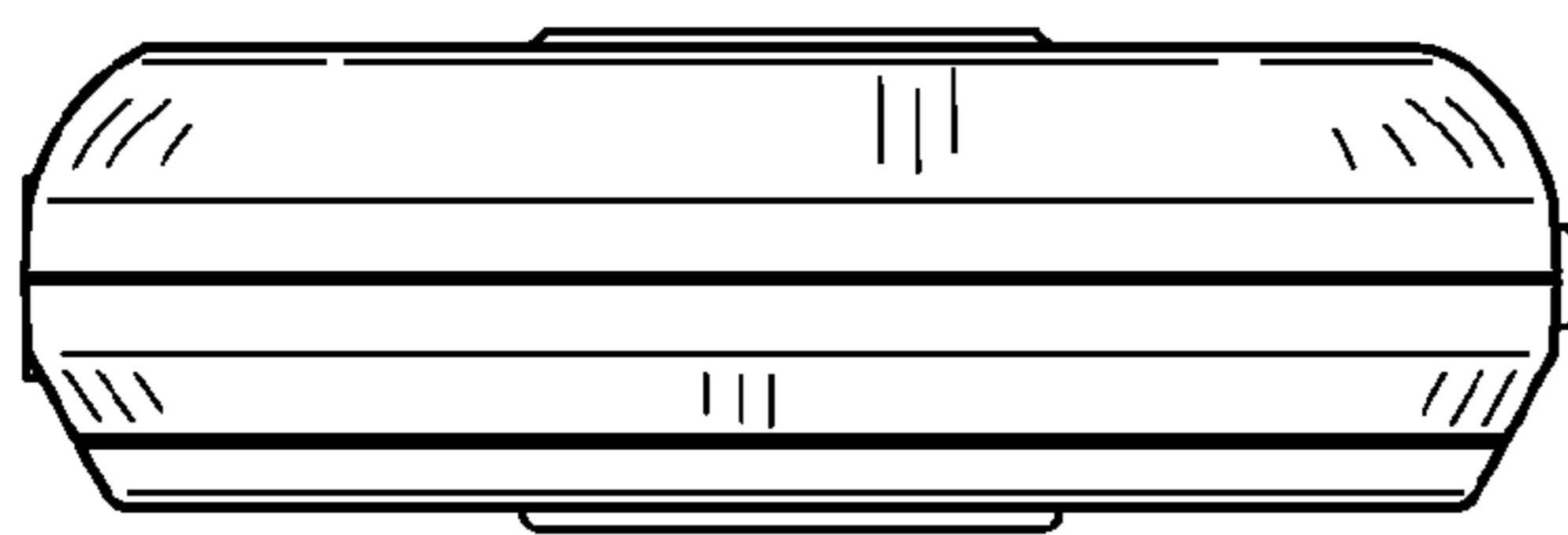

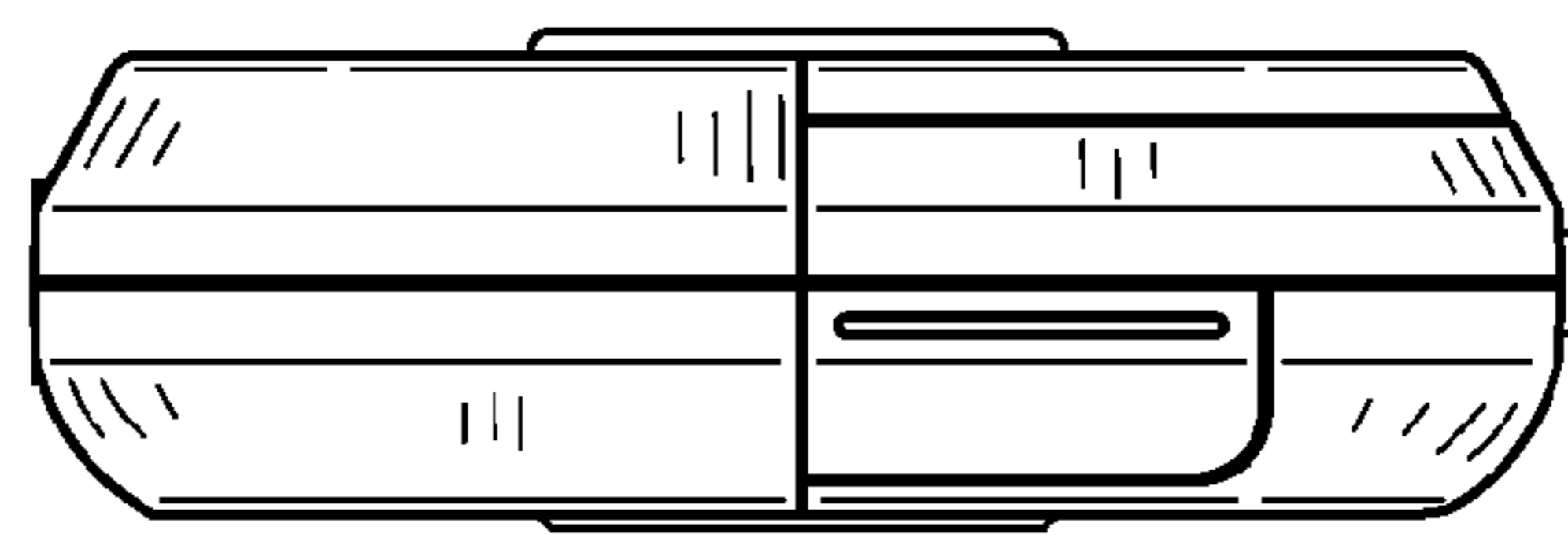
