(57) **CLAIM**

I claim, the ornamental design for a hot air blower, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hot air blower, showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is an enlarged left side elevational view thereof;

FIG. 5 is an enlarged right side elevational view thereof;

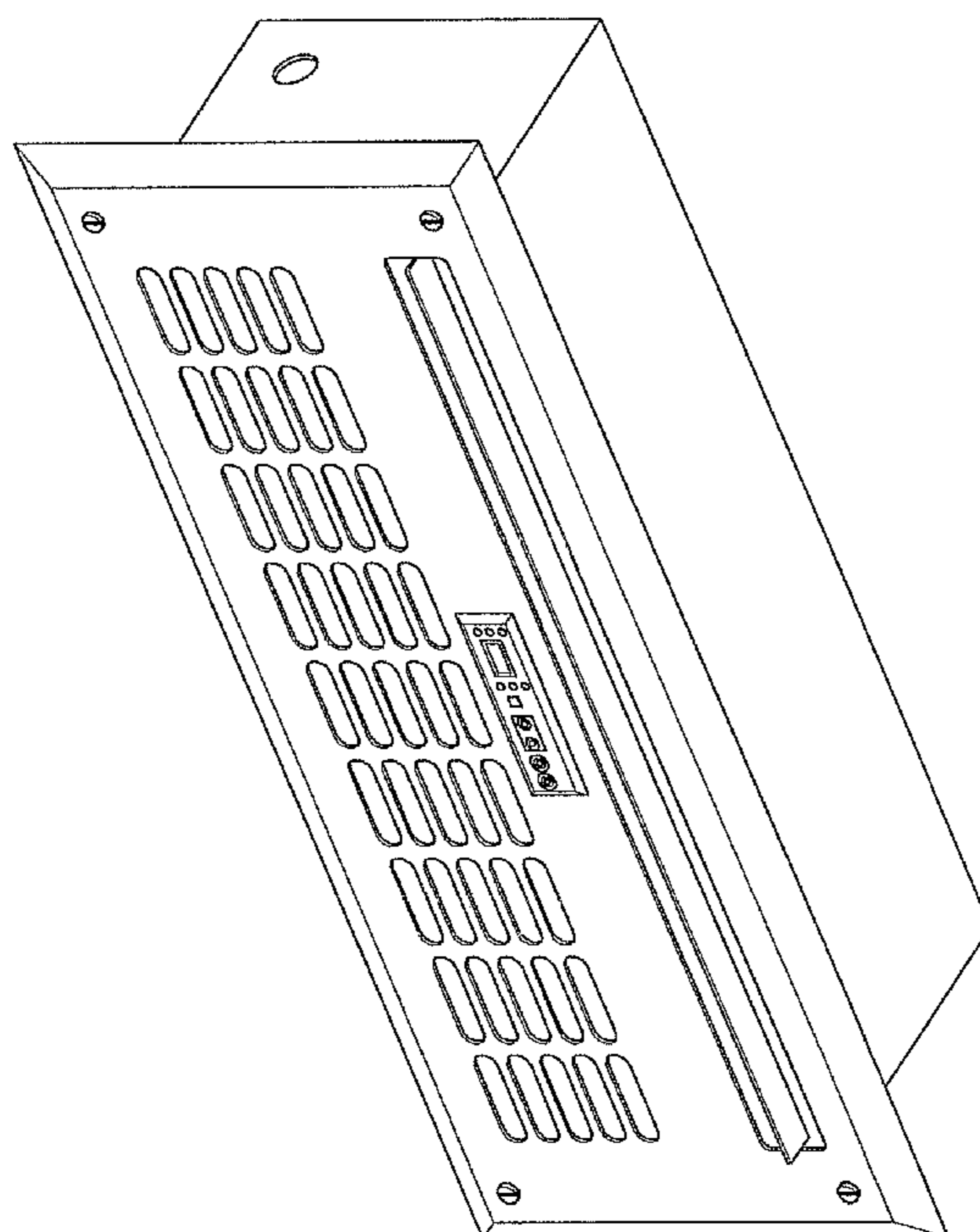

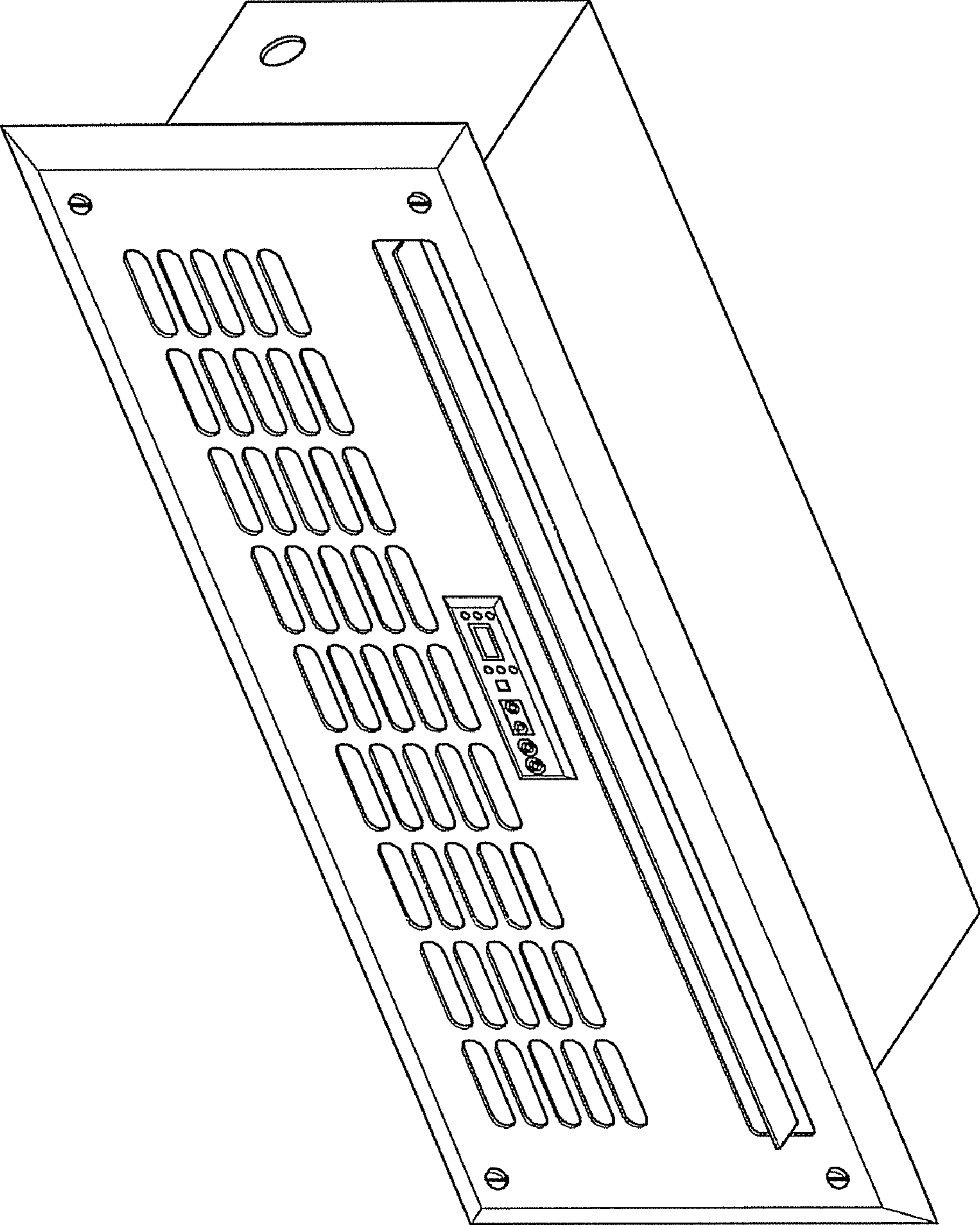

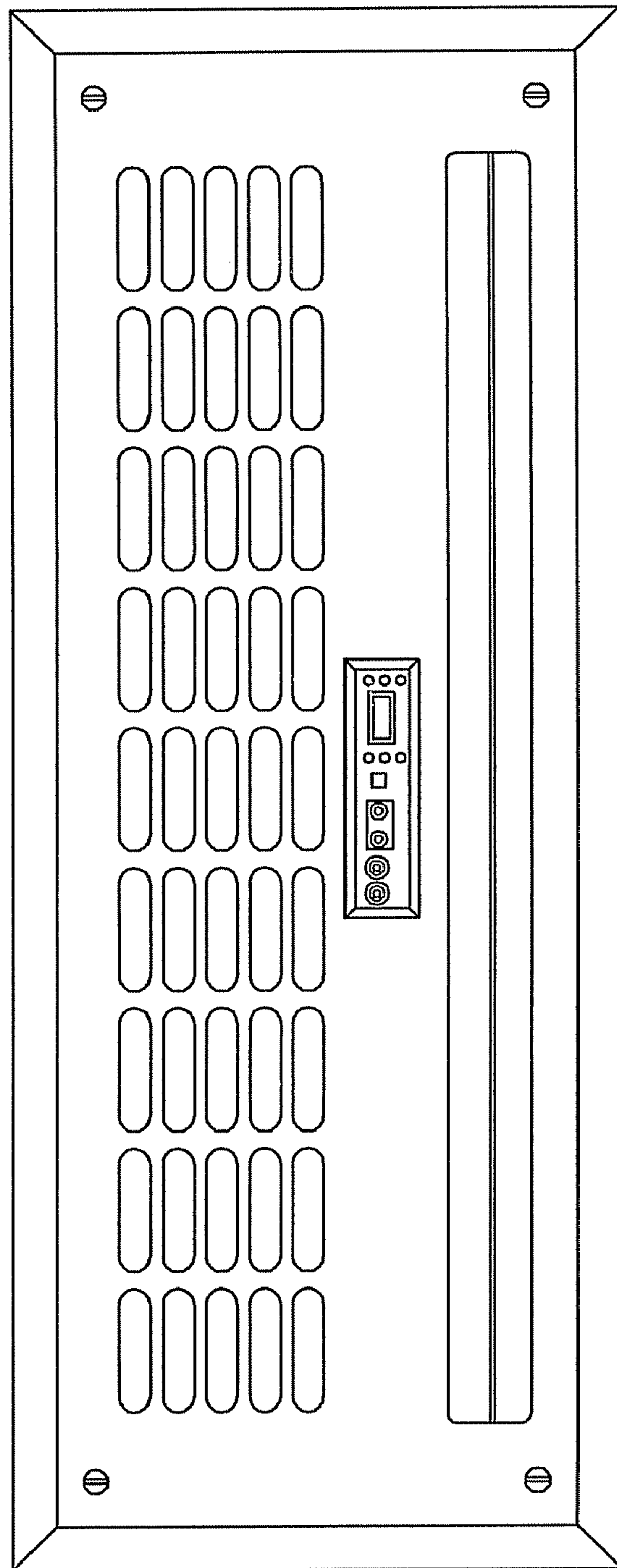

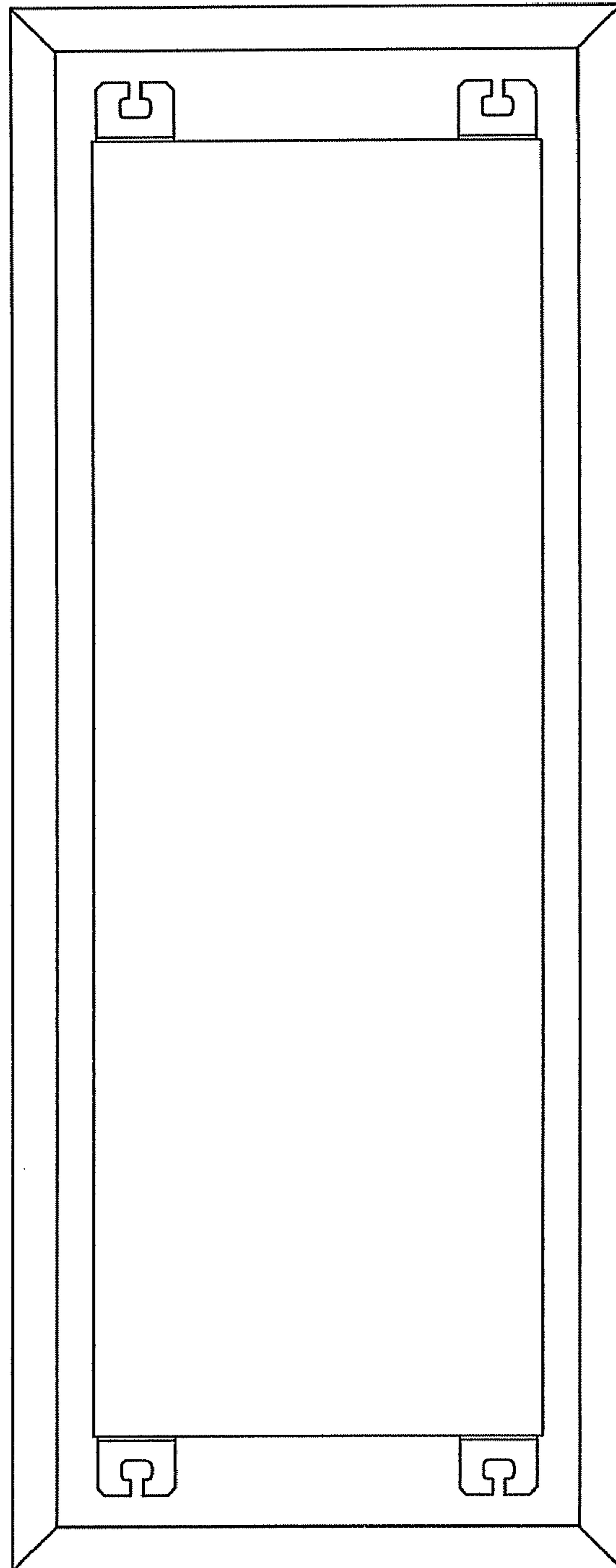

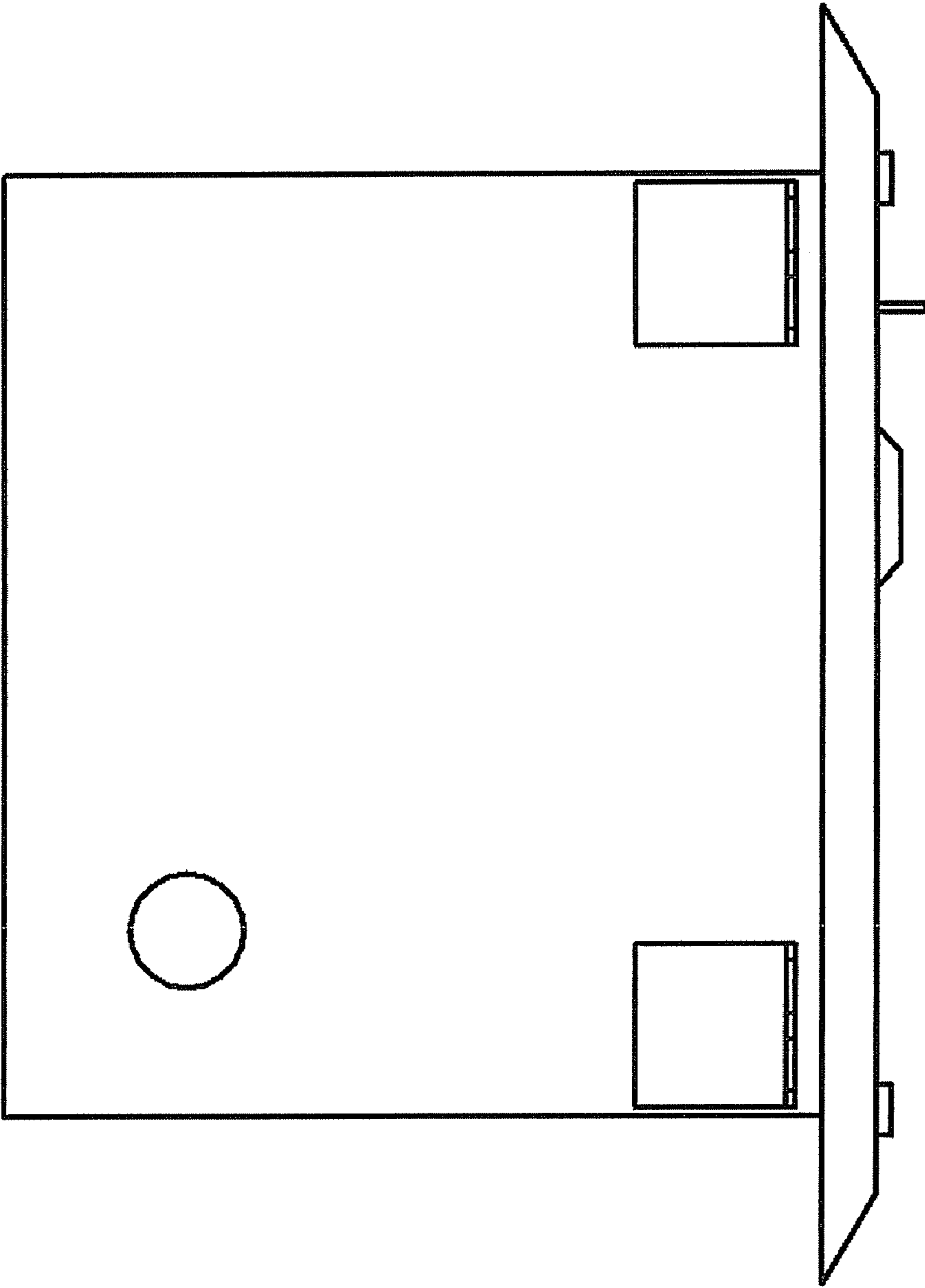

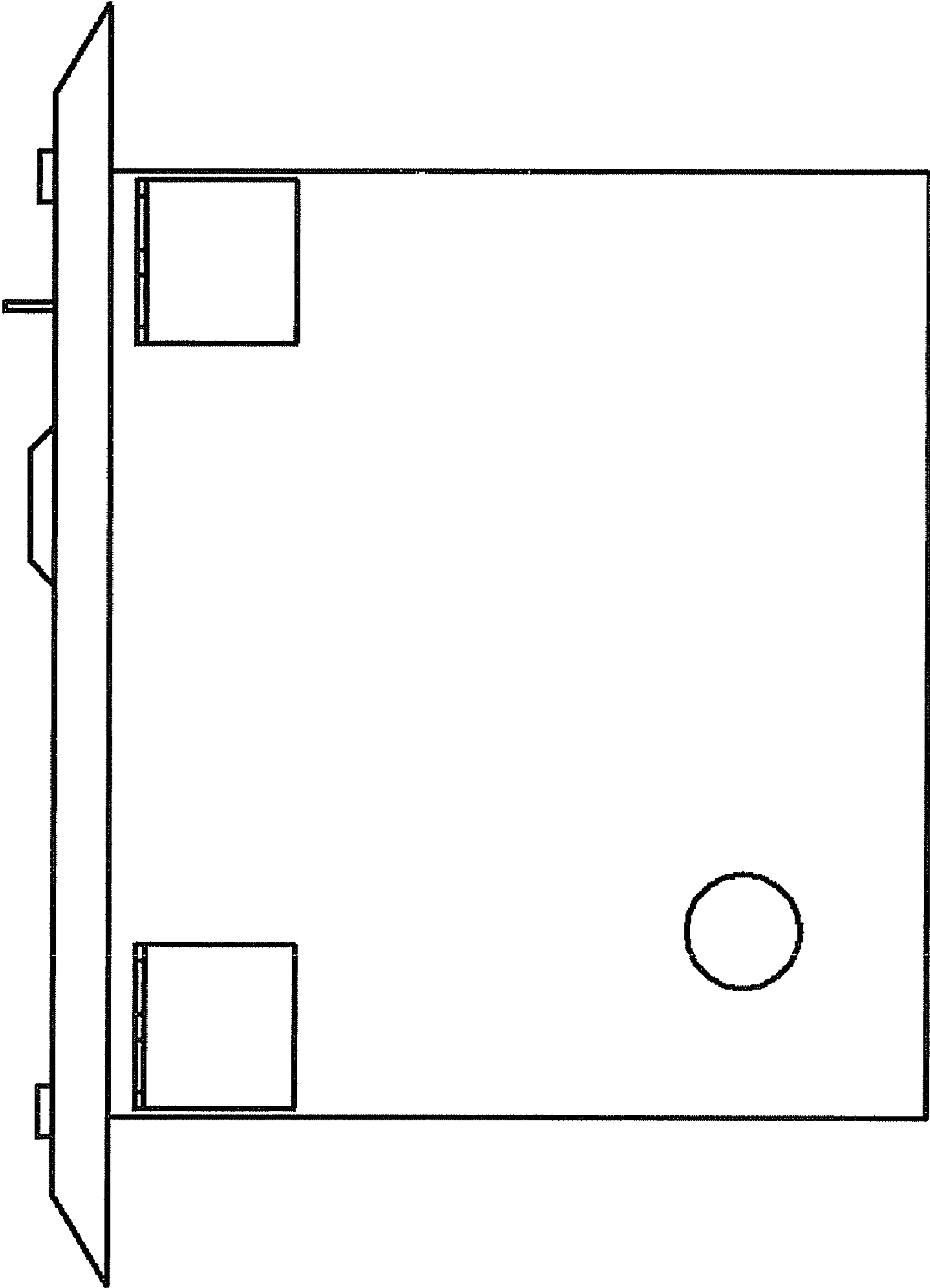

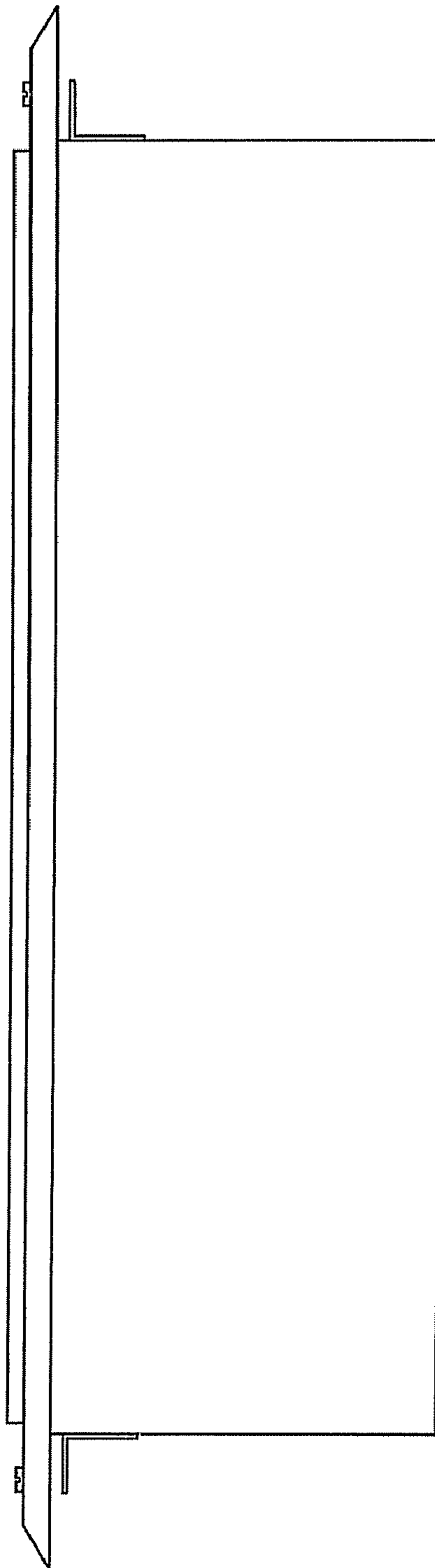
