(57) **CLAIM**

The ornamental design for an enhanced visibility safety garment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the enhanced visibility safety garment of my new design, shown in a closed position as it would look when worn by a wearer (not shown);

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right side elevational view view thereof;

FIG. 5 is a left side elevational view view thereof;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom view thereof.

The fragmentary criss-cross pattern shown in the Drawing represents fabric and is repeated uniformly throughout the areas shown.

The fragmentary stippled pattern shown in the Drawing represents mesh fabric and is repeated uniformly throughout the areas shown.

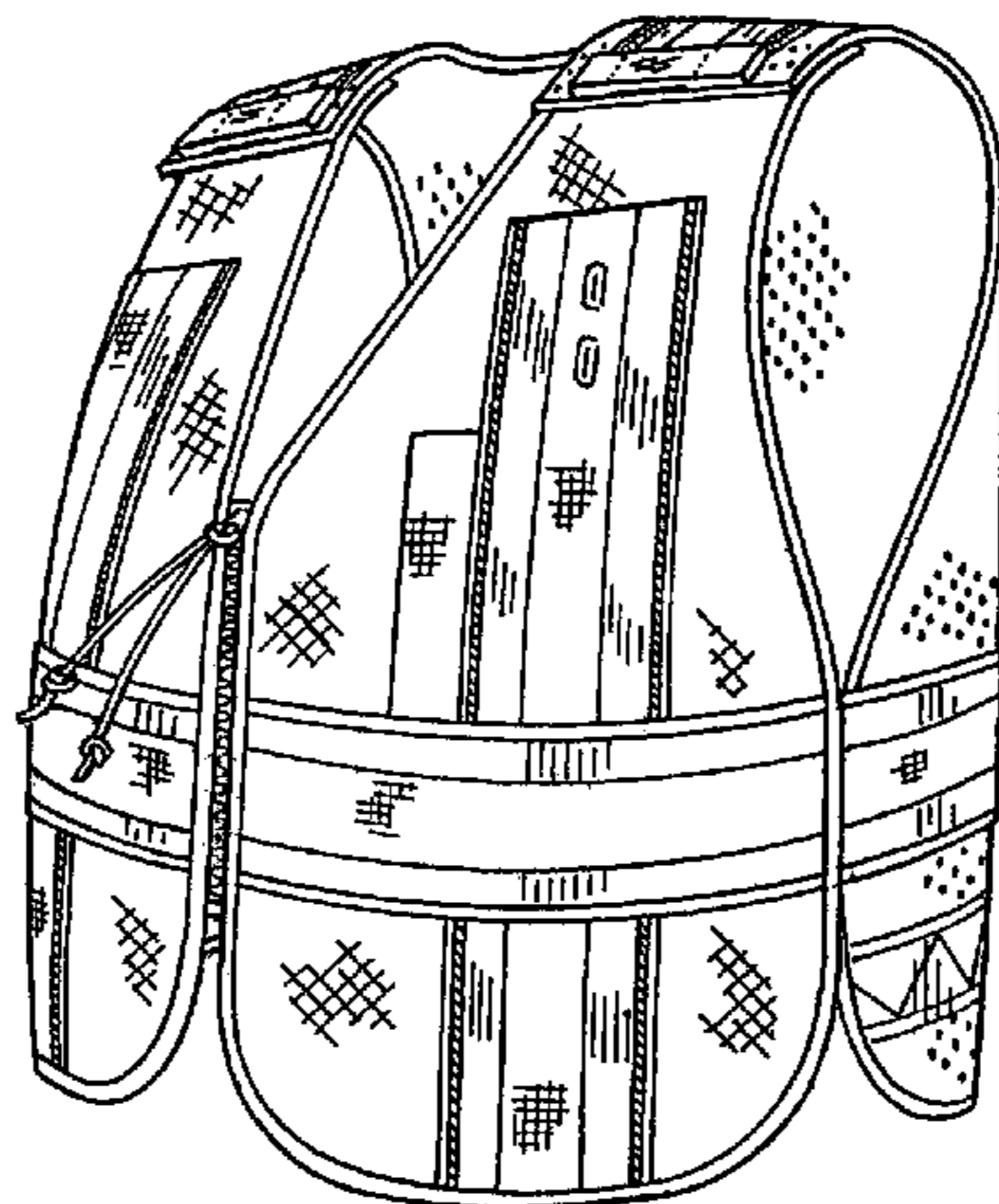

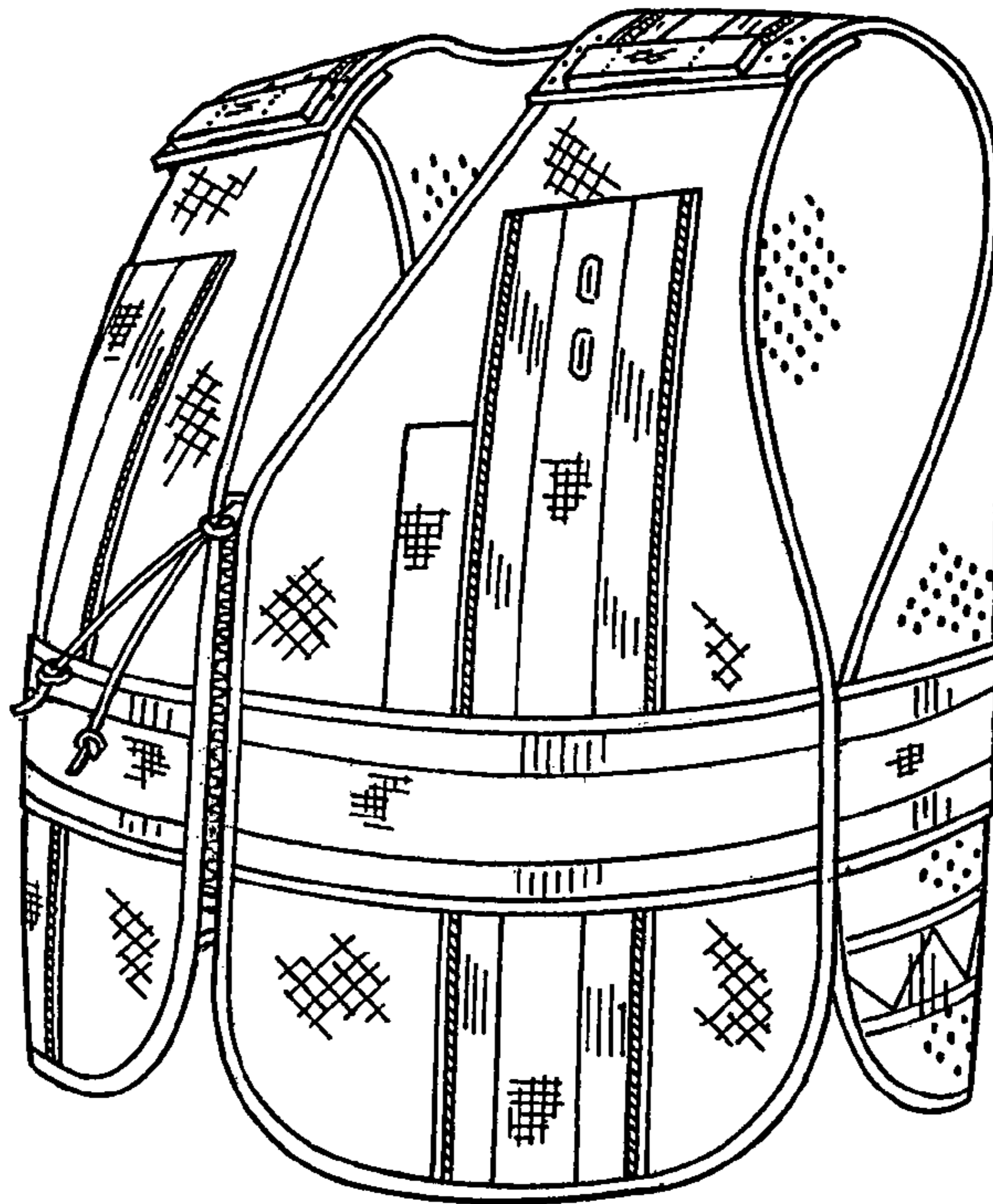

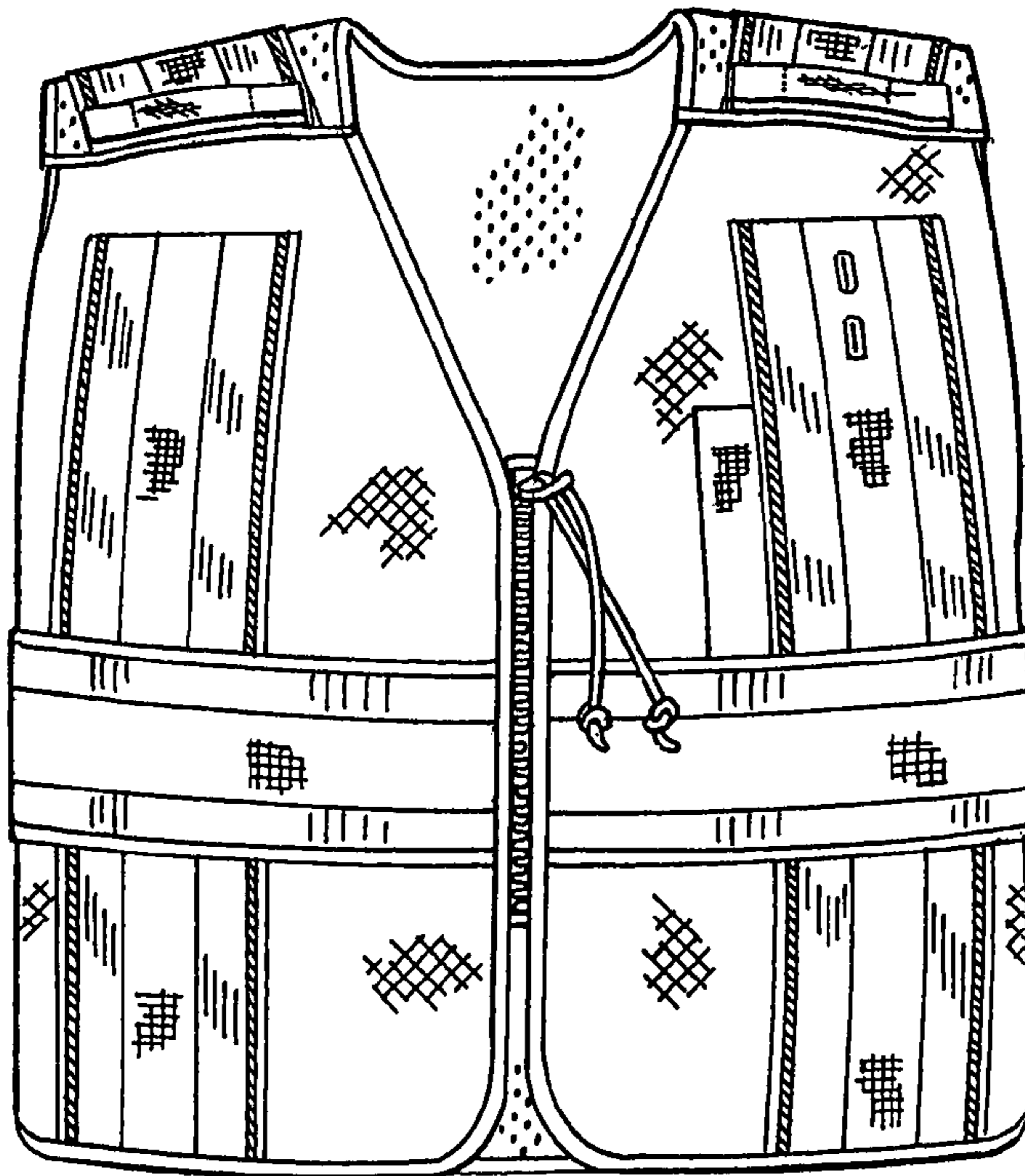

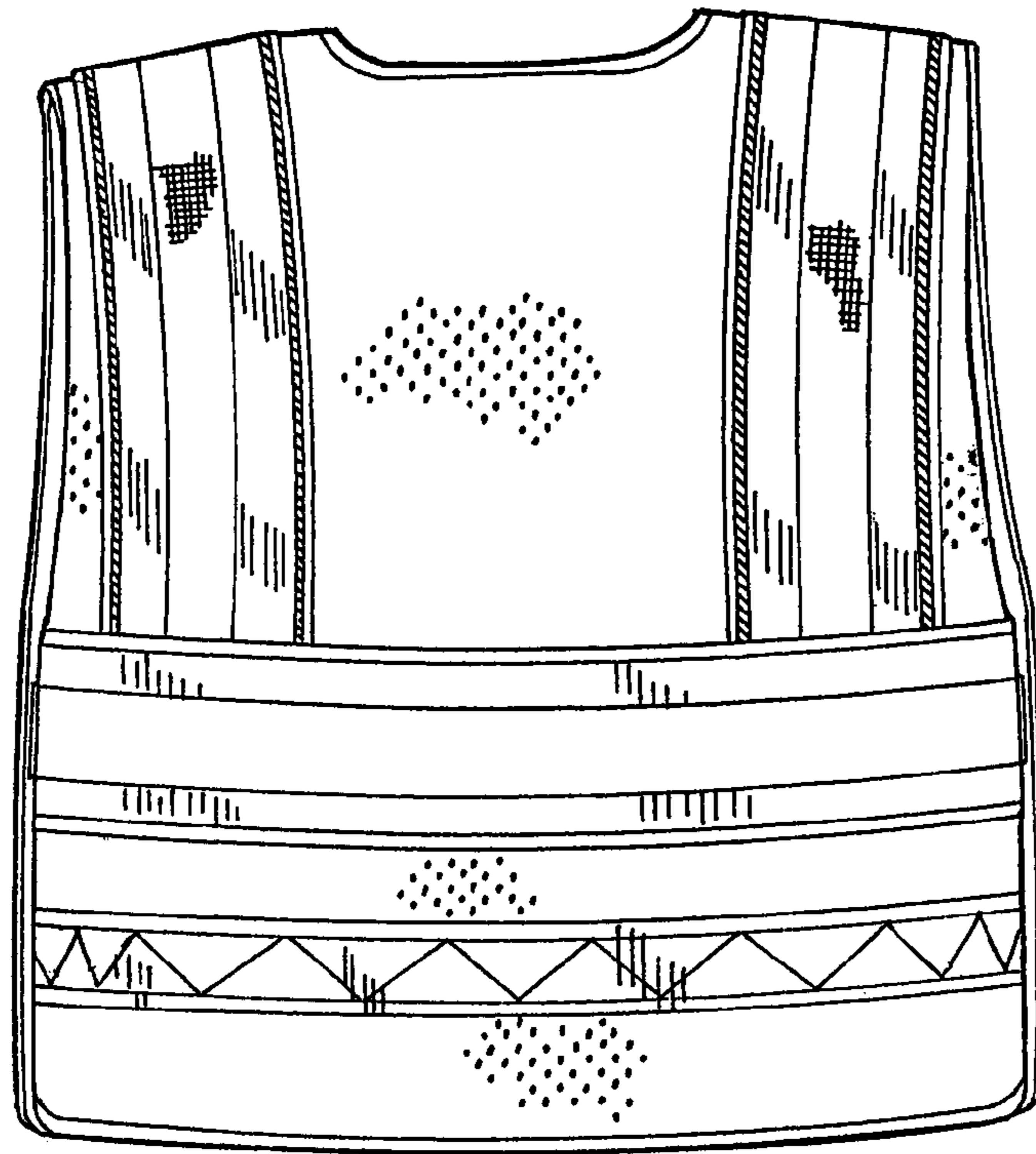

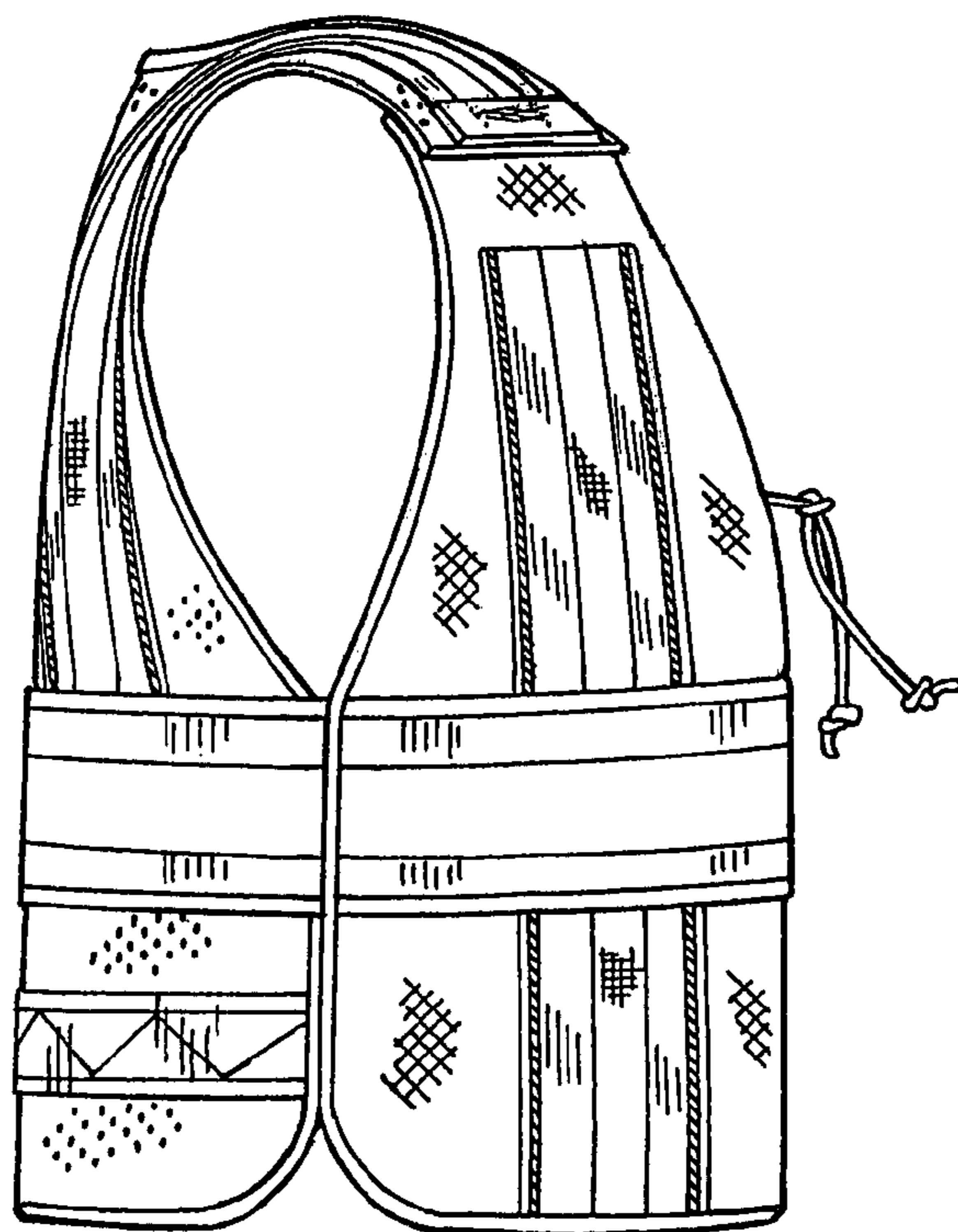

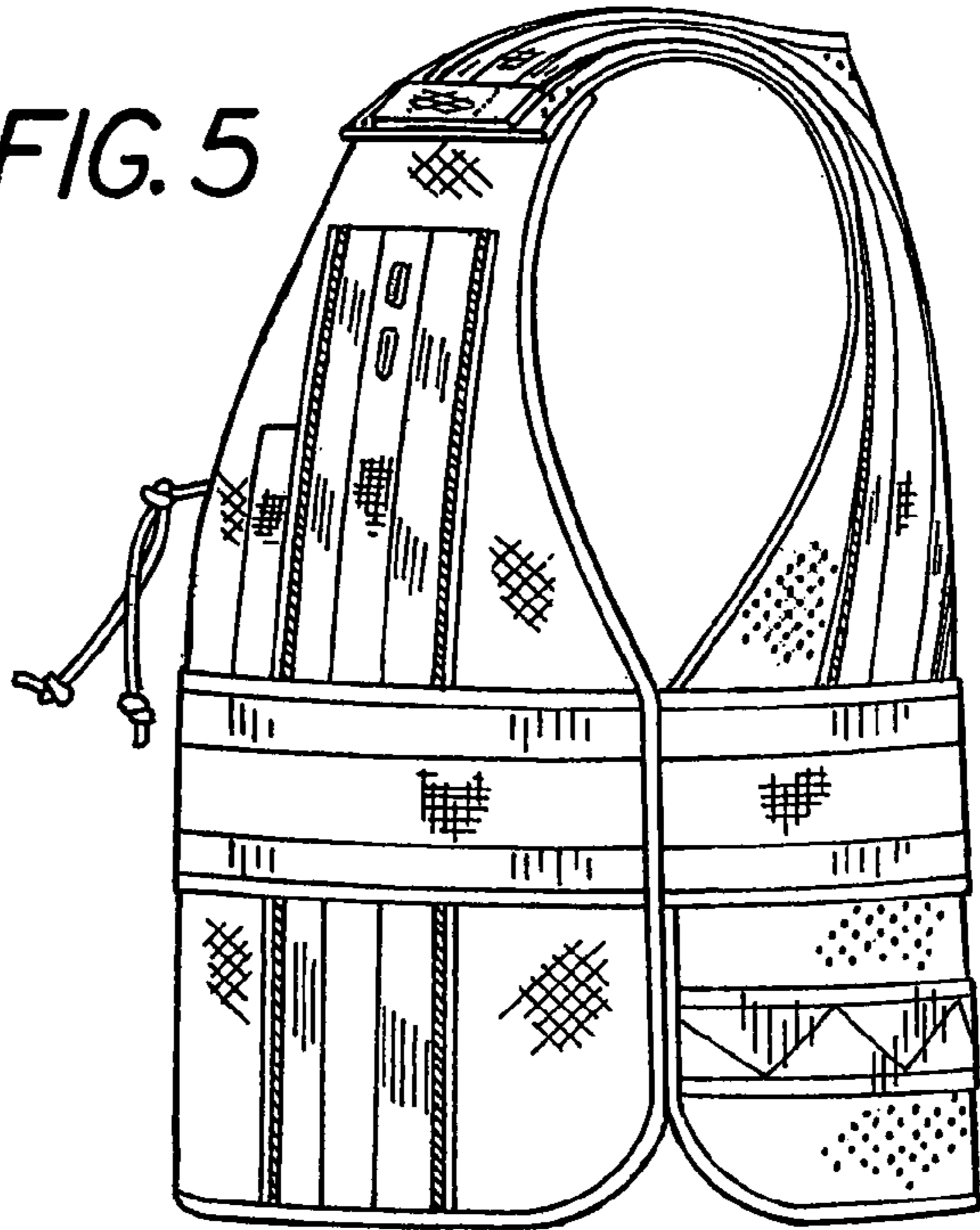

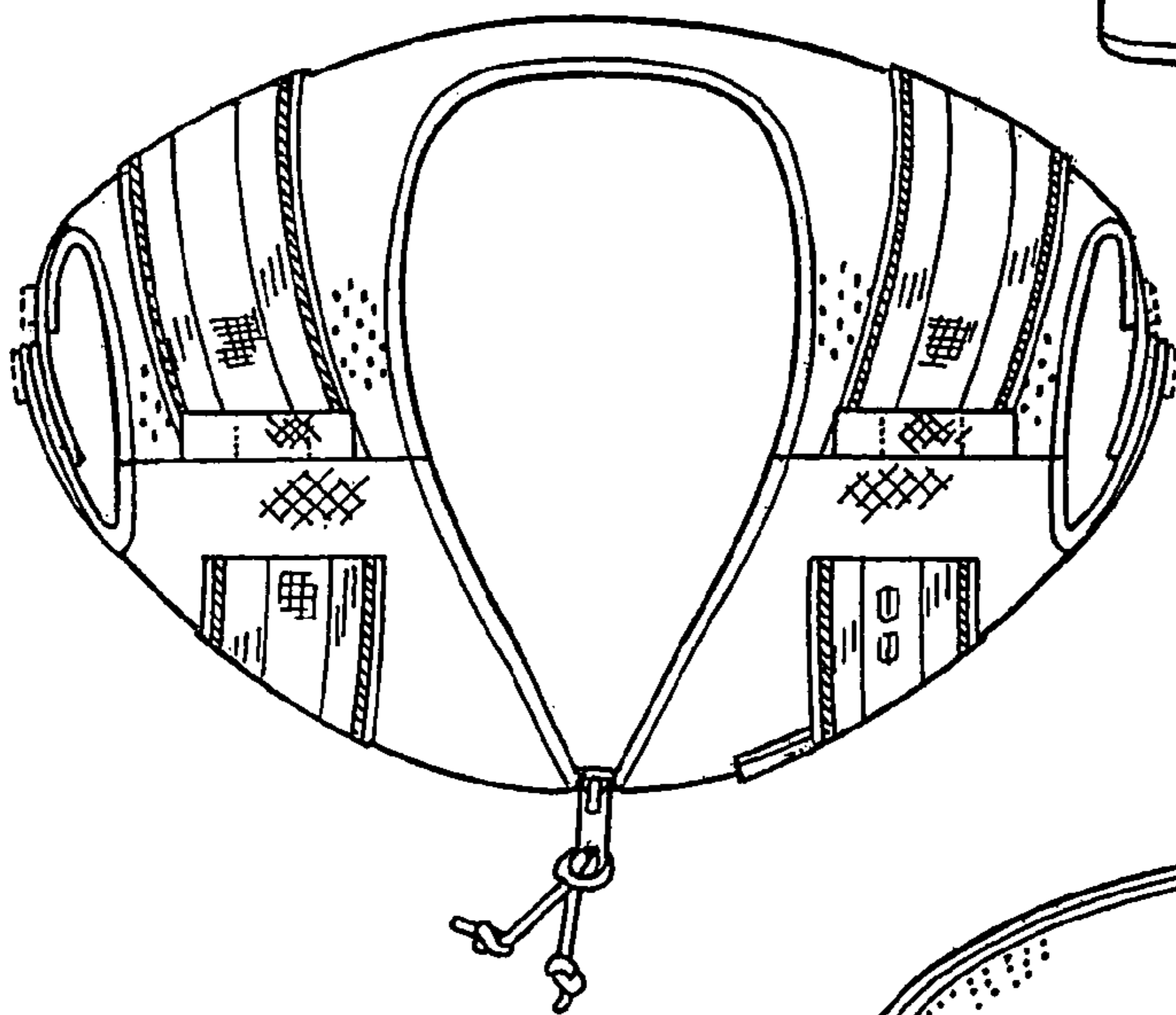
