FIG. 2 is a top plan view thereof;

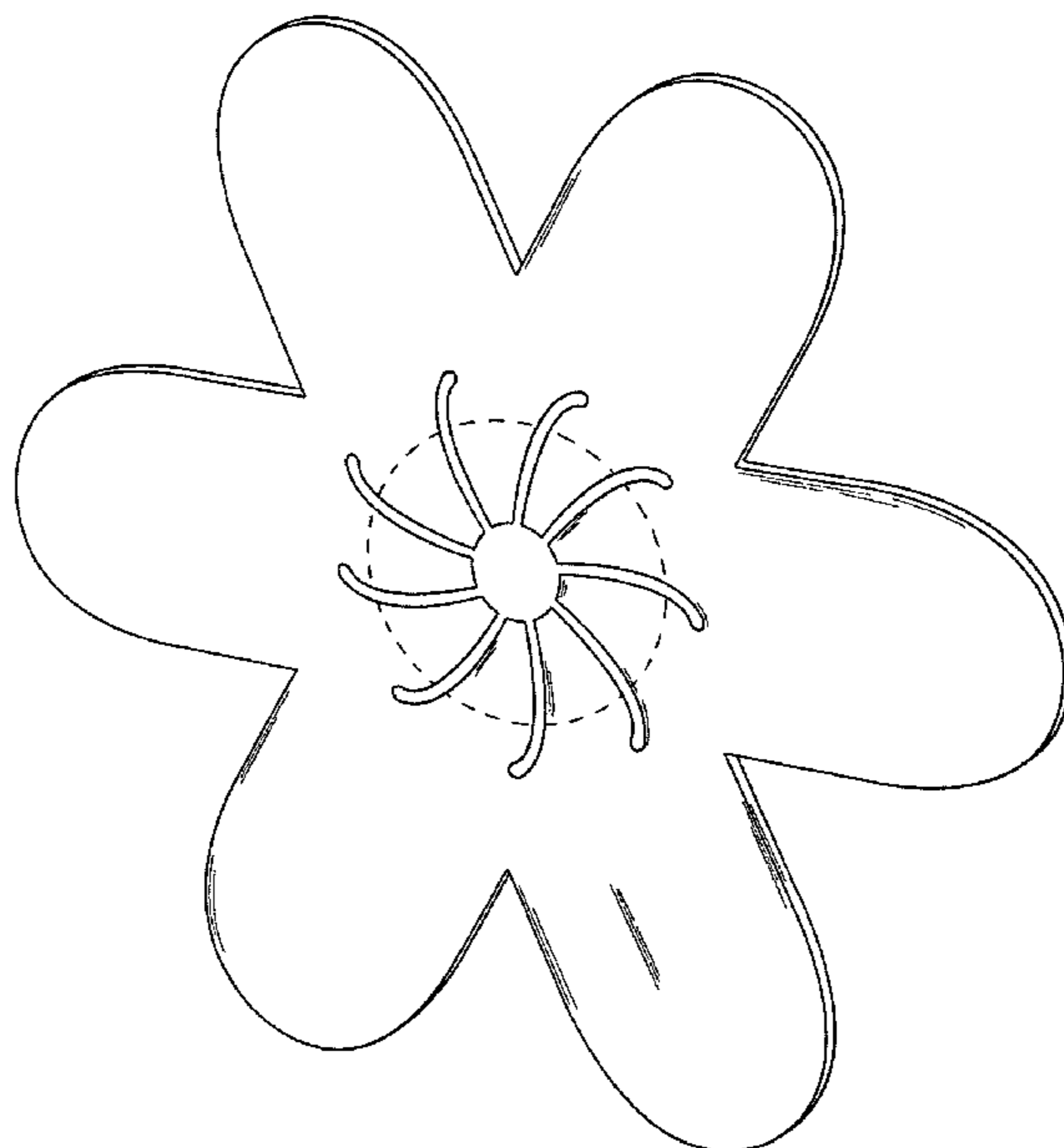
FIG. 3 is a side elevational view thereof; and,

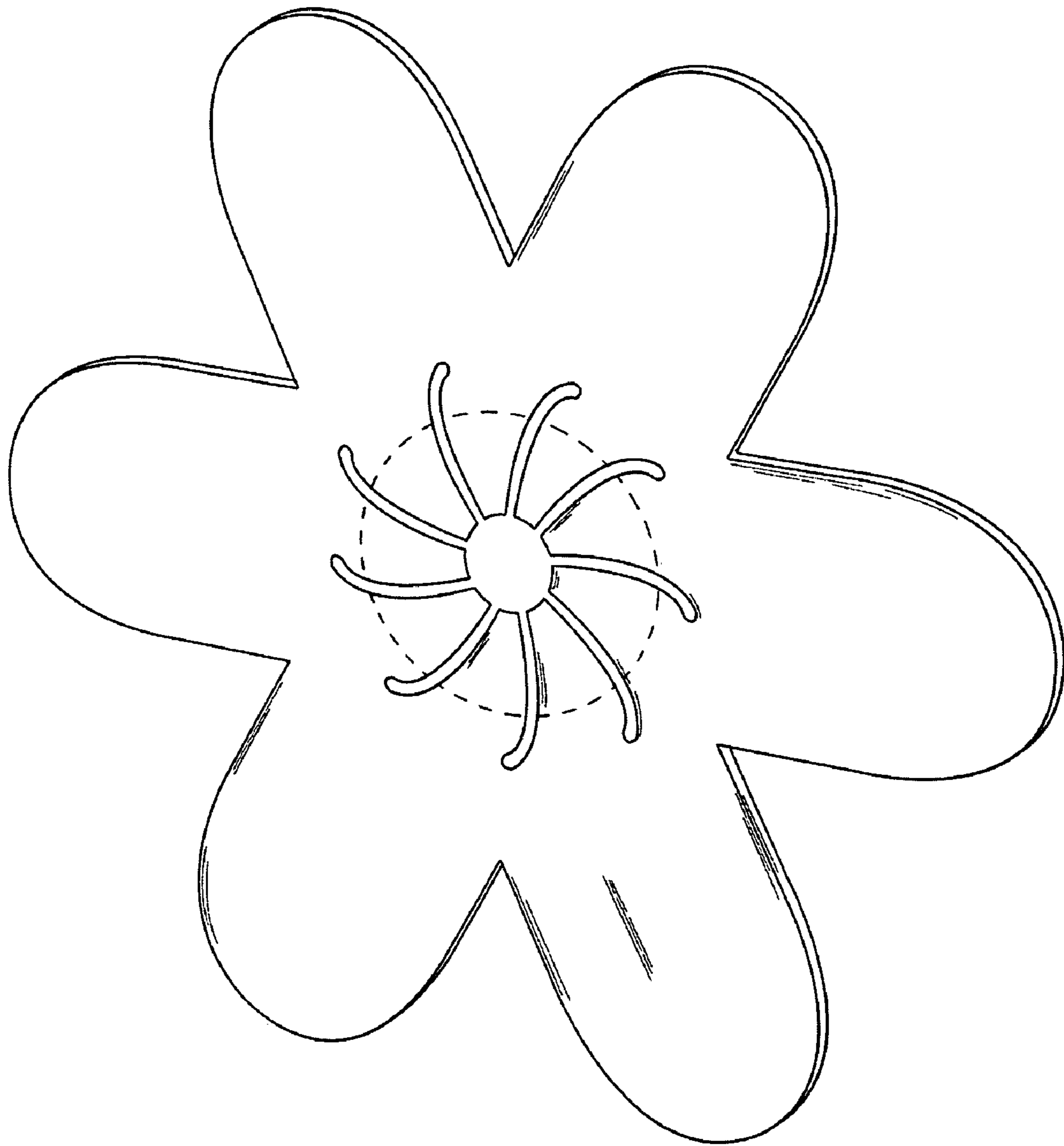
FIG. 4 is a front elevational view thereof.

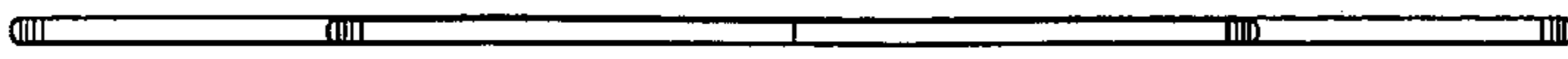

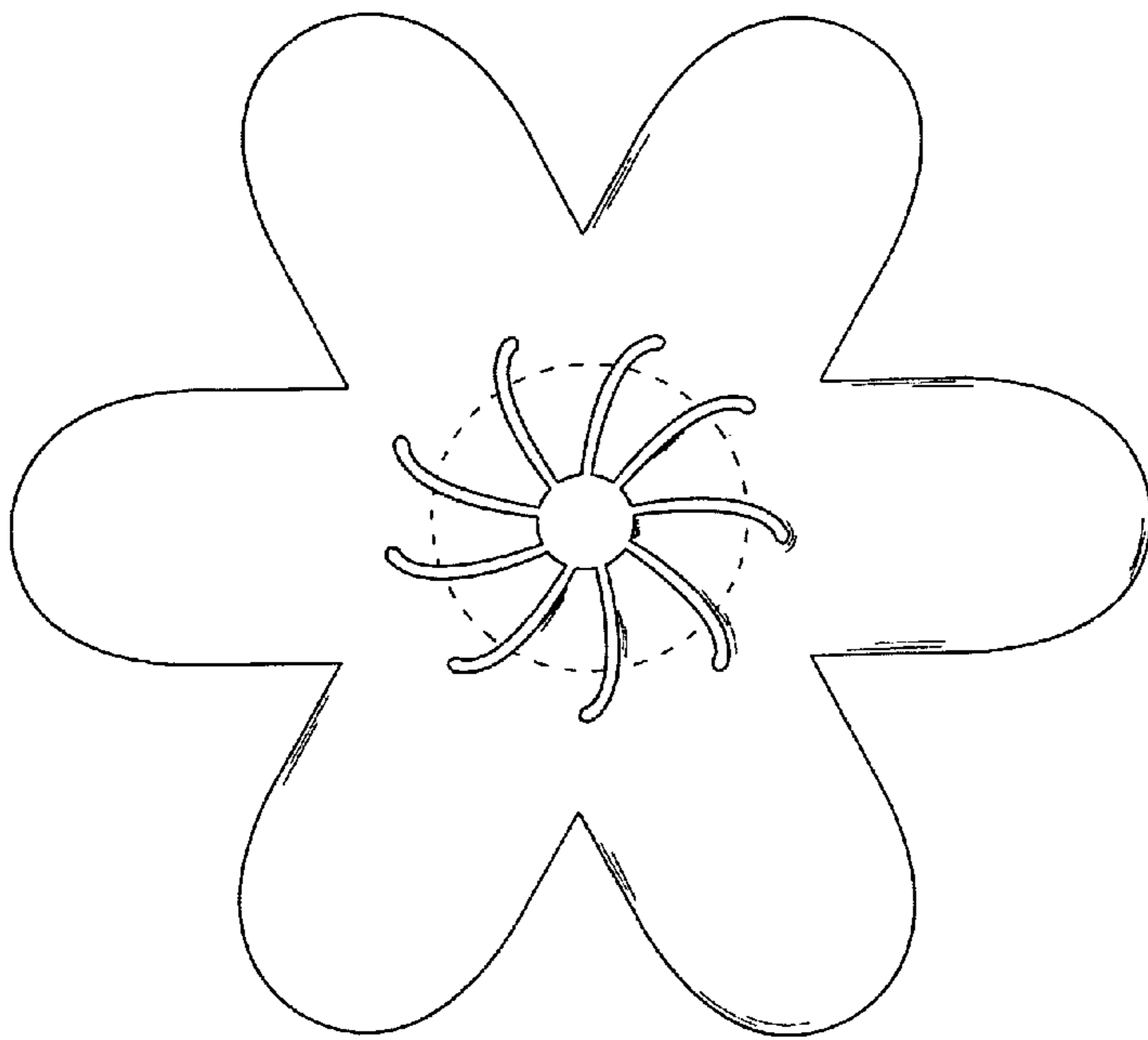
