**DESCRIPTION**

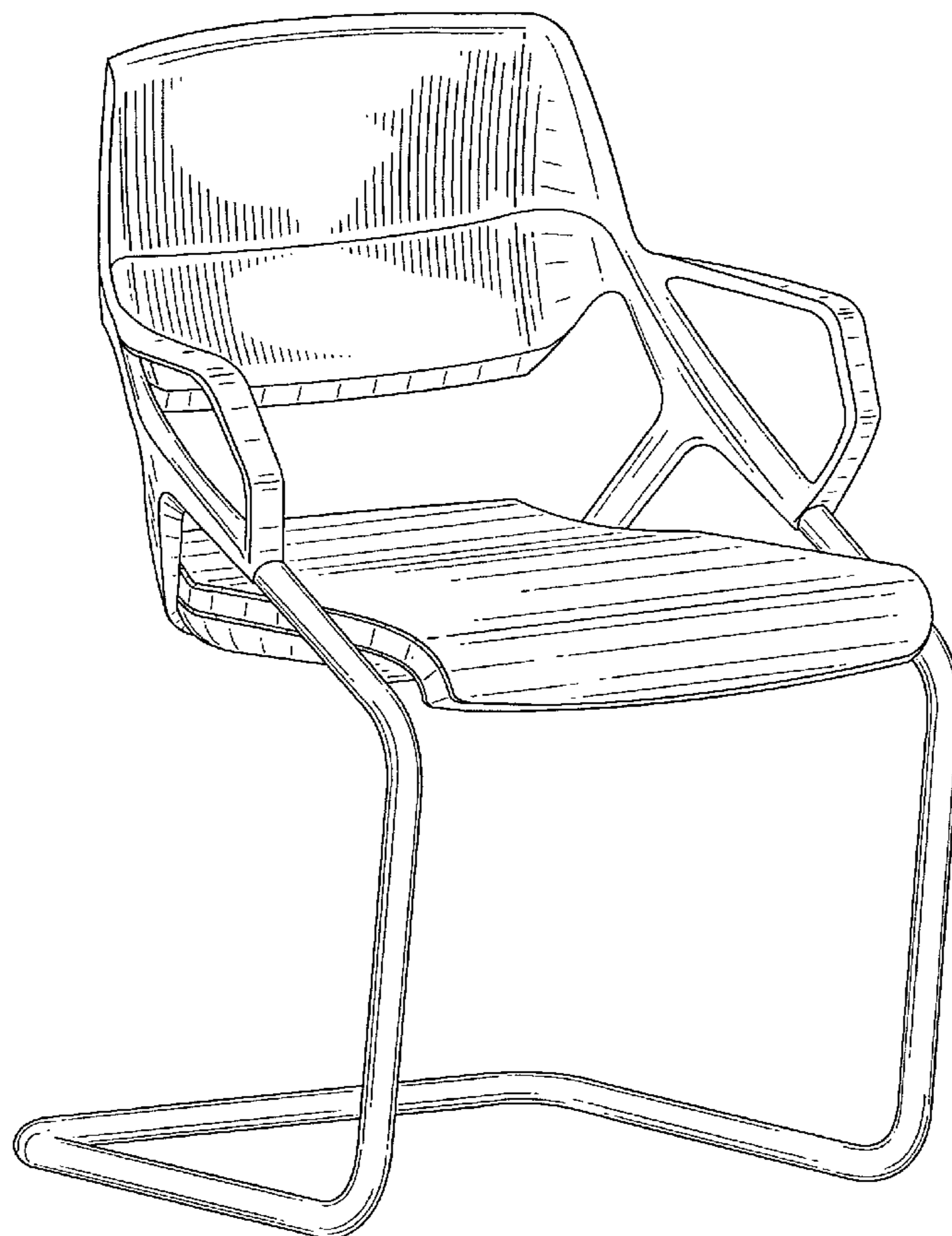
FIG. 1 is a perspective view of a perch for sitting in accordance with my new design;

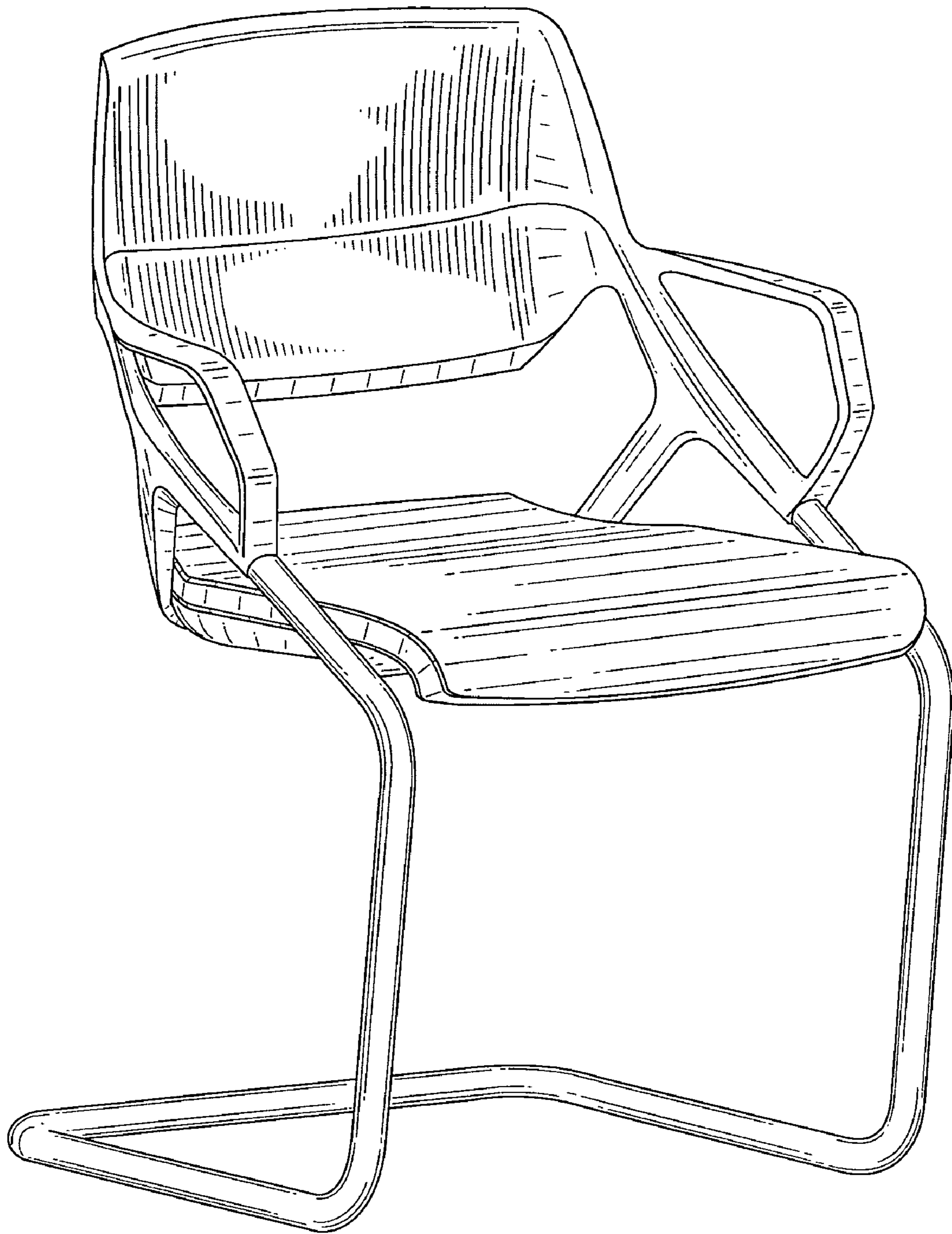
FIG. 2 is side view thereof;

FIG. 3 is a rear view thereof; and,

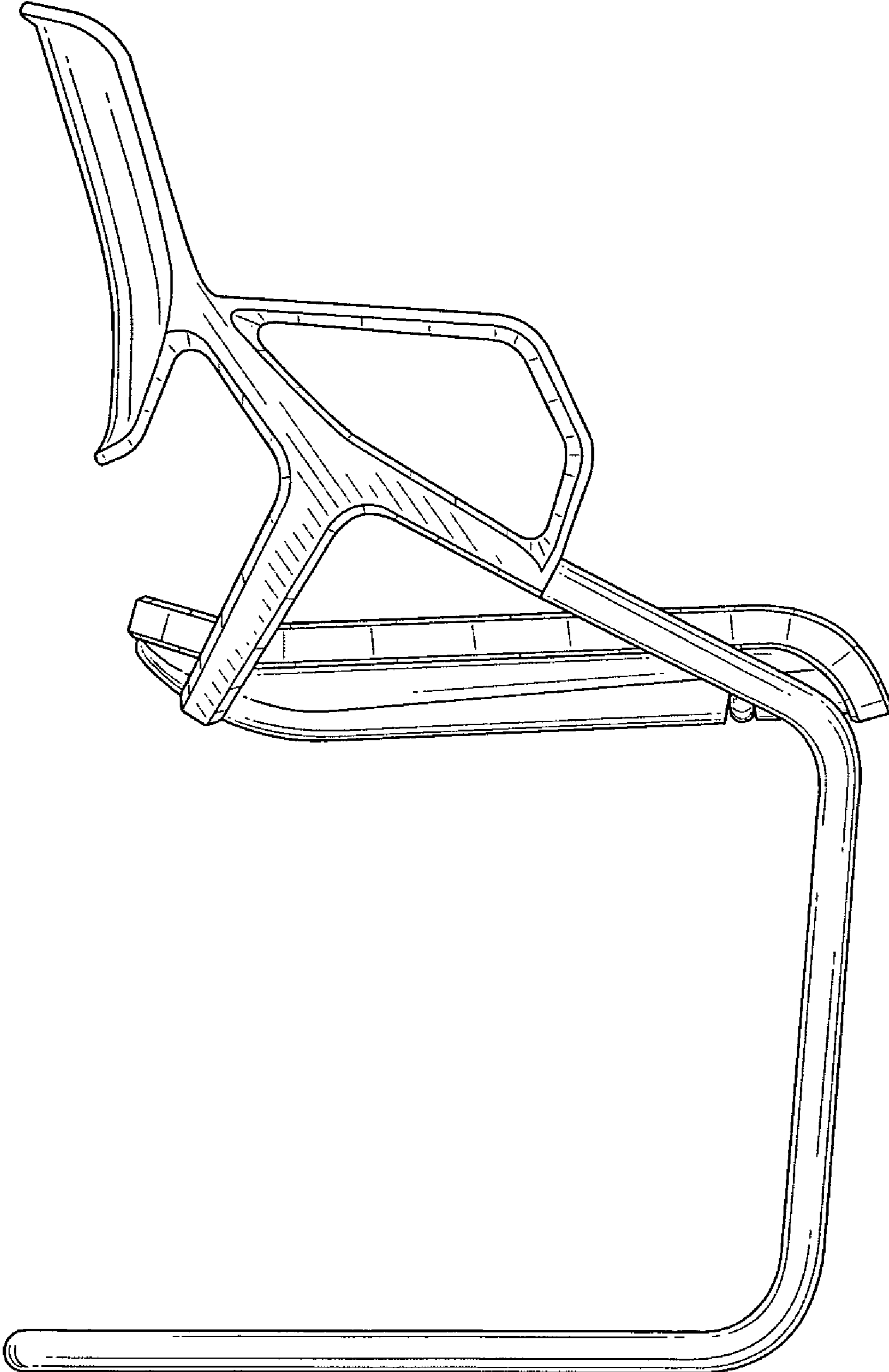
FIG. 4 is a top view thereof.

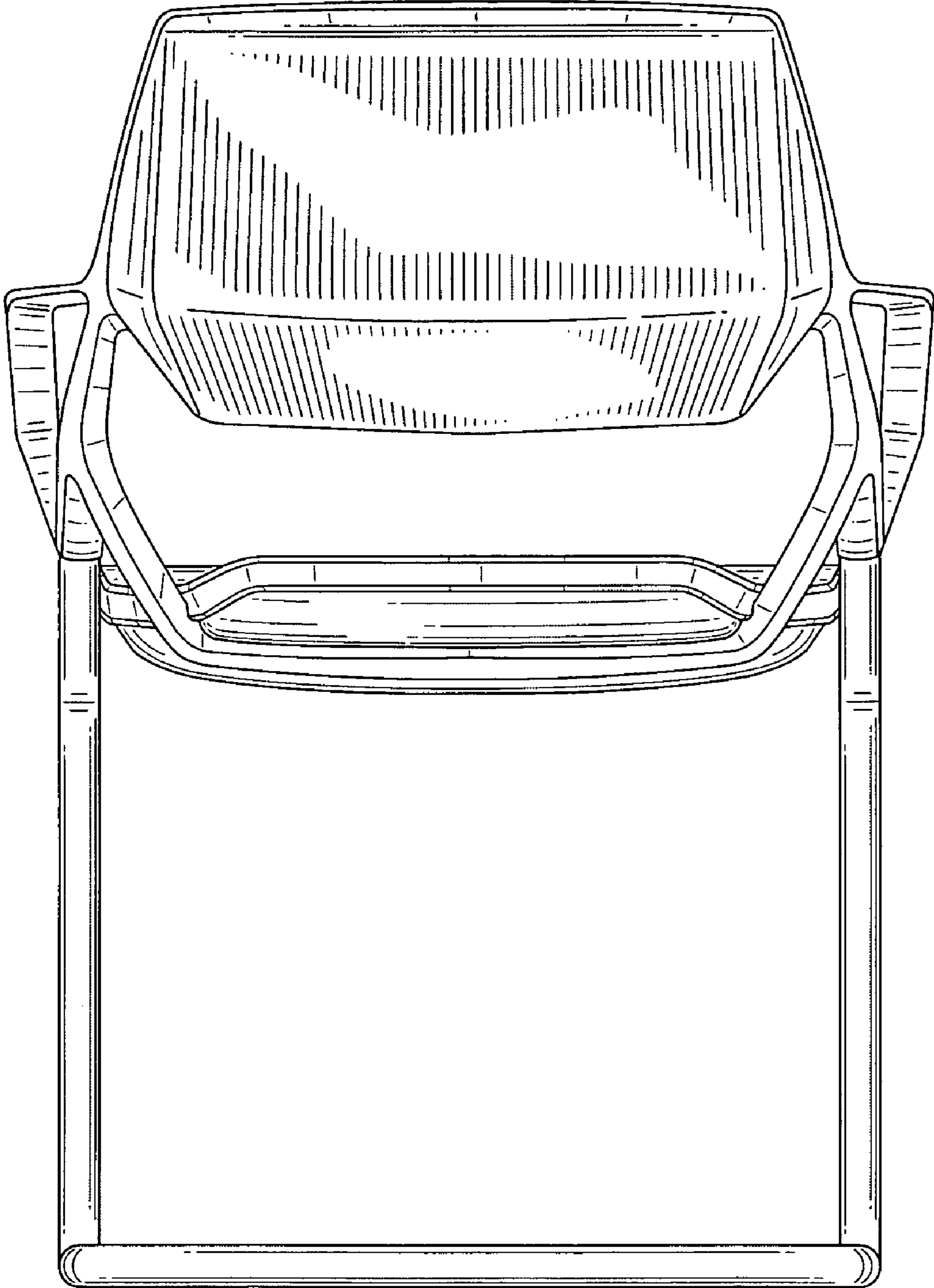




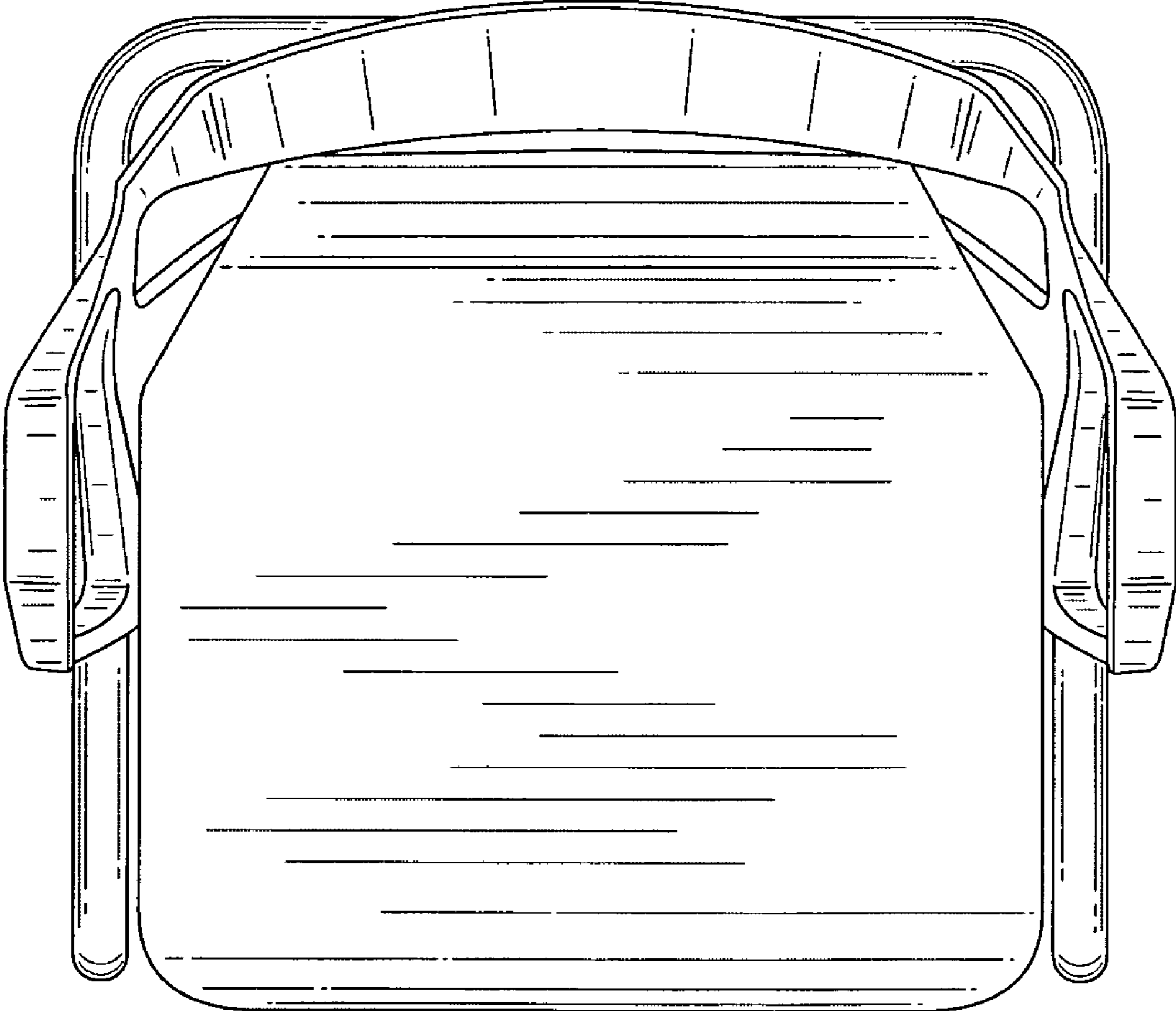
