FIG. 3 is a right side perspective view thereof;

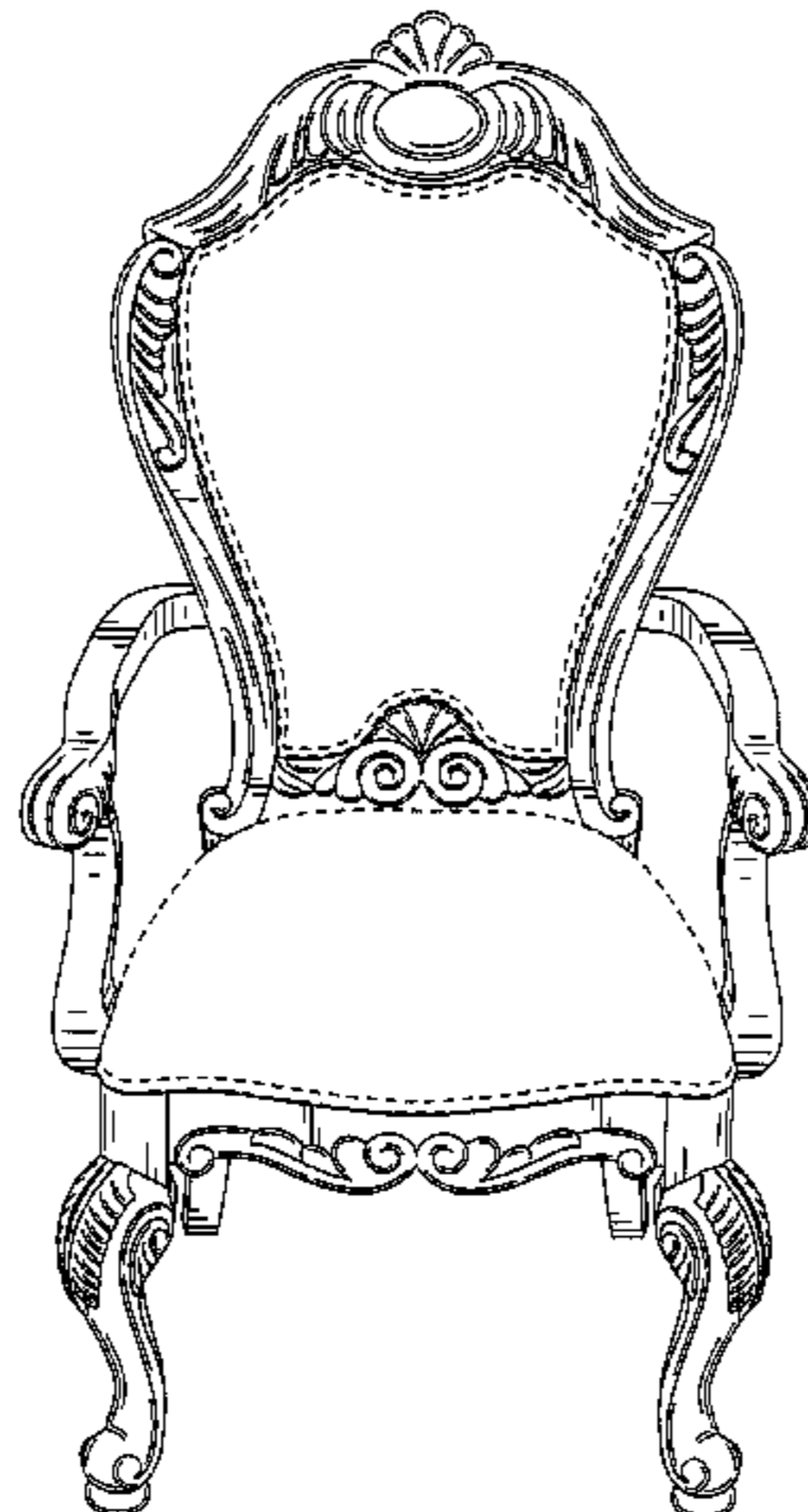
FIG. 4 is an enlarged top view thereof;

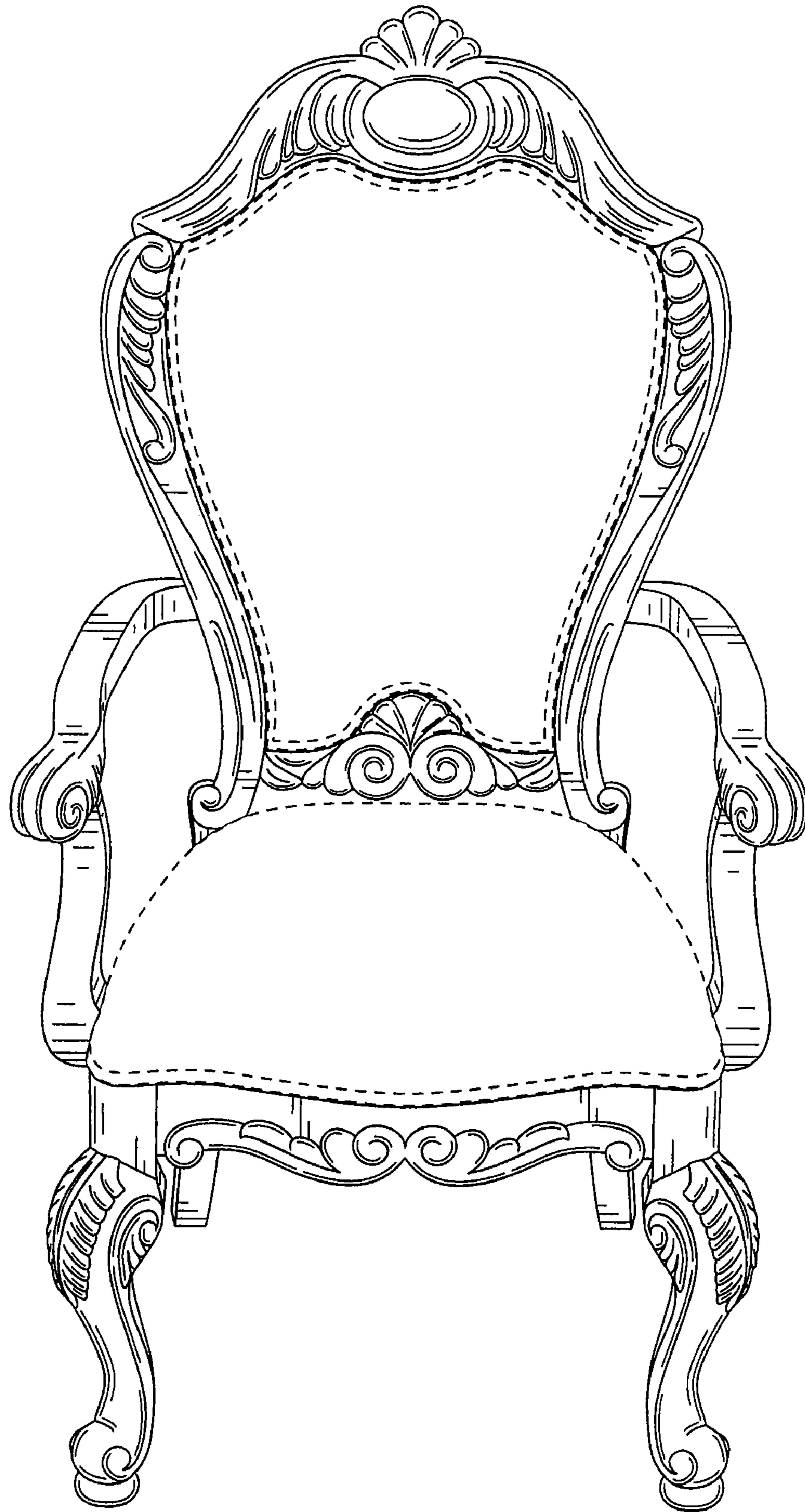

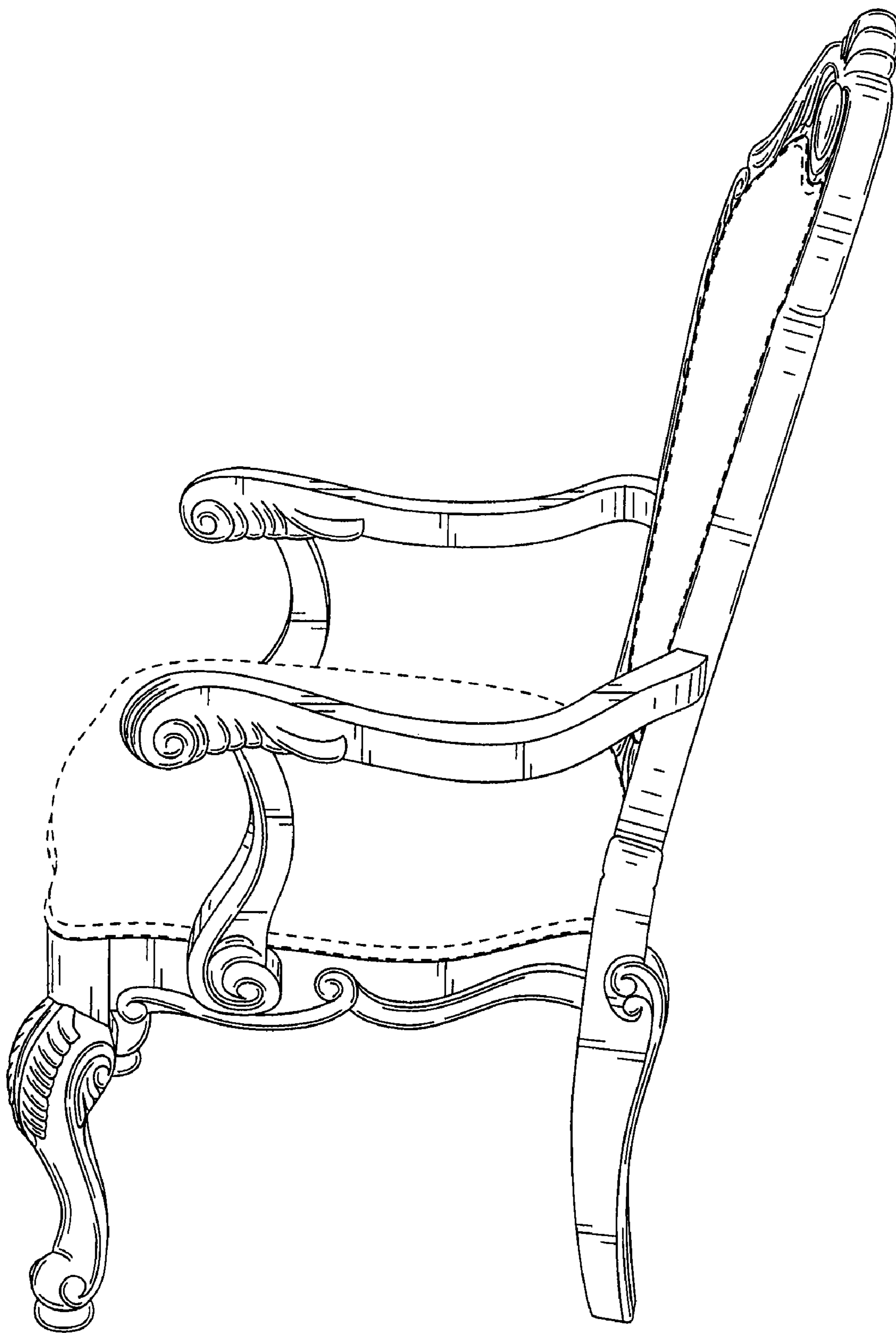

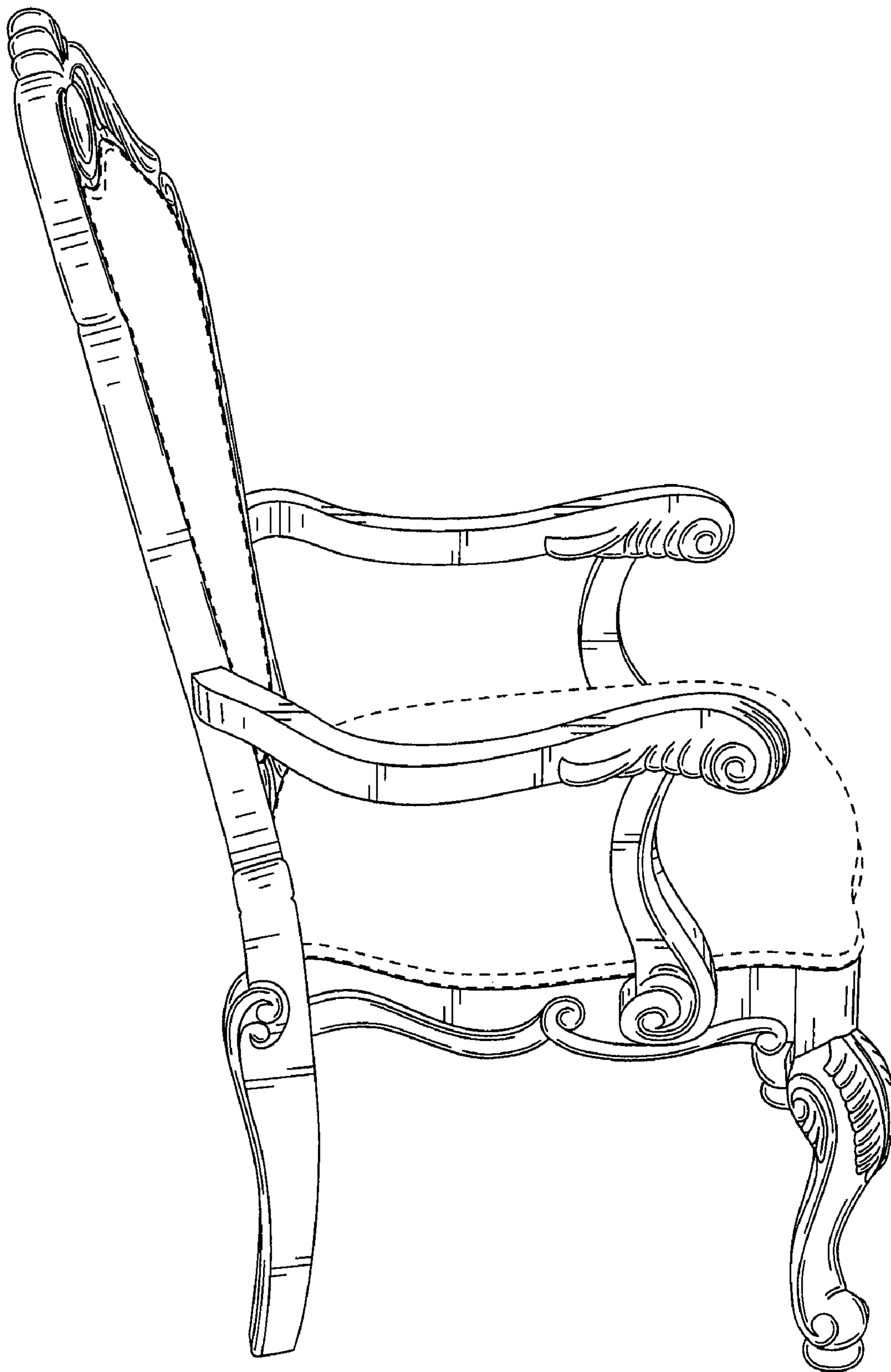

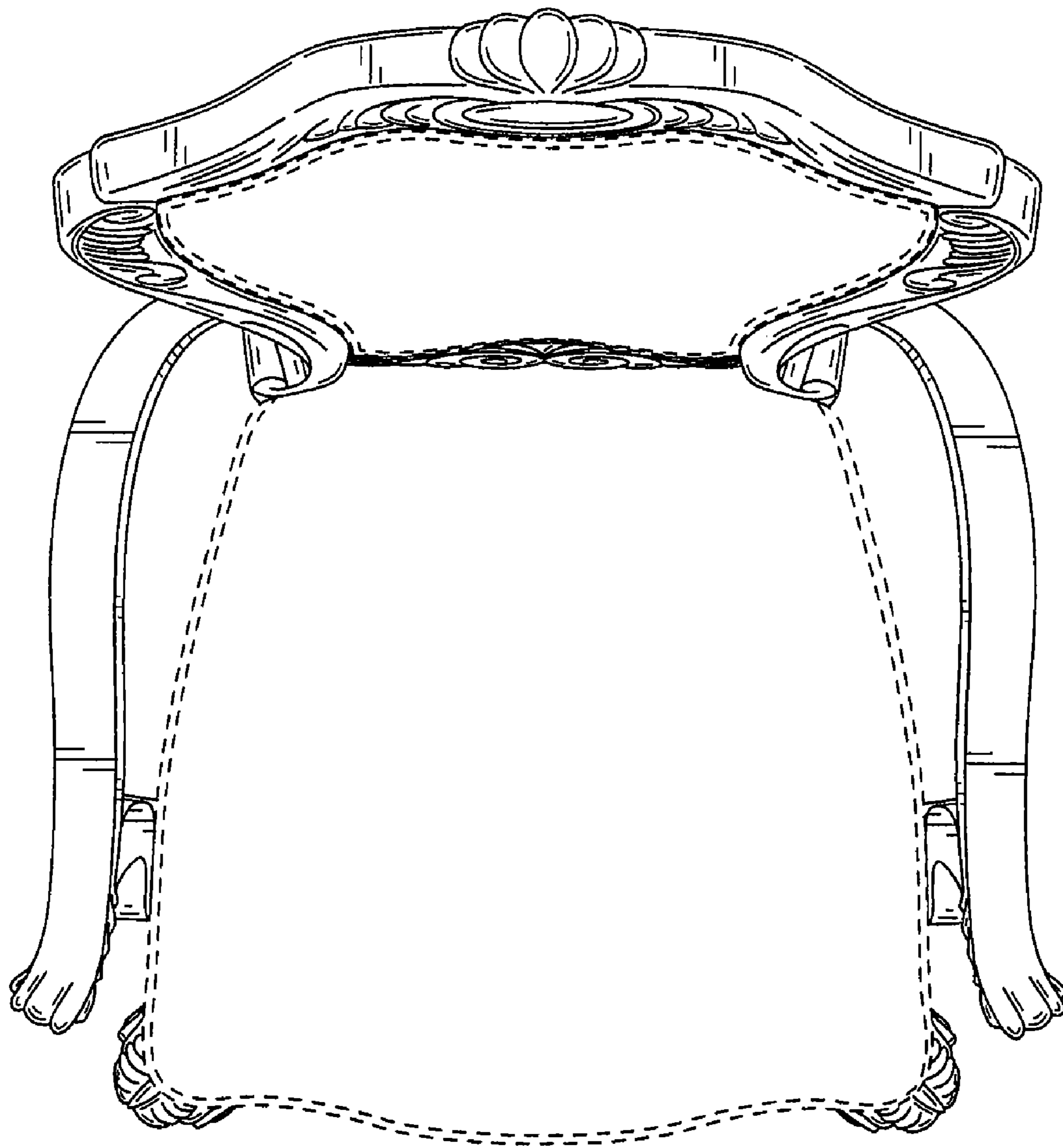

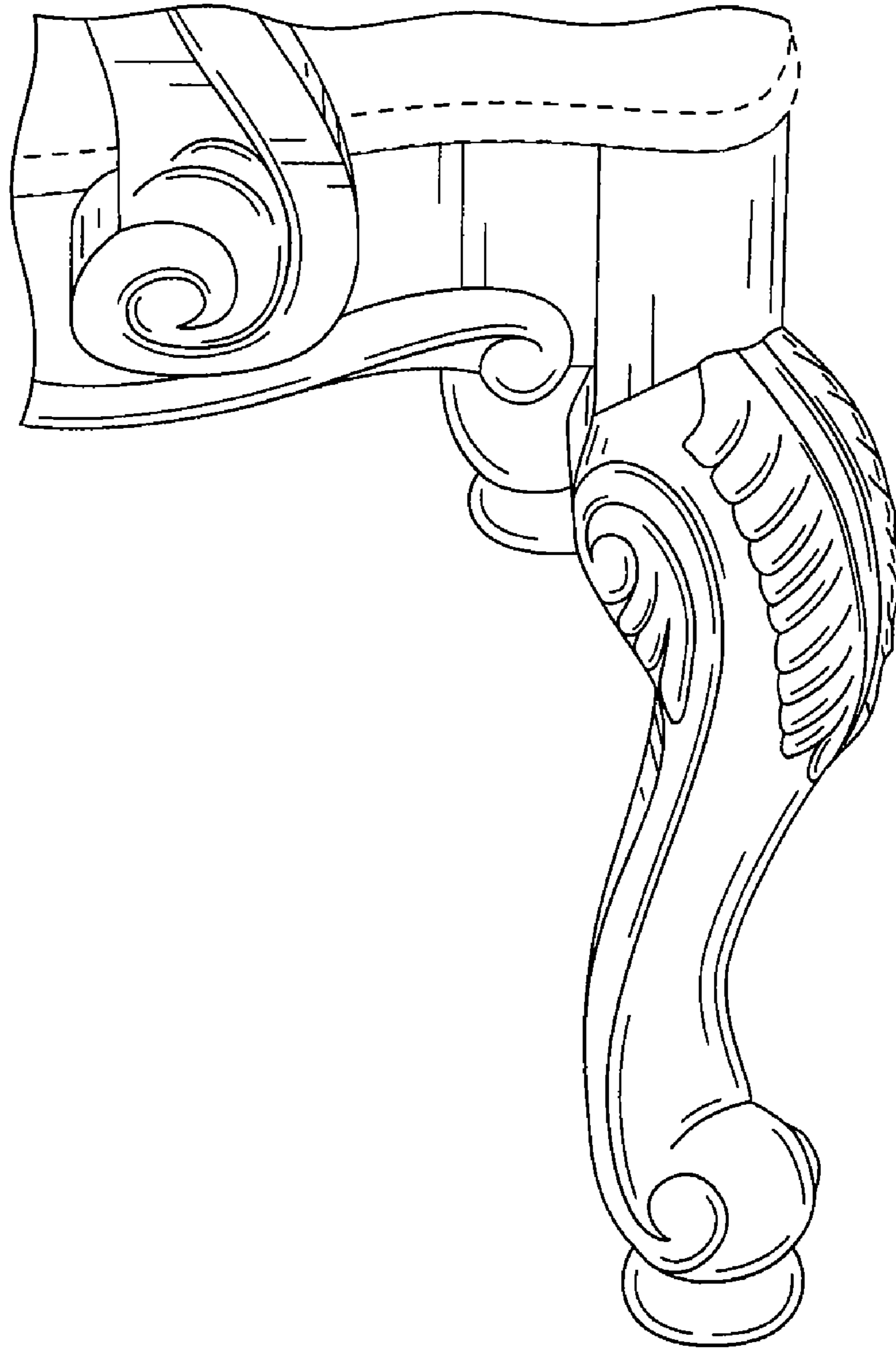

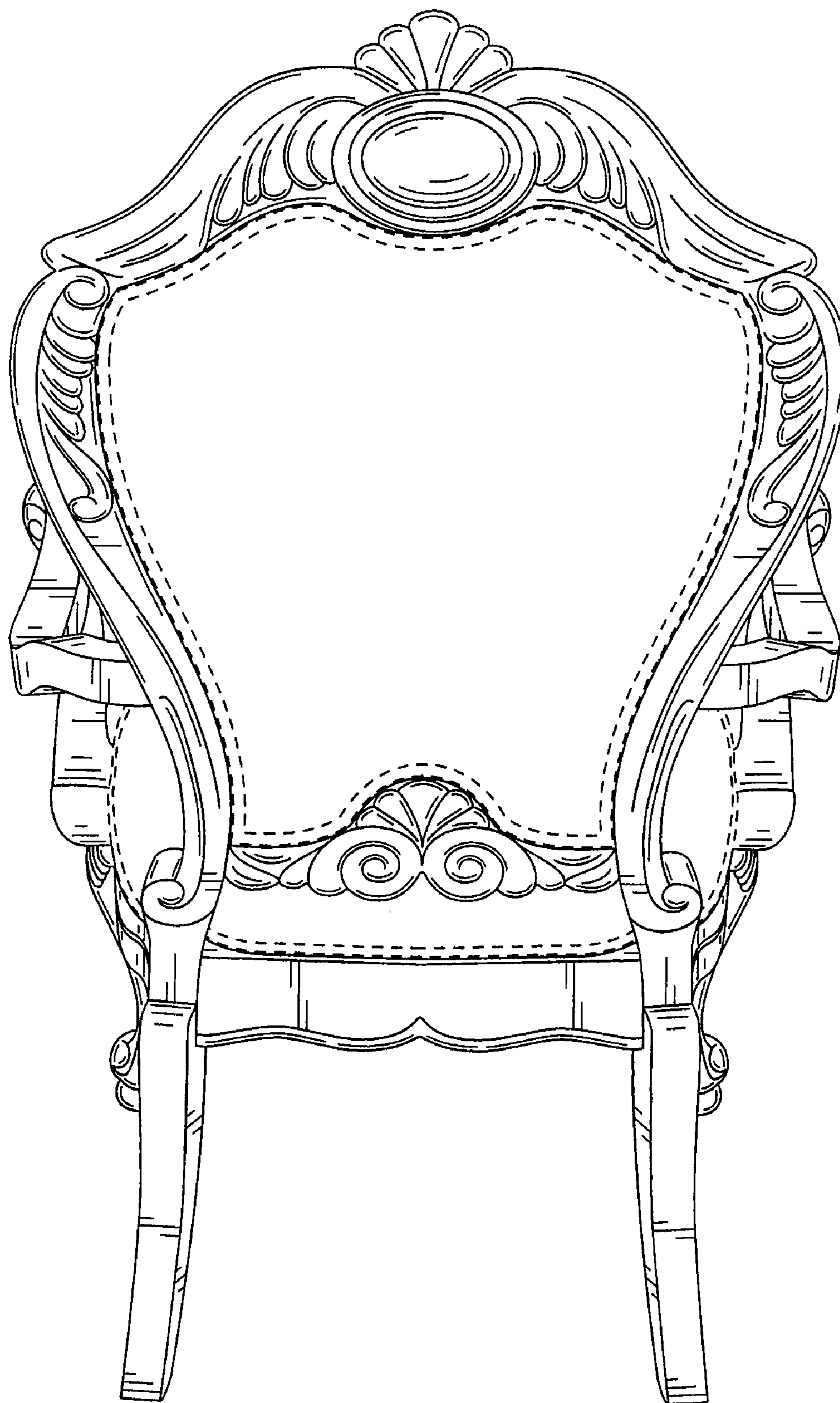
