FIG. 4 is a left elevational view thereof,

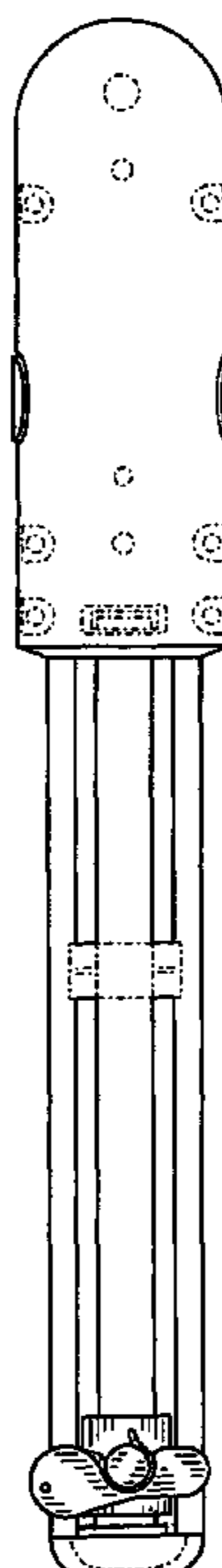
FIG. 5 is a front elevational view thereof,

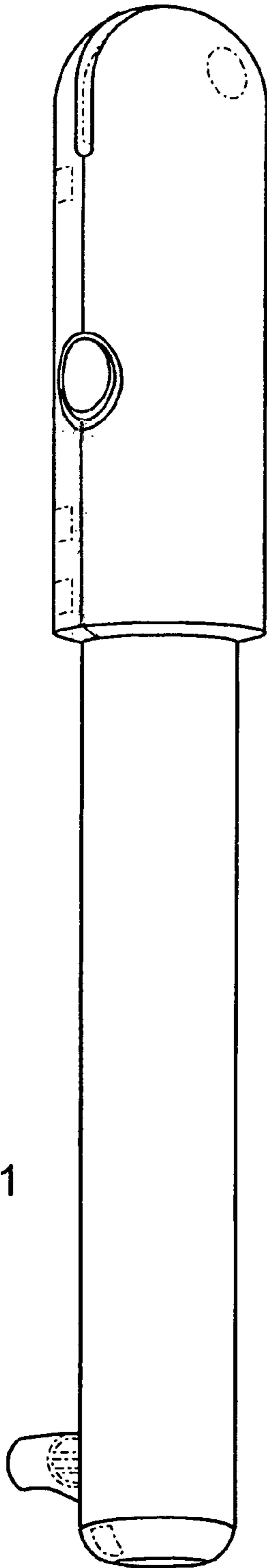

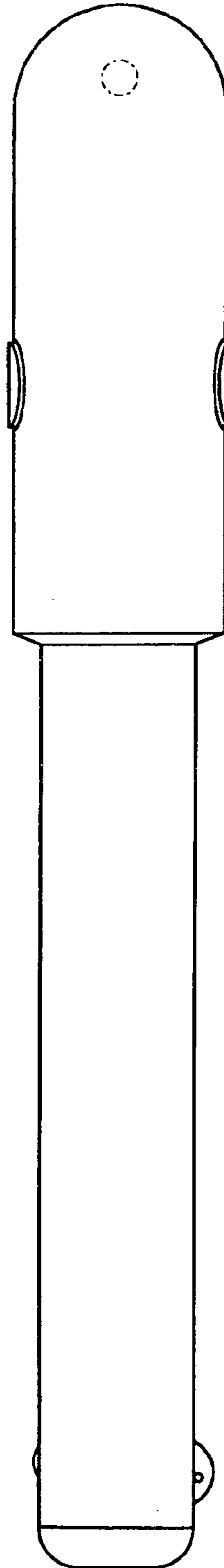

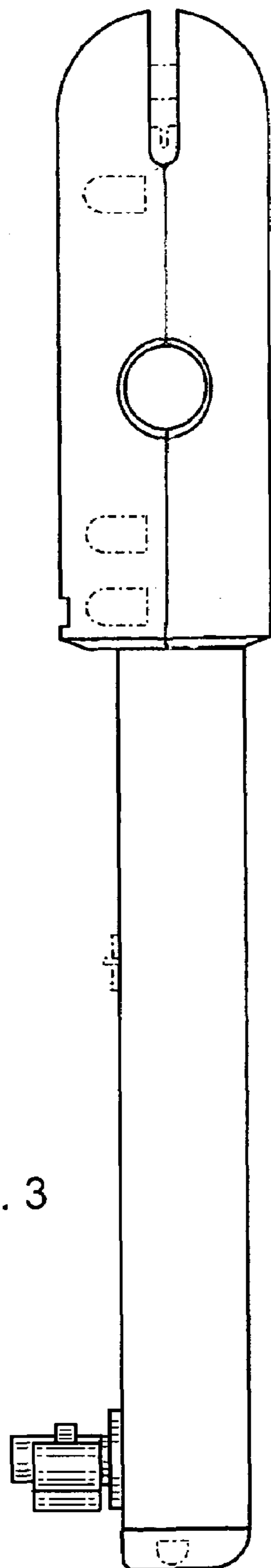

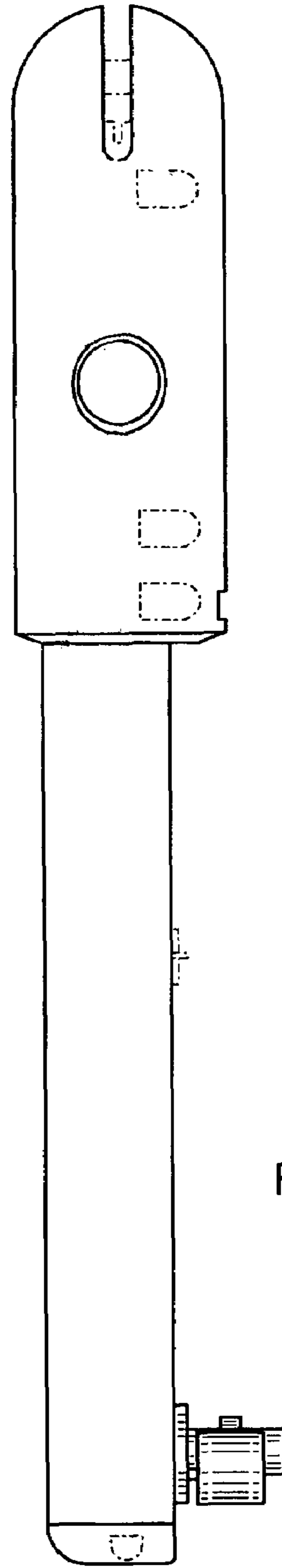

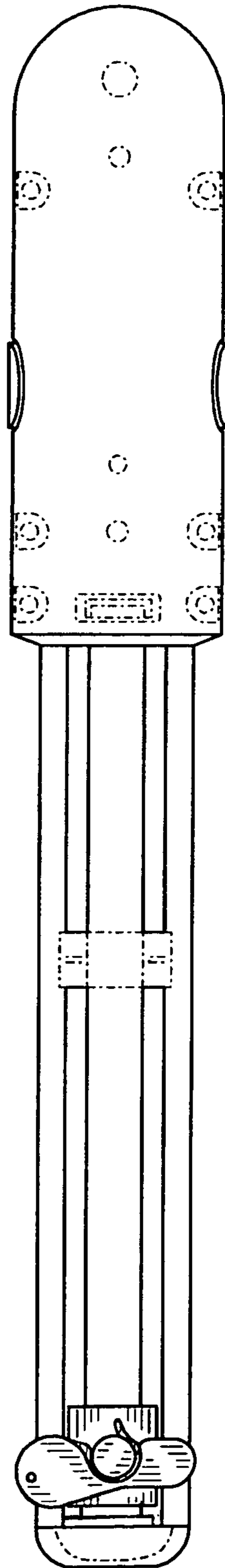

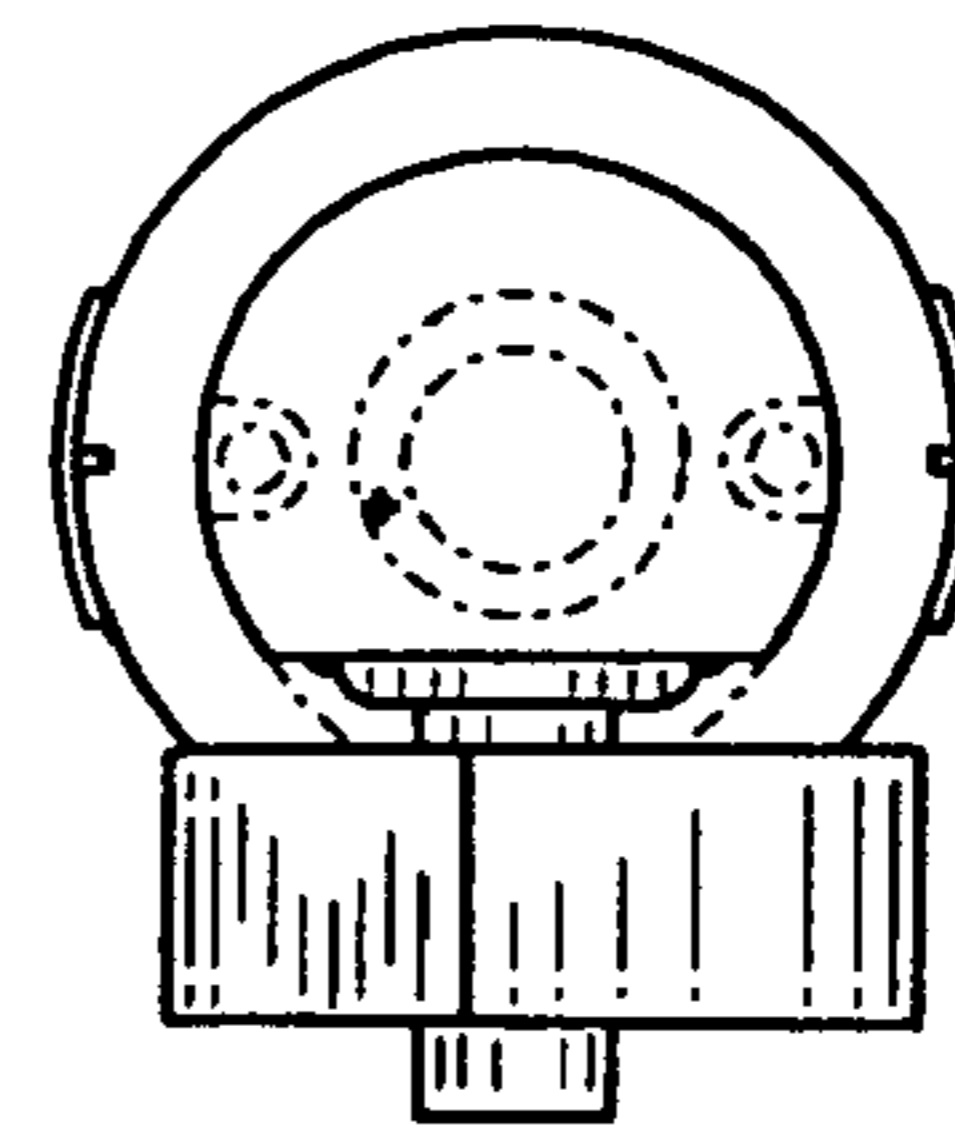

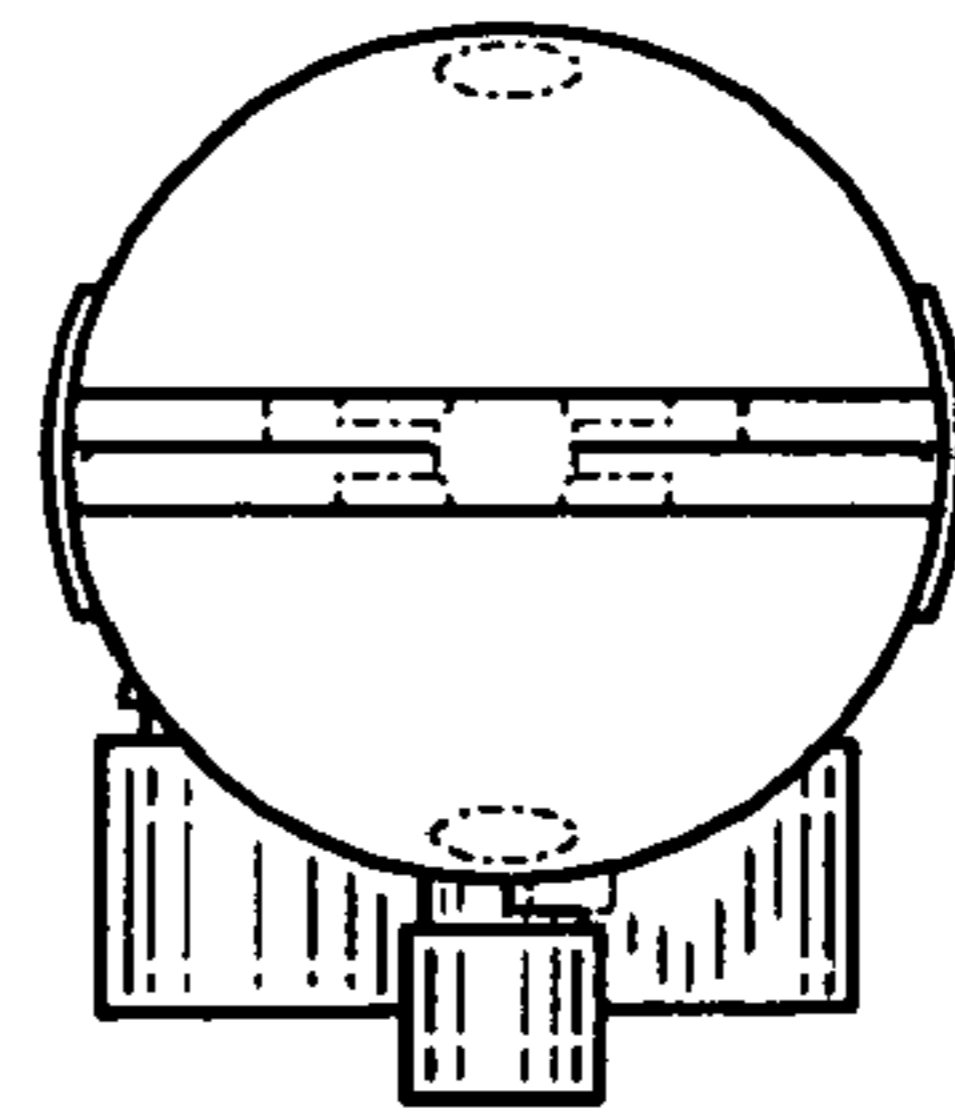
