I claim the ornamental design for a two handled pan, as shown and described.

DESCRIPTION

FIG. 1 is perspective view showing the top, front and right side of the two handled pan.

FIG. 2 is a top plan view.

FIG. 3 is a front elevation view.

FIG. 4 is a side elevation view looking from the right side of FIG. 1.

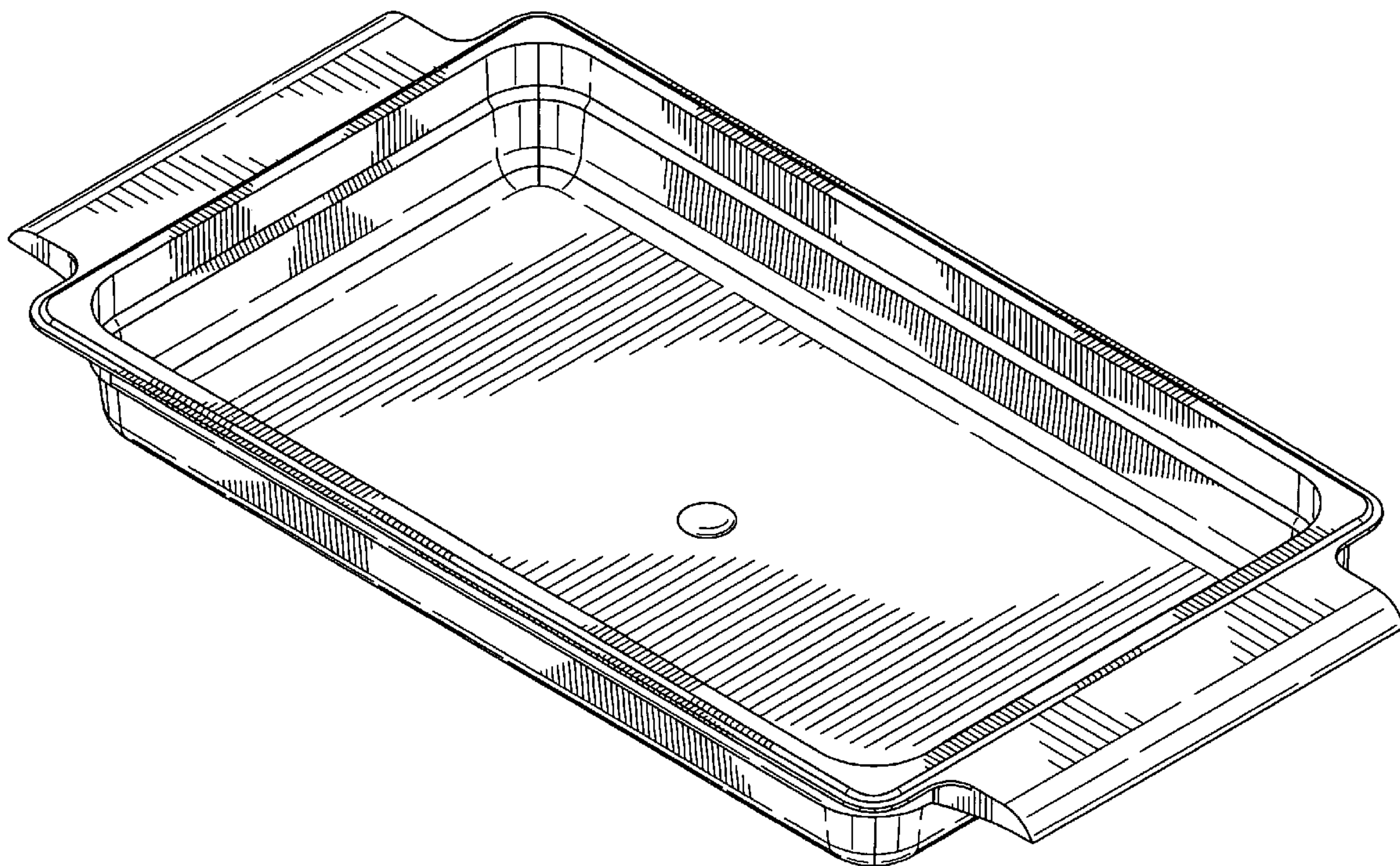
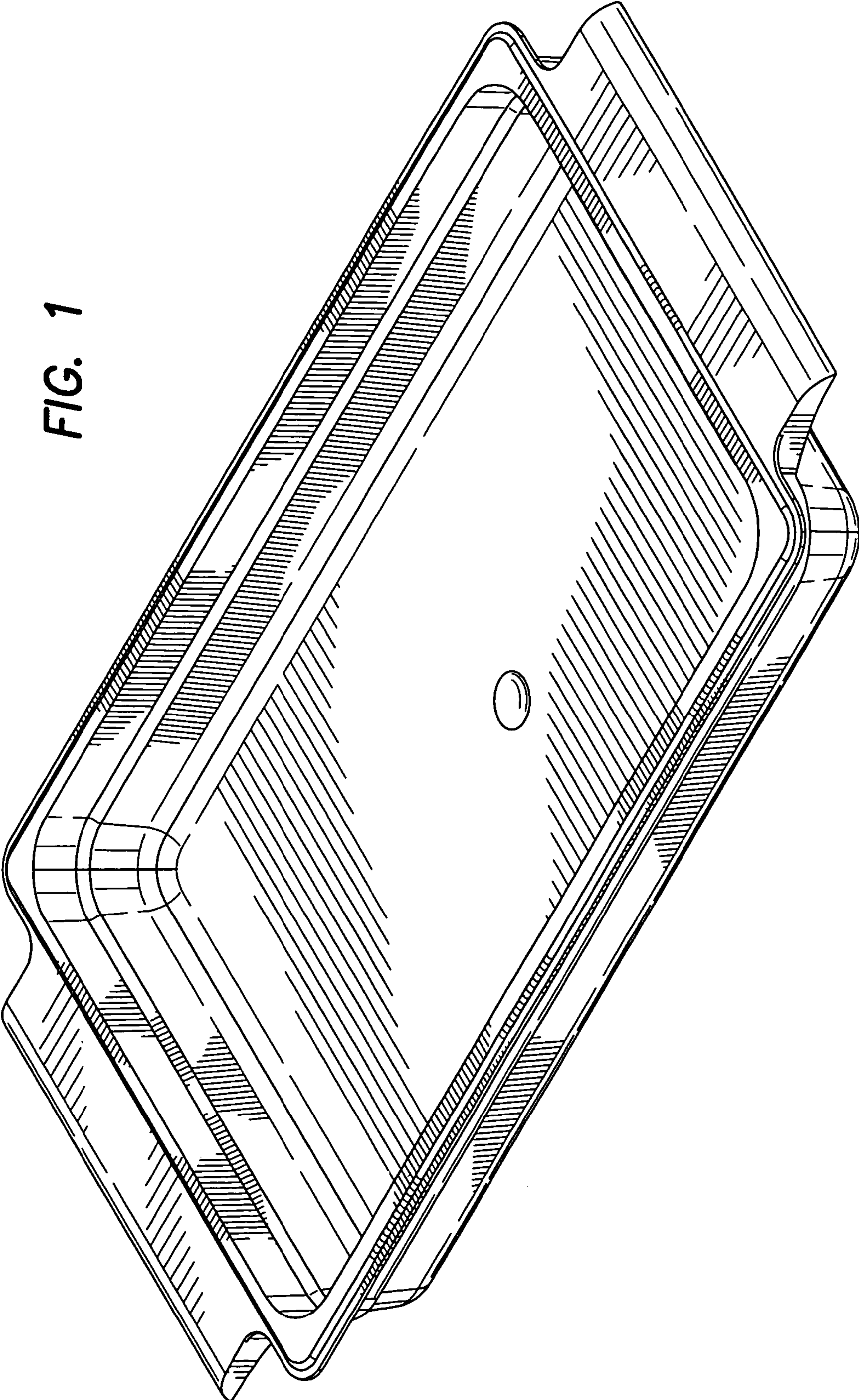

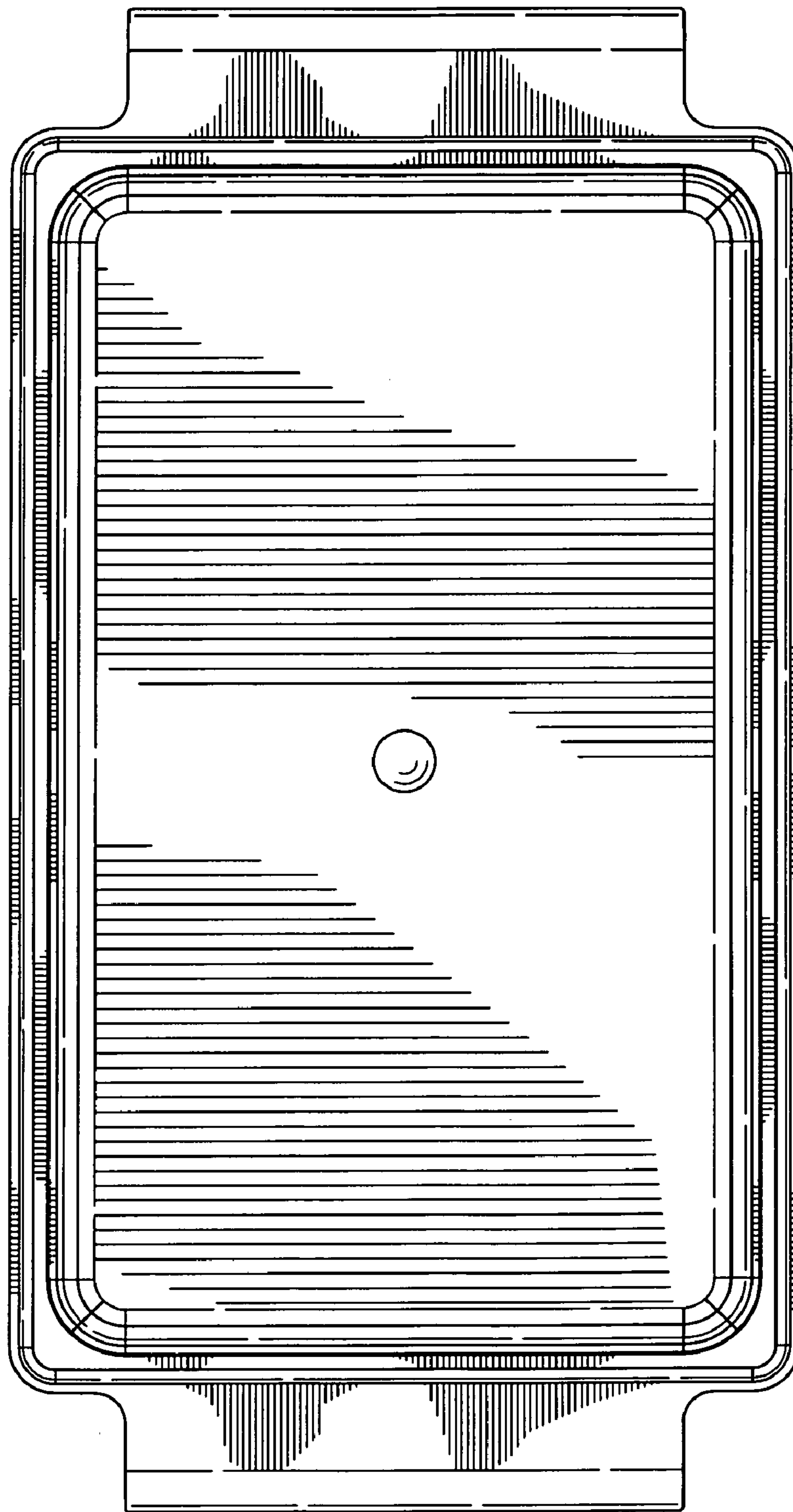

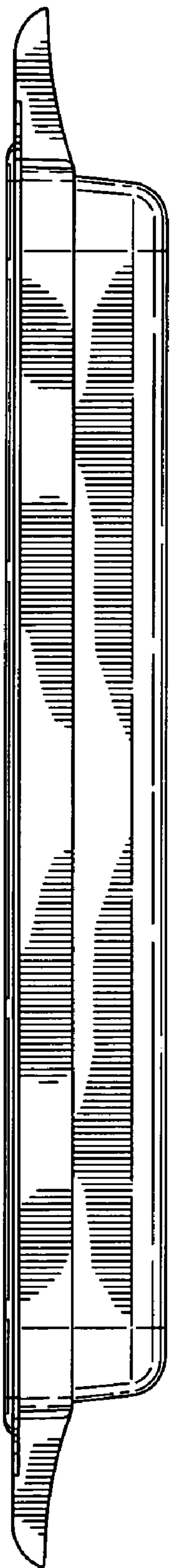

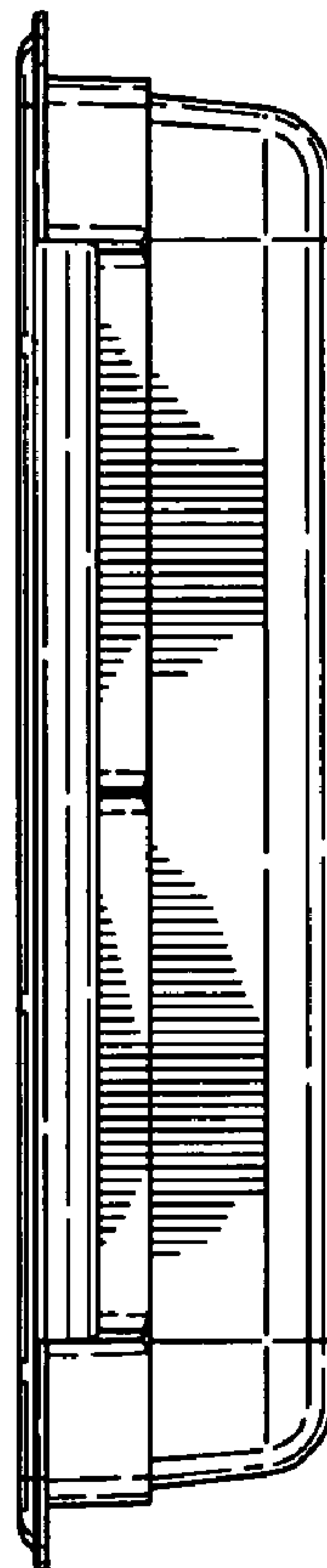

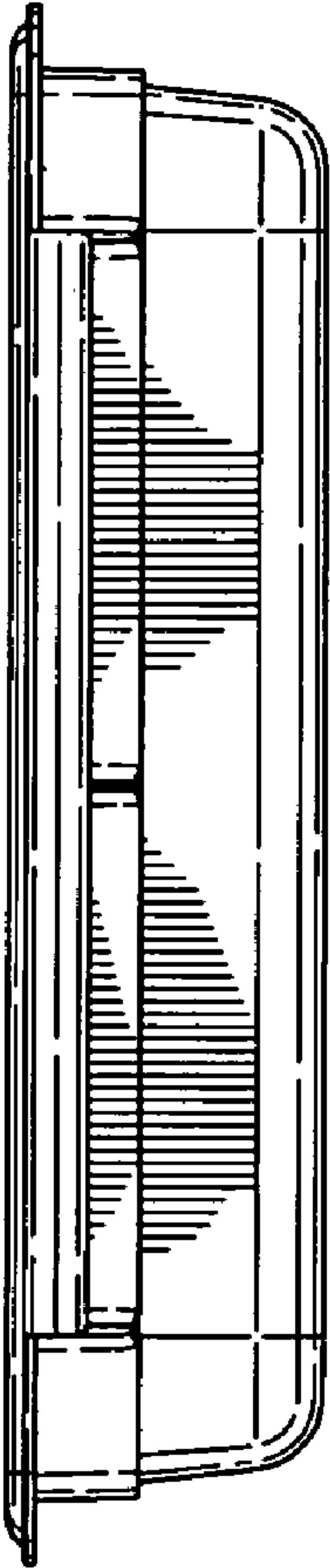

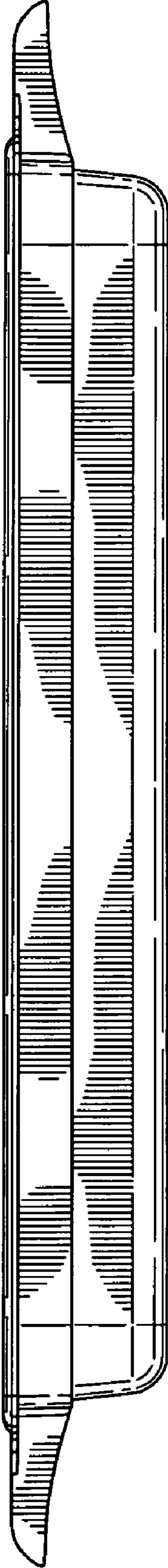

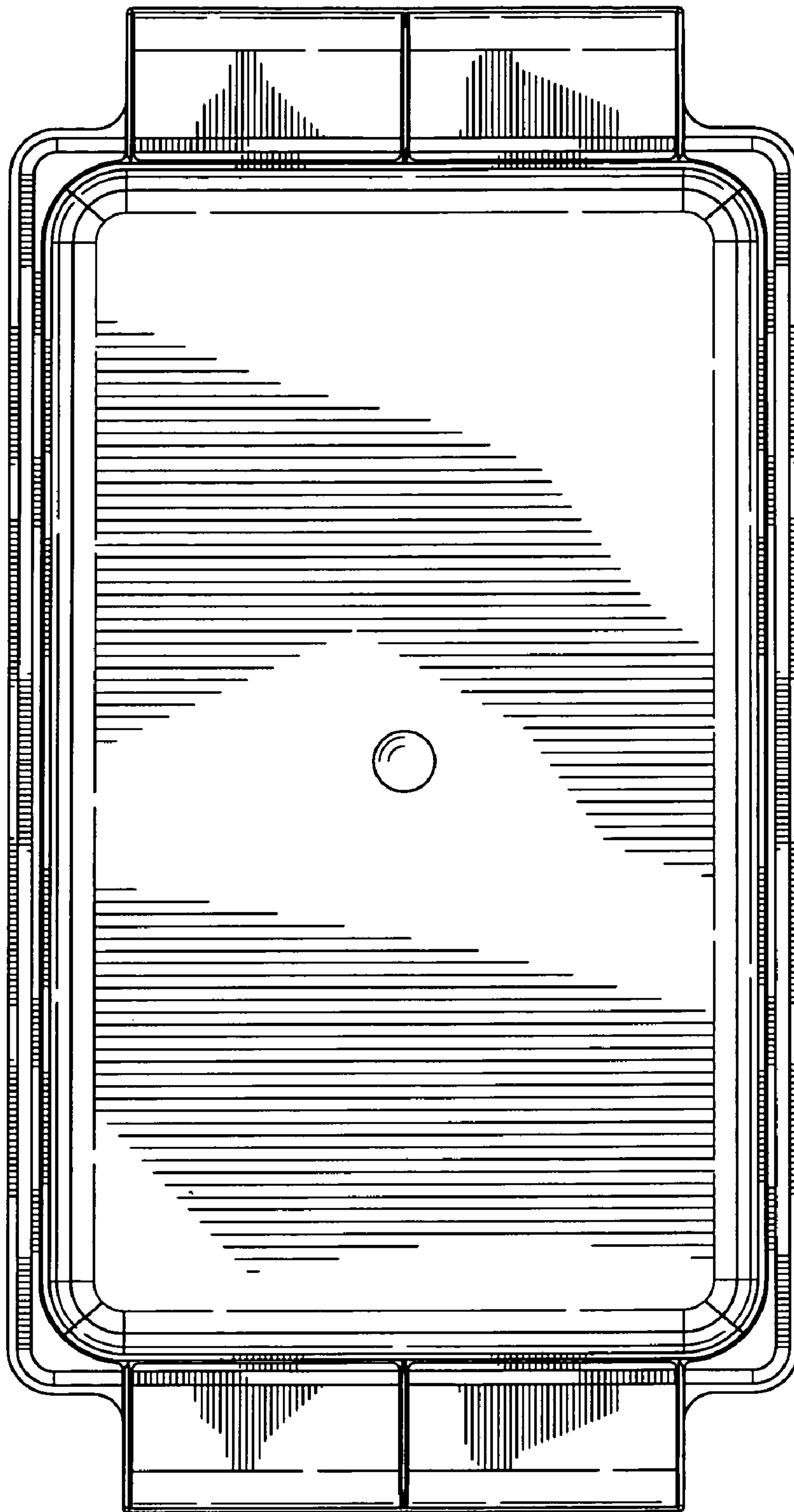
