FIG. 1 is a top perspective view of a dish showing our new design;

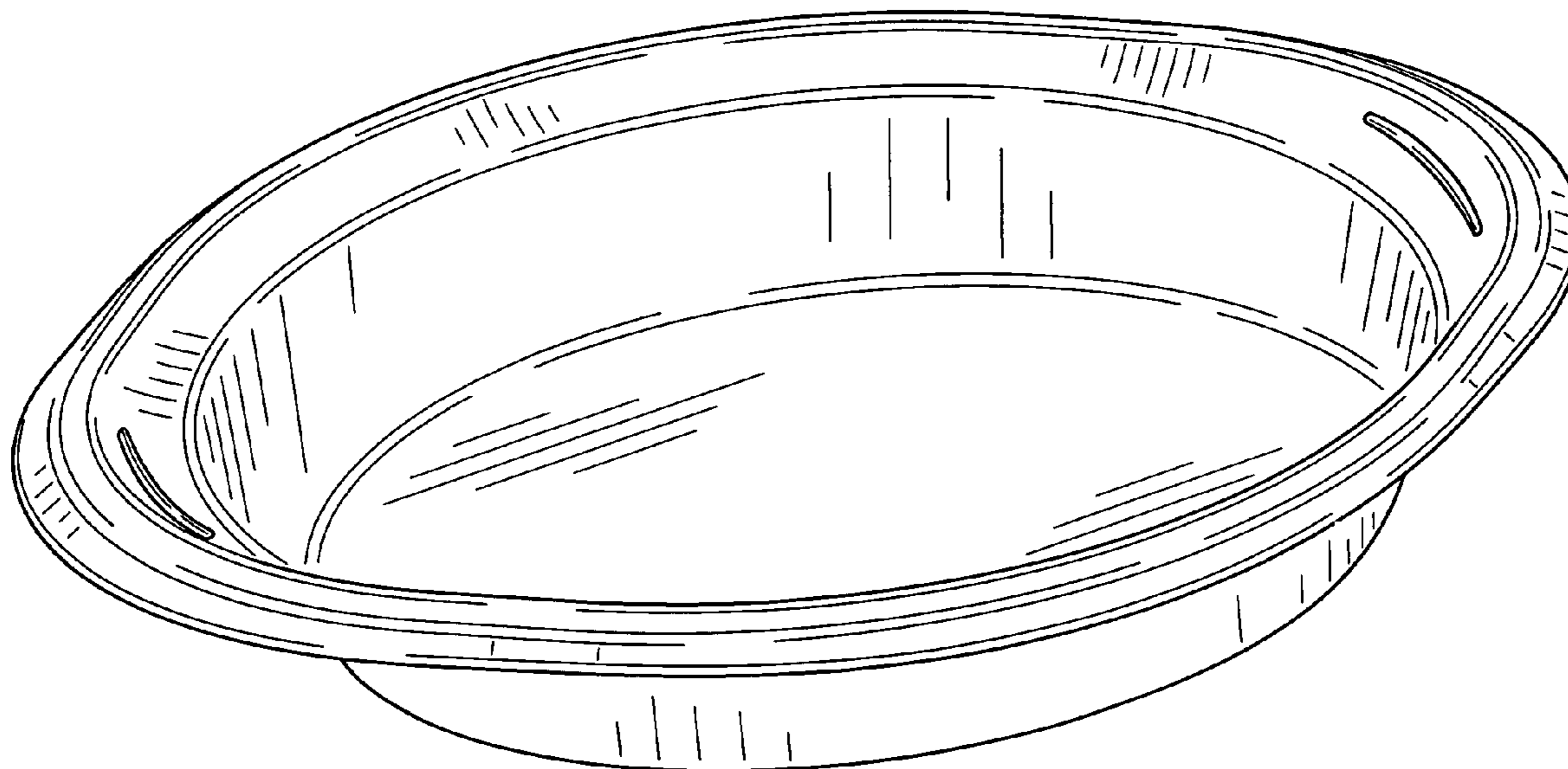
FIG. 2 is a side elevation thereof, the side opposite being identical;

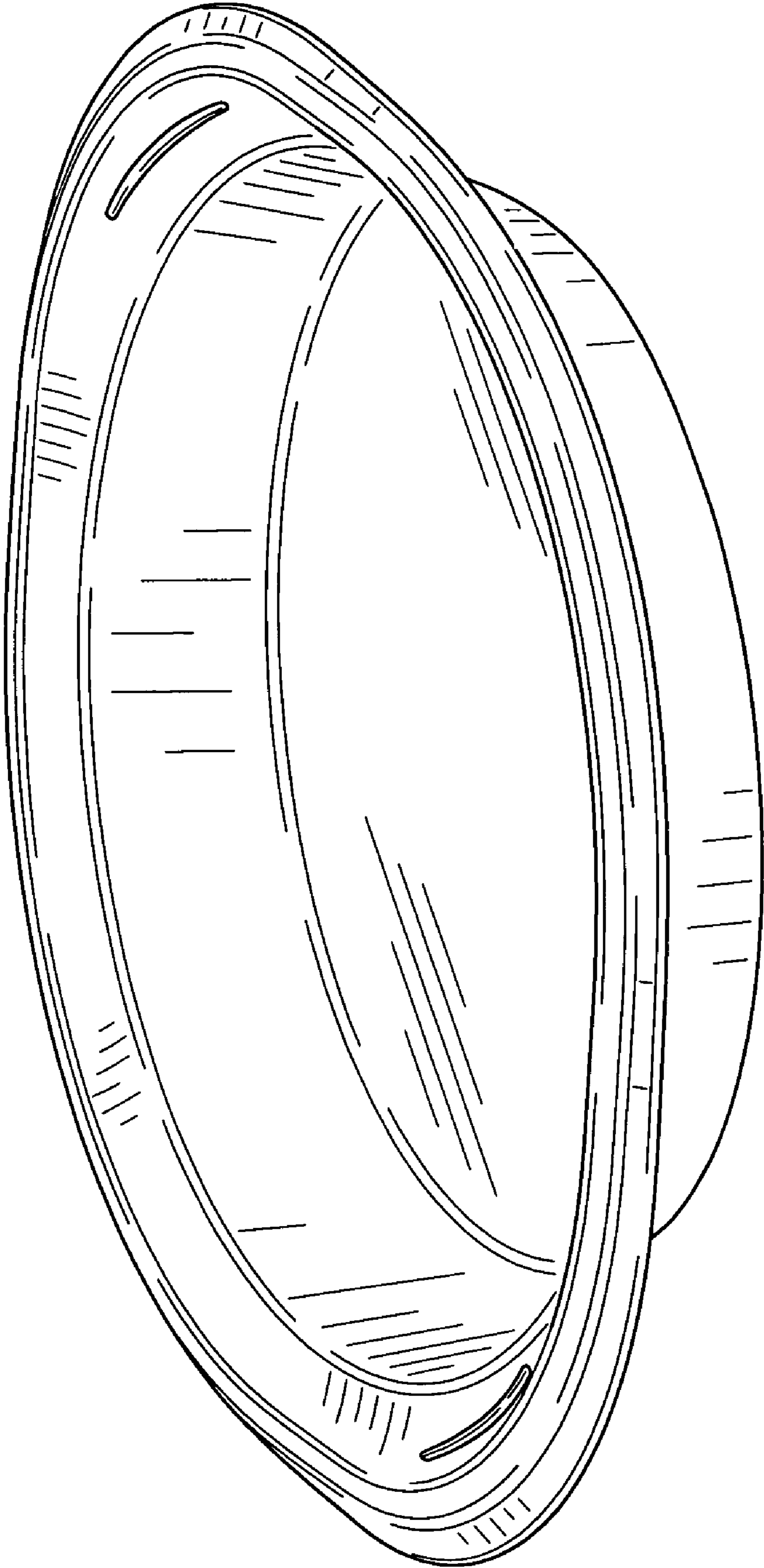

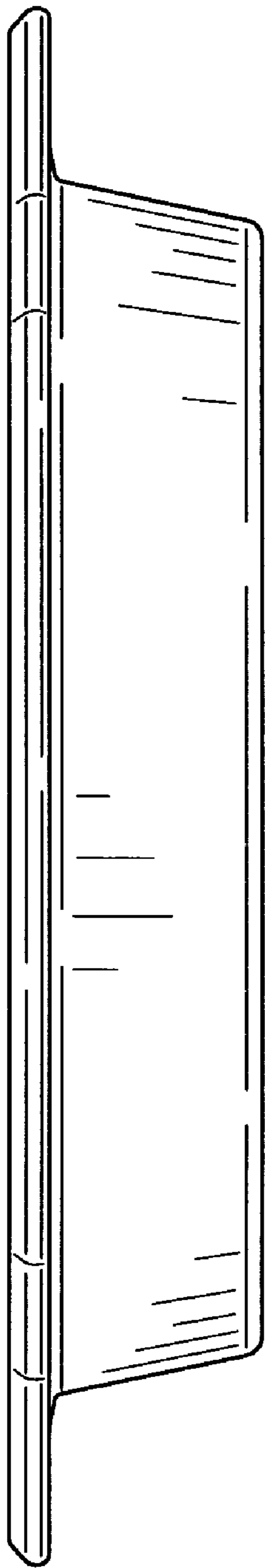

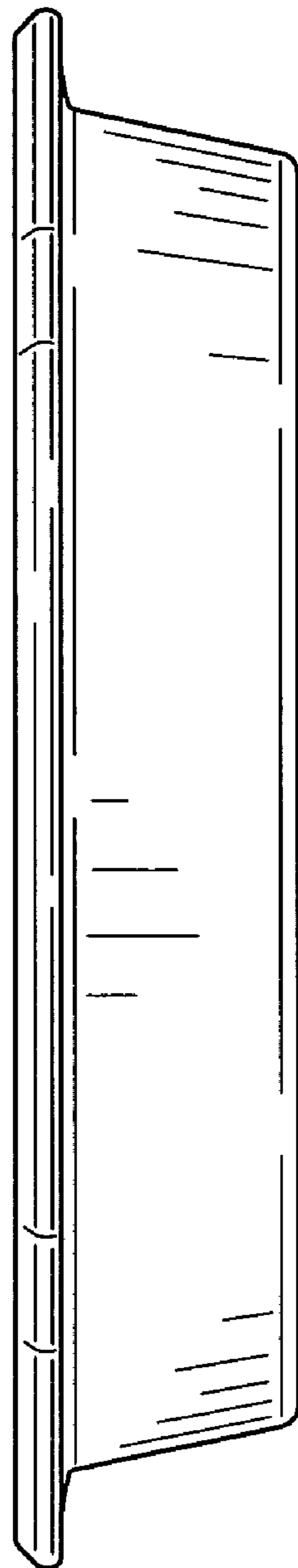

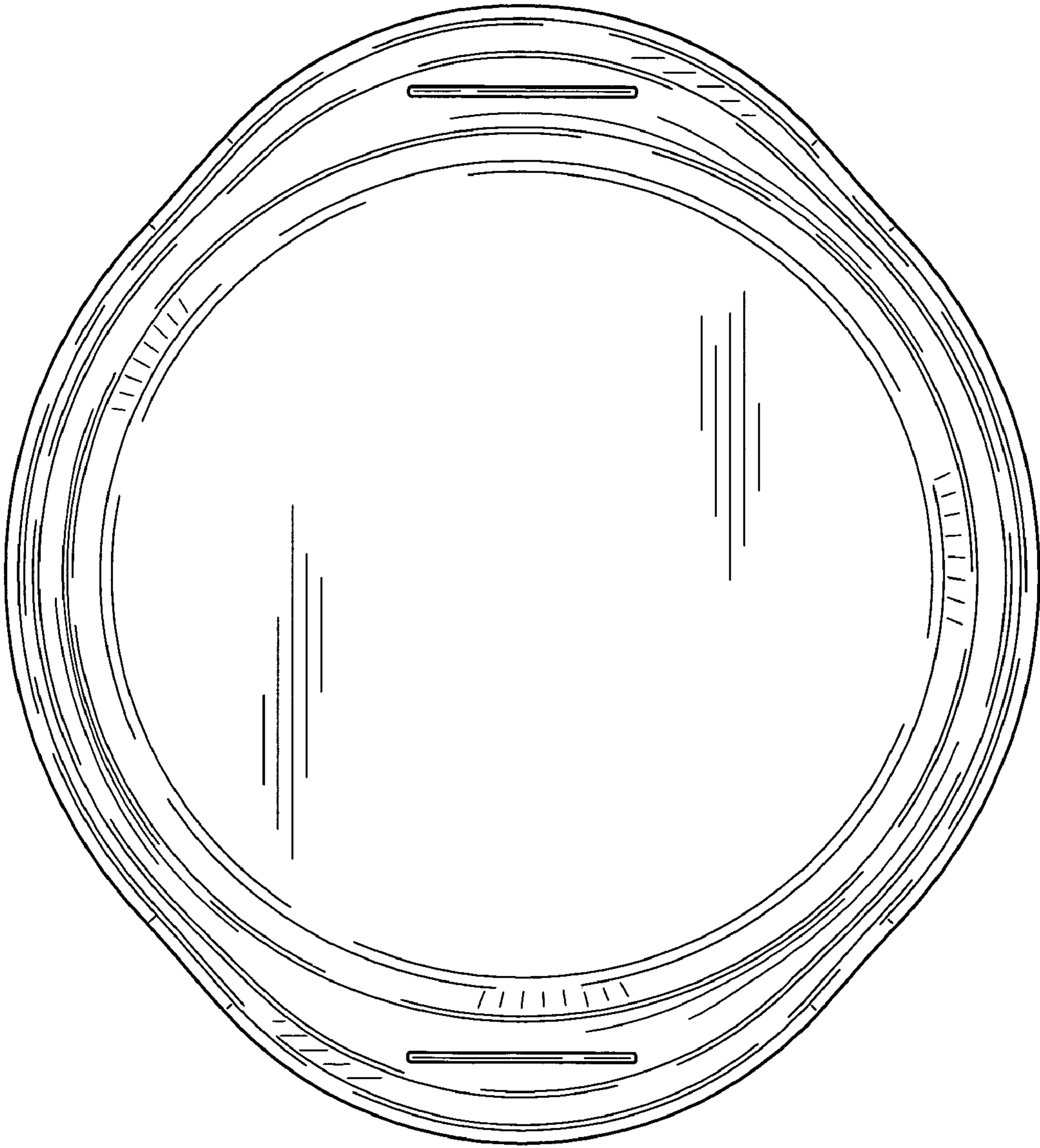

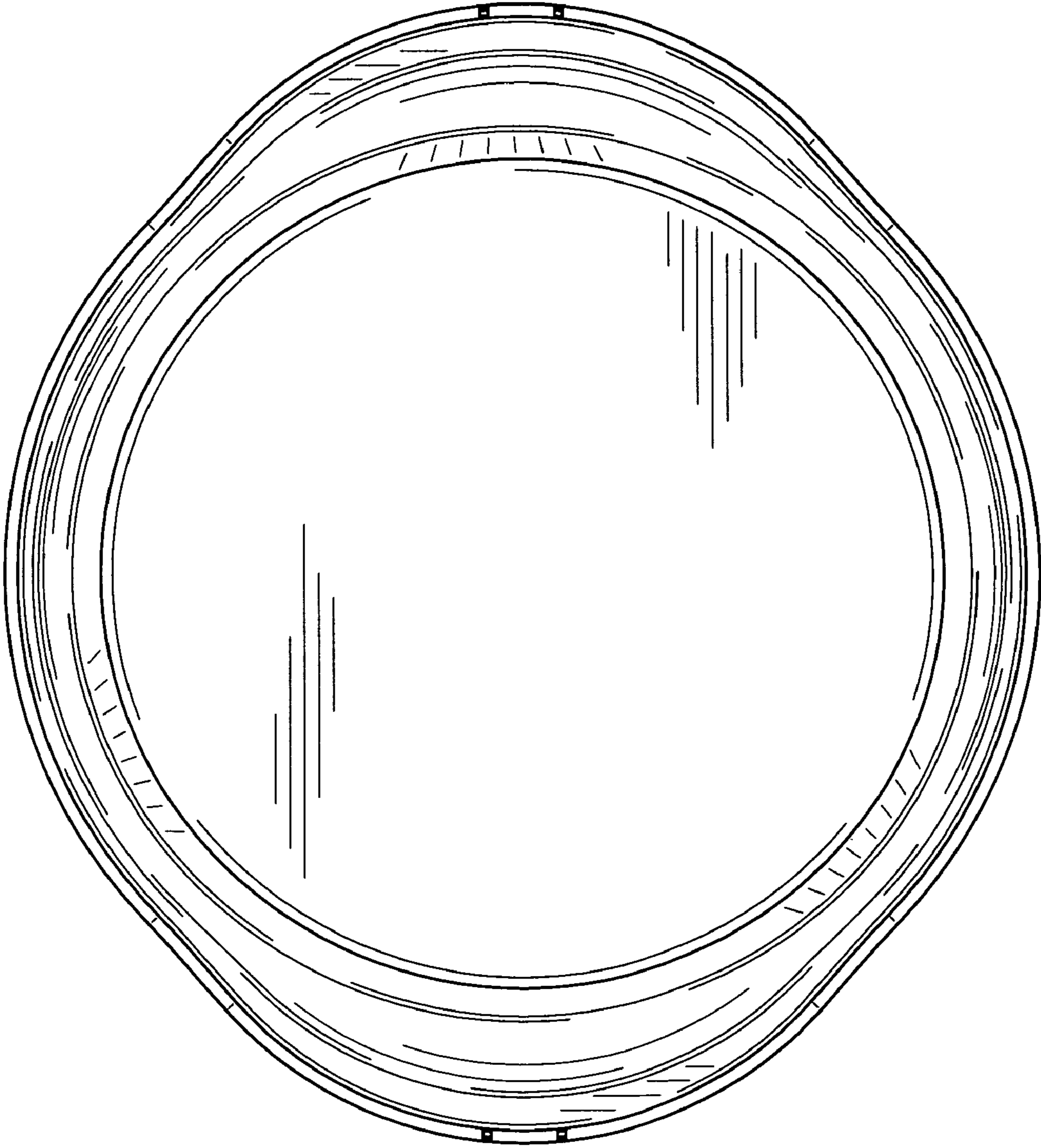
