The ornamental design for a combined foil seal cutter, cotton extractor, and pill tweezer tool, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a combined foil seal cutter, cotton extracting, and pill tweezer tool showing my new design;

FIG. 2 is a top plain view of the combined foil seal cutter, cotton extractor, and pill tweezer;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5. Is a right side elevational view thereof;

FIG. 6 is a rear elevational view thereof; and

FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is a bottom front perspective view of the combined foil seal cutter, cotton extractor, and pill tweezer tool.

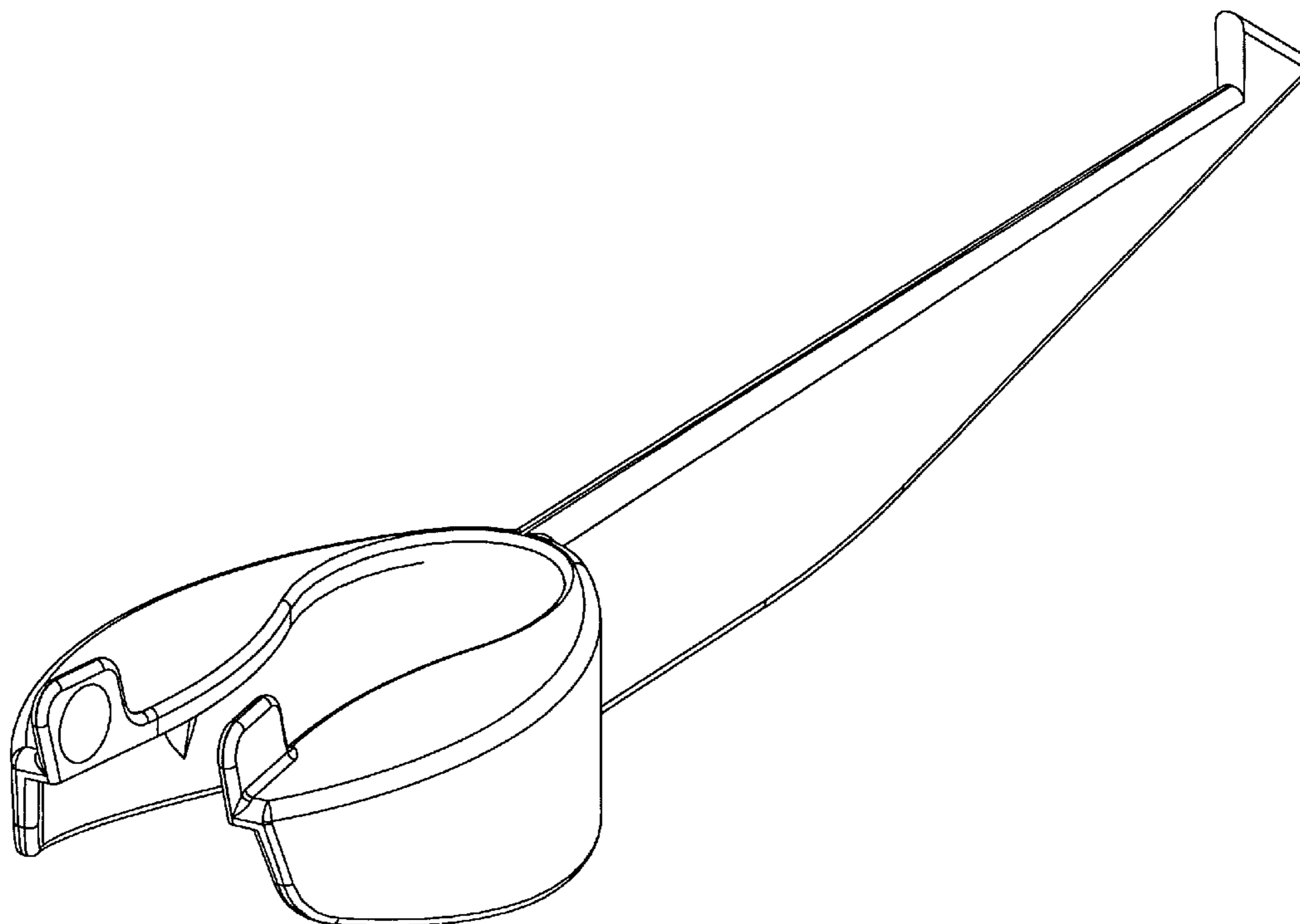

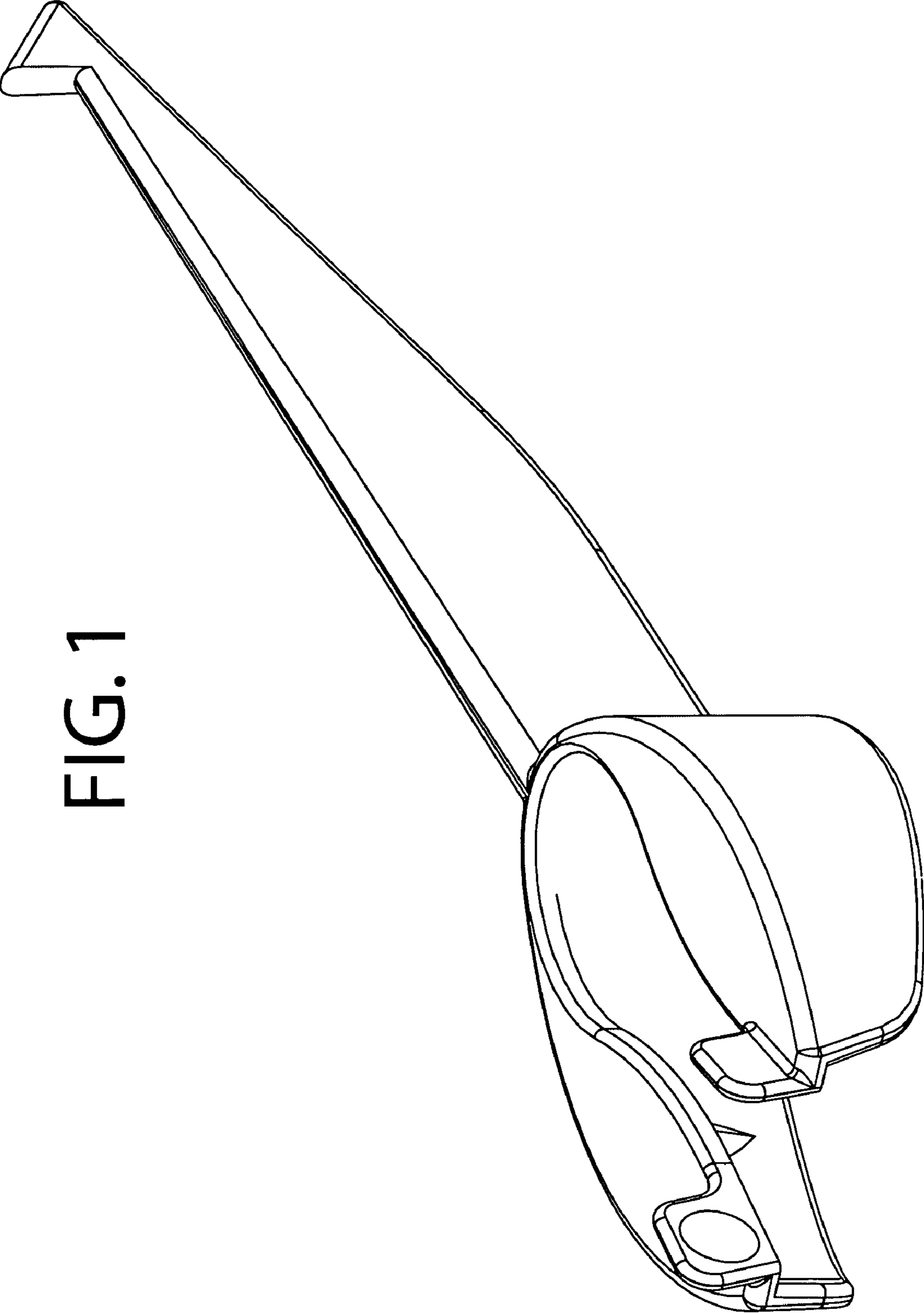

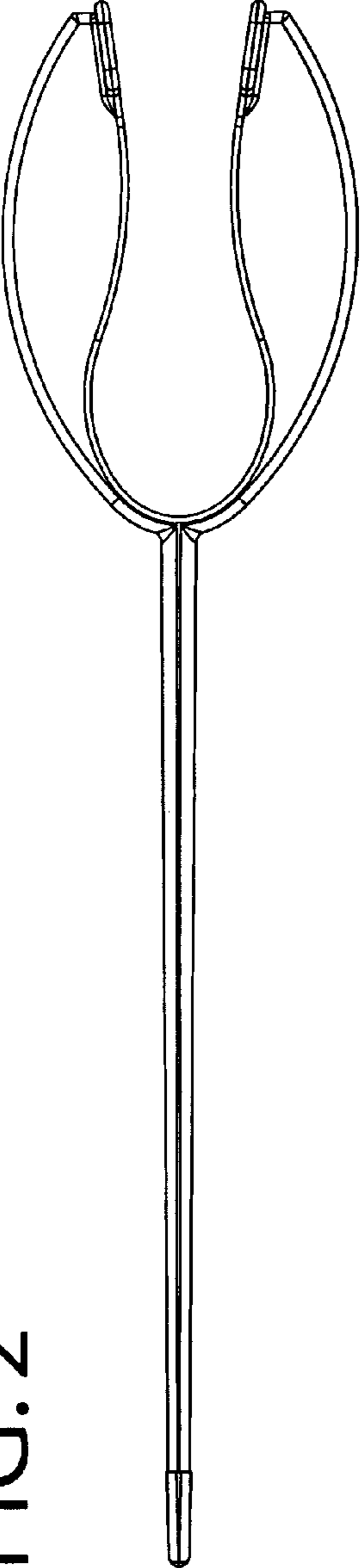

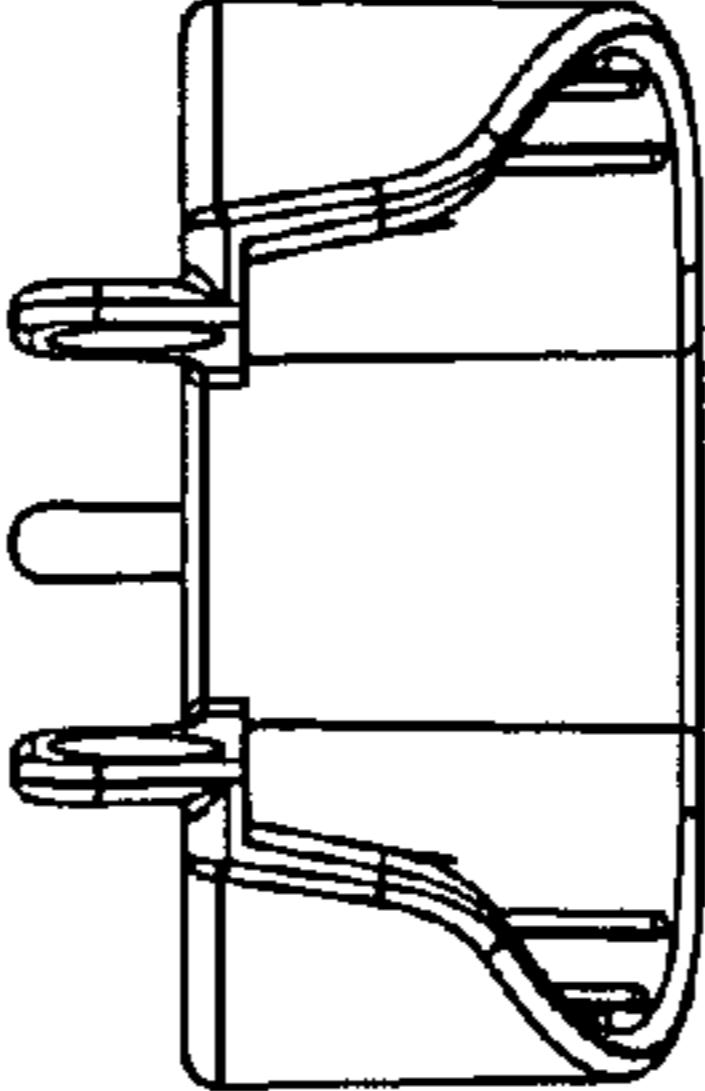

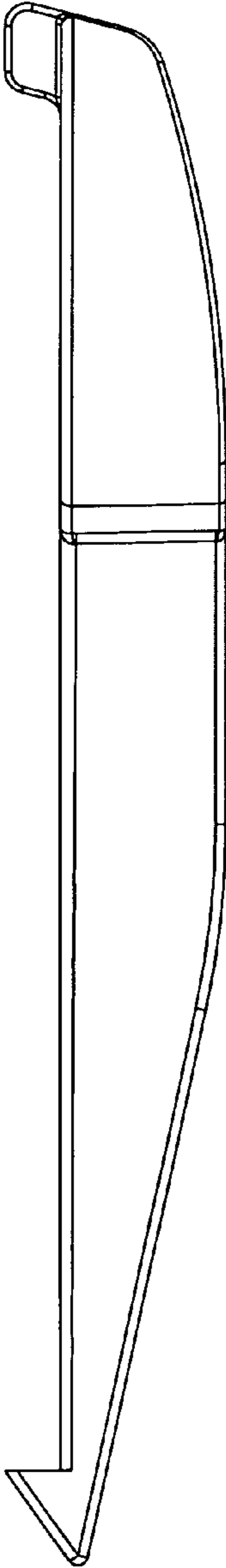

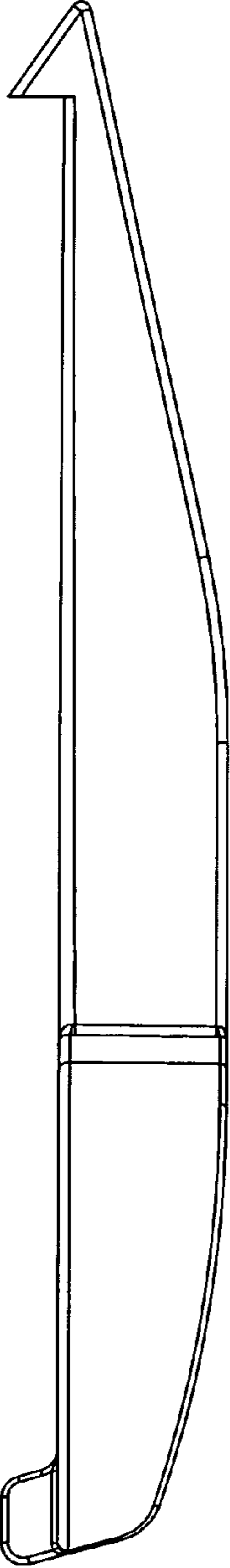

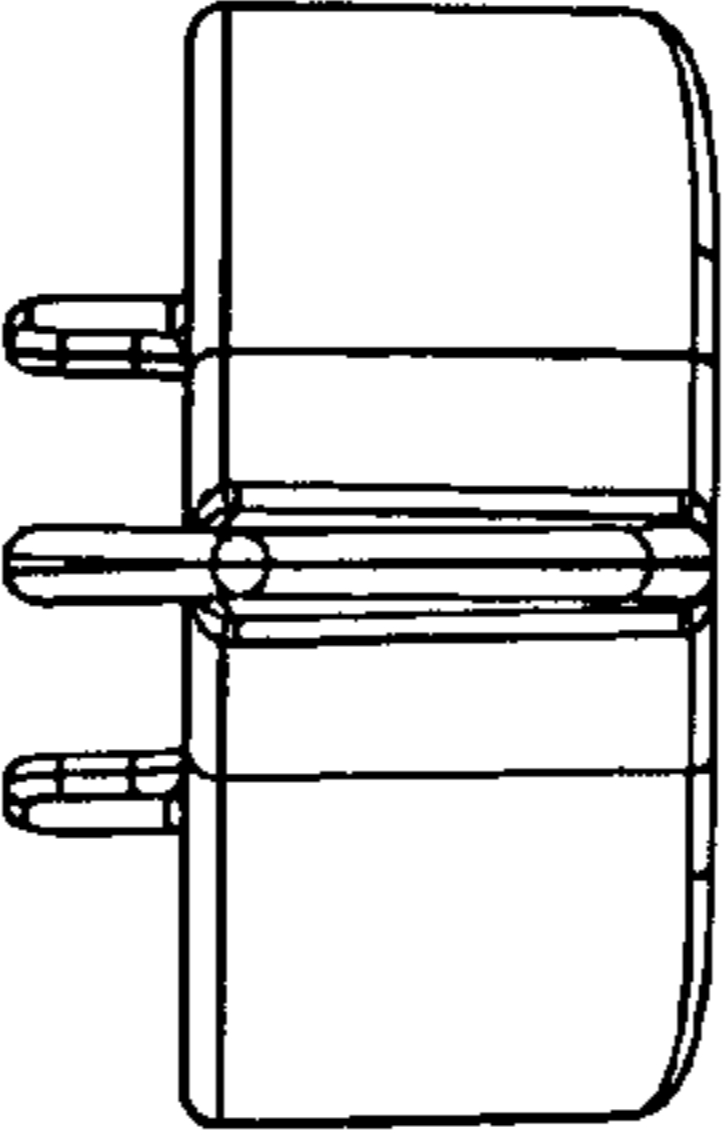
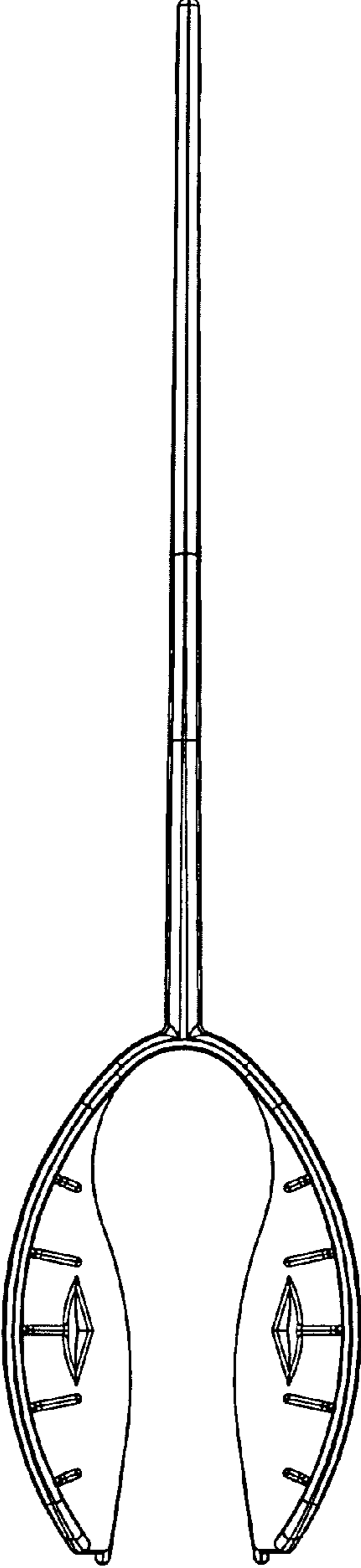

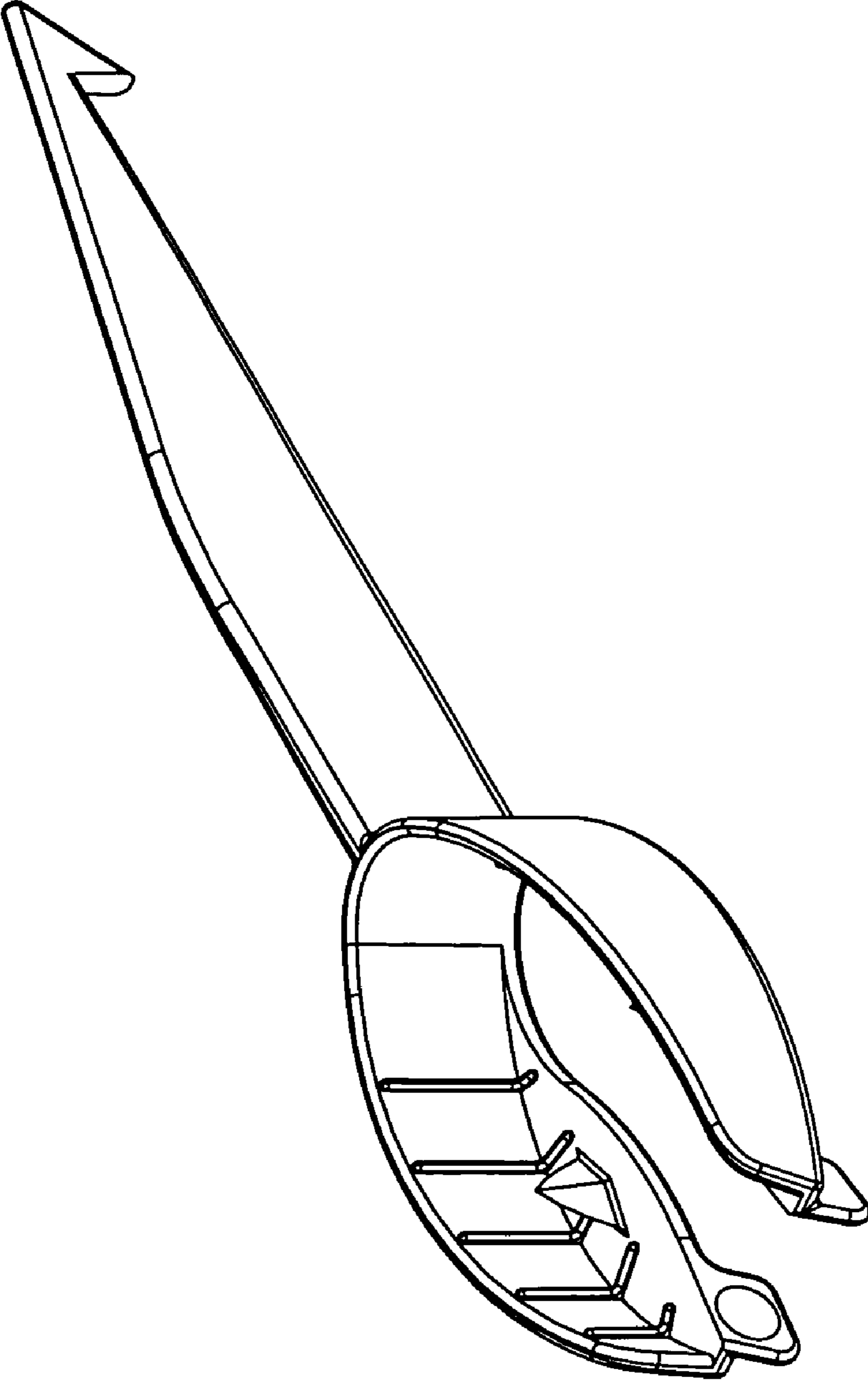
